

Notice to Inspectors of Election. To the Inspectors of Election in the several Dis tricts of the Kingdom:

Inquiries having been made whether persons who are exempt from the payment of personal taxes by reason of being clergymen, teachers, pupils in High Schools, firemen, etc., or by reason of being over the age of sixty years, or whose taxes have been excused by the Assessor on account of infirmity or poverty, are allowed by law to vote at the election for Representatives.

It is my opinion that all such persons are entitled to vote. The Tax Collector should issue to each such person a tax receipt with the words "Qualified to Vote" upon it, which he must sign, and in place of the amount of taxes he must write "exempt" or, "excused." On the presentation of this Tax Receipt to the Inspectors of Election at their sessions previous to the election, the name of the voter must be put on the list of voters and the receipt returned to the voter.

At the General Election to be held on the 3d of February, 1886, the votes of such persons must be received, unless challenged for other reasons. PAUL NEUMANN,

### EXEMPT TAX CERTIFICATES.

### The Tax Collector Ordered to Deliver the Exempt Tax Receipt.

The following opinion was delivered by Chief Justice Judd yesterday in the

Supreme Court in the exempt tax certificate case : "In order to entitle a petitioner to a

writ of mandamus it must appear that the respondent is clothed with some legal duty. The object of the writ now sued for is to obtain a tax receipt impressed with the words, 'Qualified to vote,' the production of which at the coming general election for Representatives of the people is one of the essentials to enable the petitioner to cast his vote. Section 10 of the Act of 1868 (Compiled Laws) clothes the respondent as Tax Collector for the district of Honolulu with the duty of filling out and delivering to every person entitled to vote a tax receipt so impressed. The qualifications of the petitioner to vote are not questioned by the answer. But the respondent

ered the petitioner's tax receipt to the commanding officer of the Queen's Own, ber. Is this a discharge of his duty in this respect? I think not. From the tenor of the answer it would appear that for convenience or to ensure identification of the individuals in the volunteer corps, the respondent made the Captain

of the corps his agent to deliver the receipt to petitioner. This the agent has not done, though the receipt was filled out ready for delivery on or soon after the 1st November last. The principal is responsible for the acts of his agent and answerable for his neglect to deliver the receipt. He cannot in this way evade the express duty which the law explicitly casts upon him, and upon him alone. The agent is presumably under the control of his principal, and I cannot anti-

cipate that respondent will have any difficulty in revoking the agency and recovshown to be insufficient and think that a legal and moral responsibility for the de-

Officer Good Discharged.

John W. McCarthy, Clerk of the Supreme Court of California, Arrested. By the Mararoa yesterday there arrived Detective J. Bee of San Francisco. He brought with him a requisition from Governor Stoneman of California for the surrender of John W. McCarty, at present in this city, and who left San Francisco January 2d, on alleged embezzlement of Government money. McCarthy held the position of Clerk of the Supreme Court of California. Soon after the arrival of the Mararoa Detective Bee of San Francisco called on

Marshal Soper, and the interview led to the arrest of McCarthy in the afternoon on a charge of embezzlement. He was afterwards released on furnishing bail to the amount of \$1.500 for his appearance in the Supreme Court. The bond was signed by Hon. W. C. Parke. Mr. W. A. Whiting has been engaged as counsel for him.


On the 4th of January McCarthy's books were examined by Controller Dunn. On looking into the record book of statements filed at Sacramento, he found that they were several weeks behind. A book in which are recorded the amounts of warrants received from the Controller contains in the margin opposite a number of entries the annotation in red ink, "Paid." The total of the presumably unpaid warrants is \$11,087 76. Add to this \$1,258 drawn by McCarthy shortly before his departure and the amount of the alleged money unaccounted for becomes apparently \$12,445 76. This was about the maximum that the opportunities of his position made it possible for him to take. He had received no fees from Sacramento for the month of December, nor did the Controller believe that

It is probable from the doctor's reticence on the subject that the entire session may pass without Senator Miller taking any active part in its work, but the Senator is out of immediate danger of death.

THE TRO.BLE IN SAMOA.

Germany's Action in Annexing the the Islands.

Prince Bismarck has received a dispatch fully confirming the report of the s izure of Samoa by representatives of Germany. Commander Weber has telegraphed that the old feeling of animosity against Germany, resulting from the support given by Germany to Tamasee against Malieto, culminated in an open rupture, necessitating the landing of a force from the German gunboat Albatross to protect the settlers until the restoration of order. The Samoan flag was not lowered until the King had fled.

Count Von Hatzfeldt, German Embassador at London, has telegraphed to Prince Bismark the following dispatch handed to him by Lord Salisbury, which was received from Mr. Powell, the British Consal in Samoa: "Commander Weber has driven the King from the seat of Government. Weber hauled down the King's flag, a force from the Albatross assisting. The King was insulted. The British and American Consuls entered a solemn protest. Their presence alone prevented a massacre of the Germans. War is imminent." The report is corrent that Germany will annex Samoa.

### January 15th.

The Mormons in a Southern Arizona set-Hement have asked Governor Zulick to supply them with arms, and it is said that they have been in the habit of supplying rencgade Aapaches with guns and ammunition. -The Anti-Chinese League at San Jose have decided to call a State convention to meet in February .- An Apache scout kill-ed a quartermaster's sergeant in a dispute over rations, and was allowed to escape unharmed .- The Mono County Bank at Bodie has suspended. Joe Doesch made an unsuccessful attempt to assassinate Judge Livingston at Lancaster, Pa.-The cold has destroyed 500,000 boxes of oranges in Florida.—The water supply of Cleveland has been cut off by ice packing the supply pipe of the water works.—The ship Un-dannted has probably been wrecked between New York and Philadelphia. -Eighteen persons are known to have perished of cold in Kansas in one week.

Au Important Contract. Much interest is excited in the steel trade in England by the placing of a contract for 40,000 tons of rails by the Government of Victoria, Australia, for railway construction. The whole contract, together with the necessary railway fastenings and other materials, amounting to nearly another 40,000 tons, has been secured by Briscoe & Sons, Australian merchants, London and Welverhampton.




