# Easter Sunday trag

EASTER Sunday in Rota turned tragic when a pick-up truck struck two bicycle riders, killing a sixyear-old boy and injuring a

Police said Joseph Castro Jr., of Teneto Village, was pronounced dead at the Rota Commonwealth Health Center.

Teresita Santos, 36, a teacher at Rota Elementary School, suffered injuries and was also taken to Rota CHC, police said.

The driver, Joaquin I. Norita,

Truck hits, kills six-year-old boy on Rota

55, was arrested and charged with homicide by vehicle, reckless driving, failure to exercise due care, and speeding.

Information gathered from the Department of Public Safety and Attorney General's Office showed that the victims were riding bicycles southward along San Francisco De Borja Highway when the accident occurred at 5:34 p.m.

Castro and his guardian, Santos,

were traveling on the shoulder lane of the road at Ugis when the southbound truck driven by Norita veered off the highway and struck them from the rear.

The boy was ejected from the bicycle and thrown some 30 feet away because of the strong im-

Santos fell from her bicycle and landed on a grassy area, police

Norita was allegedly under the influence of alcohol at the time.

Sources said Norita, a singer who resides on Saipan, went to Rota to celebrate Easter.

The boy is the second fatal vic-

tim of a vehicular-related accident in the CNMI this year.

A Chinese woman died a few weeks after a car she was riding swerved and rammed into a flame tree near the U-R-One Mobil gas station in Susupe on Jan. 21.

DPS records show that 107 people have been arrested for DUI while 28 crashes have occurred since January.

### Alien teachers given non-renewal notices

AT LEAST 87 alien teachers in the CNMI have received their walking papers, it was learned yesterday.

In issuing the notices of nonrenewal of the alien teachers' contracts, Education Commissioner William S. Torres said the Public School System "is unable to....certify that no resident worker is available to fill the employment positions that will become vacant at the end of the 1996 school year."

Public Law 10-4, also known as the alien hiring law requires PSS to issue a certification of unavailability of resident workers before it could hire alien teachers.

Torres issued the nonrenewal notices Thursday despite the recommendations of principals James Fegger and Dave Boria, of Marianas High School and Hopwood Junior High, respectively, to retain the alien teach-

Torres has expressed preference for US teachers, especially those from the mainland.

A policy clash between the Commissioner's Office and the Board of Education looms as result of Torres' move.

Upon learning of the commissioner's issuance of notices, board chairman Tom Pangelinan called for a hasty board meeting yesterday, and issuedamemorandum directing Torres to "let the principals decide whether ornotto keep their nonresident teach-

## Tenorio vetoes bill to bring back garment moratorium

THE DOORS of government will continue to be open for investors wanting to come in to do garment manufacturing business on Saipan.

This is because Gov. Froilan C. Tenorio has disapproved a bill seeking to reimpose a moratorium on any new garment manufacturing licenses.

"I agree that the prospect of more expansion in the garment industry raises some serious concerns. However, I do not believe that this is an appropriate method of dealing with the problem," said the governor in his veto message to the presiding officers of the Legislature.

Tenorio vetoed House Bill 10-152 on the premise that government is capable of controlling problems associated with growth of the industry and that is why it

should not be curtailed.

"I have faith in the free market and I think we should let it operate with a minimum of interference," said the governor.

The bill, which was authored by Rep. Pete P. Reyes and several others, was approved by the Legislature to stop the Department of Commerce from issuing any additional licenses for new facto-

There used to be a moratorium on the granting of any new garment factory license on Saipan but this was lifted last year through regulations promulgated by the Commerce Department.

Proponents of the bill said bringing back the moratorium is necessary owing to the industry's impact on the Commonwealth and the US government's insistence that the CNMI should cap immigration at the 1992 levels.

Since garment manufacturing business is labor-intensive, there is concern that opening up the island to more factories would mean a sizeable increase in the non-resident worker population.

In his veto message, Tenorio admitted that the garment industry does impose heavy burdens on



### 8 dead, 3 missing in Ecuador avalanche

OUITO, Ecuador (AP)-Three mountain climbers missing after an avalanche that killed eight people and injured nine were feared dead, the Red Cross said Sun-

The 20 climbers were caught in the avalanche Saturday, about 130 feet (40 meters) from a wooden shelter on Cotopaxi Volcano, 55 miles (90 kms) south of Quito, according to Red Cross and radio reports.

The nationwide election, held every four years, were scheduled for last June, but the minister of local government postponed them for a year. The constitution does not give the minister powers to postpone it again.

The state of emergency had been in force in the north and east of the country, and the capital, Colombo, almost continuously since 1983, giving the military wide powers to arrest

Mrs. Kumaratunga had lifted the emergency from the rest of the country after she came to power in 1994.

The rebels are fighting for an independent homeland in the north and east for minority Tamils. They claim widespread discrimination by the majority Sinhalese, who control the government and the military.

## Police probe one of Canada's bloodiest mass murders

VERNON, British Columbia (AP) -Friends preparing to bury the nine familv members massacred in one of Canada's bloodiest mass murders want to know why police granted the killer a handgun license after his wife had filed

a police complaint against him. Mark Chahal's rage over his failed marriage to Rajwar Gakhal turned a holiday weekend wedding celebration into grim funeral preparations for mem-

bers of Vernon's Sikh community. A husband and wife, their five daughters, one son and a son-in-law were

"We are pretty concerned about how he got two guns," family spokesman Jeet Dukhia said Sunday. "If it did come after the complaint, what kind of system have we got?"

Gakhal told Royal Canadian Mounted Police in Vernon in January 1995 that Chahal, 30, had threatened her but declined to press charges.

Three months later, Chahal submitted a firearms acquisition certificate application for a .40-caliber semi-automatic Smith and Wesson handgun to the RCMP police detachment in Burnaby, where he lived. He applied for a .38 special Smith and Wesson revolver last June.

RCMP spokesman Sgt. Peter Montague said Sunday he didn't know if Burnaby RCMP knew of Gakhal's complaint when they processed the applications. But it wouldn't have mattered, he said.

To reject a firearms permit request, police must have evidence of a conviction, a charge, an investigation or a history of violence, Montague said. "None of that applied."

If Chahal had been denied a gun permit, he could have bought a weapon on the black market or smuggled one from the United States, Montague noted.

Chahal packed the two handguns and a shotgun into his car Thursday morning, drove 440 kilometers (275 miles) from his Vancouver-area home to Vernon and checked into a motel.

Friday morning, Chahal went to Gakhal's home, killed his former father-in-law, Karnail Gakhal, in the driveway, then burst inside. The home was filled with men, women and children preparing for a ceremony traditionally conducted before a Sikh wedding.

"He fired multiple shots at each victim," said RCMP Sgt. Doug Hartl. "Many were shot in the head. He had three clips, 10 bullets in a clip, and we found two empty clips at the house. We

found 29 casings." Of the 13 people inside the home, nine were killed and two injured. Two small children escaped unharmed.

Police said Chahal had enough ammunition to kill the children and believe he deliberately spared them. They said a 6-year-old shot in the legs was apparently hit by a stray bullet.

Hartl said 10 other guests invited to the ceremony for the wedding of

Balwinder Kaur Gakhal, 24, had not yet arrived when the killing began.

After his rampage, Chahal returned to his motel room. He wrote a terse note, apologizing but giving no reason for his actions, put a gun to his head and killed himself.

It was the second-worst murder-suicide in Canadian history, surpassed only by the 1989 slaughter of 14 female engineering students at Montreal's Ecole Polytechnique.

Gunman Marc Lepine also ended his rampage with suicide.

Family friends say Chahal abused his arranged bride from the day they were married. But he was distraught when sh

left him after eight months and went to live with her family in Vernon. The couples' divorce was to have been completed next month. "The problem wasn't with the

authorities," said Monica Martinez, a 26-year-old friend of victim Balwinder Gakhal, the bride-to-be.

Richard Wilford, the RCMP victims' assistance co-ordinator for north Okanagan, said police are using Vancouver psychologists and members of the Sikh community to work with the survivors.

Dukhia said a memorial service will be held this later this month when relatives arrive from India.

# Gov't denies Wardlaw charges

THE C.N.M.I. government has denied many of the allegations contained in the complaint filed by dismissed Hospital Administrator Angela Wardlaw.

In an answer filed before the District Court last month to Wardlaw's complaint, the government, through acting Atty. Gen. C. Sebastian Aloot, insisted that Wardlaw was suspended for three days last February because of absenteeism, reporting late to work and unprofessional conduct.

Wardlaw filed her suit for damages against Health Secretary Isamu J. Abraham, Personnel Director Luis S. Camacho, and the CNMI last Feb.

Wardlaw's claim that the reasons for her three-day suspension were to injure her inher profession, her name, honor, and reputation, as well as to further undermine her employment is not true, the government said.

Other allegations of Wardlaw that the government denied in their entirety included:

The defendants also denied that Wardlaw had a contractual right to carry out the duties and responsibilities of a hospital administra-

"(The) plaintiff has a contractual obligation to adequately and successfully discharge the duties and responsibilities of the position of hospital administrator," they said.

The defendants said that should the court determine Wardlaw was a civil service employee, they are entitled to "an offset" for all benefits Wardlaw had received as excepted service employee, including housing, standby pay, deviations from civil service salary guidelines, and relocation and repatriation expenses.





### **WASHINGTON MERRY-GO-ROUND**

### No one is giving GOA's PAC money back

WASHINGTON-Republican presidential candidate Patrick J. Buchanan is not the only politician scrambling to explain his relationship with former campaign worker Larry Pratt, who allegedly consorted with white supremacists and radical militia groups.

Pratt's organization, Gun Owners of America, has bestowed campaign contributions totaling \$52,159 on more than 60 congressional candidates since the 1994 election cycle. Even though Pratt has temporarily left his post as co-chairman of Buchanan's campaign because of the controversy none of the members of Congress we contacted are going to return the checks they collected from the GOA's political action commit-

Two of the top recipients —Reps. Steve Stockman, R Texas, and Helen Chenoweth, R-Idahohave themselves been linked to militia groups. Another of the top recipients of the group's PAC money-Rep. Roscoe Bartlett, R-Md.- had to apologize in 1993 for saying that people with Asian and Indian surnames do not "represent the normal American."

Some of Buchanan's past diatribes dovetail with the views expressed by Pratt's political soulmates. Buchanan says he wants "to take America back," and asks "who speaks for the EuroAmericans who founded the U.S.A.?" He also believes America has failed to "assimilate" African-Americans into "our society."

Pratt, who is executive director of the GOA, admits that he has attended meetings where various extremists were present, but he denies being a militia member or discussing any racial views with white supremacists. Just days after the infamous 1992 FBI raid at Ruby Ridge, Idaho, in which two people were killed, Pratt attended a meeting with the head of the Aryan Nations, an allegedly attacked the 14th Amendment, which guarantees equal protection under the law for all

Following the Oklahoma City bombing last April, Pratt attended a meeting of militia supporters in Missouri. He allegedly equated the bombing to the tragedy at Waco by saying, "The government behaves like a beast.

Stockman, who was harshly criticized for his own role in the bombing, was the top recipient of the GOA's largess. He accepted \$6,736 in the 1994 election cycle and \$1,600 in the 1996 cycle, according to federal records. The group's financial help was considered pivotal to Stockman's defeat of veteran Democratic Rep. Jack Brooks.

Just hours before the tragedy, Stockman's office received a mysterious bulletin about the bombing by fax from an associate of a militia leader in Michigan but never alerted law enforcement officials to the ominous document until after the blast. A month earlier, Stockman had written Attorney General Janet Reno claiming he had heard from "reliable sources" that the government was planning a raid on some militia groups —a rumor that militia people had been spreading for months.

Stockman later penned an article in a gun magazine that accused the Clinton administration of staging the Waco raid in order to help push the weapons ban through Congress. Stockman's office did not return our calls seeking comment.

The GOA's spokesman John Velleco told us that the group contributes money to candidates who support guns. He added that Stockman is "arguably the most pro-gun member in the House. Militias are pro-gun."

Bartlett, who accepted \$6,726 in the 1994 election cycle, told us in a prepared statement: "I and other Americans abhor the views of some of the people Larry has spoken to and with whom he has occasionally shared a stage."

But Bartlett said he will not return the money because Pratt's attendance at meetings with white supremacists shows that he "defends all constitutional rights," from the right to bear arms to the right of free speech. "The key is that he is indiscriminate in who he talks to," said Bartlett, who is apparently" indiscriminate" about who he takes money from. (At least Buchanan was guileless enough to say he was unwilling to dump a friend overboard.)



### New Labor regs to push hiring of TWA holders

THE DEPARTMENT of Labor and Immigration wants the local business community to absorb the nonresident workers who are holding temporary work authorization instead of bringing in more aliens from foreign countries. This is one of the highlights of the amended labor rules and regulations, according to Asst. Atty Gen. Dan Aguilar.

TWAs are given to alien workers who have lost their jobs, but stay in the island pending resolution of their labor cases.

Aguilar said the number of TWA-holders in the CNMI has reached about 2,000 to 3,000.

"Many of these workers are basically unemployed," said Aguilar who authored the new labor guidelines. "Our legislators keep complaining about the large number of aliens here and we don't see the need for employers to bring in more workers from foreign countries."

Aguilar said the new set of guidelines, in effect, seeks to give second preference to TWA-holders next to local residents who are in the hiring priority list under the current law.

Aguilar admits that the new labor guidelines would draw opposition

from employers as it would limit their choices of workers.

"They need to understand that the new regulation was not meant to make hiring nonresident workers easy, but rather to make it much harder," Aguilar said.

Nevertheless, Aguilar said, the new regulation would be favorable to the employers as it would save them the bigger costs of bringing in workers from other countries. Processing of papers of a workers costs the employer about \$400, inclusive of other expenses.

"We want the employers to weigh the financial costs of hiring people from outside versus the ones who are already here," Aguilar said.

The new set of labor guidelines was published in the *Commonwealth Register* last Dec. 15. It was supposed to take effect 30 days hence, but the labor department moved to delay its implementation after receiving public comments.

The proposed regulation is in conflict with a proposal filed by Rep. Pete Reyes who wants to send home nonresident workers who have pending cases.

Aguilar said if Reyes' bill is passed into law, it would supersede the department's guidelines.





the Commonwealth.

"The thousands of employees are indeed a strain on our infrastructure. Processing these large numbers already stretches the resources of our government; expanding the industry will make it even harder. Our society will be further strained if large numbers of foreign workers come in. Workers' rights are still a concern," said the gov-

Nevertheless, he said, he believes the garment industry is presently doing more good than harm to the CNMI, and for good reasons.

For one, the governor said the garment industry contributes a tremendous amount of money to the economy -over \$20 million in fees, payroll taxes, customs user fees, business gross receipts taxes, and others.

"We receive more money from the garment industry than we do from federal CIP funding," Tenorio notes.

The governor also pointed out that the indirect contribution of the industry is even greater, saying dozens of small businesses depend on the garment industry for their survival.

Since most foreign garment workers come to the CNMI to save money, the governor said they are responsible for many millions of dollars of deposits in

"Further expansion of the garment industry, though troubling in many ways, would bring major economic benefits. For this reason alone, it should not be foreclosed without careful consideration of the true costs and benefits. No such analysis exists at this time,"

Tenorio pointed out. Another reason Tenorio had for his vetowas that a moratorium may unfairly benefit existing garment factories, by shielding them from competition.

"No other local industry is entitled to such special treatment," he said. Also, Tenorio saw no point in having

a moratorium when in the long run, there is the question on whether the industry would continue to be viable in the islands.

"Our minimum wage is rising. This will certainly affect the labor-intensive garment industry. In the next few years, the industry will also face fierce competition in the US market from Mexican factories under the NAFTA," said

The chief executive noted that although government has received a large number of applications for garment factory licenses and has approved 17 in the last six months, only three have so far gotten forward with construction or operation of new factories.

"History shows that many, if not most, of such applications are not followed up to the point of actually opening a factory. We do not believe that we will be seeing anything like the 'boom' that followed the initial entry of garment factories into the Commonwealth in 1983-1984," said Tenorio.

"Wages are higher now, land is much more expensive. OSHA and labor laws are more stringently enforced and any new investor will have to compete with the factories who are already here," he

For all these reasons, Tenorio said the Commonwealth is a much less attractive location for a new garment factory than it was ten or 12 years ago.

Lastly, the governor expressed confidence government can manage a reasonable increase in the number of garment factories.

"An additional six or eight factories would present problems, but nothing that we could not handle," said Tenorio.

He pointed out that the new Labor and Immigration Identification System will greatly increase government's capability for handling large numbers of workers quickly and efficiently.

"We would still have to be very careful about monitoring for violations of workers' rights, particularly in the case of new investors from Asia who are not familiar with American laws and standards. But I think these difficulties can be overcome, particularly given the additional tax revenue that more factories would generate," said the governor.

Tenorio ended his letter to the Legislature saying the veto is not the last word on the issue of garment industry

"If it appears that too many garment factories are coming in too quickly. if expansion of the industry threatens to overwhelmour ability to deal with it, or if a careful analysis shows that the problems are outweighing the benefits, I would quickly reconsider legislation of this nature. For now though, I think it is premature," said the governor.

PL 10-4 allows the government to continue hiring nonresident workers until year 2000. But the same law imposed hiring restrictions on PSS which put at stake the positions of alien teachers.

Compounding the alien teachers' predicament is the Commissioner's policy toward giving preference for US citizens. PSS has started recruiting teachers from Guam, Hawaii and the US main-

Pangelinan said "there is no such US-preference policy in the PSS."

The Commissioner's Office and the education board, Pangelinan said, had never discussed or forzed any PSS position on the hiring policy. Pangelinan, moreover, said that

the administration's interpretation of the law is not consistent with the original intention of the legislature. "The law is clear that the govern-

ment may continue hiring nonresident workers," he said. The board chairman maintained

that alien teachers should retain their jobs in local public schools, saying "the CNMI's diverse student population needs an equally diverse teaching population.'

"Most of these teachers have been serving PSS for more than 10 years and they have proven to be excellent ones," Pangelinan said. "We can't be sure if we can replace them with equally talented teachers from the mainland."

## Fiji Dev't Bank has \$42-M bad loans, says newspaper

THE Fiji Development Bank is reported to have 60-million Fiji dollars (US\$42 million) in bad loans, representing almost 20 per cent of its total loans. And the bank expects to write off\$15 million this financial year after having written off a similar amount last year, the Fiji Times reports.

FDB managing director Laisenia Qarase said in a report to the board in December, the interest return target of 11.23 percent for the year has been recognized as not achieveable as the bank has a high level of non-earning loans approximately 19 per cent or \$60-million of the total portfolio. He saidwrite off of these bad loans for the financial year had been estimated at \$15 million.

But, interestingly, the Fiji Times reports another paper presented to the board in January, says "accounts in arrears represented 13. 99 per cent of total loans and had been increasing in the past three months ".

The January board paper said "the bank' s target for arrears to portfolio is 11.5 per cent and the trend over the last three months show that the level of "arrears is increasing as a result of a decline in collections ".

Meanwhile, a bank has stopped agricultural loans for new applicants with "Class J" leases unless they a de-reserved as native land. Class J leases are agricultural



### Unabomber suspect's trail from Montana to California

By BOB ANEZ

HELENA, Montana (AP)- A hotel employee said Sunday he saw Unabomber suspect Theodore Kaczynski in Sacramento, California, several times in recent years - an account that places him in the region where the Unabomber's last four bombs were mailed.

Frank Hensley, a desk clerk at the Royal Hotel, next door to the bus depot in downtown Sacramento, told The Associated Press he saw Kaczynski in the neighborhood or staying at the hotel almost annually during the last five years. He stayed at the hotel two or three times, usually in the late spring or summer, Hensley

Kaczynski, 53, was taken into custody at his cabin near Lincoln, Montana, on Wednesday and is being held without bail in a Helena jail. He has been charged in federal court with possession of bomb-making materials. The charge is intended to keep Kaczynski in custody while investigators build a case against him for the Unabomber attacks that killed three people and injured 23 in nine states over the past 18 years.

Federal investigators tracking Kaczynski's movements are trying to learn how the former math professor, who had no visible means of upport could get to other states where the Unabomber's bombs were mailed or left.

They reportedly are checking whether he rode buses to those states; two bus line employees in Montana told the AP that Kaczynski was a passenger numerous times.

Meanwhile, the painstaking search of Kaczynski's 10-foot-by-12-foot (three-meter-by-four-meter) cabin continued Sunday. FBI spokesman George Grotz said investigators were combing the cabin and the surrounding forest. The cabin search already has turned

up a partially completed pipe bomb, bomb-making chemicals and components, and notes on making bombs. One law enforcement official said a type-

writer found in the cabin appears to be the one the Unabomber used to type his 35,000-word manifesto and letters. Another said investigators found and defused a live bomb in the cabin on Friday that they believe was intended for someone in particular.

Hensley said FBI agents approached him in March, showing him Kaczynski's photo.

"I recognized him right away," he said. "I remembered his face." Hensley said Kaczynski stayed at the hotel two or three times in the late spring or early summer, and his stays lasted no longer than a week. He said he didn't recall the years he stayed in

Hensley said FBI agents collected registration cards from the Royal and three other hotels in the neighborhood under the same ownership.

The agents were searching the

Royal records for a guest registered by the last name of Konrad, Hensley said. He said they did not explain The last four bombs from the Unabomber were mailed from Northern California: Two bombs postmarked in Sacramento exploded in June 1993, wounding one person in San Francisco and another at Yale University in New Haven, Connecticut. A bomb mailed from San Francisco in 1994 killed a New Jersey advertising executive. And a fourth bomb postmarked in Oakland, California, exploded April 24, 1995, killing a timber industry lobbyist in Sac-

Newsweek magazine reported Sunday that Kaczynski approached a grocer in Lincoln in the summer of 1994 to ask about getting a job.

"He said he was running out of funds," grocer Becky Garland told the newspaper. "He said, 'I don't know how to go out and get a job. It's been so long since I've done something like that."

He gave her a handwritten letter that included his difficulties growing up as "a genius in a kid's body and sticking out like a sore thumb in his surroundings as a child," Garland said.



# Sex slave fund falls short of goals

TOKYO (AP)-A governmentbacked campaign to raise money to compensate Asian women forced into prostitution for Japanese soldiers during World War II has fallen short of its goals.

So far, the Asian Women's Fund, set up last summer, has raised 300 million yen (\$2.8 million), spokesman Katsumi Taga said Monday.

Taga said the fund hasn't set a specific target for contributions, but he said the current amount isn't enough.

Previous reports have said the fund wants to raise 1 billion yen (\$9 million).

Historians estimate that as many as 200,000 Asian women - many of them youngsters were kidnapped and forced into sexual slavery at brothels overseen by the imperialist

Many have come forward recently, demanding redress from the Japanese govern-

Their testimonies tell of beatings, kidnappings, repeated rapes by soldiers in front-line cubicles. When the war ended, many were left to die. For decades, the women kept their silence, living in

Fund officials have set July

or August as the deadline for coming up with the money for the women in South Korea, Taiwan and the Philippines. Further efforts are needed to boost donations, Taga said. Donations from labor unions were expected to come in soon,

Taga denied a report published Monday in the Yomiuri sources, that said single payments of at least 2 million yen (\$18,000) each will be made to about 300 women.

"We are in no condition to be able to make such decisions," Taga said.

Taga also noted that many women have rejected the fund because it is officially a private operation. Former sex slaves have demanded that the government take responsibility but it has refused to pay direct compensation.

It was not until 1992, when historical documents surfaced, that the government even admitted it was ivolved in the "confort women" operation. The women have filed lawsuits demanding compensation, but the cases could drag

2 hours and left without inci-The incursions began after North Korea announced on Thursday it would no longer honor the buffer zone, established at the end of the Korean War in 1953.

The North's armed demonstrations were seen as its latest effort to force Washington to negotiate a peace treaty by proving the armistice ineffec-

The two Koreas have never signed a peace treaty, and their border is the world's most heavily fortified, with nearly 2 million troops deployed on both sides.

North Korea insists that the peace treaty be signed between it and the United States without the participation of archrival South Korea. Wash-

The armistice between the Koreas allows each side to have 35 soldiers in the zone at any time, carrying only sidearms. On Thursday, the North called the agreement a "useless piece of paper."

Officials with the U.N. command that monitors the border have played down the incursions. In a statement, the command said that while it was watching the situation closely, it was not particularly "There is not going to be a second Korean War because of this," command spokesman Jim Coles

said on Sunday. As of Sunday, the United Nations had not changed its troop deployments on either side of the zone. South Korea has put its 650,000-strong military on heightened alert, increasing surveillance to its

highest level in 15 years. Most of South Korea's forces, and 1.2 million from the North, are posted along the 151-mile (240 kilometer) border, which stretches across the peninsula.

It is the world's most heavily fortified border, about 30 miles (50 kilometers) or an hour's drive from Seoul, the thriving South Korean capital and its largest city. Each year, thousands of tourists from South Korea and abroad get government permission to visit the observation post just outside the

With North Korean troops only yards (meters) away, they are told not to make sudden movements or threatening ges-

On Sunday, hundreds of tourists - a normal crowd gazed through binoculars out the windows of a large pagoda at Communist troop installations and migrating birds gliding out of a hazy sky.

### US Labor secretary worried at lack of jobs

RAPID change in the world economy has widened the "fault line" of education in the United States, says Labor Secretary Robert B. Reich.

"People with only a high school education, or who have dropped out of high school, are losing ground rapidly," Reich said in an interview in Wash-

"As the old factory jobs disappear, they have little to fall back on, except retail, restaurants or low-wage hotel or hospital jobs, which come with fewer benefits and far less job security.

"At the other end of the spectrum, people with technical skills that are in demand or who have the right professional experience and background are doing exceedingly well. The gap is growing and that could be a profound social problem in this country, unless squarely addressed."

The Clinton administration favors \$2,600 government vouchers for career training for unemployed or low-wage workers and a yearly tax deduction of \$10,000 for education and job training.

After World War II, Reich said, the United States reaped "an enormous benefit" from the spread of international trade. "But over the last 15 years

we've bumped against the fundamental problem of education and skills. As we've moved from the mass production economy to an informationbased economy, education has become the fault line dividing winners and losers."

Jackson, a civil rights leader, said in a telephone interview after leading some 60 people in a "Stop the Violence Prayer."

The 18 men and one woman detained after the beatings were illegal immigrants from rural Mexico, who said they came to seek work. Authorities said the deputies chased the immigrants' truck 80 miles (128 kilometers) to Los Angeles County after it ran an immigration checkpoint in Temecula.

The two immigrants who were beaten - Alicia Sotero Vazquez and Enrique Funes Flores - were released from an undisclosed hospital Friday, the Los Angeles Times reported Saturday.

On Saturday near the Temecula checkpoint, seven suspected illegal immigrants were killed and 19 injured when the pickup truck the men were riding in overturned as it was followed by U.S. Border

Four makeshift crosses were erected at the crash site. One memorial at the ditch where the truck landed consisted of rocks in the shape of a cross. Three other standing crosses were placed amid

taken to three hospitals. Two of the men were in satisfactory condition Sunday at one of the hospitals, a nursing supervisors said. The other hospitals would not release the survivors' conditions.

# Communists seek ties with Church

By DAVE CARPENTER SERGIEV POSAD, Russia (AP) - Atheists in Soviet times, Russia's leading presidential candidates are taking increasingly reverential steps toward religion as the election ap-

proaches. Front-runner Gennady Zyuganov, after watching Boris Yeltsin establish close Kremlin ties with the Russian Orthodox Church, is nurturing the Communists' own links with the influential church.

Zyuganov toured the

church's holiest site at the Trinity Sergius Lavra, or monastery, in Sergiev Posad, north of Moscow. He also met privately with clerics for four hours on Sunday.

An unlikely pilgrim, the leader of Russia's Communist Party insists that Jesus Christ was the first Communist because he wanted social justice for all.

There will be no return to the Soviet policy of atheism if he wins the June election, he assured a questioner with a

"Our program envisions freedom of conscience and maximum respect for everything connected with the history of culture, our traditions, our holidays and our people," Zyuganov, standing alongside a priest, told The Associated

"I came here to be here, to pay tribute, to get acquainted. It's only natural for any sensible person who relies on his spiritual roots."

Coming exactly 10 weeks before the election, the timing of the visit suggested that more than religious fervor might be involved. The balding Zyuganov acknowledged that it was his first visit to "this sacred place" since he was a history student.

Wearing a black leather jacket over his shirt and tie, Zyuganov listened intently but did not cross himself as a black-robed novice with a long beard guided him through the 15th century Trinity Church and around the ancient walled compound of spectacular gold-domed buildings. Hundreds of faithful and tourists visiting on Orthodox Palm Sunday eyed the candidate curiously during his unannounced visit but kept respect-

fully clear.

Last month, Yeltsin publicly declared the rehabilitation of people imprisoned or otherwise punished for their religious activities in the Soviet era. The decree's practical ef-

fect was unclear. Yeltsin, never a churchgoer in his days as a Communist boss, regularly summons Patriarch Alexy II to Kremlin ceremonies and makes highprofile visits to cathedrals.

"By reviving the spirit, we revive Russia," the president said at a church in Prokhorovka, southwestern Russia, during a campaign swing last week.

It's not surprising that the Orthodox Church, which has viewed itself as a powerful pillar of Russian society through the ages, would cultivate top politicians. Even in Soviet times, the church always tried to maintain good relations with those in power. Its rapid reversal of fortune,

however, is stunning. Under Soviet rule, particularly that of Lenin and Stalin, religion was suppressed. Thousands of churches were destroyed or converted to other uses, and many people were persecuted for their be-

Now many churches are being rebuilt, and the Russian and city governments are the driving force behind the estimated \$250 million reconstruction of the huge Christ the Savior Cathedral, which has already become a dominant feature of the Moscow

Many Russians say the project is a tribute to political muscle, not religious faith. Now critics are making similar remarks about the candidates' show of piousness.

"Everybody from Yeltsin to Zyuganov is trying to ingratiate himself with the church in a cheap attempt to get its blessing and more votes from believers," said Gleb Yakunin, a former dissident and defrocked priest.


Such overtures, he said in an interview, have "nothing to do with real religion."

At a Moscow congress three weeks ago, the revived Russian Communists stripped atheism from the party charter and added an article stipulating that members can practice any religion and believe in any god.


Of the turnaround and the Christ-as-Communist claim, the liberal newspaper Izvestia called them "amazing."

"They are trying to convince us that Christianity and Communism have the same values and aims.' the daily said. "All that is deepest delusion."

# Offshore plants gain popularity

By CHARLES J. HANLEY KINGSTREE, South Cutting costs becomes a 'global revolution' Carolina (AP) - Addie Brown, dustrial world. Besides, they like America, had it made.

A hardworking husband. A nice little hometown. Her own job, \$8.50 an hour, with Kingstree's biggest employer, Baxter Healthcare. "I thought I was set," she said.

Then came her lesson in the new economics: Baxter closed. the South Carolina plant, laid off 800 workers and moved production to far-off Malaysia, where young women turn out the same Baxter latex gloves for barely \$8 a day.

And Addie Brown, like thousands of other American workers in the 1990s, wound up a loser in a global race to the bottom line.

Not long after Baxter shut down last November, billboards sprang up in Iowa with a new campaign cry: "Bring the jobs home!" Pat Buchanan's presidential candidacy faded by winter's end, but his slogan will live on through more seasons of discontent as workers in the United States and other industrial countries watch more of their jobs disappear.

In Washington, where some in Congress want laws to pressure multinational companies to "stay home," Labor Secretary Robert B. Reich dismisses the sloganeering.

"It is a myth that international trade has robbed America of its manufacturing industries," he says.

Myth? "What he needs to do is come to Williamsburg County," advises Kingstree Mayor Russell Kellahan.

Economists line up with Reich. Jobs are not a zerosum game in which one side has to lose, they say. Developing countries that win jobs and prosper will buy products - and create jobs - in the in-

say, labor-saving technology is probably killing more U.S.

to low-wage countries. And yet, they acknowledge, something very new is going on out there in the dog-eatdog world, where suddenly all the dogs are capitalist dogs.

"These are revolutionary times in the global economy," concludes a World Bank report on how a transformed world is affecting ordinary workers.

International trade barriers have dropped. Capital, manufacturing technology, expert managers flow freely across borders. Transportation and communication grow cheaper by the day. Perhaps most significantly, half the global work force - China, India, the former Soviet bloc- is suddenly entering the free mar-

Hard-pressed companies in a worldwide market will spot more and more opportunity in wage costs -50 cents an hour in China, for examp

le, against an average \$18 in the industrialized nations.

Klaus Schwab believes in the "win-win" creed of free trade. But the German economist, leader of the annual World Economic Forum, foresees 20 or 30 years of difficult adjustment, as multinational companies thrive on hightech, high-productivity but low-wage operations in developing countries.

While those countries catch up on income, Schwab said in an interview in Geneva, millions of workers in today's industrial nations will "stagnate ... will be the losers."



LONDON (AP) -Jerry Garcia's widow Deborah has sprinkled the ashes of the Grateful Dead lead guitarist into the River Ganges in In-

dia, according to a London news report Monday.

### With landmark run near, epic runner gets honored

(AP)- By the time the festivities honoring his record 61 Boston Marathons entered the final stretch, Johnny Kelley was feeling a familiar fatigue.

"I feel as though I've already run the marathon," said the 88year-old, who finished 58 of the races and won two of them.

On Saturday, Kelley returned to the place where he began each of the runs, this time to pick up another honor.

Officially it was declared Johnny Kelley Day in the town that has served as the starting line for most of the marathon's long history including for this year's 100th running on April 15.

During a special presentation that drew about 1,000 people, the center of the Hopkinton Green where two paths meet was renamed "Johnny Kelley Crossing." Future plans include placing a monument to mark the spot.

Although he has received many honors over the years, Kelley was visibly moved at this one and the amount of attention he received from some 500 students who were on hand to compete in half-mile or one-mile races Sat-

> heart." Four-time Boston Marathon winner Bill Rodgers paid special tribute to Kelley, saying: "For me, Johnny Kelley is Babe Ruth or Jim Thorpe."

Kelley responded: "I love this guy. He's what the marathon should be about.'

Guy Morse III, the race director, said Kelley "is part of the tradition that makes this whole thing unique."

Kelley no longer runs marathons, having retired as a long distance runner in 1992. He will serve again this year as the race's grand marshal, traveling the course by car rather than on foot.

One of the many points he will pass is a statue in his honor; titled "Young at Heart," which sits at the foot of Heartbreak Hill in Newton. It depicts the older Kelley holding the hand of a younger version of himself. Runners touch it for luck as they start up the grueling hill for the last seven miles of the course, which stretches from Hopkinton to Boston's Back Bay.

On Saturday, Kelley also signed T-shirts, posters and other items being sold to help raise funds for a new track and other sports facilities in Hopkinton.

lowing a lunar eclipse. It said the ceremony took place near Rishikesh on the upper Ganges where the river flows out of the Himalayas into the plains.

It said they acted in secret because Mrs. Garcia feared if word leaked out in the United States and Europe about the ceremony, thousands of the American band's fans called Deadheads might have flocked to India and spoiled what was a private occasion.

Garcia died on Aug. 9 last year of a heart attack at age 53 at a northern California drug rehabilitation center and was

The Grateful Dead grew out of an acoustic jug band that Garcia, Weir and others formed in 1965. For three decades, it was one of rock 'n' roll's top-drawing acts. It combined rock, bluegrass and folk influences in its songs, which included "Truckin'," "Casey Jones," "Sugar Magnolia" and "Friend of the


Devil." Deadheads worshipped the Grateful Dead as though its members were tribal gods rather than musicians and followed the band from concert to concert like pilgrims, the paper noted.

"The other band members who stayed behind in California had written farewell mes-

sages to Jerry," The Independent reported from New Delhi. "According to witnesses, Mr. Weir and Mrs. Garcia - the guitarist's fourth wife -poured some of Garcia's ashes on each message before setting it adrift in the currents. Mr. Weir's own paper was blank when he sprinkled on his best friend's ashes."

It said Weir's bare chest was garlanded with marigolds as he stood waste deep in the Ganges and uttered the words: "May you have peace, Jerry, and travel to the stars."

It said the earlier, during the eclipse, Weir had picked up a guitar and begun strumming "Friend of the Devil" but was overcome by grief and could not finish the song.

### AP specialist in business reporting dead at age 84 WASHINGTON (AP) -Ster-

ling F. Green, a Washingtonbased Associated Press reporter who specialized in business and economic news at a time when such coverage was rare, died Sunday in Tarpon Springs, Florida. He was 84 and had suffered a series of

Green had worked for the AP for 36 years when he retired in 1973, earning repeated praise from his boss as "the most all-around valuable man in the Washington bureau."

Green was walking near Blair House on Nov. 1, 1950 when two Puerto Rican nationalists tried to assassinate President Truman who was living there while the White House, across the street, was being renovated. Green dictated the story from a nearby

pay telephone.

He rejected lucrative offers from government and industry to remain a reporter, until he left to join the Washington Forum as vice president of research. He retired there in 1981 and moved to Florida.

Green was graduated from the University of Oregon, where he was elected to Phi Beta Kappa, and became a reporter for the Oregon Journal.

Green married Dorothy Louise Webber of Portland three days before starting his carrer with the AP in San Francisco. After transferring to Washington in 1941, he was put in charge of covering war agencies. He moved from there into his specialty of economics, finance and business. He leaves his wife, two children and two grandchildren.

# Bulls nears NBA record

**NEW YORK (AP)** - It looks like the Chicago Bulls may reach 70 wins with a week to spare.

The Bulls took another step toward eclipsing the best record in U.S. National Basketball Association history by beating the Orlando Magic 90-86 Sunday.

With eight games left in the regular season, the Bulls need just four more victories to reach 70 and outdo the best record in NBA history - 69-13 by the 1971-72 Los Angeles Lakers.

Charlotte, Philadelphia and New Jersey are Chicago's next three opponents, so the Bulls would seem to have a great shot at getting No. 70 next Sunday at Cleveland.

Given the fact that Orlando entered the game with the second best road record in the league, trailing only Chicago's 37-0 mark at the United Center, Sunday's game figured to be as tough as any the Bulls have played this season.

The Bulls had their problems, too, scoring only 15 points in the fourth quarter. But Michael Jordanhit a tough turnaround jumper with just under a minute left to put Chicago ahead for good.

The Magic had a chance to go for the tie or the win in the final 10 seconds, but Anfernee Hardaway missed a driving shot in the lane. Shaquille O'Neal grabbed the rebound, but perhaps thinking the buzzer was about to sound, rushed his follow shot and threw up an airball.

Dennis Rodman got the rebound, Toni Kukoc was fouled and made two free throws and the Bulls had upped their record to 66-8.

"It was a sweet win. We really kind of lost our rhythm in the second half, but we found ways to scrap and win. I think it shows the character of this team," said Jordan, who finished with 27 points in 10-for-30 shooting.

"A win is a win," Jordan said. "Sometimes you escape, sometimes you dominate and you're in

control. I think in the first half we dominated.

The second half we lost control, yet we were able to control it down the stretch."

In other games, the Los Angeles Lakers beat San Antonio 107-97, Utah downed Sacramento 107-92, Denver defeated Houston 111-105, Boston edged Detroit 98-97 and Phoenix beat Vancouver 112-92.

### Bulls 90, Magic 86

In Orlando, Florida, Toni Kukoc added 20 points and Scottie Pippen had 17 for the Bulls, who won their sixth straight game.

The Magic, who won their first 33 home games this season, lost for the third time in their last four home games.

the second quarter. He had been in New Jersey attending the funeral of his grandmother.

'It's unfortunate that we had to lose that game," Orlando coach Brian Hill said. "I thought in the second half we did everything we had to do to win. We said going in that if we held them to 90 points, we would win the basketball game."

Chicago won the season series 3-1.

"When the playoffs begin, what happened in the season series doesn't matter," Hill said.

### Nicklaus wins 100th tourney

SCOTTSDALE, Arizona (AP) -Jack Nicklaus embellished his legend on Sunday, vaulting past Hale Irwin with a three-shot swing on the 12th hole and staying ahead for his 100th pro victory and fourth in the Tradition.

He was the defending champion in the 8-year-old tournament, which he also won on his first attempt, in 1990, and in 1991.

Nicklaus carded his second

straight 7-under-par 65 for a 16under 272 overall, beating Irwin by three strokes.

Irwin began the round at 10-under, one shot ahead of Nicklaus and two up on Raymond Floyd, and reached 15-under by No. 10. But he couldn't overcome three straight bogeys on Nos. 11-13 and shot 69 for 275.

He wasn't the only great to wilt before Nicklaus, who has won 70 titles on the regular tour, 10 as a senior, and 20 others around the world. Nicklaus is driving better than he has in years, and his short game was flawless in the bogeyfree final round.

Floyd had two bogeys and a double bogey in the last five holes of the front nine and needed a strong finish to get back to 281.

PRAGUE, Czech Republic (AP) -Turns out the United States needed more than its third team to advance in the Davis Cup, after all.
