# Panel seeks change in new wage law

THE PANEL tasked with monitoring minimum wage issues in the Commonwealth is seeking some changes in the implementation of the yearly wage increase proposed under Public Law 8-21 According to David M. Sablan
newly elected chairman of the Wage and Salary Review Board, the 10 -member body will soon be recommending a one year waiting period in between projected increases in the Commonwealth's minimum wage.
"As you know, the new minimum wage legislation(Senate Bill

8-146) was drafted in middle of 1992. Its authors then anticipated it to take effect before January of 1993. But when the Legislature took long in passing it, it did not occur to them that there ought to be some necessary adjustments in the timing of such minimum wage increases," said Sablan in a tele-

## Hiroshima-Saipan flights proposed

THE CNMI govemment is currently taking steps to entice international airline companies into providing direct flight service between Saipan and Hiroshima, Japan.

This was the disclosure made by Govemor Larry I. Guerrero when recently asked about current developments in the area of aviation.
According to the governor, the Governor's aviation task force has recently met and recommended that efforts be initiated to establish a direct link between Saipan and the famous Japanese city in the northwestem-mostpart of that country.
"This is an idea worth pursuing because Hiroshima is one of
those cities in Japan with the largestpopulation. Havingdirect flights between Saipan and Hiroshima would definitely boost up tourist arrival figures, not only on Saipan but the two other islands," said the governor
Hiroshimaisone of the twoJapanese cities that were devastated by two atomic bombs used by the United States against Japan during World War II, the other one being Nagasaki.
The bombs that wrought both cities were dropped by the Enola Gay, a US Air Force fighter plane that took off from the island of Tinian.
Guerrero, who was a recent Hiroshima visitor, said he and the governor of the Japanese city had
had initial talks about the possibility of the direct flight link.
He said there was enthusiasm on the idea as it will enhance the relations between the two local governments.
"Hiroshima is a very beautiful place and there is a big group of potential tourists there. It is worth pursuing to promote our islands there," the chief executive said in a recent convesration
According to the governor, among the first ones being invited to service the proposed route is Continental Airlines.
Other airlines will also be enticed to fly the same route, he said.

## Guerrero wants a vote on constitutional convention

REPRESENTATTVE Herman T. Guerrero is proposing to ask CNMI voters in the upcoming November elections whether they want to have a constitutional convention to consider any amendments to the Commonwealth Constitution.
In a letter to the governor Tuesday, Guerreroasked assistance so that the question of a possible constitutional convention could be through a direct vote by the people during the November 6 polls.
"Time is of essence in posing this question to our people. I sought the governor's help be cause it seemed the Senate showed a lack of interest in carrying out its constitutional mandate and duty to adopt House Joint Resolution 8-22," said Guerrero.
Guerrero, who is running for Washington representative this year, introduced H.J.R. 8-22 to take care of the requirements involved in placing the issue of a
constitutional convention through a vote
Article 18, section 2(a) of the Constitution states that the Legislature, by the affirmative vote of the majority of the members of each house, may submit to the voters the question, "shall there be a constitutional convention to propose amendments to the Constitution?"
The same section also provides that the question shall be submitted to the voters at a regular general electionnolater than ten years after the question was last submitted to the voters.
Guerrero noted that on. October 4, 1983, the Third NMI Legislature adopted House Joint Resolution 44 directing the Board of Elections to submit to the voters the question of whether to hold a convention.
Such a question was officially posed to voters on November 6, 1983 as Referendum No. 2. About $76 \%$ of the voters approved of
such an issue.
"As you will note, the 1983 general election was the last time this question was submitted to voters. It is now ten years since that time and as a result, I introduced H.J.R. 8-22, which was subsequently adopted by the House July 9, 1993," said Guerrero.
But according to the San Vicente lawmaker, such a resolution may experience difficulty in the Senate, as indicated by Senate President Juan S. Demapan.
Guerrero said during a previous conversation with Demapan, the latter informed him that the Senate will probably not act on the joint resolution.
"He (Demapan) suggested that I request the govemor's action on this matter pursuant to Article 18 of the Constitution which delegates this authority to the governor in the event the Legislature fails to act on it," Guerrero noted. (RHA)

The new law mandates a $30-$ cent annual increase in the hourly minimum wage from the current

\$2.15, starting 1993, untif it reaches the current prevailing federal minimum wage of $\$ 4.25$ by 1999. Such increase was to take effect every January 1st of each year.
But the bill, which was signed intolaw last June 23rd, contained a provision that says the new law takes effect 180 days after it was enacted, which means the minimum wage will become $\$ 2.45$ on December 21, 1993.
But since the provision on January 1st yearly pay hikes remained intact, another 30 -cent increase (to $\$ 2.75$ ) is being expected on January 1, 1994, notwithstanding the increase effected eleven days earlier.
According to Sablan, the sudden 60 -cent increase in a matter of eleven days may not have been the intent of the Legislature in passing the new minimum wage
"Needless to say, this drastic change will have a devastating effect on individual busimesses and corporations that have executed their contracts basing on the current levels. They might have not even planned for the $\$ 2.45$ basic pay and here comes the $\$ 2.75$ wage coming up after just 11 days. We're worried about the ripple effect such increases would create," said Sablan.
According to Sablan the Board is planaing to suggest certain changes in the existing law so that the effective dates of the planned wage increases be put back, with about one year in between them.
"We would rather recommend that after the December 1993 increase to $\$ 2.45$, the next would come in December of 1994 and so forth, so as to have a period of adjustment that would at least lessen the impact of such increases to the economy," said Sablan.
Sablan, yesterday, was unanimously chosen by the ten-member panel to serve its chairman during an organizational meeting held yesterday at the govemor's office in Capitol Hill. Ellie Friedman of the Department of Commerce andLabor's Economic Development Division was elected vice chairperson.
Other members include David Wiseman, Richard Zsumiel, John K. Riggins, Joe Ayuyu, M. Lee Taitano, Don Conner, and exofficio members Eloy S.: Inos, Frank P. Rosario and Joaquin S. Torres.

The U.S. Department of Housing and Urban Development (HUD) has allocated \$171,000 of HOME PROGRAM funds to the CNMI for FY 93. the funds will be used for residential housing rehabilitation activities, primarily benefiting very low-income homeowners.
Rehabilitation activities include: Providing safe and adequate water storage facilities; construction of septic and/or leaching field; repair or replacement of refrigerator and/or range; provide special features and equipment for handicapped and/or disabled family members; provide typhoon shutters; payment assiatance for connection of necessary utilities; repair hazardous electrical system; repair deteriorating plumbing system; construct additional room(s) to alleviate overcrowding, repair roofs damaged by storms or typhoons; provide additional windows to ensure adequate ventilation; payment for termite and pest control; and cooling systems such as standing and/or ceiling fans.

The Mariana Islands Housing authority (MIHA) "Program Description" for the HOME PROGRAM is available for review by interested persons upon request at the MIHA Central Office on Saipan and MIHA's Field Offices on Rota and Tinian.

MDHA, on behalf of the CNMI government, will provide financial assistance under the HOME PROGRAM primarily through interest bearing loans set at $3 \%$ fixed interest rate with a repayment term of 15 years. Direct grants will be also be made available, but only in situations where the applicant(s) demonstrates a critical need for financial assistance and proven lack of financial resources for loan repayment.

The following eligibility requirements must be met, as a minimum, to qualify for financial assistance:

1. Combined gross income of all persons over the age of 18 .living in the home to be assisted, must be less than or equal to, $60 \%$ of the median area income (FY 93 Median Family Income: $\$ 34,200$ );
2. Must have fee simple or at least a 40 -year leasehold on the property; and
3. Property to be assisted must be principle residence of applicant(s).

Due to the limited amount of funds available, the time period for acceptance of applications will begin on September 15, 1993 and end on October 15, 1993, or for a period of time to allow for the receipt of 30 applications, whichever comes first.
Following closing date or acceptance of the 30 applications, all applicants will be processed for eligibility and a listingof eligible applicants will be prepared. Recipients will them be randomly selected among the eligible applicants by drawing of lots.

## IMF reports almost stagnant world economy

WASHINGTON (AP) - The International Monetary Fund reported the world economy almost stagnant last year, but with brightening prospects in the western hemisphere, southeast Asia and the Middle East.
Its annual report, covering the 12 months that ended in April, found production in the United States and other industrial countries rose by only 1.5 percent, up slightly from .5 percent in 1991. Taking into account population growth, that meant only a few more goods for the average citizen of those countries.
The report was made public Tuesday.
Third World countries on the whole improved their production more quickly than the industrial world. Their 6 percent increase was about twice as high as their population growth.
But production dropped heavily again in countries of the former Soviet Union and its allies. Poland, which showed a small increase, was the exception.
"Real (production) is estimated to have fallen in the (former Soviet Union) by nearly 20 percent in 1992, but in some states output losses have been greater," the report said.
In addition to problems of conversion from the Communist system to a market system, the fund blamed political unrest, uncertainty about reforms, and failure to stabilize finances.
Production growth in Africa already well below the growth of population there - continued to

decline in 1992 as it has done since 1990.
Though the report made no predictions, some of it appeared to foreshadow improvements. In a summary of a meeting held in April by directors representing the 178 member governments, it said:
"Most Directors felt that the natural forces of recovery were taking hold in the United States."
They met in July to talk about Japan. They praised Japanese authorities for their packages to spur the economy in late 1992 and early 1993, and for what they called an excellent performance in keeping prices fromrising. But some directors called for further easing in Japanese monetary policy whileothers suggested caution in further reduction of interest rates.
The Japanese are now planning an additional stimulus package.
Most directors predicted a decline in the huge Japanese sumpluses of exports over imports, surpluses which have worried US and European authorities.
The report noted that world trade grew by 4.2 percent last year, that interest rates and prices paid by consumers were down. Prices rose more slowly than in past years both in Third World countries, by an average of only 8.7 percent, and in industrial countries, 3.2 percent. But the 1992 increase in the former Soviet Union was 1201.8 percent.
That meant people in those 15 republics on average had to pay more than 1,200 rubles at the end of the year for a purchase that would have cost them only a single ruble on Jan. 1.
IMF officials, who insisted on remaining anonymous, wouldnot speculate on prospects for an additional $\$ 1.5$ billion loan sought by Russia, pr on indirect aid to the Palestine Liberation Organization. One official pointed out that the fund has so far lent only to member states, and the PLO isnot recognized as a state.
The report said the Middle East as a whole made a strong recovery from the Gulf War.
It called China's rise in production dramatic and noted strong growth in Bangladesh, India and Pakistan, as well in Latin America outside of Brazil.

WASHINGTON (AP) - President Clinton and Australian Prime Minister Paul Keating warned West European countries Tuesday against reopening an agreement on reducing farm subsidies.
The two leaders agreed at a White House meeting that "a top priority for both countries" is the successful and balanced outcome by December to the seven-year global trade talks in the interest of freer trade and more jobs, the president told a joint news conference.
"The prime minister and I strongly urge the European Community not to reopen the Blair House accord on agricultural trade, as has been suggested," Clinton said. "We need to move forward, not backward."
The so-called Blair House accord was an agreement reached with the 12 -nation European Community last November dealing with the reduction of European farm subsidies:
French officials have vigorously opposed the agreement and urged that it be renegotiated. Clinton's administration has insisted that large cuts in subsidies are critical to completion of the long-stalled global talks known as the Uruguay Round.
Keating seconded Clinton's assessment, waming that reopening the Blair House agreement "seriously risks jeopardizing" the trade talks overall.
"Frankly ... I don't think the Europeans can let the French decide" that the round should fail,
will want to carry the odium of the round failing at their expense."
The two leaders said they take strong positions in upholding human rights with countries such as China and Indonesia. But that should "not undermine our relationships, commercial and political, with countries that we think are making an honest effort to shoot straight with us and to work with us," Clinton said.
Keating said neither Australia nor the United States "will ever compromise its shared sense of democracy, commitment to human rights and respect for human values" but such issues still must be treated as "part of a total relationship" with countries such as China and Indonesia.
Democracies need to influence such countries on vital matters like weapons proliferation and "the influence may be diminished if the totality of the relationship only devolves to human rights questions," the Australian leader said.
Clinton said both Australia and America have questions about the treatment of the former Portuguese colony of East Timor by Indonesia, which he described as "one of the most underestimated countries inthe world" in terms of size and economic pqtential.
The meeting between Clinton and Keating had been postponed a day because of Monday's White House signing ceremony for the Israeli-Palestinian peace agreement.
Clinton praised Keating for his role in helping put together the
eration conference in Seattle that is scheduled for November.
Secretary of State Warren Christopher and other US officials also participated in the White House talks. Keating arrivedSunday on the long-planned Washington visit, hes first as prime minister.
Clinton spent Monday with Israeli and Palestinian leaders and other dignitaries involved in the Middle East developments. Keating did not witness the Middle East signing but spent the day in talks with US Trade Representative Mickey Kantor, Treasury Secretary Lloyd Bentsen, Agriculture Department officials and members of the House Foreign Affairs Committee.
His Tuesday schedule included Clinton, Christopher, Senate Majority Leader George Mitchell, Minority Leader Bob Dole and Defense Secretary Les Aspin. Australia, which had a $\$ 7$ billion trade deficit with the United States last year, complains that subsidizedUS grain exports have cut deeply into Australian markets.
The two countries plan negotiations here next month over efforts to limit the number of passengers American air carriers may carry between Australia and Japan on through flights to and from the United States. Australia has accused Northwest Airlines of exceeding its traffic rights at Osaka and United Airlines has protested limiting Tokyo passengers on its proposed New YorkSydney route.

## Dollar mixed as new data show economy growing sluggishly

NEW YORK (AP) - The Ameri can dollar finished mixed against major currencies on Tuesday as economic statistics failedto budge the market from its perception that the US economy is "going nowhere fast," as one trader put it:
Gold prices rose domestically and were mixed overseas. On the New YorkCommodity Exchange, gold for current delivery closed at $\$ 344.80$ a troy ounce, up $\$ 2.10$ from Monday. At 4 p.m. (2000 GMT), Republic National Bank of New York quoted gold at $\$ 344.80$ a troy ounce, an increase of $\$ 1.30$.
The dollar leaped Tuesday moming after the Labor Department said the August consumer price index rose 0.3 percent, above the 0.2 percent gain predicted by analysts.

Higher inflation is seen as an indication that US Federal Reserve Bank is less likely to lower
interest rates. Such cuts usually hurt the value of a currency since investments in that currency earn less.
After the dollar rose, currency traders sold it, locking in profits, traders said.
The enthusiasm for the dollar waned, however, as investors determined the inflation figure and August retail sales statisticsshowing a modest 0.2 percent gain didn't reflect much change.
"It kept the market very much in an unchanged mood. That is, that the US economy is going nowhere fast," said Erik Nickerson, a foreign-exchange economist at Bank of America.
The dollar may have been sold by European central banks, which have steadily been selling stockpiled dollars and buying German marks to repay the German central bank for its loans during the European exchange-rate crisis in

American to cut a total of 5,000 jobs by end of 1994
NEW YORK (AP) - American Airlines plans to accelerate its shrinkage by cutting a total of 5,000 jobs by the end of next year, retiring more jets and eventually selling assets such as maintenance bases, the company's chairman said Tuesday.
The airline plans to cut a total of 5,000 jobs, or 5 percent of its work force, between now and the end of next year, Chairman and Chief Executive Robert L. Crandall told reporters and Wall Street analysts. The total figure includes management job cuts of less than 650 workers announced earlier, the company said.
Overall next year, the airline is scheduled to reduce its capacity to fly passengers by 4.5 percent, Crandall said.

The airline plans to retire 11 more DC-10s in addition to the 31 already planned for grounding, he said. The airline aims to cut costs and compete with the likes of Southwest Airlines and its imitators.

American Airlines also plans to reduce some of its transatlantic ilights this winter, Crandall said. Crandall said that he would be willing to consider any offer for any asset at the airline.

## Budweiser to tap Japanese beer market <br> By SETH SUTEL.

TOKYO (AP) - Antheuser-Busch Inc. is preparing to pablicly anncunce a joint venture with Japan's No. 1 beer maker, Kirin Brewery Co. Lld., in order to tap further into one of the world's biggest beer markets.
Anheuser, the word's biggest brewer, is cropping an affiliation with a smaller brewer, Suntory Ltd to link up with Kirin. The US brewer is the biggest foreignbeer inJ apan, yethasonly a 1.2 percentmarket share.
Anheuser is also hoping to take advantage of recent moves to deregulate the akcohol industry by becoming the first foreign brewer to set up is own distribution network.
First deliveries of Budweiser to retailers will start Friday.
"Bud's chances in Asian markets are very, very big - especially in Japan," says Shuichi Shibanuma, food and beverage analyst at Morgan Stanley (Japan) Ldd.
Anheuser-Busch had relied on Suntory, Japan's largest whiskey maker but a lightweight in the beer business, to brew and market Budweiser under license since 1984.
Bud sales had been growing, but not at the rate one might expect for the world's top brand.
The S. Louis brewer hopes to change all that with the deal to be announced Thursday - a joint venture owned 90 percent by Anheuser and 10 percent by Kirin, which controls half the domestic beer market and is the fourth biggest brewer worldwide.
The new company, Budweiser Japan Co, will import canned beer from the United States and sell botles and kegs made under license by Kirin More importanly, it will hamess Budweiser's advertising prowess and set up its own distribution network.
That would have been unimaginable several years ago, but rapid changes in the rigidly controlled alcohol business might just give Budweiser a fighting chance.
With deregulation making it easier to get a liquor license, discount liquor stores have been popping up every where, and even supermarkets and convenience stores are starting to carry beer.
Unlike the traditional mom-and-pop stores that still sell much of the beer here at prices fixed by the major brewers - Kirin, Asahi, Sapporo and Suntory - the larger retailers are starting to shake things up by cutting prices and carrying more brands.
Experts say those factors could help Budweiser make it into the tighly knit distribution system, but the going will be tough. Even with the muscle of mighty Kirin behind them, many wholesalers are likely to initially resist Bud's advances.
"Budweiser has to convince Japanese wholesalers that they're trustworthy," says Atsushi Hamaguchi, who heads the imported wine and beer department for Hiroya Co., a medium-sized wholesaler.
As deregulation makes the market more competitive, Kinin will benefit from Budweiser's proven marketing prowess, analysts said.
A standard 10.5 -oumce ( 294 grams) can of beer goes for more than $\$ 2$, although half of that goes to tax, and the overall beer market is one of the few in the world that is still growing.
Beer sales grew about 7 percenteach year from 1989:10 1991 , and the market is now worth aboul $\$ 25$ billion. The recession cut sales growth to 2 percent last year, and cool summer weather this year is likely to make things worse, but the long-term trend is still upward.

Stock market closes lower

NEW YOORK (AP) - The stock marketfollowed bonds lower Tuesday, after a higher-than-expected reading on inflation.
The Labor Department said US consumer prices rose 0.3 percent in August, above the 0.2 percentmany private economists had forecast.
Thatnews, combined with aseparate report showing surprisingly strong retail sales last month sent bonds sharply lower. Stocks have followed bonds for months because the low interest rates that come with higher bond prices make the potential returns from shares more attractive.
The Commerce Departmentsaid US retail sales rose 0.2 percent in

August, the latest in a five-month string of increases and higher than the flat sales many analysts had expected.
Bonds don't like indications of stronger-than-expected growth because that carries the threat of inflation, which erorles the value of fixed-income securities such as Treasuries.
Stocks ended mostly higher abroad. In Tokyo, the 225 -issue Nikkei Stock Average fell 0.9 percent. But in London, the Financial Times-Stock Exchange 100 -share indexrose 0.1 percent, in Frankfurt stocks ended 0.4 percent higher and in Paris, they rose 0.7 percent.
Many computer stocks fell again

Tuesday. Gold stocks, which have been losing ground lately, were higherfollowing the inflationnews. Many people consider gold and gold shares hedges against inflation. The Dow Jones industrial ayerage fell 18.45 points to 3,615.76.
Declining issues sumumbered advances by about 2 to 1 on the New York Stock Exchange, with 1,328 up, 678 down and 606 unchanged.
NYSE volume totaled 258.62 million shares as of 4 p.m. (2000 GMT), against 243.44 million in the previous session.
The NYSE's composite index fell 1.09 to 254.97.

WASHINGTON (AP) - Daily doses of beta carotene, vitamin $E$ and selenium reduced cancer deaths by 13 percent in a study conducted in rural China by US researchers.
The five-year study, involving 29,584 people in an area where cancer rates are among the highest in the world, showed that some vitamins and minerals can be of benefit against cancer, according

* to the National Cancer Institute researchers.
"The study is the first randomized trial to show a significant reduction in cancer in a population supplemented with vitamins andminerals," Dr. William J. Blot said Tuesday.
Blot added, however, that the results "don't automatically trans late to the situation in the United States."
Blot and.other NCl experts also said the single study does not present conclusive proof that vitamin and mineral supplements, such as in vitamin pills, are protective against cancer.
"At this point in time, NCI rec-
ommends that Americans eat a well-balanceddiet, low in fat, high in fiber, with plenty of fruits and vegetables, as a way to maintain good heal thand to reduce the risk of cancer," said Dr. Peter Greenwald, director of the division of cancer prevention and control at NCI. "We do not have a recommendationnow for vitamin and mineral supplements."
The population studied, in four communes in a farming area of Northern China, gets less nutrition than most Americans, and has a much higher rate of cancer, Blot noted. As a result, he said, it is impossible to draw a scientifically accurate conclusion that the vitamins that lowered cancer incidence and overall death rates in China would háve a similar effect in the United States.
"We feel they do offer a hopeful sign," said Blot. "It strengthens our growing knowledge of the relationship between nutrition and cancer."
The study was conducted in an area of China called Linxian, about 300 miles south-southwest of Beijing, the capital. The people in the area are mostly farmers

Epidemiologists have long been interested in the area because of its extraordinarily high rate of cancer, particularly cancer of the esophagus.
Deathrate fromesophageal cancer among people aged 40 to 69 in the US is 5 to 19 per 100,000 . In Linxian, the rate is 470 per 100,000 amongpeople of the same age.
In cooperation with the Chinese government, NCI researchers arranged for a study group of almost 30,000 adults, aged 40 to 69. They were divided into groups that received different combinations of vitamin supplements or placebos. Blot said the vitamin and nutrient doses were up to two times the US recommended daily allowance.

The vitamin groups were:
_Retinol, a form of vitamin A, and zinc, which helps metabolize retino $l$.
_Riboflavin and niacin, two B vitamins.
_Ascorbic acid, which is vita$\min \mathrm{C}$, and molybdenum, a nutrient.
_Beta carotene, a form of vita$\min \mathrm{A}$; alpha tocopherol, a form of vitamin $E$, and selenium. These are all considered anti-oxidants which are thought to help prevent damage to DNA in cells.
Some people received all of the vitamin groups, while others received different combinations of the groups. In this way, the benefit of the specific vitamins could be analyzed, Blot said.
At the end of five years, three months, Blot said the group receiving beta carotene, vitamin E
and selenium"showed significant benefits."

Total death rates, from any cause, were down 9 percent in this group and cancer mortality dropped 13 percent, he said. Stom ach cancer deaths were reduced by 21 percent and stomach cancer was down by 16 percent, when compared to those in the study taking other combinations of vitamins.
Beta carotene is found naturally in fruits and vegetables that have a yellow, orange or dark green color, such as carrots, squash, yams, peaches and broccoli.

Vitamin E is naturally in vegetable oils, nuts and whole grains Selenium, a mineral, is found naturally in seafood and liver. Seed foods grown in soils rich in selenium also contain the mineral.

The Wage and Salary Review Board was created under P.L. 821 to function in an advisory capacity with regards to issues dealing with the minimum wage and hour laws of the Commonwealth. The Board's members serve for a term of two years.
The Board's duties and responsibilities are:
-monitor macro-economicconditions in the CNMI;
outilize as a guideline, the criteria developed by the Minimum Wage Study Commissioninmaking a comprehensive study of the social, political and economic ramifications of minimum wage issues in the Commonwealth;
-subject to appropriated funds, hire the necessary staff and commission economic studies to be performed locally or in cooperation with the federal government;
-accept and apply for federal grants related to Wage and Salary Board duties; and
-by way of an annual written report to the Legislature and the governor, makerecommendations to change the provisions of the Minimum Wage and Hours Acts as presently constituted or amended.

## US black workers hit hardest by job losses <br> By Sonya Ross <br> Employment Opportunity Com- <br> corporate America that they had

WASHINGTON (AP) - Black workers were the only group to experience a net loss of jobs during the recession of 1990-1991, according to an analysis of govemment laborrecords by The Wall Street Journal.
Black workers lost 59,479 jobs from July 1990 through March 1991, after three years of gains, the newspaper said. Black employment fell at six of nine major industry groups.
The Journalreported that Asians gained 55,104 jobs during this same period, and Hispanics gained 60,040 jobs. Whites gained 71,144 jobs, although they outnumber blacks nearly eight to one at the 35,242 companies surveyed.

The Journal studied employment changes at the companies, which filedreports with the Equal
mission for more than 40 million workers in 1990 and 1991.
It found that some large corporations disproportionately shed black workers. Especially hard hit were blacks in blue-collarjobs. They lost nearly one-third of the 180,210 blue-collar jobs that disappeared during the recession. And while the economy added 53,548 service-industry jobs; blacks lost 16,630 jobs in that sector.
Companies blamed the shift on the fallout of corporate downsizing, saying they had no idea the impact on workers would be so disparate.
But blacks say the Journal's findings prove their long-held belief that they suffered disproportional job loss in the past few years.

## Revived Karpov beats Timman in game 6 of FIDE championship

ARNHEM, Netherlands (AP) - Playing his best chess of the match, Anatoly Karpov trounced Jan Timman Tuesday and regained the lead in the FIDE international chess federation championship match.
The sixth-game victory gave Karpov a lead of 3-1/2 points to 2-1/2. .
The game came to a swift climax with both players in time trouble, needing to make 21 moves each in just half an hour. Butitwas Timman, play--
ing black, who cracked first, as he allowed the Russian ex-world champion to start an attack and outmaneuver him on the king's side.
Timman's defense crumbled as Karpor chased the black king around the board with his queen and rooks, and the Dutch grandmaster resigned in a hopeless position on move 33.
The match moves to Amsterdam Friday with game 7 at City Hall in the Dutch capital. The first 12 games are being held in the Netherlands, and the last 12
in the Gulf sultanate of Oman.
Although the match is for the FIDE world title, a rival championship is being held concurrently in London between defending champion Garry Kasparov and Briton Nigel Short, who bolted to form their own federation. Kasparov won the fourth game Tuesday and leads 3.
The first player to reach 12 ( points in the FIDE contest wins $\$ 875,000$. The loser gets $\$ 735,000$.

Promoter believe ringside judge exceeded his powers

NEW YORK (AP) - Pernell Whitaker's pkomoter, believing a ringside judge exceeded his powers, says his fighter should be made the winner of last week's WBC welterweight title bout with Julio Cesar Chavex.
Dan Duva has asked the Texas Department of Licensing and Regulation, which oversees boxing in the state, to take such action regarding Friday night's draw in San Antonio
A department spokesman said no action could be taken until.a formal complaint is filed.
The controversy concerns the sixth round when Whitaker threw a low body punch. Referee Joe Cortez stopped the bout for 30 to

45 seconds to allow Chavez to recover, but didnotdeductapoint, obviously considering the low blow unintentional.
Itwas a big round for Whitaker. Judges Franz Marti of Switzerland and Jack Woodruff of Dallas each scored it 10-9 for Whitaker, while Mickey Vann of England scored it 10-9 for Chavez.
James Lawton, writing in the Daily Express in London, quoted Vann as saying. "The referee didn't take off a point, but I thought it had to be done."
Ken Gorman of the Daily Star of London also quoted Vann as saying he deducted a point making it $10-9$ for Chavez rather than a 10-10 round.
Boxing rules stipulate worldwide that the only one who can
take a point away is the referee.
Vann, speaking by telephone from England, told The Associated Press he did no such thing.
"I deducted no points on any round and I told no one that I deducted a point," he said. "I gave it an even fight (115-115). Mr. Marti scored it an even fight. If Mr. Woodruff had given Chaven just one other round, he would have had it an even fight. That's how close it was.
Marti also scored it 115-115, while Woodruff scored it 115113 for Whitaker.
In a poll of 16 ringside reporters conducted by New York Newsday, 14 thought Whitaker won and two called the fight a draw. Three of the writers favorIng Whitaker were Juan Carlos

Gutierrez of Excelsior (115-114), Carlos Rivero of Uno Mas Uno (116-113) and Carlos Hernandez of La Journada (116-114)
"We seek to overturn the erroneous decision in order to ensure Whitaker's rightful place in boxing history as the first man to 'officially' defeat the 'unbeatable' Chavez," Duva said Tuesday.
Although he failed to win a fourth worid title, the draw kept Chavez unbeaten, with an 87-0-1 record. His super lightweight title was not at stake.
Duva's lawyer, Pat English, protested the scoring in a letter to Elvis Schultz, counsel for the Department of Licensing and Regulation.
"There is no discretion given for a judge to unilateralliy deduct
points under the Texas Boxing Act and Administrative Rules,' he wrote, noting the WBC rules are identical.
"As the bout was held under the auspices and authority of the Texas Department of Licensing and Regulation, we request that the commission correct the objective error and correct the score of Mr. Vann in accordance with the Texas Administrative Code."
The department's Jack Garison said no investigation has begun and a complaint form was being sent to English.
"We have to have a complaint form before we look into it," Garisonsaid. "The letter indicates wè ought to change the score without a hearing, but we are not going to do that."
