Lorrin Andrews Takes Wife and Leaves Islands

Head of Republican Territorial Committee and Department Leaves Vacancy to be Filled in March.

SAN FRANCISCO, Dec. 30.—Lorrin Andrews of Honolulu yesterday obtained a license to marry Miss Amy S. Busby of Yakima, Washington. Andrews gave his age as 49 and Miss Busby's is given as 21. The wedding is scheduled for noon today at the Hotel Bellevue and the couple will leave tonight for a honeymoon in Southern California.

Andrews has told associates that he has left Honolulu for good and intended to enter the practice of law in Los Angeles where he had already made arrangements to that end. He said he had turned his Honolulu law practice over to W. B. Pittman, his former partner.

HONOLULU, Dec. 30.—Miss Busby has been here for some time working as a stenographer. She went to the mainland on the same steamer with Andrews.

John Wise, acting chairman of the Republican central committee in the absence of Andrews says that if Andrews does not return to the Islands by March he will call a special meeting of the committee to elect a new chairman as he does not wish to serve in that capacity.

New Low Levels for Raw Sugar Reached

New low figures for raw sugar were reported by the Associated Press yesterday the New York market quotation sinking to 3.39. Refined sugar shared in the decline and was quoted at 4.80. San Francisco dispatches by the same news agency said other refineries quoted fine granulated at 5.20 and California-Hawaiian quotation was 4.65.

Yesterday's declines followed weakness displayed on Wednesday which the Associated Press reported. Refined sugar broke below 5 cents for the first time in several years, due to continuous weakness of raws with further declines to 1.6 in old crop Cuba. Other sales were made on a basis of 1.84 f.o.b. Cuba, the lowest price in ten years.

Waimanalo Increases Its Capital Stock

HONOLULU, Dec. 30.—Stockholders of Waimanalo Sugar Company yesterday voted to increase the capitalization of the company from \$250,000 to \$1,000,000. Three quarters of the total will be issued now and one quarter will be retained in the treasury.

Outstanding stock of the company will be replaced share for share and an additional \$500,000 will be floated, offered to present share holders first pro rata, two for one.

The charter of the company was also amended.

Ex-Policeman Charged With Grave Offense

Charged with an offense against the person of a little girl, less than four years of age, Joe Gonsalves, a former Maui policeman, is in the county jail, held to await the action of the grand jury which will meet next month, January 9. Gonsalves was given a preliminary hearing Tuesday in the Wailuku District court.

Evidence offered at the hearing tended to show that the defendant attacked a little girl who lives with her parents near Kihel. In his own behalf he said he was drunk at the time of the alleged offense and knew nothing about it until he was awakened and arrested by the sheriff at 1:45 in the morning in a back room of the home of the little girl's parents. Other evidence showed the prisoner to be an habitual drinker to excess of okolehao.

The police department says that Gonsalves was dismissed from the force about eight months ago on charges of drunkenness and conduct unbecoming to an officer.

Music Department Rehearsal—It is announced that the next rehearsal of the music department of Maui Woman's Club will be held on Friday January 6 instead of Thursday, January 5. The reason for the change of date is that the use of the Territorial building is required by the Fair and Racing Association for its annual meeting Thursday. The hour of the music department's meeting is unchanged from 3 o'clock. Members are requested to pass the news along.

Fancy Dress Ball Is Chief Attraction On Eve of the New Year

Maui's biggest social event of the year, the annual Fancy Dress Ball of the Maui County Fair & Racing Association will be held in the Territorial Building on the Fair Grounds at Kahului tomorrow evening, beginning at 8:30 and preparations have been made for a larger attendance than last year.

Work of decorating the hall was started today under the direction of Mrs. J. T. Fantom whose artistry in the arrangement of decorations has become well known in Central and East Maui. C. P. Ludin is arranging the electrical effects and all the prizes with the exception of the chief prize for the best dressed couple have been selected. For that prize there are a dozen articles of electrical equipment in the window of the Maui Electric Company, ranging from an electric oven to a curling iron, from which the winners may choose. All of the preliminary arrangements, even down to the purchase of liberal quantities of noise makers and confetti, are complete, Chairman Joe Meinecke said yesterday.

It is expected that the award of prizes will have been announced before 10:30 tomorrow evening the parade of contestants or grand march during which the selections are to be made to be started at 9:30 which will give the judges a full hour to come to an agreement. Mr. and Mrs. Moir will lead the grand march.

At 11:30 the noise makers and confetti will be distributed and at 12 o'clock sharp, official time, "Happy New Year" will blaze up electrically and then the fun will be at its height. Music and dancing will continue about an hour longer.

Visit of Navy Boys to Maui Is Filled With Good Times

Full of enjoyment was the trip of the Navy football players to Maui according to the story of it which appeared in the Pearl Harbor Athletic Club Weekly in the last issue of that little paper that will be issued. The article tells of sight seeing and entertainment in addition to the game and follows:

"Accompanied by the R-20 and Eagle-58 the football team journeyed to Maui last week-end for what proved to be a trip long to be remembered.

"Both ships left Pearl Harbor Wednesday night. Most of the travelers steered shy of the submarine, but after clearing Diamond Head in the Eagle everybody wished they had taken the sub instead. Even "Buck" Taylor had to take to the rail.

"The team arrived at Kahului, Maui a little past 9:00 a. m. Thursday. Through the kindness of Mr. Walsh, superintendent of the Kahului Railroad, a special train was furnished which took the members as far as Paia. There special trucks, furnished by Mr. Harry Baldwin, were waiting to carry the team up the mountain to Luana, the mountain house of Mr. D. B. Murdoch and Mr. Will Baldwin, two prominent citizens of Maui.

"After a precarious upward climb over slippery mountain roads on which all hands often had to "get out and push," the team finally got to Luana at sunset.

"Luana is situated on the side of Haleakala 5,000 feet above sea level, and commands a wonderful view of the country below. Everybody slept under two blankets that night.

"Friday morning fifteen of the more energetic began a climb to the top of Haleakala, 10,000 feet above sea level, to see the extinct crater. It was some climb, but those who took it felt well rewarded for their efforts. The hikers slept at the crater rest house that night under three blankets. The descent started Saturday morning. The remainder of the day was spent at Luana.

"Sunday morning trucks arrived to take the team down to Paia, where a train was waiting for further transportation to Wailuku.

"Sunday afternoon on the Wailuku gridiron a game was played against the Maui All-Stars. Maui held us to an 0-0 score first half, but in the second period Navy opened with her big guns and piled up 20 points. From a view of clean and fair sportsmanship the game was everything that could be asked. Maui put up a game fight against heavy odds.

"After a dinner at the Grand Hotel in Wailuku the team returned to Kahului. The R-20 arrived at Pearl Harbor Monday morning, with part of the team. The Eagle-58 brought the remainder along Tuesday morning.

"The trip was a complete success and the team desires to express its appreciation to the management of the P. H. A. C. and to the people of Maui who made the trip possible. "Maui No Ka Oi."

STUDENT PLAYERS AND "YELLOW JACKET" WIN MAUI'S PRAISE

Delightfully attractive, charmingly produced was "The Yellow Jacket" as presented by the Chinese Students Alliance of Hawaii to an audience which filled every chair in the Kahului Theater, Wednesday evening and was repeated to a practically capacity house in the Pioneer Theater at Lahaina last evening. It will make its third and final Maui appearance at the Wailuku Hippodrome tonight.

None of the large audience at the Kahului theater, Wednesday evening wonder how it is that "The Yellow Jacket" has been produced so many times and always to a crowded house in Honolulu. With the excellent acting of the east, the marvelously beautiful costumes and settings and the interest and charm of the play, it could hardly be otherwise. Certainly it is one of the most worth while offerings that has ever come to Maui.

Novelty Lends Charm
A Chinese play, produced in English but according to the manners and customs of the Chinese dramatic art is what "The Yellow Jacket" actually is. Hence criticism of it is an unusual and a difficult problem. It must be remembered at the outset that each actor is, as a matter of fact playing not the part that he or she is cast for according to the program but is actually playing the part of a Chinese actor or actress cast for such part in the play. It is that fact that makes the acting of the young Chinese student players the more remarkable. In reality each was cast for a composite role, the actor in a Chinese play and the character such Chinese actor would be seeking to present.

It is easy to forget that the youthful actors are amateurs, so polished is the performance and a particularly noticeable feature is the unusual clarity of enunciation by each member of the cast. It is not surprising that letter perfection in lines is there after so many performances together though such uniform histrionic ability in so many young folk does provoke admiration. And the candor of the play, the way each one speaks out with evident close adherence to truth his or her innermost thoughts, lends to the play a naivete that is most appealing.

Perfectly Balanced Cast
Each player is admirably fitted to his or her part but as in every play there are characters which give greater opportunity than others, the leads, individual criticism then becomes still more difficult. There was a charm to Tso as played by Miss Lucy Seong that made the audience regret her early removal from the play by deapitation. As Chee Foo, the kind mother, who sacrifices herself that her child may live and attain greatness and lets out her life blood for him, Miss Ah Hee Yong, rose splendidly to the occasion and furnished some really dramatic moments. Lawrence Lit Lau as Wu Hoo Git, full of buoyancy and eagerness of youth, the hero of the play, filled his part to perfection and R. C. Tong as the aesthetic usurper of the hero's throne, the villain of the play showed genuine cleverness. The chorus, played by Jen Fui Moo, who tells all that is to happen in the play, "modestly" assumes all credit and responsibility for it and finally admits even its authorship furnished comedy moments that took his audience off their feet. Beatrice Chong, as Plum Blossom is a charming ingenue, as the bride to be of Wu Hoo Git. The property man, James Chung was a difficult piece of well executed pantomime comedy.

And these are but a few of the outstanding features and the only reason that others did not shine with equal brilliancy as those particular stars was that the opportunity was not their's for each filled his or her particular niche in the play perfectly.

Costumes and Music
Beauty and gorgeousness of the costumes, robes and trappings woke admiration and delight and are a feature of the production not to be overlooked in favorable criticism nor is the entre act singing which drew round after round of applause and between the second and third acts received an enthusiastic encore.

It was a thoroughly pleased crowd that fled out of the theater after 11 o'clock and on all sides were heard remarks commending and thanking the United Chinese Club of Maui and the committee on arrangement for the giving of the opportunity that was so much enjoyed.

Further Armament of Hawaii Regarded As Insincere—Mochizuki

(ASSOCIATED PRESS)
HONOLULU, Dec. 30.—Increase in the fortifications of the Hawaiian Islands would indicate insincerity on the part of the United States is the expressed opinion of K. Mochizuki, leader of the opposition party in the Japanese diet who arrived here from Washington yesterday, a passenger on the Siberia Maru.

In an interview to the press Mochizuki said that the success of the Washington conference has laid the cornerstone for peace in the Pacific. We must go on and lay the cornerstone for peace in the Atlantic and establish its certainty there the same as in the Pacific.

Although satisfied with general results of the conference Mochizuki said, "as a member of the Japanese parliament I can hardly say that I am satisfied with the manner in which the Japanese delegation has conducted itself, especially as regards the Chinese and other Far Eastern questions."

He said the prospect is that fortifications of Hawaii will be left unchanged and that he believed any increase would indicate insincerity on the part of the United States. "A large Hawaiian armament would be a menace to Japan owing to the possible misunderstanding that might arise in the minds of the Japanese because Hawaii is the gateway of the United States toward the East. Under present conditions there is no possibility of a blow from or at here from either side."

China Is Urged to Boycott Japanese

WASHINGTON, Dec. 30.—General boycott of Japanese goods by China is urged in a message sent to China from representatives of seven societies here. Action followed a formation of a provisional organization here and the watching of the course of the conference that assembles November 11 and is still discussing armament limitations.

The cablegram dispatched urges upon China and its people a boycott of Japanese goods and services "to show righteous indignation against Japan's aggressive policy" and adds that Japan "has adopted a policy of obstruction against China's aspirations and has shown unwillingness to make amends for the wrongs it has done China."

Important Decision Will Be Made Soon

HONOLULU, Dec. 29.—Attorney General Harry Irwin announces that a decision affecting the payment of territorial income taxes by sugar plantations will be handed down shortly after the first of the year which will clean up five doubtful points covered by test suits brought by Ewa and the Hawaiian Sugar Co. of Kauai, the other plantations having agreed to abide by the decision reached in those cases.

Among the points at issue are whether loss on the sale of bonds is deductible, whether income derived from mainland investments is taxable, whether contributions to the Oahu strike losses may be deducted in 1920 only or extended over a period of three years, whether increased value of leases can be considered depreciation and whether the loss on stock sold under the reorganization plan for California-Hawaiian Crockett refinery is deductible.

W. W. WRIGHT DIES

HONOLULU, Dec. 30.—W. W. Wright Jr., overseer of Makaweli plantation, Kauai, died yesterday according to advices received here.

Wright came to Hawaii from Australia when two years old. During the world war he served with the British forces. Two months ago he married Miss Bertha Ebeling, formerly of Hilo.

Submarines Are Vexing Problem At Conference

One Resolution Adopted In Principle and Second Considered. France Upsets Plans by Her Stand.

WASHINGTON, Dec. 30.—Submarines and their uses came before the full naval committee of the conference for the limitation of armaments at yesterday's session and two important resolutions were considered, one being adopted in principle and the other left for further discussion. Both resolutions were submitted by Eilhu Root.

Approval in principle was given to the first of Root's resolutions making the use of submarines conformable to international law. The resolution was then re-submitted to committee for minor changes to be made in drafting.

The second resolution recognizes the impossibility of using the submarine as a commerce destroyer and inviting the assent of all nations thereto was considered by discussion of it was not completed when the committee adjourned. Relative to the second resolution the British delegates said they would accept it only on condition that it should become effective upon ratification by the five greater powers irrespective of any action by other nations.

Behind proposed submission of the second resolution to committee after he had expressed adherence to it in principle. Schanzer for Italy pointed out that the first resolution seemed to permit the use of submarines and the second to prohibit. Root replied that the first merely stated the law as it stands and the second proposes changes in it, that the present law is inadequate and a new law is necessary. He opposed reference to committee. "I should be ashamed to continue this conference without a declaration against submarines," said Root "a declaration that will make it plain to all the world that no man again can commit such an act as the sinking of the Lusitania without being stigmatized as a pirate."

France Criticized
The London Daily Chronicle, according to yesterday's dispatches, in commenting on the conference says: "It is useless to try to find pretty names for the ugly fact that by the French action a great part of the hope of limiting naval expenditures has been defeated."

Paris dispatches said that the chamber of deputies endorses the action of the French delegation in demanding a submarine tonnage of 90,000 instead of 60,000.

Entente Attacked
Senator King has issued a statement in which he says the conference will be likely to be more memorable and historic for its "monumental failures" than for its achievements. He said that many senators are in doubt on interpretation of the proposed quadruple treaty. Senator Borah and Joseph Tumulty discussed the proposed entente but nothing of the conference has been given out. It is surmised Wilson's attitude toward it was considered.

Reported Agreement
It is understood the naval committee has practically agreed to accept the American proposals to limit auxiliary craft to a maximum of 10,000 tons displacement. The French are said to be holding formal approval in abeyance pending further advices from Paris.

All delegations are understood to have agreed to limit guns on auxiliary craft to 8 inches.

Big Mail Order House Kept Upon Its Feet

CHICAGO, Dec. 30.—Sears, Roebuck Co., announces the sale of a part of its Chicago real estate to Julius Rosenwald, president of the company, for \$16,000,000 and the receipt of a gift from Rosenwald of 50,000 shares of its stock, thus "permitting the company to pass through the readjustment period without impairment of its capital."

The company will continue to use the real estate.

WILSON'S BIRTHDAY

WASHINGTON, Dec. 28.—Former President Woodrow Wilson observed his sixty-fifth birthday, at his home here today. Many telegrams, cablegrams, letters and greeting cards were received and intimate friends called to congratulate him in person.

NEW YORK, Dec. 28.—Women from all parts of the United States attended a luncheon here in honor of former President Wilson's birthday this noon. A plan was advanced to raise a million dollar endowment fund from the income of which periodic awards should be made for "meritorious service to democracy, public welfare, liberal thought or peace through practice."

SPORTS

Financing Sport Is No Easy Task

Athletic Committee Works to Make All Branches Self Sustaining; Two Successes Scored in Year.

Swimming, baseball and football may be ranked in the order named as the three self maintaining sports of Maui. Football in its initial year has paid its running expenses and something more than a third of the outlay for uniforms, regarded as an excellent showing for the first year. Other branches of sport conducted under the auspices of the Athletic Committee of the Fair and Racing Association all show losses, largely because of adverse circumstances that they met in the past year. At the meeting of the Athletic Committee, Tuesday evening the report of the football committee was received and the committee agreed to furnish the cups for the winners of the winners of the All-Maui tennis tournaments of the year that is just closing.

Baseball Leads Way

Taking into consideration the part that baseball plays in the sports and entertainment for Fair crowds the National Game must be given leading place in sports and without the assistance which it gave to the finances of the Athletic Committee that body would have been in considerable of a hole for the season. The weekly games, however, show a much smaller profit than would be expected, largely because by no means all those who see the games pay for the privilege since the Wailuku and Lahaina grounds are not fully enclosed. It is proposed that all East Maui games in the league be played at Kahului next season on the Fair grounds diamond which will make possible the collecting of admission fees from all who attend.

Swimming to the Fore

Swimming, like football, is a new sport activity this year. Two meets and an exhibition for the Press Congress visitors were held. The first was a fine financial success and the second meet, the two nights of swimming that followed the Fair, was a greater success in every way except financially. It had about an even break owing to the expense entailed in bringing over and entertaining while here the leading swimmers of the Islands who were the particular attractions and made mostly for the success of the meet and because attendance was cut down as a result of the activities of the Fair and the Press Congress visit which immediately preceded it. Still swimming shows an excellent profit from the first meet at the Puunene tank but such profits have gone into a special fund which is to be used only for the building and equipping of a boat house when it reaches the necessary proportions and has not been used to defray Athletic Committee expenses for other branches of sport.

Sports Show Losses

Basketball of last season would have been self supporting but for the bringing of a team from Hilo and the sending of a team to Honolulu but those expenses put that branch of sport on the wrong side of the ledger. Track and field sports had been expected to show a profit but the annual field meet had to be postponed after having been well advertised, then had to be readvertised and finally was held at a time when it did not draw so well. A financial loss was the result.

To the soccer games no admission was charged in the effort to popularize that branch of sport and no income resulted from it though the committee contributed financially to its conduct.

Dances Bring Revenues

The entertainment committee helped to meet the losses of the attempted New Year sports when rain prevented any receipts aside from the New Year's eve fancy dress ball at the opening of the present year. The dance was a splendid success financially as well as socially. Again at Fourth of July the entertainment committee gave a profit making dance but the net proceeds were turned into the general association treasury instead of being retained by the Athletic Committee.

Tennis is an activity taken over by the Athletic Committee this year for the first time and has furnished no revenue but has entailed no expense to the committee aside from the raising of funds for the championship cups. the jurisdiction of the association. Uniforms are more costly than for other sports and it is necessary to have at least 18 suits for each team. Thus it was hardly hoped that football would pay all of the equipment costs in addition to other expenses. It has refunded something more than a third of the expenditures for equipment, met its other expenses and there are still to be reckoned the proceeds of the coming two games with the Inter-Scholastic Stars from Honolulu who will play on a 60-40 basis.

Real Success Won

Aside from the financial end the committee has never been so successful. It has basket ball on a fine going basis with two leagues engaged in tournaments now in progress. Despite a late start baseball held interest to the very end and has as strong a hold on Maui as ever even when entering into something like competition with swimming and football. Swimming has put Maui squarely on the map of sports and the future for aquatics on Maui is bright. Football shares with swimming the highest popularity aside from tennis. It is probable that at least four semi-teams will be on the field next fall and several junior teams may be expected to develop. The pigskin game has also gained a footing in the schools. Tennis has the largest number of active participants of any branch of sports, including, as it does, women as well as men, but it is in a different position from basketball, baseball, football or swimming or even track and field sports. Soccer may be revived but is dormant at present.

One of the important achievements was the perfecting of arrangements so as to give a joint jurisdiction over amateur sports to A. A. U. with the Athletic Committee.

The introduction of two new sports in the year is in itself an important achievement for the committee which is headed by J. Garcia and has fourteen members, each heading one of the sub-committees which has direct supervision over some branch of sport or some activities of the main committee. It has kept sport clean and prevented the arising of any disagreeable clashes, bickerings or disputes which is one of its chief provinces and never have there been so many engaged and interested in clean sport as at the present time.

On the eve of a New Year Maui News extends this expression of its appreciation for the splendid support accorded it during the past year and the hope that its usefulness in the community may be doubled in the year to come. To all readers it tenders sincere wishes for a happy and prosperous New Year.

THE OLD AND THE NEW.

Popping firecrackers, interspersed with louder detonations from exploding bombs, tooting horns, resonant blasts from steam whistles, chiming bells, lifting music, the dance, flying confetti and general hilarity will welcome the birth of a new year at midnight tomorrow. They will be the requiem of a dying year as well and the same sounds and similar sights marked the advent of 1921. The joy of its passing will be as unconfined as was that which marked its coming, for the year has not brought all the joys and the hopes that were looked for when it was so inaudibly welcomed and youth lives in the tomorrow and ever finds that realization does not wear the bright and attractive garb of anticipation. Thus it is but natural to cast aside that which has been found disappointing and reach out to grasp the new, the novel, the unknown. Only the good and the desirable are seen ahead and in prospect. The ill is cast aside with the dead year as if it never were nor had been.

Thus it is that the annual New Year holiday is one of gaiety, happiness, a careless, care free day when the world lives for the nonce in its hopes of good things in store and judges the future not by what it has found in the past but by what it is hoped to find. It is a new turn in life's road and tempting scenes and vistas appear in the offing.

The dying year was one of reconstruction, of "getting down to brass tacks" again and it was not easy nor has it been pleasant. Hardships were greater than had been expected and in many respects 1921 has been one of unpleasant disappointments.

One great achievement started in 1921 may make the year prominent in history, the conference for the limitation of armaments, perhaps the longest and most decisive stride civilization has ever taken. Aside from that no great advance has been made by the nations of the world.

This country has suffered business depression and unemployment in its efforts to return to normalcy. There have been industrial disturbances and threatened strikes from which the outstanding development was the firm stand taken and held by the government in the railroad labor disputes. How much 1921 has done for industry, what its lessons will mean to the employer and to the employed, and how they will be heeded, 1922 and the years to follow it alone can show.

Politically, the Republican party has come back into power and holds the reins of government in firm hands that have shown their skill in guiding successfully in past years.

For Hawaii the old year has been especially disappointing. It has brought diminished crops through labor shortage, a steady and continuous decline in the price of raw sugars to the lowest figure known in a decade. With such a state of affairs came disappearance of bonuses, decreased wages and salaries and vanishing dividends, decreased incomes in all directions. Public improvements have lagged if not halted but the lesson has been taught to those who were willing to learn, a lesson of self reliance and independence, of the need of economy in all affairs whether public or private, community, business or individual.

So young 1922 enters with no very promising estate to manage bequeathed to him by his predecessor and with a task of building up and construction to be faced. He is a "hard times baby" as it were, but that need not make folk pessimists for there may be a "gold spoon in his mouth" after all and the young visage is more pleasant to look upon than the wrinkled, care worn face of the departing year. From the New Year not nearly so much is looked for and hoped from. That will mean fewer disappointments with the passing days. He comes clasping in his chubby fists a gift of hopes for Hawaii of a duty on raw sugar that may bring better prices and of relief for the labor shortage, of a stabilizing of the money market that may make sales of bonds possible once more and renew the era of progress and improvement.

And as the old year totters onward there is reason for optimism, confidence, happiness and for joy in the hope that the darkest days have passed or are passing with it and that the turn of the road back to general prosperity has been reached or is only just ahead.

For each one 1922 will be just what he or she makes of it according to the attitude that he or she takes toward it. Each can make it happy or sad, bright or somber, for himself or herself and for those about him or her as the will directs, for true happiness is ever within the reach of all who will grasp it or labor for its attainment.

COMMUNITY SUPPORT.

Contributions to the church, to charities and benevolences, membership in civic organizations, are all essential parts of community support just as is the payment of taxes. They all go to the upkeep and upbuilding and betterment of the community but they are not enough to constitute the whole hearted community support that is absolutely necessary for success. Patronage of the home business houses is equally necessary.

Seldom has Maui been in greater need of whole souled, whole hearted community effort than at the opening of the new year. Reduced salaries and incomes have demanded economies in every home and such economies cannot do other than reduce the volume of retail sales in Maui's stores. But such reduction can be minimized if the true community spirit is exercised and every purchase made at home that is possible. Were half of the mail order purchases of this year diverted back to the business houses of Maui next year there would be no complaint of slackness of business.

Without community support no local store can carry lines of goods that will even meet the emergencies of customers. The more meager the demand the smaller the stocks of goods that can be

Every business enterprise on Maui pays its license and its taxes. Every dollar of its income pays its percentage into the territorial and the county treasury. The less any business house pays the more some one else must be taxed to meet the governmental expenses. Every dollar sent away is withdrawn from circulation here and depletes the resources of the home banking institutions. The larger the volume of home sales the lower the merchant can sell.

One of the best New Year's resolutions that can be made is: "I will buy at home during the coming year whenever it is possible for me to do so."

You like to read about your neighbors and your neighbors like to know about you. Why not drop a line to Maui News about your own and your neighborhood doings from time to time during the coming year. There are too many square miles on Maui to be covered each week to do so in person.

One of Maui's most important civic enterprises is its fair grounds and fair. If bonds are issued to consolidate its indebtedness the entire community should get in and boost to the limit of capacity.

SYLVESTER NIGHT FROLIC

For "Sylvester Night" or "Watch Night," as New Year's Eve has been called from time out of mind, frolics and parties are in order. If a dance has been planned there should be at least six couples; seven would be better, or, altogether, fourteen participants. These are given names and symbols: January, a calendar; February, a valentine heart; March an Irish harp; April, a fool's cap; May, a small Maypole; June, a rose; July, and American flag; August, a sheaf of wheat or a tiny watermelon; September, a school book; October, a little pumpkin; Jack o' Lantern; November, a toy Thanksgiving turkey; December, a spray of holly; the Old Year, a tag, "Farewell, 1921," and the New Year a label "Welcome, 1922!" If there are more than fourteen in the party additional days can be assigned to them, with suitable emblems: Washington's Birthday, a little hatchet; the Vernal Equinox, a violet; Easter, a lily; Memorial Day, blue and gray ribbons; Labor Day, a square paper cap; Election Day, a miniature ballot box; Columbus Day, a tiny ship; Armistice Day, a little dove, etc.

The dates so symbolized are written on cards, and placed in two boxes one box for the men's dates, the other for the girls'. The men draw their partners for the first dance from the box of girls' dates, and later in the evening each of the girls draws a card from the men's box and reads it aloud, when the man who personifies that date comes to claim her for a supper partner.
