## 80 homesteaders get NMHC help; 50 deeds out

SOME 80 homestead permit holders will be assisted by the Northern Marianas Housing Corp. in obtaining loans to construct houses following a "grant of public domain" issued on their lots by the Division of Public Lands.

At the same time, acting Lands and Natural Resources Secretary Bertha Leon Guerrero, in an interview, said close to 50 permit holders have been issued deeds after a review of their lots qualified them for the land title.

"There are 80 (homestead permitholders) that have already been approved by the Attorney General's Office and also by DPL and the Board of Public Lands to issue a grant of public domain over to NMHC to assist our homesteaders in building their houses," said Guerrero.

By issuing a "grant of public domain," a homestead permit holder becomes eligible for loans with the NMHC using their lots as collateral.

The permit must however be at least three years old.

"DPL and NMHC are working

together in assisting homesteaders to get the loans to build their houses," said Guerrero.

Guerrero said most of those entitled to NMHC loans are permit holders who need funds for their houses' "finishing touches."

She said more homestead permit holders may soon avail of the loan arrangement.

Meantime, acting DPL chief Henry Hofschneider said the close to 50 homestead permits who were finally issued land deeds were those whose cases have been pending since 1995 and 1996.

"The deeds were issued to people who have alrready fulfilled all the requirements," he said.

The deeds were likewise issued following review by the AGO.

Hofschneider said government is conducting an inspection of homestead permit holders in Kagman III in view of releasing more deeds.

"We are in the process of reviewing those (permit holders) we still have so many under review," said Hofschneider.

### Chun: DOI 'pushed' for more OSHA inspections

#### By Mar-Vic C. Munar Variety News Staff WALTER Chun, a former official of the Occupational Safety and Health Administration (OSHA) yesterday suggested the agency has intensified its inspection of labor camps in the CNMI upon instruction from the Department of Interior.

Chun, in a letter sent to Saipan media, said DOI "funds these inspections and this is what they want." Local officials perceive DOI as a "nemesis" of the CNMI.

They suspect that DOI is orchestrating a "smear campaign" against the Commonwealth to push the federal takeover proposal in US Congress.

Chun, meanwhile, said another reason cited by OSHA Region 9 to justify its intensified inspections in the CNMI was that "the number and type of violations (here) are very serious."

But he criticized OSHA for focusing too much on the CNMI while ignoring largerscale violations of safety standards in other parts of the Continued on page 33

## **Fund:** Terminate **Woosung contract**

THE NMI Retirement Fund has sought the termination of the contract between Woosung Construction Co., Ltd. and the Department of Public Works due to the delay in the completion of the Judicial Complex project.

Retirement Fund Administrator Edward H. Manglona told the Variety yesterday that the Fund's Board of Trustees are very concerned over the continuing delay of the multimillion-dollar complex.

He said he asked E.F. Camacho Engineers and Architects, a firm hired by DPW to perform the contract administration of the project, to speed up the process of termi-

nating the Woosung contract. Manglona recommended that avail of the surety bond to complete the remainder of the building.

The money used in the construction of the complex comes from the Retirement Fund pursuant to a loan agreement it had with the CNMI government.

Meanwhile, Efrain F. Camacho, president of E.F. Camacho Engineers and Architects, concurred with the Fund's request that

Woosung's contract be terminated and that surety be brought in.

"In fact, we recommended several months ago that DPW should terminate Woosung's contract for default. However, DPW has not yet acted on our recommendation," said Camacho in his letter sent yesterday to Manglona.

Camacho yesterday also urged acting DPW Secretary John B. Cepeda to halt Woosung's contract for default.

#### Alien card 'brouhaha' to be looked into-- Tenorio

Variety News Staff GOVERNOR Pedro P. Tenorio yesterday said he will look into complaints regarding the supposed "redundancy" of the alien registration card.

Nonresident workers who already possess an entry permit are still required to pay for the alien registration card (ARC), which costs \$25, or the equivalent of 8-hours in minimum wage rate. ÷.

The CNMI minimum wage rate is \$3.05 an hour.

At the same time, Tenorio said alien workers should appreciate the CNMI government's efforts to enforce health screening and ensure a "healthy community."

He said the government does not intend to generate revenues from the health screening fees and ARCs. CNMI law requires that Continued on page 33

SYDNEY, Australia (AP)\_Close to 3,000 migrants accused the Australian government of discrimination Thursday for allegedly favoring visa applicants from six countries over others.

In a class action in the Federal Court, about 2,800 migrants claimed the government's special visa category for people from selected countries is in breach of Australia's Racial Discrimination Act.

The countries are Sri Lanka, Kuwait, Lebanon, Iraq, China and the former Yugoslavia.

# Annan: US is key to Mideast peace

AMMAN, Jordan (AP) \_ The United States has the key mediating role in the Middle East peace process, the U.N. chief said in urging Palestinians and Israelis to work with American officials for a permanent settlement

U.N. Secretary-General Kofi Annan's praise of the U.S. effort came on the same day British Foreign Secretary Robin Cook wrapped up a visit to the region in a bid to expand Europe's role in the peace process.

Annan didn't comment Wednesday on the European initiative.

"The mediator for the Palestinian-Israeli issue is the United States, and I support very fully their efforts, and I encourage the parties to work energetically and constructively with them in search for a durable peace," said Annan, who reiterated that he did not plan to step in as mediator.

Annan, who arrived a day earlier in Jordan, toured two Palestinian refugee camps with Crown Prince Hassan in Amman, where he chatted with residents under freezing temperatures and heavy snowfall.

Annan later flew to Cairo for meetings with Egyptian officials. His Mideast tour will also take him to Syria, the Palestinian territories and Israel.

The Mideast peace talks have been deadlocked since the rightwing administration in Israel came to power in 1996 vowing a tougher line in negotiations with the Arabs.

Annan and Hassan, King's Hussein's brother and heir to the throne, inspected the services provided to camp refugees who fled their homes in the 1948 and 1967 Arab-Israeli wars. About 120,000 Palestinians live in the two camps run by the U.N. Relief and Works Agency.

Government officials said Hassan and Annan talked about ways to make Israel comply with U.N. Security Council resolutions, which urge its withdrawal from Arab lands captured in the 1967 Mideast war.

"Jordan stressed the fact that the U.N. should apply the same standards while enforcing its resolutions, in other words to be as firm with Israel the way it is with Iraq," said one senior government official who spoke on customary condition of anonymity.

Annan and Hassan also discussed methods to ease the suffering of Iraq's 22 million people, raining under sweeping sanctions imposed following the 1990 Iraqi invasion of Kuwait.

Cook, the British foreign Secretary, said Wednesday in Beirut, Lebanon that Syria expects progress in its long-stalled talks with Israel before it will support a plan for Israeli forces to withdraw from southern Lebanon.

Syria, the main power broker in Lebanon, is demanding the return of the Golan Heights, a strategic plateau that Israel seized in the 1967 war. Israeli Prime Minister Benjamin Netanyahu says the area is vital to Israel's security.

Negotiations have been stalled since March 1996.



#### Zachares warns departing workers:

## No ARCs, no reentry'

ACTING Labor and Immigration Secretary Mark Zachares has warned that nonresident workers leaving the Commonwealth will be refused entry if they fail to show alien registration cards.

The warning came following reports that five nonresident workers, who had left the Commonwealth on official function elsewhere, have been denied entry upon failure to show an ARC.

"I would advise that if you are about to travel from the CNMI right now and you're are an alien worker, that you make sure that you have your (Alien Registration) card or a receipt that your card is in the works," said Zachares.

Close to 1,300 nonresident workers have been found without ARCs during simultaneous unannounced inspections conducted by labor and immigration operatives in at least five garment factories since last week.

Government has ordered these workers to secure ARCs within 24 hours or face possible deportation.

However, a lawyer for Tan Holdings Group of Companies, from which the bulk of workers without ARCs were found, is contesting the legality of deporting a nonresident worker on grounds of not having an ARC.

"They (government) have taken the position that it is deportable. It's our position that it is not," said Steven

Pixley, in an earlier interview. Pixley said he is seeking a dialogue with Rob Goldberg, counsel for the Department of Labor and Immigration on the

matter.

Zachares has maintained that ARCs ensure that the holder is free of tuberculosis, HIV and syphilis as the worker would first have to undergo medical tests prior to the issuance of the "yellow card.'

"It (ARC) is one way that we can be assured that people are actually getting their medical tests," explained Zachares.

DOLI has been abuzzed with activities brought about by hundreds of workers queuing up to apply for an ARC since the unannounced inspections started last week.

### Tenorio will sign bill on hiring moratorium

GOVERNOR Pedro P. Tenorio yesterday said he will sign the bill that would stop the hiring of alien workers in the CNMI before he leaves for Washington, D.C.

The governor, who will testify before a US Senate committee on March 31, said he still has to review House Bill 11-31, but added that the CNMI needs such legislation.

"If there's no flaw in the bill I'll sign it today or tomorrow," he told reporters.

Tenorio at the same time expressed support for H.B. 11-77, which seeks to create a special fund for the Public School System (PSS).

He said the bill would alleviate the PSS's classroom shortage and even eliminate the multi-

track calendar system. Passed on Tuesday by the House of Representatives, H.B. 11-31 proposes to prohibit the new hire of alien

workers, particularly in the garment industry. Exempted from the moratorium are alien workers who are already in the CNMI and whose contracts will be re-

newed. Also exempted is the hiring of an alien worker to replace another alien in the same employment position.

The bill would authorize the governor to grant other exemptions, specifically to prospective employers who have invested at least \$5 million in either a "major new development" or the expansion of an existing development project.

## EDITORIAL **Scrap the ARCs**

THE CURRENT uproar over alien registration cards (ARCs) appears to be one needless offshoot of the ongoing crackdown on erring Saipan employers.

Although the current campaign to rid the garment industry of labor law violations is commendable and long overdue, the attention given this card requirement just doesn't make sense.

It seems authorities have unnecessarily made a big issue of such a small requirement, instead of focusing on the more bothersome labor problems like stinking bathrooms, cramped barracks and unpaid overtime.

The whole thing borders on harassing an already harassed group of individuals. Swooping down on business establishments and threatening employees of deportation if they don't have the card is quite an ordeal for these workers.

Barring reentering workers for not having their ARCs is even more unconscionable, especially since there was not much of a warning about the consequences of not carrying these IDs upon their entry at the airport.

True, workers under the law are supposed to carry their ARCs in their person at all times. But shouldn't their be some form of consideration given in as much as this requirement has not been fully enforced over the years and workers have gotten used to not being stopped and admonished for such an infraction.

One other concern is the appearance that the card requirement has become a money-making imposition.

While government bemoans the financial crisis it is in and needs to step up its revenue efforts, it is almost immoral to think of the down-trodden working class as a veritable source to shore up collection, especially since most of these people are toiling hard for a meager amount of wages.

Shelling out \$25 is already a big expense for these workers, especially for minimum wage earners, who have to give up a day's pay just to put up with this seemingly unnecessary requirement.

Why unnecessary?

Because it is a bureaucratic redundancy.

DOLI officials have defended the ARC requirement as one way of ensuring workers have gone through the needed TB and HIV disease checks.

If this is the contention, why can't DOLI just attach this requirement to the issuance of the entry permits?. After all, isn't a health examination already a requisite for the renewal of worker permits?


It would definitely make sense if government just comes up with one single card, the LIIDS card, except if the intention is really to milk workers of more cash.

What the crackdown on ARCs has resulted to is a lot of inconvenience for the workers and their employers, not to mention the tremendous amount of hours spent queuing up at the DOLI counters and the resultant panic it has caused.

We hope that Gov. Pete P. Tenorio would act swiftly in addressing this problem as it is quickly causing resentment among an otherwise uncomplaining non-resident worker community

Workers can live with reasonable regulations and requirements of the law.

The ARCs rule, however does not seem to fall under that category.





## **Displaying patriotism**

I THINK it's the flu speaking as I write this, which is why I hope ninang Julie wouldn't mind if I raise an issue over the Consulate's plan to provoke patriotism among the Filipinos in the CNMI by "enjoining" them to display the Philippine flag at their barracks. It would, I think, have the same result as an aphrodisiac used by a nostalgic 89-year old satyr who wants to get it up.

According to a Variety report, the US citizens-led, and hence misnomered, United Filipino Organization (or ET, I mean, UFO) is also preparing activities for June 12th, which will mark the 100th anniversary of the declaration of Philippine independence ("under the protection of the Mighty and Humane North American Nation," read the original proclamation written in Spanish, and it was not referring to Canada.).

The report, in addition, mentioned a festival sponsored by the Philippine Centennial Foundation in the mainland US. The festival's "centerpiece" is the jeepney, "a mirror of the Filipinos' talent to embrace forms from many countries to come up with a distinctively Philippine 'style.'" In other words, our ability to transform surplus US military vehicles into something gaudy and kitschy, a road nuisance and an environmental hazard. Philippine transportation officials have actually revived plans to phase out the use of the jeepney for public transportation, but this is, I guess, a minor detail for the festival's organizers.

Meanwhile, in all government offices back home, employees have been ordered to wear the barong or the terno every Monday in observance of the centennial.

All this, the government seems to assure us, will rekindle Philippine nationalism in more ways than just watching the national team compete in the Asian basketball championship, or our candidate vie for the Ms Universe title.

However, these "measures" merely manifest a state-sanctioned confusion over form and substance, over gestures and deeds. As if, for example, those miniature flags propped by sticks could pass for national sentiment, the existence of which remains problematic. For a Filipino is only an individual, not a member of a nation, as the patriot Jose Rizal noted in 1890, perhaps not knowing that 108 years later it would remain a valid observation.

And there being no real national sentiment to commemorate, it is likely that the centennial celebrations here will highlight folk dances and folk music, which will be labeled Philippine "culture." Again, it seems that nothing has changed. "National culture," says Filipino historian Renato Constantino," is not the glory and the achievement of the past; it is not folklore; it is not a revival of tradition. [Rather] it is the summation of the needs of the people, the description of their present condition, the appraisal of their values, thoughts and emotions, the depiction of their struggle to liberate themselves."

That was written in 1969, but we are still into tinikling and fandango sa ilaw. We still believe, moreover, that heeding the IMF's advice and exporting rattan and gewgaws are the keys to economic development, and we have refused to learn anything from the post-World War II industrialization of Japan, South Korea and Taiwan. We still think like a US colonial and we neither have appreciation for our history and our people's heroic struggles to be free nor do we intend to have one. We send our sons and daughters to universities that they may get a job abroad. Those of us who are abroad would rather stay there. Our government, knowing this, calls us "new heroes," and we believe it.

To make an approximate comparison, if the Palestinians are the people without a nation, then the Philippines are a nation without people. I say approximate because the Palestinians, at least, now administer a sliver of territory.

Of course, things can never be hopeless for the Filipinos, as their country's history, though largely ignored, will show. But it is doubtful whether displaying the Philippine flag at their barracks would instill nationalism in our kababayan who, even as I write this amid a haze of flu, is still wondering when the hell will the feds take over and hand out those lovely green cards.

#### Forbes has successfully framed debate

MALCOLM S. Forbes was positively giddy last week.

The once-and-future presidential candidate, who prefers the name "Steve," was joyous because President Clinton used a major policy speech to denounce a Republican plan to sunset the current tax code as an "irresponsible scheme."

Clinton's speech was notable not for its policy substance, which is consistent with past administration policy, but because it legitimized two years of steady conservative propaganda by the millionaire publishing heir from New Jersey. For the past month, Forbes has been on the road with what he calls a "tax code termination tour," trying to drum up support for a congressional GOP plan to abolish the current tax code by July 4, 2001, and replace it with a simpler system. Forbes, of course, prefers the flat tax, arguing that every family would save big under the plan (few more so than Forbes himself).

If he hasn't yet captured the imaginations of the suburban "soccer moms" and other swing voters who decide presidential elections, he's definitely getting the attention of GOP grass-roots activists and the political cognoscenti in the nation's capital. In straw polls of Christian conservatives and other party activists, Forbes has outpaced most of his prospective rivals. And his inherited millions have caused inside-the-Beltway types to take notice.

Says presidential historian Allan Lichtman of American University: "I think he's a strong candidate, for a number of reasons. No. 1, it's a wide-open field (in 2000). There's no clear front-runner. ... No. 2, he has a lot of money and can spend a lot of money in the primaries. This time around, no one's going to have all the money. The regular party money will scatter.'

His best efforts notwithstanding, Forbes won't be the next president of the United States; that much we'll predict with near-certainty. But it won't be for a lack of trying. In the two years since he abandoned his quixotic bid for the 1996 Republican nomination, Forbes has campaigned virtually full time for the 2000 nomination, even though the primary season is still nearly two years away and he isn't close to officially announcing his candidacy.

Hardly a day goes by that Forbes doesn't lob a grenade against the Clinton administration. Using his "issues" organization — Americans for Hope, Growth and Opportunity as a kind of campaign headquarters, Forbes has crisscrossed the country making speeches and trying to refine the stilted campaigning style that hurt his performance in 1996. Last year he made 205 speeches, including 50 fund-raisers, leaving him little time to pursue the publishing business that his father left him.

Unlike the last self-funded presidential candidate, Ross Perot, Forbes is politicking the old-fashioned way: by pandering to any audience that will have him. In New Hampshire, the privately educated Forbes has been running radio ads telling Granite Staters how to fund their public schools. Similar ad campaigns have cropped up in other states where local referendums were on the ballot.

Some Republicans have suggested, jokingly, that the Forbes media crusade is threatening to "privatize the (Republican National Committee)."

The net result of all this: While Forbes remains a long-shot to win his party's nomination, he has defined the terms of the debate, two years before the first presidential primary.

COMPUTER DISASTER - In the very near future, disaster relief workers at the Federal Emergency Management Agency's numerous field offices will be able to call up potentially life-saving information on their computers in a matter of seconds. At least that's what agency bigwigs would like everyone to believe.

As we reported last week, development of a new, comprehensive FEMA computer system, dubbed the National Emergency Management Information System, is 10 months behind schedule and \$23 million over budget. Agency spokesmen acknowledge that early tests of NEMIS exposed "shortfalls," but insist these kinks have been worked out and the system will be up and running by spring 1999.

FEMA employees working on the project have confided to us that NEMIS is still plagued by numerous problems, and have doubts as to whether the vaunted computer system will ever prove reliable.

Complained one insider: "When I turn on the computer and it doesn't work or when I turn on the computer and keep pressing buttons and they're not doing what they're supposed to be doing, I'm frustrated."

Following a winter in which El Nino related storms devastated many American communities, that's not very comforting.

## **Bond delay hurts casino hopes**

By Aldwin R. Fajardo Variety News Staff A BUSINESS sector leader vesterday said further delays in the flotation of bond for the

island's airport may jeopardize marketing efforts to make Tinian the casino gambling hub of the Pacific. Analysts believe direct

flights can encourage more gamblers to fly to the island, as the Commonwealth bends towards promoting Tinian as the gambling center of the Pacific with the grand opening of the Tinian Dynasty Hotel and Casino next month.

"It is very unfair of the CPA [Commonwealth Ports Authority] to justify all of that funding for Saipan and Rota, and refusing to float a bond for Tinian," said Phillip Mendiola Long, president of the Tinian Chamber of Commerce.

Long was referring to the \$54.6 million bond floated by CPA. Proceeds of the fund will be used to finance existing projects of CPA such as the \$7.6 million dredging work at Saipan harbor, corridor expansion of the Saipan International Airport and other federal-funded projects which need complement funding from the ports agency.

The Tinian business leader also expressed disappointment over CPA's apparent refusal to float the bond for the island's airport, which Long said would be detrimental to the casino industry "in this part of the Common-

CPA executive director Carlos Salas has said that the Ports Authority is not increasing its proposed bond to \$80 million, citing dwindling air and sea ports revenues.

The Commonwealth Development Authority [CDA] wanted CPA to increase its proposed bond flotation from \$54.6 million to \$80 million to accommodate Tinian airport expansion project.

With next month's grand opening of the first casino in Tinian, Long said CPA officials may have failed to realize that the airport needs immediate funds in order to bring in as many casino players as possible.

"How do they expect us to bring in casino gamblers without a better airport? There have to be direct flights to Tinian for the casino industry to kick off," he told Variety.

He stressed that the Tinian business community agrees that there is a need to 'tighten the belt' but added that CPA should have identified what projects have to be financed first.

"I don't have anything against CPA but it doesn't make sense to say they don't have the money if they don't even know how much it is going to cost them," he continued

Long lamented that CPA officials must reconsider their priorities, "especially now that everybody is predicting that Tinian's casino industry will save CNMI's ailing economy.'

"If they think the casino industry is going to help the CNMI economy, they have to help Tinian get an airport. And study what to cut and where to put the money first," he said.

He said Tinian would be in a 'major crisis' if it failed to have its airport rehabilitated and improved, while adding that CPA must help encourage the growth of the casino industry, especially now that Saipan is at a losing end with dwindling tourist arrivals.

Long said there are other directions to look at. "Down south is the island of Tinian which has a bright potential to encourage more tourism activities with the pending opening of the casino," he continued

Salas said CPA is getting separate financing for the Tinian project, while adding that his office is still working out some important details in terms of repayment of the bond that has to be floated to finance the project.

Originally, the CPA sought to float \$140 million, most of which would have funded the expansion and improvement of both the Tinian air and sea ports.

### MCV programming changes to take place

SUSUPE, Saipan — When Marianas CableVision makes changes to their channel lineup next week, viewers will notice many temporary additions to their regular service.

Several "premium" movie channels will be unscrambled as MCV technical crews make adjustments to the signal going to each and every subscriber.

"Premium channels require a small device or 'trap,' as we call it, to either permit or prevent you from seeing that service, depending on what you've chosen," says MCV General Manager Joe Butters.

When the lineup is changed, MCV then has to "re-trap" each residence and apartment complex so that they will be getting the right services.

"Since we can't change out everybody at once, we will be unscrambling the movie channel signals and duplicating them in the upper channels for a short time, so that folks who are paying for those channels can still watch them," said Butters.

This is expected to take about two months to complete.

Butters cautions parents though to pay a little more attention to children's TV viewing habits during this time.

"On the one hand, it's nice to get an HBO or Showtime free for awhile, but there are some programs on these channels that parents may not want their kids to see. Unfortunately, the project we have ahead of us does not allow us many options on blocking out some adult content, so we're asking for some help from families on this end," adds Butter.

Starting next Monday, MCV's premium channels will be located between channels 15 and 23.

They will also be duplicated from 56 to 64 to ensure that subscribers who are paying for those services still see them during the time MCV is completing this project.

However, Butters adds that subscribers can call any of the Customer Service line, 235-4628/6365-7 if they are not receiving a service they should be having or if they would like more information on receiving some of these channels once the project is complete.

MCV advises subscribers to make a note of these changes and to watch for further announcements on programming and service area schedules so that they can be better prepared for the changes taking place over the next several weeks.



## **US** Court hears apportionment case

US DISTRICT Court Judge Alex Munson yesterday denied "tentatively" the government's motion to dismiss a taxpayer's lawsuit challenging the constitutionality of the CNMI Senate apportionment.

Munson has yet to issue a written decision, but government lawyers said they don't expect the judge to reverse his "tentative ruling."

Munson heard yesterday morning the oral debate on the case filed by Jeanne Rayphand and Stanley Torres who are asking the federal court to strike out the provision in the Covenant which gives the islands of Saipan, Tinian and Rota equal representation in the Senate regardless of their respective popu-

lation. The plaintiffs, represented by lawyer Ted Mitchell, said voters from Saipan, which has the biggest population among the three islands, are denied equal protection because Tinian and Rota senators are controlling the political process although they represent islands with numbers of resi-

dents that account for only 10 percent of the CNMI's population.

"The whole purpose of this lawsuit is to try to correct the imbalance that exists now between Tinian, Rota and on the other hand Saipan," Mitchell said.


Respondents in the case are officials and members of the Board of Elections.

Asst. Atty. General Robert Goldberg, chief counsel for the government, has asked the court to dismiss the case arguing that the issue had already been decided on by the CNMI Supreme Court and the US District Court some years ago.

Goldberg invoked the federal court's 1987 decision in Hillblom case, in which the constitutional challenge to the Covenant was dismissed as a political issue that should be resolved between the CNMI and the U.S. through 902 consultations.

Munson, however, was not convinced that the Hillblom ruling was an appropriate basis to dismiss the case.

Mitchell said the Hillblom



case was "meaningless" as it was never decided on the merit of the issue.

"Hillblom didn't ask the court the same thing that we're asking now. We're saying that this malapportionment is wrong and that it violates the US Constitution," Mitchell said.

"Hillblom went to ask the court to give a ruling that it is right," he added.

Goldberg also argued that the Rayphand case should be dismissed based on the Supreme Court's ruling in Sablan v Tenorio. In this 1994 ruling, the high court threw out the complaint, citing the "legislative immunity" being enjoyed by the respondents, who included the governor and members of the Legislature.

Munson, however, said the legislative immunity principle does not apply to the present case because the respondents are election board officials who "are not acting legislatively but administratively."

Munson, in a brief interview later, said he hasn't made a final decision on the case.

#### AGO opposes the release of slay suspect pending trial

Variety News Staff THE ATTORNEY General's Office yesterday opposed a murder suspect's request to be released to a third party custodian pending trial of the case.

Assistant Atty. Gen. Kevin Lynch said given the disregard for human life defendant Berlin Sedurante had demonstrated, the government does not see how a third party custodian living in another household can effectively "insure the court he will not be a danger to the community."

Lynch said the government is also unconvinced that the

surrender of Sedurante's travel documents will guarantee his continued presence in the Commonwealth.

Antonio M. Atalig, counsel for Sedurante, asked the Superior Court to modify the pretrial release order for clients.

Atalig said in the absence of any clear and convincing evidence that Sedurante is a flight risk, defendant shall be released to a third party custodian pending trial.

Sedurante was charged with second degree murder in connection with the fatal assault of a carpenter in Garapan on July 1, 1997.

The court originally set a \$100,000 bail for his release. but later reduced it to \$10,000 cash. The trial was set for July 13.

Lynch said the case resulted from an unprovoked attack upon the victim by defendant who was intoxicated at the time

"Defendant attempted to hijack a busload of workers and the deceased was a passenger on the bus whom defendant struck, causing the death," said the prosecutor.

Lynch said the defendant has no ties in the CNMI and apparently came to the Commonwealth for work purposes.

"It is fairly well known that there is a market in forged travel documents, which makes it possible for a person who has no travel documents to leave the Commonwealth." he said.

"Given the gravity, the nature and circumstances of the offense and the other factors listed, the \$10,000 bond set by the court is not excessive and is proper under the circumstances of this case," Lynch added.

## Airline official unperturbed: **Moratorium hardly to affect route**

THE MORATORIUM on the importation of new guest workers to the Northern Mariana Islands is expected to impact air traffic demand to and from the workers' home countries.

But Continental Micronesia said the freeze-hiring law will hardly affect the airline's Manila flights since the Guam market can offset the declining demand in the Commonwealth.

"There has been a steady decline in thenumberofforeignworkers' movement. We are already seeing lower number [since the Asian recession]," said Continental vice president for sales and promotions Walter Dias.





## Heart disease risk 'high' in women

WITH OBESITY fast becoming an epidemic in the Northern Mariana Islands, experts believe local women are twice at risk in developing heart disease and stroke, which is the leading cause of adult disability.

Each year, about 100 women in the Northern Marianas are admitted to the Commonwealth Health Center for heart diseaserelated conditions. A heart attack occurs when an artery is blocked, preventing oxygen and nutrients from getting to the heart.

In a recent women's health conference, CHC internist and pediatrician Dr. Norma Ada said

#### Gov't to form body to tackle tourism slump

Variety News Staff GOVERNOR Pedro P. Tenorio will form a committee in an effort to shore up the sagging tourism industry in the CNMI, the chairman of the Marianas Visitors Bureau board of directors said yesterday.

Antonio S. Guerrero said the committee would be going out to meet with prospective investors including two airline companies in Taiwan that are reportedly interested to fly in.

"One (airline) is very serious to come in, and there's another one that is very interested to fly to the Marianas," Guerrero said in an interview with mediamen.

Guerrero said the governor was concerned about the continuity of the CNMI being projected and promoted in its various tourist markets.

Since October, a confluence of factors like the Korean Airlines crash in Guam in August that resulted in the suspension of flights to Micronesia and the Asian economic turmoil has led to a critical reduction in the number of tourists here.

Another factor that contributed to the decline is the stoppage of promotional work by I&S, the Marianas Visitors Bureau's official advertising and PR agency in Japan in the absence of a formal contract that the government has refused to

A renegotiation is reportedly in the works between the CNMI government and the I&S.

Guerrero said structural reforms like the reorganization of the MVB as proposed in a newly introduced Senate bill would help in a more aggressive promotion of the CNMI.

"The reorganizaion would be very effective if that comes true because they're going to go back to the previous system where the tour-related businesses like the Duty Free Shoppers and the hotels would be very, very much involved in this promotion and also in this reorganization that is going to happen," Guerrero said.

cardiovascular disease is the leading cause of death among indigenous population in the CNMI.

Heart attack is characterized by chest, jaw, neck, shoulder and arm pains, nausea and vomiting. Ada said the chest pain is often described as squeezing, burning or heavy type of pain and can occur during rest, sleep, exercise or periods of mental stress.

The World Health Organization said heart disease and stroke is most common among obese people, who are also vulnerable to diabetes and mellitus.

In the Micronesia, up to 70 percent of women and 65 percent of men are class-1 obese, which refers to people weighing between 80 and 85 kilograms. The highest obesity rate in the world has been reported. Melanesians, among Micronesians and Polynesians.

Ada said diabetes is one of the most common diseases in the CNMI affecting about 1,880 people. At least 28 percent of the indigenous population over

he age of 40 have diabetes. Experts said the principal

causes of the accelerating obesity problem are sedentary life-styles and high-fat, energy-dense diets.

Beside obesity, Ada identified several known risk factors for heart disease, which include smoking, high-blood pressure and post menopausal status, as well as clan history for CVDs.

"Cigarette smoking is the leading preventable cause of death among women in the US. If a' woman smokes, the risk of heart disease is two to four times higher than for a non-smoking woman," she said.

Heart disease and stroke boil down to obesity, which experts said has blown out to becoming an epidemic that reflects the profound changes in society and behavioral patterns of communities they have a genetic predisposition to gain weight readily when they are exposed to unhealthy diets and lifestyles.

An ounce of prevention Ada mentioned several factors

o prevent heart attack and stroke. She is advising women to consume balanced diet, which has to be low in fat and salt but high in fiber, adding that at least a 30minute walk everyday will also minimize the risk of heart attack and stroke.

"Quit smoking," she strongly said, adding that alcohol should be drank in moderation and that people, especially those at the high-risk age group, should see a medical practitioner at least once a vear.

WHO experts said prevention policies aimed at a country's entire population were imperative. The policies, they said, must include promoting healthy lifestyles, consumption of vegetables, fruits grains and cereals, and increased physical activity.

Health officials also advised that countries with high obesity cases must encourage behavioral change among its population, with emphasis on weight management rather than on short-term weight reduction.

Phyllis Hazelwood, CHC di etician, said active women who regularly perform some form of high impact exercise are more likely to maintain stronger bones, as well as avoid stroke and heart attack risks, as they age.

Hazelwood said aging women should jog, walk, jump, dance and do aerobics for exercise and relaxation. She mentioned areas where people can walk at, other than the Beach Road Pathway which include: Marpi pathway; Navy Hill baseball field; airport field, among others.

Weight bearing exercise done on a regular basis - daily or minimum of 3-4 times a week for at least 30-60 minutes each exercise session.

Hazelwood said exercise reduces high blood pressure, helps control weight, relieves stress, improves muscle strength, helps control joints swelling and pain associated with arthritis, improves stamina endurance and helps reduce the risks of fracturing bones.

## **CNMI In Focus** An economic contingency plan

I was thinking about the government and private sector's current preoccupation with the possible loss of immigration control and the imposition of the federal minimum wage and wondered what would be on the Commonwealth's agendaif these vital issues were not of such immediate concerri.

Certainly there are many other important matters to address none the least being education, health, infrastructure improvement and, from my perspective, economic diversification and growth.

If the burning issues of the day were not of so much concern would attention be directed, and energy and resources expended, toward encouraging increased foreign and domestic investment?

If so, in what areas should such an endeavor be aimed -increased tourism; the exploitation of marine resources; computer software develop-


long range, comprehensive master development plan designed to direct the island into the next century?

Considering the future of manufacturing and the fact that the World Trade Organization and its signatory members will be eliminating trade barriers in the near future and, in particular, import quotas on most manufactured products in a move to embrace "free trade" among nations -the period remaining for the CNMI's export manufacturing sector is limited

Phase four within the agreement negotiated in the Uruguay Round of trade talks which covered multi-fibers takes effect on January 1, 2005. All the sensitive import items en-

tering the United States market are within this phase including CNMI manufactured garments. The net effect being that the

Commonwealth's use of Headnote 3 (a) within the U.S. Customs Schedule which has permitted duty free



They will be able to manufacture products any where in the world e~cept mainland China and Taiwan and ship them to the United States. Indeed, sometime within the next

six and one half years manufacturers in China and Taiwan will probably be able to do the same.

Recently on CNN there was a news -story about immigrant workers in Thailand, Malaysia and elsewhere that were being sent home as a result of the economic meltdown in the those nations.

I have never given much thought to immigrantworkersemployedinother nations but realized that as long as these nations permit companies to pay their guest workers far less than the minimum wage earned in the United States, and offer few, if any. benefits, then American workers on the mainland will never be able to produce products that will compete in price with imports from Southeast Asia. Central America and elsewhere. In any case, the treatment of such workers in those foreign nations will not matter a bit as the United States will be unable to do anything about conditions in their workplace.

When the economies of southeast Asia get straightened out - and they will-their exports to the United States will increase and because their workers earn lower wages, their products will be landed in the United States at a lower cost than can be produced domestically.

The higher paid American workers will lose jobs in various industries while the American consumer will benefit from the lower and more competitive prices of the imported items. That is, he or she will benefit as long as they have a job to earn the

money to purchase the product.

The government will have eliminated the CNMI's garment industry and it will not have the slightest effect on the United States labor market within that domestic industry.

American garment workers will be out of a job sooner or later. I saw a sport coat advertised in an American catalog that had been made in Russia, exported to the United States at retail price of \$69.

Imagine what the Russian worker was paid to produce this garment. Probably the equivalent of about one dollar an hour or less.

The universal "game plan" is to keep manufacturing costs down to remain competitive and keep profits up. Everyone can do it except the United States based garment manufacturer.

His production costs are high because of higher wage rates and costly government regulations.

Remember the North America Free Trade Agreement, (NAFTA), that wastouted to increase jobs for American workers.

A recent issue of the Economist Magazine carried a story which read, "the future of Paseo del Norte turns on the maquiladora (factory) assembly lines where Mexican workers use American equipment to make goods that get exported duty-free to the United States.

General Motors established a plant

in Juarez as early as 1971. Now, 330 manguiladoras in Juarez employ nearly 200,000 people, more than any other border city."

This is a direct result of the fact that "economics pulls labor intensive work to the Mexican side of the border. Work that needs a lot of capital or education tends to stay on the American side."

Again, the all consuming goal is to keep manufacturing costs down move plants to locations where this is possible. There are no occupational health and safety laws in Mexico, Central America or Asia.

No environmental regulations or historical preservation concerns.

No requirement to provide employee medical and retirement benefits. Companies move to these locations to maximize profits, almost always because of low labor costs, few regulations and a large pool of available workers willing to work for low wages under austere conditions.

Some readers may think I'm progarment industry - the fact is I'm not. I could care less whether they stay or leave the Commonwealth. My interest is with the economy and its measurement.

The industry happens to be a major player here.

When the garment industry does leave the islands all that will have been accomplished is reduced tax revenues for the CNMI government and less money placed in circulation in the local economy.

With no garment industry and thus no garment workers, CUC will have an excess of power generating capacity with no one to buy it's full production potential and a fixed, debt service obligation to meet with reduced revenues.

The Ports Authority may also be faced with a similar scenario - an obligation to service bond interest

#### Leap of faith 'Miracles can come true' Of course, like other normal people "I entirely quit from all of my civic monwealth Health Center [CHC] Roma, despite her faith, was frightened.

TEARS were seemingly flowing endlessly down her cheeks five years ago. And why not, she was diagnosed to have been afflicted with an already at an advance stage cervical cancer.

Facing death is not an easy thing to do, especially for a mother who raises five children. Just the thought of leaving the kids behind makes Roma Aranda sick, what more a chronic disease that was slowly leading her down her grave.

"Almost five years ago, in April of 1993, I was diagnosed with cervical cancer and it was [already at] stage-3. I know that when you hear the word cancer, you think that you're going to die, and that's exactly what I felt," Roma testifies.

She says it was not very easy to accept especially when she was religiously taking her regular annual medical check up in the Philippines. No cancer was detected until she bled profusely, was rushed to the Com-

One can just imagine the pain Roma had to go through, dealing with the thoughts of leaving her family behind. and the physical pain she had to bear with an advance cervical cancer which not so many are able to survive.

"I was lost, depressed, and I don't want to socialize, I don't want to talk to anybody. It's like I shut the whole world down," she adds.

She confesses that she started having a lot of anxieties. "I was taking anxiety pills because I was having nervous breakdown and a series of fainting spells."

Roma was president of the Children of God the Father Inc., of Our Lady of the Most Holy Rosary Oratory, former president of the Ist Women's Lions Club on Saipan and vice president of the Filipino-USA Association [FILUSA] before the cancer news broke down.

activities because sometimes I wasn't feeling very wellconsidering my anxiety problems," she admits.

But persisting thoughts that she was alone in her ordeal did not last long. Soon, Roma discovered she had so many friends to turn to. "It seemed like the Blessed Mother and the Lord spoke to me telling me to have my medication and I will be healed.'

She says it was her faith which brought her to the doorsteps of medical institution in Hawaii where she underwent rigid radiation therapy for 25 days and radium implant.

"I knew that God was with me and at that moment, whatever he decides, I'll surrender myself entirely to Him. But with the treatment that I went through and all the prayers during my ordeal with cancer, I braved the pain," she recalls, tears starting to run down her cheeks.

Roma learned one lesson from her cancer ordeal: "Think positive because that can pull you through."

"Each one of us has a special gift of God, especially women, we are the mothers and we have children to take care of and if we're gone from this world, who's going to take care of them," she adds.

There is no doubt in Roma's heart

and mind that her recovery and eventual survival from cancer was the will of the Divine Providence. "It's a miracle!" she quips.

A lot of people know her for being a very religious person.

"Up to the time that I was ready to die in my room and yet I still didn't want to go to the hospital because I believed that the Lord and the Blessed Mother was there. They can and they will heal me" she says.

But she believed her prayers brought her to the hospital. "The Lord wanted me to get the proper medical care for my treatment so that's how I got treated."

"I attribute my recovery to the Divine Providence, my recovery is a miracle," she continues.

She felt like the world was trembling down on her, thinking death was already knocking upon her door.

"I thought of death. It wasn't easy [because] I have five children," she


But unlike some people who blame God for their misfortune, Romaheldon with her trust that the Lord and the Blessed Mother, whom she is devoted to, will help her survive and give her a second life

"My faith becomes stronger when I fell ill. I know that the Lord will not abandon me. I knew I will recover because of my faith. I never gave up, l know the Blessed Mother's intercessionwillhelpmesurvive,"shestresses.

Five years hence, Roma remains a mother to her five children and a loving wife to her husband. She proudly stood before 300 multiracial women during a health conference recalling every detail of her once painful but lesson-filled ordeal.

Indeed, prayer does. Because as Roma stood before her counterparts, she appears to be a living effigy of God's miracles and a living proof that nothing is impossible even with just a little leap of faith.







TOKYO (AP) — Indonesia Vice President Bacaruddin Habibie arrived Wednesday for talks with Japanese leaders about his Southeast Asian nation's economic cri-

During a four-day visit, Habibie will meet with Prime Minister Ryutaro Hashimoto, Foreign Minister Keizo Obuchi and other officials, Japan's Foreign Ministry said.

Habibie's trip follows a meeting Sunday in Jakarta between Hashimoto and Indonesian President Suharto in which Japan pressed Indonesia to speed up the implementation of promised economic reforms.

The International Monetary Fund has postponed extending the latest installment of a \$ 43 billion emergency rescue plan for Indonesia amid concern Suharto was backsliding on his commitment to liberalize his country's economy.

Japan and Singapore have agreed to contribute \$5 billion to the IMForchestrated bailout package for Indonesia, making them the two largest single contributors.

Habibie was sworn in Monday as Indonesia's new vice president.

## Foley says Japan trade surplus could become a political issue


TOKYO (AP) - U.S. Ambassador Thomas Foley said Wednesday Japan's growing trade surplus could become a political issue in the United States during this year's congressional elections.

Speaking at a luncheon, Foley urged Japan to open its markets and buy more goods from the ailing economies of Southeast Asia and South Korea.

One way for Tokyo to soothe trade tensions and help ease the Asian economic crisis would be to revive domestic growth.

Foley said he would be "very impressed and satisfied" with an 8 trillion to 10 trillion yen (\$ 62 billion to \$78 billion) economic stimulus package that he said he expects Japan's governing Liberal Democratic Party to propose soon.

Last week, the Finance Ministry

announced that Japan's current account trade surplus with the world in January had mushroomed to more than three times its level a year earlier.

The surge reflected a low demand for imports due to a sluggish domestic economy and robust sales in the United States and elsewhere of Japanese goods.

Japan's economy remains mired in an 8-year-old slump.

Washington has repeatedly urged Tokyo to spend its way back to growth, either by increasing funds for public works or cutting taxes.

## **RP** pushes for radar project

MANILA, Philippines (AP) Citing a plane crash last month that killed 104 people, the Philippines' transportation chief pressed Tuesday for restoration of a shelved radar project to improve air safety.

Transportation and Communications Secretary Josefina Lichaucosaid the Feb. 2 crash of the Cebu Pacific DC-9 was a reminder of the urgent need to improve the country's radar system.

A 3.45 billion peso (\$86.2 million) radar system upgrade was being planned in 1994 by GEC-Marconi Avionics of Britain but was shelved after criticism that the project was overpriced.

The plan was to create a national system uniting civilian and military radar, which now are operated separately

"Seeing that most of the recommendations of the air safety task force in 1994 remain unaddressed to this day, there definitely is a need for the project to be implemented, in fact, within the soonest time possible," Lichauco said in a statement.

"Effective airnavigation (is) something we have to undertake urgently given the nightmare of the recent air tragedy." she added.

The plane crashed as it was preparing to land in the southern city of Cagayan de Oro. Air transport officials investigating the accident have not released a report on its cause.

Civil authorities now operate about five radars across the Philippines. The military has only one fully functioning radar facility, hampering the country's ability to detect foreign intrusions

The functioning radar, on Lubang Island in Mindoro province, south of Manila, monitors the southwestern section of the archipelago.

Two other radar stations in the north were not fully functional, the military chief said in a Senate hearing last October.

The military depends on the government's civilian radar to monitor foreign air and sea intrusions but these have limited capabilities, officials said.



The human rights accord was to be signed later Monday in the Netherlands, where peace talks aimed at ending one of the world's longest Marxistinsurgencies have proceeded sporadically since 1992.

"Along the tortuous way, we have hurdled many obstacles to reach what at times seemed to be an unreachable goal,"Howard Dee, the chief government negotiator, said in a statement.

The accord, called the Comprehensive Agreement on Respect for Human Rights and International Humanitarian Law, is the first of four agreements the two sides hope to reach in a political settlement to end nearly three decades

Details of the agreement, which commits the two sides to respect human rights, were not immediately released.

"The first fruit of this agreement must be a marked reduction or, better yet, a total suspension of armed hostilities," Dee said.

He said the two sides will be able to shift their focus from "annihilative offensives" to the promotion of human rights, especially for poor Filipinos.

BANGKOK, Thailand (AP) \_ Stung by the biggest economic crisis in decades, Southeast Asian nations are developing an alarm system to help defuse future turmoil before it erupts.

The system would depend on "a checklist of triggers of financial and economic crises,"according to a draft proposal from the Association of Southeast Asian Nations seen Wednesday by Dow Jones Newswires

The proposal was approved in principle by ASEAN finance ministers

#### Singapore to maintain active role in local property market

SINGAPORE (AP) \_ A government minister has said Singapore will continue to monitor the local property market and make efforts to curtail sharp swings in land prices which could undermine the country's financial and economic stability.

Development Minister Lim Hng Kiang told Singapore's parliament Tuesday the government has no plans to lift anti-speculation curbs on the property market implemented in May 1996, The Straits Times newspaper reported Wednesday

The measures were implemented during a period when property values ballooned, but in recent months weak demand has caused real estate prices to fall.

The government's stance is important because it is the main supplier of land for property development.

Kiang said the government will promote pricing transparency by publicizing its land sale programs in advance and providing information on property stocks, occupancy levels and supply, the newspaper report said. "But at the end of the day, market forces will settle the price levels, not the government," the paper quoted Kiang as saying.

#### Islamic banks urged to help Indonesia end economic crisis

JAKARTA, Indonesia (AP) - Indonesia is appealing to Islamic banks around the world to help it overcome its worst economic crisis in three decades.

In a meeting Wednesday, President Suharto told an official of the Organiza tion of Islamic Conference, which represents more than 50 countries, that Islamicbankswerenotdoingenoughto back Indonesia.

The official, Muchrim Hakim, said there are about 40 Islamic banks nationwide.

"We hope the banks will help Indonesia with their money, not promises and oral statements at seminars or gatherings," said Hakim, vice president of the Islamic Chamber of Commerce for Southeast Asia.

Indonesia is 90 percent Muslim.

Hakim, who visited Dubai recently, said Dubai Islamic Bank would accept Indonesian letters of credit to help Indonesiantradersexport cotton to that counuγ.

The warning bells include over-valued currencies, lending booms, and increases in short-term borrowing denominated in foreign currency.

The economic crisis was blamed on "poor banking supervision and lack of transparency" in the financial system.

The crisis began last July when Thailand abandoned its fixed exchangerate system after nearly draining its foreign reserves in a futile defense of the baht.

The illness spread rapidly to other Asian countries that foreign investors thought resembled Thailand in their financial flaws. Eventually, financial markets worldwide were affected.

Thailand, South Korea and Indonesia are in recession and have received more that \$100 million in bailouts arranged by the International Monetary Fund. Most other Asian countries are suffering lower growth.

As the crisis began, some South east Asian countries blamed foreign currency speculators. But increasingly, leaders acknowledge the blame lay with regional governments.

The ASEAN proposal says such mistakes can be avoided by practices used by the Group of Seven leading industrial countries and ECOFIN, an organization of European Union finance ministers.

Leaders of those groups hold regular meetings in which they coordinate cooperation on economic-policy issues, the proposal says.

ASEAN countries also need to go beyond the global economic-monitoring system adopted by the IMF, the proposal says, which fails to capture "the essence of regional relation-

A regional system can encourage peer pressure to pursue sound policies, it said. A database could be developed to compare relative financial health between members.



## **General: Thai shelling kills 7**

BANGKOK, Thailand (AP)\_A Tha general said Wednesday that seven members of a Myanmar band of marauders were killed and 20 wounded when his troops shelled their camp across the border.

The Thai army shelled the base inside Myanmar belonging to the pro-Yangon Democratic Karen Buddhist Army on Sunday in retaliation for its cross-border attacks on refugee camps in Thailand.

Members of the DKBA are reportedly furious over the Thai assault and have vowed to burn down all the refugee camps in Thailand.

"Good. I'm glad they are furious. This (retaliation) is one way of telling the DKBA that we will not tolerate their actions.

We will not allow our sovereignty to be violated," said Gen. Chamlong Photong, commander of the 3rd Army, based along the Thai-Myanmar border.

He said the casualties were confirmed by Col. Sai Phone of the Myanmar army in neighboring Myawaddy.

More than 100,000 people, mostly ethnic Karen, are living in more than 20 refugee camps in Thailand after fleeing abuse and offensives by the Myanmar army.

Most of the refugees are sympathetic to the Karen National Union, a guerrilla group that has been fighting for Karen autonomy since 1948.

The Myanmar army has launched an offensive against the KNU 7th Brigade, which abandoned its mobile

headquarters inside Myanmar this land. week.

Myanmararmy operations against the KNU are frequently accompanied by theft, burning of villages, rapes, torture and extra-judicial killings against Karen villagers.

The DKBA split from the KNU and allied itself with the military government in Myanmar, also known as Burma, in 1994. It has repeatedly attacked the refugee camps in Thai-

"I can't accept the fact that innocent people, women and children, in these camps are being attacked. There are just too many children running around in these camps," Gen. Chamlong said. "We look at them as refugees but

the DKBA looks at the Karens in these border camps as terrorists," he added.

Also Wednesday, the Australian

government condemned the attacks on the camp and instructed its ambassador in Yangon to protest to the Myanmar government and ask it to stop the DKBA attacks.

The DKBA is armed and controlled by the Myanmar army. Refugees have said that Myanmar troops have participated in some of the attacks on the refugee camps.

"The Myanmar army in the area keep saying that they cannot control the DKBA," Gen. Chamlong said.

He said that in the past, the attacks on the camps were intended to force the refugees to return to Myanmar under DKBA control. Now, however, with the refugees clearly rejecting the DKBA, he believes the attacks are motivated by revenge.

## **Dead man sentenced to 20 years**

**PHNOM PENH, Cambodia (AP)** The Cambodian court that convicted deposed co-prime minister Norodom Ranariddh of conspiracy also ordered a 20-year prison sentence for one of his co-defendants, even though he has been dead for almost eight months.

The late Brig. Gen. Chao Sambath former deputy chief of the army's intelligence department, was one of dozens of Ranariddh supporters executed in the aftermath of the coup last July in which Second Prime Minister Hun Sen toppled Prince Ranariddh.

Judge Nhey Thol said the government decided to try Chao Sambath because it was not convinced he was dead.

"The court has no evidence, so we still consider him alive," he told reporters before the trial opened.

Chao Sambath's badly decomposed body was exhumed by human rights workers in Kompong Speu province five months ago. He had been shot in the head and had a broken leg and arm, indicating probable torture before the killing, they said Family members positively identified Chao Sambath's body, including a distinguishing tattoo on his forearm. They criticized the court proceedings Wednesday.

"If they want to put him in prison, they will have to go get his bones," said a relative who asked to not be identified. "They already killed him \_ isn't that enough?"

The military court on Wednesday found Ranariddh, Chao Sambath and two other Ranariddh loyalists guilty of plotting a takeover in league with Khmer Rouge guerrillas. Ranariddh, in exiles ince the coup, received a 30-year prison sentence.

The charges are widely seen as politically motivated, and the trial is being called a sham by observers. The court system is under the influence of Hun Sen's Cambodian People's Party.

Amnesty International, the London-based human rights group, called the decision to summons Chao Sambath "farcical" and noted no one had ever been arrested for the killing and torture of scores of the prince's supporters.

CANBERRA, Australia (AP) — The government said Wednesday some illegal foreigners arriving in Australia had been detained for "appalling" lengths of time, and outlined a plan to streamline immigration appeal procedures.

A United Nations Human Rights Committee in May last year criticized Australia for detaining for more than four years a Cambodian man who arrived illegally by boat. The committee said his human rights had been breached.

The Australian government rejected the criticism at the time. But Immigration Minister Phillip Ruddock topped the figure Wednesday, saying one applicant had waited five and 1/2 years for a decision on his refugee application.

"This is appalling," Ruddock said. Many other foreigners refused entry to Australia, either as migrants or refugees, faced very long delays, he said.

Under the conservative Liberal-National government's plan, applicants' right to appeal deportation decisions by the government-appointed Refugee Review Tribunal would be removed from the courts, which are independent of government. Instead, most appeals would be heard in special tribunals set up by the government.

Ruddock criticized decisions Australian judges have made in deportation cases.

"Only two weeks ago, a (government) decision to deport a man was overturned by the Federal Court, although he had been convicted and served a jail sentence for possessing heroin with a street value of U.S. \$ 2 million (Australian dollars 3 million)," Ruddock said.

"The courts have reinterpreted and rewritten Australian law, ignoring the sovereignty of parliament and the will of the Australian people. This is simply not on."

The new measures, if enabling legislation is passed in the upper house of Parliament, where the government does not have a majority of votes, will reduce the amount of time taken for judicial review and retain the fairness of the present system, Ruddock said.

Immigration lawyer Colin McDonald said the plan would be a disaster if implemented.

"It is essential, if there is to be any semblance of fairness in the refugee appeal system, for there to ultimately be an entitlement for recourse to a judge," McDonald said.



## <u>According to Butler:</u> **Iraq inspections done in a year**

UNITED NATIONS (AP) — U.N. arms experts could finish their job in Iraq within a year if Baghdad honors last month's agreement and allows weapons inspectors unhindered access to presidential palaces and other sites, the chief inspector said Wednesday.

That could set the stage for the Security Council to lift crippling economic sanctions imposed on Iraq in 1990after President Saddam Hussein invaded Kuwait, touching off the Gulf War.

"My perception is ... that we could get this done within a year or so maybe slightly less," Richard Butler, head of the U.N. Special Commission, said in an interview with Associated Press Television.

"Who knows? It depends on the degree of cooperation" from Iraq.

Butler leaves New York on Thursday for meetings in Vienna with the International Atomic Energy Agency. He then travels to Baghdad, where he will holds talks Sunday and Monday with Iraq's deputy prime minister, Tariq Aziz.

U.N. officials said that Butler's teams will then begin inspecting eight presidential compounds that Iraq agreed to open under a deal signed Feb. 23 with Secretary-General Kofi Annan.

Iraq had placed those sites off limits, prompting the United States and Britain to assemble a huge military force in the Gulf and threaten air

#### Over 40 die in Cameroon of mystery virus

**YAOUNDE, Cameroon (AP)** — More than 40 people have died in the past three months of an unidentified virus in Cameroon's East province, health officials said Wednesday.

The disease, which is marked by severe headaches, vomiting and bloody diarrhea, has not yet been identified, Dr. Mpiwong Lombo, a Cameroonianhealth official, told The Associated Press.

Victims can die of dehydration three days after contracting the disease, he said.

While the disease has some of the same symptoms of the deadly Ebola virus, Ebola has been ruled out, Lombo said.

Health officials quoted on state radio said 330 cases had been reported since December in the Ngoyla area, which borders the Republic of Congo..

Out of those, 40 had died, 147 had been cured and the rest were being treated in nearby hospitals.

The privately-owned Galaxy newspaper also carried reports of the disease, but put the casualty figures at 63, with more deaths daily.

It said Ngoyla, which has a population of about 100,000, had only two senior nurses for the whole area.

Ebola, which causes massive internal bleeding and is spread through bodily fluids, kills up to 80 percent of those infected.

Symptoms include fever, vomiting, diarrhea and severe internal and external bleeding.

Outbreaks occur in Africa, where a 1995 outbreak in Congo, then called Zaire, claimed 245 lives. strikes.

Butler's inspectors are trying to determine whether Iraqhas complied with U.N. orders, issued in 1991, to destroy all long-range missiles and chemical, nuclear and biological weapons.

Iraq claims it has complied but that the United States and Britain have manipulated the inspection program to keep sanctions in place. Butler, however, said he believed that once his team reported Iraqi compliance, "I'm sure they'll be full support from the council" to end sanctions.

He said the biggest question was the state of Iraq's biological weapons program.

"It is the field where Iraq has been the least helpful," Butler said. "After all, in our seven-year relationship, they spent the first four years denying they had such a program at all."

He said Iraq's most recent claims about the state of its biological weapons program "sadly has been a story that has not been able to be accepted, not just by us but by international experts."

Australian ambassador to the United Nations, said he was encouraged by a "new spirit" of cooperation which Iraq has demonstrated since the Annan agreement.

He cited the fact that American inspector Scott Ritter had been allowed to inspect the Iraqi defense ministry for the first time in seven years. In January, the Iraqis refused to allow Ritter to perform inspections, claiming he was a spy.

Butler refused to say what Ritter had found at the ministry but said there was "no surprise there."

Asked whether he expected to find any proscribed materials in the presidential sites, Butler said his teams wanted to verify "not the presence but the absence of prohibited materials."

"We must be able to do that credibly, believably, and that means full access at any time, full cooperation by Iraq through the presentation by them to us of any relevant materials," he said.

"Truly, the ideal circumstance is actually that we find nothing provided we can report that credibly."

March is Developmental Disabilities Awareness Month Think "People First"

L anguage is a reflection of how people see each other. That's why the words we use can hurt. It's also why responsible communicators are now choosing language which reflects the dignity of people with disabilities —words that put the person first, rather than the disability. Read on for a short course on using language that empowers.

- 1. Think "people first" Say "a woman who has mental retardation," rather than "a mentally retarded woman."
- 2. Avoid words like "unfortunate," "affected" and victim." Also, try to avoid casting a person with a disability as a superhuman model of courage. People with disabilities are just people, not tragic figures or demigods
- 3. A developmental disability is not a disease. Do not mention "symptoms," "patients" or "treatment," unless the person your writing about has an illness as well as a disability.
- 4. Use common sense. Avoid terms with obvious negative or judgmental connotations, such as "crippled, deaf and dumb, lame and defective." If you aren't sure how to refer to a person's condition, ask. And, if the disability is not relevant to your story or conversation, why mention it at all?
- 5. Never refer to a person as "confined to a wheelchair". Wheelchairs enable people to escape confinement. A person with a mobility impairment "uses a wheelchair."
- 6. Try to describe people without disabilities as "typical" rather than "normal."

The proposed deal will be presented in China next week by senior State Department officials, the paper said.

It said the proposal was sent on March 12 to senior officials at the State, Commerce and Defense departments, the Joint Chiefs of Staff, the Office of the U.S. Trade Representative and NASA.

The paper quoted from a cover letter, stamped "secret," from Gary Samore, a White House National Security Council official, which said:

## Pentagon restricts drug

#### By LAURA MYERS

WASHINGTON (AP) \_ The Pentagonsaid it won't give U.S. troops an experimental drug that has been implicated in post-Gulf War illnesses except when a specific nerve gas attack is imminent.

Thedrug, pyridostygmine bromide, or PB, "is a valuable and necessary element" of defense against chemical weapons attacks, Gary Christopherson, acting assistant secretary of defense, told the Senate Veterans' Affairs Committee in a letter.

But in the future, he said, PB will be used only if "intelligence indicates imminent use of the nerve agents Soman or Tabun against U.S. forces" or when one of the poisons is actually being used.

During the Persian Gulf War against Iraq in 1991, the military gave PB to about 600,000 troops without their consent although the Defense Department had no reason to believe Soman and Tabun were being used. Instead, intelligence indicated Iraqi leader Saddam Hussein had stockpiles of the nerve gas Sarin.

Sen. Jay Rockefeller of West Virginia, ranking Democrat on the Senate committee, said Tuesday that the limited use for the drug suggests the

Pentagon never should have given it to Gulf War troops.

"The DoD has finally acknowledged that our troops were given a drug to protect against a nerve agent they knew the enemy did not have," Rockefeller said.

"That this happened to our troops is very disturbing. That it took the DoD seven years to admit their error is inconceivable."

The Department of Defense guidelines for the future use of PB were laid out in a letter to the committee, which held a hearing Tuesday on the matter, in answer to questions posed by Rockefeller.

The senatorsaid he wanted to know Pentagon plans on the use of vaccines and drugs to counter chemical weapons in case the Iraq crisis flares into conflict.

In January, the United States came close to ordering a substantial air attack on Iraq after Saddam refused to allow U.N. inspectors full access to suspected sites for making nuclear, chemical and biological weapons.

The inspectors are now back at work, but U.S. forces remain on alert, including aboard two carriers. Defense Secretary William Cohen already has announced plans to speed

up vaccinations of U.S. troops to

#### counter anthrax. During the Gulf War, the Pentagon

didn't tell U.S. troops they were given the experimental PB because the military did not want to tip off Iraq about its preparations for such attacks.

The Food and Drug Administration, which had approved the drug's limited use, complained and the Pen-

tagon said future vaccinations will be fully disclosed.

PB is under scrutiny for possible links to Gulf Warillnesses, which can include chronic fatigue, headaches, nausea, diarrhea, depression, joint and muscle pain, rashes, memory loss and insomnia. Thousands of Gulf War veterans have complained of

such undiagnosed maladies.

Algeria disallows UN rights visit 1992. Some 75,000 people are esti-GENEVA (AP) — Algeria apmated to have died in the conflict. pealed to the world's main human rights commission on Wednesday forhelp in combatting terrorism, but refused to consider allowing U.N. human rights experts into the coun-

Algerian Foreign Minister Ahmed Attif asked the 53-nation U.N. Human Rights Commission to acknowledge that Algeria faces terrorism and to help cut off money and weapons to the terrorists, among other things.

"It is urgent that the international community understand the unacceptability of terrorist violence, in whatever form and with whatever motivation," he said.

Terrorists in Algeria "wanted to impose a totalitarian, retrograde society,"Attifsaid, not mentioning the armed Islamic militants whom the government has been battling since

Attif rebuffed suggestions that a U.N. inquiry might be needed to determine whether human rights violations have occurred during the conflict. Privatehumanrights groups contend that Algeria's security forces may have taken part in some of the attacks.

Attif said the government wouldn't consider a visit by U.N. experts at the moment. Moreover, experts on execution and torture hadn't asked to visit, he said.

However, U.N. officials, speaking on condition of anonymity, said experts had met with the Algerian diplomats to express "their desire to make a joint mission to Algeria."

The Algerian government, which puts the death toll at about 27,000, insists the warfare is an internal affair and has rejected calls for a full international investigation.

He mentioned, for example, statistics which showed that of 354 labor camp inspections in 1997, at least 77 percent or 271 were conducted in the CNMI.

"All of the employers in the States were inspected once in 1997. The employers in the CNMI were inspected repeatedly, at least 47 or 17 percent of these employers were inspected twice during 1997; some of them were inspected more than twice," Chun said. He pointed out that inspec-



payments from a reduced revenue base as a result of reduced port activity. Sound complicated?

It is, but that's the world we live in. I suppose some areas will have more water available than now is the case and there will be less pressure on parks, police, fire and immigration.

So, with the departure of the manufacturing sector that will leave tourism as the principal source of fuel for the Commonwealth's economic engine.

Tourism is a highly competitive

industry. In my opinion, now is the time to develop an economic contingency plan to attempt the difficult task of diversifying the economy and 'take some of our "economic eggs" out of the tourism basket and work to replace those that fall from the garment basket.

The primary goal in my judgment should be to: maintain current govemment revenues without a reduction in services and without a tax increase.

If this is not done - then look forward an eventual reduction in govemment services along with the possibility of an increase in taxes.

There are only two ways for a government or a business to make money: hold expenses and increase income.

If that's not possible - then maintain the income level and reduce ex-

So what might the scenario be when the garment industry relocates? There are those in the community that would welcome a reduction in the size of the economy along with fewer nonresident workers.

These people should also be willing to accept the "trade -offs" that accompany reduced economic activity and the distinct possibility that a smaller economy means diminished government revenues, less government services with fewer employment opportunities which seems to be the career choice for many.

Less money in circulation and thus lower profits for many businesses; reduced demand for leased land and rental property; less disposable income; possibly reduced retirement benefits; lower salaries and, as a result of what economists refer to as unachieved or limited "economies of scale" resulting from a smaller market, possibly higher utility rates along with an increase in the cost of living primarily as a result of higher freight rates on

imported commodities because surface carriers will have to contend with a one way revenue generating voyage by returning with empty cargo holds.


It other words, "deadheading." It may be that we will soon have an economic tiger by the tail and we had better attempt to plan to ride it's back rather than run the risk of winding up inside.



## Woods tries to end slump

By DOUG FERGUSON ORLANDO, Florida (AP) \_ Times are indeed tough for Tiger Woods.

Never mind that he's had a chance to win all of the four tournaments he has completed this year \_ two seconds and a third before really bottoming out two weeks ago at Doral by tying for ninth.

Ignore his PGA Tour rankings\_first in overall driving, second in scoring, fourth on the money list, an average of dlrs 133,400 per event.

The Masters is four weeks away, and Woods is still looking for his first PGA Tour win of the year.

"I'm just hoping to peak at the right time," he said. "I know I need to work on a few things, and I'm working on them right now. But I've got to take care of two tournaments before then."

The first one starts Thursday when Woods leads the best field of the year in the Bay Hill Invitational, where tournament host Arnold Palmer has ordered up thick rough and hard, fast greens at Bay Hill Club.

Woods and defending champion Phil Mickelson are among 36 of the top 50 players in the world at Bay Hill. Among those missing are David Duval, who withdrew Wednesday, and Greg Norman, who has decided to play only Doral and The Players Championship as his prelude to Augusta.

Woods has won once this year, coming from eight strokes off the lead on Sunday to beat Ernie Els in a playoff at the Johnnie Walker Classic in Thailand.

His last PGA Tour victory came at the Western Open in July, a streak of 13 starts.

A slump? Don't bet on it.

"I'm playing a lot better than I did last year at this time," Woods said. "Last year I had great rounds, and I had really bad rounds. This year has been pretty much an even keel. If I keep doing that, improving and hopefully get a few putts to fall in at the right time, who



knows? I can start winning again."

Woods didn't exactly roll into Augusta last year with a full head of steam. He tied for ninth at Bay Hill a year ago, although he was never in contention, then tied for 31st the next week at TPC.

At the Masters, he rebounded from a 40 on his first nine holes to win by 12 strokes in a record 18-under-par 270, took a month off and then won again at the Byron Nelson.

Still, there's no substitute for confidence, and Woods would like nothing better than to head to Augusta having won at least once on the PGA Tour.

"It would help out a lot," he said. "I've been right there in the hunt going into Sunday, or ended up in the hunt. It would be nice to get that one win under your belt. But if it doesn't happen, it doesn't happen. As long as my game peaks in April."

This week figures to be a stiff test.

Bay Hill can be trouble in prevailing spring winds \_

Woods hit a driver and a 4iron just to reach the 18th hole. And just in case the conditions are relatively tame, the greens won't be.


"The thing I've tried to do is give the golfers a little bit of a taste of what they're going to be seeing probably at The Players Championship and the Masters, and that's some fairly fast and hard greens," Palmer said.

"Barring rain, the golf course is going to play reasonably difficult, maybe a little more difficult than it has over the past couple of years." Mickelson won last year by

closing with a 7-under 65 to win by three strokes over Stuart Appleby.

It was his first victory in Florida and seemed to put him in perfect position to win his first major. What did Mickelson do? Miss the cut at TPC and the Masters.

"Last year was a huge disappointment," Mickelson said. "Coming off a win here, I really thought I'd carry it into Augusta."

### His status as the WBC's 175-pound (78-kilogram) champion is uncertain, however.

The WBC has designated a fight Saturday in Berlin between Michael Nunn and Graciano Rocchigiani of Germany, with the winner to challenge Jones.

Jonessaidhe probably wouldn't fight the winner, meaning he would be stripped of the title by the WBC, making either Nunn or Rocchigiani the champion.

In his most recent fight, Jones regained the WBC title he had lost on a disqualification for hitting Montell Griffin while he was down. In the rematch, Jones knocked out Griffin in the first round Aug. 7.

It appeared Jones was headed toward a heavyweight fight against Douglas, with the understanding he would get a title match against Evander Holyfield if he won. Then he asked the advice of his father, his former trainer.

"My father told me, 'You're not guaranteed enough money,'"Jones said. 'You're not a heavyweight, and they tell you if you win, Holyfield will be next. But if you beat a heavyweight, Holyfield might not be next.'Jones, a former IBF middleweight and super middleweight champion, has a 35-1 record, with 30 knockouts.

The tournament is limited to 60 participants only and features six categories: Championship Flight, A-Flight, B-Flight, C-Flight, Seniors and Ladies.


If there are less than 6 participants in a flight, that category will be cancelled and entrants will be placed in another flight based on their handicaps.
