## **62 Rota homesteaders** may lose their permits

SOME 58 village homesteads and at least four agricultural ones on Rota have been found not complying with government regulations requiring permit holders to build structures within three years.

In an interview, Public Lands Administrator Louise Morisheta said the 62 permit holders will be issued revocation notices in the coming days.

## Plan to put up schools in Alamagan, other isles

THE PUBLIC School System's new capital improvement projects would consist of schools to be built in the remote islands of Alamagan, Anatahan and Agrigan.

Education officials said funding for the new school projects would be taken from the \$32 million it recently received from the CNMI's general obligation bond.

In the recent CIP committee meeting, Board of Education member Thomas Pangelinan pointed out the need to have small **Continued on page 23** 

"These people will be notified in letter. We have been packed up issuing revocation letters. We will be notifying these people on the revocation of their permits," said Morisheta.

She said though that the Division of Public Lands (DPL) may have to allow the erring permit holders an extension depending on the latter's justification for failure to build houses on their designated lots.

Areas covered by the inspection, which was held January this year, include Sinapalo II and III. Morisheta said there is another 63 village homestead permit holders on Sinapalo III that were found not complying with the regula-

tions. But, she said, since the village is a relatively new one, the erring homesteaders will merely be issued notices asking them to expedite construction.

The 58 village homesteads recommended for revocation is all in Sinapalo II.

No inspection was done on Sinapalo I as the lots there have already been deeded.

There were 13 agricultural homesteads inspected of which four were recommended for permit revocation and three will be issued letters to continue improvement.

### Man found dead off Suicide Cliff

A 22-YEAR old man who had been reported missing by his family was found dead at the foot of Suicide Cliff in Marpi, Sunday, according to the police.

The remains of William Gerald Torres was pulled out from a deep ravine, police said.

Police are still investigating whether the death is accidental, a suicide, or a result of foul play.

In a release, public safety spokesperson Rose Ada said police received a report about an abandoned vehicle on Suicide Cliff, Saturday afternoon.

Police were immediately dispatched to search for the vehicle occupant, but found none

The following day, the family of the victim filed a report to the police's missing persons unit after they were informed about the abandoned car.

The family rented a helicopter which helped in the search and later spotted the body which was retrieved by rescue teams from the ravine. Ada said investigators are

still consulting with the Attorney General's Office whether there is still a need for an autopsy.



WASHINGTON (Reuters) -With hopes fading of an early agreement to bring China into the the World Trade Organisation, President Bill Clinton is expected this week to ask Congress for a simple one-year extension of U.S. trading privileges for China.

He is expected to ask on Thursday for just a one-year renewal because negotiations on a broader deal with China have suffered a series of setbacks.

Clinton to strike a deal with Chines Premier Zhu Rongji during his visit to the United States in April, the bombing of the Chinese Embassy in Belgrade earlier this month and the release of a scathing report last week alleging Chinese nuclear spying.

Even a scaled-down request for renewal of China's trade status once called Most Favoured Nation (MFN) and now named Normal Trade Relations (NTR)-for just one year will likely spark an intense battle in Congress, where China bashing is in vogue.

"I think there are people who are going to perceive that trade is another avenue for espionage," said Russell Smith, a trade lawyer with Willkie Farr & Gallagher.

Congress can vote to overturn Clinton decision to renew trade benefits. NTR gives China the same low-tariff access to U.S. markets as nearly every other country in the world.

Labour unions oppose it, but business groups plan to fight hard for it and trade analysts believe that in the end lawmakers will

## Japan's anti-organized crime bill becomes law

By MARTIN FACKLER TOKYO (AP) — Japan's lower house Tuesday passed a bill that would finally allow police to use wire taps against organized crime, a power long enjoyed by law enforcers in other countries.

But as the bill goes to the upper house for final approval, opposition groups have vowed to fight it to the end.

Japanese police's spotty record of using its powers in support of conservative rule and against leftwing politicians and groups.

By passing the lower house, the more powerful chamber in Japan's bicameral Parliament, the bill is almost assured of becoming law. Behind the measure has been a

groundswell of public support.

A large segment of voters had long opposed handing police increased powers as long as memories were still fresh of secret police brutality during World War II and then crackdowns on radical students and labor unions in the 1950s and 1960s.

That changed in the wake of the 1995 poison gas attack on Tokvo subways by a religious cult that killed 12. An enraged public de-

manded law enforcement be more aggressive in monitoring potentially dangerous groups.

For their part, police have long sought the power to wire tap, saying it would strengthen their hand against the yakuza, Japan's organized crime syndicates. They point to how recorded conversation's helped U.S. investigators lock up New York Mafia boss John Gotti for life.

Two other bills also under consideration would stiffen penalties for organized crime and increase protections for witnesses.

The wire tap bill has already been rewritten once in an attempt to allay opposition fears.

The new version requires police to seek court permission for each wire tap, and that would be granted only in cases involving smuggling of drugs, weapons or persons, and murder. Kidnapping and arson were stricken from the list during the revision.

Opposition remains stiff, however, because of a deep-seated distrust of the police.

Critics of the bill point to an incident in 1986, when a Communist Party lawmaker accused police of bugging his phones.

Police at first issued denials but were eventually forced to admit the taps were theirs.

To address these concerns, the bill requires a third party monitor be present to ensure that wire taps are used only for their intended purposes. Transcripts of all taped conversations must also be submitted to a court.

"When the police, who are supposed to be enforcing the law, get caught breaking it, they just feign ignorance," said an editorial in the influential, left-leaning Asahi newspaper.

"In this country, no institution exists that can seriously control or serve as a check on the police," the Asahi said.

Leftist opposition to bills is not without irony, given the role the underworld has lent in the past to roughing up leftist demonstrators and labor unions.

But opponents say they have no choice for fear the new powers would be used for political purposes.

"Ordinary citizens will end up becoming the main targets,' Yukio Edano, an opposition Democratic Party lawmaker, was quoted as saying in the Asahi.

## Deadly virus kills 2 in Malaysia

KUALA LUMPUR, Malaysia (AP) — A new virus that has killed more than 100 people in Malaysia has claimed the lives of two more victims on the outskirts of Kuala Lumpur, news reports said Tuesday.

Both of the latest victims were workers at a pig farm who had been hospitalized since May 15 after being infected with the deadly Nipah virus, the Sun newspaper reported.

Their deaths, which occurred last Friday and Saturday, brought the official death toll for the viral

encephalitis outbreak in this Southeast Asian nation to 103.

The virus first surfaced in Negri Sembilan state in western Malaysia. It has since swept into the states of Perak, Johor, Kelantan, Malacca and Selangor. .Health officials initially believed the disease was Japanese encephalitis, which is transmitted from pigs to humans by the Culex mosquito. Later, scientists identified a new virus, named Nipah after the Malay-

The stubborn virus, which first spread from pigs to humans, has baffled international and local scientists researching its origin and mode of transmission. Scientists recently determined that it might be spread through other animals, including horses, cats and dogs.

The eight-month outbreak has ruined the pig-farming industry in many parts of Malaysia. Pig farmers in the worst-hit area, 60 miles southeast of the capital of Kuala Lumpur, abandoned their homes in March.

HOPES are high that China Airlines will consider flying directly to Saipan as current market demand shows great potential, the Marianas Visitors Authority (MVA) disclosed yesterday.

The Taiwan-based airline firm had its inaugural flight in the neighboring island of Guam on March 18, and the CNMI is optimistic it will also receive the same flights and services.

Taiwan arrivals into the CNMI posted the largest increase of 33 percent among the Northeast Asia markets in April compared to the same period last year.

MVA also recorded a 95 percent increase in arrivals from Taiwan in February and 23 percent in January this year.

MVA Board chairman David Sablan said when the CNMI first expressed its willingness to have China Airlines to service Saipan early this year, the said airline firm did not discount the idea.

"I think we should revisit them ... Taiwan as a point of origin has a great potential. The market is there," said Sablan, as he urged Gov. Pedro P. Tenorio's Aviation Task Force to form a mission team to hold discussions with the officials of China Airlines soon.

The MVA official pointed out that Taiwan nationals have restarted travelling to other destinations like Thailand after getting hit by the Asian economic crisis,

and the CNMI also aims to capture part of Taiwan travellers' grout

Sablan said MVA is in the process of developing the Chinese market in order to induce China Airlines to operate here.

"We are willing to cooperate with them, to extend incentives to them just like what the Aviation Task Force and the CPA are giving to airlines that qualify to these various incentives . . .

"We should really develop that market together with the airline which is willing to provide us service from Taiwan as point of origin," said Sablan.

He added that China Airlines. which boasts of latest equipment, may utilize Boeing 757 and

Boeing 767

"Most likely they will be using newer equipment," he added. China Airlines is flying biweekly to Guam using MD-11 aircraft which has a capacity of

304 passengers. Early this year, MVA requested Far Eastern Air Transport (FAT) to service the CNMI. Although

FAT did not down play the idea, it admitted having some problems on its equipment. MVA then moved to request

Eva Air but the airline firm was more interested in servicing metropolis cities.

"Obviously, Saipan is a resort island so they did not consider flying here," said Sablan. Only China Airlines had the

greatest potential to service the CNMI at that time and the MVA now is pursuing this.

In related news, a Taiwan-based magazine, China Times Weekly, recently visited Saipan to take photographs for its June issues, a development which local tourism officials believe will give the CNMI additional exposure as a prime tourist destination for Chinese nationals.

The most popular modelling magazine in Taiwan, CTW will give the CNMI four pages of exposure through editorial or a travel report, and 28 pages of photographs of spots and swimsuits.

CTW has a 250,000 circulation and a readership profile of 18 to 45 years old.

## MVA's Saipanda big hit in Japan

THE MARIANAS Visitors Authority's advertising concept "Saipanda" has now become a sensation in Japan three months after its formal introduction, a development which is expected to boost Japanese arrivals into the CNMI, it was learned. Bartley Jackson, MVA Board member, informed tourism officials of Saipanda's effectivity

as a vehicle to separate and differentiate the identity of Saipan from Guam, on top of Japanese nationals' apparent penchant for characters and mascots.

MVA admitted that among tourists who have not heard of Saipan or who have not known its location, the mere mention

of Guam used to make it easier for them to relate.

With the introduction of Saipanda, Japanese have become more curious about what it stands for and therefore makes them more interested.

Local tourism officials have expressed optimism this advertising concept will put Saipan in Japanese tourists' priority list of favored-destinations.

"Saipanda is now creating a mind share for Saipan separate from Guam. We are creating a lot of attention and interest in Japan and the recall of Saipan is proving helpful for us," Jackson said

Hocog has more absences in his first 14 months as House member compared to Cing's record during the past eight years, the senator said.

"The reasons for those absences were valid-either I was on official business or I had to attend to my mother, who was then sick and dying," Cing said.

"The voters should not tolerate absenteeism among their elected representatives.

## DPH warns the public against dengue, Japanese encephalitis

Variety News Staff THE DEPARTMENT of Public Health yesterday issued a stern warning to the community against possible outbreak of the dreaded dengue fever and the Japanese encephalitis virus

Acting Health Secretary Ned Arriola yesterday said current weather condition has increased the breeding of adult mosquitoes which are carriers for life-threatening viral diseases.

"Rainy days are here again, and we don't want to take any chances. We don't want another outbreak," said Arriola.

DPH's issued the warning to help prevent mosquitoborne outbreak in the CNMI just like the recent dengue outbreak in the Philippines and the Japanese encephalitis in Malaysia which forced its

government to kill hundreds of pigs.

"All home owners, business establishments, schools and the general public has a vital role in preventing the spread of harmful communicable diseases that can be transmitted by mosquitoes by simply following prevention steps . . .," said Arriola. The acting health secretary

urged home owners, schools. business establishments and the general public to clean their surrounding by disposing of trash and garbage properly, among others, to prevent mosquitoes from breeding.

DPH also advised the community to cut down or trim overgrown bush or grass to at least two to three inches from the ground and to discard empty bottles, cans buckets and other artificial containers that can hold water, by either turning them upside down or take them to the public dump.

Saipan recorded an outbreak of Japanese encephalitis in October 1990 with one male death and 14 cases. The U.S. Centers for Communicable Diseases assisted the CNMI in the said outbreak.

Japanese encephalitis is a disease caused by virus trans-**Continued on page 22**

## Stories of the islands

IN the earlier times, islanders gathered at night to tell and listen to stories. They told enchanting tales that answered questions about how the world was created; how things became the way they are; why animals behave the way they do, etc.

According to a Northern Marianas legend, mosquitoes were produced by the curdled blood of a woman who was killed by her husband because of her infidelity. The woman was an absolute whiner when she was still alive. That, according to the legend, was the reason why mosquitoes buzz in our ears. They suck human blood in hopes of becoming "human again."

Pacific island legends have survived oral transmission from one generation to another. Here comes a written version of the story-telling tradition that would provide a window into the enigmatic part of the world, which most visiting writers from the west unfairly depict as a region inhabited by "cannibals" as well as Spam and Budweiser freaks.

The story of mosquitoes is among the 44 legends retold in the book *Pacific Island Legends: Tales from Micronesia, Melanesia, Polynesia and Australia*, published and recently released by the Bess Press, Inc. The authors are people known to most of us: Bo Flood, instructor at the Northern Marianas College; William Flood, pediatrician at the Saipan Health Clinic who writes weekly health column for the Variety; and Beret E. Strong, former principal of the Northern Marianas Academy. The book is illustrated with culturally appropriate woodcuts by Saipan artist Connie J. Adams.

Samples of the enchanting legends in the book were published earlier by the *Islands Variety* (which, sadly, folded a few months ago.) The 280-page book contains legends from each and every island in the Pacific.

A legend from New Caledonia explains that the seagull digs in the sand at low tide to look for the first mussels that hid from her a long time ago. A Guam legend describes how women saved the island from an island-eating monster. A poor village boy from Caroline Islands is able to marry the tribal chief's daughter by stealing the moon.

A scatter-brained warrior from New Zealand goes to the world of spirits to earn his wife's forgiveness by getting a tattoo. It is because of this man's forgetfulness that all living are forever blocked from entering the world of spirits.

Legends are stories that don't demand logic; they are stories in which possibilities are infinite. They have been existing long before the magical realism of Gabriel Garcia Marquez and Salman Rushdie, which defies the concept of impossibilities, became part of modern literature.

Although written for the upper-elementary/middle school level, *Pacific Island Legends* produces a lyrical magic that is inherent in every story. Some of them are funny; others are sad; and still others are tragic. Just like our own life. At any rate, they speak a universal language.





## Office 2000 may be for you (Part 1)

IT'S coming .... coming .... the ALL NEW AND EXCITING STUPENDOUS AND CO-LOSSAL END-ALL, BE-ALL office productivity program. Tah Dah!! Yes, FINALLY, Microsoft Office 2000 is coming out of the gate and will be ready for public consumption later this month.

Is the end result worth all the PR hype that's going to surround Microsoft's upgrade of Office 97? The answer is yes ... and no ... depending on who (whom?) is doing the answering.

I've been using Office 2000 for the past few months - first as an advanced beta and then the final "gold" version that's going to be sold. If the truth were known, it was hard to tell the difference between Office 97 and Office 2000. However (my favorite word), I noticed that the pieces of the package I use most - Word, Excel, Front Page and Access worked smoother and seemed to be more intuitive.

My experience is akin to getting a new set of tires for an older car. It still goes, but you seem to be more satisfied with the smoother ride. Office 2000 seems to offer that "smoother ride" that we all crave.

Above all, decide if you want to spend the upwards of \$200-800 it will take to upgrade from Office 87. For many of us that's a good hit. In my opinion it's worth it for the individual who NEEDS and USES their computer every day for word processing, spread sheet management or Access data massaging.

If you use your computer to do a few letters, maybe put the family budget on a spreadsheet, track a few stocks, etc., then I'd recommend staying with Old Faithful — Office 97.

This column is written from the consumer viewpoint and I am not necessarily swayed by what the "big computer magazines" have to say because to some extent they are beholden to Microsoft and other advertisers. Does that affect what they write? I really can't say.

Microsoft and other software dealers provide me with a free copy of the program to use as I see fit. Usually I just install the software and put it through its paces and probably never touch it again except to move it from one hard drive to another.

I now have five hard drives in my poor machine. They hold several years' worth of software tests. Microsoft Word is and has always been my word processor of choice because of how well the files it outputs can be used in other things instead of just letters or a few columns.

I loved my Office 97 version, but Office 2000's edition is so much better because the giant software company has taken a leaf from Burger King and made it — and ALL THE OTHER PRO-GRAMS IN THE OFFICE 2000 SUITE — adjustable "your way."

I found the intuitive program bars wonderful. As you use certain aspects of the programs such as file, edit, format and the subprograms, the access actually moves higher up on the menu bar. So, if you use an obscure command a lot you will find it is at the beginning of the menu bar and no longer at the end. Plus, the Office 2000 suite allows you to turn off and on various components of the programs, move them around on window bars, create specialized command bars that float or stay put as you wish.

Office 2000 was designed from the ground up to be used in a collaborative office or work group atmosphere. A Mercedes will probably do 200 miles an hour if pushed. But, in both cases you don't HAVE to do either.

The Office 2000 programs work just fine in the one-person office and if the user has to interface with a larger office atmosphere, then the small time guy has the same powerful tools as the corporations.

As we all know Internets and Intranets are becoming the common denominator for the business world. Those networks speak hypertext markup language or HTML. Microsoft has designed office 2000 with that fact in mind. EVERYTHING you can do with the suite is easily converted into an HTML structure.

Yes, I mean everything.

I was especially impressed with how Microsoft has jazzed up PowerPoint. In the past it was almost impossible to create a PowerPoint presentation designed to be shown in real time on a web page.

Doing so required a convoluted series of downloading players that did not always work or as my grandfather used to say — "worked at" something. I really don't have enough room here to talk

## **Deportation bill needs** to be reviewed further

GOVERNMENT officials have acknowledged the need to clarify existing policies dealing with the deportation of nonresidents, who have already outnumbered the indigenous population.

But Gov. Pedro P. Tenorio wants any proposal to ease deportation proceedings or clarifying grounds for deportation reviewed thoroughly in order to avoid the implementation of another law that may not actually address the problem.

Tenorio has indicated support on moves from the Legislature to clarify confusion on the provisions of the Constitution and address the problems surrounding the conflicting interpretation between the Superior Court and the Attorney General's Office.

He however stayed away from the legislation offered by Rep. Oscar M. Babauta, adding that whether he will support any particular legislation or not depends largely on how the bill has been drafted.

The governor is yet to receive any copy of the proposed measure and said he would rather keep mum on Babauta's proposed bill until he gets a copy and reviews the provisions it offers.

"I have not seen the bill yet but I think it depends on how the legislation is drafted. Right now, I'm not sure how it is drafted," he said.

But the CNMI chief executive offered an unsolicited advise:

"Review the proposal thoroughly."

Tenorio explained that an extensive review of the proposal is needed if it is really intended to solve the concerns raised by local residents on the allegedly increasing crime incidents that involve foreign workers.

Over the last 10 years, crime incidents in the Northern Marianas have jumped nearly three-fold with around 4,000 cases documented last year compared with the 1,000 incidents in 1988.

According to Babauta's proposed legislation, a single conviction of misdemeanor in the CNMI or court sentence on charges of prostitution and illegal drugs will be grounds for deportation of foreign workers.

## Teno not keen on casino for Rota

Variety News Staff PROPOSALS to legalize casino gambling in the island of Rota is not likely to chalk up Gov. Pedro P. Tenorio's support as he yesterday reiterated his stand against the establishment of gambling facilities in the Northern Marianas.

"Personally, I will not support any casino or gambling in the CNMI," he said, explaining that the Tinian Dynasty Hotel and Casino was established following areferendum which reflected the will of the residents of the island.

Moreover, the Northern Marianas is in an economic condition not conducive to casino gambling as manifested in the fate of the Tinian Dynasty which continues to suffer from low occupancy rate due to the still unstable tourism industry in the CNMI.

Tenorio pointed out that the casino gambling facility on Tinian was decided upon by is-

land residents, adding that the same process will be implemented in Rota whether or not the local population will go for the duplication of Tinian's experience.

"I'm not sure whether the people of Rota will vote for the legalization of casino gambling there," he said. He added a host of factors will have to be considered before another gaming facility is erected.

However, Tenorio said everything will have to depend on the people of Rota's will although he openly expressed opposition against gambling in the Northern Marianas.

"My personal view is that I will not support any casino in the CNMI but I will respect the decision that may be reached by each senatorial district. If the people of that particular district wanted a casino, there's nothing I can do because they have to go through the initiative by referendum," he said.

Health group considers HIV policy change

Variety News Staff THE ASSOCIATION of State and Territorial Health Officials (ASTHO), of which the Commonwealth Health Center (CHC) is a member, is seeking to amend its policy on HIV/AIDS counseling and testing for pregnant women.

In a report, ASTHO said its executive committee already approved the proposed amendments. The full membership is set to vote on the amendment in Sep-

tember to make it official. This amendment, said ASTHO,

was prompted by the Infectious Disease Policy Committee's review of the Institute of Medicine's report entitled "Reducing the Odds: PreventingPerinatal Transmission of HIV in the United States."

The central recommendation from the IOM report is the adoption of a national policy of universal HIV testing — with patient notification — as a routine component of prenatal care.

CNMI Health Secretary Joseph Kevin Villagomez earlier offered Continued on page 22

## Senate to confirm all but one

## Man in extortion case gets 31 mos.

THE FEDERAL court yesterday sentenced to 31 months' imprisonment a man who was among a group of Chinese nationals busted by Federal Bureau of Investigation-CNMI Task force for engaging in an extortion racket.

Judge Alex R. Munson said upon release from jail after completing the sentence, defendant Shuji Liu shall be turned over to the Immigration authorities for immediate deportation.

If the deportation proceedings fail, Munson said Liu shall be placed under a three-year supervised probation.

The judge also required the defendant to pay \$3,964 in restitution to the victim Guo Hua Lu.

Munson said the sentence is appropriate to send a strong message to the community or deter other guest workers who might otherwise be inclined to involve in extortion ring.

Liu and co-defendants Delin Fang and Xiong Jie Li were indicted for conspiracy to interfere with commerce by extortion.

Liu and his court-appointed counsel Jesus C. Borja entered a plea agreement with the US Attorney's Office represented by Assistant US Atty. David T. Wood.

## Land owner files Article 12 case

A LAND owner has filed an Article XII case in Superior Court in an attempt to recover her land which she had leased to a private corporation.

lovita B. Tomokane asked the court to void a lease agreement with defendant Tokyodo Enterprises, Inc. due to alleged unconstitutional sale of the subject 3,101 square meters of land in Susupe.

If the court should only declare the violative provision of the lease agreement as being void, Tomokane sought to terminate the lease for failure to pay rent and to secure a judgment for rent owed.

Tomokane, through counsel Jesus C. Borja, requested the court to declare that the lease is void for violating Article XII. Plaintiff also sought judgment

awarding possession of the land

and declaring the lease forfeited and terminated for defaulting on the \$12,300 rental payments.

Borja in the complaint said that in 1989 Tomokane leased the land to Tokyodo for a 55-year- term.

Pursuant to the lease, plaintiff granted Tokyodo the option to purchase the premises if the first year's rental of \$6,600 plus \$46,117 were paid within one year of the date of the execution of the lease

Borja said the firm exercised its

option and paid plaintiff \$57,000. The lawyer pointed out that since Tokyodo was incorporated in 1980, until the July 1996 filing of its last annual corporation report, it never complied with Article XII requiring 100% of its directors and voting shareholders to be persons of Northern Marianas descent.

Plaintiff had no knowledge until late last year that the lease she executed violated Article XII,

#### Borja said.

In Dec. 1998 counsel for plaintiff sent Tokyodo and its then registered agent, Peter Yun, a letter advising that the May 1989 lease violated Article XII.

The letter was returned unclaimed, Borja said.

During the first five years, Borja stated that Tokyodo should have paid the rent of \$33,000.

Borja said the amount was paid, but during the second five years, defendant should have paid rent \$36,300 but gave only \$24,000.

Defendant was required to pay \$7,260 by May 1997, but it gave only \$2,200.

"Defendant has breached the terms of the lease, by failing to pay rent. Plaintiff has not received rent since Sept. 1997. She has been entitled \$12,300 under the lease," the lawyer added.

A BIG construction company has been fined \$2,000 and asked to pay at least four alleged abandoned guest workers \$35,600 for "work not provided" and liquidated damages.

In a ruling he recently penned, Linn Asper, supervisor of the Department of Labor and Immigration's (DOLI) Administrative Hearing Office (AHO) said Woosung Construction Co. Ltd. "has reduced its business on Saipan to the extent that it should be considered closed."

abandoned them," Asper said in his ruling.

According to Asper, Woosung allegedly convinced many employees to return to the Philippines for an unpaid "vacation."

Woosung, Asper said, failed to bring the employees back as promised. The four guest workers did not

leave the commonwealth and were instead left without employment.

"(The guest workers) should be awarded for work unprovided. (Woosung) should be fined \$2,000 for labor law violations and should be permanently barred from the employment of nonresident workers in the commonwealth," Asper said.

Asper referred the matter to the Attorney General's Office (AGO) to assist the workers in collecting their money claims.

At least two of the workers-Loreto Cabo and Jesus Lorenzo - were given transfer employment relief while one -Gregorio Capaoran-has opted to repatriated. The fourth worker -Gil Paclibar - has changed his immigration status by marriage.

Shoda that CPA will be responsible for problems arising from the transfer of the Rota harbor land occupied by the Commonwealth Utilities Corp. (CUC) to the ports authority.


In an interview yesterday, DPL Director Bertha Leon Guerrero at the same time said the division will "see what (it) can do" to "help" CUC in its bid to get back the contested site, which is needed for a power plant expansion project on the island.

Guerrero said the division was given assurance by then CPA Executive Director Carlos A. Shoda that the ports authority will handle problems arising from the transfer of the contested land to CPA, which took place during the previous administration.

She recalled raising concerns during deliberations on the transfer that CUC was occupying the

"My biggest concern is that why

should we designate the land that is already being utilized by CUC," said Guerrero.

Guerrero said DPL may have to review the deed transfer.

"Iunderstand what their (CUC's) concerns are. I can understand their problem. We are going to have to review the designation that we gave CPA. I may have to discuss this with our lawyers," said Guerrero.

"If CUC asks our help, we'll see what we can do to help them. We'll

If there is something that we can do we'll try and see what we can do," Guerrero added.

She said DPL may be compelled to "support" CUC on its appeal to have the land back so long as it is premised on the "efficiency" and "effectiveness" of the power plant and on minimized expenses that may be incurred in constructing it.

The CUC has been requesting CPA to give back the harbor land to allow it to move on with its Rota power plant expansion project. The utility agency has issued a request for proposal in connection with the 10-megawatt project.

The CUC started making the appeal shortly after it bailed CPA out a few weeks back from a financial quandary the latter found itself in due to its stalled airport sewer line project.

Utility Board Chair Juan Dela Cruz has said CPA should return the favor by giving back the land.

Variety News Staff THE CHAIR of the House Committee on Ways and Means yesterday said Gov. Pedro P. Tenorio should be commended for reducing the deficit despite the significant decrease in government revenues.

Rep. Karl T. Reyes (R-Prec. 1, Saipan) said Tenorio's sound fiscal policies are keeping the government "afloat" even as the economy remains in a slump.

Reyes said in 1998 alone, the administration succeeded in reducing government expenses, resulting in some savings by the end of the year.

Further, he said, the size of the deficit—which stood at \$57.3 million as of Sept. 30, 1997-has finally stopped increasing.

At the same time, Reyes said the governor has created several task forces and pieces of legisla-

tion that aim to attract new investments in the CNMI.

"It's not that the administration and the Legislature are not doing anything to improve the economy," he said.

"We have to remember that this economic crisis is regional, and is enting Asian investors from ing their countries.

....

"That's why the intent of [the administration-backed] free trade zone legislation is to lure more US investments, to convince them that opening businesses here will be good mainly because we're near Asia," Reyes said.

"You could say that right now the governor is trying his best to do what could be done to improve the economy.

"And we should also remember that the governor is doing all these things while under pressure from our critics in the federal government who do not want the kind of economy we have," he said.

Administration officials earlier said that they have so far paid \$27 million in outstanding bills "inherited" from Tenorio's predecessor.

They warned, however, that the \$57.3 million deficit as of Sept. 30, 1997 could further increase

## Human smuggling trial on in Guam

HAGATNA — The US District Court yesterday resumed the trial of five men accused of human smuggling involving natives from China's Fujian province.

The trial is on its third week. Undocumented Chinese who had testified at the court alleged that they paid Fu Wu Chun to bring them to Guam. The Chinese migrants said they fear for their lives and that members of the "snakeheads" gang who brought them here are very powerful with connections. An apparently frightened Li Oing Xue told the court that the boat that they used stopped

about 200 miles outside Guam. It waited when it received a radio message that a previous boat ferrying illegals encountered trouble entering Guam earlier. Xue said that the boat turned

around to go back to China. He and the other smuggled aliens got scared. They were told by one of the five men charged with smuggling nicknamed "Da Tou" Li that if they each were to sign a LO.U for an additional payment of \$0,000RMV, the boat would turn around and go to Guam Xue said each person signed the paper but later jump on Da Tou and beat him up because **Continued on page 9**

## **CNMI** bashing by media hurts investment hopes

CRITICISMS hurled against the Northern Marianas in the mainland US are hurting the Commonwealth government's efforts to entice foreign investors to pour in fresh capital into the islands, according to Gov. Pedro P. Tenorio.

Concerns have been raised by prospective foreign investors that they may suffer similar bashing from media and human rights organizations should they decide to operate a business in the CNMI.

But the governor is optimistic that foreign businessmen wishing to invest in the Northern Marianas are more familiar with the islands and are more objective in their view of what actually transpires in the CNMI, as well as how the government is addressing loopholes raised in the mainland US.

"They are familiar with the place and they know what's going on. We assure those people who want to invest over here that we are doing our best in trying to make sure that the investors are being protected and at the same

time, they comply with local and federal laws," Tenorio said.

The CNMI have failed to encourage fresh foreign investments into the islands with the Department of Commerce recording less than 10 applications for new businesses since January last year.

Also, the Northern Marianas has witnessed a severe dislocation of businesses last year with more than 1,700 establishments reported to have closed shop since January 1998 due to the dramatic decline in local economy and the increasing animosity between lo cal and federal officials on issues surrounding minimum wage and immigration.

At the same time, the CNMI chief executive lashed back at ABC's 20/20 crew which, he said, went to Saipan to gather information which will better serve the program's intentions at the expense of objectivity.

"I was hoping that they will be more objective on the [prostitution and sweatshop] issues. However, they just have one purpose and their purpose is to videotape what they want to show on national television and listen to what they want to hear," Tenorio said.

He said the 20/20 crew did not even bother to inquire about the Commonwealth government's reform efforts, as manifested by the way questions were asked the governor during the interview.

"It would be more appropriate if they can report what we have done and what we have been doing. Unfortunately, they decided not to do so. There's nothing we can do about it," he added.

## Tarantino likely Guam AG

HAGATNA — Prominent island residents including a former police chief say that John F. Tarantino is a man that has very high ethical standards, is beyond reproach and a good choice to be Guam's attorney general.

Former police chief Adolf Sgambelluri, in his testimony before the Legislature's Judiciary Committee chaired by Sen. John Salas, said Tarantino has demonstrated "leadership highlighted by intelligence and compassion," and is "a head and shoulders performer."

Sgambelluri said Tarantino's nomination deserves to be confirmed by the Legislature.

Oscar Miyashita, managing partner of Ernst & Young accounting firm, told the com-

mittee that Tarantino is a person not afraid to express his opinion. Calvin Hollaway, who resigned over two years ago, was the last attorney general whose nomination was confirmed by the Legislature.

Members of Salas' committee was concerned that the integrity of the office has been "damaged" by political interference.

Describing Gov. Carl T. Gutierrez as someone who "very much wants to be in control, Sen. Joanne Brown asked Sgambelluri, "what makes you think that Tarantino wouldn't be just another puppet for the governor to play with?

Sgambelluri replied, "In the past we have had phonies filling the shoes of AG, but I wholeheartedly believe this man is not [a phony]."

Guam attorney and business-

man Robert Klitzkie also pushed for the speedy confirmation of Tarantino's nomination.

He said Tarantino is a "quick study," honest, has a keen sense of ethics, and a commitment to the public good.

Tarantino, for his part, told the committee that he would perform his duties with the same consistency and integrity that marked his 17 years of practicing law on Guam.

When asked about special fundraising ticket sales within the Law Department, Tarantino said such activities occurring during his watch will not be tolerated and must be reported immediately.

Tarantino's name is expected to be brought up for confirmation by the Legislature when it holds a session later this month.

## Manglona to go up to Supreme Court?

## Amnesty-seekers try to beat program deadline

By Jojo Dass Variety News Staff THE NUMBER of overstayers seeking annesty could reach more than 3,000 as several hundreds more trooped to the Department of Labor and Immigration (DOLI) yesterday to beat the deadline on government's limited immunity program.

In an interview yesterday, Task Force Limited Immunity chief Jeffrey Camacho at the same time said a number of those applying for annesty were already illegally hired by employers coming forward to avoid prosecution for harboring illegal aliens once the six-month grace period is over. Camacho also said that there were isolated cases involving amnesty-seekers being disqualified as they have been here after Jan. 1 last year. The limited immunity law only covers

illegals who have been here before the mentioned cut-off date. Camacho failed to give figures on the overall result, explaining that the task force is still ironing out the numbers. The limited immunity pro-

gram is part of the government's efforts to shape up its labor and immigration affairs amid mounting pressure from the federal government which has been that the claiming commonwealth's employment scene is one heavily dependent on abused foreign workers.

The program started Jan. 1 this year following law enacted on the matter late last year. The program expired yesterday. Camacho reiterated that DOLI operatives will today begin its crackdown on overstayers who have opted to remain in hiding. **Continued on page 22**

The body which will continue to work for the complete implementation of the policy and guidelines governing the island's factories is being headed by former labor director Frank Camacho.

Camacho, also a former deputy commissioner of the Department of Public Safety is joined by other officials from various factories. They are Francis Lam, Annie Castro, Moses Fejeran, William Fong, Eloy Inos, and Mathilde Cabrera.

The officers were installed during a meeting SGMA members held last May 26.

The SGMA has also been done with its review of proposals submitted by different groups which have applied to become the association's external monitoring group for the code of conduct, and one company, Price Waterhouse Coopers, appeared to be on top of the list.

The advanced training for the code which is being administered for SGMA by the Business for Social Responsibility is scheduled this August.

The association is expecting to have officials from the OSHA and EEOC during its sessions, which are the final training requirements for the implementation of the code.

Richard Pierce, SGMA executive director, said the compliance committee would be responsible in monitoring the factories' submission to the code.

It can recommend to the SGMA board the taking of sanctions against any violating companies, and can issue certifications in behalf of any factory member.




## ATTENTION ARTISTS **REQUEST FOR PROPOSALS**

The NMI Council for the Humanities and the CNMI Council for the Arts and Culture are interested in awarding an art commission to commemorate the millennium. We envision a series of historical paintings celebrating the strength, endurance and adaptability of the indigenous people of the Northern Mariana Islands. Over the centuries the indigenous people of these islands have demonstrated countless times and in countless ways an extraordinary ability to adapt to profound changes in nearly every aspect of life-religious, economic, political and cultural. And despite all the upheavals and vicissitudes of thousands of years of history the people and their culture are still here intact. We want to celebrate this quality and preserve this unique history for future generations. Respondents should consider these requirements:

- The theme for these paintings, the single element that ties them all together is: The Endurance of a People and Their Culture. The paintings must be based in the history and culture of the Mariana Islands. Respondents may consider historical events, folklore, legends, stories, songs, dance or any other appropriate cultural expression to emphasize the theme.
- The paintings must be painted on a material that will withstand time and the elements.
- The paintings will be displayed at the CNMI Museum in the recessed arches underneath the covered walkway. These arches are approximately three inches deep, six feet tall, and five feet wide. Paintings will be protected by a transparent barrier. Both paintings and barrier must be removable. (The cost of the barrier is not part of the proposal).
- As many as six paintings may be necessary.
- Deadline for completion is January 1, 2000.

Respondents should submit pencil or charcoal sketches, and / or paint studies of each painting, a brief narrative explaining the overall composition of the paintings, the historical and cultural basis for each, how the theme is expressed through out the series, and plan for completion including the total cost of the proposed paintings. ## Pacific free trade area pushed

SUVA (Pacnews) — Forum Trade Ministers meeting in the Fiji capital. Suva have been urged to seriously consider the longterm benefits of the proposed Free Trade Area.

Speaking to a high level closed door session of forum trade ministers, Forum Secretariat's Secretary General, Noel Levi said the proposed regional trade grouping would determine whether the nations of the Pacific region are ready to respond as a region to the enormous pressures of globalisation and trade liberalisation.

Levi said the idea is not new. It was first discussed at the Forum meeting in 1971 by founding members of the Forum Secretariat, who felt the need to form an economic union in the region. He said this vision had not been

realised and hope the trade ministers would build on what the founding fathers of the Forum Secretariat discussed 29 years ago. "The main difference between

1971 and now of course is that we no longer have the luxury time in front of us and major events and pressures continue to raise the need for us to respond and quickly respond."

"The whole world around us is organising themselves into trading blocs because they see that as the only way to make themselves strong enough to deal with globalisation and trade liberalisation", Noel Levi said.

He said only last week; another region of developing countries in Africa reached an agreement also to form themselves into a free trade area.

Levi challenged the ministers

saying "we are perhaps the only region in the world that has not engaged in a trading bloc to help meet the demands of trade and liberalisation. The fact that our individual smallness and isolation would seem to be a clear indication that we do need to form a trade bloc to create economies of scale, to enhance our strengths and to foster a collective purpose."

The draft framework agreement has taken into consideration the welfare and economic benefits of many members who are relatively small.

"The agreement is initially to be an arrangement between countries of similar development status with common trade interests. Our members are saying they need time to adjust and to gather some strengths and

momentum before taking the big step of non-preferential liberalisation. That is what we have tried to capture in the draft framework agreement." Levi said.

The Forum Secretary General appealed to trade ministers to endorse the draft agreement and begin negotiations in earnest.

He said the negotiation process would take months before a draft treaty is text is ready for consideration.

"Even if by the end of next year you agree to establish the proposed free trade area, its gradual implementation over 8 to 10 years or more, would mean that you would have the time to make the necessary adjustments," Levi said.

A decision by the trade ministers would be further deliberated by Forum leaders in Palau later this year.



## Fiji banks freeze *Elsewhere in the Pacific* **PNG troops rescue** Indonesia hostages

PORT MORESBY, Papua New Guinea (AP) - Soldiers on Monday rescued 11 Indonesians held hostage by Free Papua Movement (OPM) rebels for almost a month.

The seven women and four men were reportedly safe Monday night and on their way to the Indonesian consul in the town of Vanimo on the border of Papua New Guinea and Irian Jaya, Deputy Police Commissioner Gary Baki said.

Baki said the Javanese hostages held captive in the jungles of Bewani since May 5 were rescued by security troops at midday Monday.

He did not release details of the rescue operation or whether there had been any casualties sustained either by the security forces or the rebels.

It was not clear whether the troops stormed the rebel camp to free the hostages or whether the rebels gave up the hostages when they were surrounded

Baki described the rescue operation as a desperate attempt to save the hostages.

It was carried out by members of the Papua New Guinea Defense Force based in Vanimo, whose main task is to patrol the common border with the Indonesian province of Irian Jaya.

The platoon of soldiers were helped by 35 members of a Police Mobile squad flown in from the highlands township of Wabag for the operation.

The rescue operation went into full swing from last Friday after negotiations to release the hostages broke down.

It involved about 70 security force personnel who were put in strategic locations near the camp where the hostages were being held at Bewani inside the Papua New Guinea border.

The 11 hostages had been captured during a raid by the rebels

on a building project at Arso, in Irian Jaya.

They were to have been released Friday to a high-powered delegation from led by Defense Minister Peter Waieng.

But when the talks failed at the last minute, OPM rebel leader Hans Bomay had a change of heart and the handover was called off.

Hans Bomay, the rebel leader who led the May 5 raid, had said the abductions took place because the rebels were frustrated by the withdrawal of Indonesian military authorities from a scheduled meeting in February to discuss independence claims for West Papua.

The Organization of the Papua Merdeka (OPM, or Free Papua) has been fighting for an independent Melanesian state of West Papua since 1964, when the former Dutch West New Guinea became part of Indonesia.

The United Nations recognized Indonesian sovereignty in 1969.

RABAUL (Pacnews) - The newly-elected President of the Bougainville Peoples' Congress (BPC), Joseph Kabui, says negotiations with Papua New Guinea over the future political status of Bougainville will be tough.

"Independence is not a new 1988 by a similar margin. debate between Bougainville and PNG. Its cause, however, was colonialism, not the people of PNG. It has now been written in blood and we must address it directly and honestly. It is still a long road ahead," said Kabui.

"However, I think we have all had a chance to stand back and look at the situation over these past two years of peace. I believe that PNG can see there is no turning back from the aspirations of the Bougainville people and I am confident we will reach an early understanding on the way forward to lasting peace."

Kabui, the former Vice-President of the Bougainville Interim Government and a proindependence supporter, was elected as President of BPC with an 88.5 per cent majority. President Kabui won the last elected premiership in

A statement from his office said the two Vice-Presidents, James Tanis and Thomas Anis, are also independence campaigners.

"I am honoured by the trust my people have placed in me in selecting me to lead this historical Government into negotiations with PNG on the question that has been at the bottom of these past twelve years of conflict and division," Kabui said.

Kabui appealed to PNG and the international community to appreciate the fact there could be no turning back for Bougainville.

#### Samoa agrees to increase compensation for student

APIA (Pacnews) — Samoa will pay \$FJ97,212 (\$US62,206) to a Fijian student, Saimoni Tuigali, as final payment of his claim against three Samoan students who assaulted him, the Prime Minister's Department has announced in the capital, Apia this week.


Tuigali lost his eyesight in the attack.



# **RP, IMF maintain economic targets**

MANILA, Philippines (AP) ----The Philippine government and the International Monetary Fund have decided to maintain their 1999 revenue and growth targets for the country despite an initial shortfall in revenue collection, an official said Mon-

Finance Secretary Edgardo Espiritu said both sides are optimistic the targets can be met despite the shortfall in the first four months of the year. The government is aiming to collect 521.9 billion pesos (\$13.7 billion) in revenues this year.

Gross national product is proiected to grow between 1.5 percent and 3.5 percent this year, while gross domestic product growth is targeted at between 1 percent and 3 percent. GNP measures a country's total production of goods and services, while GDP excludes the billions of dollars sent home each year by overseas Filipino workers.

On Friday, the government announced sharply better-than-expected first quarter growth data, boosted mainly by strong agricultural output and steady growth in the services sector.

GNP grew 2 percent in the first quarter while GDP rose 1.2 percent. The government initially predicted GNP and GDP growth of 1 percent and 0.8 percent, respectively, for the threemonth period.

Espiritu said the government will be able to make up for its revenue shortfall in the coming months, and that revenue collection in May has already shown an improvement. The data are due for release this week.

In the first four months, the

government posted a budget deficit of 22.023 billion pesos (\$579 million), exceeding the ceiling of 14.796 billion pesos (\$389 million) prescribed under the IMF program.

An IMF mission is in the Philippines to conclude a review of the country's economic performance in the first quarter. The review is a continuation of one conducted in April, which was unable to cover revenue targets because the government's data was not complete.

The government must meet its economic targets to continue to tap a borrowing arrangement with the IMF and hopes to draw an additional \$220 million under the arrangement in June.

#### **Cory Aquino gets** telemedicine demonstration

HOUSTON (AP) — Former Philippines President Corazon Aquino says the computer technology she saw at a Texas hospital this week could help developing countries such as herown

Ms. Aquino listened as Dr. Yadin David explained how Texas Children's Hospital uses interactive computers to give medical advice via the Internet to rural and foreign communi-

"I hope that, in time, the Philippines will have access to telemedicine," Ms. Aquino said. "No matter how far away from Houston you are, you can touch base with (specialists)."

Ms. Aquino, who succeeded Ferdinand Marcos in 1986, was in Houston to give the University of St. Thomas commencement address Saturday. She also spoke to the Houston World Affairs Council on Friday.


At Texas Children's Hospital Center for TeleHealth, she heard how Houston physicians are using telemedicine to diagnose illnesses and treat patients far away. Doctors can use interactive computers to hold two-way conversations, send documents, examine patients and look at X-rays.

David, director of the FeleHealth center, said telemedicine allows for earlier medical intervention, local hospitalization and steady care when a patient must go to another city or country for treatment.

Texas Children's wants to expand its telemedicine program to the Philippines, and Ms. Aquino seemed receptive.

She said it might have helped experts diagnose a little-known heart disease affecting one of her seven grandchildren.

She said doctors had trouble diagnosing Kawasaki syndrome, a disease found mostly in young Asian boys which can lead to weakening of the heart if it isn't treated.



## Estrada cancels safe conduct passes of rebel negotiators

MANILA, Philippines (AP) - President Joseph Estrada said Monday he has canceled the safe conduct passes of Communist rebel leaders after the guerrillas terminated peace talks with the government.

The cancellation of the passes exposes rebel consultants and negotiators to possible arrest if they have pending arrest warrants.

The government has not announced any plan to pursue such arrests.

"They're the ones who refused to continue the talks. We have no choice at this point in time so we'll terminate all these," Estrada said. Estrada said the govern-

ment is prepared for possible repercussions.

He said there was no need to place the military and police forces on heightened alert when he leaves Wednesday on a trip to Japan and South Korea.

The Marxist rebels announced they were pulling out of the peace negotiations on Friday, a day after the Philippine Senate approved an accord allowing U.S. troops to resume large-scale military exercises and ship visits in the country.

The National Democratic Front, a Marxist umbrella group, said the passage of the military agreement with the United States violated Philippine sovereignty.

Rebel leaders warned that the talks' cancellation could lead to a resumption of highprofile rebel attacks.

Estrada has said the rebels were simply using the approval of the Visiting Forces

#### Agreement as an excuse to terminate the talks, which began in 1992, and called the rebels insincere.

Estrada complained that the rebels continued to attack the government despite the release

of political prisoners by two previous administrations and the issuing of safe conduct passes to rebel leaders involved in the peace talks.

Earlier this year, Estrada canceled the safe conduct passes after the rebels kidnapped several military and police officers. He restored them after the hostages were released.

Prior to the dispute over the VFA, the rebels had suspended talks with the government after Estrada imposed what they said were unacceptable conditions, including conducting the negotiations under the framework of the Philippine constitution.

The rebels have been fighting the government for a Marxist state in the Philippines since the late 1960s.

### Central Bank chief to retire

MANILA, Philippines (AP)-The Philippines' respected central bank chief, Gabriel Singson, said Monday he will step down as scheduled, quashing speculation that he might agree to an extension of his six-year term, which ends July 5.

President Joseph Estrada had earlier said he was willing to prolong Singson's term if the central bank governor would agree.

Singson was one of the few officials appointed by former President Fidel Ramos retained by Estrada.

Singson refused to categorically state if his replacement will be Philippine Commercial International Bank president Rafael Buenaventura, Estrada's former schoolmate and reportedly his choice as new central bank chief.

"I can't confirm it. But if I will bet on it, I will give it 10 to 1 odds," said Singson.

Singson said the new central bank governor should be patient, courageous, decisive and not sensitive to criticism if he is to succeed in the job.

Singson said he considers his "most important accomplishments" as central bank governor a stable price regime and a stable financial system that has weathered the Asian crisis largely unscathed.

# All Nippon Airways unveils new reforms

**TOKYO** (AP) — Japan's All and a stubborn recession has dampened travel demand at 10 percent of its worldwide work force and establish a new discount airline as part of a broad reform strategy, the company said Monday.

Japan's second largest airline said it would cut its 28,000-person global work force by 10 percent by March 2003.

Most of the cuts will be made at the ANA parent company where 1,700 jobs will be trimmed through early retirement and by limiting new hiring, the company said in a press release.

The other cuts will be made at subsidiaries and affiliates, though the company did not say where.

A nearly two-year-long economic crisis has curbed demand for plane tickets in Asia, home.

Meanwhile, the establishment of new discount airlines such as Skymark Airlines Co. has put pressure on big flyers to cut fares.

"The business environment in Japan is extremely difficult right now," ANA President and CEO Kichisaburo Nomura said in the statement. "Many of the reforms we will undertake are going to be challenging, even painful," he added.

The president's salary will be cut by 25 percent, the company announced, though it didn't say how much he would make.

ANA will set up its own lowcost airline this year that will focus on routes out of the western Japan city of Osaka, the company said without providing details.

The carrier will also reduce interest-bearing debt by 130 billion yen (\$1.07 billion) over the next four years to about 610 billion yen (\$5.04 billion).

The announcement follows a dismal earnings report from ANA last week.

ANA suffered a parent net loss of 6.59 billion yen (\$54.46 million), deeper than its yearearlier loss of 2.68 billion (\$22.15 million). The loss stemmed from higher operating costs and a one-time charge to pay workers who retired early under an existing plan to cut jobs.

#### Japan's Nikon posts loss on weak sales

TOKYO (AP) — Major camera maker Nikon Corp. on Monday reported a consolidated net loss of 18.23 billion yen (\$150.21 million) for the last fiscal year due to a drop in industrial equipment sales.


Nikon, which had posted a 8.32 billion yen (\$68.56 million) net profit a year ago, blamed its poor performance on weak demand for precision instruments, such as devices used to make semiconductors.

Group sales slid 18 percent to 305.76 billion yen (\$2.52 billion) in the fiscal year ended March 31, the company said. Higher revenue from cameras and glasses was offset by lower revenue from industrial equipment, it said.

While Nikon said business conditions will likely remain severe in recession-hit Japan and other Asian nations, it expects to return to the black in the current business year, which ends in March 2000.

The company forecast a group net profit of 5.0 billion yen (\$41.19 million) on sales of 350 billion yen (\$2.88 billion).

Nikon had previously released its parent company earnings results for fiscal 1998 - a net loss of 9.87 billion yen (\$81.32 million).

## **Threats ahead of ballot**

VIQUEQUE, Indonesia (AP) -U.N. polling officials fanned out across remote parts of East Timor on Monday despite threats from militiamen opposed to an August independence referendum.

Militia groups are accused of waging a campaign of violence to derail the Aug. 8 ballot which will let East Timorese choose between making their homeland an autonomous state within Indonesia or breaking away completely.

Pro-independence activists say militiamen have killed dozens of civilians and intimidated thousands. The United Nations, which will supervise voting, on Monday repeated a demand that Indonesian security forces restore order.

"We have received general threats from the militias against U.N. personnel," said David Wimhurst a spokesman for the U.N. Assistance Mission in East Timor, or UNAMET. "Obviously the security situation in Timor is not good."

He did not elaborate.

"The militias have to lay down their arms," Wimhurst said.

"We'll be working with the Indonesian police and with influential leaders to get this violence to end."

In another development, 500 Indonesian policemen left for East Timor on Friday to help control the situation in the leadup to voter registration that begins June 17. Military chief Gen. Wiranto said a total of 8,500 police and soldiers will be involved in safeguarding the vote.

In Jakarta, UNAMET chief Ian Martin met jailed rebel leader Jose Alexandre "Xanana" Gusmao on Monday to discuss security in East Timor. Martin planned to formally open the U.N. headquarters in Dili on Thursday, joining 58 U.N. officials already there.

About 600 civilian U.N. personnel, as well as about 280 foreign police advisers, will be in East Timor before the ballot.


About 200 voter registration and polling stations are to be established by June 17.

Wimhurst said UNAMET's presence had helped create a safe atmosphere in Dili and that the arrival of more officials would further assuage tensions across the troubled territory.

"When our presence is felt on the ground, it will have a calming effect," Wimhurst said.

On Monday, a four-member team flew by helicopter to Viqueque, 120 kilometers (75 miles) southeast of Dili, the territorial capital.

Before their arrival, town resi-



dents said a militia group had killed several independence activists and were patrolling its streets after dark unchallenged. Many carried automatic weap-

Residents accused Indonesia's army of assisting militiamen — a charge that has been denied repeatedly by its top brass.

Meanwhile, the military accused pro-independence guerrillas of killing three anti-independence supporters near Viqueque on Friday.





## Pakistan: Any weapon to be used for defense

ISLAMABAD, Pakistan (AP) --- Pakistan has warned that "any weapon" in its arsenal — which includes nuclear weapons --could be used to defend itself against neighboring India, according to newspaper reports on Mondav.

The warning came against a backdrop of blistering artillery barrages along the disputed Kashmir border that killed 15 Pakistani civilians overnight Sunday, and more Indian air strikes against rebel positions in the Kargil hills on its side of the Kashmir divide.

"We will not hesitate to use any weapon in our arsenal to defend our territorial integrity," Shamshad Ahmed, the No. 2 man at the foreign ministry, was

quoted as saying by the independent English-language The News.

Uneasy relations between Pakistan and India plummeted last week when Indian jet fighters launched an air campaign against Muslim secessionists in the Kargil mountains on their side of the disputed border.

At a meeting Monday of Islamic clerics in the eastern Punjab capital of Lahore, Prime Minister Nawaz Sharif accused India of "ruthlessly killing innocent Kashmiri people'' and he said the militants were "freedom fighters" not extremists or terrorists.

However at their training camps in Pakistan-ruled Kashmir, the militant organizations espouse a rigid interpretation of Islam, the same as the Taliban religious

army, next door in Afghanistan. Sharif also repeated Pakistan's denial that it is sending in

Pakistan troops disguised as militants.

India accuses the Pakistan military of capturing a 5-kilometer (3-mile) piece of territory on its side of the border, then handing over the mountain posts to militant Islamic insurgents to defend.

The Pakistan Army has called the allegation "rubbish," but analysts here said the situation on the disputed border has deteriorated to a point not seen since 1971, the last time India and Pakistan fought a war.

That time the war was over Bangladesh or what was then East Pakistan. India and Pakistan have also fought two previous wars over Kashmir.

India has vowed to continue its military operations in the Kargil conflict zone until it regains its lost territory.

Both countries lay claim to a united Kashmir, which was divided between the two neighbors after British rule of the Asian Subcontinent ended in 1947

Pakistan has proposed to send its foreign minister, Sartaj Aziz, to New Delhi to try to defuse tensions. On Monday India accepted the offer.

Pakistan also has been using the latest escalation in tension to push for international mediation of the Kashmir dispute. India has flatly refused the involvement of the international community.

The international community has been calling for restraint by both countries. But Pakistani officials want a more direct involvement, repeatedly warning of the dangers of a confrontation in a region where the combatants both have nuclear weapons.

# India agrees to talk peace

KARGIL, India (AP) — India agreed Monday to high-level talks with Pakistan to defuse tensions over the disputed Kashmir region, even as its jets pounded positions held by guerrillas in the mountainous terriory.

International concern is growng over the hostilities between he world's two newest nuclear powers over the divided Kashmir region, where India accuses Pakistan of backing guerrillas who seized mountain positions earlier this month.

Six people were killed when an artillery shell demolished a government building in Kargil early Monday, said officials of the state government. Several more people were injured, in the highest casualty toll reported so far from an artillery attack.

The Foreign Ministry in New Delhi said Prime Minister Atal Bihari Vajpayee had "considered and accepted" a proposal by his Pakistani counterpart Nawaz Sharif to dispatch his foreign minister, Sartaj Aziz, to India. The dates were being discussed, said a statement.

The proposal came in a telephone call from Sharif Friday night. Vajpayee said he would consider the idea, but India was concentrating on evicting the infiltrators from the Indian side of the unofficial border. Since then, there was no further contact between the two leaders, said a spokesman for Vajpayee.

On Sunday, Vajpayee said he had turned down a proposal by U.N. Secretary-General Kofi Annan to send an envoy to the region.

"I told him if he wants to send an envoy, send him to Pakistan, there is no need to send him to India," Vajpayee said at a public meeting, describing the telephone conversation late Saturday with Annan.

U.S. Secretary of State Madeleine Albright and British Foreign Minister Robin Cook also spoke with their Indian counterpart, Jaswant Singh, to express concern over the fight-

An air force spokesman said strikes continued Monday. On the ground, Indian troops scaled towards the strategic snow-covered ridges held by guerrillas overlooking a main highway. Artillery duels continued between Pakistani and Indian forces.

A major battle was developing in the eastern sector. Reporters seeking to reach the town of Batalik, about 60 kilometers from Kargil, were turned back at a checkpoint.

Near the town of Dras, a senior commander said his troops were closing in on two outposts and were within 50 meters of the intruders hold-

ing the heights. He said two officers and an unknown number of soldiers were killed Sunday in the battle for the two peaks, now shrouded in fog and slippery with fresh snow.

Indian artillery batteries stepped up the pace of shelling along the highway running parallel to the ridges seized by the raiders. At one post near Kargil, hundreds of empty shell casings were piled high, as a half dozen 105 mm guns thundered in unison in the direction of Pakistan.

In New Delhi, India demanded the immediately release an Indian pilot in Pakistani custody, the Foreign Ministry said. Flt. Lt. K. Nachiketa had ejected from his MiG fighter jet and landed in the Pakistani territory on Thursday. "The Indian air attache in Pakistan should have immediate access to the pilot,' said the spokesman, Raminder Singh Jassal.

Senior front-line officers confirmed that for the first time since Indian airstrikes against the guerrillas began Wednesday, the air force has begun using Frenchmade Mirage 2000 fighters.

The Mirage can jam air defense batteries and drop cluster bombs, missiles or other guided ammunition, the paper said. Independent confirmation of the report was not immediately possible.

Vajpayee has pledged to keep fighting until the guerrillas are driven from the Indian-held part of Kashmir - something military officials say could take weeks of bloody hand-tohand fighting.

In Islamabad, Pakistan warned it would use "any weapon" to defend itself against India. "We will not hesitate to use any weapon in our arsenal to defend our territorial integrity," Shamshad Ahmad, the No. 2 man in the Foreign Ministry was quoted as saying by The News daily. Last year, both India and Pakistan detonated nuclear devices and both are working on delivery systems for nuclear warheads

Kashmir has been at the center of two wars fought by India and Pakistan. Both countries claim the entire territory, which is now divided between them, and there are frequent exchanges between the two sides. Meanwhile, Kashmiri Islamic groups have been fighting to gain independence from Hindu-dominated India or join Pakistan.

Vajpayee accused the guerrillas Monday of trying to alter the Line of Control, the ceasefire line established by India and Pakistan in their last war. He told a group of businessmen that it was "a warlike situation" in Kashmir, a spokesman said.

## **Obuchi favored in LDP race**

TOKYO (Reuters) — Prime Minister Keizo Obuchi, riding high in polls but near the end of his first term as leader of Japan's ruling party, will likely beat two heavyweight challenges in a forthcoming leadership race, political sources say.

Recent polls show supportfor Obuchi has more than doubled to about 40 percent since he took office last July.

But that has not stopped two senior members of his Liberal Democratic Party - Koichi Kato and Taku Yamasaki from saying they will challenge him in a leadership contest that must be held before his term as party leader expires at the end of September.

Political analysts said the two men are mainly trying to lay the groundwork to inherit the mantle of party leader which carries with it the premiership by virtue of the LDP's majority in parliament's Lower House after Obuchi serves another term

Obuchi is currently finishing out the term of his predecessor Ryutaro Hashimoto,

who resigned as party president and prime minister after a disastrous showing by the LDP in an Upper House election in July.

Most analysts agree Obuchi, who overcame being described as a dull party operative and a "cold pizza" when he took office, is almost certain to win the race and a two-year term as LDP president.

"Everybody thinks the possibility of Obuchi being reelected is very high," said Shinichi Yoshida, a senior political writer for the national Asahi Shimbun newspaper.

"The main reason the two (Kato and Yamasaki) are running is to establish very solid positions in the next LDP presidential election," Yoshida said.

Kato and Yamasaki, who both head smaller LDP factions, will need the support of members of Obuchi's faction, the party's largest, if they hope to become prime minister. Yoshida said.

While faction numbers will decide the outcome of the LDP race, Obuchi and his challengers are expected to focus their policy debate on economic issues - how to revive Japan's moribund economy while keeping the country's record high jobless rate from soaring much further.

Kato, a former diplomat, is one of the party's leading internationalists. He served as LDP secretary-general under Hashimoto and is one of the few party politicians to have addressed world television audiences in English.

He is advocating more "supply-side" measures to revive the economy, saying that taxcuts and other measures to

stimulate demand have been ineffective. Supply-side reforms aim at shifting resources to growth-generating sectors while reducing excessive and unproductive capacity in other industries.


"A presidential election can be viewed as either a power struggle or an opportunity for policy discussion," Kato told the financial daily Nihon Keizai Shimbun.

Yamasaki, who was the LDP's policy chief under Hashimoto, remains one of the party's power brokers.

Talk that key party factions were ready to move the LDP president race forward by about a month to late August has fuelled speculation that an extra session of parliament will be called in early September, possibly to debate a supplementary budget to try to kick-start the economy That could also clear the

decks for an early general election for the Lower House, political analysts say.

The LDP has a firm majority in the powerful lower chamber and an election does not have to be held until October 2000, but the ruling party wants to cement its control before the economy worsens any further.

**Report: Smoking remains** a chronic problem in Asia


NEW DELHI, India (AP) - With almost 71 percent women and 80 percent men puffing away in Southeast Asia, smoking has become a chronic problem in the region, a World Health Organization report said.

WHO Regional Director Dr. Uton Muchtar Rafei said tobacco could soon become a bigger killer than AIDS, tuberculosis, maternal mortality, traffic accidents, suicide and homicide put together, the United News agency reported.

Unlike in the West, where tobacco is mostly smoked, Asians ot only smoke it, but chew it.

In 1997, it was reported that 194 million men and 45 million women use tobacco in India alone. More than 800,000 deaths in India are caused by diseases related to tobacco use, a WHO report said. About 90 percent of all oral cancer cases in India were among

tobacco addicts.



## Jackson eyes release of two aid workers

WASHINGTON (Reuters) — U.S. civil rights leader Jesse Jackson said on Monday he had asked Yugoslavia to release two Australian aid workers and a local colleague jailed as spies, saying they were being used as "war trophies.

Jackson, who obtained the release of three American soldiers from Yugoslavia earlier this month, also renewed his call for NATO to stop bombing Yugoslavia for 72 hours.

"I talked with the foreign minister, (Zivadin) Jovanovic, yesterday, appealing to him to release the three," Jackson said in a telephone interview in Washing-

"They are being used as war trophies and they should be released, just as the three American soldiers were released. And that's how I appealed to them," Jackson said

Jackson quoted Jovanovic as saying "he would get back to me onit." He said he planned to speak with the foreign minister again on Tuesday.

A Yugoslav judge on Saturday sentenced the Australian CARE workers to prison terms for carrying suspicious documents. CARE said Yugoslav border guards misinterpreted situation reports the workers were carrying.

Steve Pratt was sentenced to 12 years and Peter Wallace received four years. A Yugoslav colleague, Branko Jelen, was given six years.

CARE said the men were delivering food and medical supplies to Serb refugees displaced during the 1992-1995 Bosnia

When Jackson went to Yugoslavia to seek the release of three American soldiers - Christopher Stone, Andrew Ramirez and Steven Gonzales - he sidestepped a request from Australia to help win freedom for the aid workers.

Australia, outraged by the jailings, has launched a campaign for their release. Former Soviet Leader Mikhail Gorbachew, U.N. Secretary-General Kofi Annan, U.N. Human Rights Commissioner Mary Robinson and South African President Nelson Mandela are among those seeking the release of Pratt and Wallace.

Jackson said the issue of the CARE workers was part of a bigger picture. Late last week, Jackson joined more than two dozen Democratic members of the House of Representatives in seeking a 72-hour cease fire from NATO.

Jackson said on Monday a bombing pause was important because the nature of the war was beginning to change. "Unintended consequences, and what we call 'collateral damage,' is now beginning to drive the war," he said.

Jackson said destruction of Serb infrastructure had left the country in terrible shape, without stopping the war.

"The humanitarian crisis within Yugoslavia is now becoming greater than the humanitarian crisis within the (refugee) camps," he said.

## **Envoys ready to test** Yugoslav peace signal

By lan Geoghegan BRUSSELS (Reuters) —

Emissaries from Russia and the European Union are preparing for a visit to Belgrade to test what Yugoslavia means by its apparent peace signals. But NATO, carrying its air

war on Yugoslavia into its 70th day and plunging the Yugoslav capital once more into darkness, is still talking hard ball.

Alliance hawks like British Foreign Minister Robin Cook insist Yugoslav President Slobodan Milosevic will not be invited to haggle over terms with Russia's Viktor Chernomyrdin and Finnish President Martti Ahtisaari.

If Milosevic "wants to end the conflict then it has to be on the basis of the NATO objectives," Cook told reporters at a European Union foreign ministers meeting in Brussels. "All members of NATO have said that there's to be no com-. promise in this conflict," he said.

And alliance spokesman Jamie Shea, taking a more aggressive line on the mounting toll of civilian deaths, said on Monday that air strikes reported to have taken dozens of lives were aimed at legitimate military targets.

Yugoslav media say more than 50 civilians were killed in the past two days in raids which included a strike on a sanatorium in the southern Serbian town of Surdulica and a direct hit on an apartment building in the southwestern town of Novi Pazar.

The state news agency Tanjug carried a warning to the West from Milosevic's office on Monday, saying that "Massacres and crimes intensified by the NATO aggressor each day...are undermining resumed peace efforts."

The agency also made official weekend reports that Yugoslavia was ready to accept terms set out by the Group of Eight - a milder, Russianbacked version of NATO's war aims.

Both sets of terms were formulated before the U.N. war crimes tribunal indicted Milosevic for war crimes - a step many experts said would make a diplomatic solution more difficult.

The difference between the two lies mainly in what sort of foreign military force would be allowed to take control in Albanian people from Serb forces.

## **Mubarak slams Saddam**

SOHAG, Egypt (AP) — Presi-dent Hosni Mubarak has rebuffed Iraq's attempt to participate in an Arab summit meant to prepare for renewing peace talks with Israel.

Mubarak, speaking to reporters Sunday while touring economic projects in this city some 390 kilometers (240 miles) south of Cairo, said Iraqi President Saddam Hussein "is un-

MANAMA (Reuters) -Bahrain's prime minister pledged on Monday to encourage foreign oil investment and to boost the role of the private sector in the Gulf Arab state.

"One of the government's top priorities is to increase and diversify the state's income ... and open the door for more oil exploration and encourage foreign investment in this field," Sheikh Khalifa bin Sulman al-Khalifa was quoted as saying by the Gulf News Agency, a day after his reappointment as premier.

Bahrain, the least wealthy of the Gulf Arab states, is a small, independent oil exporter.

It produces around 40,000 barrels per day (bpd) from its own fields and receives the entire production of around 120,000 bpd from an offshore field it shares with Saudi Arabia.

Last year, the island state signed a deal with U.S. energy firm Chevron to drill for oil in the northern and western offshore areas close to Saudi Arabia, which is the world's biggest oil producer and exporter. Chevron said last month it expected to start offshore oil drilling in Bahrain next year.

"In the coming period, the priorities will be continuing comprehensive economic development and encouraging the private sector to lead the economic development programme," Sheikh Khalifa said.

As well as reappointing the prime minister, Bahrain's Emir Sheikh Hamad bin Isa al-Khalifa named a new finance minister in a limited cabinet reshuffle as part of a pledge to give the economy top priority.

### NL roundup Vaughn homers to key Reds win 22-inning scoreless drought with

By The Associated Press NEW YORK (AP) — Greg Vaughn homered and Ron Villone and Scott Williamson combined for 6 1-3 innings of hitless relief to lead the Cincinnati Reds to a 5-3 victory over the New York Mets on Monday.

It was the fourth straight loss and fifth in seven games for New York. Cincinnati has won three in a row and 11 of 15 to improve to three games over .500 (25-22) for only the second time since September 1996.

Vaughn, who missed the last

six games with an abdominal strain, hit a solo homer to give Cincinnati a 4-3 lead in the fifth. Vaughn is batting just .211 with 10 home runs after hitting 50 homers last season.





SAN ANTONIO (AP) — On a day when the San Antonio Spurs seemed destined for defeat, Sean Elliott wouldn't let it happen.


"I felt good the whole game," Elliott said. "Sometimes you get in a situation where you feel that you can't miss."

"This gives us a tremendous amount of confidence," he added, "and it has to break them a little."

The Spurs' eighth consecutive playoff victory gives them a 2-0 lead in the Western Conference finals. The best-of-7 series resumes Friday in Portland. By then, maybe the Blazers will have gotten over the way they lost this one.

"In a word, I would probably say gut-wrenching," Portland coach Mike Dunleavy said.

Arvydas Sabonis, who had only five points in Portland's 80-76 loss in Game 1 Saturday, had 17 points for the Blazers, while Wallace, saddled with foul trouble all game, had 13 points.


ONE thing is for sure about American Samoa: When it travels, it brings heavy baggage.
