Teno signs \$13M CIP bill

Variety News Staff GOVERNOR Pedro P. Tenorio yesterday signed a House-sponsored bill into law paving the way for the construction of over \$13 million worth of capital infrastructure projects (CIP).

House Bill 11-408 became Public Law 11-79 to guarantee local matching funds for the construction of several infrastructure projects which will be partially funded by the federal government under the Section 702 of the Covenant.

Tenorio is upbeat on the ripple effect of the new construction projects which, he said, will provide for the much needed fresh capital into the Commonwealth's struggling economy.

PL 11-79 corrects the technical deficiencies in PL 11-78. This deficiencies include the abrupt changed made by the CNMI Leg-

islature in the seven-year CIP Plan which earlier prompted the governor to veto some items contained in HB 11-380 which is now known as PL 11-78.

Only two projects — the construction of a new prison facility and the completion of the Marianas High School gymnasium — under the original CIP bill were preserved.

The Adult Prison/Crime Lab, Immigration Detention facility and Youth Facility will initially get funding under the new CIP

Infrastructure projects on Saipan that include the Nang Ocha Road, Chinatown sewerage system, and power, water and wastewater systems for Koblerville homesteads, Tanapag homesteads will have to be included in the CIP Plan before it gets funding.

The governor explained the

need to formally amend the CIP Plan, incorporating the project changes in order to comply with federal requirements for release of funds.

He said the Plan requires legislative resolution to make substantive changes. He added a formal plan amendment must be done for Rota's Sinapalo/Songsong road improvement.

The CIP Plan identifies Sinapalo Road Improvements but it does not include the Songsong

project. A formal amendment is also needed to include the West Tinian International Airport in the project list.

Tenorio said the projects listed under PL 11-79 will vastly improve the infrastructure on Rota, Saipan and Tinian, as these will also provide a much needed boost in the local economy by getting over \$13 million in total funds circulated within the CNMI.

N. Korea says it needs no outside help on missiles

TOKYO (Reuters) — North Korea, repeating its position it had no plans or capability to develop nuclear weapons, also said on Monday it had not obtained technology from overseas to develop ballistic missiles.

The official Korean Central News Agency (KCNA), monitored in Tokyo, said unnamed Republican members of the U.S. Congress were floating a "strange rumour" about Pyongyang's possible nuclear and missile development through technology transfers from a third country.

"This is nothing but a groundless fabrication as it is a cockand-bull story that can be made only by those who are suffering from mental derangement,"

It said it had neither the will nor the capacity to develop nuclear weapons.

"Their talk about 'missile development' through 'transfer of technology' is also a sheer lie which does not deserve even a passing note," it said.

"We make it clear again that the launching of missile and satellite is the shining result of our highly developed 'juche' (self-reliance) oriented science and technology.'

A team of U.S. experts found mo reason last month to believe at this stage that an underground building site in North Korea violated a 1994 nuclear deal between Washington and Pyongyang, the U.S. State Department said.

Japan economy stops worsening

TOKYO (AP) — Japan's economy has stopped deteriorating as a result of government spending, though risks remain, the government said Tuesday.

In its closely watched monthly report, the Economic Planning Agency upgraded its assessment of the nation's economy in June for the first time in three months.

The agency said that the economy "has stopped deteriorating and is fluctuating sideways." Since March, the assessment had said "downward movement continues to slow to a halt."

The report is considered a key indicator of government thinking on the state of the economy and can sometimes anticipate new policy initiatives.

Japan is struggling through ts worst recession in 50 years amid record high joblessness and aggressive restructuring at corporations.

The report said that private spending continues to be pressured by wage concerns as corporations restructure, but is showing signs of slight recovery from spring lows. Last month's report said consumption was simply fluctuating at low levels.

Production was also slightly upgraded from May's report with some progress noted in inventory adjustment. Last month's report said that production was close to bottoming

The agency also highlighted strength in the housing sector.

Construction starts for new private homes in Japan rose by 12.5 percent in April after soaring 19.1 percent in March and 9.0 percent in February. Total housing starts rose 1.1 percent on year — the first rise in percentage terms in 28 months.

But analysts say the rise is not necessarily an indication that consumer sentiment has turned positive. Instead, the trend reflects both newly implemented tax incentives for home buyers and concerns that long-term interest rates may be headed higher.

EPA head Taichi Sakaiya said as much in a television appearance Sunday, suggesting that the gains may not be sustainable.

"The housing investment rise isn't part of an upward trend, it was a sudden blip higher, so I don't know if it's bottomed out,"

Concerning negative factors, the agency said Japan's labor situation remains severe. The country's jobless rate remained at a postwar record high of 4.8 percent in April. Sakaiya has said that the jobless rate is likely to rise above 5 percent in the coming months.

Also, corporate investment in plant and equipment "continues to fall at a fast pace," the report said.

Government stimulus policies, however, continue to support some sectors, the report

The credit crunch affecting enterprises has eased somewhat, and government loan guarantees continue to temper growth in the number of bankruptcies, the report said.

Corporate bankruptcies in April fell 33 percent on the year and 8.1 percent from March. private credit research agency Teikoku Databank Ltd. said. It was the six month in a row of on-year declines and the fourth month in a row of falls exceeding 30 percent.

Some analysts, however, have said that the credit guarantees amount to little more than lifesupport measures for enterprises that remain shaky.

US House Republicans seek a way out of budget bind

WASHINGTON (Reuters) House Republican leaders tried to build support on Monday for a plan to appease their conservative wing and break the logiam over budget bills that threatens to derail their legislative agenda.

Meeting with several groups of House of Representatives lawmakers, Speaker Dennis Hastert outlined measures intended to keep fiscal 2000 spending within limits set by a 1997 budget-balancing agreement, but also boost spend ing on defence and education.

"It is a game plan that will reflect Republican priorities while sticking with the fiscal discipline we passed in our budget," said a spokesman for the Illinois Republican.

Hastert's spokesman said the plan "will see savings in all 13 of the appropriations bills," but with more money for the Pentagon than President Clinton has requested. There will also be a boost in education spending over current levels,

Lawmakers emerging from the meetings declined to give specifics, saying Hastert was to speak to the full Republican caucus early on

They said the required cuts virtually ensured the bills would be vetoed by the White House - if they manage to get through Congress. They charged that the committee has no strategy for passing the controversial bills.

Conservative Republicans claimed the strategy would require drastic cutbacks in the more controversial bills, including those for labor, environment and health

They said the required cuts virtually ensured the bills would be vetoed by the White House - if they manage to get through Congress. They charged that the committee has no strategy for passing the controversial bills.

DPH checks food outlets

The restaurant, however, ignored the warning, prompting the DPH's Bureau of Environmental Health to order its temporary closure during its May 30 to June 5 inspections.

"We ordered them to correct their deficiencies but they did not do anything about it," said Rosario.

2 tourists drown

TWO Japanese tourists drowned in CNMI waters, Sunday, police reported yesterday.

The first victim, identified as 67-year-old Koichi Kano was reaching for his adrift slippers while frolicking by the Mañagaha Island beach when big waves carried him out into the open sea.

A police report said Kano swam after his slippers which were washed away by waters outside the island's designated swimming zone.

His relatives told police that they saw the man struggling against the strong currents while getting back until he disappeared from their sight.

The lifeguards eventually recovered Kano's body. He was taken to to the hospital but didn't make it.

The second victim, identified as 27-year old Iwata Susumu, went with a group of divers at a Tinian dive point for an expedition at around 11 am. The report said the woman

was seen "sinking to the bottom of the ocean" at the Dump Coke area of the Tinian Dock, which is the site of their second dive. According to the report,

Susumu was free diving at the rear of their boat when a fellow diver spotted her sinking.

The other diver informed their instructors who rescued Susumu who eventually died at the Tinian Health Center.

About 450,000 Japanese tourists to come to NMI

THE JAPAN government yesterday disclosed over 450,000 of its citizens are expected to visit the CNMI this year in line with the country's recovery from the Asian economic crisis.

At the same time, Japan said the CNMI — particularly Saipan has remained to be one of the most-favored destinations among Japanese citizens mainly because of security issues.

This despite the weakening of the Japanese yen which translated to less number of Japanese who travelled outside their country for vacation.

Yoshinori Ono, Japan's chief delegate to the Asian-Pacific Parliamentarians' 65th Council Meeting said Japanese are very much concerned about security matters for rest and recreation.


He noted that despite a decline in Japanese arrivals into the CNMI from 450,000 in 1997 to 370,000 in 1998, the CNMI has continued to receive considerable tourists mainly because of its safety fea-


"We are seeing an increase in the number of Japanese travelling abroad (this 1999), and we really hope those who will come into the CNMI will exceed the 450,000 of

House divided on four-year term

THE HOUSE of Representatives may be divided on a legislative initiative extending tenure of its members to four years, according to Rep. Frank G. Cepeda (R-Prec.-4, Saipan).

In an interview yesterday, the Chair of the House Committee on Judiciary and Governmental Operations said the division may be a result of two schools of thought about the extension.

He explained that allowing for a two-year term is good in that it allows people to remove elected officials from their posts if they don't leave up to their expecta-

On the other hand, he said, a four-year term could mean people may be stuck with an elected official who is not performing well.

"In my observation," said Cepeda, "the House is split on

The proposal was introduced by Rep. Melvin L.O. Faisao (R-Prec.-3, Saipan) who said there is a need to extend the lawmakers' term to "improve the political pro-

These are HLI 11-7, which seeks to amend Article III, Section 23 of the (CNMI) Constitution by replacing the word "indigenous" with the word "Chamorro"; and HLI 11-3, which seeks to amend Article VI of the Constitution to abolish the municipal councils and establish district commissioners in their place instead.

DPS still issuing gun permits despite lack of procedures

DESPITE concerns raised by the Office of the Public Auditor (OPA) on the apparent absence of procedures in the issuance of gun permits, the Department of Public Safety did not stop processing such applications, it was

Similarly, the public safety has

also entertained papers from applicants seeking to have their weapons and ammunitions covered by licenses.

Based on its report submitted to the Office of the Governor, the department, for the past year alone, received about 424 applications for permits of firearms and explosives of which 110 was

In his report to the House committee which is conducting an oversight hearing on DPS, Public Auditor Leo LaMotte has earlier scored the department for its apparent laxity in the issuance of licenses for guns thereby causing the proliferation of loose firearms.

His office deplored the appar-'ent negligence of the public safety department in monitoring the guns

whose papers have already expired or transferred by their original owners to new ones.

"As a result, a number of firearms in the communities of the CNMI are unlicensed and unaccounted for and more than \$39,000 in licensing fees have not been collected," the government's auditor noted.

Bill to protect people's privacy

A SENATE bill now before the House of Representatives would impose criminal sanctions on acts that violate a person's right to

Sponsored by Senate Vice President Thomas P. Villagomez (R-Saipan) and Senate Floor Leader Pete P. Reyes (R-Saipan); S. B. 11-144 would also mandate that those whose privacy were violated should receive compen-

The bill was introduced and passed by the Senate shortly after ABC's "20/20" aired its episode on Saipan which featured footage of garment magnate Willie Tan taken by a hidden camera.

The bill proposes to prohibit anyone from "invading" an adult

Not needed

HOUSE Bill 11-426 wants to achieve what stoning to death in other societies has failed to do. And that is to discourage spouses from committing adultery. Introduced by House Minority Leader Dino M. Jones, the bill proposes that having an affair should be considered a felony punishable by imprisonment for not more than two years, and a fine of not more than \$5,000.

Mr. Jones says his bill aims to "encourage fidelity and faithfulness among spouses." Which is, to be sure, a worthwhile effort. But like the more draconian penalties imposed elsewhere on two-timers, it would neither reduce nor stamp out adultery. We might as well invent a drug to "cure" us of libido.

If the bill becomes law, however, there would be a dramatic increase in the amount of criminal cases filed in the local trial court, which is already groaning under the weight of backlog. Instead of disposing the more pressing cases involving labor abuse, illegal immigration, child abuse, burglary, theft, assault and murder, our judicial system would also have to deliberate on legal issues that are better handled in divorce proceedings.

Still, like Mr. Jones, we believe that the institution of marriage deserves all the help it can get from government, which, however, can only do so much. Preventing adultery is not one of them.

We think Mr. Jones knows that, too, because his main concern about adultery is not that it is happening, but that too many alien workers are supposedly committing it, and that it should also be a reason for deporting them. He said so during discussions on deportation legislation. When told that adultery is not, at present, a crime Mr. Jones said it ought to be. Hence his bill.

But again, his concern for the morality of alien workers is already being addressed by, for example, the stringent requirements of the CNMI Marriage Licensing Office and the Philippine Consulate that Filipino nationals have to meet before they could get married here. Moreover, philandering Filipinos can be sued for bigamy by their spouses back home.

Meanwhile, there is something that is causing more anxiety among the people than alien workers with too many girl- or boyfriends—burglaries, lots of them, and they remain unsolved.

What is the government doing about it?

Ditto

THE HOUSE Committee on Judiciary and Governmental Operations (JGO) will hold a public hearing next week on the following House legislative initiatives, which are proposals to amend the Constitution:

• H.L.I. 11-3, which seeks to abolish municipal councils and replace them with district commissioners;

• H.L.I. 11-7, to create an Office for Chamorro Affairs; and,

• H.L.I. 11-9, to extend the term of House members from two to four years. We urge the public to attend the hearing so they could also tell the committee

why these legislative initiatives should be rejected. Indeed, if something should be done about the current government set-up which is the goal of these legislative initiatives—it should involve the reduction of its size, not further expansion.


H.L.I. 11-3, at least, would reduce the number of council members—to be renamed "district commissioners"—from three to two on Rota and Tinian, but would increase Saipan's from three to four. Perhaps "district commissioner" sounds better than "municipal council member," but we usually need to have a more compelling reason than that before we tinker with the Constitution.

H.L.I. 11-7 aims to create a superfluity because it can be said that the entire CNMI government apparatus is already an office for the local people. In any case, if there is a concern-and there is-that the Chamorros, and the Carolinians for that matter, are becoming a minority in their own home then this proposed constitutional amendment is not the way to address it.

H.L.I. 11-9 proposes to extend the term of House members, which is perhaps not a bad idea if it also includes expanding the term of the senators. However, and particularly in light of the economic slump, voters want their representatives to be, well, more responsive, and they usually are if they know they could be thrown out of office in the next two years.

Meanwhile, despite the administration's austerity measures, the government remains too large for its own good.

Get real

WE cannot doubt the noble intention of Rep. Dino Jones' anti-adultery bill. It may not offer a full guarantee, but at least it would try to discourage "infidelity and unfaithfulness" among spouses. The bill would make adultery a felony punishable by imprisonment for not more than two years and a fine of not more than \$5,000.

WRITER Ruth L. Tighe has sued a man who allegedly refused to pay money he borrowed from her during previous years.

Tighe, through counsel Linda M. Wingenbach, asked the Superior Court to order defendant David L. Winnie to pay a total amount including interest \$7,147.79.

Winnie, however, filed a counterclaim seeking to recover damages from Tighe allegedly in the form of excessive interest payments for multiple loan agreements over the last five years beginning in 1994.

Wingenbach in Tighe's complaint filed with the Superior Court, said on Jan. 29, 1998, the parties entered into an agreement whereby Winnie, as borrower, admitted he owed plaintiff \$10,000 for various amounts of money she had loaned him over several previous years.

Wingenbach said Winnie agreed to repay the amount owed plaintiff at the rate of \$400 per month plus interest.


Defendant made only 13 payments, making him current only through Feb. 1999. Each of the payments were late, said the lawyer, adding that Winnie is in default on the loan.

The complaint said that last May 10 Tighe sent defendant a written notice to terminate the loan agreement.

Since the notice to terminate,

no additional payments have been made, Wingenbach said in the complaint.

He said works for the reduction and nonproliferation of weapons of mass destruction have been underway since the end of the Cold War. "However, to our dismay, nuclear tests were carried in South Asia in May of last year, and in August, we saw North Korea test-fire one of its mis-

Hwa explained that such tests of nuclear weapons and development of missiles could easily prompt the heightening of tension in the Asia-Pacific region that may also cause subsequent arms race.

He called for the formulating of strong international and regional measures that would advance efforts aimed at reducing the proliferation of weapons of mass destruction such as nuclear and chemical arms.

For its part, South Korea has signed the Nuclear Nonproliferation Treaty and the Comprehensive Nuclear Test Ban Treaty.

"Establishing a lasting peace between South and North Korea is one of our government's top priorities. Not only are we providing the North with humanitarian aid, but we have also been able to promote tours to Mt. Kumkang, various investment projects and agricultural cooperation," he said.

According to him, Seoul is also enticing Pyongyang to make efforts to eliminate all doubts that the world holds against North Korea, as well as make reciprocal friendly gestures to the global

North Korea has been dubbed as the world's most isolated coun-

The Japanese Diet, meanwhile, passed a bill relating to the guidelines for the US-Japan Defense Cooperation. Ono said Japan, in the past, had focused only on its own interest in peace.

"However, as a member of the Asia Pacific, our role in the 21st century is to contribute to the peace and security of the Asia Pacific through US-Japan security cooperation," he said.

"We must achieve financial security and peace by applying our wisdom and efforts in order to implement cooperative joint efforts by the people of Asia in every world," Ono added.



He did not say what specific items in the revised APPU charter are not agreeable to the Thai delegation. He only said his group and the rest of the member countries have the prerogative to study the proposal

Philippine Congressman Carlos Padilla said the Thai delegation was asking sponsors of the Constitutional changes to specifically identify the provisions in the existing charter that they proposed to amend.

"I think that is also within the prerogative of Thailand to raise that observation. Even Japan is asking for more time. They just want to review whether there are some items in the proposed amendments that merit approval,"

Delegation from the Philippines and Malaysia reported that majority of the APPU members have recognized the need to amend some provisions of the existing charter, particularly the way Council Meeting and General Assembly are being held.

"I have been receiving comments that the way the Council Meeting and the General Assembly gets boring and dragging," Padilla said, explaining that the Council Meeting does not have the power to approve the charter change but can recommend such initiative to the General Assembly.

Malaysia's head of delegation Datukwira Abu Seman Yusop, for his part, said he has nothing against the concerns raised by Thailand and Japan because the APPU charter involves the interest of all members.

"Since it is the case, we have to look into more details of the proposed amendment. We have to have a committee. That's why Thailand proposed the creation of a committee that will study the proposed amendments," he told Saipan reporters.

Reves urges APPU members' flag carriers to fly to NMI

SENATE Floor leader Pete P. Reyes yesterday urged member countries of the Asian-Pacific Parliamentarians' Union to look into the possibility of extending their flag carriers' flights into the CNMI to boost tourism and ease travel.

"We are still concerned about providing sufficient and adequate air service

for this region. So, I am asking member countries of the APPU to consider it because most of them have their own airline and we don't have an airline here," said Reyes during a break in the APPU's session.

"We want to request that... if it is feasible to come out and establish (extension) companies here in the CNMI and fly the region or in the case of Japan, increase the number of flights," said Reyes.

Reyes, who assumed post as chair of the APPU's 65th Council meeting, said he does not want to "leave any stone unturned in our effort to try

and increase the number of flights servicing the (Northern) Marianas and the region here."

Reyes, in is address to the APPU delegation, said that while CNMI is "finally beginning to see a positive increase in tourism arrivals... after a period of long decline" problems, like sufficient air service, remain to beset the local tourism industry.

"Although this (increase in arrivals) is indeed an encouraging development for our region, we continue to encounter troubling obstacles with regards to airline service and accessibility within our region," said Reyes.

Reyes noted that APPU members are "unnecessarily restricted and actually more disconnected' due to problems with air mobil-

"We, the Asian-Pacific Parliamentarians' Union, truly are an interconnected and powerful group when viewed as a political body united in the pursuit of peace, stability and prosperity in our re-

Muna wins prestigious Japan Emperor's award

Variety News Staff COLLECTING hundreds of skeletal remains of Japanese soldiers who vanished during World War II in the CNMI and the Pacific has made the 80-year old Nicolas Q. Muna a recipient of one of the highest honors given by the Japanese government.

Muna is the only second Chamorro to be conferred the Order of the Rising Sun - Silver Rays — by Japan Emperor Akihito.

The other honoree was the late Mayor Vicente D. Sablan who received the Order posthumously on September 2, 1987.

"I would always feel content when the family of the dead Japanese had the ashes but it was really sad to see the families grieving," Muna told the Variety (through an interpreter) as he recalled 16 long years of collecting skeletal remains of soldiers.

He said after collecting the bones, he and his fellow men would burn these in the Marpi

MHS blends tradition and technology in boat-building

NMC to borrow funds to address Y2K woes

THE NORTHERN Marianas College has pushed through with its plan to borrow money from Bank of Hawaii which will be used in fixing problems pertaining to the millennium computer glitch.

The move was undertaken by college officials as a result of the meeting which they held more than a week ago wherein turning to the bank for funding was laid out as among the possible options.

Frank Oliver, NMC's computer programmer said yesterday they have already informed the Bank

of Hawaii about their decision to secure a letter of credit in the amount of \$125,000 which will be used in the purchase of a software that is y2k compliant.

"What we are waiting only right now is a response from the bank," said Oliver, adding that they were hoping to install the system soon.

The college lone computer programmer said they have also already wrote officials of the software dealer, ABT Incorporated, which is based in Pennsylvania, informing them about the plan.

He said they are also waiting for the reply of company officials. As presented earlier by NMC President Agnes McPhetres, the college will avail of the letter of credit by using a \$3.5 million college money as a collateral.

McPhetres said the amount is deposited with Pacific Insurance, which is the owner of Bank of Hawaii.

Aside from the bank, McPhetres said the college is also looking forward to the Y2K funding provided by the Office of Insular Affairs for Us territories, as a possible source of money.

She said NMC is expecting to receive about \$200,000 from the OIA.

NMHC projects said underway

The corporate director also

stated that NMHC will then move to Tinian to complete the island's Teen Community Center.

On Rota, Ada said, Chamolinian and Carolinian huts will be built along the beaches.
"We're also looking forward

for the ground breaking of Treatment Center for the Division of Mental Health Services for the mentally-challenged patients that are ready to go out there in the community," Ada said.

The funds for all such projects are from the Community Development Block Grant. CDBG's goal is to build a better and stronger community to provide a foundation for a sense of neighborhood.

Bill could lead to doctors' exodus

HOUSE Minority Leader Dino M. Jones (D-Prec. 4, Saipan) said the enactment of a bill that proposes to eliminate housing benefits for government employees may lead to the resignation of several doctors working for the Commonwealth Health Center.

Jones, in a letter to Speaker Diego T. Benavente (R-Prec. 2, Saipan), said salaries given to CHC doctors are already substantially less compared to the rates in the mainland US.

The enactment of the bill—S.B. 11-61—would cause many of the doctors to leave CHC, Jones said.


Prime minister says he is 'still in control'

PORT MORESBY (Pacnews) —Papua New Guinea Prime Minister Bill Skate says he is still in control of the country after sacking four of his ministers and brought in old "enemies" in a Government he described as "formidable" and the best team to solve PNG's economic crisis.

In a move which splits his major coalition partner, People's Democratic Movement, Skate sacked the party's new leader, Sir Mekere Morauta and three other ministers in favour of his one-time deputy prime minister, Chris Haiveta and three other Pangu stalwarts.

Haiveta would be appointed deputy Prime Minister within two weeks following a decision by the incumbent Iairo Lasaro to relinquish the second highest chief executive post in government:

Skate sacked Haiveta in 1997 after accusing him and the then agriculture minister, Andrew Baing, of trying to topple his government following the broadcast of the infamous Mujo Sefa tapes on Australian Broadcasting Cor-



poration television.

Following the swearing-in ceremony at Government House. Skate admitted that he had sacked Haiveta for personal reasons and for his own political survival.

He and Haiveta said they had resolved their political differences and were committed to working together as a team up to the year 2002, when PNG goes to its first elections in the new millennium.

The PDM ministers sacked along with Sir Mekere, who was fisheries minister, were Vincent Auali (transport), Mao Zeming

(housing) and Herowa Agiwa (environment and conservation).

Those appointed to succeed them are Haiveta (fisheries), Samson Napo (housing), Michael Ogio (environment and conservation) and Sir Pita Lus (transport).

Another Pangu MP, Robert Nagle, was appointed minister for justice, replacing Simon Kaumi from the PNG First party, who now takes over the vacated Rural Development Ministry.

The PNG Prime Minister accused Sir Mekere of not using his vast experience to help fix the nation's economy, which was now in deep trouble.

He described Haiveta as one of the best leaders in PNG who will help solve the economic crisis.

"I am in control," the Prime Minister declared when addressing a news conference immediately after the swearing-in of the

Hours after that, he issued another statement calling on four of his own PNG First party MPs to resign or be sacked for disloyalty

Solomons PM says weapons stored in NZ belongs to gov't

HONIARA (Pacnews) — The Solomon Islands Government is yet to decide on what to do with arms bought by the former Mamaloni Government, currently stored in New Zealand.

This was revealed in Parliament by Prime Minister Bartholomew Ulufa'alu and his National Security Minister, Robin Mesepitu.

Ulufa'alu said the arms, worth \$AUS19 million (\$US12.6 million) was bought from an arms supplier in the United States more than a year

The Government has agreed to store the arms for two years in New Zealand. The two years expires at the end of this year.

National Planning Minister Mesepitu said the Government has not decided on what it will do with the arms, to sell them or bring them to Port Vila.

Former Prime Minister Solomon Mamaloni had bought the arms for civil purposes and use during emergency period.

The consignment includes a hanger, night vision equipment and other sophisticated military hardwares.

They were diverted and stored in New Zealand because the former Mamaloni Government felt it was inappropriate to bring the consignment at that time when peace talks to end the Bougainville crisis were in progress.

RP peace talks sought

MANILA, Philippines (AP) — The Philippine government told local officials and law enforcers Monday to begin peace negotiations with splinter Communist rebel groups following the termination of peace talks with the main Communist party.

Government officials also discussed ways of thwarting a possible resumption of major attacks by the guerrillas.

"We are asking you to now begin to be more active in the pursuit of peace initiatives at the local level," Vice President Gloria Macapagal-Arroyo said.

Arroyo said last month's termination of peace talks by the National Democratic Front, the main Marxist umbrella group, "does not mean that we are not talking anymore and we are at

"We are merely changing our conversations and dialogue partners," she said in a statement.

The NDF, which has held onand-off talks with the government since 1992, withdrew from the negotiations on May 28, a day after the Philippine Senate approved an accord allowing U.S. troops to resume largescale military exercises in the

NDF leaders said the passage of the Visiting Forces Agree-

ment with the United States violated Philippine sovereignty and warned that the talks' cancellation could lead to a resumption of high-profile rebel attacks.

President Joseph Estrada, who is making a state visit to South Korea, has authorized government negotiators to pursue peace talks with Communist rebels at the regional level.

Presidential Executive Secretary Ronaldo Zamora said the government has identified several Communist rebel groups which may be interested in peace

He declined to name the groups and denied that the government's intention was to further splinter the Communist movement. There are a number of groups that broke off from the Communist Party of the Philippines in recent years because of differences over ideology and tactics.

The government has notified the NDF that it will cancel safety guarantees it granted to rebel negotiators and their consultants in the peace talks.

The cancellation of the guarantees, which takes effect after 30 days, will expose rebel officials with pending arrest warrants to possible arrests.

The VFA was approved by 18 of 23 Philippine senators despite strong opposition from Catholic church leaders and left-Prior to the dispute over the wing groups.

The accord allows the resumption of military exercises and U.S. ship visits which were suspended in 1996.



MANILA, Philippines (AP)—A steady softening of domestic interest rates buoyed Philippine stocks Tuesday, offsetting concerns over a possible increase in U.S. interest rates, traders said.

The Philippine Stock Exchange Index of 30 selected companies rose 12.06 points, or 0.5 percent, to 2,415.07 after rising 48.41 points Monday.

"The declining trend of local interest rates is providing the market some support," said Mariline Katimbang, vice president for research of Magnum International Securities Inc.

The broader All Shares Index rose 5.6 points to 780.04 after advancing 11.36 points Monday. Gainers beat losers 69 to 40, while 38 issues were unchanged.

Philippine Long Distance Tele-

phone Co., still basking in the news of its acquisition of mobile phone provider Smart Communications and the entry of Japan's Nippon Telegraph and Telephone as new investor, led advancers. PLDT shares rose 5 pesos to 1,125 pesos.

In Monday's weekly auction. treasury bill rates slid to their lowest levels in three years after a cut in the central bank's key overnight rates and lower-than-expected inflation in May. The average yield of 91-day treasury bills was 9.491 percent.

Taiwan pledges \$.3B aid

TAIPEI, Taiwan (AP) — Taiwan will provide U.S. dlrs 300 million to care for Kosovo refugees and speed reconstruction of the embattled Yugoslav province once they are allowed to return home, President Lee Teng-hui said Mon-

The aid will include emergency supplies for refugees and contributions to

long-term reconstruction efforts by the international community in Kosovo once a peace plan is accepted. Lee told a news conference.

Taiwan also wants to arrange for Kosovo refugees to receive short-term technical training in Taiwan, Lee said.

The aid package reflects increasingly aggressive attempts by diplomatically isolated Taiwan to play a greater role in the international community.

"We hope the three aid measures will contribute to the advancement of a peace program for Kosovo and allow all the refugees to return at an early date to safe and peaceful homes in Kosovo," Lee said.



The Macedonia deal includes a \$12 million low-interest loan for infrastructure such as roads and bridges, and a \$3 million trade grant from the import export bank, said Lin Hsiao-chuen, an eastern Europe specialist at the Foreign Ministry.

The government has also secured loans for eight Taiwanese businesses who have committed to investing \$3 million in Macedonia, Lin said.

Taiwan will also sign trade agreements during the visit this week of Macedonian Prime Minister Ljubco Georgievski, who arrived Sunday at the head of a 59-member delegation.

HK suspends European beef, dairy sales


HONG KONG (AP) — Hong Kong on Monday told local shops to stop selling beef and dairy products from four European countries following a scare over cancer-causing dioxin in some Belgian foods.

The Department of Health said the suspension of dairy products from Belgium, France, Germany and the Netherlands would include infant milk formulas and baby food.

Last week, the government ordered stores to stop selling poultry and pork products from the same four European countries.

A government statement said the Hong Kong food industry had been very cooperative in pulling the food from store shelves.

Thai gov't bans Belgium dairy and meat products

BANGKOK, Thailand (AP)-The Thai government Monday banned meat, eggs and dairy products imported from Belgium because of contamination with

dioxin, a deadly chemical. Dr. Monekol na Songkhla, head of Thailand's Food and Drug Administration, said the ban would start Tuesday, joining nations from Switzerland to South Korea banning the Belgian products.

The Livestock Department was ordered to closely check products already imported from Belgium for dioxin contamination. None has so far been found, Mongkol said.

Sixteen Thai companies im-

port the banned products from Belgium in the form of chocolate, biscuits, meat and related

The Belgian government has banned several categories of food to its citizens following the discovery of dioxin contamination in animal feed. The ban was extended Monday to butter.

Belgium's food industry federation said the 11-day crisis already has cost the sector about 20 billion francs (\$500 million).

The United States blocked European Union imports of pork and poultry, and Singapore banned all meat products from the 15-nation group, of which Belgium is a member.

Korea bans sale of Belgian, French pork

SEOUL, South Korea (AP) -South Korea ordered a ban Monday on the sale of French, Dutch and Belgian pork because of possible contamination by cancercausing dioxin.

South Korea has already halted imports of pork and other poultry products from Belgium last week and of pork from France and the Netherlands Sunday.

Belgian poultry, cattle and pigs were found to have been exposed to animal feed contaminated with dioxin

South Korea has imported 2,484 tons of French pork this year, of which 1,408 tons have already been distributed. Of 2,882 Dutch pork imported this year, some 1,977 tons have been distributed.

South Korea also imported 3,370 tons of Belgian pork this year, of which 2,430 tons have already been distributed.

About 225 tons of Belgian egg whites were waiting for customs clearance. The undistributed products will be collected and destroyed, government officials

China calls for pause in the bombing

(Reuters) - The secretary-general said that China, a permanent member of the U.N. Security Council with veto power, wanted a pause in the bombing before it approves a resolution on the peace plan, now being negotiated in Bonn. And Beijing was asking for a complete report on NATO's bombing of its embassy in Belgrade last month, he said.

"The way the process is moving along (one) may be able to satisfy them, more or less simultaneously" with the passage of a resolution. If not, "something has to give and don't ask me what," he said in answer to queries by CBS correspondent Leslie Stahl during a U.N. forum sponsored by Civilisation magazine.

Foreign ministers from the Froup of Seven industrial nations and Russia were meeting in Bonn again on Tuesday to draft the resolution that would authorise Yugoslav forces to withdraw from Kosovo and NATO and other troops to go into the Yugoslav province.

Problems arose late on Monday between the Western countries and Moscow on how the international troops going into Kosovo would be organised. Annan said he expected the foreign ministers to reach a conclusion on Tuesday or at the latest on Wednesday.





Official media reported staggering amounts of goods smuggled and bribes changing hands. One of those sentenced to death, Li Shen, smuggled more than 3,800 vehicles, 19 tons of steel, 40,000 tons of diesel fuel and 10,000 tons of raw sugar, the Xinhua News Agency said.

The head of investigations for the customs bureau of the port city of Zhanjiang, Zhu Xiangcheng, took in 2.8 million yuan (\$340,000) in bribes and had stashed away another 3.4 million yuan (\$410,000) whose source he could not explain, Xinhua said.

Xinhua gave no totals for the amounts smuggled or paid off. of the graft, those convicted included the heads of two customs bureaus, a vice mayor and a police commander in charge of border patrol, Xinhua said.

Courts last month issued death sentences for smugglers Li Shen, Zhang Qi, Deng Chongan — all from Hong Kong; mainland partner Lin Chunhua; and customs investigator Zhu and his boss, Zhanjiang customs chief Cao Xiukang. Eight others got suspended death sentences, which are usually commuted to life in prison if the prisoner repents.

Guangdong's Higher People's Court Monday morning upheld the death sentences and ordered that they be carried out immediately, Xinhua reported. It did not specify the method, but most executions in China are carried out by gunshot.

Investigators busted up the ring last year after Chinese leaders declared a nationwide crackdown against smuggling so rampant it was eroding government revenues and distorting markets. In Guangdong, the campaign dovetailed with an attempt by Beijing to enforce its authority by firing local leaders who had ignored central government orders.

"The harm from smuggling is extremely intense," People's Daily, the authoritative newspaper of the Communist Party, said in an editorial released Monday night for publication Tuesday.

Smuggling"endangers the economic and industrial security of the people. It abets the corruption, selfishness and decentralism of some places and units. It undermines the central authorities unified command. It harms the party and government's prestige with the people," the news-

Tropical Storm Maggie shuts Hong Kong and southern China

HONG KONG (AP) - Hong Kong and southern China were largely shut down early Monday but no injuries were immediately reported as a tropical storm swept past — a day after it brought severe damage and killed several people in the Philippines and Taiwan.

In China's southern Guangdong province, Tropical Storm Maggie blew down power lines and caused blackouts in the urban areas, but no one was reported hurt, China's state-run Xinhua news agency reported.

Heavy rain swelled rivers and streams and destroyed tens of thousands of acres of crops, washing out half of the crops of longan and lychee - popular Chinese summer fruits — in Huilai county, Xinhua and Hong Kong television reported.

Maggie had hit Hong Kong nearly head-on overnight, after the Hong Kong Observatory hoisted the No. 8 and No. 9 serious gale wind warning signals. The storm had peak winds of about 140 kilometers per hour (87 mph).

Some public transport was disrupted and all financial institutions, schools, government offices and courts were closed early Monday, before the observatory lowered the gale signals and many places started reopening.

The airport had remained opened throughout, but 14 flights were delayed.

Strong winds blew down some trees and scaffoldings and Hong Kong was hit by moderate rains, but no major accidents were re-

By 0600 GMT, Maggie was packing winds that had lessened to 41 kph to 62 kph (26 mph to 38 mph). The storm was centered at about 190 kms (118 miles) west-southwest of Hong Kong, moving at about 25 kph (16 mph) further into China, a government statement said.

Maggie had caused severe damage and some deaths in Taiwan and the Philippines over the weekend.

In the Philippines, Maggie killed at least three people and stranded thousands of commuters, causing major flooding in some provinces.

In Taiwan, Maggie left one dead and four missing on Sun-

One woman was swept to the sea and drowned off western Penghu Island, and three fishermen were missing after their boat overturned off a coast in southeastern Tainan city, police said. Another man was reported missing when fishing in eastern Ilan, police said.

Maggie's heavy rains and strong winds flooded rice paddies and destroyed fruit plants, causing an estimated damage of more than 150 million Taiwan dollars (\$4.5 million), agriculture officials said.

Mahathir predicts opposition to try dirty tactics in elections

KUALA LUMPUR, Malaysia (AP) — Malaysia's prime miniser on Monday stepped up. his attack on opposition parties, accusing them of using shifty tactics, including violence and the help of foreigners, before the upcoming general elections.

"I'm giving my assurance that we will not resort to dirty tactics. We will not seek the help of foreigners," Prime Minister Mahathir Mohamad, who has ruled this Southeast Asian nation for 18 years, told the national new agency Bernama.

"There is no reason for the opposition to accuse the government of being dirty, they are dirty," ne added.

Analysts have said Mahathir may call a snap poll as early as July, although general elections are not due for another year. The 73-year-old leader has faced un-


former deputy, Anwar Ibrahim, in

Mahathir has repeatedly accused the foreign media of rooting for Anwar, who insists the charges against him were crafted to end his challenge to Mahathir. Anwar, who is serving a six-year prison term on corruption charges, began standing trial Monday for sodomy, a crime in predominantly Muslim Malaysia.

"The foreign media works for the opposition," Mahathir said.

"They are using the foreign media to attack us. You've read—has the foreign media anything good to say about us?"

> Mahathir said the opposition posed a security risk to the nation, citing anti-government street rallies in which riot police have clashed with Anwar supporters who have demanded his resignation.



"Supporters of the opposition comprise those who have taken part in demonstrations last year and I am sure they will resort to violence to achieve their objective," Mahathir said.

He added that maintaining security within Malaysia was "a problem" because the foreign

media only showed one side of the story.

"When the police were to use a little violence to control the situation, they will record this and the footage will be shown throughout the world with the purpose of tarnishing our image," the prime minister said.

In the wake of Anwar's jailing, four diverse opposition groups banded together in a coalition calling for political reforms. The group is led by the National Justice Party headed by Anwar's wife, Azizah Ismail.

Recently, a rift has emerged in the coalition over diverging election strategies. The only Islamic party in the coalition, Parti Islam SeMalaysia, favors an Islamic state, which the other three party's staunchly oppose.

Mahathir dismissed the coalition as a viable threat to his rule.

Gun control debate at House

WASHINGTON (Reuters) — The House Judiciary Commit-

tee will open its gun control debate on Wednesday, using as its starting point measures closely resembling those passed by the Senate last month, a committee spokesman said Monday.

Judiciary Chairman Henry Hyde, an Illinois Republican more favourable toward gun control than most Republicans, will call for safety devices such as child-proof locks to be sold with all handguns. His plan for

background checks at gun shows will also resemble the Democratic language narrowly accepted by the Senate, Hyde's spokesman said.

The bill is likely to be bitterly debated and heavily amended in the committee, which is dominated on the Republican side by conservatives who do not share Hyde's views on guns and on the Democratic side by liberals who may try to modify the underlying juvenile crime provisions of the bill.

"We haven't been able to get

derlying bill," said Virginia Democrat Bobby Scott, who helped negotiate an earlier bipartisan version that has been thrown into question by the gun debate. "The gun debate has clouded discussion of the juvenile justice provisions."

By the time the committee finishes later this week, the bill may have changed dramatically, and its fate in the full House is also in question.


The Republicans have only a six-seat margin in the House, but guns are a regional issue as well as a party one. About 30 House Democrats from southern or rural districts are likely to join Republican conservatives in opposing tough new mea-

Similarly, some suburban Republicans, particularly from the Northeast and Midwest, will join Democrats if the Republicans try to water down the measures passed by the Senate.

"The battleground is always the suburbs," said Desmond Riley from the Coalition to Stop Gun Violence. "This will be a tough vote for Republican suburban representatives."

The announcement about the bill and the timetable, which came after Hyde met House Republican leaders, ended a day of speculation about the fate of the juvenile crime bill as the House reconvened after a week-long break. House leaders had considered possibly bypassing the committee, and taking the measure directly to the floor.

The momentum for modest new gun legislation and closure

of loopholes in existing gun law increased after the 15 deaths at Columbine High School in Littleton, Colorado in April.

The Senate last month passed a youth crime bill including a package of gun measures, the first gun legislation passed since the Republicans captured control of the Senate in 1994.

But Senate Republicans twisted and turned in that debate, switching positions several times and getting battered by public opinion.

House Republican leaders, already grappling with severe internal divisions over the annual spending bills, hoped to avoid embarrassing disarray over the gun issue and announced last month that they would act on legislation similar to, though not necessarily identical to, the Sen-

One area of dispute was whether background checks at gun shows would be conducted in 24 hours, as many Republicans favour, or in 72 hours, which is what the Senate finally accepted. Hyde's spokesman said he would include the threeday period on his bill.

Democrats had tried and failed to get the House to vote on gun measures before starting the week-long Memorial Day break, fearing the delay could dampen momentum and give the National Rifle Association time to step up pressure in the House.

The NRA is particularly opposed to the Senate gun show measure. It urged its members to "saturate" the pro-gun community, and make their voices heard in Congress.

The association said in a membership alert on its Web site that background checks would do nothing to stop school violence or crime but would "create an enormous maze of complex new federal regulations, designed to trap you and fellow gun-owners in a snare of obscure restrictions for activities that have always been lawful and constitutionally protected."

To brief officials on Kosovo peace

German envoy in Beijing

BELJING (AP) — A German envoy briefed Chinese officials Monday on plans for a United Nations resolution as part of efforts to restore peace to Kosovo, a German Embassy spokesman said.

Gunter Pleuger, the German Foreign Ministry's political director, held one day of meetings Monday with Chinese officials, including Wang Guangya, an assistant minister at the Ministry of Foreign Affairs, said the spokesman.

Pleuger gave the Chinese a detailed explanation on plans by the G-8 group of leading industrial countries and Russia to draft a U.N. resolution called for in a peace plan to end the Kosovo crisis, a state-

ment released by the embassy said. In the statement, Pleuger described his talks and "friendly and constructive" and said he encouraged China "to play an active role in the search for a peaceful solu-

His visit went ahead despite a last-minute decision by Finnish President Martti Ahtisaari, the chief architect of the peace plan, to postpone a planned one-day visit Monday to Beijing as talks between Serbian and NATO military leaders collapsed.



San Nicolas in his order explained that based upon law and DOLI's policy, Labor lacks the jurisdiction to entertain Zheng's complaint.

The director said in Nov. 1996 DOLI issued a new policy which prohibits the acceptance of labor complaints from individuals who are not bonafide nonresident workers.

On the other hand, the DOLI secretary stated that there is no acceptable explanation for the late filing of Zheng's complaint.



Race, Sinclair lose to Fiji


