1,566 packages of sugar were received yesterday.

W. R. Castle, Esq., moved into his new Law Office yesterday.

There will not be any music at Emma Square this afternoon, the Band being away on Maui.

Passengers per Iwalani yesterday: Mr. Brewer and wife, Mrs. Conradt, 2 children and servants, H. Bradley, and several others.

The steamers Likelike and Lehua from Windward Ports, C. R. Bishop and Jas. Makee from Kaula, are expected to-morrow morning.

The Custom House Guards, while examining 54 packages of Chinese merchandise, landed from the Australia yesterday, found 200 tins of opium.

The Messrs. Wall launched their new sail boat last evening. She is a centre board boat, about 29 feet long and 11 feet beam, and will carry twenty persons comfortably.

At Honuapo, last Wednesday, one of the Iwalani's boats was capsized while on its way from the landing to the steamer. The mails and baggage that were in it at the time were considerably damaged by water.

**SUGARS**—The local Refineries have made no change in their prices for refined since our last; their yellows range from 7 1-2 to 9 1-2 cents, with a rebate of 1-4 cent to regular jobbers.

Hawaiian Grocery grades 6 3-4 at 7 3-4 cents in bags, and 7 to 8 1-4 in kegs.

Cuba centrifugals in New York were sold on January 25th at 8 cents for 96 per cent. polarization, Feb. 3rd at 7 3-4, and Feb. 7th at 7 7-8.

Crop throughout the West Indies promise to be extra heavy.

Manila basis was reduced on the 10th inst. to \$6 71.

Rice selling at 4 3-4 at 5 cents cash. Sales to arrive by next vessel at 4 7-8 cents.

### Latest Foreign News.

The San Francisco Chronicle continues to try its best to upset the Reciprocity Treaty.

Ireland remains in a disturbed condition, and outrages are the order of the day.

The members of the House Committee on Labor say they will get up their bill restricting Chinese immigration inside of ten days.

The death rate in San Francisco is said to be abnormally great, and is attributed to defective sewerage.

England and France have sent a collection note to the powers, explaining their attitude on the Egyptian question.

The steamer Bahama has been wrecked on the Atlantic. Thirteen survivors have been picked up and brought to New York.

Some persons have been injured by the explosion of infernal machines in Edinburgh, Scotland.

A captain of a British man-of-war has been severely wounded by an Albanian in Asia Minor.

The German Government is arranging to have their trans-Atlantic steamers converted into cruisers, if necessary.
