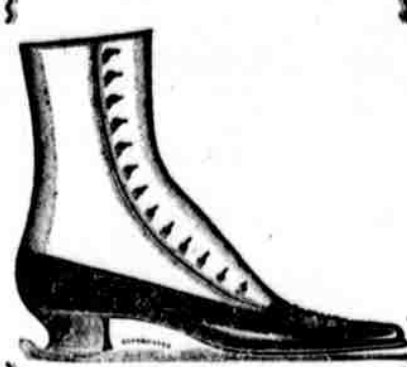

## LATE FOREIGN NEWS.

SAN FRANCISCO, April 6.  
 [By S. S. ARWA.]

### UNITED STATES.

C. A. Spreckels has brought suit  
 against his father, Claus Spreckels,  
 for about \$3,000,000 damages for  
 slander.

A dispatch from Rome says Mrs.  
 J. W. Mackay is at Monte Carlo,  
 whence she returns to London for  
 the season. Her daughter the Prin-  
 cess of Colonna has obtained a de-  
 cree of separation from her husband  
 in the Roman courts. Before leav-  
 ing Rome Mrs. Mackay was received  
 by the Queen of Italy.

E. P. Treacher and family of Cam-  
 bridge, Mass., were put in jail in  
 Mexico because Mr. Thresher dis-  
 puted a hotel bill. They were only  
 released on bail furnished by the  
 Consul.

The jury in the strikers' case at  
 San Francisco are as yet unable to  
 agree.

Governor Wertz of New Jersey  
 has been re-qualified for troops to  
 suppress labor troubles at the Staten  
 Island terra cotta works.

The Chicago Post prints a sensa-  
 tional report about the disappear-  
 ance of \$500,000 of the Democratic  
 campaign fund, levied off city hall  
 employees and others.

John W. Rockefeller and several  
 members of the Standard Oil Com-  
 pany, who have been indicted, are  
 said to be fugitives from justice in  
 Texas.

Eugene, Oregon, has elected wo-  
 men exclusively for mayor and coun-  
 cilors.

It is reported that a vein of gold  
 has been discovered near Midford,  
 Utah, of which two feet assays \$250  
 to the ton, and six inches more than  
 \$30,000 to the ton.

Frost in Santa Clara, Cal., has left  
 little more than one fifth of the  
 apricot crop.

Oil is oozing out of a hard beaten  
 path in a San Bernardino, Cal.,  
 street, and oil is the talk of the  
 town.

George H. Hallbron, managing  
 editor of the Post-Intelligencer Sea-  
 tle, Wash., aged 35 years, was found  
 dead in his bathtub. His death is  
 supposed to have been from apoplexy.  
 He had \$147,000 insurance on his  
 life.

Lippitt, the Republican candidate,  
 has been elected Governor of Rhode  
 Island by about 11,000 plurality.

Ex-Congressman Benj. Gwinn  
 Harris of Maryland is dead at the  
 age of 88.

Captain Lauchlan McKay, one of  
 the noted shipbuilding firm of Mc-  
 Kay Brothers, Boston, is dead. He  
 was a carpenter on the U. S. S. Con-  
 stellation, on which David G. Far-  
 ragut was a lieutenant. Captain  
 McKay was 84 years of age and a  
 native of Nova Scotia.

The triple screw cruiser Minne-  
 apolis is to have her final trial in  
 foreign seas, which will be a departure  
 from the old practice. Orders were  
 yesterday cabled to the Admiral at  
 Kingston, Jamaica, to put the ship  
 through a thorough two days' sea  
 trial some time between April 23  
 and May 7, which last date will be  
 just five months from that of the  
 original acceptance trial.

Subscribers to the San Joaquin  
 Valley Railroad, projected in the  
 interests of the people, elected  
 Claus Spreckels as president. Adolph  
 B. Spreckels was elected one of nine  
 trustees.

Joseph O. Donohue, a prominent  
 San Francisco banker, is dead at  
 the age of 69. He was a native of  
 Ireland and came to America in  
 early life.

Rev. Henry Varley, the English  
 evangelist, is conducting services at  
 Oakland, Cal. His zeal has infected  
 prominent ministers of Oakland,  
 so that they preach nightly on the  
 streets.

Dr. Robert S. Macbeth is in jail  
 at San Francisco for causing the  
 death of Mrs. Catherine Quinn.  
 With her dying breath the woman  
 accused the doctor of prenatal mur-  
 der, but admitted that she herself  
 had sought her fate.

The jury trying the Taylors at  
 Carrollton, Missouri, for murder dis-  
 agreed, seven to five, and were bis-  
 ed by the spectators.

German and Scotch sugars are  
 underselling the trust's article in  
 New York. The trust in a circular  
 asks brokers not to handle foreign  
 sugar.

In the Samoan correspondence  
 just made public at Washington,  
 there is a series of sarcastic letters  
 from James H. Mulligan, Consul-  
 General, reflecting bitterly on the  
 conduct of Chief Justice Ifo.

A mysterious explosion in New  
 Orleans wrecked several buildings  
 and killed five persons. Police be-  
 lieve it was an accident, but people  
 in the vicinity think it was malicious.

A shortage of more than \$80,000  
 has been discovered in the Carson,  
 Nev., mint. It is believed the stolen  
 gold was sold in San Francisco.

On the strength of a false report  
 of Queen Victoria's death, in an Aus-  
 tin, Texas, paper, the House of Rep-  
 resentatives of that State unanimo-  
 usly adopted a resolution of con-  
 dolence.

### The Woman's Temple.

Marshal Field of Chicago pro-  
 mises \$25,000, with the proviso that  
 \$275,000 more be raised by January  
 1, 1896, to pay off the debt on the  
 Woman's Temple. The building  
 cost \$1,650,000, leaving a floating  
 debt of \$650,000. When free of debt  
 the building will be decided to the  
 W. C. T. U. Lady Henry Somerset  
 of England wrote to Mr. Field, say-  
 ing that any financial failure would  
 be disastrous to temperance work  
 all over the world. In a few days  
 Mr. Field responded with his offer,  
 and plans are already perfected to  
 secure the desired amount. Mrs. C.  
 H. McCormack has subscribed \$10,-  
 000 and several smaller sums have  
 been added.

### EUROPE.

The Irish land bill has passed  
 second reading in the House of  
 Commons.

Monometallists in London will  
 appoint a committee to uphold the  
 gold standard.

The bill suspending for a year  
 from June 1st the export duties on  
 sugar from the Dutch East Indies  
 has been adopted at The Hague.

### OTHER LANDS.

The editor of a City of Mexico  
 newspaper has received a sen-  
 tence of seven months' imprison-  
 ment and a fine of \$200 for attack-  
 ing the Minister of Guatemala.

British Columbia lumbermen are  
 much put out by a decision that  
 their cedar must pay duty in the  
 United States. They hold that it  
 should be exempt under the tariff as  
 house-building material.

The Spanish Government complies  
 with the request of the United  
 States to grant a speedy trial to two  
 Americans arrested in a small boat  
 near Santiago charged with landing  
 insurgents on Cuba.

### British Victory

The British forces sent to relieve  
 Chitral, Afghanistan, defeated the  
 enemy, killing and wounding 500.  
 Three British officers were severely  
 and four slightly injured, and three  
 soldiers killed according to first re-  
 ports, but a later account says these  
 losses were only from one brig-  
 ade. Others were to hear from  
 and it is believed the losses were  
 more serious. The Scottish reg-  
 iments stormed the defenses with  
 bravery, carrying various positions  
 at the point of the bayonet. It  
 was estimated the enemy numbered  
 12,000.

### The Nicaragua Case.

The reports that the British war-  
 ship Royal Arthur has touched at  
 Panama on her way to Nicaragua to  
 enforce the British demands cause  
 some apprehension among officials  
 and diplomats at Washington. The  
 Royal Arthur is the flagship of the  
 Pacific squadron, and carries Rear-  
 Admiral Stephenson, K. C. B., com-  
 mander of the fleet, although Cap-  
 tain Frederick French is in immedi-  
 ate command. She is one of the  
 new monsters of the British navy.

There is no official confirmation of  
 the Royal Arthur's movements, as  
 the reports of naval changes do not  
 come to Washington. The opinion  
 is expressed by those familiar with  
 the situation that if Great Britain  
 resorts to force at all the Central  
 American republics will tender their  
 services to Nicaragua.

A full schedule of Easter church  
 services will be found under the ap-  
 propriate heading.

MONROE DOCTRINE DEAD.

United States Government Finds It Not Operative.

At the meeting of the Cabinet in Washington yesterday the Venezuelan case and the Monroe doctrine came up for general discussion. Secretary Gresham and Attorney-General Olney had been investigating the doctrine for three weeks. They found it a dead letter so far as the acquiescence in it of foreign governments was concerned. It was also discovered that, although avowed by all the Presidents since Monroe, the doctrine had never been endorsed by Congress. Henry Clay in 1821, General Burdette in 1879 and Representative Crapo in 1880 had respectively brought forward a resolution to affirm the doctrine, but in no case had Congress come to a vote on the question.

In the case of Venezuela the administration is in a quandary as to how far the United States should go in backing up the controversy of that South American republic. If Great Britain is willing to submit a considerable part of the dispute to arbitration, and the result should be rejected by Venezuela, it is difficult to see how the United States can espouse the cause of the little republic.

It is the principle of arbitration for which the United States contends, and not the Venezuelan view of the merits of the case. The Venezuelan authorities have contrived to spread the impression here that they are ready to go to war with England, even at the risk of losing not only the territory involved in the disputes, but more besides.

The officials of the Washington Government do not believe that any such heroic measures are necessary in order to protect Venezuela's honor. Great Britain doubtless has a colorable claim to a part of the disputed region, and the remainder, according to assurance given Ambassador Bayard, may have its ownership adjusted by an arbitration tribunal.

It is understood that Secretary Gresham's efforts are directed toward inducing Venezuela to renew diplomatic relations with England. If he shall succeed in this, one great obstacle to a peaceful settlement will have been removed.

In view of the latest news from Venezuela, which indicates that the peppery little republic will fight before she will acknowledge England's right to 4000 square miles of territory now in dispute, statistics of the fighting force of Venezuela are interesting. An effort to get an estimate of the standing army of Venezuela at the War Department was unsuccessful. It is so small that there is no available record of it. As to the navy, Lloyd's official list of the navies of the world has this entry: Venezuela, one iron steamer, Augusta, built in 1881. If there is to be a fight, it will furnish the unique spectacle of the largest navy in the world against the smallest. It is supposed, however, that Venezuela's threats are all air bubbles and that the thing she really wants is the protection of the United States in settling her dispute with England.

Mayor Grant of Fairbault, Minn., denies that the concession of land he and his associates obtained in 1884 about the mouth of the Orinoco is involved in the dispute between Great Britain and Venezuela. A small corner had been settled on by the English, but it was the least valuable part of the land. The concession includes valuable iron mines, great forests of mahogany, rosewood and an island at the mouth of the Orinoco in which there are valuable asphalt wells. It is also believed that there is gold in paying quantities.

A New Steamer.

The Pacific Mail Company has purchased another steamer of 5000 tons. It was bought in England and is newly built. Its name was the Canterbury, but it has been changed by the Pacific Mail to the Aztec, and is now on the way to the Pacific Coast to be put in service there at once. It has been greatly needed for a long time, but the company waited before buying it until it had accumulated a surplus of earnings to apply toward the purchase.

The Sabbath Association of St. Louis has begun a crusade against theatrical dives and stores doing business on Sunday. They make personal visitations to the premises of the offenders.

Income Tax Law Riddled.

The United States Supreme Court has shot the income tax law full of holes. Its decision was to be formally ratified at noon to-day. The income tax law as a whole is upheld, but only by a divided court. All incomes derived from rents are exempted from taxation by the Federal Government, and all incomes derived from State and municipal bonds are similarly exempted. In other respects the income-tax law stands as it was passed last August, but the result of the consultations in the Supreme Court shows very conclusively that the law can easily be picked to pieces piecemeal, provided there is brought to contest each particular point as it comes up.

It is a curious fact that the law which was passed at the dictation of the Populistic wing of a Democratic Congress has been distorted by the decision of the United States Supreme Court, clearly on constitutional grounds, in such a way that it will absolutely protect the class of capitalists most offensive to the Populistic element.

The landlords of the country will pay no income tax. The owners of bonds of almost any kind, either Federal, State, county or municipal, will also be free, while the business man, the manufacturer and the salaried employee will, for the present at least, be compelled to contribute to the Treasury of the United States Government 2 percent of all incomes in excess of \$1000 per annum.

When the first vote was taken as to the general principle of the constitutionality of a law of Congress taxing incomes it was found that the court was evenly divided. Only eight Justices heard the arguments, Justice Jackson being too ill to appear in court.

The vote disclosed the fact that Chief Justice Fuller and Justices Field, Gray and Brewer were opposed to the law in toto. They believed it was unconstitutional as passed by Congress and that it was a direct tax, which according to the Constitution, must be levied among the States according to the population as returned by the census.

Justices Harlan, Brown, Shiras and White voted to sustain the law as a whole. They believed and supported their opinions by a convincing argument that while portions of the law were clearly unconstitutional, the general effect of an income tax could not be considered as opposed to the principles laid down in the constitution.

The most vigorous opponent of the law throughout was Justice Field, who would consent to no compromise; who believed the law unconstitutional from beginning to end, and who supported his opinions in all the consultations in the most vigorous and able manner. It is entirely probable that he will write and submit a strong dissenting opinion, holding that the law is unconstitutional in itself and hinting at the compromise which has been reached by which certain classes of capitalists will be unduly favored while others will have to pay the tax.

**FLIGHTY HARDEN IN JAIL.**

He is Arrested in San Francisco for Affiliation with Footpads.

Francis Leo G. Harden, who has been in Honolulu several times, is in an inner cell of the city prison at San Francisco. While tracing up evidence against two burglars and footpads—who held up and shot Walter P. Blake, a Stockton newspaper man—the detectives found as they thought that Harden might be of use to them. He was accordingly arrested in company with Carlotta Rosa Cahoesa, an Indian maiden from Mexico. The Chronicle gives him two columns and a portrait to help out the notoriety he has always invited. It deals with his case humorously, retelling Harden's valorous record in many lands as given by himself—how he resigned from the British colonial naval reserve, in which he was a lieutenant, and took part in the gory scenes of the Argentine revolution; how he fought in many battles with the insurgents of Chile, stirred up a revolution in Hawaii, was deported hence and refused a landing in Samoa, came back to Honolulu and was exiled again—the whole winding up with his efforts to get into action on either side in the Oriental war, also his unavailing efforts to organize a filibustering expedition for the restoration of the Hawaiian monarchy.

**BANK OF BISHOP & CO.**

Mr. Damon Buys the Chief Interest from Mr. Bishop.

Hon. S. M. Damon while in San Francisco completed arrangements for taking over the bank of Bishop & Co. on June 1.

Hon. C. R. Bishop, head of the firm, disposes of the working capital, \$800,000, at a moderate rate of interest, to Mr. Damon for a term of years.

Mr. Damon has received great encouragement in his enterprise, banks in London, in Canada and in San Francisco being desirous of correspondence with Bishop & Co.'s bank.

Mr. Bishop being now Vice-President of the Bank of California, desired to concentrate all his financial business there. It was also his wish to leave the capital of his Honolulu banking business at the service of this business community.

In answer to a question, Mr. Damon said the change did not necessarily involve his retirement from office as Minister of Finance, although he wished to retire as soon as he could be released from his public position.

**MR. THURSTON HOME**

Has Nothing to Add to What Has Already Been Published.

L. A. Thurston, Hawaiian Minister to Washington, is again in Honolulu, looking as unconcerned about himself as if he had only been on a trip to Ewa. He smilingly asked the representative of this paper how the BULLETIN was getting along, adding:

"I always feel as if I had a kuleana in the BULLETIN" (referring to his editorship of this paper eleven years ago.)

"I have made no plans for the future as yet," Mr. Thurston replied to a question. "I do not know that I have anything to add to what I have said already. My visit home is partly in connection with personal matters."

Mr. Thurston knew nothing of a rumor circulating again to-day that Minister Willis had been recalled by the United States Government.

**THE ORIENTAL WAR.**

Japan to Seize Formosa—Indemnity in Gold.

Japan is going to seize Formosa. The Chinese are fleeing from South Formosa to the mainland and Hongkong.

The Chinese have taken vigorous measures in Swatow and Canton to resist invaders.

A German warship that was present at the taking of the Pescadore Islands reports that the Chinese made but a feeble resistance. Six Japanese warships remain at these islands and 3000 troops have been landed there.

The Chinese at Hui Chang repeatedly fired on a flag of truce sent with a messenger to inform the Chinese that an armistice had been declared.

There are 30,000 Chinese troops in garrison at Tai-Wan-Fu.

Japan will demand the war indemnity to be paid in gold. The gold will be placed to the credit of Japan in the European trade centers. It is not likely that Japan will go on a gold basis, according to an American authority, as that would place her at a disadvantage, in trade matters, with China, which must continue on a silver basis.

Li Hung Chang is nearly well of his wound inflicted by a Japanese fanatic.

The U. S. S. Charleston has sailed from Chefoo for New-chwang, where the gunboat Petrel is waiting in a mud dock.

Col. Ito's official report of the capture of the Pescadore Islands says Makulig Castle was not taken until two engagements were fought. The Chinese lost three killed and sixty prisoners. The Japanese lost one killed and had sixteen wounded.

**GIFT FROM MRS. FOSTER.**

The Young Hawaiians' Institute the Recipient of an Ornament.

A special meeting of the Young Hawaiians' Institute was called for yesterday evening. Over twenty members were present. They were agreeably surprised by the appearance in their midst of Mrs. M. E. Foster, who presented the institute with a pen and ink copy of the following verses nicely framed:

### TAX ASSESSORS SITTING.

Annual Meeting of the Board of Tax Equalization.

For several days past the Board of Tax Equalization has been sitting in the office of the Crown Land Commissioners. It is composed of the Minister of Finance (ex officio chairman), and the Assessors-in-Chief, namely: Jonathan Shaw, Oahu; H. C. Austin, Hawaii; C. H. Dickey, Maui, Molokai and Lanai, and J. K. Farley, Kauai and Niihau. J. A. King, acting Minister of Finance, usually appoints one of the other members as chairman, and leaves the board to report its proceedings to him.

The board is sitting to-day, and will conclude its labors in two or three more sessions. It is among other things arranging forms for this year's assessments. The valuation of cane lands is a prominent subject of the board's deliberations, with a view to securing uniformity on the different islands.

The members have been anxious about Minister Damon's return, so as to confer with him upon the duties of their offices. Mr. Austin, talking to a BULLETIN reporter, spoke of the benefit inuring to the taxation service from the institution of the board. Before it was brought into being, the assessors of the different islands pursued varying methods. Their assembling in conference affords an opportunity of comparing notes and exchanging ideas upon the assessment and collection of taxes, securing a degree of uniformity as well as increased efficiency with results advantageous to the country's internal revenue, besides tending to prevent discontent on the part of taxpayers.

### FRANCE AND ENGLAND.

Some Biting Sarcasm by the Press of Paris on Great Britain.

The Paris correspondent of the Pall Mall Gazette refers to the "historical extravagance" of the Paris press regarding Great Britain, and quotes Henri Rochefort as saying that "France is submitting to a series of humiliations in sending ships to Kiel to salute the victors of Werth and Wissemburg. But, worst of all, she has endured the insults of Great Britain without protest. Why does she not hide her flag?"

The Temps demands an apology or reprisals, and says: "The speeches of Ashmead Bartlett and Sir George Curson and the eastern commercial travelers are not of the slightest importance, but we are agast at the indiscretions of Sir Edward Gray and Joseph Chamberlain."

### Esthetic Apostle in Disgrace.

Oscar Wilde's libel case against the Marquis of Queensberry has collapsed, and Oscar is in an eight by four foot cell in Bow-street police station charged with misdemeanor. The jury found a verdict of justification of the alleged libel, on the ground that the warning of the Marquis to his son against Wilde was in the public interest. Edward Carson, Q. C., counsel for Queensberry, kept Wilde on the witness stand five hours, eliciting the most damaging evidence against himself. He was proved to be the author of an infamous society novel, and to have been habitually guilty of unnatural crime.

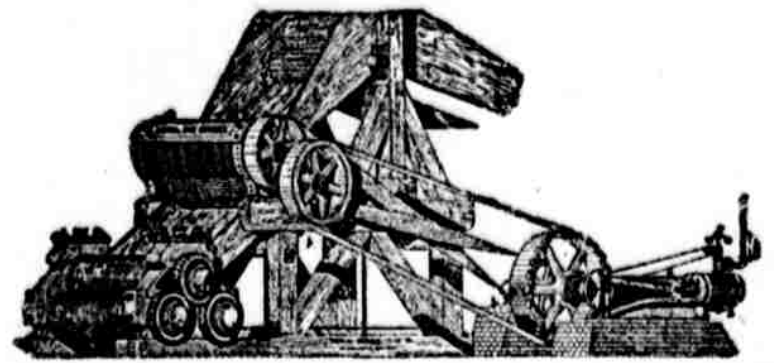

### Often Tired But Never Weary.

Let's discuss this point for two minutes. Here's a man who says that at a certain period he began to feel "tired and weary." That's precisely the way he puts it in his letter. Now anybody has a right to feel tired or fatigued (it's the same thing), after labor or much exercise. It's the body's fashion of telling you to hold up, to give it a rest. It is a natural and, in health, with supper and sleep just ahead, a pleasant feeling. But weariness—that's different. That comes of monotony, of waiting, of loneliness. Weariness is of the mind, not of the body. But it can arise in the body, all the same. If this bothers you at first, don't say, "Stuff!" "humbug!" but study up on it. A man may be tired and happy, but not weary and happy. For weariness means depressed spirits, and nerves all sagged down in the middle. And when you get both at once you will be wise to find out what's gone wrong.

It is a short letter, this is, and we can just as well quote the whole of it. The writer says: "It was in November, 1887, when I began to feel tired and weary. It seemed as if I had no strength left in me. Before that I had always been strong and healthy. My appetite was poor, and for days together I could not touch any food that was placed before me.
