STRIKE GOES ON; BOTH SIDES FIRM

\$135 CLAIM CAUSE OF TIE UP

Matter of Principle, Say Strikers—Company Losing \$5000 a Day

One hundred and thirty-five dollars is the sum total said to be involved in the back overtime pay demanded by three vessel masters in the Inter-Island Steam Navigation Company, which has resulted in a general strike and walkout of fifty captains and mates, resulting in the complete tie-up of nearly a dozen passenger and freight steamers engaged in a service between Honolulu and scores of island ports on Hawaii, Maui, Kauai and Molokai and a loss to the company of \$5000 a day.

The situation today presents a decidedly firm and uncompromising aspect on both the part of the striking officers and the company directors. Steam is up and crews are mustered on board at least six steamers which have been prepared to go to sea, pending the settlement of the differences. Company's Statement.

Vice President and Acting General Manager James L. McLean issued a statement today which says:

"The controversy between the Inter-Island Steam Navigation Company and the masters and mates is not a demand on the part of the masters and mates to be paid overtime when working on Sundays and holidays, for the mates have received overtime for such service for a long time, and the masters of certain of the steamers not running on schedule time have been receiving pay for overtime; and recently the company acceded to the request that all captains should receive such compensation.

Waiting for Kennedy.
"There are, however, three or four masters who claim overtime due them for service in certain months during the first half of the year. The amount involved is not large, but as the claim was first made when J. A. Kennedy, the manager of the company, was here, the company deferred action as to the payment of same until Mr. Kennedy's return, which will be in a few weeks. At no time did the company refuse to recognize the claim, but felt it was due Mr. Kennedy that the matter be referred to him.

"Honolulu Harbor No. 54, which is the title of the organization of the

BOAT CAPSIZED FREIGHT LOST

Rough seas at Lahaina resulted in the capsizing of one fully-loaded ship's boat and the swamping of two similar craft belonging to the Inter-Island steamer Claudine, last night.

The Claudine called at the Maui port to land and take on cargo. One of the big whiteboats became unmanageable while negotiating the heavy swell prevailing there at the time and, being swamped, the craft turned turtle and the entire contents, including sugar and several items of household goods, was precipitated into the sea and was lost. The boat was recovered after considerable effort. Two whiteboats returning to shore were flooded, but it is claimed that there was no freight aboard.

A large shipment of hardwood railway ties from Hawaii arrived today as part of the cargo of the Inter-Island steamer Claudine. This vessel returned from Hawaii and Maui ports with a large list of passengers. Seven hundred railway ties, 24 cords slabs, 10 cords wood, a quantity of empties and 41 cords of honey arrived.

Purser Kibling reports fine weather on the homeward trip. The schooner Melrose and the Matson Navigation steamer Enterprise were discharging cargo at Hilo at the time of departure of the Claudine for Honolulu.

CITY ADVISED TO YIELD IN PAVING FIGHT

Supervisors Get Statement from Legal Counsellor in Controversy

MILVERTON SAYS MUST CONCEDE TO EXPEDITE If Pavement Is to Be Laid, He Thinks Rapid Transit Must Have Its Way

The Board of Supervisors is officially advised by Deputy City and County Attorney Fred W. Milverton to yield to the Rapid Transit company in the paving controversy.

In a lengthy statement submitted to the board last night, Deputy Milverton, who has been the legal adviser of the supervisors throughout the long discussion and on whose advice the supervisors have hitherto stood pat, now maintains that if a speedy settlement is arrived at, it must be by a concession on the part of the city fathers.

Deputy Milverton's opinion, as he frankly intimates, is not based on strict interpretation of the law. In fact, he reiterates that the law is on the side of the supervisors, but sees no speedy way to make the Rapid Transit lay the paving as the supervisors insist it should be laid.

In his statement, Milverton goes into the difference of opinion that caused the fight. He tells of the efforts made by the supervisors to force the Rapid Transit company to lay bitulthic in conformity with the rest of the street, and then of the other proposition by which the company was asked to pave with bitulthic between its double tracks and which it refused to accept.

After reciting the history of the controversy, the submission of an agreed statement of facts to the Supreme Court, Deputy Milverton says:

Notwithstanding the clear statutory and charter obligations resting upon the Honolulu Rapid Transit & Land Company, which obligations were assumed by it as a condition precedent to the granting of its charter and franchise, and notwithstanding the construction placed on the provisions of the charter by the unanimous opinion of the Supreme Court of the Territory, the Honolulu Rapid Transit & Land Company has utterly failed and neglected to make the improvement in question. It takes the position unqualifiedly that it will not comply with its charter in that respect, and attempts to throw upon

Roar Of Big Motors To Jar Diamond Head

Target Practice at Fort Ruger Will Begin on Monday. Records Expected

Next Monday morning old Diamond Head will shake to the roar of the Fort Ruger mortars, and the windows of Waikiki will rattle in unison, as the bulldozers of modern ordnance bark for the target practice of 1912. Monday and Wednesday of next week are the days specified for the record shooting, and for months the Coast Artillerymen have been working toward the perfection of mechanism and personnel necessary to hurl the projectiles through miles of air, to land with deadly accuracy on the deck of an imaginary battleship far out at sea.

Fort Ruger has been about the busiest spot on Oahu for the past few weeks, and as the day for target practice approaches, the men who will serve the mortars, and the officers who will direct the fire, have been putting in some strenuous work. By Monday everything will be in readiness and the two companies under Major Timberlake's command will make a gallant try for ten hits out of ten record shots. A perfect score, which includes firing each shot exactly on time, is not to be expected, although it has been done in other target practices, but may be duplicated here. If, however, the projectiles fall eight out of ten times within the 50-yard radius of the small target that counts as a hit, the Rugerites will have good cause to be proud of themselves.

Difficulties Extreme.
In mortar firing, owing to the fact that the target is never visible to the men who are actually laying the pieces, the greatest precision of projectile and powder is required. The shots fly miles skyward, and describing a great arc, are expected to fall on the deck of a rapidly moving vessel, a small mark under the best of conditions.

From the position finding station, carved out of the solid rock of Diamond Head's crown, officers, with the most delicate instruments for range finding and observation, "track" the course of the target, estimate where it will be after the minute that it will take the projectile to reach it, and then by telephone notify the gunners hidden in the pits at the base of the mountain far below them, what angle of degree of traverse is necessary. In an instant the mortar is laid and fired, and with a roar that seems to rock the solid concrete walls and buildings of the battery itself, the projectile goes shrieking upwards. That hits are ever recorded at all is

the marvel to the layman. It seems impossible that the speed of the moving target, the exact quantity of the powder charge, the weight of the projectile, the wind variation and the distance can be so nicely calculated. One minute or so before the shot falls, but the modern mortars do make hits, and if the emergency arose, it is probable that those of Battery Harlow, would give a very good account of themselves in keeping a hostile fleet at a respectful distance.

ROOSEVELT NAMED BY PROGRESSIVES

Bull Moose Leader's Platform Read—Many And Varied Issues Advocated—Johnson to be Nominated by Southerner

CHICAGO, Ill., Aug. 7.—William A. Prendergast, comptroller of the city of New York, nominated Colonel Theodore Roosevelt today amid scenes of great enthusiasm in the Coliseum.
Colonel Roosevelt's nomination was seconded by Henry J. Allen of Kansas, General Horace C. King of New York, Governor Johnson of California, P. V. Collins of Minnesota, J. M. Parker and Judge S. B. Lindsey of Denver, Louis F. C. Garvin, Jane Addams, the noted woman reformer and head of Hull House, Chicago; General John H. McDowell, Tennessee; Alexander H. Milton of Georgia, Colonel T. P. Lloyd, Georgia.
It has been announced that Governor Johnson will be nominated for the vice presidency by John M. Parker of New Orleans.
The platform was read today, and was received with loud applause. It advocates nation-wide preferential primaries, the short ballot, the initiative, referendum and recall, an easier method of amending the constitution of the United States, woman's suffrage, publicity of campaign contributions and limitation of such contributions. It speaks of the "deliberate betrayal of the people's trust by the Republican party" as fatal to that party's success, and the "incapacity of the Democratic official representatives." By naming a Progressive, it is contended, a national menace will be eliminated.

Wilson Is Notified

SEAGIRT, N. J., Aug. 7.—Ollie James, Congressman from Kentucky, today officially notified Governor Wilson of his nomination. The ceremony was simple. Wilson, in his reply, said that he was not speaking to catch votes, but to satisfy thoroughly the conscience of the people at a crisis in the political development of the nation.

ACCUSED OF MURDERING BABE, MOTHER ATTENDS ITS FUNERAL

Chun Wong Chee, the mother of Kwal Sin, her infant daughter whom she is accused of having murdered, was present at the funeral of the dead child. With her was a police officer and Chun Kim Sut, the father of the baby. Chun Kim Sut is charged with murder in the second degree and is out on bonds of \$15,000, but the mother is held without bail on a first degree murder charge.

NO CRISIS NEAR ON PANAMA CANAL BILL

London Times Says Discussion Between London and Washington on the Panama Canal Will Be Amicable

LONDON, Eng., July 25.—Considerable interest is taken here in the news from Washington that negotiations are passing between the British and American Governments regarding the Panama Canal bill. The Times says: "We do not believe that anything that may arise from the discussion on the other side cannot be settled by friendly conference. The British government is well advised to ask consideration of its views at once. Not Great Britain alone, but the whole empire, is concerned. Canada is concerned in a special degree."
The amicable settlement in recent times of all outstanding questions between the empire and the republic is a convincing sign that this new problem will be solved in the same way. If diplomacy should find it too complex we can always take it, like the ancient controversy over the Atlantic fisheries, to the arbitration tribunal at The Hague. Failing other methods, such a solution would be a fitting testimony to the sincerity to a hundred years of peace."

MASS MEETING TO GET REPORT ON POLITICS

A mass meeting of businessmen called for next Friday afternoon at 2 o'clock at the Young Hotel roofgarden, will hear the report of the business men's committee which has been canvassing the political situation and which will bring forward the names of a number of candidates.
The special committee of five which has been at work for some weeks, held a meeting this morning. It has not yet received an answer to the series of questions it propounded to Delegate Kuhio in an endeavor to find out exactly his position. The committee has not yet made an endorsement for the head of the ticket—for the delegateship. The committee will hold another meeting tomorrow morning and prepare its report for submission to the business men Friday afternoon. An intimation comes that there will be no answer from Kuhio by tomorrow, and just what the action of the committee will be in that case is problematical.

MAN HELD IN JAIL AND CHIEF M'DUFFIE DOESN'T KNOW WHY

Who, what and why is Julius Lancerman, and wherefore is he in jail?

This is the question that is bothering Chief of Detectives McDuffie and his squad of detectives, one of whom arrested Lancerman yesterday morning and has since forgotten what he was arrested for.

"I don't know anything about the case," declared the Bertillon expert this morning. "All I know is that he was arrested by one of my men yesterday morning and that the case is marked for investigation."

"But I don't know anything about the man, who arrested him, or what

for, but we have him locked up, anyway."
Meanwhile Julius is waiting to be brought to trial—whether for drunkenness or murder the chief doesn't know.

OLD OFFENDER ARRESTED FOR SPEEDING AUTO

For the second time within a few weeks, Jonab Cummings was arrested for exceeding the speed limit and was brought before Judge Monsarrat this morning to answer to the charge. According to Motorcycle Officer Abreau, Cummings was arrested at eleven o'clock last night while speeding along King street at a rate of thirty-two miles an hour.

With him in the machine was a crowd of sailors and as the machine rocked from side to side, the men in the car kept yelling to the chauffeur to turn on more juice. Abreau caught sight of the machine at Piikoi street and followed it to Richards street before he was able to catch the party.

Several weeks ago Cummings was arrested on a similar charge and fined fifty dollars and costs and Motorcycle Officer Abreau declares that he has warned the chauffeur seven times against speeding.
Cummings case was continued until Tuesday morning, August 13, at the request of Attorney Rawlins, who is representing the defendant.

HARMONY CONFAB DOESN'T DO IT

Democrats Shake Hands All Around, but Ant-Jarrett Resolution Bobs Up

There was a "harmony meeting" of the Democrats yesterday at noon in the offices of Mayor Fern.

It was an attempt to patch up a truce between L. L. McCandless, the boss of the party, and Sheriff Jarrett and eputy Rose. According to reports, McCandless shook hands all around and Jarrett shook hands all around, likewise Rose, and all agreed to eliminate "Soap-Box" Barron and their own political differences.

On top of this, McCandless appeared at a meeting of the Democratic club of the tenth precinct, Fourth district, with Barron.
The meeting passed, according to the Star-Bulletin's information, a resolution directed against Jarrett and Rose. McCandless' and Barron's presence gave rise to the rumor that they are partly responsible for this resolution, but this was denied today by a Democrat who is no friend of McCandless, but who says that Link is really trying to pull in with Jarrett now that election's coming on.

Anyway, both Jarrett's and Link's friends are sore.

The Hourbon territorial central committee will hold a meeting tonight at the McCandless building quarters, Pauahi street, to discuss a general ratification meeting. The Democratic leaders today declared that Barron, the alleged disturbing element in the party, will be emphatically suppressed, and one went so far as to say that he will be ejected from the room. Barron says he has a good right to go, and that he will go. And the Jarrett-McCandless fight isn't patched up yet among the followers of the sheriff and the boss.

WOMAN HUSHES CRYING BABY, AND WINS SEAT IN STREET CAR

The street car was crowded. As it started up Liliha street, every seat was taken and the aisle was full. An elderly gentleman with a baby in his arms occupied one of the seats, and beside him stood a young woman. Presently the baby began to cry, and the gentleman in his efforts to quiet it only served to increase the volume of sound.

Suddenly he turned to the woman, who was evidently a perfect stranger to him. "Madam," he said, "if you can hush this child, you are perfectly welcome to my seat."

So the man stood up and the woman sat down and took the baby, which immediately ceased crying. And Conductor 31 says that the baby winked its right eye.

N. Y. LIFE SUES TO RECOVER TAX

Suit for \$2807.32, the amount of tax paid to the Territory on business done in the islands during the year 1911, has been filed in Circuit Court against Henry Hapal, deputy insurance commissioner, by the New York Life Insurance Company.


It is a dispute arising between the deputy commissioner and the insurance company over the question of amount of return premium with which the former shall be credited. Hapal, after long and careful figuring, decided that the sum which the New York Life claims to have returned to its policyholders in the Territory in 1911 was \$43,483.85 more than the amount actually received by the said policyholders, and declined to deduct that amount from the company's gross receipts, on which the 2 per cent. taxation is based.

The 2 per cent. tax on the return premium amounted to \$869.67. This is part of the company's total tax of \$2807.32, and as a result of the difference of opinion the New York Life paid up under protest.
Now, because of what it asserts is an error on the deputy insurance commissioner's part, the plaintiff demands the return of the entire tax paid into the Territorial treasury. The complaint, filed this morning by Attorney

ENLISTED MEN MUST WAIT A LITTLE LONGER FOR THEIR PAY.

The enlisted men of the army may have to whistle for their July pay for a week or so longer, after all. There is money on hand to pay them, but to hand out the July pay, with the June still owing, would cause endless complications, and snarl official red tape in a dangerous manner.
Captain Cooke, army paymaster here, has received a cable from the paymaster of the Western Division stating that the urgent deficiency bill for June will probably be passed by Congress by August 15, and advising him to suspend all payments until the final sum is available.
The officers have already received their pay in full to July 31, but Captain Cooke will await further instructions before paying the men.

BARK NUUANU MAY BE WITHDRAWN FROM ATLANTIC SUGAR TRADE

The trim and staunch bark Nuuanu, now lying at Richard street wharf after a passage covering 348 days from New York, is believed to have completed the last passage between the East Coast of the United States and the Hawaiian Islands, according to statements made in this city today. Negotiations are now under way between the owners of the vessel and a Pacific Coast shipping firm for the sale of the bark.

It is stated on good authority that the deal has not progressed that the bark is as good as eliminated from the so-called fleet of sugar and cargo carrying windjammers which have heretofore plied between New York and Honolulu.

As it is now stated, the Nuuanu is to enter the Pacific Coast and Island trade, carrying cargoes of general merchandise from San Francisco destined to the island ports of Hana, Mahukona or Honolulu. The vessel would be supplied with sugar on her return voyages to the coast.

The contention is raised in that the Nuuanu has lost her charter to transport sugar to Delaware Breakwater, the vessel will probably be sold, to enter trade in the western ocean.

Cabin Passengers Kind Room in Makara.

There is room for all applicants for first-class transportation from Honolulu to Vancouver and Victoria in the Canadian-Australian liner Makara, according to advices from T. H. Davies & Co., the local representatives for that vessel. The steamer sailed from Sydney by the way of Suva on time and is due to arrive here next Tuesday morning. A cable received this morning states that there is plenty of first-class passenger accommodation. The demand for second-class passage will necessarily crowd that section of the steamer to some extent.

Band Played Lullaby Away.

The Territorial band was present at the departure of the Matson Navigation steamer Lurline for San Francisco at 6 o'clock last evening, and a series of melodies was enjoyed by a goodly crowd of people.

The Lurline sailed with a full cargo, made up of sugar, 20,000 cases of pineapples, a quantity of coffee, honey and bunches of bananas. Fifty-two cabin and 17 steerage passengers left for San Francisco in this vessel. The Lurline was given a considerable quantity of mail destined for the mainland.

Wilhelmina Will Carry Hilo Mail.

Unless there is a decided change in the complexion of the present strike in the Inter-Island the Matson Navigation liner Wilhelmina, to sail for Hilo at 5 o'clock Thursday evening, will be given a large accumulation of mail destined for the big island. The Wilhelmina is to be discharged of some 1800 tons' freight brought down from the mainland. She is scheduled to return to this port Sunday morning.

New Weir Lined on the Coast.

A new Weir liner under charter to the East Asiatic Company of Copenhagen, the British steamer Gifford, Captain McIlwaine, has arrived at Vancouver. She left Antwerp on March 31 and called at Coronel, Valparaiso, Autogasta, San Francisco and the Sound, and inaugurated a new service from the Continent to the Sound.

Kauai Sugar Report.

The following sugar is awaiting shipment on Kauai according to a report received here this morning with the arrival of the Inter-Island steamer W. G. Hall: Mak, 22,189; G. & R. 2800; McB, 11,768; K. P. 9518; L. P. 10,229; G. F. 1246.

Steamed Through Seas Filled With Crabs.

According to wireless advices received from the oil tanker Asuncion, the vessel passed through an unusual experience five miles south of Point Reyes. The sea was covered with thousands of dead crabs, says the captain in his radiogram. He did not try to explain the reason for the condition, but it is believed that the crustaceans fell victims to some disease. The Asuncion, which is bound from Vancouver for Redondo, passed the Golden Gate yesterday noon.

Japanese Flagship sunk; May be Raised.

TOKIO, July 19.—The cruiser Nan-lawa, the flagship of Admiral Togo in the Chinese-Japanese war of 1904 which was wrecked on the Kurile Islands in the North Pacific, the latter part of June, has sunk. All the crew were saved when the vessel ran on the rocks.

Cement Steamer Goes Into Service.

VANCOUVER, B. C., July 22.—Recently purchased at Poole, England by the Vancouver Portland Cement Company to carry cement from the company's factory at Tod Inlet to this city, the steamer Leona, one of the latest additions to B. C. shipping,

is a steel screw three-masted freighter of 631 ns gross register and 242 tons net. Until recently in the English coast-wise trade, Leona had a fine run out from Humber. The passage occupied 77 days with only one call, that at Coronel on June 11 for coal. The Leona was brought out by Captain Cochrane, her skipper, formerly in command of the Marmon, and Chief Engineer Boomer.

masters and mates, was not willing to wait for Mr. Kennedy's return, and under the decision of the harbor all of the masters and mates of the steamers in port tendered their resignations, and there being no other men available who are qualified to take their places, the steamers are temporarily tied up.

The striking vessel masters and mates participated in a series of conferences at Odd Fellows' Hall this morning. At the close of a gathering held at the time of the schedule set for the departure of the liner Mauna Kea, the skippers declared themselves as determined to stand by their guns in the matter of carrying forward the strike to the bitter end.

"It is a matter of principle with us, not so much the sum of money involved in the controversy that we have had with the management of the Inter-Island," insisted one local navigator who had been present.

It is generally admitted that the claims for back pay come from but three or four men in the Inter-Island service. The rank and file of captains and mates are said to have no real or fancied grievance with the company, as it is stated that the matter of overtime payments to skippers and officers for a number of months past has been adjusted.

Several skippers and their mates joined the strikers at an early hour this morning with the arrival of the steamer Claudine from Hawaii by the way of Maui ports, and the Kauai packet W. G. Hall with general cargo and passengers from the Garden Isle.

These men joined forces with the strikers, and were participants at the several gatherings being conducted at Odd Fellows hall under the auspices of Harbor No. 54, to which all strikers belong. Company May Seek Assisatance. It is understood that the directorate of the Inter-Island has already taken steps to secure such available men to man their vessels as might be found at the port. While the Inter-Island officials remain non-committal regarding the matter of securing substitute captains or mates, it is stated today that several officers belonging to deep-sea craft now at the port have been approached with a view to securing their services as masters or mates on the idle coasting steamers.

One phase of the question, however, is the fact that most of the mariners here or belonging to visiting ships also are members of one or the other Pacific Coast "harbors" and therefore linked with their striking brethren through bonds of a secret and protective organization which has a branch at practically every port of importance on both coasts of the United States. The claim is made more or less freely that the Inter-Island would be unable to secure assistance from the

The Board of Supervisors of the City and County the blame for the unsatisfactory condition existing in the vicinity of the Fish Market on King Street, between Ryer Street and Nuuanu Street.

The opinion of the Supreme Court referred to above is not a judgment. After the rendition of that opinion, the Honolulu Rapid Transit & Land Company attempted to have a judgment entered in the submission so that it might take an appeal to the Supreme Court of the United States. Had this judgment been entered and an appeal taken it would have resulted, in my opinion, in a delay of several years before an adjudication could be had by the highest court in the land upon the rights and liabilities of the parties. When the attempt was made by the Company, however, to have a judgment entered, the Supreme Court of the Territory said:

"We think the submission was entered into by the parties without any thought as to the entry of a judgment in the case. It seems as though counsel had in mind only the obtaining of the views of the court on the questions stated in the submission."

Prompt Action Necessary. The community is confronted at this time not with a theory, but with an actual state of affairs that calls for prompt action, if possible. There are two or three remedies open to the Government, but only one of these in my opinion would be speedy and effective. Section 870 of the Revised Laws of Hawaii provides as follows:

"Whenever the said association and others or any corporation which may have been duly organized under the laws of this Territory for the purpose of constructing, operating and maintaining the lines of railway mentioned in this chapter, and as by this chapter provided (which would refer to the Honolulu Rapid Transit and Land Com-

pany), refuse to do or fails to do or perform or carry out or comply with any act, matter or thing requisite, or required to be done under the provisions of this chapter and shall continue so to refuse or fail to do or perform or carry out or comply therewith, after due notice by the superintendent of public works to comply therewith, the superintendent of public works shall with the consent of the governor cause proceedings to be instituted before the proper tribunal to have the franchise granted by this chapter and all rights and privileges granted hereunder, forfeited and declared null and void."

I believe the institution of the proceedings referred to in the section just quoted would result in a speedy adjustment of the matter. Those proceedings, however, can only be instituted by the Superintendent of Public Works by consent of the Governor of the Territory, but inasmuch as a considerable time has elapsed since the Supreme Court of the Territory has expressed its views on the matter and no action has been taken along the lines authorized by Section 870 of the Revised Laws of Hawaii, I do not believe the City and County of Honolulu can rely upon that remedy.

Another remedy open is for the City and County to do the work at its own expense if it has any funds available for the purpose, and collect the amount expended from the Honolulu Rapid Transit & Land Company. This, however, would involve the institution of another lawsuit which could be carried by the Honolulu Rapid Transit & Land Company to the Supreme Court of the United States and would involve probably a delay of several years before the City and County would be reimbursed for the expenditure.

As to Mandamus. Another remedy, although some doubt has been expressed as to whether it is available, would be by means of the extra-ordinary writ known as mandamus, which would result in a judgment, according to the opinion of our Supreme Court, compelling the Company to do the work. From this judgment, however, the company would have a right of appeal to the Supreme Court of the United States, and the work would be tied up, in my opinion for several years.

Coast within two or three weeks, owing to the scarcity of men suitable for the work. Places Difficult to Fill. The strikers, while maintaining a firm stand in the matter also, feel confident that to fill their places in the Inter-Island steamers will be a decidedly difficult matter. It is pointed out that, in the first place, men will be required to possess first-class masters' and mates' licenses. To place steamers representing several hundreds of thousands of dollars in the hands of men who are totally unfamiliar with the coasts of the several islands, it is predicted, would be a suicidal policy and one that more than one director in the steamship company would consider very carefully before authorizing the substitution.

Many of the masters of the affected vessels are of long service in Hawaiian waters. They are familiar with all twists and turns in gaining and leaving the reef-barred harbors at the sugar ports. Day or night, these men are as much at home in the several ports and inlets as they would be in their own habitation.

The Inter-Island company stands to lose a snug sum daily with the continuation of the strike. It can safely be put down that the loss to the company for each vessel that is idle will easily total three hundred dollars for each day.

In the case of the Mauna Kea, Kilanea, Kinou or Claudine, the sum of three hundred dollars would hardly cover the cost of a twenty-four hour charter, especially during a busy sugar season, a condition that now exists.

The engine and fireroom staffs must be retained at an instant call to duty. To this must be added the cost of keeping the stewards and deck staffs on call and the pay roll.

The amount involved in the loss on freights, passenger fares and mail subsidies mounts up to a figure that is believed vast in its proportions. As to Mandamus. INSURANCE ON VALUABLE CITY PROPERTY IS ALLOWED TO LAPSE

Insurance policies representing thousands of dollars held on a number of automobiles, the property of the city and county of Honolulu, and used by heads of various departments, have expired and a scramble for the business now follows.

It was Supervisor Amama who appeared most vitally interested in the question of deferring the award of the insurance business until a later meeting of the city fathers, despite the warning sounded by Supervisor Low that valuable city property now remained practically unprotected by insurance.

Amama is connected with a local firm that handles insurance business. Low made the charge that while he was absent from the city, Murray Amama and Kruger got together and turned over the insurance on several motor fire engines, to the agency with which Amama is connected in a business way.

"We should play fair in this matter," suggested Low. "Heretofore the insurance on city and county property such as automobiles has been pooled between the dozen or more local agencies."

Special representative Humphreys of the Von Hamm agency was present at a meeting of the board held last night and spoke in behalf of the insurance placed by his firm.

After much wrangling, the whole matter was left to the discretion of the ways and means committee. The city autos, valued at ten thousand dollars or more, may be reinsured following an authorization to be forthcoming at a future gathering of the city dads.

The road committee has recommended the following appropriations: Repairing Makiki ditch \$1500, gutters for Prospect street \$300, Kamehameha school drain piping \$2500.

H. K. DeFries has been awarded the contract to replank Queen street bridge, his figure of \$38.50 per thousand feet being the lowest tender received.

Treasurer Shingle reported for the month of June: Total receipts, \$155,361.93; disbursements, \$45,867.11; cash balance, July 1, 106,494.82. Garbage Department Losses Much Money.

There is a large sum of city and county money lost each month in the present management of the garbage department. A deficit of nearly five hundred dollars for the month of June is shown in the report presented by Chairman Kruger of the Health and Sanitation Committee. According to the reports the department received \$1347.43 for the month and expended \$1,824.81, leaving a deficit of \$487.38. It is said that the addition of a number of employees has something to do with the department falling behind during the past few months.

W. C. Parke was granted permission to drive an auto over the Tantalus road to convey his sister to the Queen's Hospital.

Engineer Whitehouse estimated the cost for several street areas adjoining Queen and King street, Ewa of Nuuanu, as follows: Bitulithic surface, Queen street bridge, \$3200; Queen street extension to Iwilei road \$6273; road to Hackfield wharf \$6456.60; Mauna Kea street, King to Queen street, \$4345; River street, King to Queen, \$2524.50—total, \$22,799.30.

More Honors Heaped Upon Fern. Mayor Fern is again in the limelight for additional honors. Not content with having at least a half dozen city and county thoroughfares bearing his name, he has succeeded in persuading the territorial public works department to rename a small fifteen foot lane, the highway to henceforth be known as "Fern Walk."

While it has been said that Fern never walks as long as the municipal gasoline holds out to burn, the residents along the Kalihii highway are now wondering whether the government powers that be have slipped them a little jokelet.

Speaking about autos, the police machines traveled 1443 and 924 miles respectively during the month of July. No reports have been received from machines driven by Mayor Fern, Engineer Whitehouse, Plumbing Inspector Michlstein, as prescribed by law.

The League of American Municipalities has invited the Honolulu board to be represented at the session in Buffalo September 18, 19 and 20.

Deputy City Attorney Milverton, in an opinion to the board stated that the county had the right to unlock the gates closed by the Kaneohe ranch obstructing a thoroughfare which has been used for many years by the public.

Steam Rollers Cause Supervisors to Squirm.

The subject of "steam rollers" was briefly brought up last night and there was a perceptible squirming in seats indulged in by certain minority members on the board who so far have failed to hand a contract for a new steam roller to a favored importing firm in this city.

Road Supervisor Caldwell, who urged the purchase of a new road roller through Master Mechanic Cushingham presented a statement which placed the cost of repairing all road rollers in the county service at \$5500.

A mainland firm has come forward with an offer to supply what is claimed to be a sanitary drinking fountain for the city schools. The matter has been taken under advisement.

Engineer Whitehouse assured the board that there was no objection to a change in the location of the roadway in the vicinity of Waianae plantation, believed necessary because of the addition to the Waianae forest reserve.

Taxpayers Clamor for Better Roads.

The Kaimuki district is declared as ignored by the present board in the matter of decent roads. A long petition came before the members last night with signatures from property owners residing on 5th, 6th, 7th, 8th, 9th, 10th and 11th Avenues. Also Koko Head Avenue and Waialae road. They ask that something be done as the district is growing to an extent that demands recognition.

Supervisor Amama introduced a resolution calling for \$1500 to repair Maunakea street from King to Bereania.

YOUNG WOMAN JUMPS FROM EIFFEL TOWER

PARIS, July 30.—An elegantly dressed young woman jumped from the topmost platform of the Eiffel tower today. Her body struck the iron work as it fell, and was almost torn in half. The limbs were severed before the body fell to the second platform, 525 feet below, where it was smashed beyond recognition. Four hundred francs was found in the pocket of the woman and also the address of a hotel, where she was not known. The attendants said the woman was weeping before she jumped. She scribbled something in a notebook, but afterward tore this up. The body has not been identified.

WAILUKU, Aug. 6.—The Maui Republican forces have been quietly organizing during the last two weeks.

The Eleventh Precinct Club held its regular meeting at the Makawao Court House on Friday evening, July 19th, and elected the following officers: F. W. Hardy, president; P. F. Peck, vice president; S. R. Dowdle, secretary; A. D. Morton, assistant secretary; M. Almeda, treasurer; A. R. Souza, G. M. Maalo, and Jos. Pires, judges of election; W. O. Aiken, A. F. Tavares, J. A. Aheong, L. von Tempky and Alfred Furtado, executive committee.

At this same meeting, a strong resolution was adopted against the proposed change of the Makawao Court House to the site of the Pala Hotel. The main reason for the objection to the change was the distance of the new site from the Kula region. The general opinion was expressed that the location of the present court house was admirable for the people of the Makawao and Kula regions generally, and that if the court house

were further away, the extra distance to be traveled would be a hardship upon all the people of that region.

PLAN FOR CITY PAPER LAUNCHED

First Reading of Ordinance That Adds More Salary Expense to the City

Forecasting an attempt to get the next Legislature to legalize an official organ for the city and county, the supervisors last night passed at first reading an ordinance authorizing the appointment of a special clerk as secretary to the board.

The special clerk is to get up a "municipal record" which, under present plans, is to be a mimeographed sheet and of which some thirty or more copies will be made for distribution. The clerk is to get up a report of the activities of the board which will be ready for presentation when the Legislature meets.

Members of the board say that if the plan works out successfully, it is probable that the next Legislature will be asked to designate the paper as the official city paper and that the plan is then to have this carry the city's legal advertising. The salary of the clerk has not been fixed, but \$100 a month has been tentatively agreed upon and George F. Henshall, it is said on the "inside," is to be named as clerk.

"We feel that we are justified in going to this expense," said Supervisor Murray this morning. "It is a question of getting up this report now in proper form, at an expense of about \$600, or of letting it go until the last minute and then having a hastily-drawn report. There are many things that happen that are not of general interest enough to be published in the newspapers, but that should be set down briefly.

"As the report is to cover the whole year, the salary of the clerk will amount to \$50 a month. The stenciling of the mimeograph copies will be \$1 a page."

IRON WORKS ONLY BIDDER FOR PUMPING BOILER

The Honolulu Iron Works was the only firm to offer a tender for the proposed new boiler for the Bereania street pumping station and for connecting the present boilers to all four wells. The bid, opened by Superintendent Campbell, of the board of public works, at noon today, is \$8810 for the new 250 horsepower boiler, and \$2250 for furnishing the material and making the connections between the present boiler and the wells.

The superintendent explains that at present each boiler is connected to only two wells, that the artesian level is gradually growing less in the two old wells, and that it is found necessary to have the boilers connected now with all four, so that as much of

MOUNTAIN KING IS IN BAD WAY

Reported Twelve-Foot Vein Struck but No Money to Work It

The Mountain-King mining enterprise is doomed to go to smash, as far as the local interests in it are concerned, unless the Honolulu stockholders come up quickly with their dues on assessments and call. There is \$1200 due here on assessments and \$6000 is delinquent on a call of the nature of a loan made some time ago.

A. Gartenberg brings the latest news of the mine, from a visit he paid to the company's office in San Francisco. Half an hour before he called a telephone message was received from the superintendent, which reported that the last blast had opened up a vein, between a "foot" and a "hanging" wall, twelve feet wide and full of color. The stenographer assured Mr. Gartenberg that the message was genuine. She had such faith in Mr. Hall, who with Mr. Miller has been advancing money to the works, that, although her salary was two months in arrears, she frequently dug into her own pocket for coin to pay small expenses. One instance was her paying 75 cents for a blueprint of the works to give to Mr. Gartenberg for the enlightenment of the Honolulu shareholders. It shows tracings of the tunnel and drift and the place where the vein above mentioned was struck—at least, Mr. Ogilvie, the mining engineer on the spot, says that the opening shows a general indication of a vein between the "foot" and the "hanging" walls.

"If the Honolulu stockholders do not make good and help things along," Mr. Gartenberg said this morning, "Hall and Miller will advance money out of their own pockets and the property will eventually be shut down and sold for the debt, when only those who have in the meantime contributed to the call will have a lien on the property.

"The draft for the June payroll has been issued, but there are no funds to meet it. Lately a cable call was made for a loan of \$3000 from the Honolulu people, but if the dues on the assessment and former call were paid the company would not need this money."

the public certainly should know just what are the grievances that have tied up the great sea-transportation company and threaten the most serious inconvenience to passengers, mails and freight-handling.

It is a grave matter for captains to leave their posts, and the Star-Bulletin is loth to believe that they are doing it for the few dollars involved. There is on both sides a firmness that could be dictated by nothing else than belief in a righteous cause.

But the general public knows only that an item of less than \$200 seems to stand in the way of settlement. As usual, it is the public that is suffering most, and it is not getting the frank statement of facts to which it is entitled when a public service corporation fails, even if for no fault of its own, to carry out its implied contract with the people.

DR. ROOSEVELT

Roosevelt's confession of faith" delivered yesterday in Chicago, reads much more like the label on the outside of a bottle of patent medicine.

The doughty colonel is claiming a sovereign remedy for every evil that hurts the body politic, from political headache to political gout, and he has prescribed his patent medicine as a cure-all. Twenty thousand words of his prescription were handed Chicagoans yesterday.

No such hodge-podge of issues has been submitted to a convention for many campaigns past, if at all. His adherence to the doctrine of recall of judicial decisions was expected, but this is only a small part of the heterogeneous medicated compound that he mixed and labeled "My Policies". Old-age insurance, pure-food legislation, woman's suffrage, government assistance to wage-workers, a national industrial commission, minimum wage law,—he pounded his pills and compounded his nostrums with as much bold claims to their efficacy as any peripatetic quack extolling his wares from a wagon-tail.

This paper has already given Mr. Roosevelt credit for the service he did his country in arousing the ordinary citizen to a personal interest in the affairs of government and in raising the hue and cry against corrupt wealth, but it has no admiration whatever for opportunism, and certainly his declaration of faith has all the earmarks of a bid for votes by an opportunist. Roosevelt is too recent a convert to woman's suffrage to gain many friends on this plank; his recall of judicial decisions is almost as radical as a recall of constitutional provision; and his proposals for old-age insurance and a minimum wage law are not measures of his own creation. He may have taken up the exceedingly important question of the tariff, but if so, the cabled advices here gave no mention of the fact, and certainly he could not have emphasized it or made this an effective part of the 20,000-word declaration.

Even should the colonel slide into the White House during this troublous campaign, he would not carry out half of his platform promises, and that is some reassurance. His bark is eminently worse than his bite. So long as George W. Perkins, Billy Flinn and others who do the handiwork of great wealth are members of Roosevelt's political cabinet, he will follow that famous supreme court policy of applying the test of "reasonableness".

We all like the colonel because he makes our politics interesting; he is a shrewd campaigner, ambitious, ambidextrous and omnivorous, and he is cutting some figure in spite of the evident distrust of his judgment and his subordination of means to ends.

Local Progressives are rejoicing that Hawaii is represented with a vote at the Bull Moose convention. They are deserving of credit for their pioneer work in this respect, and it is entirely probable that A. L. C. Atkinson's trip to Chicago is responsible for the arrangement in which Alaska and the District of Columbia share the benefits.

While the political party leaders are wrestling over slogans that will catch the votes of the people, some people might adopt the following, which will catch the eye of the politician: "Tempora mutantur et nos mutamur in gillis", which, being interpreted, means "The people are now on the job and won't stand for shady political methods."

weights are then marked plainly on the projectiles, which are carefully placed in position for quick handling. The rotating band which circles the base of the projectile is callipered to one-thousandth of an inch, and what is known as the bourrelet, the swell immediately behind the head, which grips the rifling, is carefully scraped and cleaned.

Powder Tricky. The "blending" of the powder is one of the most delicate and interesting operations, for no matter how carefully this is done originally, some of the powder dries out faster than other portions, under apparently the same conditions, and there are other variations in the same lot of ammunition. To make it as uniform as possible then, the powder is piled in a great heap, and ten men with wooden shovels divide it into ten equal piles. These ten piles are then re-mixed the operation of separation and mixture being known as a "cycle". Several cycles are required to assure the proper blend.

The charges are then weighed down to fractions of an ounce, sewed in bags, and tried out in the mortars, to be sure that they will go in smoothly when required. There have been instances when an entire target practice has been thrown out because it has been thrown out because it the powder bags did not fit.

The target itself is a small pyramid one, to be towed 400 yards behind the navy tug Navajo, which has been loaned by Admiral Cowles for the purpose. Any splash coming within a 50-yard radius of the target is considered a hit, the fall of the projectile being taken by the splash.

Practice Now. For some time past the tug James Makee has been towing targets across the zones of mortar fire to give the men in the station practice at tracking its course. Such calibre practice has been finished, and the gunners are now worked up to a state of keen anticipation for the supreme test of the year.

Monday the firing will be in the innermost zone, from 3,500 yards to 4,500 range. Wednesday the target will be towed at from 7,500 to 8,500 yards. On each day's practice there will be four trial shots, and ten record shots fired. The record shots are fired at one-minute intervals, from alternate pits, every mortar being fired once except the No. 1 mortar of each pit, which will be fired twice. The first shot is the only one on which time can be saved, it being allowable to fire as soon as possible after the umpire gives the command to commence firing, but after the first shot the others must be at regular intervals of one minute.

Lieutenant Colonel Campbell, adjutant general, is to be the umpire, and as such is responsible for the safety of the firing. Major Timberlake, commanding the coast artillery district, has his command in a high state of efficiency, and good results are expected.

Last year there was some trouble with the target, which became entangled in the towing apparatus, and the record practice was up to the best standards. Everyone at Fort Ruger is anxious to make the coming shooting as nearly perfect as possible.

CORNER IN SILVER MADE IN BOMBAY

BOMBAY, India, June 25.—Some interesting information has been furnished to the Times of India by Chunalal Surya, the leading spirit in the Bombay silver group, with regard to the corner in silver made by the latter.

The group, it appears, was formed a year and a half ago, some 20 persons being concerned in it, and investments were made to the extent of 30,000,000 reis, 20,000,000 reis more being afterwards available. Twenty million reis' of stock were disposed of gradually, and the remainder was sold quite recently, the profit on the whole transaction, after paying interest, being no less than 2,500,000 reis.

The stock disposed of is now distributed among about 100 stockholders, and according to Chunalal Surya, all the loans in Bombay on silver have now been paid off, the effect being that the shares of the Indian Specie Bank have risen from 52 to 66.



ENGLISH RIDERS LIVE TO RIPE OLD AGES


Trainer Jack Joyner Tells of Osborne, 80 Years Old, Still Being Able to Ride



BRAND NEW GAMES FROM PHILIPPINES

Over in the Philippines they are springing some new ones in the indoor line, which, from the descriptions in the Manila papers, seem to provide a novel variety of sport. White-bowling, basketball and indoor baseball will likely hold the attention of Honoluluans who like to put in their evenings on the gym floor, and who frequent the games hall of the Y. M. C. A. whenever there's anything on the cards, there is a good chance to put over something original by following the tips that come from over the Pacific.

These games have been suggested by the fact that they form a great part of the athletic programmes in the Philippines, to which possession the members here will be indebted, and that aside from their athletic value they present a novel side that is bound to appeal to the youths of this section.

The games suggested are termed rooster fight, day and night, wand wrestling, pig-a-back relay, crab relay, Indian wrestling and obstacle relay. In rooster fight a ring is drawn about twelve feet in diameter. Each contestant takes his turn in putting forth a contestant for a man from the other side to meet. The two fighters stand on one foot on opposite sides of the ring and at the command "Go!" hop into each other with folded arms. The contestant who is first forced entirely out of the ring or who touches his other foot to the ground or who unfolds his arms loses. This is kept up until one side is defeated.

In day and night two parallel lines are drawn across the field with a space of ten feet between them, which is neutral ground. The players line up on each side of this neutral territory. A block of wood having six or more sides, an even number being necessary, is used, which is painted with half its sides white and half black. The referee rolls the object down the center of the neutral territory. When it finally comes to a rest, the white side is up the team known as the white team must turn and run for the goal fifty feet away at the end of the ground, the other team giving chase. Anyone captured (tagged on the back) is considered out of the game and his team must continue with those not captured. The team first reduced to three men or less loses.

The contestants in wand wrestling are put forth by their respective captains as in the rooster fight and Indian wrestling. They sit on the ground facing each other with the soles of their feet against each other. The wand or stick is grasped by each man with both hands. At the word "Go!" each man leans backward and pulls as hard as possible, the loser being the first man who is pulled to his feet.

For Indian wrestling the men chosen by their respective captains lie on their backs, right side to right side, with adjacent arms locked and with the right hand on the shoulders of the opponent. At the count "One," the adjacent legs are brought up in an upright position; at "Two" the same and at "Three" the legs are interlocked. The contestant who is forced to roll over from his position loses.

Pig-a-back relay consists of lining up the opposing teams in relay position, with the exception of one man on each team, who stands at the opposite goal. At the word "Go!" this man runs to the starting line and gets man No. 2 on his back and carries him to the opposite goal. As he reaches the goal No. 2 dismounts, returns to the starting point and gets No. 3 on his back, whom he carries to the goal exactly as he himself was carried. This continues until the last man has been carried to the goal. He then dismounts and runs back to the starting point.

In crab relay the opposing teams line up in relay position. Opposite each team at a distance of thirty feet there is drawn a circle three feet in diameter. Each contestant must run backward on feet and hands (all fours) to the circle. As soon as one foot falls inside the circle the runner stands erect and returns to the starting point, where he touches the second man, who starts off backward on all fours as did the first. Each man of each team follows in his turn.

The variations of the obstacle relay are limitless, depending entirely upon the ingenuity of the teacher. A simple obstacle relay is here given. As in other relay events the teams line up in relay position. The first man on his way to the opposite goal is required to turn a backward somersault and on his way back to climb over some simple barrier erected in the center of the ground. Each player in his turn performs the same stunt, and, as in other relays, the team whose last man crosses the starting point first wins.

CHINESE PLAYERS ROASTED IN CANADA

Play Game on Sunday and Bring Down the Wrath of Montreal's Chinese Colony—Public Reprimand

The All-Chinese ball team is getting Honolulu "in bad" with the good people of Canada, and advertising Hawaii as a land of howling savages and ungodly heathens. Even their own countrymen in Montreal have turned from the Chinese half-tossers in holy horror, and have seen fit to roast them through the papers.

It seems that the Chinese scheduled a game with Montreal for a Sunday afternoon and, what's more, played it. Not content with this defiance of Canadian convention, they actually came into the city on the Sabbath, and then, to cap the climax, left the same day.

Now, over across the line our Canadian cousins have pretty strict ideas about Sunday observance. Even in British Columbia, which is considered by Eastern Canadians as a land of far too much liberty, you can't buy a stick of candy on Sunday unless you go into a private room, sit down at a table and then peek up and down the street to see that no Bobby is around, and the wonder is that in conservative Montreal the unregenerate Honoluluians kept out of jail.

Following is the account of the incident as printed in the Montreal Witness:

The visit of the Hawaii University baseball team and its game with a local team yesterday did not meet with the approval of the Chinese Christians of Montreal. They would gladly have joined in the welcome to the team had the game been on any other day.

The protest reads as follows: We, as members of the Chinese Christian Association, would hereby express our deep regret at the desecration of the Sabbath by the Hawaii University baseball team coming into the city on the Sabbath, and playing with the Montreal club the same afternoon to the dishonor of God and the discredit of the new Republic of China. JIM CORBETT'S TEACHER DEAD

Walter Watson, widely known as an instructor in boxing, died recently in New York. Watson's most noted achievement was the discovery and development of James J. Corbett while Watson was connected with the Olympic A. C. of San Francisco. Corbett received his first lesson in boxing from Watson and after being under his charge for a year became fit to cope successfully with the leading heavyweights of the time.

Watson came to America from London twenty-six years ago, and after losing a bout with Mike Donovan, the winner of which was to be appointed physical instructor of the New York A. C., went to San Francisco and took charge of the Olympic A. C. Corbett, who was but a youngster at the time, so impressed Watson with his glove work, that the instructor informed him he could make him a success in the ring. Corbett placed himself under Watson and soon became recognized as the most scientific boxer of all time.

PRESIDENT TO BE CANAL BOSS

[Associated Press Cable] WASHINGTON, D. C., Aug. 6.—According to a resolution passed by the United States Senate this afternoon, the President will be given absolute control of the Panama Canal Zone. He will have under that resolution full appointive power. The naming of the governor of the zone as well as of all the executive officers will be in his hands should the resolution be finally passed.

BECKER'S RAKE-OFF SAID TO BE \$15,000 MONTHLY

NEW YORK, N. Y., Aug. 6.—Fresh developments in the investigation following the murder of Herman Rosenthal, the gambler, came today when one of the witnesses testified that Lieutenant Becker's graft amounted to fifteen thousand dollars a month. This sum was obtained by the police official from about a dozen houses. The witnesses stated that Becker, so far from being satisfied, was continually demanding more money from the gambling joints he was supposed to protect.

ANOTHER HALT ON BATTLESHIP BUILDING

WASHINGTON, D. C., Aug. 7.—Another attempt on the part of the Democrats in the House to reach agreement on the battleship program failed today. A caucus of the Democrats called by the House leaders resulted in "no quorum." The Congressmen opposed to appropriating any funds for the construction of a battleship absented themselves from the caucus.

SAN FRANCISCO, Cal., Aug. 6.—It was learned here tonight that Lloyd Osbourne, the story teller and novelist, who rose to rapid fame some years ago, is dying at his home in this city. Osbourne is the stepson of Robert Louis Stevenson and a man of letters of no mean ability himself.

TOPEKA, Kan., Aug. 6.—The Roosevelt Progressives swept the State at the primaries today. They nominated eight electors.

WIRELESS STRIDES HERE GIVEN WIDE PUBLICITY ON MAINLAND

Recent wireless improvements here, including the establishment of the Poulsen system, are given much space in the San Francisco papers. The exchange of messages with San Francisco is heralded as a great event. After telling of the opening of the line for news service, the Call of July 29 says:

Actual communication by the Federal Telegraph Company's system was established early last week, when complimentary messages between the company's new Hawaiian station and the brand new station at San Bruno point, South San Francisco, showed that the line was clear. It only remained for the line—or is it a line?—to be opened for commercial service, and yesterday morning was chosen for this auspicious event.

The world's news follows the line of least resistance—the shortest, quickest and easiest line. Wherefore Honolulu residents have ceased to read "Special by cable" in their papers. Instead it will be "By Wireless from San Francisco." The gap is bridged and the Hawaiian city is moved up next door to the world.

The distance traversed is the greatest ever which a regular service has ever been accomplished. From time to time, under favorable conditions, wireless stations in San Francisco have "picked up" the government stations in Key West, or off the coast of Maine, and sometimes in Japan, but there has never been any possibility

of sending commercial messages. The Marconi wireless across the Atlantic is about 1800 miles, but the cable there is still the chief means of communication.

During the sending and receiving of congratulatory messages Friday and Saturday between the officers of the company in this city, including Beach Thompson, president; E. W. Hopkins, vice-president, and H. P. Veeder, secretary and treasurer, and the chief engineer, C. F. Elwell, who is in Honolulu, W. G. Irwin, the Honolulu and San Francisco sugar magnate, sent his friend, E. W. Hopkins, the following:

Honolulu, T. H., July 26.
E. W. Hopkins, San Francisco—Visited your new wireless station yesterday and congratulate you on what you have accomplished and its successful issue. It is wonderful. Hope that your health continues good, and your bridge is improving. Mrs. joins me in kind regards. We return in about 10 days. W. G. IRWIN.

All of the members of the company are delighted with the opening of the Honolulu service. Besides the officers named above the board of directors comprises: John F. Deahl, J. Henry Meyer, Charles D. Marx, Carl Philip, George A. Pope and S. E. Slade.

A. Y. Tuel, the chief operator of the company, operated the sender during the transmission of the press dispatches. He experienced not the slightest difficulty.

MANUFACTURE OF SYNTHETIC RUBBER

In a lecture before the Society of Chemical Industry in London, Prof. W. H. Perkin of Manchester University described a process for the production of rubber in the laboratory which has been widely commented upon in technical and other papers in the United Kingdom.

It was stated by the lecturer that the synthetic production of rubber offers the probability of a profit at a price of 60 cents per pound, with a possibility of its production at 24 cents per pound or less. There has been keen rivalry between England and Germany in the effort to make synthetic rubber, and priority of discovery is claimed by each country. It was contended by Prof. Perkin that the English had anticipated the Germans by about three months.

In describing the new process the lecturer stated that starch is converted into either of two substances, acetone or fusel oil, by fermentation. These substances are then by chemical means, converted into isoprene, the raw product from which the artificial rubber is produced.

In commenting upon the new process a correspondent of the Manchester Guardian gives it as his opinion that while a very cheap and rapid method has been discovered of making synthetic rubber of good quality, comparable in every respect to the natural product, and while it has answered every laboratory test satisfactorily, it has not so far been produced in sufficient

quantities to enable practical tests to be made.

In the judgment of the London Times Dr. Matthews has made a distinct advance in showing that from isoprene and sodium alone there can be made a substance resembling rubber resulting from nature's subtle forest alchemy, and his standing as a chemist is far too high to permit of any doubt being cast upon his interpretation of his immediate results.

The London Financial Times views with some skepticism Prof. Perkin's discovery, in view of previous attempts to produce synthetic rubber. It states that any calculation of the cost of a given product by means of laboratory experiments is necessarily conjectural. In this case it is more than usually so. Prof. Perkin admitted that the whole question was in an experimental stage.

KULA PIPE LINE SAVES IN TIME OF BROUGHT

(Special Star-Bulletin Correspondence)

WAILUKU, Aug. 6.—The whole Makawao and Kula region is the driest in twenty-three years. The Kula pipe line is of great service in filling the cisterns in Makawao once or twice a week. The other days the water is turned into Kula. The pipe line has been extended to Makena, so the people there can now have the benefit of a good water supply. The source of water supply for the whole region has been the greatest blessing imaginable to a large portion of the upper Maui lands.

Many people predict that the permanent water supply will make Kula the most popular summer resort of all the mountain districts in the Territory. The air is delightfully cool and the views of Haleakala and West Maui among the finest bits of scenery in the world.

BRUSH FIRE ENDANGERS COLLEGE HILLS HOUSES

Fire in a brush pile on College Hills yesterday afternoon was prevented from working havoc among the residences of the district by Miss Rose Davison, the humane officer, who telephoned the fire stations and personally directed the activities of forty laborers who had been working upon roads and buildings in the neighborhood.

The fire originated in a pile of brush opposite the residence of J. H. Young and spread out rapidly through the fields and dry grass and timber. Miss Davison, who was driving home, saw the start of the blaze, and after summoning the laborers from their work she telephoned the fire department, which immediately responded. The fire was extinguished with little damage.

It was the residence of James McAndrews that was scorched, not Dr. McAndrews', as stated in the morning paper.

JAPAN'S AIR MAIL ROUTE DIRECTED BY AN AMERICAN

SAN DIEGO, Cal., July 25.—Aerial postal line between San Diego and Los Angeles will be established in six months if the plans of W. B. Atwater, the Curtis aviator, are carried out. Mr. Atwater is at Tokio directing the operation of an aerial postal line between Tokio and Yokohama for the Japanese government.

He writes to James H. Holmes he is coming here soon to carry on negotiations with the government and make preliminary test flights between San Diego and Los Angeles.

The letter containing this information was carried from Tokio to Yokohama by the Japanese aerial route and bears the winged aerial postmark recently adopted by the Japanese government.






MISS BLASCOER PLANS TO SOLVE LABOR PROBLEM

Sociologist Would Educate the Children on Plantations to Do Farm Work

Miss Francis Blascoer, who was brought here two months ago at the request of the trustees of the Kaulani Home and since has instituted the social survey, will leave for Waialua and Waipahu next week where she intends to make a study of living and working conditions.

Miss Blascoer is personally overseeing that part of the survey which relates to the women and girls of this city and intends to make a thorough investigation of the plantation living and working conditions so as to gain a thorough insight as to the mode of living of the laborers.

While discussing her trip, Miss Blascoer mentioned the rapidly growing generation of children of the laborers and said that the only solution of the problem of what to do with these children, was to introduce a system of intensive cultivation on the plantations and to teach these children the essentials of truck and market gardening.

Miss Blascoer advocates the setting aside of small portions of land on the plantations to be turned over to the new generation which would supply the manual plantation labor. The laborers would have their own little plots of ground to cultivate and would thus be accomplishing two objects: supplying labor for the plantations at the same time becoming small farmers themselves and eventually useful members of the community.

This is the only solution to the problem, according to Miss Blascoer and must be applied sooner or later. The hundreds and thousands of children growing up among us must be found work and this is where it must be given to them, she declares.

"I would advocate the turning over of empty lots in the city to the school children where they could learn truck and market gardening. Then when they grow old enough, they will understand farming and will be able to both solve the labor problem and at the same time have homes of their own."

"Instead of spending thousands of dollars, importing laborers here, the home product will have to be utilized and if the planters do not do this eventually they will be milling the goose that lays the golden egg."

Miss Blascoer commented upon the fact that the planters at Wailuku were using this method and that she intended to submit her plan to the planters on Oahu.

NEW CHAIR INDUSTRY STARTS IN HAWAII

The Outrigger club has given the initial impetus to a new industry in Hawaii. Needing chairs for its beach and spacious lanais, the club got up a design of a folding steamer chair and sent the model to the Hawaiian development lumber mills at Pahoa. Yesterday two crates of the new chairs made of native ohia arrived. These are the first steamer chairs ever made of ohia, but already the industry is started, for the Inter-Island officials seeing the new designs have ordered two dozen Outrigger ohia chairs for the steamer Mauna Kea.

One of the new chairs was placed in the window of the Public Service yesterday and attracted much attention, many stopping to register orders for duplicates for use in their lanais and on their lawns. The new chairs of native wood are probably the strongest chairs of their kind ever put together—they are intended to be "kid" proof on the Outrigger grounds.

In the first place the ohia is so hard that holes have to be drilled in which to drive the tacks that hold the four-ply canvas in place; not only that but the Hawaiian hardwood is bolted together with steel bars. It was the desire of the Outrigger people to patronize a home industry and demonstrate that outdoor furniture can be made at home, better, stronger and more cheaply than it is abroad, and they believe that the new steamer chair will prove this.

The trustees of the B. P. Bishop estate have offered the county a right of way to the Kawailoale lots, on windward Oahu, forty feet wide and eight hundred feet long, on condition that the right of way so granted be made a permanent and definite highway connecting Kawailoale and Kaelepu with the junction of the Honolulu and Mokapu roads makai of the bridge. The offer stands open for thirty days.
