WALTER HILL DEAD.

A Former Proprietor of the Bulletin.

END OF A BUSY CAREER.

The advices per the Monowai last night brought the news of the death of Walter Hill at Adelaide, Australia, April 22 last.

Mr. Hill was born at Cherry Grove, his father's estate, near Mount Lofty, South Australia. After receiving a sound education under private tutorship he was engaged in farming and pastoral pursuits, and at an early age entered the ministry of the Wesleyan Methodists, traveling in the Goolwa, North Adelaide, and Gumeracha Circuits. Later he resigned his position in that connection, journeyed through the colonies, and finally settled in New Zealand. There the Methodists, unwilling to lose a preacher so talented and popular as he proved to be, appointed him without his consent to take the charge of a Circuit, but he declined to accept the honor, and took instead an appointment upon the staff of the Thames Guardian. When the great rush to the west coast goldfields began he went to Ross, established the Ross Grammar School, which he superintended for several years, and at the same time studied chemistry and surgery under the learned Dr. Zurborst. After graduating with honors at the Otago University he entered the medical college in connection with the University of San Francisco, and gained distinction, acting between terms as special reporter for the Alta Californian. He went to the Hawaiian Islands as correspondent of a coast paper and furnished graphic reports of affairs there, and was so enamoured of the fertility and beauty of the Hawaiian group that he remained there, entered the service of the Government, and became Superintendent of the Reformatory School. During his long tenure of office at that institution he established the Daily Bulletin. After eight years' engagement he left the service of the State, and devoted his time to the editorial work of his paper. Twice was he selected by the Hawaiian Government as plenipotentiary to China, to deal with important matters concerning the Celestials. As a writer he was terse and incisive, and lived to see many of the reforms that he advocated carried into effect. He frequently referred with pride to the laws and institutions of his native home, and especially to its main roads. Eventually his newspaper and printing plant were purchased for party purposes, and he again entered the Government service under the administration of Queen Liliuokalani, and held the responsible position of Postmaster-General of the Kingdom. When the Queen was de throne he resigned his office and declined an appointment under the Provisional Government. Prior

to his entering the Postoffice Bureau defalcations had taken place which were discovered under his administration. In connection with the office was a Postal Savings Bank. During a financial depression he undertook to raise loans for the Government and was successful, but the strain upon him was so great that his general health suffered. He tried a change to country scenery, but did not improve. A few months ago he as a last resource visited his native home, but his vitality was too much impaired, and he passed quietly away at the age of fifty-two. He never practised medicine for gain, but his advice was never sought in vain. In his adopted home his good name was in the mouth of every one as synonymous with all that is kindly, disinterested, pure, manly, and noble. He leaves behind a widow and one daughter, and his parents, brothers (3), and sisters (5), all survive him. His remains were interred at Cherry Grove, S. Australia, April 24.—Exchange.

DECORATION DAY.

How It Was Observed in the City of Honolulu.

Seldom, if ever, has such an assemblage gathered together in Honolulu as that of yesterday to witness the ceremonies incidental to Decoration Day. Long before the procession started the streets were lined by crowds of people of all sizes, ages and nationalities, who waited patiently to see what proved to be one of the finest military parades witnessed in this city.

At the cemetery from early morn until late in the afternoon friends and relatives of those who are sleeping their last sleep were busy in strewing flowers, wreaths and leis about their graves. To give any extended description of these floral emblems or of any particular grave would take up columns. Suffice it to say that they far exceeded anything of the kind ever seen here.

A little before 3 o'clock the First Regiment, under command of Colonel McLean left the barracks and marched to the boat landing for the purpose of escorting the Philadelphia's battalion to the grand army headquarters on King street.

At 3:30 the procession started on its march to the cemetery. The following were in line:

- Four Sailors Carrying Platform with Beautiful Floral Design. Philadelphia Band.

On arriving at the cemetery the troops were grouped about the Grand Army lot, where a stand had been erected for the speakers and seats provided for distinguished visitors. Members of the G. A. R. post were seated about the enclosure.

The exercises were opened by the reading of "The Duty of the Day" by Post Commander Wright. After a selection by the band, Chaplain L. L. La Pierre read the prayer, followed by "To-day is the Festival of Our Dead" by the Post Commander. Members of the Post then laid flowers upon the graves of their comrades. After reading by the Chaplain of "Comrade by This Service" and a selection by the band, Comander Wright introduced Hon. L. A. Thurston, who delivered the address of the day.

Mr. Thurston's remarks were eloquent, thoughtful and impressive and delivered in his usual style. They were appropriate to the occasion and had the merit of not being too extended.

Following Mr. Thurston's address Adjutant W. L. Eaton read the following roll-call of the dead:

This was followed by the "Salute to the Dead" by the marines of the Philadelphia. The exercises closed with the singing of "America" and the benediction by Rev. D. P. Birnie, after which the buglers of the Philadelphia sounded "taps."

Only four American flags were displayed along the Nuuanu street route. The largest and best at the residence of P. C. Jones.

The veterans did not connect with the 600 bottles of soda water provided by P. C. Jones for their comfort.

L. Adler was the oldest (76) and C. B. Edwards (48) the youngest of the "vets."

The "bloody Ninth," Col. Cass's well-known Boston regiment, was represented by Captain T. K. McDonnell.

Frank May, a member of the local Fire Department, was one of Gen. Grant's orderlies. He was at the side of Gen. Sedgewick at the battle of Spottsylvania, when that officer was killed.

The Rev. Birnie was blessed by the "vets" and volunteers for his judgment in prayer.

The Reader of the day looked cool and comfortable, but not en regle.

Col. McLean used the column judiciously, several halts en route testifying to his good judgment.

The volley firing by the marine guard of the U. S. S. Philadelphia

was most noticeable for its exactness, the thirty-four guns exploding as one.

There was not an abundance of crepe upon either the flags or arms of the veterans.

The Philadelphia's contribution of flowers was both generous and beautiful.

All of the great battles by land and sea of the American Rebellion, had participants in the line of the "vets."

His Trials and Tribulations While in the Navy.

Mr. Dunn's troubles date from the time when the ship was at Mare Island navy yard last, during which time he had the misfortune to fall overboard. A life buoy was thrown to him almost instantly and so well was it thrown that it struck the man on the forehead, cutting quite a gash thereon. The wound was plastered up, after being probed, and everything was supposed to be all right with the man.

Since arriving in Honolulu Dunn has developed strange symptoms, bordering on insanity, so much so that it has been deemed necessary to place him under guard night and day. It is supposed that in the Mare Island accident a piece of the frontal bone was fractured and that it is now pressing on the man's brain, causing temporary insanity at periodical intervals.

The Chinese Bureau.

The new regulations requiring the registration of Chinese contract laborers having come into force, J. W. Girvin, who is in charge of the Chinese Bureau of the Foreign Office has been more than busy the past few days. So far he has issued 1345 labor contract certificates, of which 135 were issued on Wednesday. Sixteen return permits have been issued to Chinese who intend to take passage on the City of Peking, due here on Saturday.

The R. M. S. S. Monowai, 2136 tons, Capt. M. Carey, after an absence of seventh months, arrived in port at 9 o'clock last night. She left Sydney on the 13th inst. at 5 p. m. and arrived Auckland on the 17th at 10 p. m. While we think of it, is Mr. Thurston drawing a salary as Minister to Washington or attorney in the "Prince Cupid" case, or both?

Mr. Thurston's address Thursday night was simply a rehash of what the people have been told many times over during the past two years, but which is still lacking in essential points. The public would like to have heard what Mr. Thurston has done for annexation during the spare time he has had to give his official duties at Washington. The public would also like to be informed, authoritatively, whether the United States has signified a willingness to annex the islands and give us the same advantages of labor that we enjoy to-day.

The prosperity of the islands depends upon our ability to maintain the only industry that exists here. Comparison with the conditions in the South after the abolition of slavery is farcical for the reason that sugar was not the only products there. There was cotton and rice and other resources since developed. In Alabama, for instance, there is one of the most extensive iron mills in the United States. Let Mr. Thurston, when he is making comparisons, tell his hearers of the condition of the people of the Carolinas and of Georgia for fifteen or twenty years after the war. How rapidly did the city of Charleston advance, and what of Savannah, and Wilmington, of Columbia and Atlanta? Their present healthful condition is not due to the production of rice or of either of the other staples in which slave labor was engaged; the States of the far south had resources that had never been developed for various reasons, the principal one of which was the fact that the others served the purposes of the owners and they were willing to let well enough alone. It was only when reverses were met and years of suffering followed, that their eyes were opened and northern capital and northern energy and brains were induced to come there, and by their thrift and enterprise put the south on an almost equal financial footing with the north. We believe it is best for everyone that the development of other resources here should begin now and put us in a position to meet the set-back which annexation would unquestionably thrust upon us, rather than suffer the pangs and inconveniences of bankruptcy for a dozen years because our leading industry had been killed by the laws of the government to which we had allied ourselves.

PRINCE CUPID'S CASE.

Before the Supreme Court at This Morning's Session.

The honorable Supreme Court of the Republic of Hawaii met at 10 o'clock this morning to hear and determine the question whether "Prince Cupid" is legally confined in Oahu jail or not, or, in other words, whether the late Military Commission was a legally constituted body.

The Government was represented by Minister Thurston and General Hartwell, while attorney Stanley "watched the case," as they say in the old country. The interests of the defendant were looked after by Paul Neumann.

After the usual preliminaries Chief Justice Judd suggested that the salient point in the petition and answer to be read, which was done.

Mr. Neumann opened his argument by stating that he proposed to make his remarks as short as possible, reserving his time for the closing. The main points on which Mr. Neumann relied were certain provisions in the constitution regarding the powers and duties of the president and commander-in-chief in declaring martial law, and others which declare that no proclamation of the president or of martial law can nullify or override the rights of trial by jury, habeas corpus, etc., granted by the constitution. Mr. Neumann further argued that the military power is at all times subservient to the constitution, that the right of trial by jury was inviolate except in time of actual war, that the proclamation of President Dole binds the authorities to a strict construction of its terms; that the offense of misprision of treason was not an infraction of the laws of war and therefore not triable before a military tribunal. He claimed that the Military Commission had no jurisdiction over the prisoner or the crime whether the courts were open or not, and, as the courts were open under the terms of President Dole's proclamation, the case should have been tried before a jury in the regular way. Mr. Neumann wound up his argument by claiming that even if the Military Commission was a legally constituted body, it had no right to go back and try alleged offenses which were committed prior to the outbreak of hostilities.

Mr. Neumann's remarks occupied about half an hour in their delivery. He was followed by General Hartwell for the Government. Mr. Hartwell, in his opening, told the court what he knew about the rights of man as guaranteed by the Constitution and then gave his views on the crime of misprision of treason, during which he said he had a great deal more respect for a man who would come out in the open and fight than for one who would stay at home and secretly plot against his neighbor. The learned counsel then gave the court a history of martial law and habeas corpus since the days of Magna Charta from which he argued that in case of necessity military rule and law superseded everything and that its power was simply absolute, as was that of any court created under it.

At a quarter to twelve Mr. Hartwell asked the court to be allowed to conclude his remarks after his associate, Minister Thurston, had argued, which was granted, and the court took a recess to 1:30 p. m.

After recess General Hartwell resumed his argument. He referred particularly to the American civil war and the numerous military trials which ensued therefrom, and cited numerous authorities in support of his proposition that a mili-

tary court is paramount to any other and may be retroactive or otherwise as the commander-in-chief may dictate.

After speaking for ten minutes Mr. Hartwell gave way to his associate, Minister Thurston, who was still speaking when our reporter left. Mr. Thurston's line of argument was devoted more particularly to the Hawaiian constitution and laws bearing on the matter at issue. As far as the argument has proceeded there is little doubt that Minister Thurston has taken advantage of the delay granted by the court to fortify himself with all the legal authorities obtainable here that will help his side of the case.

LOCAL & GENERAL NEWS.

Lau In, a Chinese prisoner at work in the quarries, had his foot injured this morning by a rock falling on him.

Among the distinguished visitors in the Supreme Court to-day were Hon. Audley Cooté and Mr. Hart of Tasmania.

Lieut. J. W. Carlin, formerly executive officer of the old Vandalia, has been made a commander through the death of Admiral Almy.

M. S. Levy will hold another auction at his store on Fort street Saturday evening. The bargains obtained by those who attended last week may be repeated on this occasion.

United Carriage Co.'s stand, besides having superior hacks always ready at the call of "290," furnishes fine livery outfits at the shortest notice—good horses and nice carriages, from buggy to wagonette.

W. R. Castle, W. N. Armstrong, Attorney-General Smith, Minister Hatch, Editor Norrie, Deputy Marshall Brown and a number of other prominent people were interested spectators of the Supreme Court proceedings to-day.

The funeral services over the body of the late Mons. Henri Leon Verleye took place at 3 o'clock this afternoon. Representatives of the government, the diplomatic and consular corps were present. Solemn requiem mass was said by Father Leonor.

The Messageries Maritimes Steamship Co. is looking forward to the establishment of a new branch of their line of steamers. The route proposed is between Portland, Oregon, to China, calling at Yokohama and Kobe, Japan. The steamers are under the French flag.

One of Nieper's express wagons collided with a dray in front of the Beaver saloon to-day, breaking the singletree of the wagon. The driver was pulled off his seat by the horse, which would probably have caused a runaway had not a passer-by taken hold of the bridle and stopped him.

The Time will be issued to-morrow. The proprietor has engaged the services of an artist who will devote his time to illustrating ideas that may be suggested for cartoons. The first of the gentleman's work has some reference to the politics of the country and in which the American League and the Planters are shown.

W. H. Rickard, Tom Walker and E. C. Crick were taken to the British consulate this morning in reference to their claims to British protection. Certain evidence has been discovered tending to show that a certificate of naturalization was issued to W. H. Rickard in 1888 prior to his election to the legislature. If this is the case he can have no claims upon the British Government. Lord Kimberley in giving his opinion of the justice of the claims of the several political prisoners of English nationality was under the impression that certificates had not been issued and consequently the men were still subjects of Great Britain. With this new disclosure the decision of Lord Kimberley will probably be reversed.

It's the fact that the locality produced in a small way and in the most primitive manner an article which caught the fancy of "canoosers" in the matter of coffee; they wanted more and they were willing to pay a good price, but there were no means of getting it. Investigation demonstrated that the land would produce an unlimited quantity, but the people in the vicinity had not given the proper attention to the cultivation, you all know the result, foreign capital came in and is coming every day, and before another decade the production of coffee will be a leading industry of the islands and the machinery used in pulping, cleaning and putting it through the various processes necessary to make it marketable will come through us. And why? Because we are interested in the coffee business; we know what is wanted and we secure the very latest improvements in coffee machinery. What is good enough for one man may not be good enough for another, but our stock of implements for the coffee business is good enough for all. The industry is still in its infancy and the growers do not know themselves just what they require, but if they will communicate with us, we can give them the necessary information.

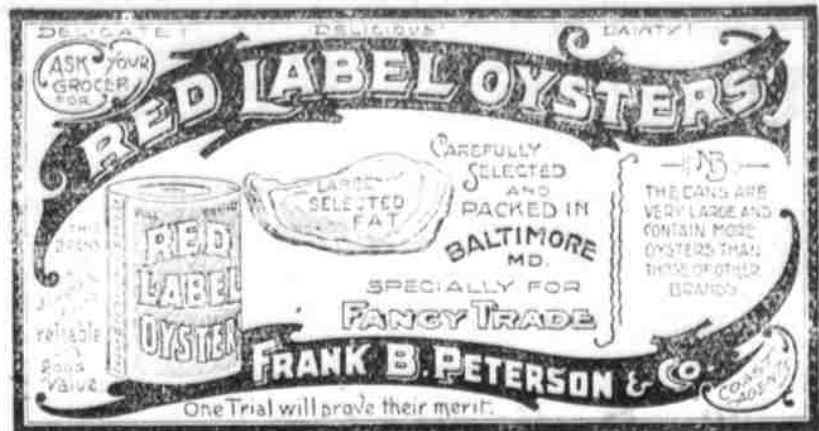
