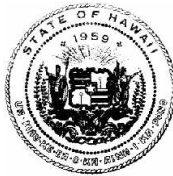

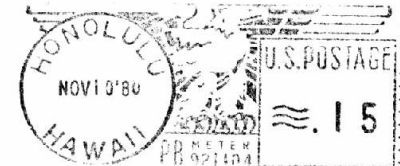

WASHINGTON, D.C. -- The Hawaii Housing Authority today received a \$55,500 grant from the U.S. Department of Housing and Urban Development, to install and test energy-saving devices in public housing projects, announced Senator Daniel K. Inouye.

The demonstration program is aimed at reducing the cost of energy in public housing in Hawaii, through the increased use of solar and other devices, and conservation measures.

Dear Senator Inouye:

The Hawaii Housing Authority has successfully sold \$100,000,000 of mortgage revenue bonds on January 23, 1980 to a syndicate managed by Merrill Lynch White Weld Capital Markets Group. Blyth Eastman Paine Webber Inc. and Salomon Brothers also participated actively in this sale as co-managers. Closing of this bond sale occurred in New York on February 14, 1980. The net interest cost and true interest to the Authority on the bonds are 8.35% and 8.41%, respectively. The interest cost permits us to purchase mortgages from mortgage lenders at an attractive rate of 9-1/2%.

The Authority wishes to extend its appreciation to all who contributed their time and effort to make this landmark bond issue for the State of Hawaii a reality.

Enclosed is a copy of the resolution adopted unanimously by the Commission at their regular meeting on February 15, 1980, and a copy of our Official Statement used to sell our bonds.
