



Judgment against Humphreys was based upon just grounds. Since the decision of the Federal Court in the Davis matter, which threw great discredit upon the findings of the Supreme Court, the opinion that Hum-phreys and Davis were made the tar-parts of factional hate at Honolulu is more general and widespread. Three are very few left who believe the pun-ishment meted out by the Supreme Court was proportioned to anything ex-cept the animosity of the majority of

cept the animosity of the majority of the Court toward the respondents. It is thought that a review of the Hum-phreys case by any impartial tribunal would result in his exoneration and in the restoration of his rights to follow his profession in the Territory of Ha-waii. It is believed that the Supreme Court finitices, either consciously or unconsciously were biased in their rul-ings by the clamor and bate of fac-tions which had waged bitter war in

Honolulu for three years. The decision of Judge Dole in re Davis gives substantial color to these


