Some of the readers may be wondering what is the "Yosebaka". Well, it is the common grave where remains from the graves of 289 immigrants having no known decendants were collectively interred. The Yosebaka with its 12-ton granite monument from Okayama, Japan was dedicated on February 8, 1986, following the conclusion in 1985 of the year-long 100th anniversary of the arrival of the Japanese contract immigrants--the Kanyaku Imin.

This year's annual memorial service was the last one held by the OKICC members. Since the organization was recently disbanded, the responsibilities of maintaining the common grave, Yosebaka, and holding the annual service was transferred to the United Japanese Society.

Another Fox in the news: In the same issue of The Hawaii Herald is an article about the United Japanese Society annual New Year's party held at the Pagoda Hotel on Januyary16. It includes a group picture of the recipients of the Imperial Decoration from the Japanese Government in 1993. These individuals were rewarded for their contributions in promoting and improving relation between the United States and Japan.

The following letter is from Ann Ishida-Ho:

Being a dutiful parent and having to serve time at the Punahou carnival, I had the wonderful opportunity to meet another parent "volunteer" who endearingly spoke of the 100th/442nd.

She told me that she that she and her children watched the 100th/442nd veterans march during the 50th anniversary last year. She tried to explain to her high school son and college daughter, who these men were and what they accomplished for her generation and that of her children. I would like to add that this next generation and generations after will also never care, until it's too late. Let's all take responsibility for passing on the legacy.
