TOPICS OF THE DAY.

The public is to be inflicted with a story about Hawaii and the South Sea Islands, from the pen of Preston Harrison of Chicago, who according to a statement made to an Advertiser reporter narrowly escaped being digested by cannibals. We have no respect for cannibals who allow such a chance to go by.

A new evil is threatened us. The Star says: "Such questions as single tax and proportional representation are going to get into Hawaiian politics, and those who dabble in public issues had best prepare for the worst." This is truly awful. Revolution, cholera, depression in trade, unmanageable land bills, everybody going junketing abroad, and now single tax and proportional representation. How shall we get over it? No wonder the Star warns us to prepare for the worst. And yet the single tax might be better than the present way of double taxation and the proportional representation, might let the majority of the people have some voice in the government of the country. However! Let her go, Gallagher. We will prepare for the worst.

Editorially the Star comments as follows: "Quite marked changes are being made in the United States Army service." It goes on to give a few unimportant changes and finally winds up by saying, "another rule compels the raw recruit to wear clean collars and cuffs, and if he was none the quartermaster is authorized to supply him and charge to his account." Is that "marked change?" Or is the editor sarcastic on his own force which he occasionally adjutants.

Elsewhere we give a short paragraph from the latest Australasian which shows what medical fads are bringing us to. We have here an instance of it in the continued prohibition of taking fish from Honolulu harbor, when it is shown that the dredger brings up neither microbes nor malaria but only sand and sea shells. Caution is good but over-caution is foolish. It is the old story of locking the stable door after the steed is stolen. By the way what has become of that investigation into the introduction of cholera here?

We are told that a man on board the Alameda was tried for talking another passenger to death, and that W. O. Smith acted as judge at the trial and Mikey Davitt as prosecutor. The culprit's name is not mentioned, but grave fears exist that George N. Wilcox at last broke loose and became eloquent. To judge from Mr. Smith's interview with the New Zealand Herald reporter, we feel inclined to believe that he was the guilty party, and was disqualified from sitting as a judge. The New Zealand Herald is talked to death evidently.

One of the best effects Messrs. W. O. Smith's and G. N. Wilcox's visit to New Zealand will have is that we shall hear more about the progress, moral, social, and financial of the Australian colonies, and less about the antiquated blue laws of the east. They have been specially struck with the high calibre, and honor, and honesty of the public men they met, and the trust the people had in them. It is well perhaps to say here that the reason of this that every one, no matter how poor, has a voice in the control of the nation and no trusts, oligarchies, or combinations of wealth, are allowed to control public affairs.

The wonderful way in which some papers express things is frightful to the average reader. Listen to what the Star says on the subject of infraction of revenue laws by illicit distilling from sugar-beets in the United States.

"Deputy marshals have for many years have been staking their lives against the illicit stilling business in the mountains of the south and the infraction of the revenue laws will be followed the same in the sugar beet sections."

Is that all that infraction of the law is to bring? Is that the "relentless" way the U. S. Government pursues offenders? No other penalty but "staking lives" by the law officers?

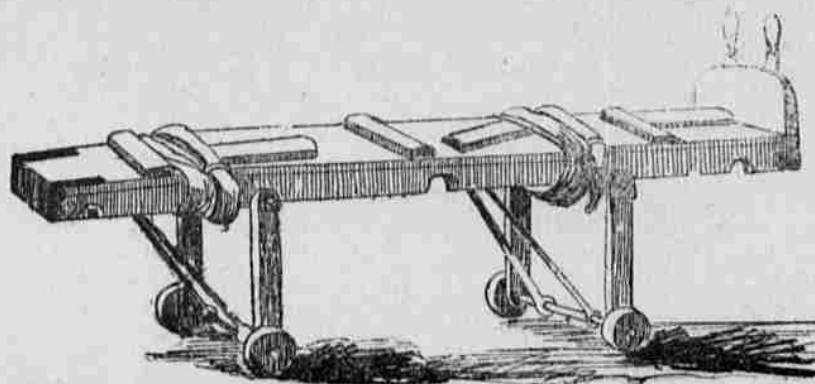

THE SAME FALSE.

We did believe that when Mr. Atkinson assumed the editorial position of the P. C. Advertiser a new policy would be inaugurated and the tempting offers to the so-called small farmer be abandoned. We find that we are wrong. In his very first article, Mr. Atkinson tells the public at least the portion of it which reads the Advertiser that he feels confident that as fine a population as that of New Zealand will in time occupy and build up fortunes in our outlying districts.

This indicates that the official organ intends to follow in the same line of the former advocates of the small farmers. It is time that the curtain is rung down. What earthly benefit can Hawaii gain by continuing an advertisement of lands which eventually must prove of no value and the sale of which to investors must prove false?

Show to us that the small farmer can make a living here. Prove to the satisfaction of the kamaainas that can find prospects which can induce them to come here, in place of total and utter ruin. If so, we shall join the crowd which to our ideas, in a most unscrupulous manner howls for the division of land and the establishment of the small farmer.

It is the same 'ake over and over again. Hawaii does not care for the "small farmer." He cannot make a living here. He will find himself ruined and homeless before many months have passed by. Shame on those who encourage him to come here and risk his dollars and labor. If a fortune or even a comfortable compensation can be made in Hawaii, why didn't the editor of the Advertiser enter the field instead of devoting his time to school jobs and newspaper business? If fortunes can be made by joining the missionaries and shouldering guns why should it ever have been necessary to ask Mr. Atkinson to go into journalism and Mr. Farrington to leave the fertile journalistic soils of Maine, and assume a job under Mr. Paris of the Hawaiian Advertiser.

Let the Advertiser come out frankly and state in explicit terms when, how and, where the small farmer is to find a market and become a success. If the Advertiser cannot do even that much it has simply come the same old failure and is as usual promoting the same old, old, falsehood.

TOPICS OF THE DAY.

The rain is trying the structure of our streets to its utmost capacity. When it is over, there will be thousands of dollars' worth of repair work to be done. Where is the money to come from? Let the army turn out and repair the streets or else take the money spent on them and hire the former laborers to do it.

We fail to see what object the government has in issuing a special license to a Chinese firm for the sale of liquor at retail. No such license has been known in these islands heretofore and we do not hesitate in stating that it is illegal. Wholesale dealers of liquor are allowed to sell by the case only. Jobbers can only sell by the gallon. Retail dealers—that is the saloons—can sell by bottle or glass and liquor can be consumed on the premises. The license now granted to the Chinaman on Nuuanu street is neither fowl or fish. He is allowed to sell liquor in quantity but not allow to serve them on the premises. The saloons in town pay big rents, good salaries to their employees besides heavy fee to the government. The Chinese firm now under the patronage of the government will be able to sell liquor at retail or wholesale prices and seriously injure the interests of the retail dealers. The Chinese liquor firm pays a small rent, demands small profit and pays no wages. Under such circumstances what show has the heavily taxed white saloon-keeper to gain a living? Mr. Thurston at one time was the leading anti-Asiatic in Hawaii. Is it not time for him to come to the front again. The majority of the people irrespective of politics rather prefer Thurston to Chinamen. If the saloon men of Honolulu have got any spunk they may put up enough coin and test the legality of this new and very peculiar license.

BY AUTHORITY.

REGULATIONS OF THE BOARD OF HEALTH.

Relating to Fishing and the Sale of Fish in the City of Honolulu.

SECTION 1—The taking of scale fish, shell fish or any product of the sea or water from any part, inlet or branch of the Honolulu Harbor, or from any stream emptying into said harbor to and within one hundred feet beyond any point affected by the tides towards the land from said harbor and within a line running from the point at Iwilei near the Pork Packing Company's slaughter house to the office of the quarantine station, thence to the can buoy, and from the can buoy to and along the western wall of the coral enclosure for dredgings at Kakaako, is strictly prohibited.

SECTION 2—The sale of fish and of all products of the sea is prohibited in the district of Honolulu, excepting at the new market building and such other places as are specially permitted where fish and the products of the sea may be exposed for sale under supervision of Inspectors appointed by the Board of Health.

SECTION 3—Such Inspectors shall have power to seize, condemn and destroy any fish or product of the sea exposed for sale, or brought to the market which they shall have reason to believe was taken from the locality prohibited by these regulations, or which shall appear to be unfit for food.

SECTION 4—The Regulations of the Board of Health relating to the sale and taking of fish dated November 13, 1895, are hereby rescinded.
