A shocking accident has occurred at Bucharest, the capital of Roumania. A circus which was performing caught fire and a number of men and horses were burnt to death.

A large fire occurred at West Eyreton, Christehurch, N. Z., on Jan. 29th, by which a farmer named Henry Simpson lost his family, consisting of 7 persons, who were burnt to death in the house.

The City of New York arrived com Auckland yesterday. She left Sydney on 26th January, and was detained at sea on Feb. 8th from 2:30 p. m. until 6 p. m. of the following day to effect certain repairs to the engine.

A fire occurred in the oil warehouses of Mr. Perry, at Bristol, Eng., on Nov. 30th. 3000 barrels of petroleum were sacrificed. Ten tons of ledgers and books, belonging to the late West of England Bank, were also destroyed.


