

denied the probability of anything unusual occurring. The BULLETIN frequently felt called upon to contradict these bare faced falsehoods, but their repetition continued all the same. We now have the satisfaction, however, of pointing to the history of the past week or two as a complete refutation of the audacious misrepresentations referred to. Events have unmistakably demonstrated the truthfulness of our position.

THE ENGLISH SYNDICATE LOAN.

In a recent article we intimated that a first duty of Ministers was to straighten out the finances of the Kingdom, more especially in relation to the English Syndicate Loan, which is considerably tangled. Since then we have had an opportunity of examining the English bond, which has been sent out for signature by the Minister of Finance and Registrar of Public Accounts, and we have no hesitation in saying that upon its face it is not in accordance with law, and should not be recognized by the Government. Its heading is enough to condemn it utterly, were there no defects in the body of the bond itself. The heading reads (taking one bond as a sample) :--

*Bond No. 397.....£100 "Hawaiian Six per cent Sterling Loan, 1886, for £200,000, being part of a loan for £400,000, authorized by Act of the Hawaiian

Legislature, dated 1st September, 1886, and amendatory Act, dated October 15, 1886."

No such loan is authorized by the Acts quoted, and therefore the Bond in question is illegal on its face, and consequently worthless. Following the above quotation and the agents' name, Matheson & Co., 3 Lombard street, London, is an extract from the law authorizing the Minister of Finance to issue bonds for \$2,000,000 United States gold coin of the present standard or its equivalent, the instrument proceeds :---

"And whereas there have been issued in representation of \$1,000,-000, part of the above mentioned amount of \$2,000,000, Bonds for £200,000 sterling (being the equivalent of the said amount of \$1,000,-000 in gold coin of the United States of the present standard) of the following amounts and numbers, namely"-

This English loan business is a discreditable mess, and carries no honor to any one concerned in it. The best thing the Government can do is to ascertain precisely what is lawfully due to the Syndicate, appeal to local capital for the amount, issuing six per cent bonds therefor, and withdraw the English portion of the loan altogether. Its manipulation at London, when it comes to be understood in financial circles, is

calculated to cloud Hawaiian credit, and the sooner the country is taken out of a false position, the better.

Foreign News Late

The O. S. S. Alameda arrived this morning bringing dates to the 1st instant. The following is a The Fidelity Bank of California shows an enormous deficit.

Washington, June 28 .- Official advices from Honolulu, just received here, show that the financial condition of the Hawaiian Kingdom is such that there is not the slightest hope of the Government ever again being independent of money lenders. The consequence will be trouble which must come sooner or later, involving the interest of Americans. Englishmen and Germans. It is understood that when that period is reached our Government will insist that only American authority shall be recognized in the Hawaiian Kingdom. In what form this control will be established has not been considered, but no foreign Government will be permitted, under plea

of setting up a protectorate to establish itself in that country. Berlin, June 23 .- King Otto of Bavaria has been officially declared insane.

London, June 23 .- A dispatch from Berlin to the "Standard" says : An effort will probably be made at the next session of the Bavarian Parliament to dethrone King Otto. It is said the Regent will accept the crown if conferred by the people. Dublin, June 28 .- Prince Albert Victor of Wates reviewed the troops in Phonix Park to-day. The reception given the Prince by the populace was a mixed one, combining cheers and hisses.

New York, June 27 .- The "Herald," referring to the order issued to Commander Jackson of the Hawaiian Navy, concerning the use of liquor on shipboard, says King Kalakaua has made bimself solid with the Prohibition vote. All the New York papers are paying much attention to Hawaiian affairs.

CLEVER F. RCERI S.

London, June 6 .- The Paris officials are very much disturbed over the discovery of very large forgeries through which a number of leading banks in Paris and throughout Europe have lost large

sums. These forgeries are very skillfully concocted letters of credit purporting to have been issued by the Anglo-California Bank of San Francisco. These letters of credit are always presented by very gentlemanly-looking men, who have with them letters establishing their

identity. Everything is in such regular form that some of the most prominent banks have been deceived. The largest sum drawn from any one bank was \$100. It is estimated that this gang of swindlers has succeeded in getting upwards of \$100,000 from varions European banks through these fraudulent letters of credit and the guilty parties have thus far escaped arrest.

JACOB SHARP CONVICTED.

New York, June 30 .- The jury in the case of Jacob Sharp, the alleged briber of Aldermen, returned a verdiet of guilty last evening, with a recommendation to the mercy of the Court.

The aged prisoner's head dropped as he was removed to jail. Sentence will be passed July 13th. The penalty is not more than ten years at hard labor, or fine of \$5,000, or both. A new trial will be asked.

A verdict was reached on the first ballot. As Sharp stepped to the welk on his arrival at the jail he said: "Boys, now it's all over, I'll tell you that I never gave one penny to Alderman Fullgraff or any other Alderman, and had no hand in bribing Aldermen." With this the old man seemed to break down.

The result was hardly expected by the people at large. Judge Barrett says this is by far a more im-

portant conviction, as regards the influence on public morality, than even that of Tweed.

The "Sun" says: The verdict has cleared the air; it will be less healthy for boodlers and bribe-givers hereafter. Now for the next.

The "World" says: No false pity must deprive this great public victory of full value. A sentence of ten years' imprisonment should be recorded against the convicted briber. Such punishment will do





THE TRUTH VINDICATED.

The events of the past two weeks have unmistakably demonstrated the untruthfulness of statements positively made, and circulated in print, many times over, both here and abroad, relative to the condition of Hawaiian affairs. Those who were interested in maintaining the old order of things, did their best to make the country and the outside world believe that it was a condition acceptable to a majority of the people, and that the faultfinding and dissatisfaction were confined to a very small faction of restless spirits, denominated "soreheads." These assertions have been repeatedly sent forth to the world with unblushing audacity, by persons who well knew their utter untruthfulness. Their friends abroad have been equally industrious in seconding their endeavors, and we find by our newspaper files which came by the Alameda to-day that while the movement which culminated in a new Constitution was coming to a

nomination of the bonds from 1 to 1928, being £7,900 in £20 bonds, 1436 in £100 bonds, and 97 m £500 bonds, making a total of £200,000 which the bond on its face declares to be the equivalent of \$1,000,000 in gold coin of the United States of the present standard-a clean shave of \$32,000, as previously explained by the BULLETIN. The bond also recites the condi-

tions of the loan as advertised by Matheson & Co., and considerately leaves blanks for the signature of the Minister of Finance and the Registrar of Public Accounts. We say "considerately," because the coupons attached to the bond dispense with the name of the latter officer, and have the name of Paul P. Kanoa printed in them. This is not a signature as contemplated by the law, nor does it comply with its requirements in other respects. The Minister of Finance signs the bond itself, together with the Registrar of Public Accounts, but the Registrar of Public Accounts alone signs the coupons. This is the form of signature on the regularly issued half million six per cent bonds made in

Honolulu. This portion of the loan has been issued in bonds of the denomination of \$5,000, \$1,000, \$500 and \$100. And the form of the bond itself, which is in compliance with the statute, is entirely different from the English syndicate bond. We have thus two sets of bonds for the same loan, which, if adopted, would lead to endless trouble and confusion in the loan account, not to speak of the loss that would be entailed upon the country.

But there is another and a fatal defect in the English bond. It is mutilated. The January coupon has been cut off, the Syndicate evidently having paid themselves interest out of the \$200,000 unaccounted for in their advances to the Government. The Minister of Finance and the Registrar of Public Accounts cannot sign a mutilated bond; but even were this to be decided in the affirmative, there is the further difficulty, that Mr. Kanoa is no longer Minister of Finance, whilst the bond purports to be made and signed by | It has been known for some time |

The Parnellites opposed the motion, which, however, was carried by a vote of 220 to 120. The Speaker then called upon the Parnellites to move the amendments standing opposite their names on the papers. The Parnellites, who were watching the proceedings from the members' side of the gallery made no reply. An amendment introduced by Balfour was agreed to without debate, and the bill was reported. Balfour announced that the third reading of the bill would be moved on Tuesday next.

On division, on the Smith motion, all the Parnellites and Gladstonians, instead of resuming their seats, retired to the side galleries and took no further part in the proceedings. The remaining amendments were

disposed of in eighteen minutes. Ballour's amendment includes one for the omission of the change of venue clause. London, July 1 .- The "Post" says that Gladstone will move the

PANAMA CANAL.

Chicago, June 27 .- W. J. Gillespie, a native of Chicago, who for the last two years has worked in a responsible position on the Panama Canal, arrived here from Panama Saturday. He is in the employ of an American dredging company

which is working on the canal. "There are from 12,000 to 14,000 men altogether at work on the canal at present," said Mr. Gillespie, "but if the canal company does not soon get another loan the work capnot go on much longer. There has been the grossest mismanagement in every direction. The parts of the canal that have been excavated have been allowed to fill up with clay washed down by the river, so that much of the work has to be done twice. Immense quantities of useless machinery, made principally in Belgium, are strewn all along the route, lying idle and rusting. In some places the line of the canal has been changed after being cut, so that a new cutting had to be made to fill in the old one. There is much mismanagement in every direction, and such a general slipshod way of carrying on the busi-ness that if they had all the money they wanted, I don't believe they could have the canal finished for ten

THE GREAT PROBLEM UNSOLVED. New York, June 27 .- The Times,

Canal, says: Those familiar with the official reports concerning the Panama Canal will not be surprised by the announcement that the chief executive officers of the canal company have left the isthmus in a hopeless frame of mind. The end seems to be near. The company's money is almost exhausted. Unless the shareholders and bondholders shall without delay raise additional millions to be thrown into the ditch, the work will be entirely suspended and a great scheme will collapse. But is it possible to procure more money. The cost of the Sucz Canal was less than \$100,000,000. The Panama Company's obligations already exceed \$245,000,000 and only a beginning of the work has been made, while new and apparently insurmountable obstacles have recently been encountered and must be added to the great problems still unsolved that had been foreseen. It may be noted that at least we have confessions of serious embarrass-ment and probable failure from some of the company's prominent officers and employes. The time seems to be at hand when De Lesseps must lose the confidence of the French The Times also asks: If the company shall abandon the work what becomes of the proposed canal? It is said that some disgusted officers expect that the United States will finish it. But the people of this country do not long for an opportunity to make such an investment. Probably the shareholders and bondholders will exert great influence in an attempt to induce the French Government to complete the ditch in the hope that thus a part of their money may be saved. If that attempt shall be made a new chapter in the history of the canal will be opened, in which certain international questions must be considered. A COLPORTEUR AND TOBACCO.
