Dear Mr. Mondoy:

I just received a call from Dan informing me that the proposed July 4th to the 7th trip is still tentative. The Senate Public Works Committee might be coming to Hawaii on June 29th to July 8th, and Dan might be coming with the group. In case this happens, Dan will have to follow the schedule of the Senate Public Works Committee. However, he will be going to your island if the Senate Public Works Committee decides to visit your particular island.
