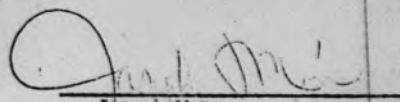

JUDGMENT

This matter was called for trial on March 24, 1976. The Government was represented by the District Attorney and the defendant by Richard Ross of MISC.

Both counsel stipulated in open court that the judgment hereinafter set forth may be entered.

Good cause appearing;

IT IS ADJUDGED and DECREED that:

1. The Government of the Trust Territory of the Pacific Islands is hereby awarded an interest, hereinafter described in paragraphs 3 and 4, in the land described in Exhibit A which is attached hereto and incorporated by reference herein.

2. The Government of the Trust Territory of the Pacific Islands shall pay to the defendants the total sum of \$47,770 for the interest awarded herein. Said sum shall be paid no later than April 25, 1976. The funds shall be paid to "Richard Ross, as trustee for the defendants in Civil Action No. 66," and Richard Ross shall deposit said funds in a trust account in the Bank

of Hawaii, Yap Branch. The signatures of Richard Ross and the Clerk of Courts, Jesse Thinfan shall be required for any withdrawals. In order to facilitate distribution, the funds shall be placed in a checking account. However, if a dispute occurs or a delay results in the distribution of the funds, they shall be placed in a trust savings account. A copy of this judgment shall be provided the Bank of Hawaii.

Upon distribution of the funds, Richard Ross and the Clerk of Courts shall file with the court a list of payees and the amounts paid.

3. The interest awarded herein to the Government is an easement and right of way over, across, under, and through each of the parcels of land hereinafter described in this paragraph and as more specifically and particularly described by the same parcel numbered on Exhibit A and as shown and described on Division of Lands and Surveys Drawing No. 5010/71, for the installation, construction, operation, maintenance, repair, placement, replacement, relocation, and reconstruction of sewer and/or water pipelines and/or mains, manholes, lift and pump stations, sewer and/or water lateral pipelines and power, telephone or utility lines and/or poles and for the construction and maintenance of highways and roads, and drainage facilities and all other structures incidental to aforesaid facilities, together with the perpetual right to remove buildings, structures, trees, bushes, undergrowth
