

Villagomez for senator

SPEAKER Thomas P. Villagomez will run for senator under the Republican Party in the November elections, this was learned Saturday.

In an interview, Villagomez said there is a move within the party to endorse his candidacy. He would fill the slot being vacated by incumbent Senator Juan S. Torres, who had decided not to run.

Jose "Morgen" Tenorio, who was earlier considered with reelectionist Jesus R. Sablan, is out of the race.

As of Saturday, Villagomez said he had not received party endorsement of his candidacy.

Asked whether he would most likely run for senator, Villagomez replied: "Yes."

Villagomez last May joined Resident Representative Juan N. Babauta in the Republican Party primary for the top executive posts. They lost to incumbent Governor Lorenzo I. Guerrero and Lt. Gov. Benjamin T. Manglona.

The possibility that Babauta may run for another term also remains. Finance Director Eloy S. Inos, who had been nominated for Babauta's post, earlier said he was willing to give way to Babauta if the latter decided to seek reelection.

Giving way to Babauta could actually help Inos avoid a difficult situation during the campaign period. His brother, Sen. Eloy S. Inos, is expected to run for mayor in Rota under the Democratic Party. (NL)

Tenorio joins priesthood

AT THE age of 16 Roger Pierre Taisacan Tenorio decided that he wanted to be a priest. On Saturday, at the age of 25, he was ordained priest of the Diocese of Chalan Kanoa.

"I'm excited. I am really excited," he said in an interview before the ordination which was officiated by Bishop Tomas Camacho.

Tenorio, whose relatives include the Commonwealth's business and political leaders and whose father, Jose, was a teacher, lawyer and businessman, naturally thought about following the steps of his elders.

His life as a teen-ager was also typical of people his age. "I had

very lively teen-age years," he recalls. "I went to dance with gangs, friends from Mount Carmel and the public school."

"Even while in college I always got in touch with friends and went dancing. It was beautiful because it helped me put everything in perspective."

But Tenorio had always been close to the church, particularly Mount Carmel cathedral. He was a catechist, was involved in charismatics and helped with the choir, and that was how Bishop Camacho noticed him and advised him to consider priesthood.

There were objections from the family. Tenorio's father was already sickly when he decided to

be a priest.

"Being the oldest of six children I was expected to help out," he said. "I was needed at home. It was hard to break away from the nest."

Eventually, both parents supported their son. "When my father passed away in 1989 my mother (Crispina) encouraged me to continue," Tenorio said.

He finished his senior year in high school at Father Duenas Minor Seminary in Guam in 1985. In 1985-1989 he attended St. Joseph's College Seminary in Mountain View, California, where he received his bachelor of arts degree in humanities.

Sablan plans plea agreement on case

FORMER Public Works Director Nicolas C. Sablan, who is accused of threatening the life of Superior Court Presiding Judge Alexandro C. Castro and his family, is planning to enter into a plea agreement with the Justice Department, this was learned Friday.

During arraignment at the District Court, Judge Alex R. Munson granted lawyer Jesus C. Borja's motion to release Sablan, 41, to the custody of his elder brother David, and on an unsecured bond.

An unsecured bond is a promise to pay the court (in this case \$10,000) in case of failure to show up when ordered to do so.

Borja, as Sablan's counsel, informed the court of Sablan's intention to enter into a plea agreement with the government. He asked the court for an order to require a psychiatric evaluation to determine whether Sablan can competently and voluntarily enter into a plea agreement and whether he can assist his lawyer in defending Sablan in court.

Sablan waived his right to a speedy preliminary hearing.

Munson granted almost all of Borja's motions which were not opposed by the Justice Department.

Sablan was released Friday afternoon, subject to the following conditions:

- He must not attempt in any way to contact Castro and any member of his family, as well as any judge in the Superior Court and Supreme Court.
 - He must not contact lawyers David Wiseman or Lecia Eason or any party in lawsuits pending in the Superior Court except for legal motions, which are best handled by lawyers. Sablan was also advised to be very careful with his language when filing motions on his behalf.
 - No trips to bars and no consumption of intoxicating beverages or narcotics unless prescribed by a physician.
 - Acknowledge in writing his release on \$10,000 unsecured bond.
 - Curfew from 7 p.m. to 7 a.m. daily, except in emergency or life situation.
 - Turn in passport and other travel documents. He must not leave Saipan without written permission from the court.
 - No change in residence without court permission.
 - No firearms.
 - Must report to court on any date and time ordered by the court or upon request by the attorney.
 - Must not violate any local, state or federal law.
- Violation of any of these conditions could be ground for revocation of the release order.

Sablan was arrested by agents of the Federal Bureau of Investigation and local police on July 7, a day after FBI agent John Holland filed a complaint accusing Sablan of threatening to injure Castro and his family.

According to the complaint, the written threat was sent by facsimile machine from Texas to the Superior Court in Susupe.

Castro reported the threat to the FBI office in Saipan on May 28. The message bore the heading - Robert Lamons. Castro said he had information that Sablan was staying with Lamons or his stepdaughter Angela May Guzman in Texas. (NL)

House rejects Senate version of '93 budget

THE HOUSE of Representatives rejected the Senate version of the fiscal year 1993 budget Friday. The two houses now go into conference committee.

House Bill 8-226 appropriates \$159.157 million for government operations, mainly for salaries of 4,052 employees.

"The Senate budget bill tries to throw us off guard. Not only does this tactic mislead the various government agencies and instrumentalities, but it is also not nice at a time when we are asking our people and businesses to pay more taxes," Rep. Pete P. Reyes, author of the original HB 8-226, said in a privilege speech.

According to Reyes, the Senate version provided for an additional 20 full time employees (FTEs) each for Saipan, Tinian and Rota, which the government may not afford due to meager resources.

The Senate version of the budget appropriates the same amount of money as in Reyes' original appropriation measure.

It provides for \$119.76 million for salaries and another \$39.4 million for operations.

This is slightly different from the \$118.76 million proposed for salaries and \$40.4 million for operations under the House version.

Although the Senate appropriation summary indicates minimal changes from the House figures, Reyes said the changes were hid-

den somewhere in the administrative provisions of the bill.

According to Reyes, there is a provision in the Senate substitute bill that allows the appropriation of \$3.425 million in lapsed funds, which were initially funded under regular general funds by the House of Representatives.

It is from these lapsed funds where the Senate wants money taken to allow for an additional 60 FTEs, for the three major islands of the Commonwealth.

"This lapsed funding is meaningless and could not be appropriated because this is meant to cover the current deficit, which runs to about \$7.3 million," Reyes said.

Reyes is also acting chairman of the committee which is conducting public hearings on proposed tax reforms, including higher taxes and lower tax rebates.

The proposal has met stiff opposition from various sectors in the light of increasing government expenditures.

"The people in several public hearings have been clamoring for a reduction in the size of government. It is our responsibility to reject the Senate version and immediately go into conference to tell our Saipan senators that our people will no longer support this type of abuse," Reyes said.

Reyes' position on the budget was shared by almost all of the House members that were present, except for Tinian Representative Joaquin H. Borja who voted in favor of the Senate budget version.

Speaker Thomas P. Villagomez named Reyes as chairman of the House conferees on the budget, along with Representatives Heinz S. Hofschneider and Herman T. Guerrero.

The conferees were instructed to remain on-island and immediately schedule a meeting with their Senate counterparts. (RHA)

He went on to St. Patrick's Theological Seminary in 1989 - 1993 where he earned his master's degree in divinity.

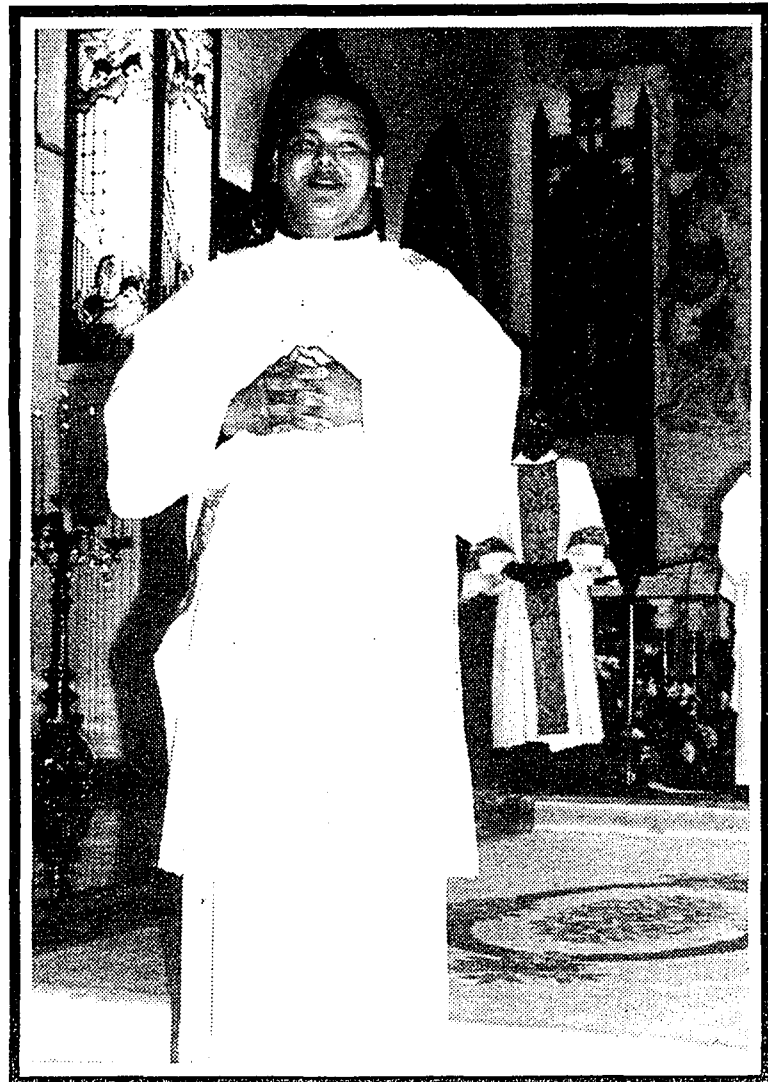
Tenorio became deacon in December 1992, five months before he graduated from St. Patrick's.

Just before his ordination as deacon, Tenorio's mother asked him if it (priesthood) was what he really wanted to do, making him feel that whatever decision he made she would always support him.

"It was great to know that at this point, if I withdrew I will still get support," he said. "So there is no fear. They were beside me - my mom, relatives, friends."

Ordination, according to Tenorio, is not the end of the pursuit. "This is just the beginning for me. Opportunity, challenges lie ahead of me, so I will need further support from my family, friends."

As a priest, Tenorio said he must recognize social problems in the community and "correct whatever injustices there are."

"I want to encourage people who are struggling with their faith," he said. "I will be part of their lives through marriage counselling and baptismal celebration."

Among social problems he cited the dilemma of alien workers, effects of gambling and the rising

number of divorces. Gambling is not necessarily evil, but its effects, like breaking up of families and straining of financial resources, are, he said.

"We need to challenge people to seriously look at our ways, priorities. It's not easy; it will not happen overnight."

He believes he is ready for the task. "In terms of pastoral ministry, I think I have a richer experience," Tenorio said. "Every summer I come back, live with the bishop, hang out with friends. They tell me what's happening in their lives, their neighbors. So I am entering priesthood not as a novice, not as a rookie." (NL)

On behalf of the 15 members of the Hotel Association of the Northern Marianas Islands, thank you for the opportunity to express our views on House Bill 8-248. The Association recognizes the need to review the current CNMI tax structure and the possible need for increased tax revenues to cover past deficits in government revenues.

"HB 8-248...includes drastic increases that will be dangerous to the health of the tourism industry and the economy of the CNMI as a whole."

Our general comment on HB 8-248 is that it includes drastic increases in the tourism industry and the economy of the CNMI as a whole. The following steps are taken:

- 1) We recommend that the Tax Task Force Commission, established by law, be given a major role in compiling a complete factual report to be considered as the authoritative recommendation for the Legislature's consideration. The task force would, of course, need to operate within an expedited, but reasonable, time frame to receive input from all sectors of the community. The end result should be a tax reform bill which answer the current financial needs of the Commonwealth while ensuring continued economic growth.
- 2) We must encourage and request the CNMI government to share the burden with the business community in reducing our local deficit. Government expenses should be reduced as much as possible. Perhaps a task force should be formed to help identify areas where savings could be realized.

One thing that we would like to strongly emphasize is the need for advanced notification of whatever tax increase is being proposed so the tour companies who normally negotiate and publicize their rates at least 6 months in advance can adequately plan. These rates are publicized and advertised by our tour companies and are bound by law to stick to those rates. If the tax increase is passed without

101 abused Filipino maids flown home

KUWAIT (AP) - More than 100 Filipino maids who claim they were mistreated or cheated by their Kuwaiti employers were flown home this week at the expense of Kuwait's crown prince, the Philippines Embassy said Saturday.

The group of 101 women left on a Friday night flight. They raised to 416 the number of domestic helpers repatriated under a program financed by Sheik Saad al-Abdullah al-Sabah, according to Lamberto Marin, the Philippines labor attache.

It was not known how much Sheik Saad paid for the operation, but a one-way ticket to Manila costs about 170 dinars (\$595).

Marin said two women and their newborn sons stayed behind until the babies are strong enough to travel.

One of them, Mercedes Lorenzo, has filed a rape case against her employer. The circumstances of the other birth were not known.

The two women, and a third recovering from a broken leg suffered in an auto accident, remain in a two-story villa that has been used since the 1991 Gulf War as a "safe house" for maids fleeing hostile employers.

Marin said the house would be closed soon and that maids fleeing their work will now be handled by Kuwaiti police.

In addition to those repatriated with the help of Sheik Saad, hundreds of

other Asian women, many of them Filipino, went home at the expense of their employers.

The women had complained of abuse, non-payment of salaries or miserable working conditions.

Middle East Watch, a New York-based human rights group, said in a report last year that physical assaults on maids had been largely ignored by the government.

Kuwait complained that reports about mistreatment of Asian maids were exaggerated and designed to hurt its reputation.

A Kuwaiti man and his wife currently are standing trial for savagely beating their 23-year-old Filipino maid. Sonia Panama died in March after a month under intensive care.

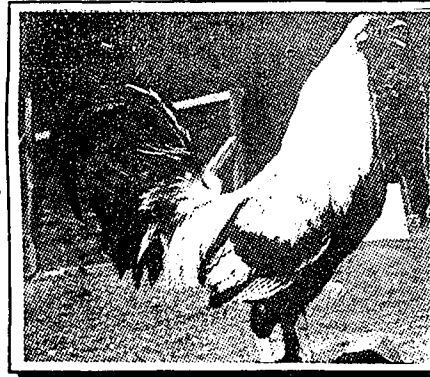

Northwest supports Vietnam Wall trip

NORTHWEST Airlines in conjunction with IT & E and the Guam Hilton is proud to announce that a five day display of the Vietnam traveling memorial wall replica is scheduled for July 17-21.

Plans are almost complete for the display of the traveling replica. An elaborate opening ceremony on July 17 at the governor's parade field in Adelup at 10 a.m. will initiate the display period, which will end on July 21, Guam's 49th Liberation Day.

During the ceremony, a roll call of Guam's 72 native sons, who died fighting in Vietnam will be held, and survivors will be escorted by military personnel to place flags and candles at the wall where their loved

ones name are inscribed. Seventy-two US flags will also be flown at the wall to represent each casualty and will be given to survivors at the end of the display. Should a Vietnam casualty have no immediate survivors present, he will be represented by a military escort.

The Vietnam memorial traveling wall is a half-size replica of the original Vietnam memorial wall in Washington, D.C., and like the Washington memorial the 250-ft. long replica also has the names of the 58,183 US servicemen and women who died in Vietnam engraved into its panels.

A group of Vietnam veterans from California led by John Devit came up with the concept of the moving

wall while attending the dedication of the Vietnam Veterans memorial in Washington, D.C. At first, it was decided to build a replica and display it on the West Coast so that people who lived far from the capital could have a chance to experience the wall.

Devit now travels all over the world giving hundreds of people the opportunity to experience the memorial.

The memorial is made of 0.100-inch aluminum panels, with a surface alodined and electro-painted a

gloss black which gives a mirror like finish, mounted on angular aluminum frames. Because of the amount of handling and the extreme and varied weather conditions the structure is subject to, it was finally decided to use aluminum panels, giving the structure the necessary durability so that it would continue to look like the original structures.

The entire structure is supported by 74 steel square-tubular braces. It was decided that silk-screening was the best way to replicate the names.

making each name as legible as it is on the memorial in Washington. Completed in October 1984, the replica made its first appearance on Oct. 15 in Tyler, Texas. The project, like the Vietnam Veterans Memorial in Washington, was funded by the public.

Bringing the moving wall to Guam was the idea of a former senator, Jerry Rivera. Rivera tried to bring the moving wall to Guam while he was a member of the 19th Legislature.

Political status hearing extended

DELEGATE Ron de Lugo, chairman of the subcommittee for insular and international affairs, has scheduled an additional day of hearings, August 3, on a congressional resolution regarding self-determination and non-self-governing territories to hear from leaders of American Samoa, Guam, Palau and the US Virgin Islands.

The resolution sponsored by Representative Jose Serrano (D-NY) is intended to state that Puerto Rico has the right to determine its future political status and a hearing on this proposal is scheduled for July 13th.

But the language of the resolution would also relate to other insular areas for which the US is responsible

as well as Puerto Rico and de Lugo said that he is scheduling the August 3rd hearing because of this.

In addition to statements regarding Puerto Rico, H. Con. Res. 94 would state that peoples generally have the right to determine their political status and that the interests of the inhabitants are paramount in matters concerning non-self-governing territories.

American Samoa, Guam, Palau and the US Virgin Islands are among the 18 areas listed by the United Nations as non-self-governing territories. De Lugo said leaders from these areas would be invited to testify at the hearing.

Pacific Magazine marks 100th issue

PACIFIC Magazine, serving the Pacific Islands since 1976, has published its 100th issue.

The July/August number features special reports on 17 Pacific Island countries and territories in its 124 pages. The magazine circulates throughout Micronesia, Polynesia and Melanesia.

Started by publisher Bruce Jensen as The American Pacific in mid-1976 to identify it more with US insular territories, the name was later changed to Pacific Magazine to better describe its coverage of the entire Pacific basin.

"There was only one magazine in the region at the time, published in Australia, and its editorial coverage was mostly below the equator," Jensen said. "So, I decided to start an American publication about the Pacific Islands. It's hard to believe we've reached out 100th issue."

The bimonthly has a circulated press run of 10,000, with readers throughout the world. Jensen said that with this issue, someone will be reading the 1-millionth copy of the magazine.

Japan's splinter parties plan to form parliamentary group

TOKYO (AP) - Two of Japan's several splinter parties - the Japan New Party and the New Party Sakigake - said Saturday they have reached an agreement to form a joint parliamentary group after the general election on July 18.

The election was called after Parliament passed a no-confidence resolution against Prime Minister Kiichi Miyazawa last month for failing to enact promised political reforms.

JNP leader Morihiro Hosokawa and Masayoshi Takemura, head of Sakigake, a governing party breakaway, made the announce-

ment in separate news conferences.

Sakigake, which means pioneer or harbinger, is one of two groups of Liberal Democratic Party members who quit the party following the no-confidence vote.

The other group formed the Shinsei (New Life) Party, which is also campaigning in the election against the Liberal Democrats, the Socialists, the Komeito (Clean Government) party, the Communists and the Democratic Socialists.

Hosokawa and Takemura said the two parties will exercise influence as a joint group in Parlia-

ment.

Hosokawa, a former LDP member of the upper house and a former prefectural governor, formed the JNP in May last year.

The Liberal Democrats could lose their majority in the powerful lower house of Parliament for the first time since the party was founded 38 years ago, largely because of a series of corruption scandals.

The JNP and Sakigake announcement makes it likely that the two parties will refuse to participate in a possible Liberal Democrat-lead coalition.

Mississippi floods leave 16 dead

ST. LOUIS (AP) - As levees collapsed and flooding that has killed 16 people along the Mississippi River spread south, President Clinton ordered emergency aid for flood-ravaged regions of three states.

More heavy rain fell Saturday across parts of the upper Mississippi Valley, feeding floodwaters overflowed levees as far south as St. Louis on the river system that drains the central third of the United States.

In Iowa, some 3,200 people were ordered to evacuate their homes near Des Moines late Saturday, joining more than 20,000 people earlier forced out of communities along the rising river.

Officials estimate crop and property damage at more than \$2 billion in South Dakota, Minnesota, Wisconsin, Nebraska, Iowa, Illinois and Missouri.

The river had flooded 431 square miles (1,116 square kilometers) along a 200-mile (320-kilometer) stretch of Missouri from Hannibal south to Cape Girardeau, said Gary

Dyhouse, a spokesman for the Army Corps of Engineers in St. Louis.

From Hannibal south to St. Louis, most of the levees along the Missouri side of the river had been breached or overtopped, he said Saturday.

"Everything north of us is pretty well gone," said Dyhouse.

In Kansas City, Mo., and neighboring Kansas City, Kan., the Missouri and Kansas rivers wrought havoc Saturday after 8 inches (20 centimeters) of rain fell. More rain was forecast for Sunday.

In Kansas City, Mo., firefighters extended a 100-foot-long (30-meter-long) aerial ladder from a highway overpass to rescue people stranded at a restaurant, said Fire Capt. Christopher Bosch.

"The water was probably 8 feet (2.5 meters) deep there," Bosch

said.

In Kansas City, Kan., 276 families were evacuated from a flooded mobile home park near the Kansas River. Water 4 feet (1.5 meters) deep flowed through the city's Kemper Arena.

In other states, scores of levees lining rivers collapsed, including one that gave way in Niota, Ill., Saturday night, sending the Mississippi flowing over thousands of acres (hectares) of farmland and into the city of 400 people.

Twenty miles (32 kilometers) from Meyer, in Quincy, Ill., much of the fertile, river-bottom farmland had also been inundated. From the air, farmers could be seen tearing up their corn crops to build dikes around their homes and farm buildings.

At hard-hit Davenport, Iowa, one of the few river cities with no levees

or flood walls, the Mississippi was at 22.4 feet (6.8 meters) Saturday, 7.4 feet (2.25 meters) above flood stage.

The Mississippi and Missouri rivers created a double threat for St. Charles County, Mo., just north of St. Louis. Part of the county forms a peninsula separating the two rivers as they approach their confluence.

The Mississippi already was flooding lowlands at Portages Des Sioux, on the peninsula's northern side, and threatened to take a short cut to the Missouri and turn the peninsula into an island, said Missouri Water Patrol Capt. Charles Scroggin. Missouri's state Emergency Management Agency said about 14,000 people around the state had been evacuated because of flooding on the Mississippi and Missouri.

Heat wave grips East Coast

TWELVE people died of heat-related causes in the Philadelphia area alone on Saturday as a record-setting heat wave gripped the East Coast.

The heat has now killed 21 people along the Eastern seaboard during the past week.

The latest victims included a 4-year-old boy who had climbed into his aunt's parked station wagon while visiting relatives outside Philadelphia, police said. It was not known how long he'd been in the car, police said.

Meanwhile, New York City fried for a third straight day Saturday, tying a record dating to 1948. No relief was expected until Tuesday, when a frontal system from the West was forecast to arrive.

Philadelphia also tied its record for consecutive days of above 100-degree (38 C) temperatures. The last time its temperatures topped 100 (38) for three days in a row was in 1966.

In Massachusetts, 20,000 chickens died in the heat after lighting struck a henhouse ventilation system.

By noon Saturday, temperatures in Atlantic City had reached 97 (36 C), breaking the old record for the date set in 1880. And those teeming to the New Jersey shore had to cross a scorching strip of sand before reaching the cool Atlantic.

"The sand is dangerous," said Lt. Jack Schellenger of the Cape May Beach Patrol. "It'll take the skin right off your feet. We see a lot of people jumping around."

Miami's temperature of 91 degrees (33 C) at 1 p.m. compared

with a 102-degree (39 C) mark in New York and 100 degrees in Philadelphia.

It was the seventh straight day temperatures in Pennsylvania reached at least 95 degrees (35 C).

Unlike the five deaths earlier this week in Philadelphia, at least four of Saturday's victims had been drinking alcohol, said Jeff Moran, a spokesman for the city Health Department.

Seventeen of the 20 heat-related deaths reported this week have been in Philadelphia, with one each in New York City; Allentown, Pa.; Brooklawn, N.J.; and Keene, N.H.

In Westminster, Mass., chicken farmer William T. Mason had no idea how to dispose of the 20,000 birds that died in high heat and humidity.

Oppression of Baha'i continues

THE IRANIAN government's continuing systematic oppression of the Baha'i community of that country has taken a new turn with the removal of corpses from the Baha'i cemetery in Tihiran.

The graves are being destroyed and the bodies loaded into trucks and removed to a destination unknown to the Baha'is.

The government's official high-level policy to oppress and persecute the 350,000-member Baha'i community in Iran was revealed in a United Nations report released this February to the United Nations Commission on Human Rights in Geneva. This previously secret document, issued by Iran's supreme Revolutionary Cultural Council and endorsed in the handwriting of Mr. Ali Khamenei, successor of the late Ayatollah Khomeini, listed specific action to be taken to "confront and destroy" the cultural roots of the Baha'i Faith.

The policy, according to quotations from the memorandum, also aims to treat the Baha'is of Iran "such that their progress and development shall be blocked".

The document, published by Special Representative Reynaldo Galindo Pohl of the United Nations Commission on Human Rights, and who has been investigating charges of human rights violations in Iran for the commission since 1985, is seen by the International Baha'i community as a further attempt by the Iranian government to create an environment where the Baha'i community in Iran can be slowly strangled without arousing international attention.

According to local Baha'i spokesperson Annabelle L.H. Aguon, "The world has known for years that Baha'is have been targets of persecution in Iran. However, this document brings to light the degree to which the persecution of the Baha'is is controlled and condoned at the highest levels of the Iranian government. The National Spiritual Assembly of the Baha'is of the Mariana Islands has, along with the rest of the Baha'i world, sent letters of protest to the Iranian government over this recent and disgraceful action."

Aguon says representatives of the Marianas Baha'i community are approaching the governors of Guam and the CNMI, as well as other local government leaders, in order to seek support for an international campaign to bring the contents of this document to the attention of governments, NGOs and the world at large.

Since 1979, more than 200 Baha'is have been executed or killed in Iran, hundreds more have been imprisoned, and thousands have been deprived of jobs, pensions, and/or education. Although the rate of killings slowed in the late 1980 and early 1990s, in April 1992 a Baha'i businessman in Tihiran was executed solely for his religious beliefs, triggering concern that a new round of killings might be underway. The current action of digging up and removing the bodies of the Baha'is buried in the cemetery of Tihiran is certainly a further step in implementing the objective of destroying the cultural roots of the Baha'is, as stated in the secret document.

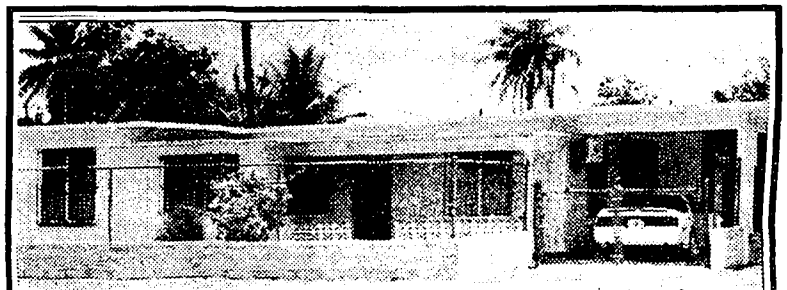

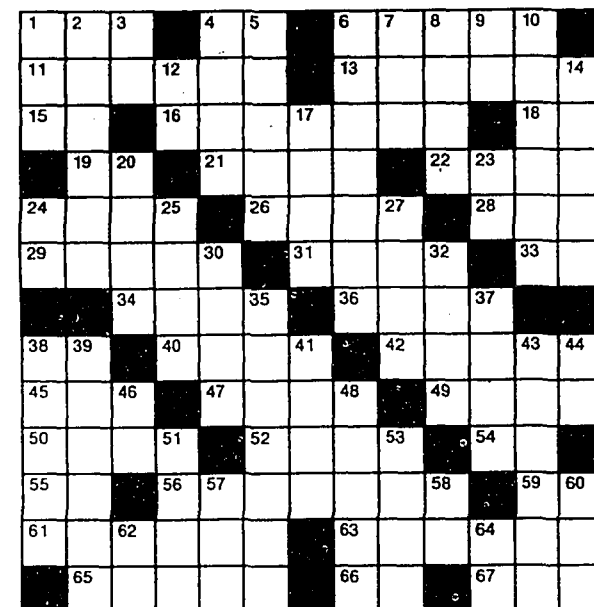

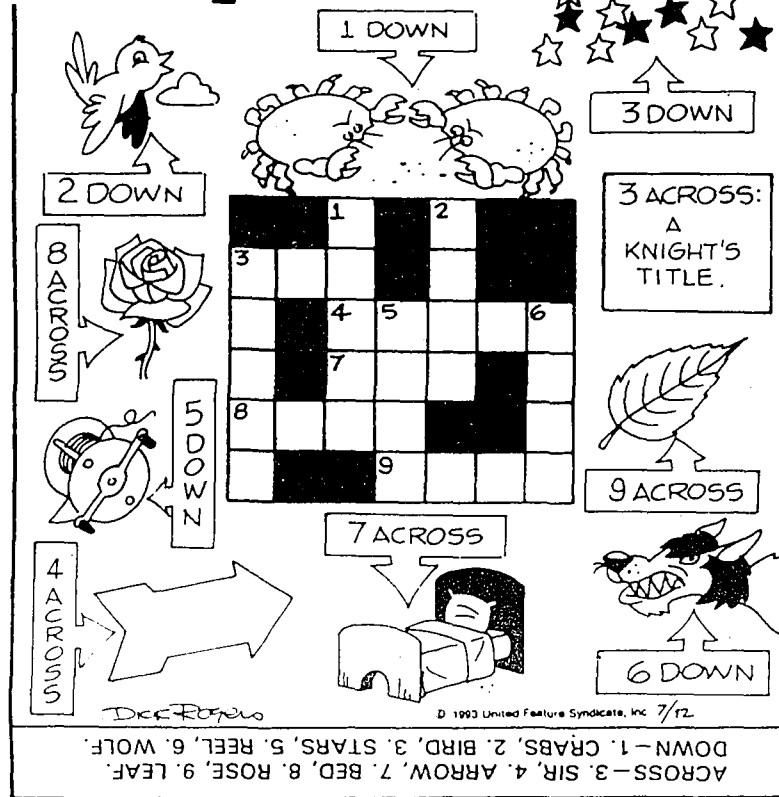

Nick versus Nick at British Open

SANDWICH, England (AP) - One Nick owns it. The other Nick seems to be owed it.

Nick Faldo is certain to be the favorite when golf's oldest tournament, the British Open - or as the British simply call it, the Open Championship, begins Thursday at formidable Royal St. George's for the 122nd year.

After all, Faldo owns the title, and is the recent winner of the Irish Open.

His principal opponent in the British Open's field of 156 figures to be Nick Price, who has every reason to believe this event owes him one.

And Price, arguably the hottest player in the world at the moment, would like nothing better than to collect - even if he disavows the debt.

"Oh, no," Price said. "Not in this game. Golf doesn't owe me anything. If anything, it's the other way around."

But runnerup finishes in 1982 to Tom Watson and in 1988 to Seve Ballesteros remain at the forefront of his memory.

"The first time, I was only 25 and I wasn't ready for it. 'I couldn't handle it,' recalled Price, who, from the lead, lost four strokes to par over the last six holes at Royal Troon.

"The second time, I played the best I could and I just got beaten by the best player in the world playing at the top of his game," said Price, who had a closing round of 69 at Royal Lytham and St. Annes, only

to lose to Ballesteros' brilliant 65.

Now, however, Price is a more accomplished and more confident performer.

He is in his golfing maturity and comes into this event with spectacular credentials and an even more spectacular putter.

The putter was given to him by close friend Denis Watson after Price's bid for the US Open was betrayed by poor work on the greens.

He has been on a tear ever since, however.

This amiable man who grew up in the former Rhodesia and resides in Florida is the current US PGA champion and, in the last 11 months, won seven times around the world.

This season, he leads the American tour with slightly more than \$1 million in earnings and is the only three-time winner.

That includes rare consecutive victories in his last two starts, the Greater Hartford Open and the Western Open, both of which he attributed to growing confidence and proficiency with that new putter.

"He's doing kind of like what Freddie Couples did a year ago," Greg Norman after finishing second, five shots back, to Price in his last victory.

And the Australian ace opened up some interesting speculation.

"You have to put him up there as the best player in the world. He deserves to be No. 1," Norman said.

Faldo, of course, currently holds that position, at least in a world-wide rating system that is recog-

nized by most major tours.

Faldo did nothing to hurt that standing in his last start.

The 1.90 meters (6-foot-3) Englishman was less than impressive in the first half of the year but signaled he was ready for the defense of his British Open crown with a comeback playoff decision over Jose Maria Olazabal in the Irish Open.

Noting that the Irish victory immediately preceded his emotional triumph at Muirfield last year, Faldo said, "I hope we're seeing the start of a trend."

While not exactly what he had in mind, the major trend in the British Open in the last decade has been the unsuccessful struggle of American players.

Americans won 12 of 14 times between 1970 and 1983 but won only once in the nine years since then as the European stars - led by Faldo's three British Open triumphs - moved to the fore.

Nicklaus charges to lead US Senior

DENVER (AP) - Jack Nicklaus climbed past a faltering Dale Douglass and charged to the third-round lead Saturday at the US Senior Open.

Nicklaus birdied the last three holes to finish the round with a 4-under-par 67. He stood 5-under at 208 entering Sunday's final round.

Nicklaus, who hasn't won since the Senior Open two years ago, capped his round with a birdie on the 450-yard (405-meter), par-4 18th hole - which has played the toughest on the course all week.

One stroke behind was Douglass, who had steadily built a three-stroke lead with some precision iron play before bogeying the final two holes. Douglass drove behind a tree on the 17th hole and missed the green on the 18th.

The Colorado native, who finished with a 68, appeared headed for sole possession of the third-round lead after birdies at Nos. 15 and 16 to go 6-under.

The clear winner on Saturday was venerable Cherry Hills Country Club, which proved nearly impervious to sub-par rounds.

Chi Chi Rodriguez, the first- and second-round leader, began the day with a bogey. But three straight bogeys on the back nine dropped him from the lead.

His playing partner, Japan's Isao Aoki, fared even worse. Aoki, who began the day a shot behind Rodriguez, lost four strokes to par on the front nine and never recovered.

Two shots off the lead was Kermit Zarley, whose carded a 69. Rodriguez, who limped home with a 75, was at 212, along with Tom Weiskopf and Larry Ziegler. Ray Floyd and Miller Barber finished at 213. Aoki, who had a 76, was at 214.

Lee Trevino, Jim Colbert, Dave Stockton and Simon Hobday stood at 215.

10,000-meter run in less than 27 minutes

OSLO, Norway (AP) - Veteran Yobes Ondieki of Kenya became the first man to run the 10,000 meters under 27 minutes, finishing in 26 minutes 58.38 seconds at the Bislett Games on Saturday.

Ondieki, 32, slashed nine seconds off the previous mark of 27:07.91, set by countryman Richard Chelimo in Stockholm, Sweden, only five days ago.

It was the 50th world record since 1924 at Bislett Stadium - billed as the "world record track."

Ondieki posted split times well below those Chelimo had in Stockholm throughout Saturday's race as he and fellow Kenyan William Sigei set the pace. Ondieki then took the lead for good with eight laps left after clocking 13:28 at the 5,000-meter mark.

"I know I was capable of breaking the world record tonight," said Ondieki, who was competing in the grueling distance for the first time of the season.

"I knew I could do it if my body felt well. I'm in such good shape and I had prepared well."

"The first five kilometers were

a bit quick, but as the race progressed I felt strong."

A late bloomer, Ondieki emerged into world class in 1988, and then had a brilliant season in 1989, when he became the first man in 10 years to beat Said Aoutia of Morocco at 5,000 meters. He won the distance in the 1991 World Outdoor Championships in Tokyo.

Sigei was second in 27:16.81, Alejandro Gomez of Spain third in 27:39.88, Richard Nerurkar of Britain fourth in 27:40.03 and Todd Williams of the United States fifth in 27:40.37.

Earlier, Olympic champion Linford Christie of Britain won the 100 meters in a wind-aided 10.09.

Andre Cason, the new US champion and winner of the 100 Wednesday over Carl Lewis in Lausanne, Switzerland, dropped out of the final because of a illness.

"I have a virus and I guess I contracted it yesterday," said Cason, who won the first of two qualifying heats in a wind-aided 10.16. "I hope I'll be invited back here next year."

Cason's coach Loren Seagrave

said "it may have looked easy for him in the first heat, but immediately afterward he felt he was going to vomit." "And during the warmup he had to sit down because he felt dizzy," Seagrave said. "It wasn't worth the risk to run the final."

Seagrave said Cason, competing for the first time in the Bislett Games, felt very tired when he arrived in Oslo for the meet Friday.

"It was very difficult for him to sleep," Seagrave said. "He showed signs of a fever over 38 degrees and we had to change bed twice because he was sweating so much."

Cason planned to return home to Atlanta on Sunday and will rest next week before resuming training.

Christie took the lead early and held off Frank Fredericks of Namibia, runner-up in both the 100 and 200 in the Barcelon Olympics, by two hundredths of a second. Third went to Michael Gren of Jamaica in 10.21. Christie posted a time of 10.26 in winning the second qualifying heat ahead of Green.

\$207M stadium project for '96 Olympics begins

ATLANTA (AP) - Without a shovel in sight and despite about 50 demonstrators who don't want the structure in their neighborhood, Olympic organizers broke ground Saturday for the \$207 million stadium that will be the centerpiece of the 1996 Games.

The stadium will be built in a parking lot across the street from Atlanta-Fulton County Stadium. After the Olympics, it will be converted into a baseball stadium for the Atlanta Braves.

The stadium, which will be the site of the opening and closing ceremonies and athletics events, is scheduled to be completed in the summer of 1995.

Some 1,000 people showed up in 90-degree Fahrenheit (32-degree Celsius) heat for the one-hour ceremony, including the demonstrators, who held up signs declaring opposition of the stadium in their neighborhood.

The protestors jeered and chanted "sold out," "sold out" during speeches by city and state leaders. The list of dignitaries included Gov. Zell Miller, Mayor

Maynard Jackson, former Olympic gold medalist Wilma Rudolph, Atlanta Committee for the Olympic Games chief Billy Payne and ACOG co-chairman Andrew Young, the city's former mayor.

"This is a great day," Young told the crowd. "We're on time, on schedule and within budget."

Young was mayor of Atlanta in September 1990 when the city won the right to host the Games.

"Today is a day of celebration," Jackson said. "Tomorrow we take our place on the world stage for peace through sport."

Eight officials then got into earth-movers - no shovels - and picked up dirt from a 20-foot by 40-foot (6-meter by 12-meter) mound in the middle of the parking lot, symbolizing the start of construction.

The Rev. Joseph Boone, retired pastor of Rush Memorial Congregational Church in Atlanta and an opponent of the stadium, tried to speak after the last dignitary left the stage. But the microphone was turned off and he was drowned out by the engines from the earth movers and the band playing.
