In accordance with established usage in Christian countries, there will be no paper issued from this office to-morrow, Dec. 25th, of all the golden days of the year, stands pre-eminent as the memorial of the greatest event that has ever been recorded—the dawn of hope, love, peace and good-will to mortal man. Let it then be kept as the brightest and happiest day of the year, when youth and age of every creed and every nation may meet around the festive board, and before the sacred altar bless the great Ruler of the universe for the peace and good-will that reigns throughout our country.

"A MERRY CHRISTMAS" to every reader.

We happened to come across a copy of Saturday's *Elele* yesterday and were edified to find that every one of our own editorial effusions had furnished our esteemed contemporary with a text. Without meaning to in the least, we have been shaking a red rag at an angry bull. The bellowing and lowering of horns is awful, and as for us we hasten to get over the fence. The *Advertiser*, which has been thought a too conservative sheet, turns out to be very "red" indeed, when shaken at the *Elele*. The editor of the latter journal is having the delirium tremens in print. He sees snakes on all occasions, and at the sight of our own harmless productions his fevered imagination conjures up the most horrid monsters.

The difficulty is the editor is hired to furnish bile on all occasions. Every one who has ever been searick knows how hard that gets to be. Fancy the public standing by and having to watch the strainings and retchings. Fortunately they are spared that infliction, for nobody reads the English of the *Elele*, we believe, except the editor, the compositor and the man who furnishes the anonymous communications.

The Bulletin, a few days ago, called the ticket propounded by the Mechanics' Union a good "compromise" ticket, which might be hard to beat. Now that the revised ticket has come out the compromise looks very fishy indeed. It reminds us of that aged story of the Indian and white man who went out hunting together. They "compromised" on the spoils, but somehow, in spite of all compromise, the white man carried off the turkey and left the Indian to be satisfied with the chicken, if he could. So here the compromise is happily effected by the Mechanics making all the concessions.

The men who are trying to humbug the Mechanics have a notion of compromise which is delightfully funny. They think it consists in nominating men together who love each other about as much as the devil loves holy water. They think you can get the lion and the lamb to lie down together by simply nominating them on the same ticket. Such schemes argue an imperfect acquaintance with these animals. They cannot be induced to fondle each other affectionately upon such short notice. The millennium is not

to be so cheaply coaxed into existence. You must give it time.

The individuals who are trying to manipulate the Mechanics' Union probably feel themselves that their programme was too thinly foolish to deceive anybody who has brains enough to put two and two together. They do not want any compromise at all. They want to capture the Mechanics' Union, not to compromise with it. None could be deceived as to their intentions by a ticket so ridiculously put together as the one which they first proposed. That is probably the reason why they amended the ticket by dropping about the last element of compromise it contained and making it pretty nearly of one color.

One would have to be without the sense of humor not to be struck by the conduct of the leaders of the Mechanics' Union, chiefly on the comic side. Those leaders seem to think that the mechanics themselves have no sense of humor. Could they otherwise imagine that they could be hoodwinked into voting for Wilcox? The leaders apparently are trying to put up a practical joke on the members. Imagine men who a few months ago shouldered a musket to suppress Wilcox, now going to the polls to vote for him. This is a hoax which almost passes a joke. If the Mechanics' Union really represented the mechanics, it would be an incredible state of things. But it is safe to answer that it does not. The King's party may capture the Mechanics' Union, but it cannot capture the mechanics themselves. If the ring into whose hands the organization has unhappily fallen insist in nominating men who utterly fail in character, aims and occupation to represent laboring men and their interests, and if they insist on making the union ridiculous by nominating loafers like Hoapili Baker to represent it in the councils of the nation, the only result will be to discredit the organization and break it up. No one would deplore this result more than the *Advertiser*, but it is none the less inevitable.

We do not care to look at the right or the left, we shall at all times dispense to our beloved people our heart's best and warmest advice.

We feel at the same time extremely obliged for the splendid translation of Aurora's article of the 14th inst., because the truth, and nothing but the truth is there only to be found, and at the same time, the luminous rays of the Aurora have been thus thrown broad cast, and every one may gladly enjoy its vivifying warmth.

All the mystification to be found, lies in the *Advertiser's* perversion of the true sense and meaning of the question; whereas, Aurora is sailing smoothly in another direction. Aurora tries to impart to the Portuguese, the uppermost sentiments of her heart in their behalf. She has so far done her duty as the lawful exponent of the true interests and well-being of the Portuguese colony; pleased and happy will she be, if they attend and listen to her advice; if not, let them reap the consequences. Remember, however, that back of all this, lies snugly encoined the vexatious question, mountain high, of the Chinese and Japanese, the perplexing problem of which we leave to the *Advertiser* to solve at his leisure, and after its full digest, you will be the first to admit Aurora's justification in the premises. ## BUMPS AND JINKS.

The Pair of Noble Brothers Again on Deck.

As our reporter was wandering about a few evenings ago he came across our old friends Bumps and Jinks who were engaged in earnest discussion of politics. Jinks had but recently returned from another voyage and had evidently been recounting some of the things he had heard, and Bumps, in a rather than usual earnest strain, was explaining the situation.

After hearty greetings were exchanged Jinks turned to Bumps and continuing said:

"By the way I don't get my bearings exactly, most every one whom I hear say anything about it says the Ministers is pretty good fellows, and the Government has 'parently done things on the square an' there has been big improvements made and all that, an' yet a good many talks agin them an' says there ought to be a change. I don't size it up somewhat. What's the matter?"

"Well," says Bumps, "it seems kinder strange. But there's always reasons for things. Of course, there is some who is not satisfied because they have not made as much out of it as they expected, some heads is sore, and others think they could run the thing a good deal better themselves."

"Of course there is lots of unreasonable men to be found everywhere, but Jinks," it seems to me that there is some reasons as has not bin spoken of much which may help to 'count for some of the talk yer hear."

"Well," what is it Bumps, I'm not here as much as you is, and don't git tye hang of these things anyhow."

"I'll tell yer, Jinks, besides personal reasons individuals have, there's a good many folks talks that way 'cause they doesn't know enough about what's goin' on in the Government. You see the business is a kinder close corporation concern. Formerly the old man and the Ministers jess everlastingly owned the hull thing and run it to suit themselves, an' that led to the fuss they had two years ago. There has been a good deal of change in this respect' but there's some left. The old man don't own much now but the Ministers does. There's something funny 'bout Government business that changes feller's ideas. When a feller's whoopin' it up to get hisself elected, or ter git some other feller out, he jess opens his soul ter ther 'dear people,' (es they calls them) and tells 'em as how the Ministers and all folks in office is only their servants, and they, the dear people, is the owners; an' the light of public scorking in the weight of their 'spisibilities and they shun up like clam shells an' folks outside don't know much about it than they did before. Now it 'pears to me that's just one big cause of the bile in the public stomick."

"But, Bumps," said Jinks, "I thought these fellers that's been running the thing the last two years had been doin' different, an' besides lots of public works had been carried on an' there had been a great change for the better."

"That's so, Jinks," replied Bumps, "but human nature is human nature, an' there's alluz a tendency in folks to feel how important an' necessary they is. An' there's something in natur' that when big power is given to a feller after a little he begins ter think he's the only feller that ken do the job. An' the nex' thing is ter become secret an' mysterious. The old man was prepared for the shipping articles they calls the "constitution" in Ameriky understood human natur', an' special the kind that comes out under the high livin' of office, or livin' of high office, they fixed it different. Among other things they had it so that the crew was shipped for short voyages. At the end of the voyage the hull gang could be shipped over again if the owners chose, but they had to ship new each time. An' then they had it fixed so that the owners knew what was going on."

"But I thought, Bumps, that when they took the ship into dock here two years ago and patched her up they kinder fixed the thing an' made her over after the Amerikin model."

"Well, they did, Bumps, after a fashion, but the frame of the critter wasn't changed much. They couldn't do that without taking her all ter pieces. They made big changes in her rig an' made her easier to handle and sail better, but the model wasn't changed much. Now these fellers who hev been sailing her the last two years has done fust rate in the main but there's fault in the system. The thing may be making a good voyage but somehow the durned owners don't know about it."

"I tell yer, Jinks, I believe that a good deal of the growling you hear is jess because the owners hasn't been kept informed enough about what's going on, for they that knows as she's been handled fust class and has been making the best voyage she ever made." You see the Ministers stay right in their offices and don't go about the country to see the owners or to see what's needed or to explain nothing. How would it work to have the cap'n and officers of a ship shut up in the cabin all the time and send all their orders and git their information by letters? Now that feller in the Interior Office has been around two or three times an' it's done lots of good to him and to the people. There's something wrong in the sailing orders, or in the management somehow, when the chief officers has to spend all their time shut up doing clerk's work."

"Now, in the edification department there's a different arrangement; they have an inspecting officer who keeps goin' around to see how things is. They've got a big, good lookin' feller for inspector, an' the fact that the teachers knows he's coming around has a powerful effect. In that department things is kept trim and shipshape, an' you hear precious little growling."

Christmas Festivities—School Exercises, Etc.

Pleasant weather, good roads, the advent of Christmas and its attendant gayeties, all combine to make people happy.

On Thursday evening a crowd of Japanese, 123 in all, assembled by invitation, at the residence of the Hon. W. H. Rice. The verandas were decorated with the Hawaiian and Japanese flags, and gayly-colored lanterns swung from arches made of palm branches. The Japs came from Lihue, Grove farm and Hanalei, and brought with them, in quantities, coffee, bread and butter and cakes were served, and they enjoyed the role food immensely. After the repast was finished, they were invited into the parlors where they inspected the furniture, ornaments, paintings and other things, with the greatest curiosity. But what impressed them most was the piano, which was open. Many were the glances cast upon the keys and the case, and at Mrs. Rice's request, Mrs. Altman played for them. At the first sounds from the instrument they seemed almost spell-bound, and slowly they came closer and closer to watch the keys as they rose and fell. It was as though a revelation had come to them. A few, bolder than the rest, went close to the piano, then stooping on the floor looked under the instrument to see what produced the sound. One young fellow pressed a key gently with his forefinger, and when he heard the sound which he had caught, he smiled and held his hand away as though it had been burned. It was very amusing to those who were looking on. The Rev. Mr. Haasura addressed them in Japanese, telling them that Mr. and Mrs. Rice were giving them this pleasant evening to show them that there were people in this world who, though so far above them in station, thought enough of them to invite them into their houses, and who were willing to help them. In eloquent words he besought them to turn to God, to abjure their false religion, and to walk in the right path. A collection was then taken up, either to send to the Japanese association in Honolulu, or to be the foundation of a similar benevolent association on Kauai. After this a handsome Christmas card was given to each person present, as a souvenir of the occasion, and then the happy laborers proceeded to the Y. M. C. A. rooms where they were treated to a series of magic lantern views. Many said that it was the happiest evening in their lives.

On Friday morning the private school taught by Miss Hattie Needham had its closing exercises. The children were examined in reading, writing, arithmetic, grammar, spelling, geography and history, and their answers showed a thorough instruction they had received. Hawaiian history and geography were a specialty in these recitations. After the examination, the children sang songs, read original compositions and recited pretty selections. The composition "Thanksgiving Day," by Grace Altman, a description of the day, as depicted by her in Lihue, was well written. Miss Elsie Wilcox wrote and read a pretty story entitled, "One Christmas," with much spirit and expression. A cute little piece "First Speaking Day at School," was well rendered by Miss Mary Rice. The younger children acquitted themselves well, and the visitors departed much pleased by what they had seen and heard.

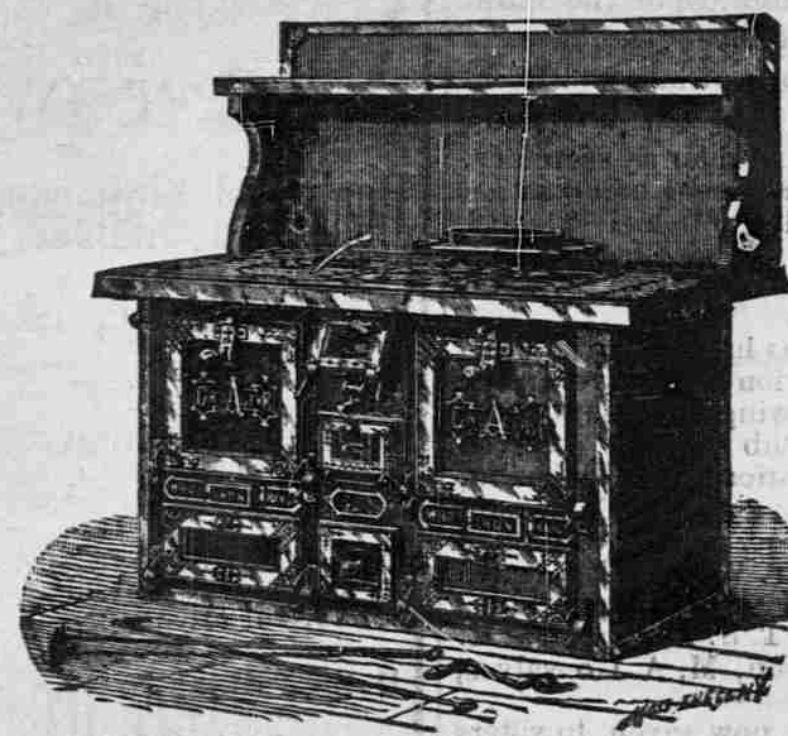

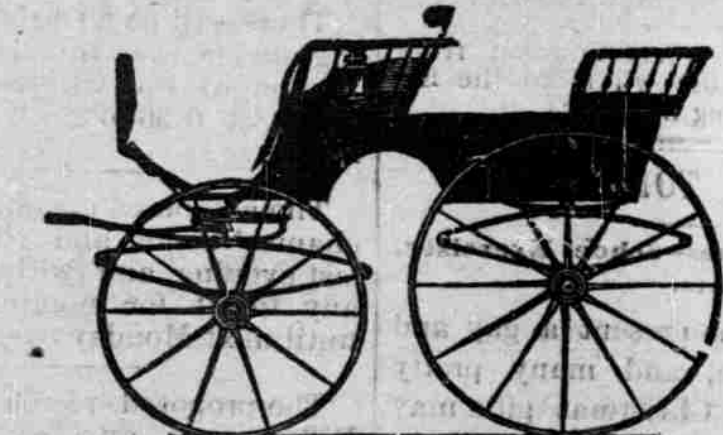
