FIRST TRUST TERRITORY GROUP LIFE INSURANCE CLAIM PAID

(Press Release, TTPI, Nov. 14)...The first Trust Territory Group Life Insurance claim was paid today to Mrs. Francisca Igisaiar Kileleman, mother and beneficiary of Joaquin Igisaiar Kileleman, who was killed in an automobile accident on October 16. The policy insuring the life of the 23 year old District Education Department employee had been in effect for 23 days.

In the Office of the High Commissioner, Mrs. Kileleman received a check for \$2,000 from Mike Flaharty, District Manager of National Fidelity Insurance Company, Guam. Also present were Acting Deputy High Commissioner Robert K. Shoecraft, Marianas District Administrator Peter T. Coleman, District Land Title Officer Elias P. Sablan, Woodrow W. Carpand, General Agent for National Fidelity Insurance Company, and Jack Webb, Trust Territory Personnel Specialist.

The \$2,000 was a double indemnity payment for accidental death on a \$1,000 Trust Territory Group Life Insurance policy.

Mr. Kileleman had been employed by the Trust Territory Government since February 1960.

TURNOVER OF PETROLEUM OPERATIONS TO MOBIL OIL COMPLETE

(Press Release, TTPI, Nov. 14)...Receipt of a check in the amount of \$402,940.79 from Mobil Oil of Micronesia, Inc., was announced today by Mr. R.K. Shoecraft, Acting Deputy High Commissioner of the Trust Territory Government. This amount is in payment for the inventory of all petroleum products of the Government purchased by Mobil at Saipan and in the other five districts of the Trust Territory in accordance with the agreement between Mobil and the Government.

This is considered to be the largest known single purchase of its kind within the history of the Territory.

The turn-over of all petroleum operations of the Government has now been completed, and negotiations have been progressing for some time in the leasing of both current sites and facilities as well as in the selection of permanent sites in some districts for the construction of new bulk plant facilities.

The Headquarters for Mobil, under the direction of Mr. John Pilshaw, Manager, has now been formally established in Saipan. Branch offices have been established in each of the district centers.

PONAPE DISTRICT LEGISLATURE ADJOURNS

The Sixth Regular Session of the Ponape District Legislature which convened on November 14, 1966, completed its deliberation and adjourned on November 23. The greater part of the session was devoted to re-consideration of the Acts passed and disapproved during the Fifth Regular Session by the High Commissioner.

There were eight measures introduced during the session but only seven cleared the floor before the adjournment. Five of the measures were bills relating to control of alcoholic beverages in Ponape District; family allowance for students studying outside of the Trust Territory; revision of the dangerous weapon law; up-grading the Legislative Clerk and District Treasurer to C-1 and C-2, respectively; and prohibiting the voluntary introduction of life endangering mammals, reptiles and insects into Ponape District. The two resolutions passed requested the District Administrator to find ways and means to revise and/or codify the District Laws and to expedite the implementation of Public Law 43-65 relating to the erection of reef markers.

The District Administrator, District Land Title Officer, and Acting District Agriculturist were among the persons called by the Legislature to give testimonies and information during the session.
