Earthquake hit at worst time for Guam tourism

AGANA, Guam (AP) - The earthquake that rocked Guam Sunday evening hit at the worst possible time for the tourism industry, according to island tourism executives.

"August is the second peak season to travel here from Japan," said Mikio Maruyama, public relations manager of PMT Guam Corp., a subsidiary of the Japan Travel Bureau and the largest inbound tour agency on Guam.

"We charge a premium price because so many people want to come at this time. So obviously this is bad for us," Maruyama said.

The agency had planned to bring in nearly 13,500 people from Japan this month. But PMT has cancelled all incoming tours until at least Thursday and most likely until Monday, when it will reassess the situation, Maruyama said.

Aki Shinjo, customer service manager at R&C Tours, the second largest inbound tour agency, said his company has cancelled all tours from Japan until Sunday. The company had planned to bring in about 9,500 tourists from Japan this month.

The island's tourist industry caters mostly to Japanese vacationers.

Peter P. Ada III, chairman of the Guam Visitors Bureau board of Directors, said most hotels were 85-100 percent occupied when the quake measuring 8.1 on the Richter scale struck.

Several hotels have closed, and more closures are expected next week, Ada said.

Five hotels sustained serious damage and most likely will have to be torn down, according to government officials.

Hideo Kobayashi, president of the Japan-Guam Travel Association, said the main concern is to get utilities back on line.

He also is looking at long-term effects of the quake on tourism.

Guam tourism officials can't simply go to Japan and say their island has recovered, Kobayashi said.

"To get our point across we have to be able to say there have been improvements to the tourism infrastructure," he said.

While many Japanese visitors left for home after the quake, others finished their vacations on Saipan.

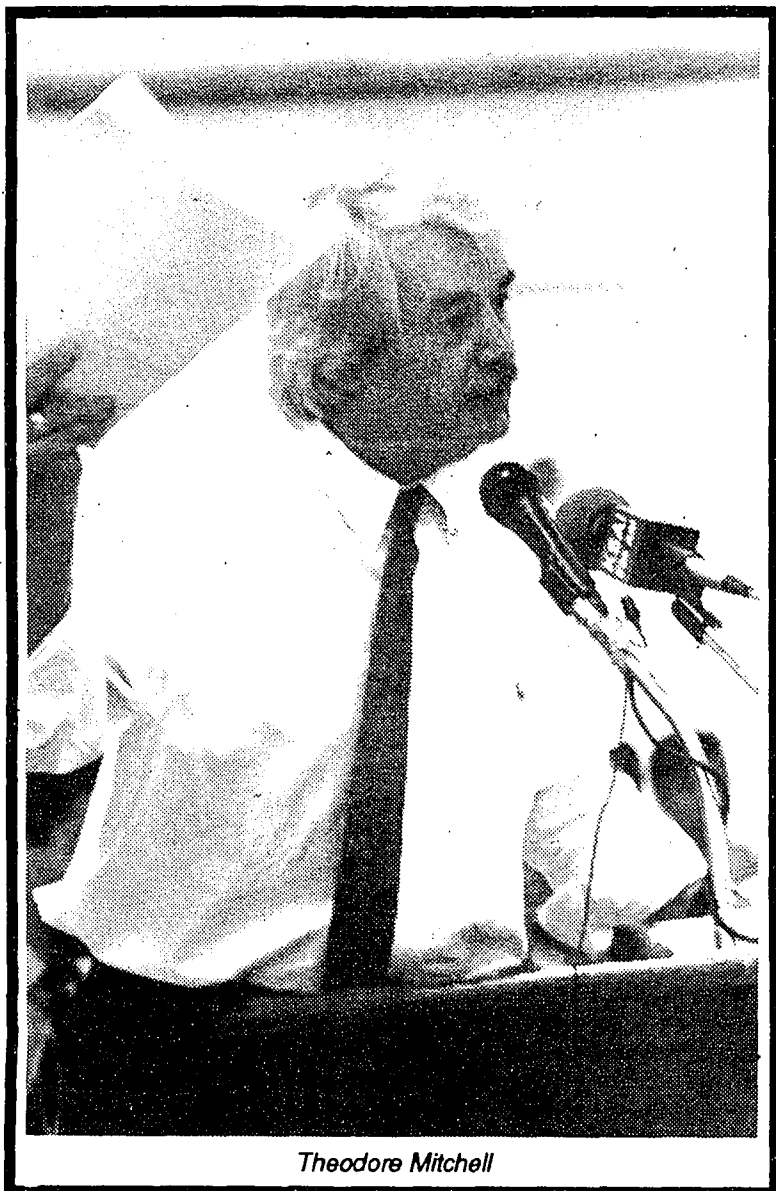

Manglona denies wetland violations

THE GOVERNMENT yesterday denied that it bulldozed wetlands at the American Memorial Park in violation of federal law.

In a letter to John Lawrence, staff director of the US House Committee on Natural Resources, Lt. Governor Benjamin T. Manglona said the government took all the necessary precautions to make sure wetlands in the site are protected as it prepares for the 50th anniversary of the Marianas campaign during World War II.

"We know full well that it is against federal laws and regulations to clear wetlands and we wish to abide by that law," he said. "However, within the park we have no well-defined boundary for its wetlands, but still, we believe we have not affected the wetlands themselves. If at all, the disturbance is negligible."

The Governor's American Memorial Park Committee which Manglona chairs is presently doing beautification work in the park, including the construction of a monument.

Manglona's letter to Lawrence was in reaction to an accusation by Brian Henry, National Park Service (NPS) area director in Honolulu, that the CNMI bull-

dozed wetlands in ongoing efforts to beautify the area for the anniversary.

The Clean Water Act prohibits dredging and filling of wetlands unless a written permission is obtained from the US Army Corps of Engineers.

Wetlands are water-based land areas which serve as habitat to marine life and other water-reliant greenery.

The NPS claim was brought to the attention of the Natural Resources Committee chaired by Rep. George Miller, prompting an inquiry from committee staff member Lori Sonken who in turn, sought an explanation from the local government.

According to Manglona, even before the clearing work started, local regulatory agencies delineated wetland and non-wetland areas.

The determination basically relied on the are topography, and on the judgment of the agencies like Fish and Wildlife, Coastal Resources Management, Historic Preservation Office and the Division of Environmental Quality.

"This was done to avoid any damage to the wetlands. We have made sure that all land clearing

and bulldozing activities have taken place outside of the flagged areas. None of it has been in the wetlands proper," Manglona said.

While utmost care was taken to ensure wetlands were not touched during the project, there may have been instances that some land and vegetation have fallen into such low-lying areas, though unintentionally, Manglona said.

"Sometimes when you clear up an area, it is very difficult to contain debris, soil or vegetation from falling in. But we have made it a point to clear up the mess at once," he said in an interview yesterday.

He said the reports of violations might have been a communication problem between the local and federal agencies involved, as there had been no notices of violations sent yet.

"It is very disturbing that instead of calling our attention about the presence of those wetlands in the clearing area, some people may have grabbed the phone and reported us to the NPS," Manglona said.

We honestly believe we have acted within the proper guidelines because we are very concerned about our wetlands and its preservation." (RHA)

Governor urges US to stop benefits to illegal immigrants

SAN CLEMENTE, Calif. (AP) - The United States should stop rewarding illegal immigrants with welfare benefits, health care and education at the expense of American citizens, California Gov. Pete Wilson said Tuesday.

Rejecting cries from civil libertarians who call his plan un-American, the Republican governor in recent days has crusaded against illegal immigration in a series of stops across the state.

He also published his opinions

in an open letter to Clinton on Tuesday in full-page advertisements in the West Coast editions of The New York Times and USA Today and in The Washington Times.

In the most controversial part of his plan, Wilson calls for the federal government to deny citizenship to US-born children of illegal immigrants, an idea that runs in direct conflict with the US Constitution.

Wilson's battle cry: citizens of other countries are robbing the state of \$2.3 billion each year in

services that could be used to help legal residents.

"We are compelled to cut aid to the needy, blind, disabled and elderly in California in order to comply with federal mandates to provide services to illegal immigrants," Wilson said at a press conference at the San Clemente checkpoint of the US Border Patrol.

States that offer generous benefits to residents, such as California, Florida and Illinois, have become magnets for illegal aliens, the governor claimed.

against the wall by Grizzard's companion. "At the same time, he took a strong grip on my windpipe, just around my Adam's apple and began choking me," Mitchell said. "He choked my throat for

some time. The pain was intense and I began to panic. I know that a person can be killed by crushing the windpipe and I was afraid that this assailant was going to kill me."

Just when Mitchell succeeded in

forcing his assailant to release his grip, Mitchell said he saw Grizzard rushing toward him. "He was moving fast and he was coming straight at me in a threatening manner," Mitchell said.

"When Grizzard lunged at me, I placed my two hands on his chest and pushed him straight back, away from me," Mitchell said.

He said Grizzard lost his footing and fell down on the floor. According to the police, Grizzard hit his head on a cigarette vending machine. People gathered around him and Mitchell said he heard someone asking for an ambulance.

"I never had any intention of harming Mr. Grizzard," Mitchell said. "I had just freed myself from the grip of the man who was choking me. My only intention was to defend myself against Grizzard..."

Asian news briefs

Military chief visits Russia

MOSCOW (AP) - China's military chief of staff has begun an official visit to Russia to discuss increasing military and technical cooperation between the former archenemies.

Col.-Gen. Zhang Wannian was expected to meet Wednesday with Russian Deputy Defense Minister Andrei Kokoshin and Russian chief of staff Col.-Gen. Mikhail Kolesnikov, the ITAR-Tass news agency said.

Once-hostile relations between the two countries have been thawing over the past decade, and Zhang is the highest ranking Chinese military officer to visit Russia.

Gen. Liu Huaqing, however, who as vice chairman of the Communist Party Central Military Commission is more powerful than Zhang, visited Moscow in June.

Russia has sold \$1.8 billion of arms to China, including 26 Su-27 fighters, Foreign Ministry spokesman Grigory Karasin told a news conference on Tuesday.

Zhang arrived in Moscow late Monday and on Tuesday visited the Kubinka Air Force Garrison outside Moscow, where he watched Russian pilots perform stunts at a special airshow, ITAR-Tass said.

The Chinese delegation is scheduled to visit a cosmonaut training center and the Motorized Infantry Brigade of the Moscow military district, ITAR-Tass said. The delegation also will visit the Russian cities of Volgograd and St. Petersburg before returning to China next Tuesday, the report said.

Kokoshin led a delegation of Russian defense officials to China in October.

Air China hijacker gives up

TAIPEI, Taiwan (AP) - A Chinese man who threatened to pour acid over passengers on an Air China jet unless he was flown to Taiwan gave himself up on arrival in Taipei today. None of the roughly 150 people on board was hurt.

The hijacker, a 30-year-old businessman, said he would rather die in a free country than live under Communism. He was arrested and faced trial in Taiwan, where hijacking carries a death penalty not likely to be imposed on a Chinese defector.

The airplane and its other passengers and crew returned to China 24 hours after landing at Taipei International Airport, police said. There were 25 foreigners aboard, but police did not know their nationalities.

Seoul warns Pyongyang

SEOUL, South Korea (AP) - South Korea told rival North Korea today it would risk punitive measures if it did not act immediately to resolve suspicions about nuclear facilities believed storing weapons-grade material.

The South had proposed that the two sides meet to reactivate an inter-Korean nuclear control commission intended to watch over their nuclear arms ban treaty.

The Communist North rejected the proposal, insisting instead on an exchange of special envoys to discuss the two Koreas' first-ever summit meeting. This would speed the way to solving other issues, including the nuclear dispute, it said. South Korea wants the nuclear issue solved first.

Hyundai workers reject offer

SEOUL, South Korea (AP) - Militant workers at a Hyundai furniture company, reversing their earlier decision, voted down today a management offer of a 4.7 percent pay raise and other benefits.

The management of Hyundai Wood Industries Co. immediately declared the vote void because workers already had voted to accept the contract a week ago.

The move by Hyundai furniture workers cast doubt on efforts by the giant Hyundai group to end seven-week-old labor disputes at two other subsidiaries any time soon.

Rebel lawmakers form party

TAIPEI, Taiwan (AP) - Six maverick legislators formed a new political party today in the first major split in the governing Nationalist Party since it moved to Taiwan from mainland China in 1949.

The formation of the New Party was a big blow to the unity of the Nationalists, or Kuomintang, ahead of their party congress next Monday.

Legislator Jaw Shau-kong, leader of the rebellious legislators, said they established the New Party because the Nationalists have become a corrupt party obsessed with money politics.

Death toll from blast rises

BEIJING (AP) - The death toll climbed to 13 from last week's explosions in a Shenzhen inflammable goods warehouse, the official People's Daily said today.

The newspaper said six other people remained in critical condition in hospitals five days after the massive blasts, which knocked out windows several miles (kilometers) away and forced the evacuation of 150,000 residents.

The state-run Xinhua News Agency said the evacuees began returning to their homes Tuesday and factories in the area that had been shut down were preparing to resume operations.

House starts budget work

THE HOUSE of Representatives have started preparing a new budget bill for fiscal year 1993.

Speaker Thomas P. Villagomez said in an interview Tuesday that the House Ways and Means Committee would finalize the budget package in two days.

"The House has been asked to redraft the budget only late last week," he said. "Since then we have made the necessary revisions but still we found out we need more time, perhaps a couple of days more. We cannot just introduce something that is not acceptable."

A conference committee, earlier failed to come up with a compromise budget.

There were differences on how the previous year's estimated \$6.3 million in unused lapsed funds would be used to cure a \$7.2 million deficit incurred in that same year.

The House said that the entire lapsed amount should be used to

retire the shortfall to lessen the impact of the current fiscal year's anticipated deficit. The Senate wanted to limit the amount to 50 percent.

The conference committee decided to just let the House draft a new budget package.

Ways and Means Chairman Pete P. Reyes called all committee members into a meeting Tuesday to gather input on the latest budget measure.

In the past, the task of putting together a budget appropriation act has been done mainly by the chairman himself.

"This time I am trying to get all members' participation so that we would not have trouble getting support on the measure when it reaches the House floor," Reyes said.

Villagomez, on the other hand, said the agreed version reached during the meeting Tuesday would lead to a budget that is more acceptable than House Bill 8-226, the bill

Productivity of US workers falls

WASHINGTON (AP) - The productivity of US workers fell at a 2.5 percent annual rate from April through June, the largest decline in more than four years, the government said Tuesday.

The Labor Department said the seasonally adjusted drop in productivity - defined as output per number of hours worked - marked the first back-to-back quarterly declines in more than two years.

It was the largest drop since productivity fell 3.9 percent in the first

quarter of 1989 and followed a 1.6 percent fall from January through March.

They were the first consecutive quarterly declines since productivity decreased in the final two quarters of 1990 and the first three months of 1991.

Economists maintain that increased productivity is essential for improved living standards and to make US products more competitive in overseas markets.

The report buttressed arguments of some analysts that the recent spurt of productivity following the

recession was related to the economic recovery and did not represent a long-term improvement.

Productivity growth averaged less than 1 percent at an annual rate during the 1970s and 1980s, down sharply from an average annual rate of 2.5 percent during the prior two decades.

But it jumped at a 3.2 percent rate in the final three months of 1992, registering a 2.6 percent annual increase, the best in 20 years. The economy itself grew 2.1 percent in 1992 after declining 1.2 percent a year earlier.

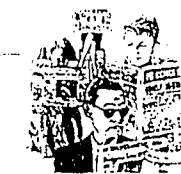

Ruining people considered a sport

WASHINGTON (AP) - Deputy White House counsel Vince Foster committed suicide after writing a note in which he said, "I was not meant for the job or the spotlight of

public life in Washington," officials said Tuesday.

"Here, ruining people is considered sport," Foster said in the note found torn to pieces almost a week after his death July 20. Foster had been a life-long friend of President

Clinton.

US Park Police Chief Robert E. Langston said the condition of the scene, the medical examiner's findings and the information from friends and family about Foster's anxiety and job concerns clearly indicate that he committed suicide.

"Our investigation has found no evidence of foul play," Langston told a Justice Department news conference.

Foster's body was discovered in the Fort Marcy National Park in nearby Virginia. He died of a single gunshot wound that entered the mouth and tore through his brain, Langston said.

Said FBI agent-in-charge Robert Bryant: "What we have here is a great, sad tragedy in our commu-

nity."

The FBI investigated why the White House waited 30 hours after finding the note fragments July 26 before turning them over to the Park Police. Bryant said it was determined that White House concerns about letting Foster's family and President Clinton see them first were reasonable.

It was not known exactly when Foster wrote the note, said Langston. Foster's wife, Lisa, had told him 1 1/2 weeks before he died of a single gunshot wound to the head that he should write down his concerns, Langston said.

"The public will never believe the innocence of the Clintons and their loyal staff," the note said.

The next line was a direct shot at

the Wall Street Journal, which had targeted Foster in critical editorials: "The WSJ editors lie without consequence."

Robert L. Bartley, Journal editor, said Foster's note "suggests that he was deeply distraught over a variety of issues," and declined comment beyond the Journal's editorial of last Friday.

In that editorial, the Journal wrote, "There is no way to cover national government on the assumption that a high official and steely litigator secretly suffers from depression and may commit suicide if criticized."

Foster's note-written in neat handwriting with no scratch-outs also makes several allegations that are being pursued by the Justice Department.

1 dies in shooting at restaurant

KENOSHA, Wis. (AP) - A man dressed in military fatigues and armed with a pistol opened fire in a McDonald's restaurant Tuesday, killing one person and wounding two others before killing himself, police said.

The motive was not immediately known.

The 26-year-old man walked into

the restaurant around 1:30 p.m., ordered people to leave but then started shooting, Police Capt. Bob Young said.

The man yelled "I want you to clear out," Young said. "But then he began shooting so nobody had time to exit the building."

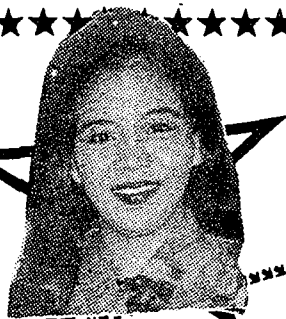
The man was armed with a large-caliber, long-barrel handgun, Young said. He brought an AK-47 assault rifle, but left it near his car in the

restaurant parking lot, Young said.

Several people who fled the restaurant ran to neighboring businesses to call 911.

The gunman killed one person, identified by Young only as a male.

A 42-year-old woman shot in the side was in critical condition after surgery at Kenosha Hospital and Medical Center. An 18-year-old man wounded in the wrist was in stable condition at another hospital.

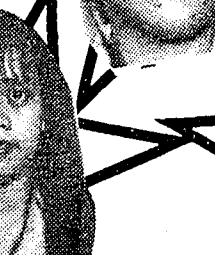
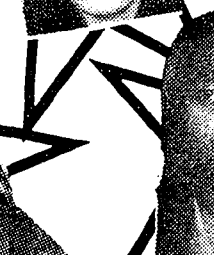
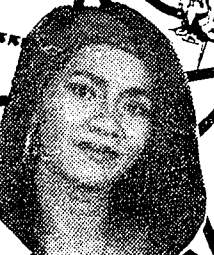

Clinton signs \$496B anti-deficit budget

WASHINGTON (AP) - President Clinton signed his deficit-fighting budget bill into law Tuesday, saying the plan will begin to bring needed change to America.

"After 12 years of trickle-down economics ... we now have real fairness in the tax code," Clinton said in ceremonies on the White House lawn.

"This country has begun to take responsibility for itself," he said. Vice President Al Gore, who cast the tie-breaking vote that allowed the \$496 billion plan to pass the Senate, described the plan as a victory for Clinton and "a victory for people who believe in hard work."

Clinton said it would give 97 percent of small businesses a tax cut, raise taxes on the wealthy and reduce them for the poor.

Democratic Senate and House members in the thin majority that voted for Clinton's package joined his Cabinet on the White House lawn for the signing ceremonies.

Clinton had used a campaign-style rally Monday in Charleston, W. Va., to whip up public support for the huge package of tax increases and spending cuts and to court Republican and dissident Democratic support for a tough legislative agenda ahead.

Health care, welfare reform and

anti-crime legislation are just some of the contentious programs Clinton will try to push through Congress later this year.

"We have got to do some of these things together," Clinton said in an open appeal for "an end to the partisan rancor" in Washington.

Clinton hailed the budget plan as a symbol of change.

"Now there is a new direction in America," the president said.

On Monday, Clinton chided lawmakers who didn't side with him. "None of us were sent to Washington to keep our jobs. We were sent to Washington to help you keep your jobs."

Experts see 2.8% US growth in '94

WASHINGTON (AP) - After speeding up in the second half of 1993, the US economy will slow again next year because of the Clinton administration budget and health-care plans, some top economists believe.

The newsletter Blue Chip Economic Indicators reported Tuesday that the consensus forecast of 51 economists in an early August survey projected economic growth of 2.8 percent in all of 1994.

That would be down from annual growth rates of 3.1 percent projected for the current July-September quarter and 3.3 percent for the final three months of 1993, according to the Sedona, Ariz., publication.

Editor Robert J. Eggert Sr. said many of the economists did not believe the full effects of higher

Dollar climbs; gold prices close mixed

NEW YORK (AP) - The US dollar climbed Tuesday against most major currencies in light but volatile trading marked by continued skittishness toward most European monies.

Gold prices were mixed. On the New York Commodity Exchange, gold for current delivery closed at \$380.90, off \$2.40 from Monday's close. At 4 p.m. EDT, Republic National Bank of New York quoted gold at \$383.25, up \$7.25.

Analysts said the dollar gained as investors bought German marks and sold weaker European currencies.

The move out of most European monies came after the German central bank, the Bundesbank, maintained its lending rate for two-week securities repurchase agreements at a fixed 6.80 percent. Some investors had expected a reduction in the repurchase rate, used by the Bundesbank to influence other rates.

"The actions of the Bundesbank today signaled tighter German rates," said Lisa Finstrom, a senior currency analyst at Smith Barney Shearson brokerage firm. High interest rates increase the value of a currency, since investments denominated in that currency earn more.

Investors sold other European currencies, anticipating they will decline as countries lower their

interest rates now that they are no longer pegged as tightly to the German mark. European Community leaders decided last week to relax the continent's exchange rate system after several currencies came under attack by speculators.

Some investors bought dollars to escape the uncertainty surrounding the European currencies, traders said.

"We think the US is still the safest and best place to be," said Zlatko Glamuzina, chief trader for the New York branch of Banco di Sicilia.

In Tokyo, the dollar closed at 104.47 yen, down 0.11 yen from Monday's close. Later in London, the dollar was quoted at 104.63 yen. In New York, the dollar fell to 104.70 yen from 104.91 Monday.

In London, the British pound

was quoted at \$1.4795, down from \$1.4928 late Monday. Later, in New York, the pound was trading at \$1.4660, cheaper than \$1.4915 a day earlier.

Other dollar rates in New York as of 4 p.m. EDT (2000 GMT), compared to late Monday, included: 1.7170 German marks, up from 1.6970; 1.5265 Swiss francs, up from 1.5023; 6.0385 French francs, up from 5.9540; 1,615.60 Italian lire, down from 1,616.00 Italian lire; and 1.2930 Canadian dollars, up from 1.2920.

Jury clears American Airlines in fare cut case

GALVESTON, Texas (AP) - A federal court jury Tuesday found Continental and Northwest airlines were not intentionally damaged by American Airlines last summer when the nation's largest carrier slashed fares.

After less than three hours of deliberations, jurors failed to get past the first question in a six-part test devised by US District Judge Samuel Kent to help them reach a verdict.

The question was whether American Airlines intended to monopolize "relevant markets" with its value pricing plan last summer.

Plaintiffs Northwest and Con-

tinental airlines contended that a relevant market can be any of several airport hubs, while American said the term refers only to the national airline market.

Northwest and Continental had sought \$1 billion in damages. Since awards can be tripled in antitrust cases, American could have faced \$3 billion in penalties.

The plaintiffs contended American's value pricing plan, which slashed unrestricted fares 40 percent, was designed to drive them out of business. American said it merely tried to simplify fares and generate profits.

Kent told jurors they had to be convinced only that American made an attempt to monopolize markets, not that it was success-

ful.

All three airlines lodged immediate objections over the questionnaire with the judge in anticipation of appeals.

Northwest attorney Joe Jamail said the form should have included only two questions: whether American violated the law and a recommendation on damages. American also disputed the form's wording.

American introduced the value pricing plan in April 1992. It shunned special offers and gimmicks that have been prevalent in the industry and allowed only four tiers of fares, based on the level of service and how far in advance the tickets were bought.

gasoline and personal income tax increases in the Clinton budget package would be felt until next year, thus permitting faster growth in the last six months of 1993.

"Several also said fears of still higher taxes to pay for the Clinton administration's plans to expand medical coverage to those now uninsured will add to uncertainty next year in the business community, hampering business spending and hiring," Eggert wrote.

President Clinton, who signed the budget bill Tuesday, has not yet submitted his health-care proposals.

The survey found 36 of the 51 analysts had lowered their 1993 economic forecast since the July poll. The latest consensus forecast projected economic growth of 2.5 percent, down 0.1 percentage point a month earlier.

As recently as April, the Blue Chip economists had predicted the economy would expand by 3.3 percent this year.

The Clinton administration also is lowering its growth forecast for the gross domestic product this year, according to Laura D'Andrea Tyson, chairman of the White House Council of Economic Advisers. The GDP is the total output of goods and services in the United States.

Although the administration also is looking for a significant pickup in economic activity in the second half of the year, Tyson told reporters last week it would shave its GDP forecast to 2.1 percent, from 3.1 percent earlier in the year.

"Now 28 months old, the current economic recovery is the slowest in post-World War II history," Eggert said.

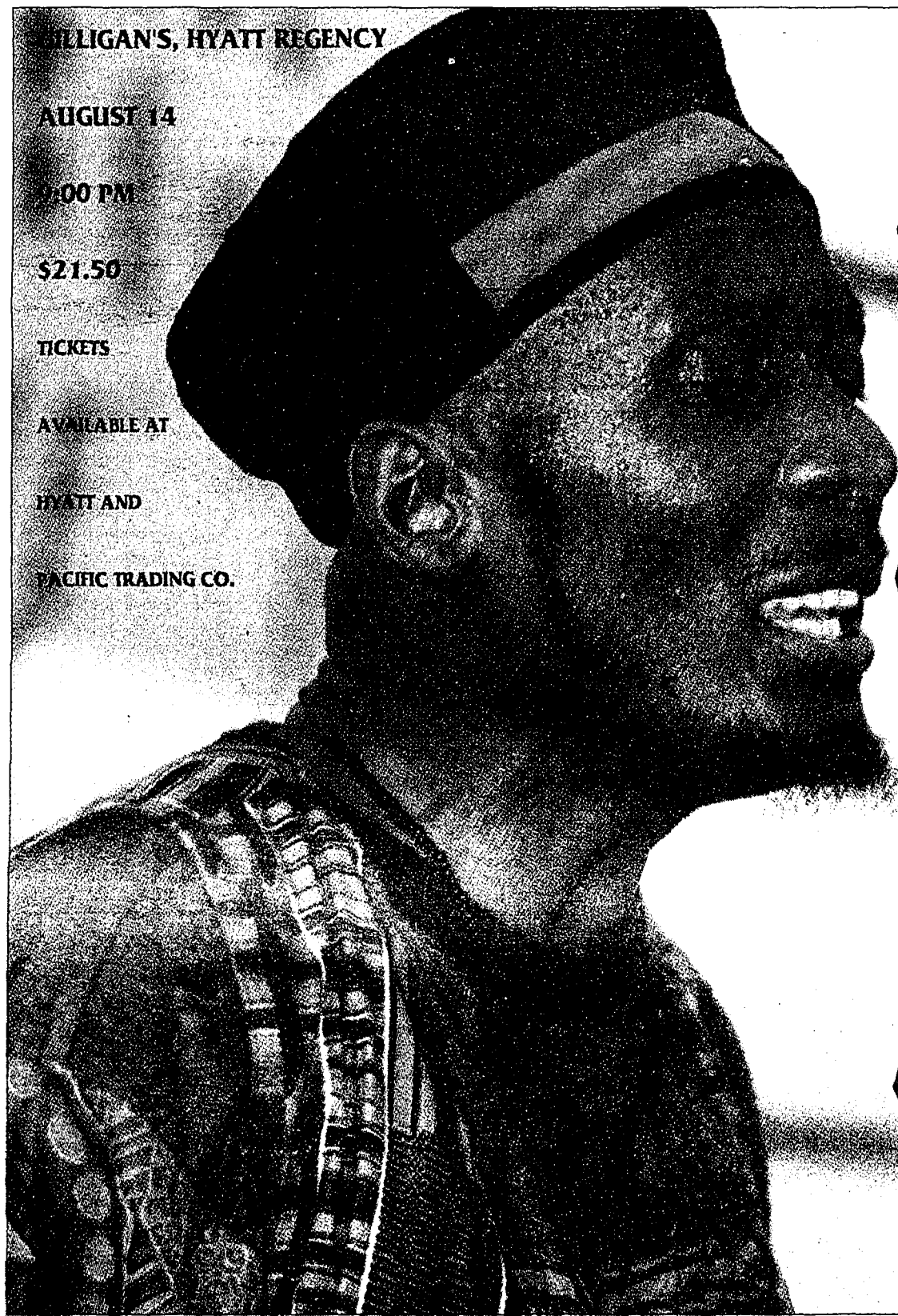

Profit-taking sends HK share prices down

HONG KONG (AP) - Asian stock markets closed generally higher Tuesday, but share prices plunged in Hong Kong on profit-taking.

The Hang Seng Index, the Hong Kong market's key indicator of blue chips, fell 52.41 points, or 0.7 percent, closing at 7,329.81.

Brokers attributed the plunge to profit-taking following the sharp rallies of the past two weeks, when the index gained almost 10 percent because of a buying spree in blue chips.

On the Tokyo Stock Exchange, the two major indexes closed nearly unchanged in light trading.

The 225-issue Nikkei Stock Average gained 0.70 points, closing at 20,493.75. On Monday, it had climbed 135.11 points, or 0.66 percent, closing at 20,493.05.

The Nikkei was up 110 points early in the session, but lost most of its gains in the afternoon on selling by institutional investors discouraged by receding prospects for a tax cut.

New Prime Minister Morihiro Hosokawa told an afternoon news conference that it is not the time for the government to think about an income tax cut, since the nation's sluggish economy has cut into government revenues.

The Tokyo Stock Price Index of all issues listed on the first section was up 2.21 points, or 0.13 percent, to 1,661.22.

Taipei: Share prices closed little changed in modest trading. The market's weighted index rose 0.58 point, closing at 4,093.31, after Monday's 66.09-point gain.

Sydney: Australian share prices closed higher following a firmer gold price, a rise in US shares and strong interest in industrial issues. The All-Ordinaries index of share prices rose 16.1 points to 1,860.4. Wellington: Share prices finished nearly unchanged in busy trading after widespread advances in medium-size company stocks were offset by declines in selected blue chips. The NZSE-40 Capital Index rose 0.33 points to 1,903.97.

Singapore: Share prices closed higher in reaction to favorable data about Singapore's economy. The 30-stock Straits Times Industrials Index rose 27.59 points to 1,898.84.

Kuala Lumpur: Malaysian share prices closed narrowly mixed in moderate trading as the market continued to mark time in the wake of its recent rally. The Kuala Lumpur Stock Exchange Composite Index rose 0.73 point to 780.60.

Manila: Share prices closed higher in heavy trading. The Manila composite index of 30 selected issues rose 18.40 points to 1,734.19 following Monday's 18-point slump.

Seoul: Share prices closed higher in active trading, snapping a three-day losing streak. The Korea Composite Stock Price Index rose 9.85 points to 719.44.

Bangkok: Thai share prices closed higher in moderate trading. The Stock Exchange of Thailand index rose 2.32 points.

New York market end mixed

NEW YORK (AP) - Stocks ended mixed Tuesday after being down slightly most of the day, as investors took profits from Monday's record highs and waited for inflation news later this week.

The trading is typical of this year's market, which has seen several new highs - followed by drops - on the way to even more gains, said Eugene Peroni, director of technical research at Janney Montgomery Scott Inc. brokerage firm in Philadelphia.

"It's very normal, minimal profit taking. The market is allowing these brief opportunities

for buyers to come on board," he said. "This should help to preserve the uptrend, at least over the short term."

Friday's passage of the budget plan pushed investors Monday to new heights of optimism for continued low interest rates and economic growth. Low rates can boost the economy and improve corporate profits by stabilizing the cost of doing business. They also help stock prices as investors shun low-paying money market investments and switch to equities.

Investors will be watching for

any signs of renewed price increases in the wholesale and retail inflation statistics for July due out Thursday and Friday, said Ray Dalio, president of Bridgewater Associates, an investment management firm in Wilton, Conn.

Retail stocks were mostly down following some disappointing earnings reports. The Dow Jones industrial average dropped 3.35 points to 3,572.73.

Advancing issues were slightly ahead of those declining on the New York Stock Exchange, with 1,002 up, 804 down and 649 unchanged.

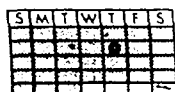

The quality of mercy?

In 1868, the infamous Ku Klux Klan formulated its revised constitution, declaring that the organization was to be governed by patriotism, chivalry, humanity and mercy. The southern states were to be the empire of the Klan, with its body of officers, or "ghouls," led by the supreme wizard. The order, of course, was formed to regain white supremacy in the South.

Getting the words right

The earliest preserved dictionary is an Akkadian word list, dating from 600 B.C., from central Mesopotamia. At the same time, the Western-style dictionary was emerging, thanks to the labors of Greek philosophers. They began to analyze speech patterns and language while establishing the roots of syntax and grammar. The Greek language itself was already in transition from its archaic origins to its classical beginnings.

The toast of Beantown

On Oct. 28, 1636, Harvard College was founded by an act of the General Court of Massachusetts. Its entrance requirements were the following: "When any scholar is able to understand Tully or such like classical author extempore, and make and speak true Latin in prose ... and decline perfectly the paradigms of nouns and verbs in the Greek tongue, let him then and not before, be capable of admission into the college."

Sacrificial rites

Thomas Jefferson was assigned the task of drafting the Declaration of Independence, which he worked on in Philadelphia. A total of 86 changes were made, which eliminated 480 original words and left 1,337.

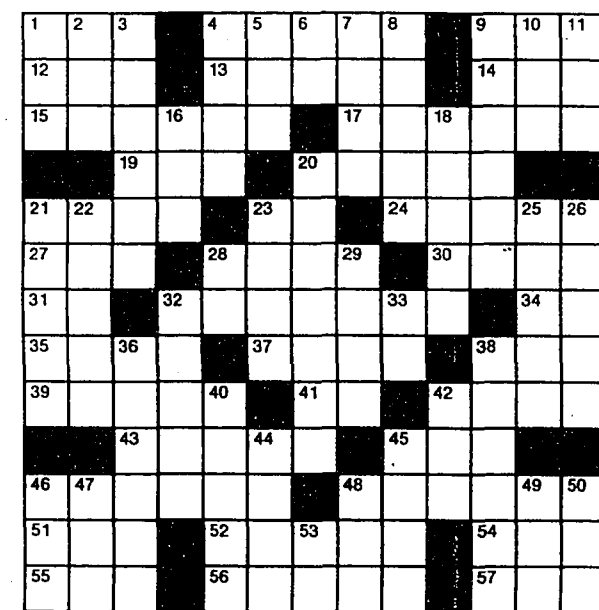

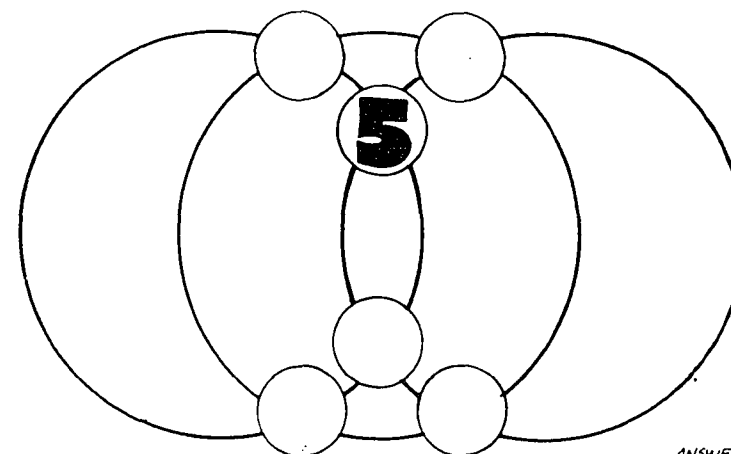
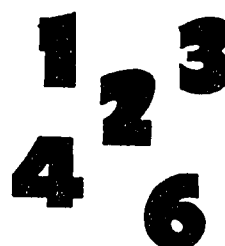

to quit. X-rays found no major injury.

"If I cannot serve or hit a forehand, it's no fun to play," he said. Only one player made an unexpectedly abrupt exit Monday - Canadian Open champion Mikael Pernfors, who isn't handling his celebrity well.

Pernfors became comfortable with anonymity during his three-year comeback from Achilles tendon surgery. His win in Montreal changed things dramatically.

"I probably don't sign more autographs. It's just that people recognize me when I sign them," he said.

Pernfors didn't do much to get recognition Monday, losing to 15th-seeded MaliVai Washington in the first round, 6-4, 6-2.

Pernfors was hoping to build on the momentum from his big win in Montreal, where he knocked off Jim Courier, Alexander Volkov, Petr Korda and Todd Martin to win \$235,000 - more money than he had earned in the last 3 1/2 years. But the

hullabaloo was still spinning in his head, taking the edge off his game.

"I still had a little bit of trouble concentrating," he said. "I was thinking about what happened two weeks ago."

It showed in his serve and in the rallies. The 30-year-old Swede tried to force things and wound up getting himself in trouble.

"I think I lost my patience before he did," Pernfors said. "He served real well, and I served terrible."

Washington, who has been erratic this year, was a little tougher on the tough points.

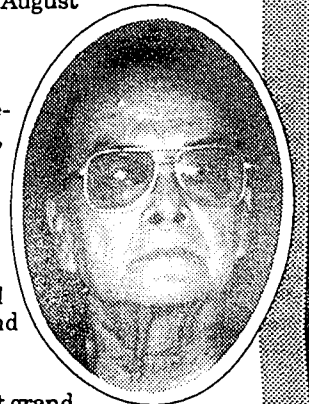

Cincinnati loses to San Francisco

BILL Swift won his seventh straight start and joined teammate John Burkett as the National League's only 17-game winners as San Francisco at home beat Cincinnati 2-1 Tuesday.

Robby Thompson went 3-for-4 with a homer and a triple, and scored both San Francisco runs.

Swift (17-5), who beat Cincinnati for the third time this season, shut down the Reds on two hits in eight innings. He allowed only one hit before Kevin Mitchell drilled a 436-foot homer, his 17th of the season, in the seventh.

guay 6-1, 6-0; Liz Smylie of Australia eliminated Jolene Watanabe 6-0, 6-3; Natalia Baudone of Italy outlasted Maria Jose Gaidano of Argentina 6-2, 3-6, 6-3, and Elena Likhovtseva of Kazakhstan topped Louise Field of Australia 6-4, 6-2.

Agassi drops Martin in ATP Championship

MASON, Ohio (AP) - Andre Agassi finally figured out Todd Martin, using precise passing shots to undercut his net game during a three-set victory today in the first round of the ATP Championship.

Agassi had lost his two matches this year against Martin, a fast-improving player from Lansing, Mich. Martin has jumped from No. 87 to his current ranking, a career-high 14, by improving his serve-and-volley game.

Martin's serve produced 23

aces, but Agassi broke it to go up 4-2 in the final set. The unseeded Agassi served out a 6-3, 6-7 (7-2), 6-3 win over the tournament's 11th seed.

The \$1.65 million tournament lost another seeded player today when No. 9 Goran Ivanisevic of Croatia retired in the second set with a sore forearm.

Ivanisevic felt a little pain in the left forearm during practice Monday. It intensified today, interfering with his serve and forehand. He trailed Luis Mattar of Brazil 6-3, 3-1 when he decided

IAAF to admit Yugoslavians

STUTTGART, Germany (AP) - Yugoslavia may be ostracized around the globe, but its athletes continue to gain a backdoor entrance to the world's top sporting events.

The International Amateur Athletic Federation on Tuesday allowed athletes from Yugoslavia, now consisting of only Serbia and Montenegro, into the world championships - but only under strict conditions.

Yugoslavia is under a United Nations embargo as punishment for fomenting the war in Bosnia-Herzegovina, one of the former Yugoslav republics.

Serbia and Montenegro will be treated as individual participants and will not be allowed to carry their flag or any other identification linking them to Belgrade during the 10-day event, which opens Friday.

Yugoslav athletes will wear white uniforms and will march

under the flag of the IAAF.

In Stuttgart, no relay teams will be allowed and if any Yugoslav athlete wins a gold medal, parts of Beethoven's 9th Symphony will be played instead of the national anthem.

Yugoslavia is expected to send a half dozen athletes, who will still need to get visas from German authorities. A Yugoslav delegation was expected to attend Tuesday's IAAF Council meeting but failed to obtain the necessary papers.

The conditions set out by the IAAF resemble those used for the 1992 Olympics in Barcelona.

While Yugoslavia remains the outcast, the other former republics are making their mark. Macedonia's membership is expected to be approved by the IAAF Congress ahead of Saturday's start, allowing its athletes to participate in the world championships.

Slovenia is sending four athletes, Croatia two. It is uncertain whether Bosnia will send a delegation.

On other issues:

The IAAF Council put off any discussion on the case of German sprinter Katrin Krabbe, who is fighting a suspension for doping. The German federation was hoping to clarify her status, but the IAAF is not planning to take up any individual doping cases in Stuttgart.

The Council put forward a proposal to move the IAAF headquarters from London to Monte Carlo. The IAAF has been based in London for more than 40 years. IAAF general secretary Istvan Gyulai said Monte Carlo would be less expensive and would give the federation a juridical status it lacked in London. The proposal still needs approval from the full Congress.

The Congress will discuss a proposal by the German federation for a flexible system of doping penalties, starting with a minimum one-year ban for a first offense. Under current rules, an athlete faces an automatic four-year ban for a first drug violation.
