Salary forces Sasamoto resignation

An unfair salary appropriation for Civil Defense Coordinator Felix Sasamoto has forced him to submit a letter of resignation Monday to Governor Larry I. Guerrero.

Sasamoto's resignation will become 'effective a few days from now, or to be more specific, on July 5.

His resignation is mainly due to an "unfair" salary which he will be getting under the Salary Act, signed last week by the Governor.

The Act calls only for an amount of \$36,000 for the Civil Defense head.

In an interview, he considers such scheme as "a slap in the face", considering that such amount would not give him any raise at all.

Prior to the Act, the coordinator is receiving \$30,000 a year plus a \$6,000 standby default.

With the new law now, he will be given a flat \$36,000 annual rate without anymore standby default.

In his letter to Gov. Guerrero, Sasamoto said the legislature has overlooked the Civil Defense Office as if it is nothing more but a "cosmetic public office with minimal responsibility."

The letter said that Sasamoto feels his "new" salary is "not only humiliating, but also so sickening that I lost all enthusiasm to continue serving this government in providing essential public service."

Moreover, Sasamoto pointed out that he is "not stupid enough" to accept such a very low salary.

According to Sasamoto, he is not the kind of person who begs, but someone who has kept silent for long and has never opened his mouth.

"But now I don't think it is fair," he stressed.

According to him, other direc-

tors and assistants that were also appointed are given higher salaries ranging from \$43,000 and above.

He reiterated that the legislators are not giving him enough encouragement considering the responsibilities he is undertaking. He remains "disgusted and frustrated with the result of their actions."

"But what concerns me most is the person who is going to replace me...the legislature should 'scrutinize and base' salaries on the function of the office the employees are in," he said.

Describing their job as too risky, he claims that the solons only knew of their existence when disaster strikes. "After that no more," he laments.

"We are a life-saving department that does not deal only with search and rescue operations but also with other things."

Sasamoto added that after July

5, he will still be willing to stay for two more weeks to assist the staff momentarily.

Sasamoto mentioned that he

was supposed to have resigned last year, but did continue on to

Teachers walk-out to be investigated

A Board of Education member is asking that a thorough investigation and assessment be held on the real cause and the people behind the recent massive walk-out of more than 500 Public School System (PSS) employees taking part in crippling activity in Saipan's 13 public schools.

In a seven page document which was informally presented to the members of the Board, Anicia Q. Tomokane has presented questions regarding the recent strike and the pressing issues which the Board needs to immediately address the "unrest" in the educational system.

She has also cited the former Commissioner of Education Elizabeth D. Rechebei for the achievements and the improvement she has brought to the PSS during her 15-month term of office.

"I share in the blame as part of the Board, but...some of us are still making every effort to see that the right thing is done to individuals and to the system," Tomokane stated.

Although no specific names were mentioned, Tomokane is asking that the Board include in the investigation several top officials within the educational department who may be implicated in the strike.

Tomokane is questioning the involvement of management level staff who, together with other PSS Central officials, school principals and teachers, were said to have met secretly in hotels at night "to plot the strike."

Tomokane said that the decision to come out with the statement had been a difficult one for her considering that she is a part of the Board.

However, she said that she did it because she wanted to help improve the educational system through a departmentwide change that would see a reorganization from the highest to the lowest ranking officials within the PSS.

The members of the Board were expected to meet with school officials and teachers to get their input and views on the recent strike.

However, it still is not clear whether they have proceeded with the scheduled consultations and what the result of the meetings were.

Rechebei tendered her resignation on the second day of the strike.

Her letter listed four condi-

tions of her resignation which, as of this time, the Board has yet to address.

Among her conditions include that her name be vindicated by a list of the accomplishments that the PSS has achieved during her term of office and that a thorough investigation be conducted on all the "unusual circumstances" that resulted in the strike.

Although the Board has complied with one of Rechebei's condition by making the department's annual report a document which listed her accomplishments, they still have

US will slash CNMI funding

Honolulu (AP) - The U.S. government apparently will slash by nearly 23 percent its operational and capital development funding to the booming Northern Mariana Islands.

The U.S. government also is on the verge of ending the financial arrangement with the Western Pacific commonwealth by end of this century, according to comments made last week by Stella Guerra, the U.S. president's special representative, in talks with CNMI officials in San Francisco.

Guerra told CNMI Lt. Gov. Benjamin Manglona the U.S. government would like to end its multi-year funding with an estimated \$175 million grant possibly spread over seven years starting Oct. 1.

If those terms are reached during current financial talks called for under a commonwealth covenant, the U.S.

contribution would drop by \$53 million from \$228 million the Northern Marianas will have received during the past seven years.

The CNMI received \$27.7 million this fiscal year, the last installment of the pact. Under current law, the funding level would remain at that amount unless (U.S.) Congress provides otherwise, Larry L. Morgan, spokesman for Guerra said in a weekend telephone interview from Washington.

Manglona has insisted that the

CNMI needs more than the \$228 million to build new roads, water, power and sewer systems and to improve education and health standards.

Guerra, who also is Assistant Interior Secretary for Territorial and International Affairs, said the U.S. Budget Enforcement Act requires that there either be a reduction in another direct spending program or a revenue increase. The act apparently precludes increased funding, Morgan said.

Guerra also has told Manglona

that the commonwealth has to achieve self-sufficiency and become less dependent on U.S. economic aid.

Without a new agreement and future action by the U.S. Congress, either through additional appropriations or a new full faith and credit pledge, we do not believe there is any guaranteed funding beyond fiscal year 1992," Guerra told Manglona and his team at the San Francisco

to the hardware I'll check on the price of rope." "How much do you think we

might need?" I asked. "I'll ask the guys at work who

shot a video there last week." "Well then, I'll ask at the hospital too. I think some of the young doctors enjoy hiking too.'

So we made our plans. Our confidence had been building over the past two months as we conquered each increasingly difficult climb. Our weekly weigh in on the scales told us the hiking did help our diets and our breathing was far less labored now, than when we started

Richard drove to the east side of the island where the road gave away to a long ago abandoned air strip with weeds growing from the middle.

He then also turned right and proceeded to make believe we were on a drag strip. Throating powerful drag-strip noises of imaginary motor reeving and power shifting as he drove at the sound breaking speed of 45mph, dodging pot-holes and asphalt skin wrinkles towards the far end of our drag strip. We missed the unmarked turn and wondered



Boy injected the wrong medicine

Hospital officials said on Monday that a quality assurance process is being observed in the hospital to assure that patients get the proper and quality health care they need.

The assurance came in light of a recent incident involving a minor under the age of 17 who was administered the wrong kind dosage of medication by a nursing practitioner.

The boy, who was complaining of vomiting and abdominal pain, was admitted to the hospital emergency room on May 5 and was administered Demerol, amedication intended for another patient.

Hospital administrator Pete Untalan said that when the attending physician learned of the mistake, he immediately ordered the nurse to inject another solution that will counteract the effect of the drug.

"The incident was a result of a simple, honest mistake. There was no punitive intent on the part of the physician," Untalan said.

Untalan said the boy is now in good shape and that he only suffered a hang-over as a result of the accident.

Based on the investigation of the Medical and Nursing staff committee of the hospital, the physician was attending to two cases of epigastric complains that night.

"The physician wrote two separate medication for the nurse to administer. He apparently failed to determine which patient the medication was intended for," Untalan said.

Untalan said the nurse carried out the doctor's orders without questioning her superior about

He said that when the physician realized that he has made an error in the order, he immedi-

ately acted on the situation by ordering the nurse to administer "Narvan", a counteractive drug to the previously administered Demerol. of atterprocess process will a Untally The

Untalan said that a thorough investigation of the incident led to the forced resignation of the nurse and the admonishment of the attending physician.

The multi-disciplinary committee is composed of a fivemember representative from the hospital's various departments.

The hospital administrator said that the committee reviewed the quality assurance process which the hospital has been implementing since three years ago.

The process involves the identification and review of emergency room indicators that may determine the cause of "unusual circumstances" in all the different departments in the hospital and incident reports which are filed by both the attending physician and the onduty nurse.

Upon completion of the process, the results are then forwarded to the hospital's Quality Assurance Coordinator Geraldine Thornburgh who is also a Public Health Service Assignee.

Aside from the investigation, an interview of the parties involved was also conducted and Untalan said the committee came out with their decision a week after the investigation was concluded.

The committee came out with three recommendation which addresses hospital logistics and the status of both the nurse and the physician.

In terms of logistics, Untalan said that they will be providing clerical support to the on-duty physician to assure that things are kept in order.

He said that walk-ways along the emergency room have also been designated as secure areas and that only those who have been identified as emergency patients will have access to the

Access to the sliding doors have also been limited to patients who are in immediate need

of attention and that the regular process of patient identification will also be fully implemented, Untalan said.

The hospital administrator said that in such "unusual cases", the responsible party is usually given a letter of reprimand where he is advised to undergo 20 to 40 hours of continuing education.

"In this case, we admonished the physician while the nurse was made to resign from her position," Untalan said.

Untalan said that mistakes are common occurrence in the medical profession and that like any profession, the people who are involved in the health care arena are also liable to commit mistakes.

"We must bear in mind that we are humans. The solution to a dilemma is to correct the mistake from which we try to refine and improve the health care that we provide to the community," Untalan said.

Statistics show that in bigger, more modernized hospital in the United States where there are twice the number of staff, errors are committed at the rate of 4%-5%.

Dr. John Crowley, head of the hospital's nursing division, said that compared to the Mainland hospital, the errors at the CHC were low when compared to national standards.

"We in the staff are not callous. We are concerned with the services that we provide the community and we are trying our best to improve the quality of health care that we deliver," Untalan said.

"I have full confidence in our staff. In comparison with other hospitals in the Micronesian area as well as those in the U.S., we have more adept personnel and we deliver health care which is comparable to those in some of the major hospital in the Mainland," Untalan said.

The boy's parents are intending to send him to an offisland medical facility where further evaluations will be done.

Untalan, on the other hand, said that he is not aware if the boy's parent's will file any action against the hospital.

Saipan solons to act on Salary Act amendment

The Saipan Legislative Delegation is now in the process of gathering information from its various members to form part of what could be the possible amendments to the Salary Act of 1990.

Last Friday, members of the Public Servants Compensation Rights Committee, headed by its chairman and CUC Executive Director Ray Guerrero met with the delegation.

The compensation committee went out to make sure that members of the legislature would push through with the requested and needed amendments to the act to fairly compensate workers.

Sections in the bill that needs to be amended, as push forth by the committee, includes those "frozen" employees under step 10, who needs to wait for two more years before getting to step 11 or an increase in salary.

Another would be the "restructuring" or "rearranging" of the different salaries that is going to be received by the various department heads, directors and special staffs.

The committee calls that salary schedule should be commensurate to the type of work and function the officials or employee has in a department or agency.

Meanwhile, Saipan Legislative Delegation Chairman Herman Guerrero said that he agrees to the fact that everyone should be paid equally and be given step increases.

"I for one is more than willing to amend the Act, as a matter of fact, I have introduced two salary bills about four to five years ago...but it did not push through."

In order to address what has been requested by the committee, Guerrero have asked members of the delegation to submit amendments to the Act, "using their own versions."

He said that they will also talk with the other members of the Tinian and Rota legislative delegations..."to iron things out as this is a CNMI wide matter."

According to Guerrero, he is expecting some sort of a "tug-of-war" as they go on and make the changes in the salary law..."but still, we have to do it in an appropriate manner."







Mei Qun Zhu, 20, a sewing operator of Linson's Garments was struck by a black Nissan pick-up while she was trying to cross the Chalan Pale Arnold street from the Highway Market.

Chief of Police Tony Reyes identified the responsible as Juan R. Limes, 20, of Chalan Lau-lau and a cadet trainee of the Department of Public Safety.

According to preliminary reports, Limes was travelling northbound when, as he neared the vicinity of the supermarket, Zhu crossed the street from the said store.

"Limes had very little time to make an evasive maneuver," Reyes said.

Police found no skid marks near the accident site and brethalyzer results indicate that Limes was alcohol-free at the time of the incident.

Zhu sustained a complete fractured ascervical and a dislocated spinal column and an autopsy is expected to be conducted this week.

Finally we reached an open area with vegetation only waist high. We had almost made it. Then we saw it. The water dug drainage ditch, gouged out, path way lay just ahead of us. inclining at least 60 degrees and only 2 1/2 to 3 ft. wide, the trail twisted and curved, wriggling itself down hill for the last of the really dangerous section. Because the rock filled, water runoff gully looked grease ball slippery, we tied one end of the borrowed climbing rope to a small iron wood tree and threw the remaining rope over the embankment.

We could have easily gotten down without the rope, but we would really need it on our return trip up. No slippery slide ever built in an amusement park could offer such a thrill and satisfy a personsquest for danger as this naturally engineered slide promised us now. One false move and we would be dead meat. Richard lowered himself to his bottom and inched downward, ever so slowly, trying not to cause a rock slide.
