Gov't may hire 200 more FTEs

THE GOVERNOR'S special assistant for Administration is seeking legislative approval to be able to hire an additional 100 to 200 full time employees to work in various agencies under the executive branch.

SAA Vicente T. Attao, in an interview yesterday said he has asked the House to allow the reprogram of lapsed salaries under the Fiscal Year 1996 budget appropriations act to fund the salaries of the new FTEs.

Attao's request has been incorporated in House Joint Resolution 10-13, sponsored by Rep. David M. Apatang, which seeks to reprogram unused FY 1996 funds for the Department of Public Safety's police and fire training courses.

The said resolution, which proposed the reprogram of \$500,000 for the operations of Attao's office, is currently being entertained by the House Ways and Means Committee.

But according to a Management and Budget official, a reprogram could not be done by a mere House resolution as the budget process requires passage of an appropriation bill by both houses of the Legislature and approval by the governor.

It was also unclear whether Attao's request has been sanctioned by the Administration, which has months back imposed a freeze on new hiring.

The Variety contacted Public Information Officer Mark Broadhurst but the latter was unavailable for comment.

Meanwhile, Attao emphasized that the FTE request is his own and does not constitute an official Administration action.

According to Attao, the reprogram is imperative owing to the government's need for additional manpower, especially in the remaining months of FY 1996.

He said he has proposed that the FTEs be given to his office

RP welfare officer arrives on Saipan

A LABOR official from Manila arrived last week to join the staff of the Philippine labor representative office on Saipan, Consul Generoso Calonge announced yesterday.

Calonge said the appointment of lawyer Federico Biolena as welfare officer for the CNMI is part of the Philippine government's efforts to "increase the presence of government representatives who will deal with problems of our contract workers"

Biolena was board secretary and legislative liaison officer of RP's Overseas Workers Welfare Administration before he was appointed to his current position on Saipan.

He arrived on the island last May 22 and officially assumed office the following day.

In a brief telephone interview, Biolena said his task is to assist the labor staff and to look after the welfare of the Filipino workers.

"I'll be dealing with matters like remittances, welfarecases and other things that are not related to the contracts of our workers," he said.

"Now that the Philippine labor office is fully-manned, we would be more prepared to face the problems of our workers," Calonge said. "This is our government's counterpart effort to that of the CNMI's."

Calonge said that with the anticipated arrival of more workers from the Philippines following the lifting of the ban, problems may be inevitable.

"We believe we are now better prepared to face these potential problems," the Philippine consul said. "We don't want another ban to be imposed. We hope it won't happen again."

House action shuts door on any new garment factories

DOORS have been shut for investors wanting to put up garment factories in the the CNMI as the House of Representatives voted yesterday to override Gov. Froilan C. Tenorio's veto of the garment expansion moratorium bill.

House Bill 10-152 became a law when the House, voting 14-2, complemented the Senate's earlier override move against the governor's veto of the bill.0

Vice Speaker Jesus Attao and Rep. Ana Teregeyo voted against the override.


"The vote showed the House

members' overwhelming concern about the effect of having additional garment factories in the CNMI," Speaker Diego Benavente said.

The bill stops the Department of Commerce from further issuing licenses for garment businesses

"Putting up additional garment factories here would entail the arrival of additional nonresident workers," Benavente said, "and that would mean additional burden to us in terms of infrastructures, particularly water and power."

Rising yen pushes Tokyo prices higher

TOKYO (AP) - For the price of a dozen eggs in New York, a consumer could buy only 7.4 in Tokyo, according to a recent survey of consumer prices around

The survey, conducted by Japan's Economic Planning Agency, found consumer prices in Tokyo were 59 percent higher than those in New York last

The consumer price gap between the two cities grew by 7 percentage points from 1994, said the report, released Monday. It attributed the rising gap to the increased value of the yen - an average of 94

to one dollar compared to 102 in 1994. The rise comes despite a trend in Japan toward American-style discounters,

supermarkets and larger retail shops. The EPA surveyed the average prices of consumer items in Tokvo. New York, London, Paris, Berlin and Geneva. The sampling included such diverse

items as furniture, thermometers and condoms. Shoes and clothing, for example, were 93 percent costlier in Tokyo than in New York. Food was almost double its London price.

The yen's losses against the franc and the mark contributed to a slight decline in the price gap between Tokyo and Paris and Berlin.

Prices were 34 percent higher than in Paris, down from 43 percent in the previous year. Tokyo prices were 35 percent higher than Berlin's, down from 44 percent in 1994, the report said.

US expects no inflation problems before 1998

WASHINGTON (AP) - The U.S. economy appears safe from recession at least through next year, forecasters said Tuesday.

At the same time, the forecasters contended that spotty signs of rising prices were temporary and inflation would remain in check, while the low unemployment rate would be little changed.

The consensus of the 38 professional forecasters surveyed by the National Association of Business Economists called for the economy to grow 2.2 percent this year, faster than the 1.9 percent pace they predicted in February.

But the gross domestic product the broadest measure of the nation's economic health - would decelerate

slightly to 2.1 percent in 1997, according to the survey conducted earlier this month.

The GDP grew 2 percent in 1995. Many economists say the Federal Reserve target for economic growth is between 2 percent and 2.5 percent - a rate they believe would sustain the five-year-old expansion without heating inflation.

A separate survey of 143 association members found only 20 percent expected Fed policy-makers to cut short-term interestrates in the next six monthstostimulateeconomic growth. Sixty-eight percent predicted no change and 10 percent expected a tighter monetary policy.

The other survey found the forecasters expecting inflation to grow 2.9 percent this year and 3 percent in 1997. The Consumer Price Index rose 2.5 percent in 1995, the tamest since a 1.1 percent gain in 1986.

"The survey panel members expected that much of the recent hike in inflation rates - caused by rising oil and grain prices - will be reversed over the remainder of this year and next year," the survey summary said.

The consensus forecast also called for the unemployment rate to remain unchanged at 5.6 percent this year and rising slightly to 5.7 percent in

In their examination of economic growth, the forecasters expected GDP growth to begin moderating during the second half of 1996. The panel estimated an annualized growth rate of 3 percent in the current quarter, up from 2.8 percent in the first three months, before slowing to 2.2 percent in the final six months.

Defector: North Korea has plans to invade South

SEOUL, South Korea (AP) - The North Korean pilot who defected in a Soviet-built MiG-19 jet said Tuesday the Pyongyang government has a plan to invade and occupy all of South Korea in a week.

"If Kim Jong Il issues an invasion order, the (North Korean) military is fully prepared (to execute) it," Capt. Lee Chul Sootoldanews conference.

Lee, 30, flew his jet to South Korea across the border last Thursday in the first such North Korean defection in 13 years. In 1983, a communist pilot defected to Seoul in another MiG-19

The North's military, led by Soviet tanks, occupied Seoul in three days when it invaded South Korea in 1950, starting a three-year war.

Lee said that after taking control of Seoul within a day, the North's military then would try to occupy Taejon, a major central city, in the secondstage and the southern coastal city of Pusan in the third stage.

Under the war program, most of the North's 1.2 million-member military, including its air force jets, have been deployed closer to the demilitarized zone running roughly along the 38th parallel, he said.

Despite worsening food shortages that have created a near-famine situation, North Korea is stockpiling food and fuel for the military, ensuring full preparations for a possible second Korean War, Lee said.

"Kim Jong II is diverting all resources to a war preparation," he said. "He (Kim) has repeatedly told the military that they should not expect a peaceful reunification with the South and that the reunification must come from the gun barrel."

But the defector acknowledged that the fuel shortages have grounded many fighter planes, forcing the air forceto limit training flights and spend more time on on-ground exercises.

North Korean authorities, he said, are telling the military that a war with the South is inevitable because of the South's increasing border provocations and the North is responding in kind by removing land mines in the demilitarized zone and moving forces closer to the border.

Lee's remarks can not be independently confirmed. He was debriefed by South Korean authorities before the news conference.

In the past two months, North Korea has increased tension along the border by repeatedly sending armed troops into the buffer zone in violation of the armistice that halted thethree-year Korean conflict in 1953.

South Korean officials see the North Korean border incursions as an attempt to put pressure on Washington to accept direct peace negotiations with it, excluding the rival South.

The Joeten family's privatelyowned piece of beachfront property in Garapan just north of the 13 Fishermen's Memorial is being acquired by the government for a private beach park.

The land, which has an area of about 2,000 square meters, is being exchanged for 3,000 square meters of government-owned land near the Royal Taga Beach Club in Susupe.


When sought for comment, Mike Sablan, spokesman for the Joeten family said, the land exchange is justified.



NMI population Increases

PRELIMINARY mid-decade census figure says there are about 60,000 people in the Northern Mariana Islands. The Filipino population is the largest, followed by the indigenous people and others. Of course, this doesn't include illegals whose number runs anywhere between three to five-thousand.

The fact that there's no major construction projects anywhere in the islands brings into focus why is there such a large population of non-citizen workers? There's also the miasmatic presence of—for lack of a more humane term—overstayers.

I tried to pin down why the rather large non-citizen workers. There are those who quickly offer that the indigenous people are "basically lazy", therefore, the need to bring in more foreign workers. I find this flabby statement condescending in that such a problem—bouncing around in private sector jobs—is as perennial as weed be it here

Frankly, our labor laws need major surgery! It is no longer relevant in the sense that there's the obvious imbalance in responsibility between employee and employer. Current laws shift the entire responsibility to the employer. Why should an employer be responsible for all that happens to an employee, i.e., fatal auto-accident during his/ her off-hours activity?

Furthermore, while mandated minimum wage is \$2.75 an hour (slated to increase if and when the governor inks the new wage bill), the employer is responsible for his employee's lodging, food and transportation which, when lumped together, translates to an effective wage of at least \$4.86 an hour. The same employer doesn't provide the same perks to indigenous employees.

· For anyone to say that resident or indigenous employees do not need the same perks, excuse me, sir, but there's the obvious discrepancy in terms of effective wage! The indigenous work force are people too! We have automobile and housing loans to wrestle with, including meeting the basic needs of every child in the house. Limiting fringe benefits to non-citizen workers is the single most discouraging factor for citizen workers whose basic needs are the same for one and all, citizens and noncitizens alike.

The non-compensatory aspect of these fringe benefits is difficult to stomach in that many of our people working in the private sector have raised these issues time and again. For instance, I was at the Laolao Golf Resort around lunch time when employees—locals and non-locals—brought their food together. Locals brought their own lunch from home while their counterparts were handed their lunch plate from the company cafeteria

I looked around and quizzed a local employee whether he's getting the same benefit like his counterparts do? The answer was "No, sir. But we get the same salary while they get three meals a day for free!" These freebies include free housing and ground transportation to and from work. Therefore, it seems that the company is ready and willing to invest in the well-being of non-citizen rather than citizen workers.

Do we blame the company for this inadequacy? No! Such is the nature of the law and this law needs some major reform!

I understand that Representative Heinz Hofschneider has introduced a comprehensive labor law designed to distribute employee/employer responsibility fairly. I say let's do it right here and now! I hope too that this proposed labor law would bring to equal playing ground what non-citizen workers receive in fringe benefits, i.e., free food, lodging and transportation. In other words, either indigenous and resident workers are included in company paid meals and other freebies or compensate them directly for it. Once and for all, let's treat everybody sensibly and equally. You like free lunch, I like free lunch, everybody likes free lunch, yeah?

My heart bleeds when I see illegals paid less than mandated wages after twelve to sixteen hours of long and hard work. Interesting that some of our policymakers refuse to vote for the newly approved minimum wage bill because maids, fishermen and farmers were given a raise from \$150 to \$300 a month. Some admitted paying their maids the proposed salary now, but refuse to vote for it. So what's \$100 friends for someone who works from six to six washing your dirty laundry, cleaning your house and serving the role of a mother to your children because your spouse is out somewhere playing computer or socializing with friends at some bar during happy hour?

I sympathize with live-in-maids who go through twelve to sixteen hour daily routine of washing dirty laundry, cooking, feeding the kids, cleaning the house, massaging si sir and mam when they come home from work, wash the dishes after dinner, wash the family car, etc. I mean, this person is a human being too and doesn't deserve to be treated as some slob or slave. Maids are people too! So what's \$100 for someone we've treated like a slave?

I also asked several overstayers why risk abuses against them by unscrupulous employers: Said one: "Ai, nako boss, dis island is heben. I'm die when I go back to FI." My pareko sees these islands as the land of opportunity. "Ai nako, boss, don't tell si Mr. Tommy Sablan, because if I will be caught, I'm die". I was caught between the compassionate part of this scribe and the requirements of the law. I know that if I was caught exceeding the thirty-day visitation limit in Manila or Beijing, the entire Filipino and Chinese population of some 62 million and 2-billion people respectively, would want me out of their country: "Sorry, you piolate da lo, you fay. You



Singapore to force support for elderly poor

SINGAPORE (AP) - A tribunal that has the power to force Singaporeans to help support their aged and poor parents opens for business this week.

Parents could compel their children to give them a monthly allowance or a lump sum payment through the Maintenance of Parents Act passed by Parliament in

Designed to enforce filial piety, it led to the creation of an 11-member panel headed by a former director of the Legal Aid Bureau.

The tribunal will open on June 1 and plans to meet once a week, Minister for Community Development Abdullah Tarmugi said Monday.

Needy seniors would be able to claim maintenance from one or more of their children, including stepchildren as well as adopted or illegitimate offspring.

Only parents who cannot support themselves are entitled to claim maintenance.

The process is supposed to be non-adversarial with claims submitted at no cost and without the need for lawyers, rather than in court proceedings.

Three weeks after an application is filed, a date will be set for the claimant to appear before the tribunal which will evaluate the claim.

Those that are not dismissed as frivolous move to a mediator for settlement. If mediation fails, a hearing before the tribunal is the next step.

Hearings will not normally be open to the public, and lawyers may enter the process only if appeals move to the High Court, Abdullah said.

Approved third parties, such as relatives or welfare groups, may file a claim on behalf of the parent.

The statutory retirement age is the minimum age for a claimant, except for the infirm. Singapore plans to gradually increase the retirement age from 60 to 67.

The new law made local legislative history as the first that was not introduced by a member of the ruling People's Action Party. It was proposed by Walter Woon, a law professor and an appointed member of Parliament, who can vote on all issues except money bills and

It was folly to pretend that Singapore had a perfect Confucian, Christian, Islamic or Hindu society, where the aged had sufficient savings or were taken care of by loving children. Woon said.

He targeted "the recalcitrant, small minority that cannot be counted on to do what is right." Woon said he introduced the measure after examining similar laws in Israel, India, Taiwan and some American states.

Critics of the proposal said that a conservative Asian society should not rely on law to solve family problems.

The law is Singapore's latest response to the prospect of a rapidly aging population. It is among the richest in Asia with an annual per capita income of more than 25,000 dollars (U.S. \$ 17,606).

But the proportion of elderly is increasing faster than in many Western and other Asian countries. Demographic changes were speeded up by official tinkering in the 1960s when, worried by high population growth and unemployment, the government urged "Stop at two."

The two-child policy was reversed in 1987 after proving so successful that the fertility rate fell below the replacement level.

Officials then began preaching: "Have three or more if you can afford it."

Yeltsin travels to Chechnya

MOSCOW (AP) - President Boris Yeltsin made good on a campaign promise and traveled Tuesday to the breakaway republic of Chechnya a day after signing a cease-fire with the rebels' leader, officials said.

Yeltsin planned meetings with civilians in the Chechen capital Grozny as well as with Russian troops who have been fighting for 17-months to defeat the rebels' independence drive.

The trip, three weeks before presidential elections June 16, is likely to provide Yeltsin a boost in popularity. Polls show that the war in Chechnya is the main concern of Russian voters.

Yeltsin traveled first to the Russian military headquarters in Mozdok, 130 kilometers (80 miles) north of the Chechen capital in the neighboring republic of North Ossetia, the ITAR-Tass news

The truce agreement signed Monday in the Kremlin was hailed as a presidential campaign coup but met with immediate skepticism that it would end 1 1-2 years of war.

Yeltsin called the deal signed Monday with rebel chief Zelimkhan Yandarbiyev "his-

Under the cease-fire agreement, reached after Yeltsin initiated unprecedented faceto-face talks with the separatist leader, hostilities are to be halted Saturday and hostages and prisoners exchanged within two weeks. Prime Minister Viktor Chernomyrdin signed for the Rus-

The main sticking points, however, remained unaddressed. The rebels insist on independence and full withdrawal by Russian forces, while Moscow refuses to let the breakaway republic go and demands complete rebel disarmament before it pulls out its tanks and troops.

Few doubt that politics, not peace, was the primary motivation behind the cease-fire deal.

Yeltsin has said he needs to show progress toward ending the war to defeat his Communist rival in the June 16 election. The rebels, meanwhile, want to negotiate while Yeltsin is still eager to curry favor with voters.

Judge nixes 'gag order' motion

Variety News Staff THE SUPERIOR Court has denied Chief Public Defender Daniel J. DeRienzo's attempt to stop the govemment from giving information to the media which he called "non-public" in connection with the so-called Fujian Group.

During Friday's hearing, Associate Judge Miguel Demapan said after hearing the arguments and considering the pleadings filed, the court finds that there is no reasonable basis to issue a gag order.

Demapan said the court was presented with insufficient evidence to show that the defendants will have an unfair trial due to the publicity coming from the Department of Public

In his motion for gag order, DeRienzo, who is representing defendant Lin Hua, asked the court to order the DPS and the Attorney General's Office to refrain from disseminating alleged non-public information to ensure that his client receives a fair trial.

Hua was among the three Chinese nationals arrested for allegedly kidnapping and assaulting businessman who refused to give them money. The victim was taken to the Capitol Hill cemetery where he was also stabbed with a knife on the right thigh.




"It has been held that publicity concerning a wholly unrelated case was not prejudicial as affecting a defendant's right to a fair trial,' Norcross said.

AG seeking full sentence for Mobil station 'thief'

THE ATTORNEY General's Office has sought the revocation of a suspended sentence against a man for violating one of the conditions when he allegedly joined a group of men who broke into a gas station on Rota and stole money.

In his motion, Assistant Atty. Gen. Gabriel Acosta said Tilford S. Toves failed to obey all criminal laws, which was one of the conditions of his suspended sentence.

Acosta said last March 7 Toves entered a plea of guilty to a criminal offense and was sentenced to 90 days in jail, with 45 days suspended for one

The 30 days were converted to 240 hours of community work service.

Acosta said last May 9 on Rota, Toves entered the Dean's Mobil Station through the window.

The defendant destroyed a computerized cash register worth \$7,000 by throwing it to the floor so he could retrieve money

Toves also aided his two other male companions in stealing cases of beer and cartons of cigarets from the store. Toves and his companions were charged with burglary, theft and crimi-

nal mischief. While under police investigation, Acosta said the defendant admitted

participation in the gas station incident.



sentencing pending the submission of the Probation Office's pre-sentence report.

Charles Rotbart, Babauta's counsel, told the court that he has not received a pre-sentence report. Uponlearningthis, Castro formally

requested the Probation Office to do the report as he set the continuation of the sentencing on Aug. 12.

The judge also granted Rotbart's request to allow the release of Babauta during the schedule of his school classes.

Babauta has been detained at Kagman Juvenile facility since he was arrested last year for the killing of Nazrul Ansary.

Babauta entered into a plea agreement with the government and testified against James I. Itibus.

A jury, however, reached a verdict last February declaring Itibus not guilty to all the charges in connection with the murder of Ansary and attempted murder of another Bangladeshi security guard. (FDT)

The Department of Commerce lifted the moratorium last year, and later issued 12 new licenses to garment manufacturers.

Proponents of HB 10-152 saw the need to reimpose the moratorium considering the impact of having more factories in the Commonwealth.

At the same time, the US government has raised concern over the CNMI's failure to maintain the immigration cap at the 1992 level.

In vetoing the bill last month, Tenorio said the garment industry "is doing better things than harm" in the CNMI.

The industry contributes a great deal to the CNMI's revenue, the governor has said.

Meanwhile, Benavente recalled that the issue on immigration was among the major concerns raised by Sens.. Daniel Akaka and Frank Murkowski when they visited Saipan on a fact-finding mission last February.

Benavente, however, said the House's action was just "partly" in response to the concern raised by the Washington officials.

"Our main consideration when we acted on the bill had to do with our own people's concern," Benavente said. "Our people are more concerned with the problems we would face if we bring in more and more factory workers to the Commonwealth."

Licenses issued to new factories will not be revoked, but they would be asked not to bring in more alien workers, Benavente

Justifying her negative vote on the override, meanwhile, Teregeyo argued that the imposition of a moratorium would curtail competition within the indus-

The garment businesses currently operating, she added, "will stand a better chance to continue to make huge profits and remain in business.'

"With less competition to worry about, plus the action this body took earlier to enact a minimum wage partial application to the garment and construction industries, the garment industry in particular will stand to benefit more than any other industry," the con-

Attao, for his part, said barring the entry of more garment factories in the CNMI would lessen the government's sources of the much-needed revenues.

"I'd like to see the Commonwealth generate more revenues for our projects," Attao said.

AS for the federal government's concerns about immigration, Attao said the local government would have to "deal that issue separately."

"First of all," he said, "we have to generate millions on dollars in revenue before accomplishing anything else.'

Foreign worker abuse increasing

MANILA, Philippines (AP) - While working as a housemaid in Oman. Nenet kept a pair of scissors hidden under her pillow to protect herself from the sexual advances of her

"I might kill him," she wrote to her mother in the Philippines. "He wants me and he is insistent."

Nenet, who spoke on condition that her last name not be used, spent 20-hour days cleaning, ironing and cooking - with no days off - while trying to avoid her harasser. She finally convinced her employer to let her go home to the Philippines by fabricating a story that her 3-year-old child was ill.

Nenet's experience is becoming increasingly common, according to about 50 U.N. experts who began meeting in Manila on Monday to discuss the growing problem of abuse associated with exported female la-

The problem particularly affects Asian nations. Overall, about 50 percent of Asian overseas workers are now women, up from less than 15 percent two decades ago, according to a U.N. study.

Among Filipinos, most overseas workers a decade ago were men who labored at construction sites in the Middle East or as crewmen aboard ships. Today, women now account for about 55 percent of the more than 5 million Filipinos working abroad out of a total population of about 68 mil-

In the first five months of this year, 94,136 Filipino overseas workers encountered serious trouble, more than double the 40,971 in all of the previous year, according to the Kanlungan Center Foundation, a Manila group that works on behalf of workers abroad.

But the "scare stories" about workers abroad do not discourage Filipinos from continuing to go overseas, said Miriam Tugawin of the Kanlungar

"I think they are more scared about the life they have here than abroad," she said. "Here, they have nothing to

Nenet says she went abroad to make more money. In Oman, she earned dlrs 156 a month. In the Philippines, where unemployment is 8.3 percent and millions find work just a few hours a month, many earn well below the minimum wage of dlrs 6.35

The policy of encouraging labor exports from the Philippines was launched in the 1970s by then-President Ferdinand Marcos in response to an economic slowdown.

The governments of India, Bangladesh, Pakistan, Thailand and other countries also actively encourage overseas employment as a means of reducing unemployment at home and earning foreign exchange.

About 80 percent of the half-million Sri Lankan workers abroad are women, nearly all working as house-

time, hundreds of maids there are being harbored in Sri Lankan embassies after fleeing rape and physical abuse by their employers, the govern-

ment says. As reports of abuse increase, the Philippine government has started to reconsider the labor exports. Many Filipinos feel ashamed that their nation has become a supplier of maids to the world. Many also question why so many women - and men - have abandoned their responsibilities as parents and spouses for the attraction of money abroad.

Children of overseas workers often perform badly in school and grow up with little self-discipline because of the missing parent, says Simeona Rojas, principal of Christ the King College high school north of

The school began a special program to help children of overseas workers after it discovered that they account for about 30 percent of its 3,500 high school and elementary stu-

"Psychologically they are like orphans," Rojas says. "They do not know what to do so they are easily influenced by gangs."

The numbers of new workers going overseas declined last year after

Filipino maid, Flor Contemplacion, was executed in Singapore for the murders of another maid and a child in her care. Although Contemplacion confessed to the crime, many Filipinos believe she was innocent. A delegate at this week's U.N.

Asahara tried twice to kill self in prison

TOKYO (AP) - Doomsday guru Shoko Asahara said Tuesday he had twice tried to kill himself in prison, and that he hoped that those who died in last year's subway nerve-gas attack would be reborn in a higher

The statements came as Asahara made a last-ditch appeal against the cult, accused in the subway attack that killed 12 people and left more than 5,500 injured.

At an administrative hearing in the jail where he is being held during his murder trial, the 41-year-old cult leader argued that neither he nor his group poses a threat to society.

"I would never give orders or

outlawing of his Aum Shinri Kyo commands to carry out destructive activities,"he said, speaking in a clear, self-assured voice. "Please let my followers continue their training."

Aum has already been dissolved as a religious organization and declared bankrupt. But authorities are seeking to invoke a rarely used antisubversive-activities law that would effectively ban the cult, prohibiting its members from raising funds or assembling in large groups.

Tuesday's hearing was the fourth on the issue, and the Justice Ministry's public security agency, which is arguing for the ban, wants it to be the

At the hearing, Asahara's lawvers cited notebook entries made by the cult leader in the months following his arrest last May.

In them, Asahara defends the cult and rails against his treatment by police and prison officials. He described interrogation sessions lasting 10 hours, and said he twice tried to kill himself in his cell by suffocation.

"I was not able to die," he said.

Asahara saidhe was continuing his religious training in jail, with the aim of achieving rebirth on a higher plane for everyone, including those who died in the subway attack. But he acknowledged no responsibility for

Some top disciples have implicated Asahara as the mastermind of the March 20, 1995 nerve-gas attack on the subways. Asahara's trial began last month, but he has so far refused to enter a plea to any of the charges against him.

In court, Asahara has said little, and refuses to respond to his birth name of Chizuo Matsumoto. But in the hearings on the anti-subversive law, he has spoken vigorously in his



Monday's story quoted an unidentified interior ministry official as saying that the motive for the attack on Ali Saeed al-Khayarin had been "subversive." It did not elaborate.

The minister was parked at a petrol station in Doha. the Oatari capital, when gunmen pulled up and sprayed his car with more than 100

Following the attack, dip-lomatic sources told The As-

sociated Press in Doha that one of the assailants was a senior army officer.

Qatar, a tiny Gulf state on the eastern side of the Arabian Peninsula, has been tense since June 1995, when the emirate's present ruler, Sheik Hamad bin Khalifa Al Thani, ousted his father in a bloodless palace coup.

Al-Khayarin is not considered a key figure in the struggle for power among supporters of the current ruler and his deposed father, now living in exile in the United Arab

In February, authorities said they had foiled a coup attempt which the government blamed on supporters of the former ruler, Sheik Khalifa bin Hamad Al

Suu Kyi: Free all detainees

RANGOON, Burma (AP) - Prodemocracy leader Aung San Suu Kyi closed a dramatic opposition congress Tuesday with an appeal for the military regime to free hundreds of delegates

Reading to reporters the resolutions adopted by the handful of delegates who eluded mass arrests, Suu Kyi urged the government to open a dialogue with the opposition and said the powerful military should be subject to control by a civilian Parliament.

The resolutions demanded the ruling State Law and Order Restoration Council call into session the parliament elected in 1990. It was never allowed to conveneafterthe pro-democracy movement won 392 of 485 contested seats.

In an olive branch to the military, the resolutions stated that the armed forces were "a necessary institution in this country and we endorse the view that the armed forces should be an honorable institution which will take care of the defense of the nation and help bring about democracy."

The three-day conference posed the biggest challenge to the regime offered yet by Suu Kyi, winner of the 1991 Nobel Peace Prize for her non-violent promotion of democracy, since she was freed from six years of house arrest last July.

Burmese music played as she took the podium to read the resolutions before about 200 supporters under a specially built bamboo-and-thatch meeting hall draped with the fighting peacock banners of her National League for Democracy.

Wearing a traditional Burmese sarong, Suu \bar{K} yi adopted a tone of irony when asked about reports in government-controlled papers that up to 90,000 state employees had attended demonstrations in favor of the junta Monday in parks around Rangoon.

"The government allows its supporters to meet in public parks," Suu Kyi said. "Why not us?"





Climate change raises worry about flooding

BELJING (AP) - Climate change will cause sea level rises of 15 to 75 centimeters (6 to 30 inches) in the next century that could inundate large parts of China's heavily populated coast, according to predictions by Chinese oceanographers.

The warning is the result of a fiveyear research project by the State Oceanic Administration, the China Daily reported Tuesday. It said scientists urged the government to build new bulwarks along areas likely to be inun-

Rising sea levels also would increase the hazard of storm surges, the salinization of farm land and erosion of the coastline, said researcher Du Bilan, who lead the study.

its population of 1.2 billion people. Rapidly industrializing China depends on coal for 75 percent of its energy needs.

A United Nations report estimates China's carbon dioxide emissions will increase three-fold between 1990 and 2020. Carbon dioxide is the leading greenhouse gas building up in the atmosphere and resulting in global warming

Local governments have raised the purchase price of grain for mandatory state quotas in a move to give farmers more incentive to produce it.

The price of wheat in central China's Henan province has risen to 76 yuan (\$ 9.2) per 50 kilograms, an increase of 41.5 percent over the previous year, the China Daily reported. It did not give a creases, but China's agriculture minister said in March the state would increase the purchase price of grain by 20 percent this year.

The summer harvest is expected to start in about 10 days in north China. The country's present annual output of grain is about 450 million tons, and last year's harvest was 465 million tons.

Bulls sweep Orlando

ORLANDO, Florida (AP) - It was revenge for Michael Jordan and a return to the National Basketball Association championship for his Chicago Bulls.

The Bulls dethroned Orlando as Eastern Conference champions Monday, defeating the wounded Magic 106-101 behind 45 points from Jordan.

The Bulls meet Seattle or Utah in the final, which could come Friday if Seattle wraps up its Western Conference series against Utah on Tuesday night.

Jordan, who led the Bulls to titles in 1991, 1992 and 1993 before a truncated retirement, returned last season only to make Jordan overwhelms with 45-point output

numerous mistakes in a second-round loss to Orlando.

He has said that memories of that bitter defeat motivated him for this season, when he won his eighth scoring crown and fourth Most Valuable Player award and led Chicago to an NBA-record 72-victory season.

After three below-average games this series, Jordan was sensational Monday. He was 16 of 23 from the floor, kept the Bulls in the game when they struggled in the first half and helped them overtake Orlando in the third quarter.

Now his Bulls are 11-1 in the

playoffs and back in the finals for the fourth time in six years. And they have beaten the Magic seven straight times.

The Magic became the first team since the Chicago Stags (1948-50) to be swept from the playoffs three straight years. Orlando lost 3-0 to Indiana in the first round in 1994 and 4-0 to Houston in last year's finals.

But despite injuries that sidelined starters Nick Anderson and Horace Grant as well as top reserve Brian Shaw, the Magic played with heart and desire.

Led by Shaquille O'Neal and Penny Hardaway, who finished with 28 points apiece, the Magic opened with a 15-4 burst and were still up 73-65 with 3 1/2 minutes left in the third quarter.

But the Bulls then went on a 15-3 run, with Dennis Rodman scoring five points and Jordan and Pippen getting four each, to take the lead for good.

Chicago led 80-76 when Jordan went to the bench for a rest with 9:55 to go and increased that to 88-81 when he came back about three minutes later thanks to Toni Kukoc's 3-pointer, Ron Harper's three-point play and Luc Longley's 15-footer (4.5-meter shot).

Upon returning, Jordan immediately made an impact, hitting a 20-footer (6-meter shot) and a 3-pointer for a 95-85 lead, and the Magic never threatened.

Brooks Thompson, Orlando's first guard off the bench in place of Shaw (neck spasms), scored 17 points. Anthony Bowie started for Anderson (sprained wrist) and had eight points.

Once again, however, nobody could help the Magic at power forward. Grant, who excelled against Chicago in the playoffs last year, missed the last three games with a

hyperextended elbow.

Without Grant to contest him, Rodman dominated the boards. He had 14 rebounds Monday, giving him a 15.8 average in the series, as the Bulls won the rebound battle all four games.

Hardaway scored 13 points and O'Neal 10 as Orlando led 31-23 after one - the first time this series that the Magic scored more than 30 points in a quarter. Jordan, who had 13 points in the period, kept the Bulls close.

O'Neal and Rodman exchanged shoves with 1:31 left in the second quarter and each was assessed a technical foul. O'Neal then made his fifth straight free throw, giving the Magic a 51-40 lead.

O'Neal was 6 of 9 from the line but still finished at 36 percent for the series and 39 percentinthe postseason as Orlando set a record for lowest free throw percentage (.543) in a playoff series. Houston, which shot .567 against Utah in 1985, had held the mark.

Top women seeds win at start of French Open

PARIS (AP) - Under drizzly skies, two top-seeded women easily defeated their first-round challengers on the opening day Monday of the \$ 10.5 million French Open.

Fifth-seeded Iva Majoli of Croatia, fourth-ranked in the world, defeated Silke Meier of Germany 6-3, 6-4.

Meanwhile Anke Huber of Germany, sixth-seeded at the French Open and a finalist in January's Australian Open, had little trouble stopping American Gigi Fernandez 6-2, 6-2.

They played on a damp Center Court where Pete Sampras was playing Magnus Gustafsson in the afternoon.

"It was awful playing," said the fifth-ranked Huber. "It was cold and there was always a bit of rain."

Third-seeded Agassi was up against Spain's Jacobo Diaz, while former two-time champion and seventh-seeded Jim Courier faced Andrei Olhovskiy of Russia.

Muster, among the walking wounded at the French Open, was talking down expectations.

"Last year was a now or never occasion," he said Sunday. "But this year is a different story. Winning or losing is not going to make a lot of difference."

While No. 2-ranked Muster was spared the first day of play, topseeded and top-ranked Sampras was recovering from back spasms.

Sergi Bruguera, the 1993 and 1994 champion recovering from a foot injury, was to face fellow Spaniard Javier Sanchez.

Norman plans to continue maintaining a low profile this summer, despite an outpouring of compassion and support from fans and peers around the world.

"He's not giving any (individual) interviews over the next couple of months," said Frank Williams, his business manager. "He's refusing everybody, even close personal friends. We feel he's overexposed."

Norman was scheduled to appear Wednesday at a news conference at Muirfield Village Golf Club, one day before the 21st Memorial begins in suburban Dublin.

It will be the first time sports writers have had access to him since April 21, after the final round of the MCI Classic at Hilton Head Island, South Caro-

lina.

Norman spent most of a month on his yacht, Aussie Rules, off the coast of Mexico and Central America. During that time, he made only one public appearance - at a previously scheduled outing in Fort Worth, Texas, for Bell helicopters, one of which he owns.

He spent last week at home in Hobe Sound, Florida, practicing his game and tending to his business, Great White Shark Enterprises Inc.
