The Paradise of the Pacific for October is out. With the present number the paper appears under the editorial management of Mr. Frank Godfrey, a well known journalist of Honolulu. The announcement is also made that Messrs. J. J. Williams and Frank Godfrey are the proprietors. The journal gives evidence of much improvement under the new management, both as to variety and arrangement of matter. The editorial matter is judiciously written and will serve to extend the scope and influence of the journal abroad as well as at home.

Hon. A. Marques spoke like one who knew all about it the other day, when he told the House that pretty much the whole civilized world took their consuses this year. Therefore, Hawaii, by adopting the reasonable proposition of the Minister of Finance that, on account of shortness of time, the census should be postponed till next year,-would appear foolish. Mr. Marques was, however, only showing ignorance in making the statement in question as a ground of opposing postponement, as he showed childishness-a thin House confirming his juvenile petishness-in moving in effect that the Hawaiian census be abandoned altogether. The fact is that all great nations do not take their censuses in the years ending decades. Great Britain and at least some of her large dependencies take their censuses in the years beginning the decades. As those countries represent a respectable number of millions of the world's population, Hawaii would have pretty tolerable company in taking her census next year.

Mr. D. Howard Hitchcock, the talented young Hawaiian artist, left Honolulu by the Zealaudia to begin his studies and travels abroad. Mr. Hitchcock had not, when he left, fully matured his plans and hence they are subject to change. It is a pleasure to make this notice of a home artist of Mr. Hitchcock's ability, and we have no hesitancy in placing him before the public as more than an amateur, from whom his many friends and admirers in Hawaii may expect to hear further in actual and meritorious work.

Mr. Hitchcock goes from here direct to New York, where he will remain a few weeks getting his bearings before crossing the pond for Europe. He will probably take a French steamer direct from New York to Havre. He will go thence to Paris where he will likely remain two years studying under at least two masters. At the close of his Paris tuition the young artist will travel and study throughout the principal galleries of Europe, including those of Germany, Italy and England. He will probably be absent from Hawaii four or five years.

NOT REPRESENTED.

EDITOR BULLETIN: -Being a countryman and loyal subject of a foreign government, having its representative to the court of this kingdom, I was quite struck with a remark made use of in my hearing to the effect that a certain foreign dignitary was absent during the hearing of a recent case before the Supreme Court, wherein the defendant (a countryman of mine) was cited to appear in

court and show cause, etc. How far it is a rule, or custom, among the foreign dignitaries to attend in Court, I don't pretend to know, still it is not unusual to notice their preside in Court, as one often reads in the newspapers; in fact I have seen more than one instance of a foreign representative present in court watching the proceedings against a subject of his government, whose liberty was at stake.

Of the recent case referred to, it would be idle to say that the absent dignitary had no knowledge of the pendency of the matter, especially as the case was pretty well known among the members of a certain society; and besides enough publicity concerning it had been made by a member of said society in one of the newspapers whose local columns are edited by a fellow.

COUNTRYMAN.

EDITORIAL THEORY.

EDITOR BULLETIN:-In an editorial of the Advertiser of Oct. 21st is the following: "Unless the cost of field labor comes down very materially indeed, our great industries will be so crippled that the mechanic will come in for his share of the loss and suffer severely," etc. The above is only one more sample of the many toots blown from the horn of the Advertiser during the last year or more, in order to frighten the workingmen into passiveness and submission, so that the planter can again open the flood gates of Chinese invasion.

The whole course of the planter proves conclusively that he is no friend of the white or native mechanic; he wants no such trash as long as he can get a Chinaman to fill the bill; be it as carpenter, sugar boiler, mason or engineer. And mind you, if John Chinaman could handle the plowing on plantations, as well as the native, the native could go to Jericho also or else come

down to starvation wages. Another thing, the planter wants no one on his plantation who has the independence and manhood to assert and stand up for his rights when trampled upon; therefore his yearning and pleading for servile coolie labor. Taken altogether the planter in his past and present mood wishes to overrun the Islands with hordes of Chinese cheap laborers to enrich himself. He is to be looked upon not as the great benefactor he would fondly have the people believe, but rather as the greatest embodiment of selfishness, that ever appeared within the realms of Hawaii nei.

FANATICISM AND INTOLERANCE.

EDITOR BULLETIN:-In the "Forum" for Sept. of the present year appear an article entitled "The Christianity of the Future" which might supply the numerous fanatics and intolerant extremists of temperance preaching with healthy food for thought. In community on the "backward developof Christianity during the ment' first decades after the coming of Christ and later, the author of the article, Prof. John J. Blackie, shows the extremes, from uncurbed license to austere asceticism, into which the early Christians went, and regarding the latter goes on to say: "The opposite extreme the denial of the rights of the flesh altogether, was more obvious and we have asceticism in various forms. * * * In the New Testament the flesh is used as a comprehensive term to designate sin generally, but to conclude from this that the flesh has no rights, is as absurd as it would be in a workingman to deny the right of his tools to be kept in good working order, or in a rider to deny the right of his horse to be well fed and well cared for. The flesh or the body or the material outside of a man has as much right to its own sound condition and healthy enjoyment as a good house has to a sound foundation, or a good picture to a sound canvas. But of course every hasty fool does not see this, so the newly converted sinner, in his hurry to become a saint, thinks he can eradicate all vice at a stroke by retreating from every field where a temptation is possible, and by abstaining from every enjoyment that may shoot up into a vice. Hence asceticism and monkery, which look very pretty in the lives of a certain class of saints, but which in fact are only a cheap method of getting freedom from certain vices at a bound, and of acquiring the reputation of a hero by refusing to fight a battle. For, say what we will, abstinence is the despair of virtue. I abstain because I am too weak to be temperate; I retreat because I dare not

No doubt it is wise in some persons in some cases to play the coward; and self-sacrifice and self-denial in some exceptional style, like the amputation of a limb, may be the only safety to a man for whom a large freedom cannot be claimed. But neither our Lord nor his

apostles were taught that the absti-nence prescribed for the moral diseases of the few was to be laid down as a rule of health for the many. Not only temperance-cranks, but advocates of the Sunday-law in all its absurd Puritanical rigor; which denies all innocent and healthful recreation and amusement to the hardworking members of society; business men, mechanics and laborers. would profit by studying the lesson of this article, which includes all kinds of abstinence self-denial and asceticism. THE LEGISLATURE.

109TH DAY.

WEDNESDAY, Oct. 22. The House met at 10 o'clock.

REPORTS OF COMMITTEES.

Rep. Kahookano presented the report of the education committee on the petition of Kaniho for the restoration of land taken for school purposes in Kohala, recommending for reasons given that the petition be laid on the table. Adopted.

Rep. Kabookano presented the report of the judiciary committee on the bill to make the Hawaiian version of the laws the binding one when there is an irreconcilable difference between it and the English version. They recommend that the bill be laid on the table.

Rep. Baker moved that the report be laid on the table to be considered with the minority report.

The report was adopted. Rep. Kahookano presented the report of the select committee on the petition of Kalaola, for \$100 for carrying the mail from Honokohau to Lahaina. They recommend for reasons given that the petition be laid on the table.

Rep. Lucas presented printed bills from the printing committee. ORDER OF THE DAY.

Consideration of the Appropriation Bill on third reading. Salary of the President of Board of Health, reconsidered.

Rep. Brown moved \$7000. Rep. Hookano moved \$6000. Noble Pua thought \$6000 sufficient. The House had passed no measure to increase the revenue, while continually increasing the Appropriation Bill. He did not know where the money was coming from. The present President had not done the work that he was appointed to do. He had not dismissed Kahalahili or Reynolds, or reinstated Sister Rose Gertrude and Dr. Lutz. Therefore the President

was not worthy of his hire. Looking at what he had done, he considered the President not worth more Noble J. M. Horner did not wish to say anything against the official. As the item had been opened he moved it pass at \$5000. He had given the subject of Government official salaries a large amount of study, and come to the conclusion that in the interest of peace they should be reduced, till the office should seek the man and not the

man the office. High Government salaries were the curse of Honolulu. The people were divided in the name of politics, but the division was really on account of the spoils. Those having high salaries wanted to hold on, while those who hadn't the high salaries wanted them. In what ought to be a lovely town bickerings were produced by high salaries, and characters blackened in and out of the press. If salaries were reduced peace would reign in this community. What a pity that such heavenly prospects should be turned into a hell of contention by high salaries! (Laughter.) Aye, the condition of things makes even Satan laugh. (Renewed laughter.) The President once served without

incumbent and be paid a salary. Noble Widemann-To make a place for a henchman—yes, for three of them.

I move that the item pass at \$5000, and feel a squirm of conscience in promising to vote for that amount. The President of the Board of Health has very little to do

and plenty of time to do it. Noble Widemann did not believe hardly a word uttered by the previous speaker, but strange to say he arrived at the same conclusion. He would vote for \$5000, as this man was well settled and the question was reconsidered to give him more. There was a competent medical man in the position, a hard-working physician-he referred to Dr. Trousseau-but that beautiful Reform regime wanted a place for a hench-man and put a third-rate physician in his place at a high salary. He was not aware of the terrible scrambling for office in Honolulu.

Noble Walbridge-You weren't at that lunch at the Hotel yester-

Noble Cornwell-I rise to a point of order, and would like to know what is before the House. Is it lunches at the Hotel or the the revolution of 1887? (Laughter.)

Noble Widemann wanted to know who had the floor. The hon. Noble was spiteful because his bill was defeated yesterday. (Laughter.)

Minister Brown said he moved reconsideration so that a small amount should be added to repay the present incumbent for the amount drawn on the previous scale of \$7000 by his predecessor. He would move that the item pass at \$6191.20. At the same time he did not think that \$7000 was too much for the duties. With the control of an expenditure of \$350,000 and the care of nearly a thousand lepers his mind must be full all the time. Formerly the Minister of the Interior was President of the Board, and drawing a salary as Minister he could not draw

another. Dr. Trousseau took the Presidency at the speaker's personal solicitation, but asked as a personal favor that he should not be request-

ed to serve beyond four months.

Noble J. M. Horner thought the Minister of the Interior had doubtless performed the duties with satisfaction. It was a strange way of balancing the account between the two Presidents for the House to increase the salary.

Passed at \$6191.20. Salary of Superintendent of Water

Works, reconsidered. Noble Macfarlane believed that the salary should be put up again to \$6000. It would be very hard to replace the present incumbent. Although he had consistently advocated economy in expenditures, he considered it would be false economy to reduce this salary. Noble Pua moved \$4800.

Rep. Rosa said it must be remembered this was the head of a bureau. The town was constantly extending and the work was therefore continually increasing. The Superintendent was a very competent man. In addition to his duties as head of this bureau, he served the public gratuitously as Chief Engineer of the Honolulu Fire Department. Passed at \$6000.

Likelike claims reported on by select committee, recommending the payment of \$24,039.80.

Rep. Rosa moved the insertion of an item, State funeral of H. R. H. Likelike, etc., \$24,039.80. He thought it would have been better if the Reform Government on coming into power had paid these claims. There was some carelessness in the incurring of these debts. The two Ministers baving to do with the matter were dead, the other two having been absent from the city at the time. Coming into power by force of arms the Reform Government should have settled such matters, but instead they would not have anything to do with them. It had come down to history that the Reform Government was down on anything emanating from the Royal Family. The speaker referred to the decision of the Supreme Court, when the King was sued through his trustees for the debts. That decision was technically right, although the change of Government was so swift that there was no time to have the orders of His Majesty ratified. He believed that the claimants had equitable grounds. The previous Legislature provided that some of the items be paid and others not, although it was a principle of law and equity that if one part of a contract was illegal the whole was illegal. Another thing was that those recommended to be paid a certain proportion were to give a receipt in full, but J. T. Waterhouse was paid without having given such a receipt. He did not like to attribute wrong, but this looked like partisan partiality.

Recess from 12:05 to 1:30.

The reception to Capt. Isaiah Bray, General Secretary of the Oakland Y. M. C. A., and his friends, at the Y. M. C. A. hall last night, was well attended. The platform was decorated with palms and ferns. Mr. T. Rain Walker, President, made a happy opening speech.

The musical part of the pro-gramme consisted of choruses from the Kamehameha Glee Club, a piano solo by Miss Carrie Castle, and a song by Miss Patch.

Mr. S. D. Fuller, General Secretary, gave a brief address of welcome, to which Capt. Bray responded. Mr. Charles Campbell, a former associate of Mr. Fuller in association work in Sacramento, said he expected to find a missionary field here subsisting on outside benevolence, instead of which he found a self-supporting Christian community assisting fields abroad.

Refreshments and social conversation closed the evening.

GOVERNMENT LAND SALE.

Mr. J. A. Hassinger, Chief Clerk of the Interior Department, held a sale at auction of Government land

at noon to-day. The leases of certain lands in Kau, Hawaii, were bought by W. G. Irwin & Co., Ld., represented by Mr. W. M. Giffard for the upset prices, viz.: Lease for 15 years of the lands of Kawala, Aemaloo, Poupouwela, Kanuamano, and Papaikou, 2700 acres, \$600 per annum. Lease for 15 years of Hionaa, 1332

acres, \$150 per annum. Hon. J. T. Baker bought the fee simple of 268 acres of grazing land at Kamehameiki and Pulehuiki, Kula, Maui, for \$2825. Hon. W. H. Cornwell and Mr. Monswar contested the sale inch by inch, or rather \$50 by \$50, with the successful bidder, until his last advance of \$25 broke the camel's back. The purchaser says the land will grow anything and is well watered.





Noble Macfarlane was doubtful about the legality of the lease, but there were some extenuating circumstances. According to Mr. Corn-well's statement his father let adjoining lands at \$75 a year, and he doubted if this could have been rented for more than the lease calls for. However, he would take the ground that the lease was illegal. It has been stated that Mr. Cornwell has a good claim for damages. Even if the Government would have to pay damages of \$20,-000 on account of breaking this lease, he did not think that the House could afford to make a new lease after the previous one had been adjudged illegal. He would not admit that the late Minister of the Interior was actuated by high motives and a conscientious sense of duty in breaking that lease. Mr. Thurston was personally interested in an adjacent piece of land—the land of Omaupio, situated in the middle of his Haleakala Ranch-in the case of which the application was carefully pigeon-holed and it was not until fifteen months after that the lease was put up at auction, when it brought \$730 per year. In that case Mr. Thurston was not paying a cent of rent, it was what is known as a "sleeper" on the land. There were numbers of other expired leases over the kingdom, including valuable business property and sugar lands, which should have been renewed by Mr. Thurston and at considerably advanced rentals. Noble Macfarlane then proceeded to read a list of these lands.

Noble J. M. Horner called the speaker to order. He should give is information to the Minister of

the Interior. Noble Macfarlane proposed to give the information to the House. If Noble Horner did his duty he would move a resolution to-morrow to have all the illegal leases of public lands broken, and the expired leases put up at auction at once as provided by law.

Noble Baldwin wished to correct the previous speaker. He was equally interested with Mr. Thurston in the ranch to which reference was made. There were thousands of acres there of which the outside public had more use than the nominal holders. The land was largely worthless for agricultural purposes, and it was when they desired to fence a portion of it for a cattle run that, in order to establish their right, they concluded to have it put up at auction. This was done and the lease run up to three or four times its value by Chinese and others. Whether the slur by the hon. Noble was intended for Mr. Thurs-

should be withdrawn. Rep. Cummings gave some facts from his own experience in leasing public lands to prove that the lease in question was a reasonable one when made. Opponents of this measure were overlooking graver encroachments on public rights, such as the harbor lease previously mentioned. A few years ago you could get all the land on the Honolulu plains for a dollar an acre, whereas now you could not get it for a thousand dollars an acre. Mr. Cornwell's enterprise had increased the value of this land, and now an outery was raised that he was getting it too cheap.

King's Guard shall consist of a captain and two lieutenants who shall be appointed or removed by His Majesty. These officers shall have power to make, alter and revoke all regulations not repugnant to the provisions of this Act, concerning enlistment, discipline, exercises, accoutrements, arms and clothing, and to make such other rules and orders as may be necessary to carry into effect the provisions of this Act, and to provide and prescribe penalties for any violations of such regulations not extending to deprivation of life or limb or the infliction of corporal punishment. Every such rule, regulation or order shall require for its validity the approval of His Majesty the King, and shall be countersigned by the Minister of Foreign Affairs.

His Majesty the King shall be Commander-in-Chief of al the military forces, and shall have power to convene courts martial and to confirm the sentences thereof, and vide for and regulate the sending of they appoint persons to serve with-Hawalian youths abroad to be edu- out pay on his personal staff with such honorary rank us he may de-

Section 4. There shall be a paid permanent military force of not less than 65 men nor more than 100 men of all ranks, which shall be named the "King's Royal Guard."

Section 5. The King's Royal Guard shall be the body guard of His Majesty the King, and the King shall have the sole right to appoint and commission all its officers, which commissions shall be countersigned by the Minister of Foreign Affairs. Passed.

Section 6. The soldiers of the King's Royal Guard shall be enlisted to serve for three or five years, and shall be men of good physical development and in sound health, which must be certified to by two regular physicians. One-half be-tween 20 and 30 years old shall be enlisted for three years, and onehalf between 20 and 25 years old shall be enlisted for five years, and all shall take the oath prescribed in Schedule A. Passed.

Section 7. All public property used for and in connection with the military forces of the Kingdom, and the expenditure of all moneys appropriated for military purposes and for bands, flags and salutes, shall be subject to the orders and under the general supervision and control of the Minister of Foreign Affairs.

Section 8. Any armed force not organized in accordance with the provisions of this Act shall be illegal, and is prohibited. Provided, however, that this section shall not

apply to the police. Noble Marsden moved it be indefinitely postponed. It will be illegal under this section for any rifle club to carry on its sport. It will work against the uniform rank K. of P., who wear uniform and carry

Noble McCarthy did not like the section as it stood. He moved to amend by inserting the words "without permission of Minister of Foreign Affairs."

Rep. Brown moved to amend so as to read "Any military or armed force." Noble Widemann-There are a

great many who take pride in a rifle club. They carry rifles and make a show of them when they go out. Noble McCarthy-The bill is aim-There is no harm in that. The amendment by Rep. Brown was a good one, but, if passed, there should be another section to provide for the punishment of anyone who would misconstrue it.

This Act shall be in full force and effect from and after the time of its approval, and Chapter XXV. of the laws of 1888, entitled "An Act relating to the Military Forces of the Kingdom," and all other laws and parts of 'aws in conflict herewith are hereby repeal-

ed. Passed. The schedule referred to in Section 6 was read and passed. The
