ALOHA. THANK YOU FOR INVITING ME TO ADDRESS ISSUES OF
CONCERN TO THE SENIOR CITIZENS NOT JUST IN MY HOME STATE OF
HAWAII BUT ACROSS OUR NATION AS WELL.

AS CHAIRMAN OF THE SENATE SUBCOMMITTEE ON COMMUNICATIONS, I
AM AWARE OF THE IMPACT THE ELECTRONIC AGE HAS ON EACH AND
EVERY CITIZEN. THIS IS BECAUSE WE ARE NO LONGER AN
AGRICULTURAL OR A MANUFACTURING ECONOMY BUT A SERVICE
ECONOMY.

THIS IS TRUE FOR BOTH THE STATE OF HAWAII AND THE UNITED
STATES, WITH COMMUNICATIONS ASSUMING PARAMOUNT IMPORTANCE.
ALL SECTORS OF THE ECONOMY DEPEND ON TELECOMMUNICATIONS:
WE HAVE ARRIVED AT THE STATE WHERE EVERYTHING --
PHOTOGRAPHS, INVOICES, TELEVISION PROGRAMS AND HUMAN SPEECH
-- CAN BE ENCODED AS DATA TO BE RELAYED AND MANIPULATED
THROUGH COMPUTERS.

TELECOMMUNICATIONS IS MORE THAN AN INFRASTRUCTURE. IT IS THE HEART OF EVERY DEVELOPED ECONOMY IN THE WORLD.

A WORD, NOW, ABOUT THE IMPORTANCE OF SENIOR CITIZENS IN OUR SOCIETY. IT HAS OFTEN BEEN SAID THAT OUR CHILDREN ARE OUR BEST RESOURCE AND OUR BEST HOPE FOR A BRIGHTER FUTURE. I ALSO CONSIDER THOSE WHO POSSESS THE VAST BREADTH AND DEPTH OF EXPERIENCE THAT COMES WITH AGE TO BE A MOST VALUABLE RESOURCE WITH MUCH TO CONTRIBUTE TO OUR COMMUNITY. WE NEED OUR SENIOR CITIZENS TO REMIND THE COMMUNITY WHERE WE HAVE BEEN AND TO COUNSEL SOCIETY ON HOW FAR IT HAS TO GO TO ACHIEVE ITS GOALS. OUR CHILDREN ARE OUR IMMORTALITY. BUT IN THEIR VEINS RUNS THE BLOOD OF THEIR ELDERS WHO GAVE THEM LIFE. AND SENIOR CITIZENS . . . MYSELF INCLUDED . . . SHOULD BE THE SOURCE OF INSPIRATION, GUIDANCE AND ENCOURAGEMENT TO THOSE WHO WILL LEAD US TOWARDS A BETTER TOMORROW.

I MENTIONED EARLIER THE IMPORTANCE OF COMMUNICATION IN OUR SERVICE-ORIENTED ECONOMY. COMMUNICATION IS ALSO IMPORTANT FOR ANYONE WHO ACTIVELY PARTICIPATES IN THE AFFAIRS OF HIS COMMUNITY. COMMUNICATION FOSTERS UNDERSTANDING, AWARENESS AND KNOWLEDGE. THUS, THE INFORMED PERSON HAS THE ADVANTAGE OF INFLUENCING DECISIONS AND EVENTS THAT AFFECT HIS LIFE, HIS COMMUNITY AND THE FUTURE OF HIS CHILDREN.

WHEN YOU INVOLVE YOURSELF IN THE DECISION-MAKING PROCESS, YOU ARE, IN EFFECT, FULFILLING YOUR OBLIGATION AS AN AMERICAN CITIZEN. WE ARE ALL OBLIGATED TO PARTICIPATE IN THE DEMOCRATIC PROCESS BECAUSE, HOWEVER IMPERFECT, DEMOCRACY IS OUR WAY OF LIFE. IT IS THE SYSTEM UPON WHICH WE BASE OUR IDEALS AND OUR PRINCIPLES. AND WITHOUT OUR IDEALS AND OUR PRINCIPLES, THERE IS NOTHING SPECIAL OR WORTHY TO DEFEND.

WE CAN INVOLVE OURSELVES IN THE DEMOCRATIC PROCESS IN ANY NUMBER OF WAYS. WE CAN ENGAGE IN DISCOURSE AND DEBATE IN SO-CALLED TOWN MEETINGS, MUCH AS THE EARLY SETTLERS DID AT THE MASSACHUSETTS BAY COLONY IN THE MID-1600'S. IN THOSE DAYS, ATTENDANCE WAS MANDATORY AND ABSENTEES WERE FINED. THOMAS JEFFERSON'S VIRGINIA DID NOT SUBSCRIBE TO THIS DEMOCRATIC SYSTEM BUT HE NEVERTHELESS PRAISED THE TOWN MEETING AS "THE WISEST INVENTION EVER DEvised BY THE WIT OF MAN FOR THE PERFECT EXERCISE OF GOVERNMENT."

WE CAN ALSO PETITION OUR GOVERNMENT WITH A LIST OF OUR GRIEVANCES. AND WE CAN EXERCISE PERHAPS THE MOST POWERFUL INSTRUMENT OF DEMOCRACY -- THE POWER OF THE BALLOT. WE SAW HOW "PEOPLE POWER" IN THE PHILIPPINES TRANSFORMED THAT COUNTRY IN 1986. JUST THIS YEAR, WE WITNESSED THE MOMENTOUS CALL FOR CHANGE IN SOUTH AFRICA, WITH THE OVERWHELMING APPROVAL OF A REFERENDUM ENDORSING CURRENT NEGOTIATIONS FOR A MULTI-RACIAL AND DEMOCRATIC CONSTITUTION.

THE BALLOT BOX CAN WIELD ENORMOUS POWER AND INFLUENCE BEYOND THAT OF THE BAYONET OR THE BARREL OF A GUN. A VOTE THAT IS CAST IS AN THE EXPRESSION OF THE WILL OF THE PEOPLE. WHEN PEOPLE EXERCISE THEIR RIGHT TO VOTE, THEY DEMONSTRATE THEIR DESIRE TO HELP SHAPE THE COURSE AND DIRECTION OF THEIR COMMUNITY, AND THEIR COUNTRY.

WHILE I HAVE WORKED TO ADDRESS ISSUES OF SPECIFIC CONCERN TO SENIOR CITIZENS, THERE HAVE ALSO BEEN ISSUES WHICH TOUCH ON ALL AMERICANS, REGARDLESS OF AGE. I RECENTLY WORKED OUT AN AGREEMENT TO BUILD A VETERANS HOSPITAL ON THE GROUNDS OF THE TRIPLER ARMY MEDICAL CENTER. I WAS ABLE TO WIN APPROVAL OF A NUTRITION SERVICES PROGRAM FOR ELDERLY NATIVE HAWAIIANS. I HAVE CONSISTENTLY FOUGHT AGAINST CUTS IN THE TWIN PILLARS FOR SENIOR CITIZENS -- SOCIAL SECURITY AND MEDICARE. I WILL CONTINUE TO SUPPORT EFFORTS TO PREVENT STATES WHICH IMPOSE THE SO-CALLED "SOURCE TAX," WHICH IS AN INCOME TAX ON THE PENSION INCOME OF INDIVIDUALS WHO ARE NOT RESIDENTS OF THAT STATE. AND I WILL NOT GIVE UP THE FIGHT TO ELIMINATE THE DISCREPANCY IN SOCIAL SECURITY BENEFITS RECEIVED BY THOSE BORN BETWEEN THE YEARS 1917 AND 1926.

OF GENERAL INTEREST THIS YEAR TO ALL AMERICANS WAS THE SENATE'S PASSAGE OF WHAT IS CONSIDERED THE NUMBER ONE CONSUMER BILL BEFORE THE CONGRESS THIS YEAR -- THE CABLE TELEVISION CONSUMER PROTECTION ACT OF 1991. THIS BILL, WHICH I COSPONSORED, PROPOSES TO SCALE BACK EXCESSIVE CABLE RATES AND PROMOTE COMPETITION IN THE CABLE INDUSTRY.

I HAVE ALSO PUSHED FOR A NATION-WIDE STUDY ON WHETHER TO GRANT TAX BREAKS TO THOUSANDS WHO LIVE ON LEASE LAND.

I AM HEARTENED TO SEE OUR ELDERLY -- THE "NA KUPUNA" -- CONTINUE TO TAKE SUCH AN ACTIVE INTEREST IN THE AFFAIRS OF OUR GOVERNMENT. YOUR PARTICIPATION IS MOST WELCOME, AND MOST URGENT. AS A SENIOR CITIZEN MYSELF -- I CAN ATTEST TO THE WILLINGNESS AND ABILITY OF SENIORS TO CONTRIBUTE TO OUR SOCIETY. WHEN WE COMBINE OUR SKILLS, WISDOM AND OUR ENERGY WE CAN MEET ANY CHALLENGE, AND SECURE ANY GOAL. I COMMEND YOU FOR YOUR EFFORTS TO SERVE OUR COMMUNITY. ALOHA.


Dear Jon:
