Surely, in view of these facts Judge Robinson, having abandoned his position regarding the Portuguese, will go one step further and withdraw the Koreans from this class, for thus only can he escape the fate of the man who was laughed out of court.

Pauperism In America ***********************

The census bureau has just isthe pauperism of the United States as represented by the paupers in almshouses during the year 1904. The number of paupers enumerated in almshouses on December

31, 1903, was \$1,764 and the number admitted during 1904, \$1,412, r aking a total of 163,176 persons who were in almshouses during the whole or a part of the year 1904. Of this total 111,817 were males and 51,359, females. The number enumerated included 52,444 males and 29,320 females and the number admitted, 59,373 males and 22,039 females.

The number of paupers enumerated in almshouses in 1880 was 66,-203 and in 1800, 73,045. But although the number of almshouse paupers is increasing, the increase has not kept pace with the growth of population and consequently the ratio of almshouse paupers to population ber of almshouse paupers in each o lation is decreasing. In 1880 it was 132 per 100,000 of population; it decreased to 116.6 in 1890 and to 101.4 in 1903. In part at least this decline in institutional pauperism is due to changes in the treatment of the mentally and physically defective poor, who in former times were sent to almshouses but are now cared for in hospitals or asylums, and also to the development of rationally organized charity, which strives to make the poor self-supporting and to place destitute children in families rather than in almshouses.

During the decade 1880 to 1890 the number increased and the ratio decreased for both male and female paupers in almshouses, but during the period 1890 to 1903 the number increased and the ratio remained rearly stationary for the male paupers, while both the number and the ratio decreased for the female paupers. At each census the ratio was less for females than for males.

Although pauperism is less prevalent among females than among males, the chief distinction between the two sexes seems to be that females, having once entered an almshouse, aer there permanently, while men, to a large extent, only winter boarders.

Th percentage of discharges do not, however, signify that the discharged never return, for of thousands who are discharged with the opening summer, the majority can be depended upon to return with the cold weather. In fact, the number admitted during 1904 were, for the most part, seasoned inmates.

This mobility of the almshouse population suggests that many inmates are able to provide for their own support for a part of the year at least, and this is found to be the case, since about three-fourths, 74.6 per cent, of those discharged were discharged "to their own keeping" rather than to the care of relatives or friends.

There is, however, no reason to believe that many immigrants drift into almshouses soon after their arrival in the United States, for only 2.3 per cent of all the foreign born in almshouses had been in this country less than 5 years. Among the different nationalities of foreign born whites the degree of thrift, combined with racial characteristics, seems to determine, in large part, the tendency towards pauperism

That pauperism is in a large measure a concomitant of age and its accom panying evils is shown by the large percentage (59.7) at least 50 years of age and the rapid increase in the numthe succeeding quinquennial age per-iods between 35 and 65 years, after which the high death rate prevents any further increase






