In an effort to improve the lines of communication within our party and to make our endeavors more effective, it would be helpful if you would supply information about the newspapers, television and radio stations in your district.

This list is imperfect, and it is the hope that it can be brought up to date as well as sugmented by the addition of certain other information. It is also hoped that you will make a notation of any newspaper or station which has gone out of business or been replaced, or of any additions to the media in your district.

The additional information requested is the answers to the following questions:

1. Has the newspaper, radio or television station been friendly toward you?
2. What is its general political alignment?
3. Is it influential in political matters?
4. Has it been friendly toward the Kennedy administration?
5. Who among the editors (or newscasters) has been most friendly?

6. Which writer is the best contact for political news?

The cards furnished are work cards, and it would be most convenient if concise answers were appended directly to the cards.

Comments about other publications which might come into your district or which might extend from your district into others, also would be appreciated, as well as any other information pertinent to the subject-matter of this letter.

It is important that these notations be completed within a few days. Someone will stop at your office beginning Wednesday to pick up the completed cards or to provide any assistance desired.

Your co-operation will be sincerely appreciated. I believe that completion of this project will be beneficial to all of us.
