

CZAR SPEAKS FOR PEACE

Asks Europe to Decease Its War Paraphernalia.

Would Thus Secure Continual Peace—Humanitarian Views Put Forward.

London, Aug. 28.—The text of the note to the powers issued at St. Petersburg is as follows: The maintenance of general peace and the possible reduction of the excessive armaments which weigh upon all nations, present themselves in existing conditions to the whole world as an ideal toward which the endeavors of all governments should be directed.

International discussion is the most effectual means of insuring all peoples benefit—a real, durable peace, above all, putting an end to the progressive development of the present armaments.

In the course of the last twenty years the longing for general appeasement has grown especially pronounced in the consciences of civilized nations; and the preservation of peace has been put forward as an object of international policy.

It is the better to guarantee peace that they have developed in proportions hitherto unprecedented their military forces and still continue to increase them, without shrinkage from any sacrifice.

The financial charges following the upward march, strike at the very root of public prosperity. The intellectual and physical strength of the nations' labor and capital are mostly diverted from their natural application and are unproductively consumed.

It appears evident that if this state of things were to be prolonged it would inevitably lead to the very cataclysm it is desired to avert and the horrors whereof make every thinking being shudder in advance.

To put an end to these incessant armaments and to seek the means of warding off the calamities which are threatening the whole world—such is the supreme duty today imposed upon all states.

Filled with this idea his majesty has been pleased to command me to propose to all the governments whose representatives are accredited to the imperial court, the assembling of a conference which shall occupy itself with this grave

problem. This conference will be, by the help of God, the happy presage for the century which is about to open. It would converge into one powerful focus the efforts of all states sincerely seeking to make the great conception of universal peace triumph over the elements of trouble and discord, and it would at the same time cement their agreement by a corporate concentration of the principles of justice and right whereon rest the security of states and the welfare of peoples.

NEW INTER-ISLAND BOAT.

CANADIAN-COLONIAL CABLE

New Zealand Recommends the Four-Ninths Scheme.

Legislative Committee Reports Favorably—Canada to Have Construction in Charge.

Wellington, (New Zealand), August 31.—The report of the Committee on Legislature, just issued, recommends joining the Australian colonies with Canada and the mother country by a Pacific cable, on the basis that if Great Britain and Canada together would guarantee five-ninths of the cost of the work, New Zealand and the other colonies would contribute the remaining four-ninths, of which amount New Zealand will contribute one-ninth.

The committee also recommends that Canada be intrusted with the construction administration, and maintenance of the cable on the understanding that the contributing colonies are to be entitled to representation and votes on matters of policy of the management, and that the cable is to be jointly owned and controlled by the contributors. The report concludes by advising that a conference of the colonies concerned in the new cable be held in New Zealand.

Nicaragua and the Canal.

Managua, Nicaragua, August 18.—The Diet of the Greater Republic of Central America has asked the Government of Nicaragua for all the documents in its archives relating to the construction of an interoceanic canal across Nicaragua, for the purpose, as El Liberal, Government daily newspaper says, of "investigating the reasons why the United States of North America appears to have decided to construct the canal."

Luanai At Anahau.

The luau given by the Princess Kaiulani at Anahau in honor of the Commissioners, was a decided success. In all there were some 150 people present. The luau was in the lanai where three tables were arranged in native fashion. The Quintette club and the New York regiment band furnished the music. Dancing occupied the latter part of the evening.

Natives Quit Work.

A dozen or more natives, constituting the lumber carrying force at Allen & Robinson's wharf, quit work at 12 noon today. The men had trouble with George Allen, the foreman, and refused to do anything more.

Joe Duchalsky who stowed away for Manila in the Australia when that vessel passed through here with troops, came back on that vessel this morning. DREYFUS AFFAIR AGAIN

Col. Henry Admits Forgery and Then Suicides.

This Forgery Played Important in Conviction—France Again Stirred Up With Army Matters.

New York, August 31.—A Sun cable from Paris says: A day of anguish to the vast majority of Frenchmen, ended today in indescribable emotion, caused by the news that the author of the army's latest disgrace had committed suicide in the cell he occupied in the fort at Mont Valerian. Colonel Henry, who was arrested yesterday on a charge of having forged a letter that had an important bearing on the Dreyfus case, was found lying in a pool of blood, having cut his throat with a razor he had taken to prison with him in a bag containing clothing. His confession of the forgery was immediately reported to Cavaignac, Minister of War.

It is a bare, terrible fact, that an officer, holding one of the most responsible and most delicate positions in the French army, head of the department concerned in procuring secret information, should have stooped to forgery in the pursuit of an obscure, underhand plan, that fills Frenchmen with despair of whom to trust, whom to believe among all officers concerned in the trial of Dreyfus. For the moment, anti-Dreyfusites and Dreyfusites among the Parisian public maintain their previous contentions more vehemently than ever. The former are now cursing both Colonel Henry and Dreyfus, but in Government circles the forgery revelations are working momentous changes. There is authority for stating that Cavaignac has decided to grant a revision of Dreyfus' sentence. True, he maintains that Colonel Henry's forgery does not affect the proofs of Dreyfus' treason, but his speech in the Chamber of Deputies, which was rapturously applauded and placarded throughout France, in which he proclaimed his possession of proofs of treason, was based on Henry's forgery.

To Muster Out Rough Riders.

New York, August 31.—General Wheeler received a telegram from Adjutant-General Corbin today directing him to muster out the Rough Riders at Camp Wikoff at once. The cavalrymen will accordingly be mustered out of the service here tomorrow.

Pavloff Sent from China.

London, August 29.—The Daily Mail's Peking correspondent says: "M. Pavloff, the Russian Charge d'Affaires in China, who has been appointed Russian Minister to Corea, will be succeeded by M. de Giers, who is at present accredited to Brazil. M. Pavloff's removal is generally attributed to Great Britain's sudden change of policy, the object of which was to impress Russia with the advisability of recognizing our paramount influence in the Yang-tse Kiang valley.

No Occupation Yet.

There is no sign of the occupation of the Executive and National Guard buildings by a detail from the United States garrison. No reply has been received to Minister Cooper's statement of the Government's position sent to General Merriam last Monday.

Hawaiian National League.

The Executive Committee of the Hawaiian National League is holding a meeting this afternoon. It has been decided to allow a committee from the league to meet for a conference with another from the Hui Aloha Aina as requested by the latter. This will take place next week.

OUR TIGHT LITTLE ISLAND

Wailua Already in Training for Its Great Expansion.

Labor Healthy and Quiet—Railroad Extension Humming—Dr. Peterson Back from Inspection Tour.

Dr. C. A. Peterson, Inspector of Immigrants, was at his desk in the Agricultural Bureau this morning, after an official visit to Wailua, Kahuku and Laie plantations. He found almost no sickness—nothing to speak of.

Everything was quiet. There was not a vestige of restlessness among the Japanese laborers, following the expectation of a general strike, against contracts and for higher wages as free labor, consequent upon the hoisting of the American flag. The warning issued by Colonel Hirai has evidently had a most wholesome effect.

Wailua plantation is just finishing up its crop, amounting to about two thousand tons of sugar. Everything is being managed on the plantation to suit the immense expansion of its scope under the new company. The corporation just formed will have two thousand acres prepared for the first planting.

Both at Ewa and Wailua it was understood as decided that W. J. Lowrie, the manager who has piloted Ewa plantation up to its unparalleled position, would take charge of Wailua plantation the first of October. Mr. Lowrie will be back from the Coast in the Belgic on Friday night.

The O. R. & L. Co. is putting up a fine station at Wailua opposite the church. Finishing touches are being put on the railway bridge there. Pile drivers are being put in place for work at the Waimea bridge on the Kahuku extension. The line is nearly all graded from Waimea gulch to Kahuku. Contractor Jensen's camp is lively.

It is impossible now to go from Wailua over the gulch in a buggy, unless one has a crew enlisted to drag the vehicle up over the rocks after crossing the quicksands, as the Government bridge swept away by flood has not been rebuilt.

A native farmer a little beyond Kaena Point has piped water from a place high up in a gulch to his little holding near the railway—quite a neat piece of engineering.

Dr. Peterson is now making up his reports. He will probably go to Maui next, leaving Heeia and Waimanalo plantations, on this island, for visiting later.

Mrs. W. G. Irwin received news by the Australia of the death of her brother, Mr. Alfred Ivers of Oakland, on July 30. Mrs. Ivers, the mother, is now stopping with Mrs. Irwin at Waikiki.

ARMY OF 100,000 PROPOSED.
 Congress Will Be Asked to Pass the Necessary Law.
 New York, August 27.—One of the important matters that will occupy the attention of Congress at its next session will be legislation to increase the strength of the permanent military establishment, says the Washington correspondent of the Tribune. Chairman Hull of the Committee on Military Affairs of the House will, early in the coming session, introduce a bill to correct the defects in the existing law and to increase the strength of the Army on a peace footing to 100,000 enlisted men. The strongest opposition to the reorganization bill last winter and spring came from the representatives of the National Guard organizations of the various states. The experience of the last four months, there is no reason to believe, has convinced that element, as well as a great many Congressmen, who surrendered to its influence, that the opposition was ill-judged and unreasonable.

Sugar Factory to be Idle.
 Salinas, August 31.—The new sugar factory of the Spreckels Company at this place will not be in operation this year. All the beets in Santa Cruz, San Benito and Monterey counties that were to come here for consumption will be crushed in the Watsonville factory. 

SOME MILITARY MATTERS

General Merriam's Work Being Completed He Will Soon Leave.

Inquiry Into Manoa Valley Vandalism—Colonel Fisher Talks About the Standing of the National Guard.

An officer of high rank in the United States uniform said to a BULLETIN reporter yesterday that he did not think the Executive buildings or grounds would be occupied by the troops.

As previously stated in this paper, the Government has offered the old stone barracks for housing a detachment of the garrison to do the saluting and guard of honor functions for Uncle Sam when required.

General Merriam and staff will leave in the Australia. Since the creation of a military district covering the islands their work here is about done.

An order was promulgated late Tuesday convening a Board of Officers, with Major Emmett at its head, to investigate acts of vandalism apparently committed by U. S. soldiers.

Colonel Fisher is annoyed at having been falsely represented in print as the authority for unfounded statements regarding the occupation controversy. No reporter had seen him about the matter, and the use of his name was wholly gratuitous.

He says the National Guard of Hawaii is an association existing under the laws of Hawaii, which laws continue in full force and effect until new laws be made by Congress, in accordance with the annexation resolution. If the premises heretofore occupied by the National Guard be now occupied by United States soldiers, the National Guard will simply have to move out. Their company rooms had been fitted up at the expense of the men themselves and it would be hard lines for them to suffer summary ejection. Then there might be annoyance arise from the necessity of passing the garrison sentries by N. G. H. men going in and out.

Regarding the talk about mustering a Hawaiian battalion into the United States service, Colonel Fisher disclaims any authority or responsibility in the matter. If the United States military authorities desire to muster in a local battalion, it is their function to publish a notice to that effect and abide the results. Had the war lasted, however, a Hawaiian battalion could have been mustered in, "in a wink," for active service in the Philippines.

An Insurrection Claim.
Mr. Sweger, attorney, presented the claim of Harry Juen before the Hawaiian Commission yesterday. It is for damages for illegal arrest, imprisonment and deportation of the claimant in connection with the insurrection of 1895. The late Minister Willis refused to press the claim, which was then sent direct to the State Department at Washington. The Department advised Juen to exhaust all judicial remedies in Hawaii. But the Hawaiian Government had, in the meantime, had a law passed preventing anyone, without the consent of the Legislature, from prosecuting the Government for damages for anything arising out of the suppression of the insurrection. Chairman Cullom accepted the claim for filing at Washington.

If steamships could run for political office, the Australia will be on top of the popular wave.

It's a case of whistle and wait for those who want to know what the Commission is driving at.

The Executive certainly has no reason for worry from President McKinley's instructions thus far.

Secretary Alger says the people have no reason to make him "dance on the carpet," but the people don't see it that way.

Times will be hard and there'll will be snow in the streets of Honolulu, when Hawaii can't get up some sort of a political circus.

France is again racked by the Dreyfus sensation. The facts of the practical murder of this officer are bound to come to the light sooner or later.

Tell American ship builders that they can't furnish ships enough under the American flag to do the Hawaiian business and see what they say about it.

Granting that Hawaii is a political hodge podge, may the Powers be merciful to the man who selects a name for Porto Rican, Cuban and Philippine political conditions.

The steamer Malolo and the Hawaii channels won't be in it for numbers when compared with the politicians who will be fishing for Hawaiian office about the Washington mill pond.

It does begin to look as though Minister Cooper were after all the commander-in-chief of the American military. If he wins the fight for the Executive, we'll have to congratulate him as the winner against big odds.

In the midst of war mutterings the Czar of Russia sounds a note for international peace. It is a good thing to talk about but we doubt whether any of the European nations, Russia included, will withdraw any orders for war equipment.

Our Advertiser friends appear to have forgotten that Senator Ingalls, who said: "The best governed city in the United States is the city where the people do not govern themselves" is no longer in politics. The people delivered him of his office and when last heard from, Ingalls was reporting prize fights.

If the Chamber of Commerce is actually considering asking the American Congress to make an exception of Hawaii in the extension of coast wise shipping laws, we trust its members will think twice or even three times before jumping. Such action is bound to arouse the antagonism of every shipping man in the States. These men have heretofore been among the staunch friends of Hawaiian business interests. Certain it is that what is worth having is worth asking for, but we fear that by asking too much special legislation our business people stand liable to turn former friends into strong enemies.

NO COMMISSION GOVERNMENT.

So the Advertiser thinks this country whose institutions have been built up on American principles, has suddenly become a political hodge podge. We are sorry to note the sudden falling away from the good works of the American business men and American missionary. Not without personal reason, the morning organ has cause to fear a government by the people. But it should not allow private greed to run away with its views on what is best for the country. A commission government is hinted at, and yet in the same columns the Commission now sitting is ripped up the back for its secretive methods. We do not believe in the methods of the present Commission, and having had this experience we see no reason why government by commission can be more acceptable than government by the people. Of course when the Advertiser talks about government by commission, it is to be taken for granted that the scheme will be a fine one—if the Advertiser constituents are made the controlling members.

There is no reason why the Republicans should give the Hawaiian territory anything more restricted than manhood suffrage. As a territory the islands will cut no figure in Presidential or Congressional elections. There is no reason why every American citizen in this territory should not be given the right of franchise. If in the course of time the people here find certain restrictions necessary to the welfare of the territory, then will be time enough to talk and let the people decide for themselves. There are some leaders here who are afraid of the people. We trust that the Commission in its deliberations will not allow itself to be swayed by the theories of the minority.

"As a rule" appointive offices will be filled as usual; "republic does not necessarily imply independence." These are some of President McKinley's instructions. There is room for still farther definite interpretation.

COURT NOTES.

Trial Long Drawn Out—Papers on File.

Lucas vs. Perry, quieting of title, mixed jury before Judge Stadley, is on for the twelfth day. It will go to the jury this afternoon. Only rebuttal witnesses were left this morning.

Wm. White of Lahaina, the famous politician, has taken the oath to qualify for renewal of license to practise in the inferior courts of the Hawaiian Islands.

W. R. Castle and P. L. Weaver, attorneys of record for W. S. Luce, administrator of the will and guardian of Beatrice M. G. Luce, minor heiress, in the matter of the estate of the late Mary E. Luce, have filed withdrawals in both cases.

Bruce Cartwright by his attorneys, Monsarrat & Weber, has filed a supplemental petition for perpetuating testimony in the suit of petition against R. W. Wilcox and others on a claim of title to certain lands in Palolo Valley.

FIGHTING IN CHINA.

Government Troops Said to Have Suffered Defeat.

London, Sept. 1.—A special dispatch from Shanghai dated Wednesday says—

The Chinese Government troops, it is reported, have been defeated in two pitched battles during the last ten days by the Kwangsi rebels, losing 3000 men. The rebels are said to number 80,000 and the provincial forces are against them.

A Governor of high rank has been ordered to lead his troops in person and competely suppress the rebellion within a month, under penalty of severe punishment.

An imperial edict just issued strongly censures the Governor of Kwangsi province for deceiving the Emperor in July last by reporting that the rebellion had been suppressed.

FOREIGN NOTES.

The steam whaler Fridjof has arrived at Tromsø, Norway, after landing Explorer Wellman and his party in the Arctic.

General Merritt has left Manila for Paris where he will appear before the Peace Commission.

Washington, Aug. 30.—Orders have been sent by the War Department to Manila, directing that General Greene, United States Volunteers, be sent to San Francisco to be mustered out, that General Babcock return to San Francisco for duty as Adjutant General of the Department of California, and that Major Simpson report at Washington for duty in the Adjutant General's office.

OLD BOAT BACK.

Australia Arrives from San Francisco This Morning.

It was certainly a good sight to see the old Australia hauled alongside the Oceanic wharf this morning with Captain Houdlette on the bridge, Chief Officer Lawless giving orders to the men, "Tommy" McCombe rushing around attending to the newspaper men and Chief Neiman standing on the deck bowing to his many friends on the wharf.

She was to have sailed on the 2d of this month and the agents were not expecting her until tomorrow. As it was she got away a day sooner. A fine trip throughout was experienced. The Australia brought 23 cabin and 40 steerage passengers. Most of the latter are men in search of work down here. The Australia also brought 57 bags of mail and a cargo of general merchandise.

On account of the fact that the Australia was not looked for until tomorrow, the Scandia was not moved from the Oceanic wharf. This caused the Australia to wait a half hour in the stream or until the Scandia could get out.

H. C. Houdlette, commander; R. T. Lawless, chief officer; P. Anderson, 2d officer; Geo. W. Lasswell, 3d officer; W. H. Neiman, chief engineer; J. W. Smith, 1st assistant engineer; Jas. O' Connor, 2d assistant engineer; T. C. McCombe, purser; Dr. H. J. McNulty, surgeon; J. G. Penfield, chief steward.

Well Officered School.

Mr. Fitz, who arrived in the steamer Aorangi, has come out from Hurstpierpoint, England, to take up a position in Iolani school, the institution long maintained with an excellent record by Bishop Willis. The school is now in the hands of Mr. Lane, seconded by Mr. Fitz, and perhaps has never had a stronger staff than it has today. The Bishop has also Miss Heslop acting as matron of the school, which takes boarding as well as day pupils. A number of new boys have entered this term.

Moonshiner Nalei.

Deputy Marshal Chillingworth, in the guise of a soldier, went far up into Maunā Tuesday night and captured the Moonshiner Nalei who had in his house, okolehao of the finest brew. In the Police Court this morning the defendant plead guilty to the charge of distilling liquor.

Nalei was released from jail four years ago when he had been sent for ten years, having been found guilty on the Island of Kauai of murdering a Japanese, his associate in the work of distilling liquor.

The Japanese and he had a quarrel on the banks of one of the streams. The two fell in and Nalei, being the superior swimmer, held his antagonist under water until he was dead.

When arrested by Deputy Marshal Chillingworth last night he confessed his guilt in the matter of distilling okolehao.

ITEMS FROM HARBOR FRONT

The schooner Olga has arrived safely in Eureka from Kahului. The Scandia hauled over to the Irmgard wharf this morning.

The schooner Orient arrived in Port Blakeley from this port, August 31. The brig Lurline sailed from San Francisco for Kahului, August 31.

Nanaimo, B C—Sailed Aug 30, ship Henry Villard with coal for Honolulu.

Tatoosh—Passed out August 27, ship J B Brown, from Nansaimo for Honolulu.

The Santiago from Hilo, arrived in San Francisco, August 30, 23 days from that port.

The Noeau will make an attempt at recovering the Honokaa Mill roller lost at Honokaa.

The Vincent is taking on ballast while discharging the last of her coal at the Fort street wharf.

The S G Wilder, McNeil master, sailed for San Francisco with a full cargo of sugar early this afternoon.

The R P Rithet has been chartered by Welch & Co to bring a cargo of general merchandise to this port.

The Maui was unable to get away yesterday. She sailed this forenoon, taking the foreign mail to Hilo.

The bark Mobican sailed from San Francisco for this port, August 28. She should be here inside of a week.

The steamer Iwa sailed for Makena yesterday afternoon but returned to port later with her machinery broken down.

The R P Rithet, 31 days from Honolulu and the Transit, 29 days, both arrived in San Francisco for this port, August 29.

The Australia brought the news that, while on the way from Manila to Nagasaki for coal on the return trip, the O S S Zealandia was caught in a terrific typhoon which promised for a while to result disastrously. Luckily the Zealandia weathered the Horn.

Word was received yesterday from St. Michaels, Azores, of the arrival there of the British ship Philomena, from Baltimore to Honolulu. Her cargo had become heated, and she will have to discharge about half of it and will also undergo a new survey.—S F Chronicle, Aug 28.

Purser Fernback of the James Makee reports as follows on Kauai shipping matters: Fine weather on Kauai. Mikahala at Hanamaulu. Landed roller in good shape on Hanamaulu side. She will be in tomorrow. Sugar left, 3000 bags at Hanamaulu, 3000 at Koloa and 71 at Makaweli.

The four-masted schooner Defender left Hilo ten days before the bark Santiago, but Captain Johnson of the bark wagered that he would not be more than ten hours behind the Defender when the voyage was over. He kept his word, as both vessels reached port yesterday morning. Twice this year the Santiago has made the run to Hilo in twelve days, and Captain Johnson says he will equal that on the run to San Francisco before the year is out.—S F Call, Sept 1.

The steamer Charles Nelson returned yesterday from Honolulu after delivering safely her share of the New York Volunteers now doing garrison duty on the islands. She left Honolulu the same day as the Moana and made the return trip in eight days. She brought several passengers, among them T W Hobron, an influential resident of Honolulu, who has come up to arrange for the shipment of a yacht he is having built at Tiburon and which he intends to use at his island home.—S F Chronicle Aug 28.

The Hawaiian bark Helen Brewer has just completed a trip that breaks all previous records and wins for her skipper, Captain Mahoney, \$500, says a late San Francisco paper. The \$500 was a pool made up by Captain Mahoney and the master of four other ships that left New York on the same date. The Brewer left New York with 62,000 cases of kerosene on April 2d, crossed the equator April 25th and passed the meridian of Cape of Good Hope May 19th. She anchored at Anjer June 21st, and arrived at Wosung July 13th, having made the voyage in 102 days.

Judge Early of Arizona, who arrived in the Mariposa, thinks the Hawaiian climate all right.

Among the arrivals on the James Makee this morning were the following: Mr and Mrs W H Rice, C M Cooke Jr and Col De La Vergne.

The last of the expeditionary soldiers in the Queen's hospital was transferred to the United States Army hospital day before yesterday. It was Sergeant Hatcher.

A drawing of the store and office building to be erected by Sam. C. Allen, at King and Alakea streets, by Mr. Traphagen the architect, is shown in the Hawaiian News Co. window. It is of a handsome three story block.

No word has been received from Ernest G. Thrum by his family, although the Panama steamer had arrived two days before the departure of the Australia. He was a passenger in the ship Kenilworth, put into Valparaiso burning a few weeks ago.

The Arizona has not hauled alongside yet. She will not get away as she is to take on eight or nine hundred tons of coal yet. Captain Messer of the Scandia says he will get out by Sunday. No additional orders were received by the Australia for either vessel.

At three o'clock this morning the inmates of the Mills Academy were startled by the cry of fire and great excitement prevailed. The fire was in a kitchen in the rear of the building and threatened to become serious. Mr. Schroder of the Mechanic's Home organized a "bucket-brigade" and the incident was soon pau.

Captain Houdlette of the Australia was asked why he did not invest in a few hundred thousand cigars on speculation when he was at Manila. "I could only manage to get 5000 for myself through hard work," he answered. The captain had to work it a round about way through officers of British warships that had the privilege of getting in to the inner harbor.

Charles Clark, the attorney, has been a resident of Honolulu for one year and his growing practice attests his popularity and ability. Mr. Clark came here from New Jersey. He was admitted to the bar in New York, which is far more rigorous in its examination of candidates for the bar than another state in the Union. He has figured in national politics and came to Honolulu on the account of his wife's health.

St. Paul Arrived.

Manila, August 31.—The transport St. Paul arrived today.

Under American or Spanish Flags.

London, September 1.—The Manila correspondent of the Times telegraphing Wednesday says: Pursuant to the decision of the Washington Cabinet regarding trade with Spanish ports in the Philippines General Otis, who is now acting Governor of Manila, communicated on the subject with the Spanish General, Rios, now acting Governor-General of the Spanish possessions in the Philippines, who replied today from Iloilo, agreeing to permit commercial vessels to enter ports in the archipelago under Spanish or American flags.

Arrangements have been made to facilitate bona fide transfers of vessels to individuals legally entitled under the Consular regulations to carry the American colors.
