## Court issues TRO to Tinian poll hearings

The certification of the results of the recent general elections may stand to be delayed indefinitely after the Superior Court yesterday issued a temporary restraining order to inhibit the Board of Elections to conduct hearings on some 24 contested ballots on Tinian.

Associate Judge Alexandro Castro read out the preliminary injunction order and scheduled a final hearing on December 6, 1991, after lawyer Theodore Mitchell indicated his intention to seek summary judgment and permanent injunction.

Mitchell, acting as counsel for plaintiffs Esteven M. King et al, filed motions for TRO and preliminary injunction after he allegedly found the Board of Elections acting in excess of its lawful authority to the substantial damage of the plaintiffs.

It was argued that the poll body has no jurisdiction to conduct hearings on contested ballots on the First Senatorial District. The plaintiffs reportedly requested the poll body to stop these hearings without any luck.

Court records show that the board held hearings on Tinian to hear challenges made on the eligibility and residency requirements of 24 voters starting on November 12, with the next hearing supposed to be scheduled yesterday.

According to the plaintiff's motion, under the current Election Code, the jurisdiction to hear and determine election

contests is vested either in the Commonwealth Senate, the House of Representatives, or the Superior Court, depending on the election on issue.

If the object of the challenged vote is a seat in the House, then it is the House that should hear the case; if a seat in the senate is contested, the Senate; all others in the executive branch, contests are to be filed before the Superior Court.

Prior to the enactment of Public Law 5-7 in April 9, 1986, the Election Code provided that all election contests were to be initiated in the Board of Elections, from which appeals could be taken to the courts.

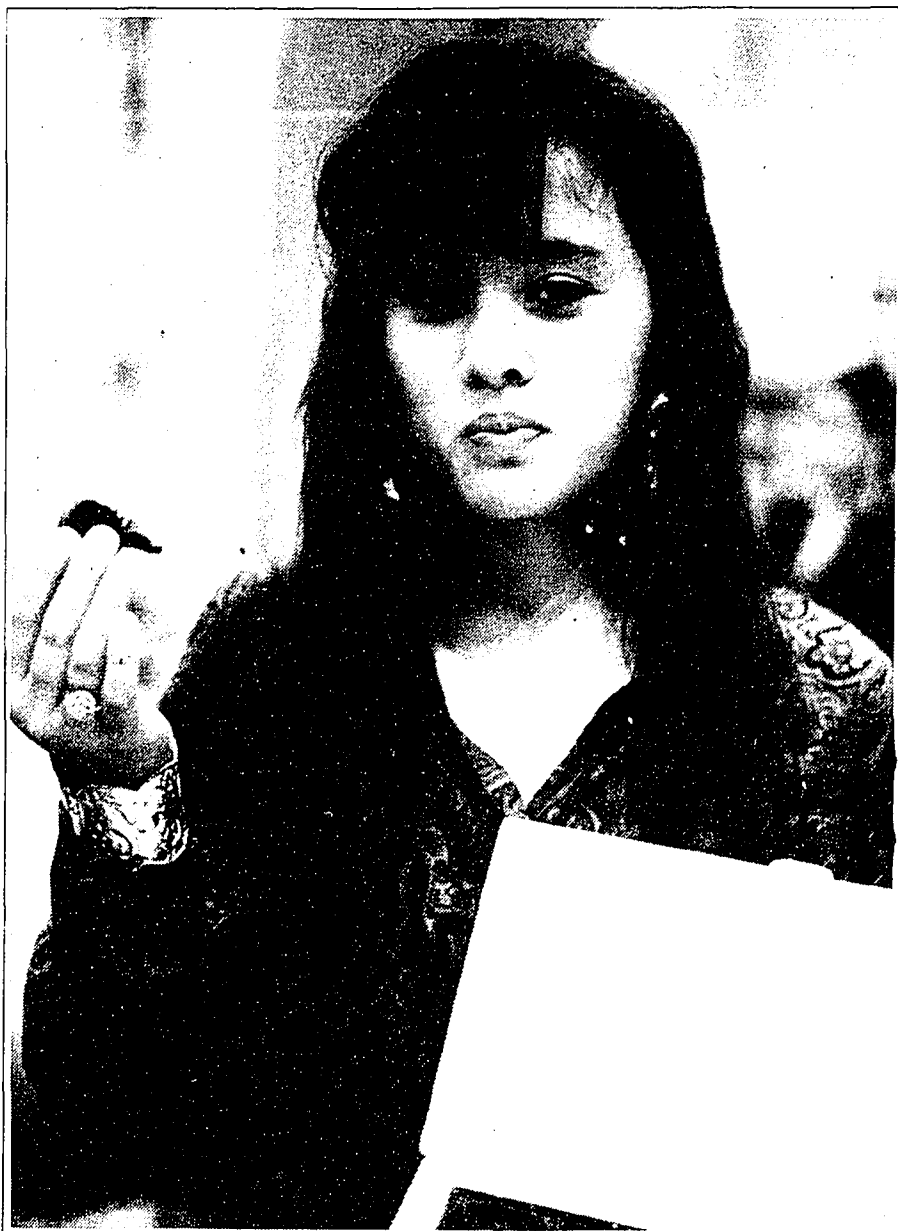
The said public law allegedly altered the original administrative jurisdiction of the Board with respect to election contests.

"The TRO stops the Board from conducting hearings any further. On December 6, the court will decide whether the Board will be permanently enjoined from conducting such proceedings, and whether it will order the poll body to go ahead with the final counting of the ballots and the certification of the results," Mitchell said.

But the counsel for the defendants came up with the argument that an adjudication proceeding to determine the eligibility of a voter to vote is not an "election contest" as plaintiffs have defined and argued it to be.

"The plaintiffs confuse 'election contests' with 'challenges to voters.' The ongoing cases on Tinian are hearings on challenges to voter qualifications and are

## Trustees decide not to honor part of Retiree law

The Board of Trustees of the NMI Retirement Fund taking on the recommendations of its legal counsel, has recently decided that it will not implement certain provisions of the Retiree Law that provides cost of living allowances for former government employees.

Sections 7 and 10 of Public Law 7-39, though now binding as statute after Governor Lorenzo I. DL. Guerrero signed it October, is being put on hold by the Fund until an appropriate judicial determination is attained as to their constitutionality.

This means that those affected can come in and submit their claims for benefits offered by

the said sections, but that the Fund would have to deny these claims until they go through the appeal process and to court if they deem necessary.

"We'll just sit back and not implement the said section, wait for affected members to appeal, and if anybody brings up the case, the courts will decide," said Retirement Fund Administrator

Tomas Aldan in an interview at his office yesterday.

The trustees, composed of Saipan members Teresita Aldan, Marian Tudela, Nicolas Palacios, Joaquin Ogumoro and Michael A. White, Rota member Cris Taitano, and Tinian Member Ben Sablan came up with the plan to defer implementation of the said statutes.

Section 7 of the said law, relating to the hiring of retirees under the Older Americans Act, was deemed by Aldan and legal counsel Lecia Eason as violative of Amendment 19 of the Constitution.

Under the said amendment, retirees who retired after January 7, 1986 when the statute was effected, and have worked for more than 60 calendar days would lose their retirement benefits for the remainder of the fiscal year.

It was alleged that the section not only permits retirees to receive wages for working again for the government but also to receive their retirement benefits as well, contrary to Amendment

19.

On the other hand, Section 10 of the same law also drew objections from the Board, especially on the provision that sets additional COLA for elected officials apart from the COLA they receive as regular government employees.

"Why must elected officials get an additional benefit when they contribute an equal 6.5% of their wages as anybody else does in Class 1," so goes the argument.

This might be viewed to be in essence "prohibited discrimination", a violation of the Internal Revenue Code, and may lead to the Fund losing its tax qualified status. This, in effect, means that the full value of all the benefits held in the Trust for vested active employees may immediately become taxable income to those employees, even though they could not yet obtain the benefit.

In addition, another possibility is that the Trust Fund would no longer be tax-exempt, and therefore, the Retirement Fund's investment return could become taxable.

## Sexual molestation charges filed against priest

A Roman Catholic priest who was booked over the weekend after being arrested for assault and battery was formally charged yesterday in Superior Court on two counts of sexual molestation.

Father Jesus Orense Hapul, 34, was arrested early Saturday evening after he was allegedly seen with a 14-year old girl at Agingan Point.

Hapul was later released after he posted a \$100 bail how-

ever, late yesterday afternoon, the Attorney General's Office filed formal charges against the clergy who is accused of having relations with the female minor since last October.

The case against Hapul is the second of its kind that has rocked the Catholic clergy. Almost a year from now, similar charges were also brought against former San Jose parish priest Father Isaac Ayuyu. The case however never made it to trial and was later dismissed.

Bishop Tomas Camacho, who

was on Rota at the time of the clergy's arrest said yesterday that he was "unaware" of the said incident.

Camacho however said he is willing to wait for the results of the investigation surrounding the charges filed against Father Jesse but, he is "doubling his prayers so that justice may prevail in this case."

The bishop said Hapul had not been "stripped of his duty" and that he even celebrated mass on Sunday.

Dear Editor:

I hope you would consider printing this letter in your paper. I know it's a long one but the public needs to know what's happening in the sport of volleyball as organized by us, Saipan Amateur Volleyball Association. Actually this letter is to respond to "Name Withheld by Request" regarding SAVA.

1. News Coverage/Advertisement: It was not only twice that Mr. Tony Rogolifoi put out a report regarding our on going league. Anyway, it is not our expertise to write about the games and put it out in the paper.

The sports people from the gym are lucky to find the time to even write about the games. It's the News media (paper and T.V.) to come down and watch some of games so that they can put it out. Sure we know how to play and call the games, but for us to find time to sit down and write it out is so hard. With limited staff at the gym, time and the expertise of reporting of the games is not there.

2. Memo: Regarding the memo given to all the team coaches, first of all, there was and never is a change in the schedule nor the starting time of the games either in the 1st game or 2nd game. The memo was meant to remind the teams of the time schedule. I put out the memo because majority of the teams are showing up after 7:00 p.m. Like what the schedules says - 7:00 starts the 1st game and 8:30 the 2nd game. What I mentioned in the memo was "all teams should be at the game site 30 minutes before the game ball as organized by us, Saipan Amateur Volleyball Association. (7:00), if the team(s) is lacking players at the time of the game, the team's first set is forfeit. At 7:15 if the team is still lacking players then the whole match or game is forfeit. Likewise for the 2nd game. When I passed out the memo to all the coaches, not one complain because the memo was simple to remind them of the schedule. The only time we encountered complain was when a

team was lacking players at 8:30 and I had to forfeit their 1st set. The concern coach had the memo 2 or 3 days before the game. Why didn't the concern coach air his complain when I handed him the memo. Why did he wait until he experienced the shortage of players.

3. As for the game officials, even if the scheduled officials did not show up, there is always myself, Rose Igitol and Tony Rogolifoi present to call the games. Yes, we are being paid (for the first time in 3 years) but only for \$5 1st Ref and \$3 for 2nd Ref and the Score-keeper.

4. Presently and for the last 3 years, Rose Igitol Secretary; Joe Lizama, Treasurer; Tony Rogolifoi, vice President and myself, President; have been the SAVA officers. For the last 2 years and just recently this year, we put out a notice for all volleyball players and interested individuals for a volleyball meeting. Always included in the agenda was the re-election of officers. Since nobody and I mean nobody would show up, but us officers we have to hold on to our seats as officers again and again. If it wasn't for our love and commitment for the sport, volleyball would not have been so popular as it is now. The last meeting we called was for all coaches and team members of the ongoing league. Only 3 coaches showed up. What hap-

pened to the rest of the coaches and to the more than 50 players. I mentioned to the coaches if they would want to take over our seats and nobody wants to.

5. As for the \$500.00 entry fees, a total of \$4,500 was collected. Breakdown for the \$4,500 is as follows:

450 (security)  
300 (gym usage)  
534.60 (players accident ins.)  
900 (trophies)  
528 (officials' fee)  
153 (game balls expense)

The remainder of \$1,634.40 is put in SAVA'S savings as it will help us out for future off-island competition.

6. Again, if it wasn't for us four (Rose, Tony, Joe and myself) the following accomplishment would not have been possible.

1. Hired a professional coach/trainer from Japan. Gave us volleyball clinic for players and coaches for 1 month. Also gave clinics to the school children. January, 1990.

2. Organized both men and women teams and select coaches for the Micronesian Games. Came out silver and bronze medal respectively, July 1990.

3. Organized both men and women teams and select coaches for the Oceania Games. First time participant. November, 1990.

4. October 1990 and 1991- Officiate the CNMI ALL School Volleyball Championship.

5. Send Saipan Representative to Canberra, Australia for coaching seminar, September 1989.

6. Send Saipan Representative to Hong Kong for volleyball conference.

7. Participated in the South Pacific Games, men's Teams, September 1991.

7. Now, if for any reason we did commit an error or errors then I as the president of SAVA apologize to the coaches and team members. But, may I suggest that next time a concern coach or team member has a complain against SAVA, please come to us and tell us. Let's sit down and talk it out. That way we will know if really we are not doing a good job as officers and coordinators of the leagues. ## CRM skeds hearing for Niizeki-Cou You resort project

The Coastal Resources Management Office yesterday announced that a public hearing on a proposed major siting project, the Niizeki/Cou-You Corporation CNS Resort Project would be conducted November 27, 1991 at the Tanapag Elementary School.

A news release from the office disclosed that the project, which would cost an estimated \$101 million, would consist of an 18-hole golf course and practice areas, a 504-room resort hotel and golf club consisting of 329 2-bedroom and 175 1-bedroom units, shops, and four restaurants.

It would also include approximately 240 units of employee housing consisting of 100 4-person dormitory units, 100 1-person efficiency apartments, 30 1-bedroom apartments, and 1-2-bedroom apartments.

An extensive 3-acre water park, a tennis pavilion, a helicopter tour terminal, a resort and golf maintenance building, a water supply building, 3 sewage system buildings, 3 irrigation system building, electrical power supply buildings, and parking area for 307 cars and 10 buses.

The news release from the CRM indicated that the water park would include slides, flumes, paths and pools, a snack bar, lockers, showers, and a first aid station. The said water park alone is estimated to cost around

\$10.8 million.

The entire project would be situated on about 204 acres (84 hectares) of leased private and public land in the Talafofo region of Saipan, just north of the stream channel of Saddok, Talafofo.

The land and its surroundings are mostly used for recreation/exploration, watershed, wildlife habitat, and ranching.

The coastline itself is a low, fingering apron reef, interrupted by high well-developed notches, stacks and arches.

According to the release, the hotel facility would be constructed primarily on a portion of the 48.3 hectares of leased private properties while much of the golf course and water park would be constructed on approximately 41 hectares of leased public lands, which represents about 1.7% of Saipan's developable public land inventory.

It was also said that the yearly rental premiums for the public land over the next 25 years ranges from \$61,500 to \$77,900 or 3% of the gross receipts, whichever is greater.

Both the Marianas Public Land Corporation and the CNMI Legislature have approved the public land lease in accordance with the CNMI Constitutional mandate to review leases in excess of five acres.

As part of the negotiations for the public land lease, the CNS

Corporation agreed to provide a variety of public benefit contributions which include the paving of 4.1 miles of access road from Esco's Store to the project area; a \$1 million contribution to Marianas High School for the construction of a gymnasium and/or classrooms and other facilities and the contribution of \$250,000 for the improvement and the upkeep of Talafofo, Hidden, and Old Man by the Sea beaches.

Currently, the CRMO is reviewing the project to determine if it would have unacceptable significant environmental impacts.

The project is anticipated to begin in one year and be completed in three years following permit issuance.

Ecological effects include the removal/replacement of approximately 70-75% of the natural vegetation on the site, identified as mostly tangantangan scrub and grasslands.

The project design has incorporated plans for preserving most of the limestone forest vegetation, significant "Riverine" vegetation, and some bands of tangantangan. Extensive landscaping will incorporate as much of the existing vegetation as possible and at least 75% of the site outside of the golf fairways, green, and tees will utilize native

plantings.

The environmental assessment, however, states that development of the site for the project will result in the loss of habitat for some 1,565 birds which were recorded on the site. Two endangered species were found to have utilized the site — the Nightingale Reed Warbler (Gaga Karisu), and the Island Swiftlet (Yayaguak).

According to a report, little or no impacts on groundwater quality is projected since there is little current nearby use of the groundwater. It also said that a popularly quoted study (Cape Cod) of groundwater contamination from golf course-associated fertilizer and pesticide applied does not threaten groundwater, even in areas of vulnerable hydrology if properly done.

It went on to state, however, that existing literature does not indicate that sufficient studies have been performed on islands, nor on geological substrates such as the ones found on Saipan and recommends thorough groundwater and marine monitoring if the project is permitted. The report further warns against over-pumping of the basal aquifer which would result in salt-water intrusion.

With regard to marine resources, the report states that no baseline studies of the marine ecosystem but it speculates that

given the numerous streams which empty onto the ocean, along with their occasional heavy sediment load and the generally constant pounding surf, it would be reasonable to assume that there would be limited coral growth on the reef in this areas.

However, it is also possible that strong nearshore currents may carry sediments to deeper waters quickly, and therefore coral growth may be active.

Social impacts were also addressed, as the report said that the Commonwealth government services would be impacted until benefits are generated to pay for service requirements.

The workload of such functions as immigration, quarantine, customs, environmental quality, fish and wildlife, public works, commerce and labor, historic preservation, police, firefighting revenue and tax and utilities would be primarily affected.

"The direct local income from wages, rents, and profits and government revenues from taxes and fees levied on this project and other resulting development would substantially exceed the costs, leading to an overall improvement in services enjoyed by the public, provided needed funding is appropriated in an equitable and timely manner," the CRM release said.

### Former bank teller extradited to face charges on Saipan

A former teller of the Bank of Guam was extradited to Saipan on Saturday where he is scheduled to answer of two counts of theft filed against him in Superior Court.

Accused embezzler Alex A. Hikuta, 34, was arrested by Guam authorities based on information received through the CrimeStoppers Hotline.

Information that Hikuta may have stolen \$6,000 from the bank's Saipan branch was filed in October however, the former teller went into hiding on Guam before any formal charges could be brought against him.

Guam authorities were alerted on Hikuta's activities after a call was placed through the CrimeStoppers Hotline inquiring about recent bank thefts and Hikuta's involvement in one.

As a result of the tip, Superior Court Judge Marty Taylor issued a warrant for Hikuta's arrest which requires Hikuta to post a \$35,000 bail for his temporary release.

On Saturday, Hikuta made his appearance at the Magistrate in Guam where he consented to be extradited on Guam to face the charges against him.

#### In other news:

\*A Japanese tourist was again the victim of a snatching incident in the Western Garapan area after he was ripped-off of his clutch bag containing less than \$400 in cash and personal documents Sunday evening.

Hiroshi Nakada became the prey of purse snatchers identified to be on board a vehicle. Nakada was on his way to the Daichi Hotel where he was temporarily housed when the robbers ripped him off. Police are still continuing their investigation of the case.

Sablan talked with members of the chambers of commerce of the different countries after he had earlier sent letters and other materials meant to induce investors to come to Saipan and see for themselves the said proposed site.

Garapan Annex I and II is a residential area that is a 74,000 square-meter prime property being planned as a possible site for a large commercial center.

"We have met with the big developers and have extended the deadline for submitting proposals to March 31, 1992 from January 4, 1992. Some of the people whom we provided insights on what investing on Saipan is, would be coming over to look at the place," said Sablan.

He was optimistic that by the new deadline date, there is already someone who will get re-acted by his recent visit and be interested in leasing and developing the area.

According to Sablan, big name developers have become aware of investment prospects here but would normally not commit themselves early without first undertaking intensive study of the proposal.

"We have provided some of these big developers copies of an aerial video of Garapan I and II as well as still photography. Nevertheless, we will continue to promote the project not only to the ones we met with but also other developers we have yet to see," said Sablan.

Primary target areas include Japan, Korea, Hong Kong, and the Philippines.

Currently, the site is underutilized as a public housing subdivision but is ideal location to create a landmark project. Bounded by two major thoroughfares — Beach Road and Upper Highway — the site is considered well-located in rela-

tion to major commercial establishments and major hotels on the island.

The property is easily accessible to the major arteries in and out of the Garapan District

neighborhood and has unobstructed mountain views of the Navy Hill area.

In addition, the site is widely visible from the higher elevations of the island.

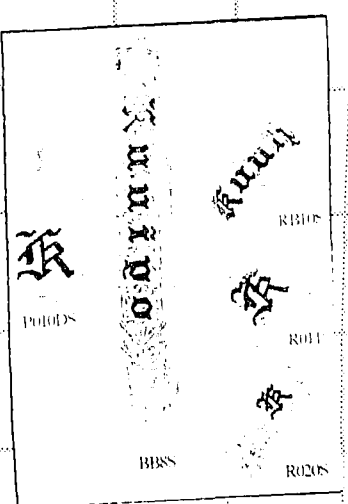
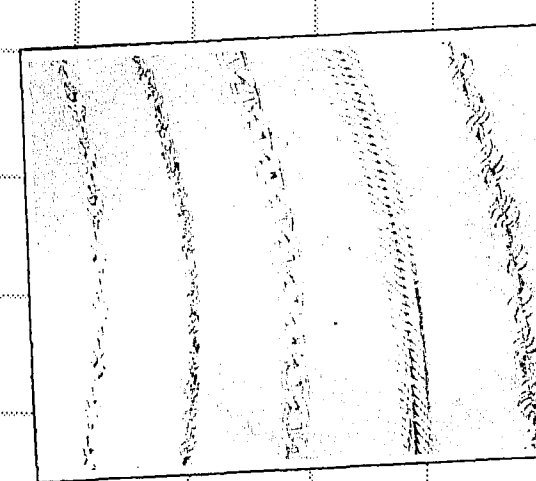

## WGA governors back Guerrero's IG resolution

A resolution sponsored by Governor Lorenzo I. DL. Guerrero to prohibit the Inspector General of the Department of the Interior from auditing locally-generated revenues was unanimously approved by the Western Governors' Association during its two-day session that started November 22 in Las Vegas, Nevada.

This was learned in a news release issued by the Commonwealth News Service, which disclosed that the governor's itinerary also includes a trip to Japan to attend an annual function of the Japan Travel Association. He is scheduled to be back on November 28.

According to the news release, Guerrero's policy is that the authority of the IG should be restricted to the audit of federal funds in the Territory of Guam and the Commonwealth of the Northern Marianas.

It was reported that the governor urged appropriate legislative committees of the US Congress to take action to limit the IG's authority to audit only federal funds in the two island nations.

## CUC to disconnect delinquent customers

For the third time this year, Commonwealth Utilities Corporation (CUC) crews will disconnect quite a number of delinquent customers who fail to update their utility service payments.

CUC crews will begin disconnecting services on November 27 and according to a press release from CUC Executive Director Ramon S. Guerrero, customers that have been given due time and have not, until now, fulfilled their obligations will not be tolerated.

The over 90-days delinquent residential customers are not the only ones affected but, large businesses will also have to update their payments as they will not be exempt from being disconnected.

CUC regulations however provide that no disconnections will be made if the customer has not yet received the customary 15-day notice.

Cracking down on delinquent customers has brought \$5 million back to the coffers of the autonomous agency. While the January and August disconnection of delinquent customers was done only on Saipan, Rota and Tinian residents now have to keep their accounts updated as they will also be affected by the said order this time around.

The continuation of authority for the IG of the US Department of the Interior to audit non-federally generated funds, accounts, and programs on Guam and the CNMI is contrary to the oft-stated federal intention of promoting greater self-government and autonomy.

There were claims that both island nations have achieved sufficient technical sophistication to conduct internal audits of their own funds and programs. No other federal Inspector General has authority to audit revenues on Guam and the CNMI nor does any federal IG have the authority to audit non-federal funds, accounts, and programs in any state.

Guerrero, for his part said he will try to have the National Governors' Association adopt the resolution during its 1992 Winter meeting in Washington, D.C. in February.

CNS said that if he succeeds in that efforts, it would be the sec-



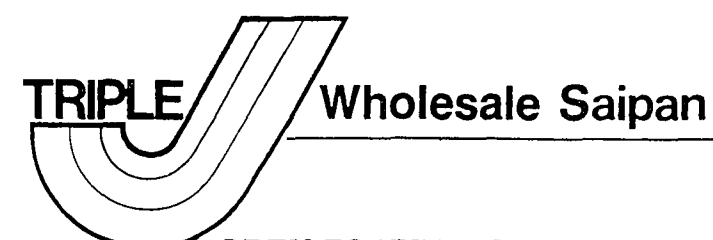

The EEZ resolution seeks that the CNMI and other states gain control and sovereignty over the marine resources in and off their waters.

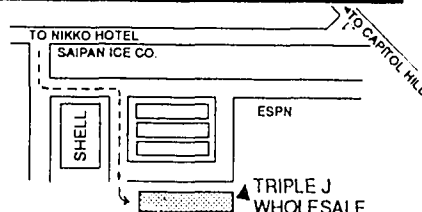

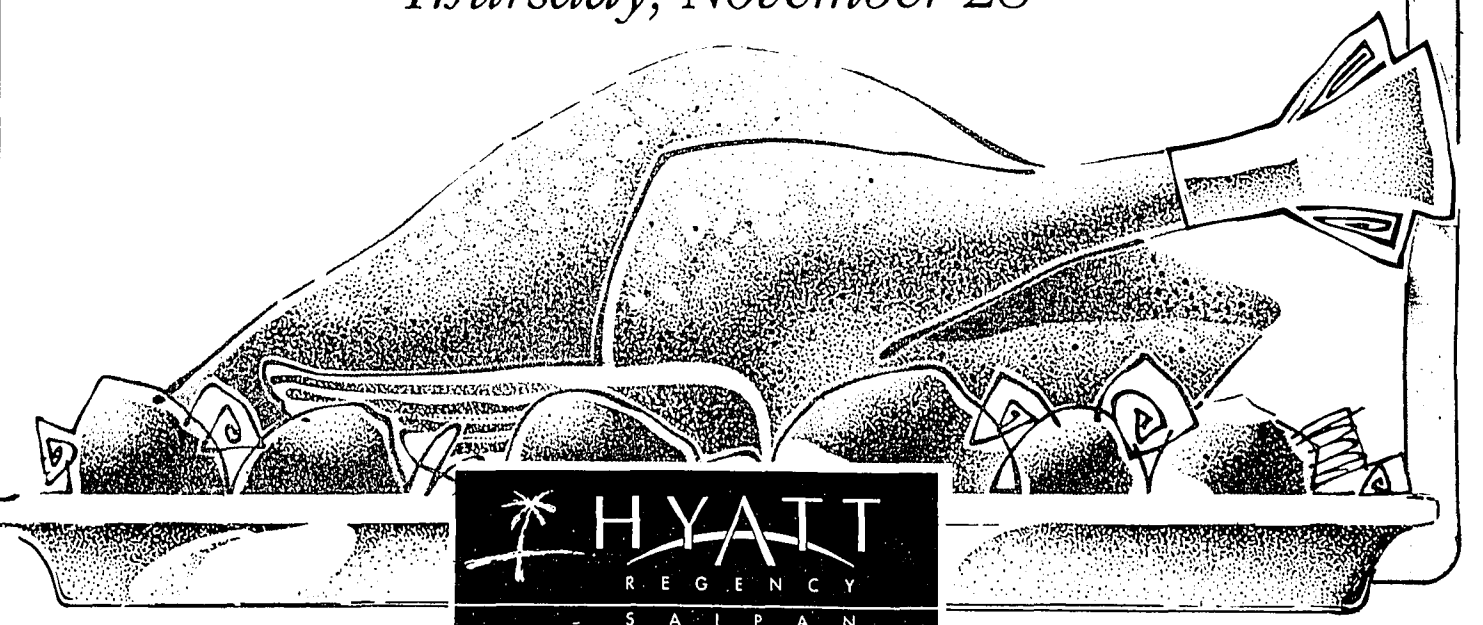

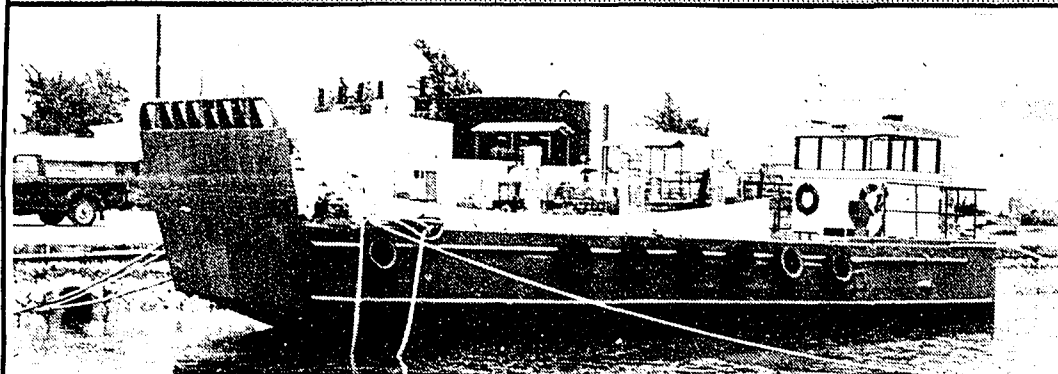

## Court issues TRO...

not election contests, because they were filed prior to the tabulation of any ballots," read a memorandum in opposition to the motion for temporary restraining order.

It was argued that the Board still has not canvassed the votes and certified a candidate as a winner; and, the actions are filed against voters and not candidates.

When the election challenges have been decided, then the Board will allow those ballots which are proper to be cast, and the tabulation of the ballots will

occur with the certification of the winning candidates.

"At that time, an election contest may be filed against one of the winning candidates, and it is at this stage that P.L. 5-7 begins to have its effect on procedure," the memorandum said.

In coming up with a decision, Castro said that before any judge can properly issue a TRO, it must be clear to the court that plaintiff will suffer immediate and irreparable damage unless and until relief is granted.

"The court finds that such an element has been fulfilled by the plaintiff in that they can not subsequently sue the Board of Elections for monetary damages," said Castro during the hearing.

The judge said that another factor is that the plaintiff must be likely to succeed in the ultimate merits until hearing all sides of the case.

"The only comment I can make at this time is that it is not the court's job to assess the wisdom of the actions of the legislature," said Castro. "In this case, it is clear that the legislature has stripped the Board of Elections of its power to conduct proceedings of this nature."

Also, the court theorized that relative harm or burden that will befall the plaintiff will allegedly be much greater than that that will befall the defendant.

"If the Board will continue conducting proceedings, it may not have the authority to do so. Thus, there would be expenditure of public funds. Accordingly, the TRO is hereby granted," said Castro as he announced his order.

Meanwhile, Board of Elections counsel James Sirok and Rexford Kosack, who acts as counsel for the real parties in interest were one in saying that the TRO will delay the certification of the election results for the whole of the Commonwealth and not only of the affected district of Tinian.

This means that possibly nobody of those who won in the elections may take office until the issue is ultimately settled on December 6 at the Superior Court, or if necessary at the Supreme Court.

"An ultimate ruling from the high court, if ever an appeal is necessary, would take long such that the officials-elect may not be able to take office on January 6, the targeted date," a counsel for the defendants said during the hearing.

Mitchell then quickly argued that he will be seeking a summary judgment and a permanent injunction with two sides.

"The negative side of it is to put a stop to the Board hearings, while the affirmative side is to ask the court to require the Board to count the ballots and certify the results," Mitchell said in court.

Both counsels for the defendants and the plaintiffs were told by the court to get ready with their motions and counter motions before the December 6 hearing.

## Fitial re-named CSC Board member

Civil Service Commission Board Member Felix R. Fitial will continue to serve as one of the members of the Board of the Civil Service Commission after his nomination was approved by the Senate during its fourth regular session held yesterday.

The Committee on Executive Appointments and Governmental Investigations headed by Senator Francisco M. Borja approved Fitial's nomination on the basis of his "excellent performance and admirable dedication to the goals and purposes of the Commission."

Now on his second term, Fitial will continue to represent Saipan and the Carolinian community.

Considering the observations and the decided advantage to the Commission of having the services of a Civil Service Commission "veteran"...Fitial is uniquely well qualified for this particular service to the Commonwealth and its people," Borja said in his recommendations.

This is Fitial's second-term as a Board member of the CSC.

The committee is co-chaired by Sen. Henry Dlg. San Nicolas and has among its members Senators Jesus R. Sablan, Edward U. Maratita and Paul A. Manglona of Rota.

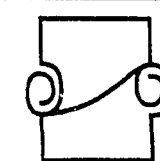
## Zoning Board to conduct Public meetings

## Senators pass initiative to increase PSS budget

More and more CNMI leaders are finally joining a bandwagon of those who have shown direct interest to improve the current state of the Commonwealth's educational system.

Senate leaders are some of those who have been made aware of the sad plight of the CNMI students.

During yesterday's session, the Senators passed a senate legislative initiative which increases the Public School System's (PSS) annual budget from the current 15% to the proposed 20% which will be generated from the CNMI's general revenue.

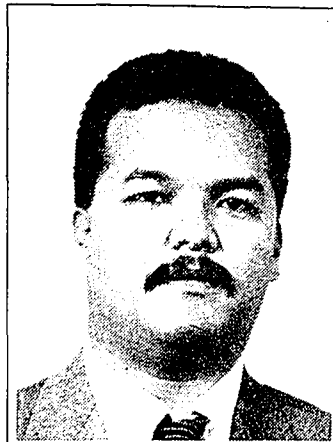
Introduced to the floor by Rota Senator Paul Manglona, the initiative will be included in the ballot for the 1993 general elections.

On the other hand, education officials and those involved in the system will have to continue their sacrifices for two more years before anything can be done to raise the budget for the CNMI's educational system.

The Public School System is entrusted and mandated to grant free, compulsory public elementary and secondary education. The PSS however cannot actually meet what has been mandated to them as the department has always been plagued

with monetary problems.

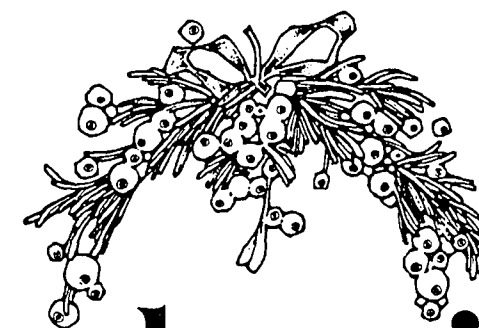
Former Commissioner of Education Elizabeth D. Rechebei said the current \$3 million annual budget which the PSS operates with will not be sufficient unless other methods could be explored to increase the operating budget of the agency.

Senate leaders approved the passage of the legislative initiative during their yesterday's session.

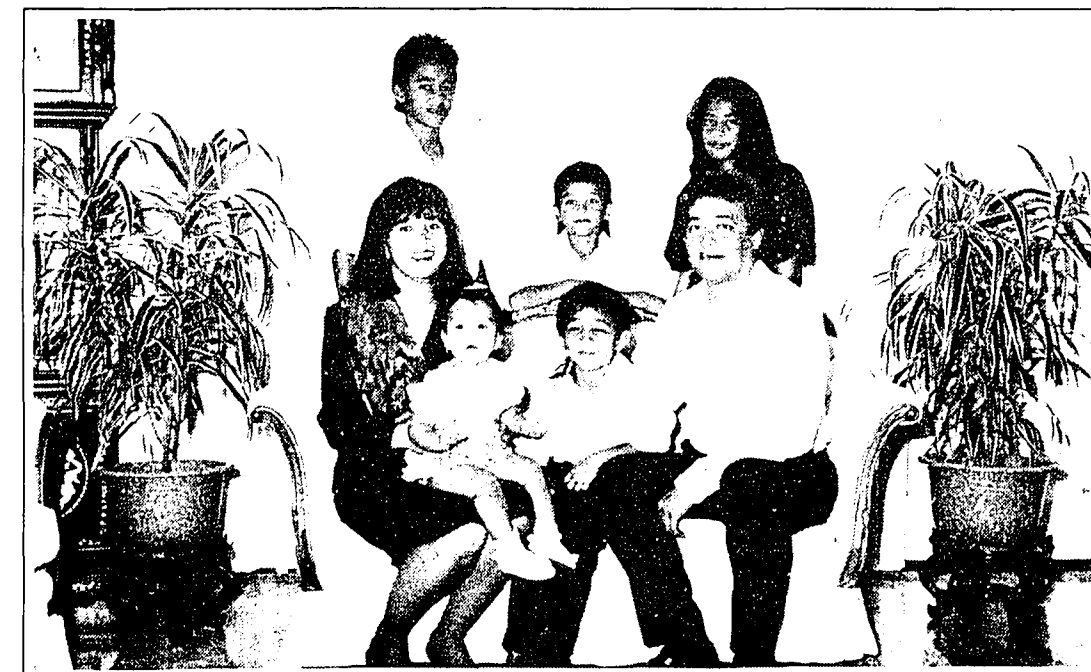

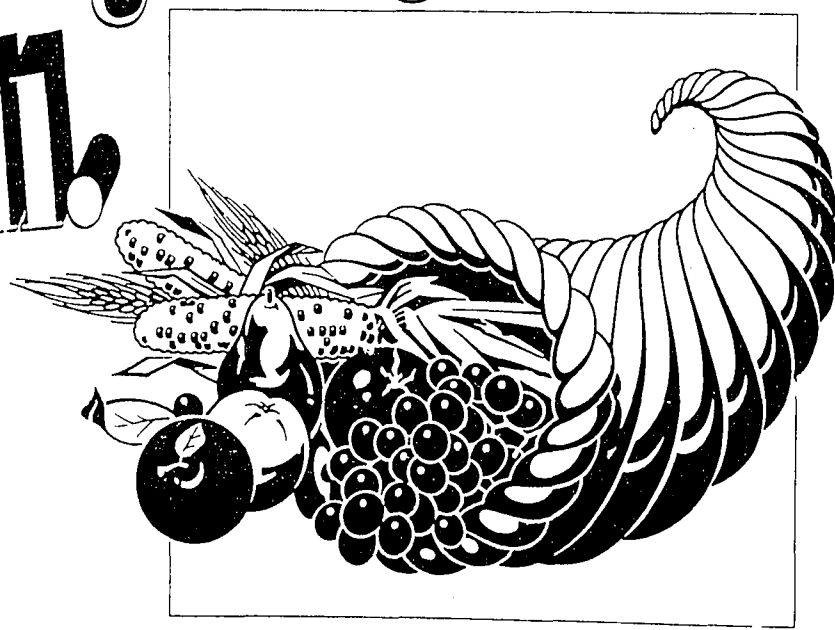

### Customs authority extended by legislative amendments

The Customs authority to conduct border searches have been expanded in scope through an amendment to the recently signed Anti-Drug Abuse Law which took into effect two weeks ago.

The amendment was introduced by the statute's author Garapan Congressman Stanley Torres during last Thursday's session of the House of Representatives.

Through the amendment, Customs officials will be allowed to have jurisdiction over drug cases from the point of entry in the Commonwealth to the destination where the accused conducts his illegal deals and distributes the controlled substance.

Customs officials can only have a limitation of 72-hours after the arrival of the alleged courier or the contraband from one of the Commonwealth's points of entry.

Customs officials also have the duty to conduct constant surveillance of the accused and the cargo once it enters Commonwealth ports.

The recent amendments also changes the language of a certain provision stipulating that any person in possession of more than a gram of the controlled substance but less than five grams will be sentenced to a term of not less than 60 days of imprisonment.

The amendments may have been spurred by recent drug cases where the authority and functions of the Customs agents have been questioned in judicial proceedings.

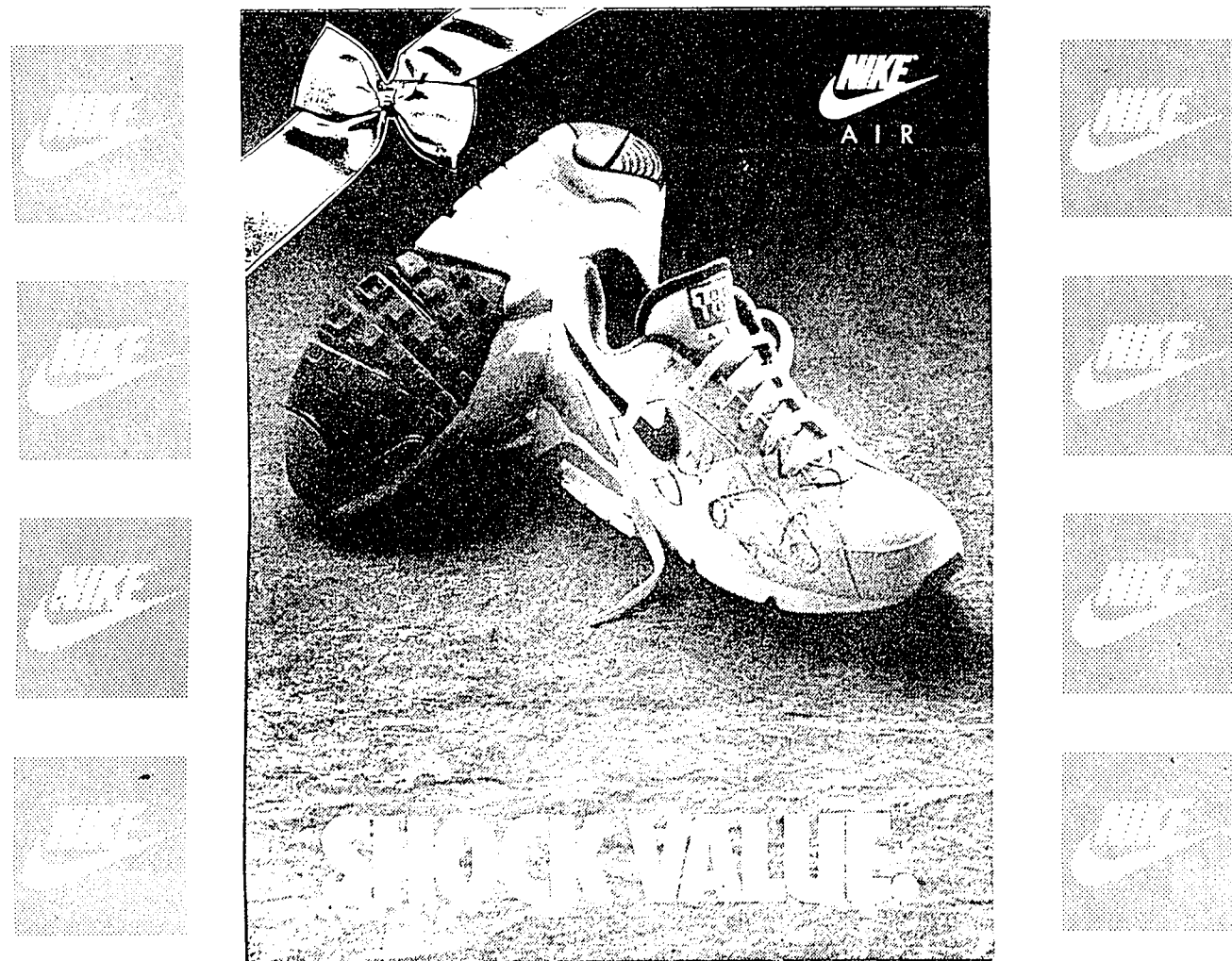

## Typhoon bulletins keep KSAI Radio busy

The rash of typhoons which hit the Commonwealth within the last two months has kept KSAI's 24-hour Weatherline busy.

By calling 234-KSAI (5724), callers provided with a complete recorded weather bulletin. Typical information provided for the caller include the latest position of the storm, its strength, the CNMI storm condition and information on school and government offices' closings. The Weatherline can take two calls at a time however, during typhoons, the lines are tied-up continually. During storms, announcements are kept short as possible and callers will be given just the essential information to allow more callers access to the system.

KSAI station manager Andrew Mazella said in a press release that during typhoon Ivy, 2,716 calls were logged-in while at the height of Mirielle, 3,878 calls were made. A total of 2,500 callers made calls at the station during typhoon Seth.

KSAI is the emergency broadcast station serving the CNMI. During Condition Three, storm bulletins are broadcasted at the top of the hour while during Condition two, bulletins are aired every 30 minutes at the top and bottom of the hour. During those times, KSAI stays on the air overnight.

"Once the Governor declares Condition One, listener's will hear the EBS signal followed by storm information to alert them that the storm is getting nearer and to emphasize the need for necessary precautions," Mazella said.

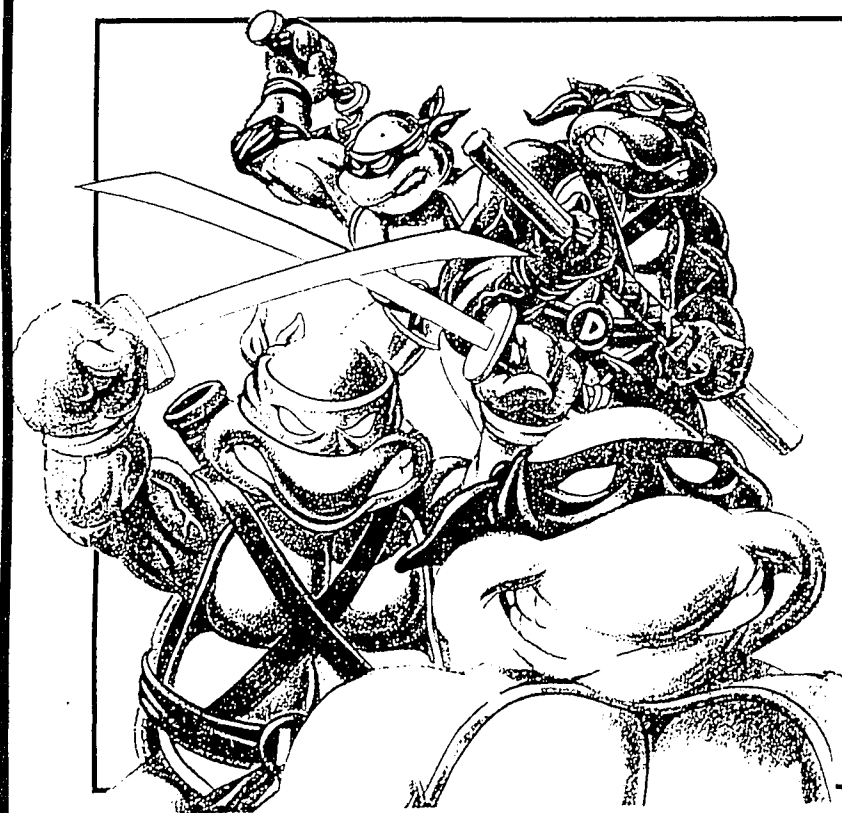

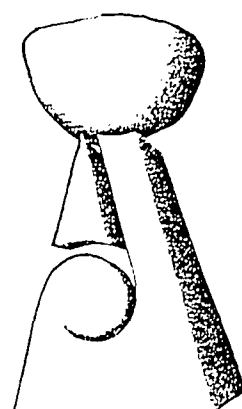

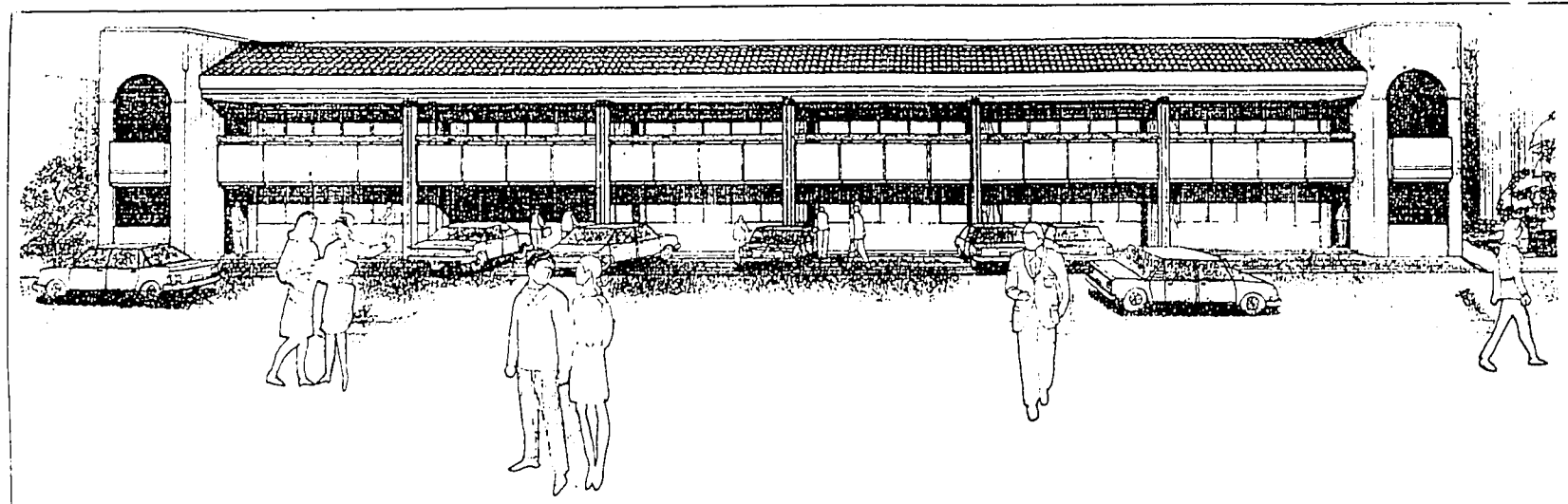

## Proposed statute exempts CUC from paying taxes

Senate leaders took a positive action on a proposed statute which will exempt the Commonwealth Utilities Corp. (CUC) from paying Commonwealth taxes.

The proposed statute was authored by Senator Juan S. Torres who deemed to exempt the CUC from paying excise and gross receipt taxes on all fuel purchases which is used internally by the agency.

The exemption however will not include fuel suppliers in the exemption. The said act was passed during the Senate's fourth regular session held yesterday.

A measure to proposing for the Commonwealth to partake in full membership of the Pacific Islands Development Bank also got the nod from legislators in their Monday session.

The act provides that the total participation of the CNMI in the said agency created by the Association of Pacific Island Legislatures. It was proposed by former APIL Chairman Congressman Manny Sablan.

The Senators also acted favorably on an act that will establish a one-time amnesty for persons who have voluntarily released any prohibited firearms and ammunition in their possession.

The proposed statute was offered for the purpose of lowering the potential of violent crimes and accident by reducing the amount of weapons available and that a one-time amnesty is the effective means of reducing firearm related incidents.

The act, which was introduced by Senator Herman R. Guerrero, provides that a six-months amnesty period will be given for anyone who wishes to relinquish their firearms to the Department of Public Safety.

The concerned individual will not be penalized with a civil or criminal penalty and his privacy will be insured by the responsible authorities.

Announcements will be made in the local media to inform Commonwealth residents of the details on the firearm and ammunition amnesty.

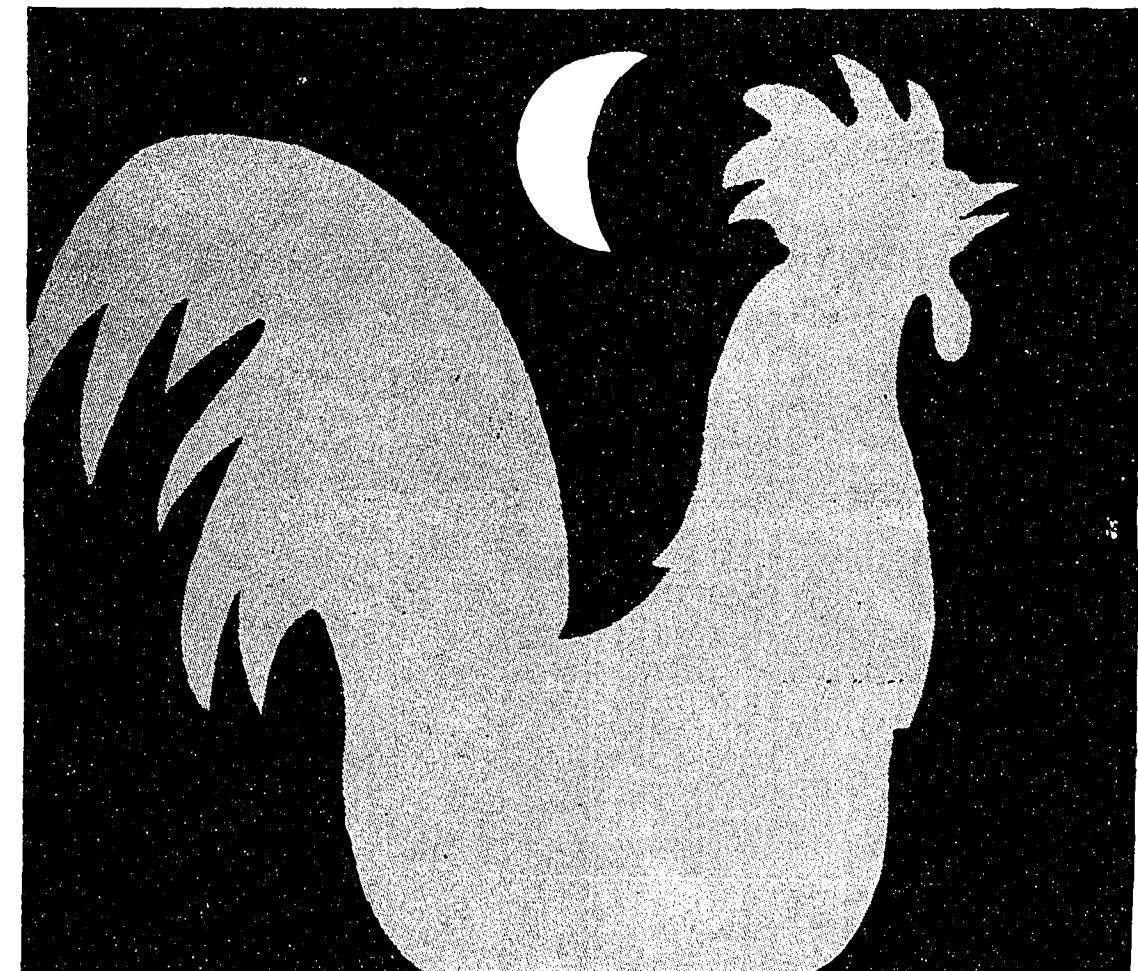

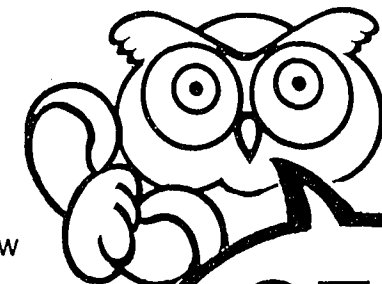

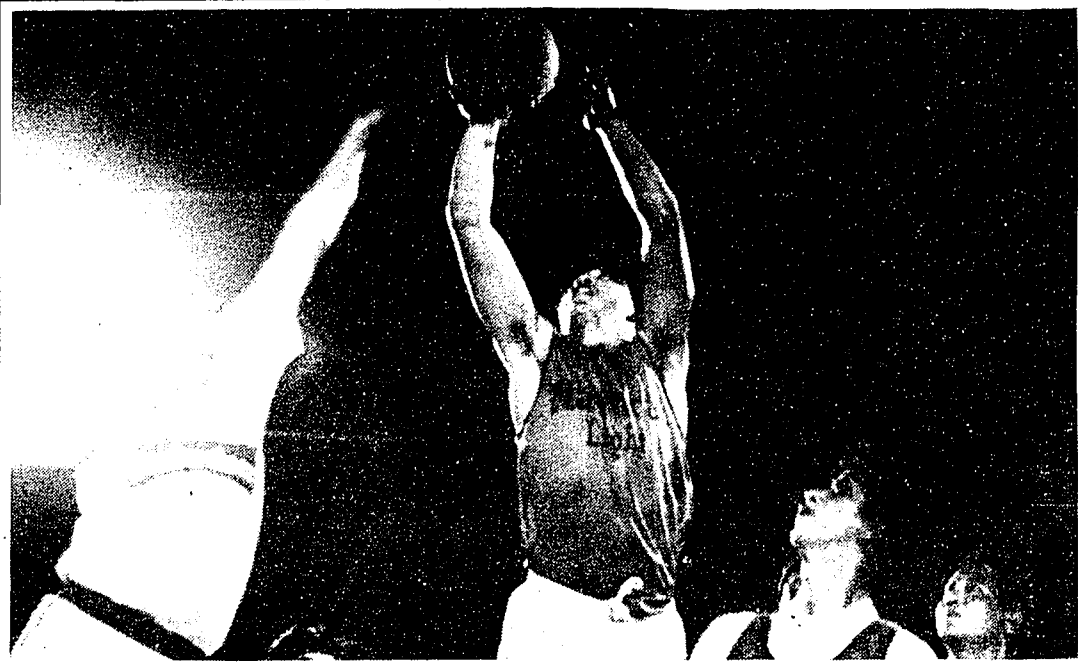
AD's Lim finished the ballgame with a team-high 27 points while PDL's Alegre did better, with a game-high 40 points.

The win brought AD Enterprises into the second round of the league along with other winners for the weekend, Jayfer International, and Marfran Enterprises.

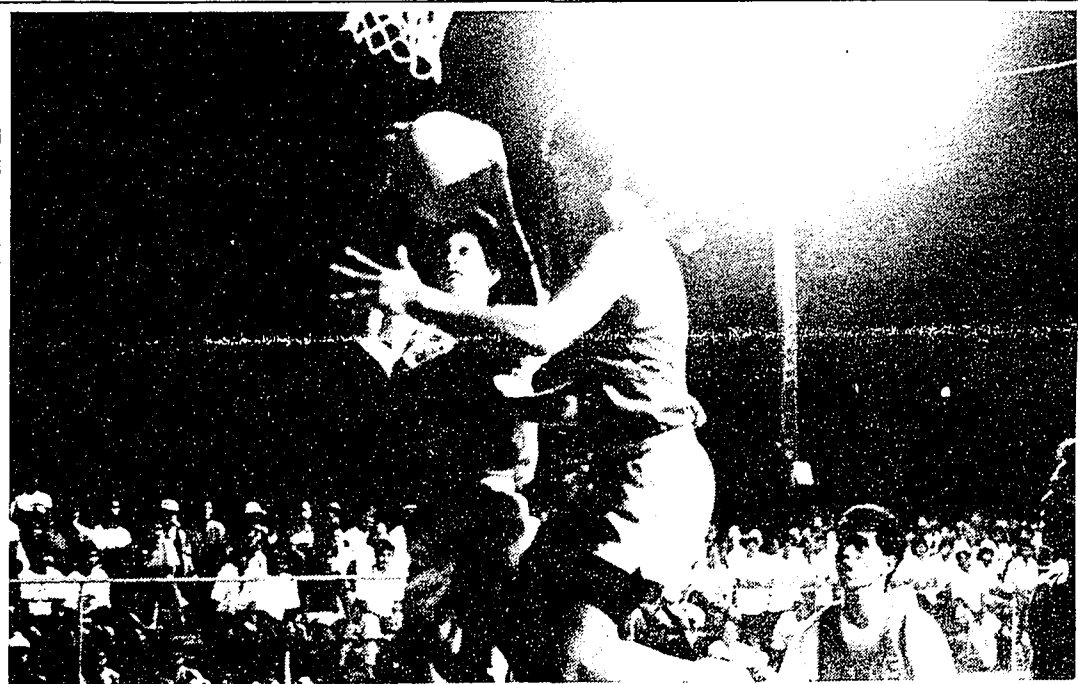
