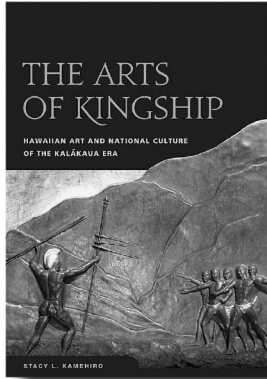


# THE ARTS *of* KINGSHIP

## HAWAIIAN ART AND NATIONAL CULTURE OF THE KALĀKAUA ERA



*The Arts of Kingship* offers a sustained and detailed account of Hawaiian public art and architecture during the reign of David Kalākaua, the nativist and cosmopolitan ruler of the Hawaiian Kingdom from 1874 to 1891. Stacy Kamehiro provides visual and historical analysis of Kalākaua's coronation and regalia, the King Kamehameha Statue, 'Iolani Palace, and the Hawaiian National Museum, drawing them together in a common historical, political, and cultural frame.

These cultural projects were part of the monarchy's concerted effort to promote a national culture in the face of colonial pressures, internal political divisions, and declining social conditions for Native Hawaiians, which, in combination, posed serious threats to the survival of the nation. The Kalākaua leadership endorsed images that boosted international relations and appeased foreign agitators in the kingdom while addressing indigenous political cleavages. Kamehiro interprets the images, spaces, and institutions as articulations of the complex cultural entanglements and creative engagement with international communities that occur with prolonged colonial contact. This book will be welcomed by readers with an interest in Hawaiian history and art and will appeal to art and architectural historians, as well as those studying Pacific history, cultural and museum studies, and anthropology.

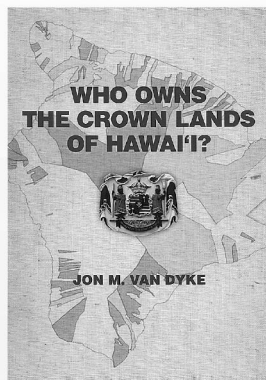

# WHO OWNS THE CROWN LANDS OF HAWAI'I?

THE 1846-1848 MAHELE (division) transformed the lands of Hawai'i from a shared value into private property, but left many issues unresolved. Kamehameha III (Kamehameha III) agreed to the Mahele, which divided all land among the *mō'ī* (king), the *ali'i* (chiefs), and the *maka'ānana* (commoners), in the hopes of keeping the lands in Hawaiian hands even if a foreign power claimed sovereignty over the Islands. The king's share was further divided into Government and Crown Lands, the latter managed personally by the ruler until a court decision in 1864 and a statute passed in 1865 declared that they could no longer be bought or sold by the *mō'ī* and should be maintained intact for future monarchs.



After the illegal overthrow of the monarchy in 1893, Government and Crown Lands were joined together, and after annexation in 1898 they were managed as a public trust by the United States. At statehood in 1959, all but 373,720 acres of Government and Crown Lands were transferred to the State of Hawai'i. The legal status of Crown Lands remains controversial and misunderstood to this day.
