REPUBLICANS ARE United In Endorsement OF H. E. COOPER

REGRET AT DEPARTURE OF STEWART

In the event of Governor Carter resigning his office, Henry E. Cooper is the first choice of the Republican Territorial Central Committee for the Governorship.

At a meeting of the committee held at Republican headquarters Saturday night the following resolution was unanimously adopted:

"Whereas, George R. Carter has resigned his position as Governor of Hawaii,

"Resolved, That in the event of his resigning that his resignation be accepted by the President, this Committee does endorse Henry E. Cooper, as its first choice for Governor of Hawaii."

J. P. Cooke presented the above. In introducing the resolution, Mr. Cooke said:

"In explanation of this resolution, I would like to refer to the resolution passed by the executive committee on Monday of this week, when this committee placed itself on record as expressing regret that Governor Carter had tendered his resignation, together with his belief that the interests of Hawaii and its people would be con-

served by the continuance in office of the present Governor. The sense of the committee was that of a hope that Governor Carter's resignation would not be accepted.

"Under the existing circumstances, with the possibility in question, it is desirable that the party should act as a unit. It is proper to express our preference for Governor Cooper, in the event that the resignation of Governor Carter should take effect. It is only fair that this committee should place itself on record in naming Mr. Cooper as its first choice. After a vacancy occurred it might be too late. If we want to have any influence in Washington, (Continued on Page 3.)

FOURTH OF JULY BIG CELEBRATION

Sports, Music, Balls, Orations, Guns, Fireworks

Honolulu will awake betimes tomorrow with the roar of cannons in her ears, to celebrate the one hundred and twenty-ninth anniversary of the adoption by Congress of the Declaration of Independence. Immigration Board Elects Its Permanent Officers

PAXTON WILL BE SENT TO N Y YORK

A meeting of the Board of Immigration was held in the Governor's office this afternoon, Secretary Atkinson presiding. The permanent organization of the Board was the first business taken up. Atkinson was designated president of the act authorizing the Board. J. P. Cooke was elected secretary and Mr. Craig auditor.

The matter as to whether outside clerical work should be used was discussed. Tenney said if the Board succeeded in doing anything a good man would be needed. Tenney also said that funds would be needed.

Atkinson said it might be a good idea to address the large landholders of the community in the work of the Board and to get their assistance.

J. P. Cooke said the Planters' Association should be asked with regard to what inducements it could offer coming settlers in the way of homesteads leases, etc.

Craig suggested writing to the various plantation managers asking for suggestions as well as for information.

Cooke said all such information could be found in L. E. Pinkham's report. It was in better shape there than anywhere else. The managers would have to refer the matter to their boards of directors and that would waste time.

Tenney said the question was if it was worth while to try Sargent's suggestion to get the labor from Ellis Island, New York.

Craig said that the people on Madeira wanted to come here. He had seen a letter showing that this was a fact.

Cooke and Tenney both said the best thing to do first was to find out what the Planters' Association would do in

the matter. This organization would be the main source of revenue for the purpose.

Carden suggested to write to Bishop Liberty and Father Valentine who were now in Italy, to find out from them what the possibilities were to get labor from Italy.

Atkinson said the Board should encourage the plantations and other large employers of labor to be more liberal with their land, giving their lands as homesteads and leases to their employees.

Craig moved that letters be sent to the plantation managers for information. This carried.

Tenney said an investigation of routes must be made.

Atkinson said he thought the Department of Commerce and Labor should be asked for an opinion on the law in order that everything the Board did should be perfectly legal.

Cooke said the idea of sending Mr. Paxton to New York to look up the matter of transportation could not be taken up before the Planters' Association had been heard from. It would have a meeting next Thursday.

Carter Did Tender Says Atkinson Actual Resignation

TALK TO CONTRARY ALL POPPYCOCK

In the face of all the rumors to the effect that Governor Carter never really tendered his resignation to President Roosevelt, Acting Governor Jack Atkinson said this morning that this talk was all poppycock. Governor Carter's resignation was as such a resignation as any which was ever written.

Governor Carter's resignation is still the subject of considerable interested discussion. It is held by many that Carter, as a matter of fact, never sent a bona fide resignation to President Roosevelt, but that he merely wished to have a personal conference with him with regard to the turn which recent events have taken.

Last Saturday afternoon Atkinson in making up the amount of the Governor's expenses, ran across a voucher reading as follows: "\$285, expense of trip to New York and return to consult the President." There was also a voucher for the payment of the expenses of Secretary Creedon, who accompanied Carter as far as San Francisco.

It is held by some that the fact that the Governor drew his expenses for the return trip shows that he intends, and all the time did intend, to return to Hawaii as Governor and that his resignation never had any actual existence. On the other hand, it is argued that even if Carter resigned and had his resignation accepted, the expenses of his return trip from Wash-

ington would nevertheless be paid by the Federal Government.

Acting Governor Atkinson was this morning asked to show the letter which Carter wrote to Roosevelt, a copy of which is kept on file. The reporter argued that the letter must already have reached the President, probably last Saturday, and that it as a communication from the Governor to the President must be an official document.

"I have not got it," said Atkinson. "It is in the safe in there and that is locked."

Atkinson pointed to the safe in Secretary Creedon's office. "I have not got the key or the combination," said Atkinson, "so I can not show the letter to you. Even if I could, I would not show it to you," he added, with his usual engaging smile.

"Have you seen the letter?" asked the reporter. "Yes; I have seen a copy of it," answered the Secretary, "but I have forgotten its contents. You can ask Mr. D. Tenney about that. All this talk about Carter's not having resigned is all poppycock. His resignation was as much a resignation as any resignation which was ever written."

ROOT REPRESENTS STATE DEPARTMENT

CLEVELAND, Ohio, July 3.—The body of Secretary of State John Hay is lying in state here. The Cabinet will act as pall-bearers at the funeral. President Roosevelt has invited former Secretary of War Elihu Root to represent the State Department.

Doubt Is Expressed Regarding Validity Of Charter REPORT IN RAPID TRANSIT COMPANY

Acting Governor Atkinson this morning received from the Attorney General's Department the following opinion relating to the validity of the Rapid Transit Co.'s charter, in which doubt is expressed as to the validity thereof owing to the peculiar conditions under which it was passed:

In pursuance of the concurrent resolution of the Legislature of the Territory of Hawaii, passed by the Senate on the 22d day of April, 1905, and by the House of Representatives on the 26th day of April, 1905, directing this Department to investigate the financial transactions of the Honolulu Rapid Transit & Land Co., for the purpose of ascertaining if any of its charter obligations to the Territory have been broken, and, further, as to the validity of its franchise, we make the following report and give the following opinion as to the legality of such franchise:

The company has not, so far as we are able to ascertain, through such financial transactions violated any of its charter obligations, and, in the issuance of stock and payment of dividends thereon, up to this date, is within the rights granted to it, as set forth in Chapter 66 of the Revised Laws of Hawaii.

The validity of its franchise is questioned, and it becomes our duty, in this connection, to investigate the various laws bearing upon the granting of that franchise, and the validity of such laws.

By the Act of Congress commonly called the Organic Act, passed April

30th, 1900, it was provided by Section 73 thereof "That, subject to the approval of the President, . . . all franchises granted by the Hawaiian Government in conformity with the laws of Hawaii, between the 7th day of July, 1898, and the 28th day of September, 1899, are hereby ratified and confirmed," and, in this connection, it might be well to call attention to the definition of the words "the laws of Hawaii," as contained in Section 1 of Chapter 1 of the Organic Act: "That the phrase 'the laws of Hawaii' as used in this Act, without qualifying words, shall mean the Constitution and Laws of the Republic of Hawaii, in force on the 12th day of August, 1898, at the time of the transfer of the sovereignty of the Hawaiian Islands to the United States of America."

The section above referred to seems to clearly indicate that in the minds of the framers of the Organic Act the transfer of sovereignty did not take place until the 12th day of August, 1898. If this construction is correct, which is doubtful, the franchise was granted by competent authority, but, the treaty of annexation having been signed prior thereto, such franchise required the approval of the Federal Government to become effective.

In pursuance of the power vested in him by Section 73 of the Organic Act, above referred to, the President of the United States approved the franchise granted to the Honolulu Rapid Transit & Land Co., upon a certificate signed by President Dole of the Republic of Hawaii, which bears date (Continued on Page 5.)

WORLD NEWS BY CABLE

(Associated Press Cable.)

DID NOT SURRENDER.

Odesa, July 2.—The battleship Potemkin was not surrendered by the mutineers, but has sailed for Sebastopol. A council of the admirals and captains has resolved to draw the fires of the squadron and send the officers and men ashore on account of dissatisfaction.

POTEMKIN MAKES PORT.

London, July 2.—The Potemkin and a torpedo boat have arrived at Kustendji, Roumania, and asked for provisions.

ONE THOUSAND DROWNED.

City of Mexico, July 2.—The city of Guanajuato has been swept away, one thousand people being drowned. Guanajuato, the capital of the state of the same name, is situated on a river in the mountainous portion of Mexico, being about 175 miles directly northwest of the City of Mexico.

FUNERAL OF HAY.

Oyster Bay, July 2.—The President has issued a proclamation requiring Government flags to be displayed at halfmast for ten days on account of Secretary Hay's death. President Roosevelt will attend the funeral.

EULOGIZED BY JAPAN.

Tokio, July 2.—Baron Komura, Minister of Foreign Affairs, has eulogized Secretary Hay, for whose death there is universal regret and sorrow here.

NAVAL PREPARATIONS.

Stockholm, July 2.—The Government has made proclamation declaring Stockholm, Karlskrona, Gothenburg and Farsund to be war ports and excluding foreign warships therefrom.

TO CONCLUDE PEACE.

Oyster Bay, July 2.—It is officially announced that the plenipotentiaries, Muraviev, Rosen, Komura and Takahira are empowered to conclude a treaty of peace.

RUSSIAN SITUATION.

St. Petersburg, July 1.—The resignation of Minister Bouligan is impending.

A number of bombs have been found in the rear of the palace of Tsarskoye Selo.

The domestic situation is growing worse every day.

Odesa, July 2.—Provisions have been sent to the surrendered battleship Potemkin. The exodus from the city continues.

CHICAGO INDICTMENTS.

Chicago, July 1.—Seventeen prominent butchers, including the Arnours and the Swifts, have been indicted by the Federal grand jury for violation of the anti-trust law. Thirty participants in the recent teamsters' strike have likewise been indicted.

MOROCCO QUESTION.

Paris, July 1.—It is believed in diplomatic circles that, in its essential details, the conference upon the Morocco question has been substantially agreed upon, and that only some details remain to be arranged.

H. A. C.'S DOWN ELKS

DEFEAT LEADERS
BY CLEAN-CUT WORK

MAILLES TROUCE KAMS BADLY.
LEMON'S PATCHED UP TEAM
ERRS OFTEN—BOWERS
THE FEATURE.

Two upsets of the baseball dope came along last Saturday. In the first place Joe Cohen's bunch caught the Kams with their fingers uncrossed and belabored them most mercilessly, fairly running away with Lemon's warriors to the tune of 12 to 3. Both teams played rather frayed baseball, the Kams piling up eleven errors by dint of some very weird throwing. In the second place, the H. A. C.'s administered a stinging defeat to the unbeaten Elks, who saved themselves from a shut-out by buncing hits in the last inning and running bases with two men out until Wilder neglected to touch first and ended the rally just when the Elks began to get busy, the final score being 6 to 3, closing up a brilliant game in spite of many errors.

The Kams had shifted men around till the infield looked like a prize craquel, and played much the same way. Jones doffed the mask and went to third, Hamauku caught, Lota guarded first, Lemon short, and an undershirted individual named Kai essayed to serve up the warps. During the three innings he presided in the box he allowed four hits, and this, added to ten errors, gave the Calves seven runs. Then Jones went to his rightful domain behind the bat, while Dick Reuter was yanked into the box. Reuter was hit safely five times and was a trifle wild before he got warmed up. After that he was effective. It was poor infield work that raised the Maille score so high.

The Mailles as usual managed to roll up a good many mistakes, but Freitas kept the hits scattered and his teammates had luck with them, so that the Kams had to work hard to score at all. By virtue of this defeat, they are now tied for second place with the Mailles, each team having won four and lost four games.

The real feature of this game was Bert Bowers. Some of the Mailles forgot to come out to the Park on time, and so Mr. Bowers, aching to get back into the arena again, temporarily signed with Joe Cohen for centerfield. Donning a jacket that fit too well and baseball trousers that didn't fit at all, he trotted out to his garden. After that there was no hope for the Kams. The spectacle of the agile Bert careering in the offing before the breeze, put the Kams far under the table, and they never could crawl out. Bert had two chances, and made one error, on backing up a hit, so he came away even. The writer has a profound admiration for Mr. Bowers as an umpire and a private citizen, but not as a Maille centerfielder. However, as a kahuna Bert has "Dooney" Hartman's gaudy hen beaten from here to yonder. He came to bat twice, each time amid the crash of applause from the grandstand. And each time he made the circuit on errors, for the Kams simply couldn't see the ball with the erstwhile umpire on bases. After three innings, Mr. Bowers' exertions so upset his equanimity that he was forced to leave the field, and in the last game Lemon umpired. Cunha and Hampton held the indicator in the first game.

The Kams scored once in the first inning. Lemon walked, went to second when Ah Moy juggled Jones's grounder. Hamauku struck out, but Lemon scored when Simpson let the ball get away from him. The Kams scored again in the third. Jones singled and Lota brought him home with a safe hit. In the eighth Pahu hit safe, Reuter was struck on the nose by a pitched ball and walked and Plunkett lived up to his name by sending Pahu home with a safety. These three were all for the Kams.

Ah Moy started the slaughter in the second by hitting safe. Bowers was safe on Jones's error at third. Bowers got to first when Hamauku dropped the third strike. All three scored when both Sheldon and Jones erred during the progress of the ball around the bases. The Mailles followed this up with four in the next session. Simpson walked, but was caught at home later. Miller singled and scored on Hamauku's wild throw to catch him at third. Ah Moy hit safe. Wright got his first hit of the season. Ah Moy scored on Lota's wild throw. Bowers walked and when Lota again threw the ball away Wright and Bowers crossed the scales. With two down in the fourth the Mailles added two to their rapidly increasing tallies. Miller forced Simpson at second. W. Chillingworth walked, Ah Moy walked and Wright again smashed out a safe one, scoring Miller and Chillingworth. In the fifth R. Chillingworth scored on a hit, Brun's sacrifice, and two successive passed balls. In the seventh W. Chillingworth reached first on Lota's error, made second and third and two more passed balls, and Wright scored him with third hit. In the eighth Simpson walked, went to second on a passed ball, third of Miller's long fly to right, and C. Chillingworth scored him with a single. With twelve runs in the Mailles stopped to take breath, and let the ninth go without molesting the scoreboard.

For sheer heart-breaking excitement, the H. A. C. game had any other contest this season looking like a session of the Old Maids' Sewing Circle for the Benefit of Foreign Mission, with the teapot and the tabby cat purring side by side on the hearthstone. It was the prettiest kind of baseball all the way through, with more star plays tucked away into nine inning than usually come in two or three games. Both teams were stretched to their limit, straining every nerve to pull the game down, and the result was a great battle. Inning after inning came and went with the men executing daring and faultless plays and the grandstand vocal with joy. There was a good deal of bitterness running around loose between the Elks and the Reds, and this kept the crowd on edge all the time. Where the nervous strain under which the teams were playing is considered, the fielding errors are mostly excusable. They were due to over-eagerness. The two errors chalked up against the Reds are both wild throws to catch men off bases. Hampton erred twice in the same way, Leslie once, Moore once, and Grady once—all due to over-eagerness. The only other error was when Hampton grabbed En Sue's grounder with a man on base, and couldn't decide where to throw it, finally letting everybody safe.

Outside of that the fielding was superb. Evers, the crack Elk shortstop, shone like a comet, taking in line drives, picking up sizzling grounders, and winging to first with great speed and accuracy. Al Williams, En Sue, Moore, Hampton and J. Williams were up on their toes in the infield all the time. The gardeners were not kept very busy, except Fernandez who cut out five flies; but Klu, Bob White and Fernandez saved several hits into their territory. Considering the number of men who were simply killing the ball, the hits are surprisingly few. But always when a fast drive would start for Diamond Head an H. A. C. or an Elk form would rise from the earth and gather it in.

The Reds won because they outplayed the Elks. Hampton was effective to the extent of holding the H. A. C.'s to five hits in seven innings. But this was not good enough with J. Williams sneaking his elusive shoots across the plate. Williams allowed only two hits until the ninth inning, when the Elks found him for two doubles and two singles. The Red captain was responsible in a great part for the victory, for his work was heady and consistent. For five innings not an Elk man ever reached the initial bag. Hampton was off color, but if Grady had been behind the bat throughout the game the score would have been different. Sam Leslie started to do the backstop work. His playing was ragged. He redeemed himself however in the fourth inning, when with a man on second, he stopped a wild pitch, breaking his finger in doing so. Then Grady came in and Wilger went to right. The change worked better, but it was too late to save the game. Thenceforth the Elks strove desperately to escape a shut-out and succeeded in the ninth inning, thanks to Cogswell and Wilder.

The bad blood between the teams boiled over several times during the game, furnishing amusement to the spectators. In the seventh inning Hampton laid on the ball for a safe one and running down to first butted Gleason off the bag. Then ensued a war of words between the two men, apparently with frequent reference to the dire fate of "knocking the block off." Hampton claims Gleason tried to stop him on first, while Gleason denies it. At that stage of the game it is probable that honors were about even, anyway. Hampton then stole second and, arriving there, bumped "Toots" Cunha somewhere in that estimable gentleman's anatomy. Cunha claims that the bumping was done with (Continued on Page 6.)

Mr. Wright takes an interest in the public schools and possesses energetic interest. That is what the public schools of Hawaii are need.

ENDORSEMENT OF MR. COOPER

The resignation of Governor Carter has developed one feature remarkable to Hawaii—unanimity of opinion as to his successor.

It has been clearly demonstrated that the people have no anxiety that the present Governor quit his work. He however has put them in such a position that they are in duty bound to endeavor to make up their minds as to the man they want for the future. Never in the history of the islands have the various factions and we might add, the political parties centered so quickly and with so little friction about a candidate as the citizens of the Territory have about Henry E. Cooper.

The action of the Republican committee on Saturday was without precedent in the history of the Territory as regards the unanimity of thought, and there was no strenuous whipping into line to bring the action about. T. McCANTS STEWART

One of the first things he did was to upset a "program" laid down for the organization of the Republican party at a long-to-be-remembered public meeting. The last thing, was to become the active agent of the County law which, being thoroughly revolutionary in its upsetting of old monarchical lines will undoubtedly go down in history as the first wedge of Americanism in the Territory of Hawaii.

In the meanwhile he has held the respect of the community while constantly assailed by a faction which, claiming to be progressive and public spirited, has inspired and carried on the most disgraceful campaign of race prejudice that could be imagined. A less evenly balanced man might have been fired to equally vicious action and united an opposing race feeling. This Mr. Stewart could have done because he has the energy and organizing power of men twenty years younger. This he could not do because he was too much of a man to be driven to the low tactics of those who attacked him.

Whether it is coincident or not, the fact is that the men who led off in mud bespattering Stewart were the enemies of the County law. It is safe to say that the County law would have had a much more doubtful course through the Legislature had it not been for the unceasing work and watchfulness of Stewart. So the credit for success and attaining the object sought went to Stewart as against his enemies. He worked in a dignified way. They never did.

His enemies have maligned him but they can't change the record that Mr. Stewart has been staunch in his Americanism, public spirited, vigorous in what he has undertaken, gentlemanly, a good friend and hard fighting but

RESIGNATION OF CARTER.

(Hawaii Herald)
The aftermath of the Oahu election, however childish the action of the Governor may have been, is not surprising, nor was his action in resigning other than in keeping with much that he did during his administration. The affair could have been averted, first by the Governor refraining from taking such an active part in the election of a County Sheriff, and again by giving the public greater consideration. As the Executive head of the Territory he was a mistake; as the implied head of the Republican party in Hawaii he was a greater one, and the rebuke he received at the polls by the election of the man he opposed was a deserved one. The sting in the statement of the Federal Judge was no less deserved than it was painful. As put by A. G. M. Robertson, both Governor Carter and High Sheriff Henry tried to put themselves above their party, but the voters would not recognize their right to the stand taken by them, and they fell victims of their own overrated hold on the people. Governor Carter could have been an idol in the estimation of Hawaii; he could have made himself so popular that a change in the Administration at Washington might not have affected him. But he chose another course and to differ with him on any line was taken by him as a flagrant breach of courtesy and doubt of what he was beginning to consider his divine right to rule and, if necessary, ruin. What he did was done conscientiously, and it is doubtful if explicit charges of a damaging nature could be brought against him, but it is conceded that his course from the beginning to the end was a series of mistakes. In resigning his office he merely redeemed himself. That it met with the approval of the people of Hilo was shown in their countenances immediately after the news was received. For the first time in history the citizens were of one accord.

CAN'T BORROW THERE

SHERIFF OFFICE WILL NOT LEND NOW

BROWN SAYS NO MORE LOANS TO POLICEMEN — CAN EN-DORSE SALARIES ONLY ONE TIME.

The sheriff's office is going out of the loan business, or rather, the County Sheriff will not continue the lending business carried by the former High Sheriff.

Sheriff Brown has got his foot down flat, and already has refused several applications. He cannot prevent the members of the force from endorsing their salaries to money-lenders, but if a policeman is found endorsing the same salary to more than one man, he will be discharged from the force.

"The proposition is just this," said Sheriff Brown this morning. "This office is going out of the money-lending business absolutely. No more loans to policemen at any rate of interest will be allowed here. I take this step because in the past there has been criticism of the money-lending by this office, and it will be entirely done away with. Under the law the members of the force may endorse their salary warrants to another person. We cannot stop this. But I have cautioned the men against endorsing to more than one man. I advised them to borrow from the same man continuously rather than going from one to the other. If they endorse their salaries to more than one man, it will amount to gross cheat, getting money under false pretenses, and when detected they will be discharged from the force."

"Under the new law 2 per cent per month is the maximum rate of interest that may be charged by money-lenders."

HALEIWA GOLF

A tournament for the Haleiwa cup was played last Sunday. The weather was warm though tempered by a breeze. This did not interfere much with the game.

IS INAUGURATED

(Special to The Bulletin)

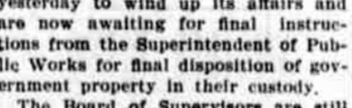
Walluku, July 1.—The Board of Supervisors for Maui County took their oath of office before Circuit Judge A. N. Kepoikai at noon today. The Board met at Kepoikai's office on Market street at noon. It was generally thought that the Board would have its first meeting at court house, and so a large number of people gathered around there expecting to take in the inauguration ceremonies, but while they were waiting the Board of Supervisors were taking their solemn oaths before Judge Kepoikai at his office on Market street. All the five supervisors were present: Wm. Henning (Lahaina), chairman; W. H. Cornwell (Walluku), T. T. Meyer (Molokai), T. M. Church (Makawao) and J. Hualalani (Hana). Sheriff W. E. Saffery, County Attorney D. H. Case, Auditor Chas. Wilcox and Clerk W. F. Kae and the five deputy sheriffs also took their oaths of office. The bonds of the supervisors were all approved by Circuit Judge Kepoikai. The Board had approved the bonds of all the County officers including sheriff and his five deputies. Treasurer L. M. Baldwin was the only official absent. During the meeting Chairman Henning received a wireless message from L. M. Baldwin stating that Supt. of Public Works Holloway had decided to turn over all property under Road Boards on Maui to the Board of Supervisors. The message was received with hearty applause by the Board, for it was really good news to Maui County. The Walluku Road Board, F. F. Baldwin, chairman; R. W. Filler and C. B. Wells, members, met yesterday to wind up its affairs and are now awaiting for final instructions from the Superintendent of Public Works for final disposition of government property in their custody.

The Board of Supervisors are still holding session discussing as to advisability of issuing new commissions for police officers throughout the County.

There will be no radical changes in police force of Maui County as County Sheriff Saffery will keep most of the men appointed by Territorial Sheriff L. M. Baldwin.

The usual number of applicants for positions as hack inspector, fish inspector and similar inspectors, are always on hand around the headquarters. A number of Home Rulers and Democrats are under the impression that Supervisor W. H. Cornwell and Deputy Sheriff Thos. Clark will run the affairs of the County and that they will all be appointed to fat billets to the utter exclusion of Republicans. There will be many disappointed ones before the week is out, and some one will surely suffer for false promises to constituents.

REPUBLICANS ARE UNITED IN ENDORSEMENT OF H. E. COOPER.

(Continued from Page 1.) one of the most essential things is the presenting of a united front. Cooke's remarks were well received and on motion of Charles Clark, seconded by W. W. Harris, the resolution was adopted.

When the Governorship matter had been settled and a motion to adjourn was in order, Sam Johnson arose with fire in his eye to say that he had been told by one of his men that there was a petition or an affidavit in circulation or ready to be introduced to the effect that he had advised men to vote for Henry for Sheriff. In whatever form this allegation was made, he said, it was a low, dirty piece of business and was utterly false. All he asked was that it be brought out; he would personally attend to the man who was responsible for the lie. Johnson looked what he said. His hands were clenched and there was fight in his attitude.

John Hughes got to his feet to declare that it was high time that straightforward Americanism should be fostered in this Territory; there was too much throat-cutting; to be sure too many men following the line of least resistance in politics, but he did not believe that William Isaac should have been hunted down for what he had done in the county campaign. "Unless we are going to stop this wrangling down here," said Mr. Hughes, "a proposition may take shape in Washington to cut us out altogether."

He added that the committee should go on record for stopping the censure resolution business and string well-meaning party workers. J. P. Cooke said he hoped no such petition or affidavit as Johnson had reference to would come up. He said that Johnson was known as a hard worker for the party and he was to be admired for the part he took in the campaign. Troubles of the campaign should be forgotten. The following resolution by Hughes was adopted: "Resolved, That this Central Committee extends its hearty Aloha to all County officers and promises them its moral support."

On motion of Hughes, proxy for Wm. Horner, it was decided to have a committee of three on rules, to be appointed later.

The following resolution, introduced by Mr. Ka-ne and seconded by Mr. Cooke, was carried unanimously: "Whereas, Mr. T. McCants Stewart has, during his sojourn in this Territory, been a prominent, enthusiastic and consistent Republican, whose valuable services have repeatedly been required by, and cheerfully given to, the Republican party; "Resolved, That the Territorial Central Committee of the Republican party of the Territory of Hawaii, while expressing extreme regret at the departure of Mr. Stewart, bids him Aloha Nui, and trusts that he may have his

full share of happiness and success during the rest of his career."

DOUBT IS EXPRESSED.

(Continued from Page 1.) the 23d day of May, A. D. 1900, such approval also bearing the initials of the Attorney General of the United States.
The first question is as to the validity of the Act granting the franchise. The Act in question was duly and legally passed by the Legislature of the Republic of Hawaii. Such Act, however, could not become a law unless approved by the President of the Republic, or passed over his veto as by law provided. The question seems to be, not as to the right of the Legislature to pass the Act in question, but as to the right of the President of the Republic to approve the same, and by force of such approval make the Act in question law. Between the time of the passage of the Act granting the franchise and the approval thereof by the President of the Republic of Hawaii, the Republic of Hawaii ceased to exist as such, and all of its sovereign rights, including the right of granting franchises, passed to the Federal Government. Its President and officials ceased to have any powers except those continued in force by the Treaty of Annexation.
Had the law in question been passed subsequent to the date of the Newlands resolution or the treaty of annexation, it would have been voidable by the Federal Government as an illegal exercise of power by a body of officials having no legal right to exercise such power. Therefore, we come to the conclusion that the Act in question, viz: the Act which granted the franchise to the Honolulu Rapid Transit & Land Co., was, so far as the Federal Government is concerned, an illegal exercise of power, and voidable at the option of the Federal Government.
The question now arises, was such invalid legislation cured by the subsequent Act of Congress permitting the President to ratify franchises granted between the 7th day of July, 1898, and the 23d day of September, 1899, and the approval and subsequent ratification of such franchise by the President of the United States, in other words, was the approval and ratification of the franchise of the Honolulu Rapid Transit & Land Co., by the President of the United States, a valid exercise of the power in him vested by Section 73 of the Organic Act?
The same lack of power which made any disposition of Government lands after the passage of the treaty of annexation invalid, made the grant of any franchise invalid. What can be said of the exercise of one power may well be said of the exercise of the other. If the President of the United States, under Section 73 of the Organic Act, is given the right to ratify sales and disposition of Government land, made by local authorities after the passage of the treaty of annexation, then why with equal force, can it not be said that franchises granted by local author-
