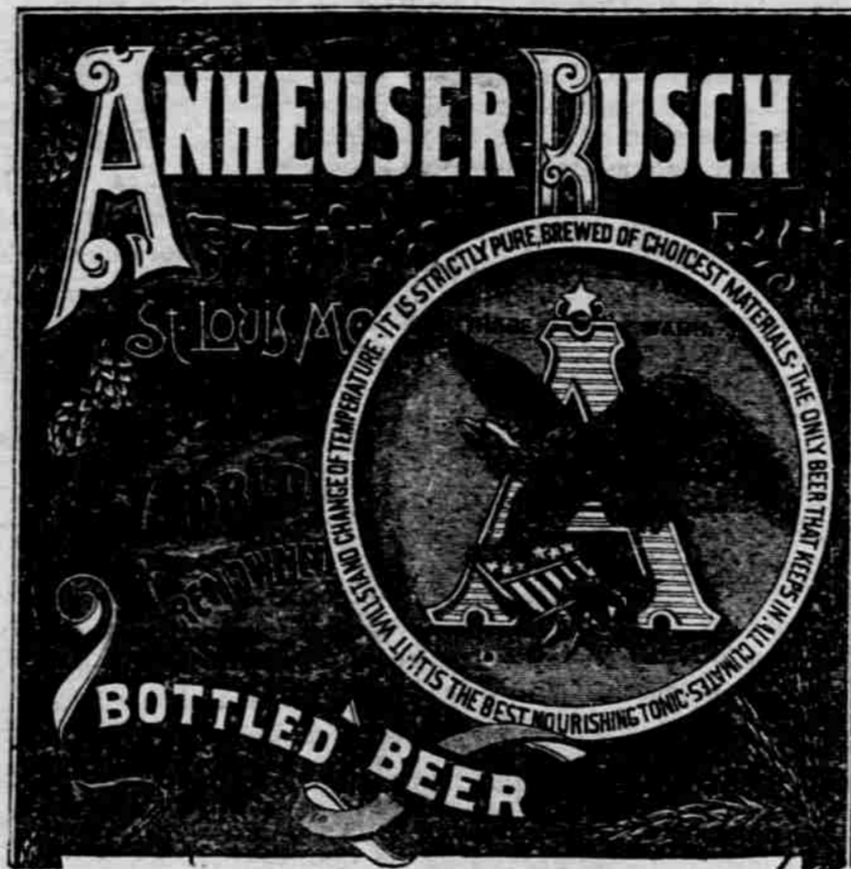

THE MASS MEETING.

As will be seen from a notice in another column, a number of leading citizens are calling a mass meeting for the purpose of discussing the situation. All interests planters, capitalists, merchants, mechanics, professional and workmen, are equally well represented, as are all nationalities. The meeting, which will be addressed by prominent speakers, will be attended by all who have the welfare of Hawaii at heart and believe in a true government by the people, of the people and for the people.

A LIE NAILED.

The following appeared in last night's Star:

A well-known Royalist asks the Star to print the following: "A meeting of a faction of the Royalists was held at A. P. Peterson's house on Wednesday evening. Wendenberg and Ashford are making desperate efforts to displace the Hui Aloha Aina and pose as the real leaders of the Hawaiians. They want a mass meeting of natives to listen to them and the HOLOMUA gang, rant on the subject of registration, etc. We learn that John Cummins, the President of the Patriotic League and his leaders Bosh Nawahi, Rickard and Marques and their numerous following will have nothing to do with the 'jumping-jack politicians' The League prefers to retain the dignified and discreet course they have kept up and the Hawaiians have no use for the Wundenberg Ashford chameleons."

As John A. Cummins, the President of the Patriotic League's name appears among the men calling the mass meeting, as well as the name of Jas. Kaulia, Secretary of the said League, it is easy to understand that the ambitious sore head who act as a traitor to the cause of Hawaii and as a "misinformer" to the Star, is nothing more than an ordinary (well-known) every day liar. The Royalists have only one cause, and they stand shoulder to shoulder, and are perfectly willing to dispense with those who are patriots only—for a consideration.

A Misrepresentation.

The Advertiser for the purpose of getting the Portuguese to register reports the Portuguese Charge d'affaires, Senhor Souza de Canavarro, as saying certain things which he neither did say nor would have said. The charge d'affaire has not advised or encouraged the Portuguese to take the oath prescribed by the P. G.

Professor Alexander, a government employee and who was formerly an honorary member of the celebrated "Hale Nana" (House of Wisdom) jocularly called the "Ball of Twine Society," gave a tourist's talk before the secret League last evening. The speaker was right in touch with the missionary spirit which at present is so noticeable amongst members of the organization.

The political Judd is not known to have enrolled in any company during any of the revolutions. In the others he was well beneath the surface, but, in this last he is well in advance, but, ready to retreat!

By the way, what salary does the registrars of election receive per day? And why are two whites needed? The native registrar has a seeming sinecure in not all three have a soft job. People's money squandered.

The Samoan War.

The news of the proceedings of the last eight days will, we should imagine, create immense surprise and a good deal of sensation when conveyed to the Great Powers who have taken upon themselves the adoption of Samoa. For the second time within less than a year rebellion has become rife amongst us, and the blood of the native population been shed. That the present outbreak should occur so soon after the Treaty Powers had shown in a practical manner their resolve to assist King Malietoa and his Government may seem somewhat inexplicable, but it proves most conclusively the fact that now-a-days the aboriginal Samoan natives have lost in a great measure the respect for the white foreigner, which was for such a length of time one of their prominent characteristics. Many causes have been assigned for the present disturbance, but we question very much if even those most versed in knowledge of the native race could give a direct and satisfactory answer to the oft repeated question—"What are the natives fighting about?" That discontent is prevalent, widely prevalent, and has been so for some time is incontestable, and that the reasons given for that discontent are ascribed to the actions of foreigners is equally without doubt.

To describe the present outbreak a rebellion against the King and Government of Malietoa is, perhaps, somewhat of a misnomer, and we are disposed to think that had the people of Savaii remained on their own island, although the feeling of discontent would still have prevailed and the revenues of the Government have suffered considerably thereby, yet no blood would have been spilt, at least for a considerable time. We are perfectly aware that many of the best informed foreign residents hold entirely different views as to the causes of the present struggle, and we will be in no way astonished to find that their view of the situation is the correct one. They assert that the quarrel is really one between the two great families of Samoa—the Malietoa and Tapua. In proof of this statement they point to the fact which, appears to be clearly proved, that Tamasese, the present head of the Tafua family, has during the last week at Aana been receiving tribute from the rebel party in the ghastly form of severed heads. However, notwithstanding these opinions, to which we are inclined to give every credit, we still incline to the belief that the trouble is more particularly one between the people of Aana and those of Savaii.

That the Government was, and yet is, strong enough to more than hold its own is certain, but it will not need many more defeats like that of last Monday to cause a large number of those who are at present wavering to espouse what they will think is the winning side. Even now, what was a task of comparative ease a few days ago presents many difficulties, and if the people of Aana effect a coalition with those of Atua, and become entrenched in Lutanaun, the Government will have—if they desire to subjugate the other party—a task, which under the present circumstances, and without outside assistance is almost impossible. Whatever is done must be done speedily to have any effect whatever, and unless the authorities so act—and by authorities we mean foreign, not Samoan authorities—they will be guilty of neglect which will lead to serious results in the immediate future of Samoa.—Samoa Weekly Herald.

The Chinese Union.

Irish Sarcasm.

A friend, who takes much interest in Hawaiian affairs has kindly sent the following remarks of Col. John P. Irish on the strictures made by one of the J[udges] L[ike] Stevens' fellow state's men. The sense is easy of interpretation and it does not require one filled with legal acumen to discover the point of argument Col. Irish said:

Mr. Boutelle, of Minn., has replied to secretary Herbert, taking the ground that the President as Commander-in-Chief of the Army and Navy, had no right to delegate his discretion to anybody, and therefore his order to the Naval Commander in Honolulu, being a delegation of discretion, was illegal.

So! Mr. Lincoln was Commander-in-Chief of the Army and Navy, and according to this Boutelle doctrine, he was guilty of the high crime and misdemeanor of delegating this authority in turn to McLellan and Grant, when he should have clothed his neck with a brass belt and led the armies and person. Witness how one violation of law leads to another. McLellan and Grant, corruptly, willfully, and illegally, proceeded to further unlawfully delegate their illicit authority to divers and sundry Corps, Division, and Brigade Commanders, and these wretched depositors of unrighteous authority passed the same on down to certain indictable subordinates, and Colonels maliciously ordered their regiments to charge upon the enemy when they should have done the charging themselves.

Now, here we are, nearly thirty years after Appomattox, compelled by Boutelle to the painful reflection that the rebellion was illegally suppressed by the pernicious delegation of authority that no one had a right to exercise except the President himself.

For a modern instance, we have Admiral Benham, in Rio Bay, firing unlawfully at De Gama's ship when he should have cabled President Cleveland to come down there and sight the gun himself. Not only was the Union illegally restored, but its subsequent proceedings have been as lawless as Chris Evans and as criminal as a tael of smuggled opium.

LATEST NEWS.

EUROPEAN.

Vienna, Mar. 21. The death is announced of Louis Kossuth, the veteran Hungarian patriot, at the age of ninety-two.

Paris, Mar. 21. The Government has decided to fortify Timbuctoo.

Paris, Mar. 21. Senator Bonlangier has been appointed Minister of the French Colonies.

Brussels, Mar. 22. News has been received that the Belgian expedition has seized the road leading to the Tanganyika, and defeated the Arabs.

Rome, Mar. 19. A bomb, to which was attached a lighted fuse, was discovered in the corridor of a theatre in Lucca. One of the audience detected the attempted outrage, and quenched the fuse.

Rome, Mar. 18. Queen Victoria arrived at Florence, and met with a most enthusiastic welcome.

Belgrade, Mar. 19. The Synod has annulled the divorce of King Milan and Queen Natalie, and the latter returns to Serbia.

Bangkok, Mar. 19. The Mandarin Phrayo has been acquitted of the murder of Inspector Gros-garm, the massacre of whose party was ostensibly the cause of the quarrel between France and Siam.

Paris, Mar. 20. In the Senate today, the rejection of a vote for the establishment of a Ministry for the colonies were reopened, and on a division the decision of the Chamber of Deputies, agreeing to such a department was affirmed.

London, Mar. 23. Mr. Chamberlain, speaking at Edinburgh, taunted Lord Roseberry with putting his neck under the heel of the Irish, by apologising when the Irish tigers raved.

London, Mar. 23.—Mr. Huddart has engaged Mr. R. S. White designer of the s.s. Campana, as nautical adviser in connection with the construction of the new 10,500 ton steamers, which he proposes to have built for the Australian-Vancouver line.

The London Daily News asserts that Russia intends to withdraw her embassy from Serbia, owing to the return of ex-King Milan.

The yacht Britannia won the chief prize at the Cannes Regatta. The Prince of Wales was on board.

Queen Victoria has been proclaimed sovereign of Pondoland.

London, Mar. 19. The Chancellor of the Exchequer estimates that the expenditure for the year will amount to £95,000,000, which is the highest on record.

London Mar. 21. The House of Commons has passed the Naval vote, both the Chancellor of the Exchequer and the Secretary of the Admiralty having given strong assurances that the supremacy of the British navy would be maintained.

The Secretary for Ireland has assured the Irish party that the second reading of the Evicted Tenants Bill will be taken before Whitsunday.

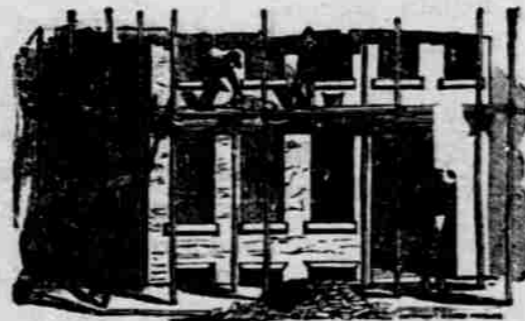
