CHINESE EXCLUSION

SENATE APPOINTS CONFERENCE COMMITTEE.

WASHINGTON, April 19.—President McKinley today appointed Senator Platt, Dillingham and Clay conferees on the part of the Senate to confer with Representatives Hitt, Perkins and Clark on the Chinese exclusion bill.

The appointment of Platt and Dillingham means that the Senate will not recede an inch in its bill and that the House conference will have to give away if a Chinese exclusion bill is passed during this session.

F. B. AUERBACH TAKES HIS LIFE

SHOOTS HIMSELF THROUGH THE HEAD WITH A WINCHESTER AT EARLY DAWN.

FINANCIAL WORRY THOUGHT THE CAUSE.

Deceased Was Investor in Branch & Company—Was For Eighteen Years a Resident of the Islands.

Frank Bond Auerbach committed suicide this morning at half-past five by shooting himself through the head with a Winchester repeating rifle of heavy calibre.

The deceased was the treasurer and manager of Henry May & Company, Limited, and has been in the employ of the firm for the last nine years.

Fourteen years ago he married a step-daughter of Benjamin D. Whitney, now watchman at the pilot house, his brother R. L. Auerbach also marrying a daughter of Mr. Whitney, step-sister of Mrs. F. B. Auerbach.

Debt and worry over financial affairs are supposed to have created temporary emotional insanity of the deceased and to this cause is attributed the suicide of this morning.

The Auerbach residence is near the corner of Keaumoku and Matlock Avenue. The next house is the residence of C. J. Ludwigen. Nearby is a vacant lot bounded on one side by a high board fence.

Deceased was a thirty-second degree Mason of the Pacific Lodge and was also a member of the Chamber of Commerce and Merchant's Association.

HAWAIIAN TIME OF TRANSITION

UNITED STATES SOLICITOR GENERAL OPPOSES HUMPHREYS-GEAR-ESTEE RULING.

FILES A STRONG BRIEF IN OSAKI MANKICHI CASE.

Attorney General Dole received from Washington this morning copies of a brief filed in the United States Supreme Court by Solicitor General John K. Richards, in the matter of the appeal of Osaki Mankichi.

The argument of the solicitor general is a learned discussion of the law of Hawaii's transition period, following in many respects the line of argument contained in the briefs and printed arguments of the Hawaiian attorney general.

"A petition for a writ of habeas corpus was then presented in behalf of Osaki Mankichi to Judge Estee, which he granted, having apparently changed the views which he intimated in the Marshall case.

"It is urged that the use of the qualifying words 'not contrary to the Constitution of the United States' after the words 'the municipal legislation of the Hawaiian Islands,' carried the Constitution into the islands and rendered void and inoperative every provision of the law of the Hawaiian Islands contrary to any of its limitations.

STREET CAR STRIKE ON

SAN FRANCISCO LINES ARE TIED UP.

United Railways Lines Are Entirely Stopped—Geary Street Men Go Out, It Is Alleged Through Intimidation.

SAN FRANCISCO, April 21.—The street car strike is on. Just one passenger car was run over each of the street lines operated by the United Railways in this city yesterday.

Although both sides did much work during the day, the strike stood last night just as it did in the beginning. President Holland of the company said with emphasis that he would not recede from the position he had taken when he first supported General Manager Vining's refusal to deal with the union in any way.

The action of the Geary-street employees in quitting work surprised even the strike committee. They had been ordered out, but as soon as the cars began leaving the barn at First and Point Lobos street a crowd began to gather.

BY A NEW METHOD

JUDGE ROBINSON SELECTS MAY JURORS.

Grand and Trial Jurors Summoned to Attend Court Next Monday—Term Under New Rules of Court.

Judge Robinson's jurists, grand and petit, for the next term of the first Circuit Court, have been selected and summoned to appear in court next Monday, when the term opens.

The May term will be the first one held under the new rules adopted by the three judges. One of the rules is the effect that each jurist shall have his own jury, instead of general summonses being issued for 48 jurors to attend all the courts, under the old system all the jurors had to appear before the presiding judge and when court opened in the morning the other two judges had to wait, sometimes half the morning, while he called the jury and got started on a case, so that he might excuse those not serving before him and send them to another judge.

There will be very little for the Grand Jury to do. There are about a dozen criminal cases to be brought before the jury and these will probably be all the jury will look into. Judge Robinson will charge the jury briefly and it is expected that the jurors will be in session only a few days.

TWILIGHT BACK IN PORT.

CAIRO (H. I.), April 28.—One of the worst disasters in the history of river navigation occurred shortly after 4 o'clock this morning near Odgens Landing, near this city. NEW BISHOP AN ELK

CARRIER OF BISHOP-ELEST REST-TARIFF.

Was Chosen Unanimously on the First Ballot in a House of Fifty Bishops-His Work.

SAN DIEGO, April 19.-Rev. Henry B. Restarick, rector of St. Paul's Church of this city, has decided to accept the Bishopric of Honolulu, to which he was elected on Thursday by the House of Bishops in session at Cincinnati. Mr. Restarick has had but one charge since he was a priest of the Episcopal Church. He studied at Grinnell College, Iowa, and at the age of 27 years, in June, 1882, he was ordained priest at Dayton, Ohio. He lived at Council Bluffs, and after returning there to be married, he started for California, reaching San Diego on the first train that brought regular passengers to the city. He preached his first sermon on the 19th of June, 1882, three days after arriving. The little church which stood where the Brewster Hotel now stands, in the heart of the city. Since then the church has grown to be one of the largest in the city, with many subordinate missions.

While the church has grown in number and wealth, honors have come to the rector. He has been named as dean of Southern California and archdeacon of San Diego county. He has three times represented the old diocese of San Francisco at the triennial general convention of the Episcopal church, and has gone twice for the new diocese of Los Angeles. He had received an intimation that he might be elected Bishop and sent to Kansas, but did not know that he was mentioned for the Honolulu office. The position pleases him better than any of the others, and there is an added reason in the fact that the honor came to him on the first ballot in a house of fifty bishops.

Mr. Restarick is the chaplain of the local lodge of Elks, and it is safe to say that San Diego Lodge, No. 163, is the first and only one to have a Bishop honor that office.

SUBURB DRUG STORE

HOBSON DRUG COMPANY OPENS THE WAY.

Will Move From Present Location Next Month and Also Open a Branch Store. The first branch suburban drug store in Honolulu will shortly be opened by the Hobson Drug Company, enabling the good people of this city to enjoy soda water and get their prescriptions filled after nightfall. But poison, colic cure or cough drops needed in a hurry, will be available and Honolulu will be quite up to date and metropolitan as far as drug stores are concerned.

T. W. Hobson, president and manager of the Hobson Drug Company has convinced himself that there is a considerable portion of the population who will patronize a drug store outside the city limits and will accordingly open a branch store at the corner of Fort and Beretania streets, in the new Sachs building. The new store will be opened in the evening and it is thought will prove beneficial both to its proprietors and the general public.

Two moves will be made almost simultaneously by the Hobson Drug Company, which has arranged to give up the store it at present occupies on the corner of Fort and King and move a little higher up town into the building at present occupied temporarily by E. O. Hall and Son. As soon as the hardware firm moves into its new building, the Hobson Drug Company will leave the location they now occupy for a number of years and move into the vacant store, which will be temporarily fitted up with the store furniture at present in use. Entirely new fittings have been ordered from the mainland and as soon as they arrive, will be placed in the new store, the furniture there taking another journey up to the Sachs building.

'We will get a great many fresh advantages in the new location,' said Mr. Hobson, 'although of course we are in a way sorry to move from the old location. The new store will be twice the size of our present one for some time and again we will have opportunity for window display the lack of which has considerably hampered us right along. I think there is an opportunity for a branch store at the head of Fort in the Sachs building. There is quite a populous community in that section and we are going to try it anyway. We expect to move about the end of next month but we shall not open the branch until the special fittings arrive for the main store. There have been many complaints, especially by the new comers, of the impossibility of getting prescriptions filled or patent medicines bought in the evening and we are going to make the experiment of trying to fill the want, if it exists.'

The new store, to take the place vacated by E. O. Hall and Son will have many different arrangements from the old one. Special attention will be paid to the facilities in the prescription and soda departments. The store fittings will include show cases especially designed for the business and the color scheme of the interior and exterior painted work will be in green and yellow, the same colors being adopted at the branch store. The photographic supply department will be given the room that has long been forcibly denied it and the convenience of patrons both at the soda fountain and in the various drug departments will be equally considered. The various branches of the trade will be separated distinctly in some cases to the extent of separate compartments especially adapted for the display of the various lines.

The bringing of the great transatlantic lines under one control is a great achievement. Whether it will be good for the traveling public or not remains to be seen. It will certainly reduce working expenses. That is fewer men in the volume of business, though not necessarily fewer men in the aggregate, because the volume of business is sure to increase. When railways came it seemed as if thousands of hostlers, post boys, coachmen and guards would be thrown out of work, but it was nothing of the kind. Where thousands were employed in the old coaching days, there are hundreds of thousands employed now.

We are beginning to reverse, or indeed have reversed the dictum of our ancestors which used to be that "competition is the life of trade." Our main object is to kill out or neutralize competition. The idea began with the department store in all probability. That united under one roof business which had been carried on under many roofs. The store under such circumstances could afford to take a smaller per centage upon its capital and the consequence was that it undersold its competitors on their special lines and yet made money.

From this comparatively crude beginning has grown the system of trusts. Like evolutions of human society they will have their period of advance and their period of decay. The friends and supporters of trusts or what should really be called monopolies, point out at how much less cost the article or articles which the trust deals in can be supplied to the consumer. But it is a question whether this is really the case. When all competition has been swept away, and sometimes, as in the case of the oil trust, but very reprehensible means, though the value of the article may be reduced for a time, it goes up again, because share holders must have dividends, and the largest shareholders must have money to advertise themselves as great philanthropists, and the weak world of poverty stricken every day workers looks on and says "what a wonderfully liberal man."

So though the consolidation of the transatlantic steamship companies may be and is a great commercial feat, and shows what can be done with money and brains, it is by no means so certain that it is going to benefit those who will have to use the steamers. Of course the consolidated lines having millions behind them will be able to undercut the remaining independent lines. But the North German Lloyd is a pretty powerful corporation, backed by a government and the patriotism of a great nation, and it will give Pierpont Morgan and his colleagues all the run they want for their money. The North German Lloyd is the very weak spot in the transatlantic combination.

It is not a good thing to come up against the Federal revenue officers or the Federal courts, as some of our moonshiners are beginning to find out. They will find out a great deal more later on, especially when the Federal operations are extended to the other islands. There will be a skurrying to do away with illicit stills. Informers upon such matters have been thrown down by the local courts, but the Federal court knows their value and takes their evidence. The immunity which two of the circuit judges threw about criminals, has been rent aside and many of these people will get their deserts.

THE BOERS.

The end of the Boer war seems in sight. Of course it has been supposed to be in sight on several occasions before, and this may be only another delusion, but it does not appear so. The Boer leaders as a rule want peace and it is only some irreconcilables that desire to hold out. The British on the other hand will only be too glad to have the country pacified and its industries developed. No industrial nation likes war for its own sake, though all industrial nations have to go to war. Indeed the power of warfare is the pivot of the industrial nation.

That a protracted guerilla war should have been carried on in South Africa is not to be wondered at when one looks at the nature of the people and the nature of the country. It took the whole force of the Russian Empire to reduce the Cossack Chief Schamyl in something like twenty years. He held the mountains, knew every foot of them and no Russian brigades could do anything against him, and they were hurried one after another like stones thrown at a rock. A great country can have a little war which is very trying and may appear humiliating until all the circumstances are understood. This will be the case with the Boer war in time.

As far as strategic work is concerned Lord Roberts showed what could and ought to be done. The capture of Bloemfontein and of Pretoria displayed military talent of a high order. But military talent is not necessarily police talent. Lord Roberts did the work he was sent to do and did it well. Unfortunately for himself Lord Kitchener undertook work which brought little if

any glory. His untiring energy, his determination to show out the affair will be appreciated later on. If the end of this unfortunate war is in sight every one who believes in advancement of all races will rejoice. The seeds of the war were sown partly in the ignorance and isolation of the Boers and still more by the vacillating policy of Gladstone. Great as he was in speech, magnificent as he was in finance Gladstone dealt his country many serious blows from which though she may recover, she will undoubtedly suffer for years to come and is now suffering from in South Africa. Without a Gladstone there would never have been a world famed Kruger.

AN IMPORTANT STATEMENT.

Public interest in the sugar problem—the share of the enormous consumption of that article supplied and likely to be supplied by the United States—has led the Treasury Bureau of Statistics to prepare a statement regarding the sugar consumption of the United States, the amount produced in this country of cane and beet, separately stated; the amount produced in its insular territory, Porto Rico, Hawaii, and the Philippines; the amount imported from Cuba, the amount from other tropical territory, and the amount from the best sugar-producing countries of Europe.

The sugar consumption of the United States has grown from 1,272,826,343 pounds in 1870 to 5,312,937,840 pounds in 1901; or, from 35 pounds per capita in 1870 to 65 pounds per capita in 1901. Of the 5,312,937,840 pounds consumed in 1901, 985,568,640 pounds, or more than one-sixth, were produced in the United States; 452,295,760 pounds, or about another sixth, were produced in the insular possessions, while the remainder, amounting to 3,475,073,440 pounds, or about two-thirds of the total consumption, represented imports from consumption.

Of the total imports during the calendar year 1901, 1,302,860,514 pounds were from Cuba; 686,616,954 pounds from the East Indies, chiefly Java; 1,122,895,887 pounds from other cane sugar countries; and 699,774,813 pounds from the best sugar countries of Europe.

Of the 985,568,640 pounds of sugar produced in the United States, about one-third was from beets and two-thirds from cane. Of that withdrawn from the insular possessions, all was from cane, as was also all of that from Cuba and from the other tropical territory; while of the 299,774,813 pounds of beet sugar imported, 484,344,904 pounds came in the unrefined condition, and 115,430,600 pounds refined.

The following table shows the total sugar consumption of the United States, stated in tons, from 1850 to 1901, and the quantity supplied by beet and cane production in the United States:

The Father Wendelin matter is liable to become a more serious one than the stone crusher, which the Board of Health undertook to do away with. In the case of Father Wendelin the Board will have to come out with distinct charges. Had the Board acted with diplomacy towards Bishop Guistan there need never have been any trouble. Oil is better than vinegar in a very large number of cases.

The bolters from the true Republican party seem to have unearthed another scheme. It is not Governor Dole's personality but it is George Carter's personality that has impressed the chief executive. The Star happens to know of the interview between Senator Carter and one of the bolters, and it has been most woefully misrepresented and misstated. However of that Senator Carter will be able to speak for himself. But the intense bitterness of a small clique against Governor Dole is shown by the attitude of the bolters. The bolters curse the President, and they may be very sure that their proclivities in this line will not be forgotten. Governor Dole beat his enemies hip and thigh and now the bolters are looking for a reason. They think they can play Senator Carter against Governor Dole, but they will find that they have made a serious mistake. Senator Carter is an ardent supporter of Governor Dole.

WHEELING IN PORT

The U. S. gunboat Wheeling arrived off port last night about 5 o'clock but remained off Waikiki over night, entering the harbor early this morning. The Wheeling is 12 days out from San Diego, but only 12 days of this time was occupied with actual steaming, as she put in five days making soundings and sounding for a mid-ocean rock and reef which had been reported at various times, by captains of merchant vessels.

The rock which was said to stand about 7 feet above the surface of the water, was reported to be in 29 degrees 2 minutes north latitude, and 157 degrees 29 minutes west longitude. The reef was reported to be in 27 degrees 40 minutes north, and 140 degrees 49 minutes west. Although the greatest care was taken in sounding for the two places, no trace whatever was secured of them. The shallowest depth secured was 2275 fathoms. The weather was very rough for three days after leaving San Diego, and for some of the time, the vessel was unable to make more than 3 knots an hour. She is quite a small craft and rolled a great deal, her heavy guns being no doubt largely responsible for this action. The weather was bad for several days before reaching Honolulu. The only thing of particular interest during the voyage was the death of A. Hamana, a Japanese cook, which occurred April 26 from heart failure. He was buried at sea.

The Wheeling is of 1,000 tons register and for an small vessel, is heavily armed, having 6 four-inch guns, 4 six-pounders, 2 one-pounders and 1 Colt's automatic gun. Her master is Commander G. Blocklinger, and the Executive officer, Lieutenant Commander Henry Winett. The other officers aboard are Lieutenants W. S. Smith, R. N. Duffenbach, J. L. Stich, Ensign R. N. Martin, Navy cadets Bryan A. Long, Passed Assistant Surgeon Raymond Spear and Assistant Paymaster E. P. Sackett. The vessel is on her way to Pago Pago, to do some important hydrographic work, in the surveys of the harbor of Pago Pago and the three Samoan Islands belonging to the United States. She will not relieve the Abarenda, as the Collier Nero is to take the place of the Abarenda at Pago Pago.

The Wheeling performed quite exciting duty for some weeks before her last departure from Mare Island. She was doing patrol duty between Colon and Panama, during the revolution. The men on the Wheeling were given an excellent opportunity of seeing the effects of war, as hundreds of soldiers were brought into both those places to be attended. Some of the sailors from the Wheeling did dress the wounded men and assist in important surgery work. The Wheeling was relieved by the Philadelphia and then went to Mare Island and back again to San Diego, for target practice. She will remain here from ten days to two weeks. A number of minor repairs will have to be made on her. Admiral Merry visited the vessel this morning. She goes direct from Honolulu to Pago Pago. She may ship some Hawaiian while in this port.

LOOK FOR EARLY PEACE

PRETORIA, April 26.—General De Wet has gone to Heilbron, Orange River Colony. General Botha, the Transvaal commander in chief, has gone to vryheid, Transvaal, and General DeWet, with Mr. Steyn, ex-President of the Orange Free State has gone to Klerksdorp, Transvaal. They have arranged to meet the burghers at different points and submit the British terms. It is believed the Transvaalers will everywhere accept the terms, as they are in no way anxious for a winter campaign. The only difficulty likely to occur will be, it is thought with the Orange Free Staters, many of whom are expected to prove recalcitrant. In the meantime there will no cessation of hostilities. The delegates are expected back to Pretoria the middle of May, and in anticipation of their return they have given orders here for new clothes, provisions, etc.

RALMORAL (Saturday), April 19.—General Lucas Meyer, commander in chief of the Orange Free State forces, State Secretary Raits of the Transvaal and the other members of their party arrived here last night and this morning proceeded to the north. They were accompanied by a British escort, and it is their intention to consult with the Boers in the field. LONDON, April 21.—The Pretoria correspondent of the Standard cables that there is good reason to believe a tentative agreement has been arrived at which will prove mutually copious and lead to an early cessation of hostilities. The Utrecht correspondent of the Daily Mail says it is recognized there that the Boer delegates at Pretoria have full powers to negotiate without reference to the Boer leaders in Europe who have no real influence on the peace negotiations.

PERFUMERY PLANTS

WASHINGTON HAS SOME SEEDS TO DISTRIBUTE.

Varieties of Plants Used in Making Perfumes of Which the Department of Agriculture Offers to Send Seeds.

Director Jared Smith has been corresponding with the Agricultural Department and with other authorities regarding perfumes which are thought to be agricultural possibilities in Hawaii. By the last mail he received the following letter from the Department of Agriculture, offering to distribute some seeds:

"The Department of Agriculture has imported from France small amounts of seed of the following perfumery plants:

- True lavender (Lavandula angustifolia). Spike lavender (Lavandula spica). Common or garden thyme (Thymus vulgaris). Wild thyme (Thymus serpyllum).

"These all furnish valuable oils which are extracted by distillation. The oil of true lavender is by far the most valuable, being extensively employed in fine perfumery. The dried flowers are used in sachets. That of L. spica serves some purposes in quantities, chiefly for scenting soaps. It is also the source of thymol. The herb is used as a seasoning in cooking.

"These are perennial plants which naturally grow in dry, warm regions, or at least in dry places. They should be grown in open ground, on light, well-drained soils. Lavender has succeeded in England, notwithstanding its moist climate, but only on porous limestone soils, not tenacious of water. In England true lavender is propagated by cuttings. Thyme can be propagated by root division and cuttings. The oils are distilled in much the same manner as that of peppermint.

"Small packets of the seeds can be had by applicants who wish to try them, as long as the supply lasts. The kinds specially desired should be specified. Reports are requested from experimenters as to vigor, size, and hardness of plants, whether they mature seed or not, and other points of interest.

J. C. Cohen was tendered a vote of thanks for his work in this connection and was also appointed manager of the league. The title carries with it the office of president and the titles and duties of president and secretary. The first game of the league will be played next Saturday between the Honolulu and the Artillery nine.

TUG-OF-WAR TONIGHT.

The tug-of-war tournament will be continued tonight at the Ania water-house. The pulls will be between the Portuguese and All-Americans and the Public Works and Lumber Yard teams. The Public Works team is mainly composed of members of the old Wela Ka Hilo team and are confident of victory. The Portuguese appeared on Saturday evening and only lost to superior weight after a hard fought struggle.

ENCOURAGES COLLEGE ROWING.

BERLIN, April 17.—In order to encourage rowing among the students of the University of Berlin in the manner in which the sport is conducted in American and English colleges, Emperor William will offer what is to be known as the "Emperor's prize" for rowing contests between undergraduates of the university.

PRESENTED TO ART MUSEUM.

NEW YORK, April 17.—James Henry Smith of this city, heir to the \$50,000,000 estate of the late George Smith, who amassed his fortune in Chicago and died not long ago in London, has purchased Rubens' "The Holy Family" for \$50,000 and presented it to the Metropolitan Museum of Art.

MISS EASTWICK RELEASED.

LONDON, April 17.—Miss Marie Josephine Eastwick of Philadelphia, who was sentenced to six months' imprisonment November 18th last, after having pleaded guilty to the charge of forcing a \$100,000 railroad certificate, will be released tomorrow. Her health was not affected by her confinement in prison.

PHILIPPINE CHOLERA.

MANILA, April 20.—The United States Philippine Commission has passed a law authorizing municipalities to appropriate funds for combating epidemic diseases. The cholera situation shows no improvement. There has been a total of 288 cases and 300 deaths in Manila and 852 cases and 602 deaths in the provinces.

THE STANFORD DINNER.

Students of the University Meet Founder at Dinner.

A dinner to old students of Stanford University was given at the Moana Hotel last night by Mrs. Jane L. Stanford. Twenty-eight covers were laid. REPUTATED BY RUSSIA.

A Daily Chronicle telegram from Berlin states that General Gribasky, author of the Blagovestchensk massacre on the Amur river during the Boxer uprising, has been dismissed from the service.

CHEAP CEMENT.

Receipt For Making It Sent to Jared Smith.

Jared Smith has received from an agricultural school in Texas a receipt for new and cheap cement, which it is thought may prove valuable here. It is made from sand, lime and coal tar. The cement was called to Smith's attention while he was on Maui and he wrote asking for the recipe. The cement is made of 73 per cent sand, 3 per cent lime and 24 per cent coal tar. With this kind of cement, which is said to be durable, a reservoir was constructed in Texas, large enough to contain 140,000 gallons of water, for \$140.

MEMORIAL TO RHODES.

CAPE TOWN, April 15.—A meeting of citizens to establish a national memorial in honor of the late Cecil Rhodes was held here today. A committee composed of Sir Gordon Sprigg, the Premier, the Mayor of Cape Colony and a number of other prominent persons was appointed. The committee will issue an appeal for funds throughout the British empire for the purpose of erecting an immense cairn on Devil's Peak, overlooking the Cape peninsula. The cairn is to be surmounted by a heroic bronze figure of Cecil Rhodes, looking to the north.

WHEAT AND FLOUR.

Another Sharp Advance is Made by British Dealers.

LONDON, April 18.—All the grain and flour markets of the United Kingdom further advanced prices today. The price of flour was raised another shilling per sack. In the Yarmouth grain market the price of red wheat advanced as much as two shillings per quarter.

LONDON, April 16.—There was a tremendous rush to subscribe to the new loan of £22,000,000 today. At the Bank of England it was estimated this evening that the loan had been ten times oversubscribed. The lists will probably close tomorrow.

It was said today that J. Pierpont Morgan, the Barings and the Rothschilds have secured an aggregate of £32,000,000.

Official confirmation of the above was forthcoming this afternoon by the Bank of England giving notice that half of the loan had been privately subscribed for and offering the other half for public subscription at 92 1/2, with interest at 3 1/2 per cent.

THE PRESIDENT CONTEMPLATES NO CHANGE.

Washington Star Says That Cooper Will Remain and No Important Changes Are in Prospect.

WASHINGTON, April 14.—President Roosevelt has for several years to come set at rest all further agitation about important political offices in Hawaii by having the following announcement made at the White House today, after a conference with Gov. Dole and George Carter of Honolulu:

"The President, after most careful investigation, and hearing as many men as possible, and hearing from others, has come to the conclusion that Governor Dole's course, as far as such as to secure his continuance as governor of Hawaii, and entitle him to the respect and hearty support of the administration." This result has been confidently predicted from the beginning by the friends of Governor Dole, who believed that his personal explanation of affairs in Hawaii would be amply sufficient to set at rest some of the charges that have been made. Governor Dole has made a splendid impression on the President. He had a conference Sunday night with the President, and was with him again today. Mr. Carter, who is a senator in the territorial legislature, was with Governor Dole each time.

Governor Dole was shown the official statement and expressed satisfaction that the President had spoken so kindly of him. Governor Dole is going to Boston and will not depart for Honolulu for two weeks. He said that he had enjoyed his visit to Washington.

Governor Dole was asked if his health would interfere with his completing his term. The understanding is that the President's conclusion as to Governor Dole means that Henry E. Cooper, secretary of the territory, will not be appointed. He will remain under Governor Dole. Mr. Cooper is acting governor in the absence of Governor Dole. No other changes of consequence will be made, and apparently the Hawaiian situation is solved for a good while to come.

ORDERED SENT BACK

HUNDRED AND FIFTEEN CHINESE IN SAN FRANCISCO.

May Be on the China This Trip—Steamship Company Wanted to Send Them To Mexico.

The Pacific Mail steamship China, which will probably arrive this evening from San Francisco, may have on board about a hundred Chinese whom the Treasury Department has ordered the company to ship back to China. The steamship company has been making a fight to get rid of the Chinese by sending them to Mexico, or beyond the borders of the United States anywhere, rather than to take them all the way home. The Treasury Department's order is that the Chinese must be sent home at once.

The Pacific Mail Company had 115 Chinese confined in detention sheds in its San Francisco wharf, at least accounts, all of them refused landings by the federal courts. The courts gave their decisions in the usual form, as Judge Estee does here, ordering the Chinese to be taken in custody by the marshal and transported to the country whence they came. The steamship company appealed the cases from court to court for it meant to the corporation increased revenue by the continuation of similar patronage.

Recently the Chinese at the wharf have been very restless and an outbreak has been considered imminent. Both the steamship people and the immigration officials had in mind the fight that occurred a month ago on the occasion of the deportation of a lot of Chinese who didn't care to return home. Accordingly extra precautions were taken, on the day of the departure of the Hong Kong Maru. The decision from Washington being hourly expected every one on the wharf expected to see trouble. But things passed off quietly and there was no need to use the big three-inch hose that had been bent on to plugs in anticipation of the worst.

The Washington ruling is stated as follows: WASHINGTON, April 15.—The Treasury Department has received from the Collector of Customs at San Francisco a telegram stating that ninety-eight Chinese who are detained in detention sheds on steamship docks at San Francisco threaten violence if they are not either taken back to China by the steamship companies or are allowed their freedom. Several Chinese who were detained have managed to escape, and the case is giving the Treasury Department some trouble. In answer to the report of the Collector, Assistant Secretary Taylor today wired him to make a written demand on the steamship companies for the deportation of the detained Chinese and to further notify the companies that the Treasury Department will prosecute them for every Chinese who has escaped.

The Chinamen who are detained in the sheds have been held there from three to nine months awaiting deportation, and the steamship companies have done nothing to send them away. They came to San Francisco ostensibly for transit to Mexico, but the immigration officers had reason to doubt the good faith of those looking after their destination, which was believed to be this country, and the Chinamen were prevented from landing and ordered to be deported. The steamship companies have a case pending in the Supreme Court which they believe may settle the right of the Treasury to require them to deport Chinamen, and that is one reason they are holding the Chinamen.

Parker, in the presence of relatives and friends of the bride and groom, the wedding being a quiet one. After the ceremony a wedding dinner was served at the home of the bride's parents.

SIBERIAN FAMINE.

ST. PETERSBURG, April 18.—The reports received here from the famine-stricken districts of Russia more than justify the anticipation of acute suffering in those localities. Scarcity and typhoid fever are devastating the peasantry throughout the whole of the Altai (Highlands of the Siberia) region. The starving people there have consumed the last remnants of their seed grain, and no spring crops have been sown. The last wheat sold in Altai fetched 25 roubles per peck against the normal price of sixteen to twenty kopecks per peck. In some places the scarcity of fodder is so great that half the houses have been unthatched to save the lives of the cattle and horses. The gravity of the situation is evidenced by the latest statistics. At Mendeisk, Government of Kufa, there have been upward of 4000 cases of typhus; at Belobelsky 682 cases have been reported and at Akmolinsk over 1900

An official statement was sent out from the White House yesterday which decides the Hawaiian controversy in the following terms:

The President, after most careful investigation and personally hearing as many men as possible, and hearing from others, has come to the conclusion that Governor Dole's course has been such as to warrant his continuance as Governor of Hawaii and to entitle him to the respect and hearty support of the administration.

This vindication of an able and incorruptible official deserves the heartiest commendation. It is so complete in its practical aspects to the politicians that the Hawaiian government will be at once released from its most trying annoyances and embarrassments. Besides that, it is the just reward of well-doing, and this makes it a subject for general congratulations.

There is no officialholder under the United States today who has a higher conception of duty than Governor Dole or a purer record in private and public life. Political power came to him in the first place as a tribute to his character, and there has been no good reason to question his motives from that time to this. Sturs against his ability have been equally groundless. He is a man of fine intelligence, with a special knowledge of Hawaii and the Hawaiians gained through a lifelong experience.

No appointee from this country could possibly have such an equipment for his office as he has, and certainly no fit substitute could be found among the intriguing faction of carpet-baggers who have been moving heaven and Hawaii for his downfall. His retention is most emphatically a triumph for good government.—Chicago Record-Herald.

ALASKAN COMING

SAN FRANCISCO, April 28.—At 5 o'clock this morning the American-Hawaiian Steamship Company's Alaskan, commanded by Captain Bonfield, will sail from Stewart-street wharf for Honolulu. On her trip Saturday, under command of Captain George Harvey of this city, the huge twin-screw freighter showed a speed of nearly twelve knots, the actual speed being 11.9 knots, and to the officers of the company and representatives of the Union Iron Works proved herself to be better than was expected. Yesterday the Alaskan took on a quantity of freight for Honolulu that had accumulated on the wharf, and the remainder of her supply of 2500 tons of coal. At Honolulu the steamer will take in 12,000 tons of sugar for New York, much the largest cargo that has ever left the islands.
