Republican Candidate for Delegate secures big majorities on every Island in the Group—The Hawaiian Voter exhibits his American Independence

Prince Cupid had a walkover in this island. Wilcox was visited with a tropical snow storm of adverse ballots and was buried too deep politically ever to be resurrected. The Hawaiian on the Island of Hawaii came boldly to the front on election day and asserted his divine right as an American citizen to vote for whom he pleased regardless of the demagogue arguments by which Wilcox has hitherto maintained his power in this Territory. The Hawaiian voter asserted his independence. The count of Tuesday's ballot shows that he has commenced to think. He is showing that he possesses the stalwart qualifications necessary to good citizenship in any country. Let it not be said any more that the Hawaiian does not appreciate the power of the ballot and knows how to use it as well. He has proved that he is capable of relegating useless political leaders to the shelf of political oblivion.

so well qualified to vote, their representatives will not be long in learning the art of making good laws. The spur to good legislation is the lash of an independent thinking voter. Only three precincts in the First District on this island were for Wilcox. These were Kalapana, Kukunahale and Papaikou. In the Second District the record was even better, Kohala alone returning a preference for the Dead Coconut of Hawaii. For the Delegate, this island cast 501 more votes this year than two years ago. The cause for the big Republican landslide may be briefly summed up. The Hawaiians were utterly sick and tired of Wilcox. They were inspired by a genuine aloha for Prince Cupid and have confidence in his ability and good faith. The white voters shared these feelings with scarcely an exception. Palmer P. Woods on the Home Rule ticket ran ahead of Wilcox

72 votes and slayed his aspiring senatorial adversaries with the broadsword of his popularity. Party lines cut no figure with the friends of Palmer Woods. He is a broad minded and able man and will not forget that he owes his position to the people of Hawaii rather than to the members of any one party. His newly elected colleague, Senator S. L. Desha of Hilo was only two votes ahead of J. D. Paris. The fact that Paris and Desha were both on the Republican ticket is a probable guarantee of no contest over this narrowly decided vote. In the representative contest, Jim Lewis, the fighter from Hilo, has the distinction of being the only man who won in a walk, as well as being the only man on the Republican ticket elected. Lewis did the hardest kind of campaign work and is known both by native and haole as a dead square fellow. Paty of Olaa was but five votes behind Fernandez, Home Ruler, and some of

the friends of the former have hopes that the official count will prove the Olaa man has won. In this district the Independents hurt the Republican representative ticket more than they did the Home Rulers. As the returns from the other Islands came in it was soon evident that the stampede to Prince Cupid was universal. The figures from the Islands contained not one ray of light for the friends of Wilcox except at the last moment when a telegram came saying that Lanai out of a total poll of 21 votes, gave 12 to Wilcox and only 9 to Cupid. The Senate according to the latest reports will contain 9 Republicans and 6 Home Rulers. The Republican Senators are Cecil Brown, C. L. Crabbe, W. C. Achi, D. P. R. Isenberg and L. L. McCandless from Oahu, S. L. Desha from Hawaii, Baldwin and Dickey from Maui and Samuel Wilcox from Kauai. The Home Rule Senators are Kalauokalani from Oahu, John Brown, J. B. Kaohi and Palmer P.

Woods from Hawaii, S. E. Kaiue from Maui and H. R. Nakapahu from Kauai.

The lower house in the Legislature will be composed of 19 Republicans and 11 Home Rulers.

In Hilo, the election passed off as quietly as a Sabbath afternoon. Voters were early in line and but one or two votes were lost by reason of tardiness late in the evening. This precinct had 384 registered voters. Ten of these were absent from the city on election day and twelve for some reason did not vote. Of those who voted, 160 cast their ballot straight republican and thirty-eight straight Home Rule, eight Independent and 113 split. If forty-five voters had not scratched in behalf of Palmer Woods, this Island would have two Republican Senators.

IRISH IN COMMONS.

Charge That There is no Justice for the Irishman in the Courts.

London, October 20.—The Irish Nationalists were much in evidence at question time in the House of Commons today. They bombarded the Irish Secretary, Mr. Wyndham with all kinds of questions, interruptions and contradictions of his statements anent the imprisonment of Irish members. Wyndham's replies, though given in a conciliatory tone, evoked storms of derisive cries, mingled with hisses, and the speaker was kept busy suppressing demonstrations.

William O'Brien moved the adjournment of the House in order to discuss questions arising out of the case of Police Sargent Sullivan, now in America, who is alleged to have obtained the conviction of innocent persons through perjury.

The Liberal leader, Sir Henry Campbell-Bannerman, cordially joined the Irish in supporting their demand that the Government fix a day to discuss the status of Ireland, but he declined to make the Liberal opposition responsible for the demand, which, he said, was made by the constitutional representatives of Ireland and in regard to a purely Irish question.

A FATAL FIRE.

Home of E. B. Friel at Honolulu Burned Three Deaths Resulting.

Mrs. E. B. Friel, Etta Friel and Mrs. Nigel Jackson were fatally burned in a fire that consumed the Friel home on Nuuanu street, Honolulu, on the night of October 29. In the house at the time but escaping without injury were Edward B. Friel, Georgia Friel, Anna Voeller, Mr. and Mrs. E. B. Watson, Leon Torbiner. The fire was discovered by patrolman McCormack about 2 o'clock in the morning, but in spite of warnings and assistance from police and neighbors three members of the family were cremated alive.

The fire is supposed to have been started with the connivance of Nigel Jackson, whose wife was one of the victims of the fire. Jackson was placed under arrest on suspicion based on damaging statements he is known to have made.

Election Forecasts.

Chicago, Oct. 19.—Election forecasts received by the Record-Herald from New York, Pennsylvania, Ohio, Wisconsin, Minnesota, Indiana and Kentucky reveal a wide variance in the estimates of party managers, with the Republicans more confident as a result of the successful negotiations of President Roosevelt for a settlement of the coal strike. The reversal of feeling in favor of Republicans on this account is reported especially from New York, New Jersey, Maryland and all New England.

BOYD ARRESTED.

Superintendent of Public Works Charged With Embezzlement.

Honolulu, Oct. 29.—Shortly after 2:30 o'clock this afternoon a warrant of arrest on the charge of embezzlement was served on James H. Boyd at the police station. The bond in the sum of \$3000 was ready at the time so that, as soon as the warrant was served, it was presented and Boyd was immediately released.

The bond was signed by Prince Jonah Kuhio Kalaniana'ole, L. L. McCandless, and E. C. Winston.

The warrant for Mr. Boyd's arrest reads as follows:

Henry C. Meyers, Deputy Auditor, Territory of Hawaii, being first duly sworn says:

That James H. Boyd of Honolulu, Island of Oahu, Territory of Hawaii, occupying the position of Superintendent of Public Works of the Territory of Hawaii, and as such being an employe of the government of the Territory of Hawaii, and as such Superintendent of Public Works being entrusted by said government with the possession, custody and control of monies belonging to said government deposited with him, the said James H. Boyd, Superintendent of Public Works aforesaid, in the Department of Public Works of the said Territory of Hawaii, did, on or about June 10th, A. D. 1902, at Honolulu, Island of Oahu, Territory of Hawaii, feloniously and fraudulently take and embezzle from said Department of Public Works of said Territory of Hawaii, certain monies, to wit, the sum of \$1650, of the value of \$1650, the same being the property of the said government of the Territory of Hawaii, and did then and there wilfully, feloniously and fraudulently convert and appropriate the said money, to wit, \$1650 to his own use and benefit, contrary to Section 158 of the Penal Laws, of 1897, of the Territory of Hawaii.

BOYD ENDS PARLEY.

Following is the letter with which the correspondence between Governor Dole and Superintendent Boyd ended:

Department of Public Works.
Honolulu, T. H., Oct. 28, 1902.
Honorable S. B. Dole, Governor of the Territory of Hawaii, Honolulu, T. H.

Sir:—As any discussion of the subject matter of your letter on even date, in regard to conduct of the office of Superintendent of Public Works by me can serve no useful purpose, I desire merely to acknowledge receipt of your said letter and to inform you that I will immediately resume the performance of my duties as Superintendent of Public Works.

James H. Boyd was violently and "with force of arms" debarred from entering the office of Superintendent of Public Works this morning. At 9 o'clock Officers Muleitner and Neilson of the regular police force, in full uniform, were stationed at the Superintendent's entrance of the Department of Public Works opening off the main corridor of the first floor of the Executive building.

It was about a quarter of ten o'clock when Mr. Boyd arrived with Frank E. Thompson, one of his attorneys, and advanced toward the departmental entrance.

"You cannot go in there, Mr. Boyd," said Muleitner as he interposed his person between Boyd and the screen doors.

For answer Mr. Boyd endeavored to push his way past the officers. Both policemen grasped the Superintendent by the arms and about the waist.

A violent struggle ensued and lasted for about two minutes. The officers strained their muscles in vain to force Mr. Boyd away from the entrance. They could not

budge him from his standing ground at the corner of the inner corridor to the left. It was like two Spanish galleons trying to move the rock of Gibraltar.

Not a word was spoken, and the actors even tried to look good natured, while the three pair of feet thrashed the hemp matting until it was left all marred in surface.

Mr. Thompson all the while stood off by the foot of the stairway, regarding with a placid demeanor the strenuous combat.

Finally, Mr. Boyd was borne down, as to his body, against a plush upholstered chair standing by the entrance, his head and shoulders resting upon a marble-topped table beyond. With a tremendous effort he raised himself upright again. There was a pause for a moment and, as the grip of the officers relaxed, Mr. Boyd said to his attorney:

"Are you satisfied?"

"Yes; that's all right," was the reply and attorney and client walked out of the building together.

Besides the attorney the only witnesses to the dramatic contest were Thomas P. Cummins of the road bureau, who watched it from the farther end of the corridor; Nick Peterson, the hackman, who came in barely in time to see the finish, and a Bulletin reporter, who came out of the Superintendent's office on hearing the ominous shuffle of feet. Possibly also the officer who for weeks has been watching against an invasion by Auditor Austin was within seeing range, as he has for several days occupied the chair over which Mr. Boyd fell.

Secretary Cooper was in the office of the chief clerk of the Department attending to some matter with one of the clerks and apparently was unaware of the lively drama outside.

Governor Dole arrived by the rear entrance of the building within five minutes after the end of the battle.

As Mr. Boyd withdrew from the embrace of the minions of force he looked about the floor as if he had dropped something. A Bulletin reporter saw a dull glitter under the chair and picked up a button that had come off Officer Muleitner's uniform, which was mute evidence of the fierceness of the struggle.

Governor Dole stated that he had received a reply to his latest letter from Mr. Boyd, simply stating that the writer intended to assume possession and direction of his office. The letter had been handed to Mr. Cooper.

GOVERNOR'S DIRECT ORDERS.

Attorney General E. P. Dole, as departmental head of the police force, was asked about the forcible exclusion of Mr. Boyd from the Department of Public Works.

"I did not know anything about the affair," was the reply, "until fifteen minutes after it occurred."

Mr. Dole further declined to have anything whatever to say about the matter of the Superintendent of Public Works.

High Sheriff A. M. Brown entered the Attorney General's office at this moment and, replying to a question about the detail of police, said:

"All I have to say is that I sent officers up to prevent Mr. Boyd from entering the Department of Public Works under instructions."

"From the Governor," the High Sheriff added in reply to a query as to the source of his instructions.

The action which James H. Boyd took at the capitol this morning and which resulted in his ejection from the office of Superintendent of Public Works by force of arms, the details of which are given above, was in accordance with the advice given Mr. Boyd by his attorneys and contained in the following communication:

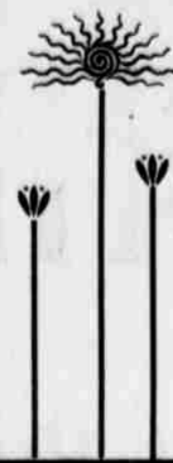

PARKHURST ON ROOSEVELT.

Says President Has Shown Himself to Be Bigger Than Parties.

New York, October 19.—Rev. Dr. Charles H. Parkhurst preached this morning in the Madison Square Presbyterian Church on "Lessons of the Coal Strike." His text was Ephesians, iv:25—"We are members one of another." In the course of his remarks he paid a remarkable tribute to President Roosevelt, and incidentally commenting upon the decision of a Judge who refused to hold a child for stealing coal, commended the decision and enunciated some views on human ownership which seemed somewhat radical when it was remembered that a minister of the gospel was speaking.

Of President Roosevelt's conduct during the strike, Parkhurst said, in part: "It is right that we should here, in this sanctuary, express our sense of gratitude to God that at a time so involved and so critical there was in the chair of the Chief Executive a man who had sufficient heroism of head and heart to hold the questions that confronted us steadily upon high and broad lines.

"It was not so much the heroism of his intentions that I was thinking, as the large way in which he worked towards the realization of his intention. Although acting outside of what could be called authorized lines, he nevertheless acted with authority, for in a way that was unique he became the embodiment of the people. Popular thought uttered itself through him; he knew it and they knew it. Without hurting the constitution he became a little more than the constitution made him.

"In keeping with what has just been said, he subordinated every special interest to the public interest. He has a heart for the laboring men, head for the capitalist, and an all-round soul for the universal necessities of the people and the country. Although a party man he is larger than both parties put together in the exercise at this time of his delicate stewardship.

"It is a great thing to see either a Republican or Democratic president stand on the shoulders of his partisans monitors instead of under their thumbs, and forget his smaller affiliations in his consciousness of the people. This feature of his case was made all the more conspicuous and noteworthy by the fluttering activity exhibited for a couple of days by the discredited patriots from this state and from Pennsylvania, who threw away their Bible lost their heads, damned the workmen and cursed the operators, and turned so much of heaven and earth as they had grip upon to secure a suspension of hostilities in time not to imperil the November elections."

Dr. Parkhurst quoted a newspaper story to the effect that a Bloomfield Judge discharged a little girl for picking up coal on the Lackawanna railroad, saying: "In my estimation, just at present it is no crime to take coal when necessity forces one to do so, as in this case it did." The preacher remarked: "Some may not think it quite proper to preach this doctrine, but there is not one of us, presumably, that would not have applauded in the Bloomfield courtroom, or, if too conservative to go as far as that, no one of us that would not have wanted to applaud. If I were dying of starvation and had no means of buying a piece of bread and were to go by a baker's where bread was within reach, I should help myself to it."

ENGLAND FACING A PROBLEM.

Belief That a Strong Force Will Be Required in Somaliland.

New York, October 20.—A cable to the Sun from London says: It is believed that the Mad Mullah now has between 30,000 and 40,000 men. Colonel Swayne's re-enforcements do not number more than 4,000. Alfred Pease, M. P., and other travelers who have been in Somaliland, say that it is now necessary to conquer the whole country, as the Mullah is certain to be re-enforced by all the petty sultans. The natives will make even the ports on the coast untenable unless the country is effectively occupied.

COMMISSION AT WORK.

President Calls the Arbitrators to Assemble at the Capital.

Washington, Oct. 21.—Shortly before 3 o'clock this afternoon President Roosevelt received a telegram from Wilkesbarre informing him that the convention of miners had declared off the anthracite coal strike. The telegram was signed by John Mitchell, chairman, and W. B. Wilson, secretary, of the convention, and was identical with that made at Wilkesbarre before noon today. Immediately upon the receipt of the information the following message was sent to Mr. Mitchell:

"Upon receipt of your telegram of this date, the President summoned the commission to meet here on Friday next, the 24th inst., at 10 a. m.

"GEORGE B. CORTELYOU,
 "Secretary."

News of the termination of the strike was received by the President with great satisfaction. Before the formal telegram from Mitchell had reached him he had been informed of the convention's favorable action.

Already telegrams have been sent to the members of the commission notifying them of the first meeting to be held in this city on Friday morning, and summoning them to be present. The meeting probably will be held in the office of Commissioner Wright. After the commission has effected its organization the members will call in a body on the President to pay their respects. At the time it is expected that he will embrace the opportunity to give the commission such verbal instructions as he may care to present to it. Besides, he may prepare a formal letter of instructions. That is the method pursued at the time of the appointment of the Pullman strike commission, of which Colonel Wright was president.

It is understood that few meetings of the commission will be held in Washington. After the work of the commission has been mapped out the first step will be to take the testimony of the miners, who may be regarded as the plaintiffs in the case. Notification will be sent to all interested parties that at certain specified times the commission will hear evidence to be presented. The parties to the inquiry will be permitted to be present at the hearings either personally or by counsel. It is probable that the first sessions of the commission at which testimony will be taken will be held in Wilkesbarre, as that city will be the most convenient for the miners' representatives. Other meetings will be held in Philadelphia or New York or in both cities.

Whether the sessions of the commission will be open to the public is a question the commission itself will have to determine, but it is regarded as quite likely that at all sessions when testimony is taken representatives of the press will be admitted.

How long the hearings will continue nobody can foretell. At their conclusion each member of the commission will be supplied with a copy of the testimony adduced and will consider it at his leisure. Subsequently the commission will reconvene, perhaps in this city, to formulate its reports for presentation to the President.

WHY ROUMANIA PERSECUTES.

London Mail Correspondent Says Hebrews Own Half the Land.

London, October 19.—The Daily Mail recently sent a correspondent to Roumania to investigate the Jewish question there, and this morning publishes a letter from its representative in which he says that in Roumania the laws are fair, but there is crying injustice in their application, or rather their non-application, to the Jews. The Jews, he writes, are persecuted not on account of their religion, but because if they were naturalized and treated justly they would own half the land, and, in short, "run" the country.

The correspondent declares that a large number of Roumanian Deputies derive large portions of their incomes from heavy bribes on the condition that they will help Jews to obtain naturalization papers.

WELL MANAGED.

The splendid Republican victory last Tuesday, which shows a Republican gain over two years ago of 2237 votes, shows among other things that the campaign was well managed. This fact is at least apparent on the Island of Hawaii. J. Castle Ridgway, the Hilo member of the Executive committee was a tireless worker from the beginning to the end of the fight. He kept in touch with the work in every precinct and directed the details of the campaign with persistency and good sense. When funds were low he went down in his pocket and kept the wheels well greased. The herculean labors of the Republican nominees on the legislative ticket had much to do with the general result. That three of the Representatives in this district failed of election is due to a few voters who knew better and should have more wisely discharged their civic and party duty.

WORK FOR YOUR TOWN.

Elbert Hubbard was alright when he said: "If you work for a man, in heaven's name, work for him, stand by him and stand for the institution he represents."

The same admirable exhortation applies to people who reside in a city or town. If you live in a town, for heaven's sake live in it; work for it; stand up for it, and defend your fellow townsmen. Every good word a man speaks for his neighbor, he speaks in a louder voice for himself. When a man backs his own town he backs his own future. The place to begin this best of all civic virtues is to begin in the town in which you now reside. The neighbor who deserves your first glad hand is the fellow living next door. Give him the fraternal mit and keep it up until you reach your office. If ten good men in a village of 5,000 set an optimistic example, their wives and daughters and the whole population soon follow the wholesome fad and every knocker goes immediately and drowns himself.

The complications in the office of the Department of Public Works which has resulted in the arrest of J. H. Boyd upon a grave charge, brings regret to the friends to all the parties concerned. So far as the facts appear there are few in this community who are ready to believe that Mr. Boyd has wilfully misused the funds coming into his office. There are many who believe that rival spirits in the Capitol building have pounced upon an apparent opportunity to crush a man of whom they have been jealous.

AMONG the sterner problems facing them, the senators and representatives should not overlook the little matter of procuring a subsidy for the Hilo band. That the Hilo band is made of the right stuff is shown by the remarkable progress it has made in the face of difficulty and discouragement. With a little financial aid from the Territory to which it is entitled, the band will soon become a credit to the Big Island to which it belongs.

THE REPUBLICAN Commissioners appointed to draft a County and Municipal Government bill should have their work printed as soon as it is completed. Copies should be distributed throughout the Islands criticisms and suggestions invited. The matter is one in which the people are vitally interested and a consensus of public opinion on the principal features would be an excellent guide for the legislature.

COUNTY and Municipal government, revised and modernized penal laws and an improved system of court procedure are tasks that await the intelligent consideration of the gentlemen elected last Tuesday.

ONE'S DUTY TO HIS EMPLOYER.

If the concern where you are employed is all wrong, and the old man a curmudgeon, it may be well for you to go to the old man and confidentially, quietly and kindly tell him that he is a curmudgeon. Explain to him that his policy is absurd and preposterous. Then show him how to reform his ways, and you might offer to take charge of the concern and cleanse it of all its secret faults.

Do this, or if for any reason you should prefer not, then take your choice of these: Get out, or get in line. You have got to do one or the other—now make your choice.

If you work for a man, in heaven's name work for him!

If he pays you wages that supply you your bread and butter, work for him—speak well of him, think well of him, stand by him and stand by the institution he represents.

I think if I worked for a man I would work for him. I would not work for him a part of the time, and then the rest of the time work against him. I would give an undivided service or none.

If put to the pinch, an ounce of loyalty is worth a pound of cleverness.

If you must vilify, condemn and eternally disparage, why, resign your position, and when you are outside, damn to your heart's content. But, I pray you, so long as you are a part of an institution, do not condemn it. Not that you will injure the institution—not that—but when you disparage the concern of which you are a part, you disparage yourself.—Elbert Hubbard.

SCHOOL BOYS' VOTE

Showed Heavy Preponderance of Republican Sentiment.

J. Castle Ridgway Republican District Committeeman introduced a voting innovation in the schools this year which should become the regular practice each campaign. He enabled the school children to vote on the respective tickets in the field for honors. The election was held last Friday in the schools at Hilo, Mountain View, Papaikou, Haasheo, Onomea, Hakalau, Honoum, Pepeekeo, Pohakupuka, Laupahoehoe, Paulo, Kaapahu, Honokaa and Kukuihale. The total vote cast by these young Americans was 749, of which 491 were for Cupid and 258 for Wilcox. The school children were provided with printed ballots and they went through with the process of voting with the same sense of dignity and display of decorum shown by their elders last Tuesday. They were allowed to vote without any electioneering from old people and their collective ballots show a great preponderance of Republican sentiment in the rising generation. The Republican senators Desha and Paris received 452 and 408 votes respectively. Pua and Woods received 219 and 249 respectively while the independent candidates received less than 100 each. The school boys also elected the Republican candidates for the House with a whoop. Lewis received 429 votes, Kauwahi 408, Paty 401 and Pritchard 415. Fernandes led the Home Rule ticket with 238 votes. The school children took great interest in the mock election and many of the boys received their first distinct impression of what it means to be 21 years old and have a hand in the government.

Hilo Dock Business.

Stockholders Confirm Various Contracts and Work Will Proceed. The stockholders and directors of the Hilo Dock Company held a meeting last Monday in the offices of the First Bank of Hilo and transacted important business in connection with the financial and construction phases of the big improvement. The meeting confirmed the supplementary contract made with the Territory binding it not to take over the dock until after a period of five years. This deal was made in order to facilitate the floating of the dock bonds, the men who are to furnish the money not caring to advance the same for a shorter length of time. The contract for building the dock made with the Hawaiian Engineering and Construction Company was also confirmed and it is thought actual work will begin by the 20th of the month. F. J. Antee, who will have charge of the work will arrive in Hilo November 19th. The metal for the dock will arrive by the Roderick Dhu in the meanwhile. The money to be realized by the company from the sale of bonds will be \$75,000, which will be furnished by Island capital. The directors of the company were also authorized to close a contract with the Hilo Railroad Company under the terms of which all the freight handled by that road will also be handled by the new Dock Company. This includes besides the Puna and Olaa sugar, the freight of several other large concerns and brings to the Dock Company an additional valuable asset.

JAMES ASHFORD DEAD.

Passed Away After Very Short Illness at Ripe Old Age. Honolulu, Oct. 30.—James Ashford, aged 82 years and nine months, passed to his last home early this morning. He had been a resident in Honolulu nearly fourteen years, in the family of his son, C. W. Ashford.

The deceased was born in Upper Canada, now the Province of Ontario, January 31, 1820, and was at the time of his death, 82 years and 9 months old. He was the oldest Free Mason, in point of membership, if not of actual age, in Hawaii, his affiliation with the Craft having occurred about 52 years ago, in St. John's Lodge, in Cobourg, Ontario. Mr. Ashford had resided here with his sons, V. Y. and C. W. Ashford, since about 1888, during which time he was a conspicuous figure on our streets, until within a few weeks past, his tall figure, straight as an arrow and his patriarchal beard marking him out for notice among the crowd.

The last illness of the deceased was short but acute, not more than thirty hours of suffering having been assigned to him. The funeral ceremonies will occur at 3 p. m. today at the residence of his son, C. W. Ashford, on Beretania avenue.

BOYD PAYS IN.

After Conferences With Dole and Cooper Tangle Disappears.

Honolulu, October 28.—Superintendent of Public Works J. H. Boyd yesterday paid into the Department the sum of \$6,307, representing money due the Government and a part of it being the \$3000 he received from T. H. Davies & Co., for Hilo road work, but which could not be traced on the books of the Department. The other payments were for land sales, and interest on deferred payments. The payments are a result of a letter to Boyd calling for "explanations."

After turning over the \$3000, Boyd paid over \$2,995 on account of public land sales by the Public Works Department and \$312 for interest on deferred payments. Just where the \$6,307 has been, or what had been done with it, is not known, and the Governor still declines to say just what the prospects are as to settlement of the difficulties.

There were reports this morning that all matters had been settled and that Boyd was about to be reinstated. When asked as to the Superintendent taking charge again the Governor this morning stated that he was not yet ready to talk about the matter. Whether this means that there are "other explanations" to be made, or that the Governor and his associates have not yet decided what to do in the matter, is not known.

The Executive Council held a meeting this morning, and the matter was discussed a good deal, but no result of the discussion was given out. It is supposed that a final determination of the matter will await Boyd's final reply to the Governor's letter setting forth the matter that were to be explained.

The money turned over yesterday was in coin and was handed over by Boyd personally. There was a number of conferences between the Governor, Cooper and Boyd, and the result, with the payment of money was a report that Boyd had been placed in charge of his department again.

The payment into the territorial treasury as a government realization, by James H. Boyd of the \$3,000 received by him from T. H. Davis & Co. as a consideration for the cancellation for that firm of an unprofitable lease, has been the subject of much discussion throughout the city today. It has been far and away ahead of party politics as a general theme of conversation when men meet. With the discussion of the payment of this money by Boyd, there was always the question "is the governor going to put him back?"

Wherever the subject was discussed there was a strong undercurrent of feeling that the matter was one too grave to be disposed of without the fullest investigation and the fullest publicity, not only as to what had been done or left undone in the past, but as to what had been found irregular or wrong, if anything. The feeling was vigorously expressed that there should be no condoning of matters that was wrong, if there were any such. And that whatever conclusions the governor came to, and whatever action he decided on, not only should the conclusions and the actions be made public but the facts on which they were based and the reasons for them should be made public.

As it was expressed by one, "If Boyd is innocent he ought to be put back in his office promptly, but if he isn't, no amount of money paid into the treasury by him or his friends ought to put him back." Public sentiment as it was disclosed in discussions where men gathered today seemed strongly in favor of the most searching inquiry and the most straightforward dealing. Boyd was shown to have many friends and well wishers, but the feeling was strong that public interest required that public affairs should be scrupulously guarded.

The feeling was expressed that the governor was carrying out a line of honestly considered policy. But if out of kindness of heart or other amiable sensitiveness he did not go as thoroughly into the matter as he ought, there was still the

grand jury which had plenary inquisitorial powers, which may make a most searching investigation of every public office. And besides investigating the grand jury could indict where it found violation of the law in any particular.

"The payment of the \$3,000 received from Davies & Company into the treasury as a government realization," said one man, rather negatives the idea put forward by some who posed as Boyd's friends a few days back, that he was holding it as a trust fund outside of the treasury so that he could devote it to the purposes for which Davies & Company gave it. If it proper to pay it into the treasury as a government realization now why was it not proper last April when it was received? And if it was proper to keep faith with Davies & Company, and necessary in order to do it to keep the money out of the treasury, why isn't it now? It seems to me that the payment of the money as a government realization now is a confession that it had not been previously, properly accounted for.

"Plenty of light won't hurt," said another, "and I hope both the governor and the grand jury will let in plenty of light into the whole conduct of public affairs."

CZAR'S PLANS.

Cranborne Admits That Russia Seeks New Relations in Far East.

London, Oct. 20.—That the recent reports of Russia's desire to establish direct relations between St. Petersburg and Cabul (Afghanistan) were well founded was admitted by the Under Foreign Secretary. Replying to a question, Lord Cranborne said the British Government had received a communication from the Russian Government proposing that direct relations be established between Russia and Afghanistan in regard to frontier matters. Russia set forth that the new relations would not have a place here, as the Russian Government maintained its former engagements and continued to consider Afghanistan outside of the sphere of Russian influence.

The British Government replied that it was impossible to consider any change in the existing arrangements regarding the proposed relations, the limitations to be placed on them and the means for insuring the observance of such limitations. Lord Cranborne added that no answer had yet been received to Great Britain's reply.

TO KILL LOUBET.

Armed Anarchist Detected Trying to Scale Palace Wall.

Paris, Oct. 22.—The Figaro this morning says a man was detected early Tuesday morning attempting to climb a wall of the Elysee Palace. It is believed that he intended to hide in the palace garden in the hope of obtaining an opportunity to assassinate President Loubet.

The man was arrested and was found to be armed with a poignard and a loaded revolver. He has been recognized as a dangerous anarchist who has already been convicted three times, and upon two of these occasions for manufacturing explosive machines. The police are trying to keep the matter quiet and refuse to divulge the man's name.

Czar and Turk.

London, October 17.—In a dispatch from Bucharest, Roumania, the correspondent of the Daily Mail says he has just returned from Constantinople, where he investigated the reported Russian diplomatic advances to Turkey. He is able to affirm positively that Grand Duke Nicholas of Russia, during his visit to the Sultan, proposed to Turkey the revival of the treaty which was concluded in June, 1833, and which established a Russo-Turkish alliance.

to the office and your right to perform the duties mentioned, are clear.

We further advise you that, as a public officer, it is your duty to regard your engagements with the people of this Territory, arising out of your said office, as a personal trust of a solemn, responsible and impressive character, and that you should personally execute, do and perform the duties of your said office, and not permit the functions of the same to be usurped by any person whomsoever. It is your legal right, and we believe it to be your duty, and so advise you, that you should forcibly expel from your office any, every and all persons who may interfere with you, or in anywise attempt to interfere with you in the discharge of your duties as Superintendent of Public Works, and to immediately discharge all and every employee or employees of said office who may refuse to execute your orders and directions, or who may directly or indirectly assume such a position as to detract from your title to the office, or which may impede or obstruct you in the due administration of your said office.

We have said that you have the right to forcibly expel from your office any person who may interfere with you in the due execution of your duties as Superintendent of Public Works; to make this more precise, we will add that this advice is given particularly with reference to one H. E. Cooper, who is now unlawfully assuming to discharge the duties of your station, by giving orders and directions to the employees of your office, by publishing notices over his subscription, and by subscribing himself Superintendent of Public Works and otherwise exercising a general superintendence and control over the affairs of said office. If Mr. Cooper should enter your office and attempt to give any direction, order or command to any of the employees of the office, you should request him to leave at once; should he decline to do so, it will then be your right and duty to expel him, as you would any other person under similar circumstances, using as much force as may be necessary to effectuate the expulsion.

This advice is given you after a careful examination and consideration of the premises, and you may safely act upon it.

Philippines at St. Louis.

Manila, October 20.—The Civil Commission will probably increase the Philippine appropriation for the St. Louis Exhibition exhibit by \$100,000, making the total \$350,000. Fair Commissioner Barrett has addressed a meeting of Filipinos, which was arranged by Governor Taft, on the subject, and the sentiment of the meeting was in favor of the increase.

Ex-Bandit Suicides.

St. Paul (Minn.), October 19.—James Younger, formerly a member of the notorious James band of outlaws which infested the western country a quarter of a century ago, committed suicide today by shooting. He left a letter to the press, in which he gives as a reason for his act despondency over continued ill health and separation from his friends.

MINERS END STRIKE.

Accept Arbitration Plan by Unanimous Vote After Debate.

Wilkesbarre (Pa.), October 21.—With a shout that fairly shook the convention building, the representatives of the 147,000 mine workers who have been on strike since last May, officially declared off at noon today the greatest contest ever made between capital and labor, and placed all the questions involved in the struggle in the hands of the arbitration commission appointed by the President of the United States.

When the news was flashed to the towns and villages down in the valleys and on the mountains of the coal regions the inhabitants heaved a sigh of relief. Many days have gone by since such welcome news was received. Everywhere there was rejoicing, and in many places the end of the strike was the signal for impromptu town celebrations. The anthracite coal region, from its largest city—Scranton—down to the lowliest coal patch, has suffered by the conflict and everyone now looks for better times.

While the large army of mine workers and their families, numbering approximately a half million persons, are grateful that work is to be resumed on Thursday, the strikers have still to learn what their reward will be. President Roosevelt having taken prompt action in calling the arbitrators together for their first meeting on Friday, the miners hope they will know by Thanksgiving day what practical gain they have made.

The vote to resume coal mining was unanimous and was reached only after a warm debate. The principal objection to accepting the arbitration proposition was that no provision was contained in the scheme to take care of those men who would fail to get back their old positions, or would be unable to get any work at all. The engineers and pumpmen get better pay than other classes of mine workers and they did not wish to run the risk of losing altogether their old places and being compelled to dig coal for a living. This question came up yesterday and was argued right up to the time the vote was taken. No one had a definite plan to offer to overcome the objection and the report of the committee on resolutions, recommending that the strike be declared off and that all issues be placed in the hands of the arbitration commission for decision, was adopted without the question being settled. A few moments before adjournment, however, a partial solution was reached, when a delegate from the furthest corner of the hall moved that the problem be placed in the hands of the executive boards for solution, and his suggestion was adopted.

Britain Leases Holdings.

New York, Oct. 17.—A cable to the Sun from Brussels says: A private dispatch from Lisbon reports that the King of Portugal has leased Portuguese Southeast Africa to Great Britain for ninety-nine years. The Portuguese flag will continue to fly over the territory, but it will be for the sake of appearances only.

STRIKERS VICTORY.
Questions on Which the Commission Will Pass.

Chicago, Oct. 17.—The Record-Herald has the following from Wilkesbarre: Here are the demands of the anthracite coal miners, which will be passed upon by the commission appointed by President Roosevelt:

1. An eight hour day for all employes working by the week, day or hour.
2. An increase of 20 per cent in the wages of all miners employed by the ton.
3. Establishment of a 2240-pound ton in all mines.
4. Recognition of mine committees in adjusting disputes or grievances.
5. More thorough organization of all the skilled mechanics employed in and about the mines.
6. Condemnation of the alleged act of the Delaware and Hudson Company in reducing wages at the Plymouth colliery.
7. Reinstatement of colliery firemen discharged by the Delaware and Hudson Company for refusing work on "swing" shifts.
8. Revision of the contract system and limitation to two the number of laborers to be employed by any one contractor.
9. Abolishment of the blacklist system.

Here are the demands of the miners that the operators refuse to consider: 1. The right of the union to work with non-union men. 2. The right of the union to work with non-union men. 3. Systematic examination of working cards at mines. 4. The right of union members to strike at colliers employing non-union labor.

It will be seen from this schedule that Mitchell has forced consideration of nine out of thirteen demands submitted by him five months ago.

KAISER WINS.
King Oscar Has Decided Against England and America.

New York, Oct. 22.—King Oscar of Sweden and Norway has decided the Samoan controversy in favor of Germany, says a dispatch to the Tribune from Washington. This fact became known on the return of Mr. Grip, the Minister of Sweden and Norway, from a long visit to his home. Mr. Grip called at the State Department but did not, of course, disclose the decision of his sovereign, which must be presented simultaneously to the three powers concerned. The announcement will be astonishing to the Governments of the United States and Great Britain, which were confident that they would establish fully the legality and propriety of the joint landing of marines at Apia in 1899 to sustain the decree of the Samoan Supreme Court and end the revolution.

The full scope of the arbitral decree of King Oscar is not yet divulged, and the extent to which it covers the claims for damages filed by the citizens of the three countries and of France may not be known for several days. These claims, which were nominally the prime cause for arbitration, are insignificant, however, compared with the question of national honor on which they depend, and if the action of the United States and Great Britain had been sustained by the royal arbiter, would have fallen to the ground.

WESTERN FORESTS.
May Be Gone in Fifty Years at the Present Rate of Destruction.

Washington, October 16.—John B. Leibeg of the Geological Survey has completed a pamphlet on forest conditions in the Northern Sierra, Nevada and California, which gives full information on the subject. Of 2,337,930 acres of forest systematic cutting has been carried on for the past fifty-years over 1,386,890 acres and 6,395,000,000 feet of board measure has been cut, or 52 percent of the present stand of timber. The stand varies from 500 to 50,000 feet per acre, and the total stand for the region is estimated 12,235,000,000 feet. Thirty percent of the timber is inaccessible.

Fire is the most potent factor in shaping forest conditions. Fire has determined the character of the forest, the ratio of species and the density and qualities of the timber. Aboriginal inhabitants fired the forest at intervals, and miners and sheepherders have ravaged the region in places. Two and three-quarter million acres show an evidence of fire. Where hydraulic mining has overturned the ground centuries will pass before the soil will sustain forests. "If we suppose that the present conditions of cutting, grazing, fires, etc., shall continue in the future as in the past for thirty-five or forty years," says Professor Leibeg, "it is not a matter to predict with accuracy that by the end of the next century, or even hence, the accessible forests will have been swept away."
