

## RUSSIA IS PREPARING

REPORTED TO HAVE LAID CABLE ACROSS YALU RIVER FOR PURPOSE OF ENABLING HER TO KEEP POSTED REGARDING MOVEMENTS OF FOREIGN NATIONS AND MASS TROOPS EFFECTUALLY IN MANCHURIA.

SEOUL, Korea, July 7.—It has been discovered that the Russians are now laying telegraph cables across the Yalu. This is regarded as unmistakable evidence that she is expecting war with Japan and is strengthening her position in every possible way as well as preparing for an actual campaign in the field.

## MURDEROUS FIRE BY THE MILITIA

EVANSVILLE RACE WAR RESULTS IN MILITIA FIRING ON MOB WITH FATAL RESULTS—SIX KILLED OUT-RIGHT, FOUR FATALLY WOUNDED, AND SIXTEEN BADLY INJURED BY VOLLEY FROM SOLDIERS.

EVANSVILLE, Indiana, July 7.—The fatalities from the race disturbances here have been so far, six dead, four fatally injured and 16 badly injured. The militia have dispersed the mob and the negroes who were threatening to massacre the whites and burn the town are fleeing in every direction.

### OPERATING ON THE POPE.

ROME, Italy, July 7.—The physicians in attendance on His Holiness the Pope, performed an operation on him, puncturing the pleura, and removing the pus which had accumulated, from the lungs. The lungs were thus relieved, and there was a slight improvement noticed in consequence tonight.

Pope Leo XIII was the son of Count Ludovico Pecci by his wife Anna Properi. He was born at Carpineto, in the diocese of Anagni, in the state of the church, March 2, 1810, and was baptized Vincenzo Gioacchino. At 8 he was sent to the Jesuit college of Viterbo where he remained until 1824 when he was sent to Rome and entered the Collegio Romano then restored to the Jesuits. He became a priest December 23, 1837. In 1843 he was sent by Pope Gregory XVI as Nunzio to Belgium and was created Archbishop of Damietta the same year. He remained at Brussels three years. January 19, 1846 he was nominated Bishop of Perugia. Pius IX created him a cardinal December 19, 1853. He was a member of a number of congregations of Cardinals. In 1877 he was appointed to the important office of Cardinal Camerlengo and as such, after the death of Pius IX was the temporary head of the church until his own coronation as Pope March 3, 1878. He was the 258th Roman Pontiff. His full title was: His Holiness the Pope, Bishop of Rome and Vicar of Jesus Christ, successor of St. Peter, Prince of the Universal church, Patriarch of the West, Primate of Italy, Archbishop and Metropolitan of the Roman Province, Sovereign of the Temporal Dominions of the Holy Roman church.

### A WAITING ATTITUDE.

## THE LOAN BILL IN DANGER

UNLESS THE HOUSE RECEDES THIS AFTERNOON FROM THE POSITION IT HAS TAKEN, THE APPROPRIATIONS MAKING THE LOAN BILL EFFECTIVE ARE DEAD, AND THERE IS NO TIME TO MAKE OTHERS.

"Unless the House this afternoon reconsiders its action of yesterday on the loan bill the bill is dead," say members of the Senate and others who have been watching legislation. This afternoon's session, it is claimed, must pass the bill as it stands after the conference report or else the bill dies, and there is no time for another. In that event the Territory will have to go through another two years with few public improvements and roads in many districts will be in most deplorable condition.

The Senate is through with the bill, it is claimed, and cannot take it up again. No matter what the House does.

## OPENING THE TORRENS COURT

JUDGE WEAVER PREPARING TO BEGIN SESSIONS OF THE NEW TRIBUNAL.

Philip L. Weaver has received his commission as judge of the land court under the Torrens act and is preparing to take the bench as soon as the necessary preliminary work is done. Judge Weaver will probably not be ready to open court for about six weeks, as there is much to be done in the drafting of rules, preparation of papers, etc.

The Torrens act allows the judge of the court much latitude in making rules of procedure, etc. The act is similar in many respects to that of Massachusetts. It was drawn by Weaver, who has long made a study of the Torrens system, and he has the blanks and rules which are in effect in Massachusetts and will use them in preparing rules and blanks for Hawaii.

"The law allows appeals to a jury, after the decision by the judge, on questions of fact," said Judge Weaver, "and appeals to the circuit or Supreme court on questions of law. Petitions are to be filed in the court asking for registration of title, and such a registration of absolute title, once finally granted is an absolute title from which there is no appeal, except on grounds of fraud in securing it. Other titles, such as that of mere possession, to preserve proof of a title which may eventually ripen into an absolute title, may also be petitioned for."

"I think that when the court opens petitions will begin to come in fast. Several parties have already spoken to me about it, wanting to be among the first. The experience of Massachusetts will probably be repeated here in the matter of attacks on the law. In that state a similar law was attacked in the courts and the attacks on it for a time frightened people from using it, but when a decision sustaining it was finally handed down, business came in fast and the law is now very popular."

"The law provides that the courtroom shall be as near to the registrar's office as may be, and I hope we shall be able to get room in the Judiciary building though this has not yet been settled."

Judge Weaver will appoint a clerk and registrar and other officers of the court, before the time for opening court. When court opens the filing of petitions and hearing of cases will go ahead without delay. It is expected that in time the court will succeed in straightening out the entanglements of Hawaiian land titles, and reduce real estate holdings to a systematic basis under which the circuit court calendars will not be constantly clogged with ejectment suits growing out of title disputes of long standing.

TEACHERS' ASSOCIATION. There will be a meeting of the Territorial Teachers' Association at the Normal school on Friday afternoon of this week. Prof. George Rebec will deliver an address. A general invitation to the public is extended.

GOVERNOR FOR LANAI. Will Depart Week From Tomorrow on 'The Iroquois.'

Governor Dole and party will depart on the U. S. S. Iroquois early on Wednesday morning of next week for Lanai and Hawaii. Those who will accompany him will be Eben Low and Land Commissioner Boyd, Dr. Humphris, Secretary Hawes and Paymaster Rhodes. The start will be early on Wednesday and the vessel will run directly to Lanai. Governor Dole and Mr. Boyd will there meet Charles Gay to attend to various land matters connected with the island of Lanai. From Lanai the party will go to either Mahukona or Kawahae where Governor Dole and Mr. Low will stop. Mr. Boyd may also leave the vessel at either of these places but this has not been positively determined. He may return on the vessel to Honolulu. Captain Rodman, the commander of the Iroquois, has made no plans after the Governor leaves the vessel. The Iroquois will be back here by July 21 as Admiral Terry, the new commandant of the naval station is expected on that day.

## JUDGE DAVIS AND MAGOON'S GOAT

THE BILLY GOAT AWAKENED THE COURT—THE TWO CHINESE COOKS AND STOLEN TURNIPS.

"The court is not in a very good humor this morning," announced Judge Davis in the police court today. Everybody immediately sat up straight, expectant of some outburst on the part of His Honor, but the Missionary Party et al escaped scathing observations from the court. J. Alfred Magoon however, the late coadjutor of Davis in the Summer case, was mentioned. "The court was wakened about 5 o'clock this morning," continued Judge Davis, "by Magoon's billy goat. It used to be that Magoon kept a pig, then he got a cow and now he has a billy goat and this billy goat waked me early this morning."

The High Sheriff, who was present, did not offer any suggestion that perhaps the goat had been secured in payment of a fee, but waited until the court's indignation against the Magoon menagerie had subsided and then proceeded with the trial of the various cases.

Two Chinese, Young Sue, who cooks for Mr. Lucas of May & Company, and Yuen Sam, who cooks for Miss Johnson's sanitarium, were charged with having stolen some turnips from a vegetable garden on Beretania street. Mr. Lucas gave his Chinese cook a splendid recommendation. It appears that the Chinese had had occasion to take some medicine on account of being ill.

"Oh, well, I had a Chinese cook," observed the court, "who used to get ill every Sunday. Whenever I would want to get something cooked he would fall to light the fire, claiming he was sick. I don't mean to say that that was the way with this defendant, but it was the way with the Chinese I had."

Yuen Sam took the stand. He, too, like the preceding witness, denied having stolen any turnips. "Do you like raw turnips?" inquired the court. "Did you ever eat any raw turnips?" persisted the court evidently having in mind the Magoon goat. "You say you are the cook for Miss Johnson's, do you sleep in that little barn back of the place?" "Yes, well then," exclaimed the judge with a rising inflection, and evidently forgetting his resentment against the goat, "are you the fellow who was making all of that noise the other night? It waked me up. My room is right near that barn."

Yuen Sam denied with tears in his voice that he had been guilty of waking His Honor. Some Japanese had been the ones, suggested W. Douthitt, the attorney for the defendant. "May be they were having a race war," said Deputy High Sheriff Chillingworth. Mounted Officer Fred Wright was called for the prosecution. He identified the alleged stolen turnips and then was subjected to quite a vigorous examination by the court after which the court discharged the defendants and took a recess for five minutes.

DEMERITOR SUSTAINED. United States Judge Etee this morning rendered a decision sustaining the demeritor to the answer in the 113 cases of Berger against Bishop, on a number of grounds. Five days were allowed for amendment. General A. S. Hartwell, appearing for defendant, stated that a denial would be filed as soon as the amended complaint was filed, and as ask that the court try the cases as soon as possible.

## JAPS EAGER TO FIGHT RUSSIA

OFFICERS OF DORIC SAY THAT WAR SPIRIT RUNS VERY HIGH IN JAPAN

The war spirit is running high in Japan. Reports brought yesterday by officers of the S. S. Doric are that the Little Brown Men are being controlled with difficulty by their government. There is an almost universal demand for war with Russia.

When the Doric reached the wharf yesterday morning from the Orient, the first question that was asked by the officers of people who came aboard was whether war between Japan and Russia had been declared. When informed that as yet, no hostilities had occurred great surprise was expressed.

"Well," remarked one of the officers, "I will bet that by the time we get back on our outward trip, they will be fighting. Why you have no conception of the state of feeling of the Japanese people against Russia. The hatred of Russia extends from the little bits of chaps that can hardly talk, up to the oldest and most influential people in the empire. The Japanese are demanding that war be declared on Russia and they are aching for the chance of getting at their hated enemies. I would not be surprised to hear at any time that Japan had declared war on Russia. It is inevitable, and I believe that war will occur in a very short time."

This statement expresses very vividly the real sentiment of the state of feeling in Japan. Not only do the officers of the Doric say that the Japs are anxious for war but returning travellers who have visited not only the sea port cities of Japan but have also gone into the interior, declare that war is now all but a certainty. The Japanese have been wrought into a feeling of the keenest, deepest resentment against Russia and the slightest overt act on the part of Russia will get Japan ablaze and nothing can then over on the part of Russia will save the north eastern part of Asia.

With characteristic energy the Japs are preparing for war. Their troops are now ready and their fleets are already assembled. A declaration of war will find within twenty-four hours, their fleets and tens of thousands of soldiers moving against Russia.

### FROM HAWAII.

SAN FRANCISCO, June 27.—Three large cargoes of Hawaiian sugar have come to port within the last thirty-six hours. The ship Servia, twenty-two days from Honolulu, arrived Thursday evening with 24,137 bags and yesterday the bark Alden Besse, twenty-one days

from Honolulu, arrived with 18,614 bags and the bark St. Katherine, twenty-seven days from Hilo, came in with 20,040 bags of sugar, besides fifteen bags of coffee and 116 bales of hides.

The steamer Whittier arrived yesterday at Ventura with the barkentine Fullerton in tow from Honolulu, both after cargoes of oil.

### W. G. HALL ARRIVES TODAY.

The steamer W. G. Hall arrived this morning from Lahaina, Maalaea, Kona and Kau ports. This is the last time that the Hall will go on the Maui-Hawaii run as the steamer Mauna Loa will resume the usual run, sailing next Friday at noon. The Hall will resume her Kauai run. **HONOLULU MAN HELD BY PIRATES**

LAM CHING WA WEALTHY CHINESE MERCHANT OF HONOLULU SEIZED BY RIVER PIRATES.

News of the abduction of Lam Ching Wa, a former wealthy Chinese merchant of Honolulu, was brought by the S. S. Doric yesterday. "The abduction of Lam occurred in the Kwang province near Canton. Chinese river pirates are believed to be the persons who kidnapped Lam and three companions. The prisoners are being held for ransom, a price of \$10,000 having been set on Lam.

It appears that Lam and his companions were inveigled into the house of a supposed friend living near the town of Sun Wal, Kwang Tung province. They were suddenly set upon by the gang of pirates overpowered and carried off. The capture of the party occurred about the middle part of June. As soon as the American authorities learned of the capture, orders were sent to the gunboat Callao to try and effect the rescue of the party, as Lam is an American citizen.

Writing from Canton to a friend in Honolulu, Lam Say Kai, a nephew of the missing Chinese, said that his uncle was held for ransom and a price of \$10,000 had been set on him, \$10,000 being demanded for the release of the other members of the party. At the time that the nephew wrote to Honolulu, none of the captives had been released.

Lam Chang Wa came to Honolulu nearly thirty years ago. He first engaged in the dry goods business at the corner of Nuuanu and Hotel streets. He extended his field of operations to include other branches of commercial enterprise. He joined the Sing Chong company about fourteen years ago. He was heavily interested in rice lands at Koolau. He is still chief owner of the Wing Chung Lung Company grocery store. He is 58 years of age and has a large family. His only son is a merchant in the native city of Hang Shan. One of his sons-in-law is a cashier in the Sing Chong Company at Honolulu.

Lam Ching was well posted regarding Chinese affairs and was consulted frequently by King Kalakaua and the advisors of Liliuokalani in matters that concerned his countrymen. He is said to have been instrumental in bringing Chinese laborers to these islands.

Another account is given of the capture of Lam. According to the second report the seizure of Lam Ching was made while he was travelling on a small steamer from Canton to Hang Shan. Recent dispatches stated that an American citizen had been seized by pirates but had later been released. It is now thought probable that the dispatch referred to Lam as he became an American by reason of having been a citizen of Hawaii at the time of annexation. His recent residence in China is said to have been only temporary.

**JAPANESE COFFEE GROWERS.**  
KAILUA, Hawaii, July 2.—The fifth annual meeting of the Kona Japanese Coffee Planters' Association was held at their office in Kailua, Hawaii, on the 30th of June. In one of the reports it says that their mill cleaned 246,128½ pounds of coffee last year, of which little more than one-half belongs to other nationalities than Japanese. The following directors were elected for the ensuing year: S. Takata, manager; K. Tomita, associate manager; Dr. H. S. Hayashi, auditor; K. Kuzukaki, treasurer.

**ADVICE TO HAWAIIANS.**  
HILO, July 3.—The Allied Trades held a most successful meeting at Firman's hall last Monday night. New names were added to the roll of membership and new applications placed on file. The event of the evening was an address before the union by Rev. S. L. Desha. He spoke to all, but to Hawaiians especially. The speaker urged the Hawaiians to sobriety and faithfulness in all they undertook.—Hilo Tribune.

**FROM WELLESLEY.**  
HILO, July 3.—The Kailua arrived last evening with a foreign mail and Misses Ivy and Ruth Richardson as passengers. Miss Ruth Richardson and her cousin, Miss Minnie Ahrens, who have been attending school at Wellesley, will spend their summer vacation visiting Miss Richardson's mother, M. Jules Richardson.—Hilo Tribune.

**JAPAN WILL EXHIBIT.**  
Among the through passengers on the S. S. Doric for San Francisco is Goodman King a commissioner for the St. Louis World's Fair Exposition. He is returning from a visit to Japan whither he went in the interest of the exposition. He says that the Japanese government is much interested in the St. Louis undertaking and \$400,000 was voted to make a creditable exhibit for Japan. An additional \$200,000 will be available if necessary.

**APPOINTED COMMITTEES.**  
At the afternoon session of the Senate yesterday President Crabbe appointed the following conference committees: Senate bill No. 2, the six months' salaries appropriations—Achi, Kalaokalani, McCandless, Woods, Paris, Nakapahu and Baldwin.  
On eighteen months' general expenses bill, House bill No. 9—Dickey, Achi, Kaohi, Woods and Isenberg.

**BIGGEST AIRSHIP.**  
The largest airship yet constructed is to be built at Ouen. It has been designed by Senor Jose de Patrocinio, who has received a subsidy from the Brazilian government for the purpose.

**BOUGHT A HORSE FOR ONE DOLLAR**

A MAUI JAP WHO WAS CLEVERLY VICTIMIZED BY A NATIVE HORSE THIEF.

A story of a Jap who was a good thing and a native horse thief of ready resources was developed in the Maui term of the Circuit court and has just ended in the native beginning a three-year term on the reef. The native is William Punia and he stole a horse from the Von Tempy place, very cleverly putting the officers on the track of one Hirobe as the real offender.

When Punia found that he was suspected he stated that a Jap had stolen the animal and offered to point out the Jap, and the horse. He went to where he had already taken the horse and promptly picked out a Jap who looked like an easy mark. He offered to sell the Jap the horse for \$1 and the Jap put up the dollar. Then Punia, in the presence of the police rode the horse up and down once or twice and turned the steed over to the Jap, demanding another dollar, in accordance with an agreement he alleged had been made, to break the horse in for \$2. "He said the horse was his," said the real thief, "and here is a dollar he gave me as part payment to break it in. He owes me another dollar."

Hirobe was promptly arrested, and Punia, free from suspicion and one dollar in pocket, prepared to testify at the trial of the Jap. The police, however, after a little further investigation unearthed the real facts and Punia was arrested for perjury at the W. T. Rawlins. He was convicted and Judge Kalua gave him three years, while the Jap who bought a horse for one dollar went free.

**FILL IN SHORE LANDS.**  
A proposition to fill in shore lands at Pearl Harbor on the peninsula was brought up in the executive council meeting yesterday by Superintendent Cooper. The question of how the parties who propose to do the filling in shall acquire title was referred to Cooper.

**TROOPS FIRE ON RIOTERS.**  
Associated Press, Morning Service.  
EVANSVILLE, Ind., July 6.—Lawlessness is rampant in this city tonight. Vengeful crowds are singing around the jail and the militia are retreating under showers of stones. In a bayonet charge many rioters were knocked down. They replied with shots and the troops retaliated, killing seven and wounding twenty.

**INDIANAPOLIS, July 6.**—Governor Durbin has ordered out more militia and has declared Evansville under martial law.

**HEAVY MARINE LOSS.**

NEW YORK, July 6.—The loss by the Jeannette is \$1,500,000.

**TROUBLE FOR CASSINI.**  
Associated Press Cable to the Star.  
WASHINGTON, July 6.—Count Cassini has left for St. Petersburg. The Russian government is disturbed over the fact that Admiral Evans' fleet in the Gulf of Pechili has been augmented to a total of fifteen vessels and that the fleet under Admiral Glass has been ordered to the Aleutian islands. The latter move is regarded as highly significant.

**ST. PETERSBURG, July 6.**—Count Cassini's diplomacy has met the strong disapproval of the Czar. Cassini has paid too much attention to the Kishineff petition and too little to the American policy in Manchuria. Russian plans require the separation of the United States from Japan and Great Britain and this Count Cassini has not affected.

**RAMPOLLA'S CHANCES.**  
Associated Press Cable to the Star.  
ROME, July 7, 1 a. m.—The Pope will probably die before morning. He is hardly breathing, his voice is weaker and he lies motionless. His chamber is filled with oxygen. Digitalis and caffeine are being injected to secure artificial respiration. Repeated doses of chloral are also being administered. His holiness sat up occasionally during the day to see the sun. Dr. Laponi says there is no hope. The Cardinals are showing great activity in preparing for the conclave. Cardinal Rampolla is considered to be the favorite candidate for the succession.

Cardinal Rampolla is, from the ecclesiastical point of view, still young; that is to say, he is on the right side of sixty, for he was born on August 27, 1843. He belongs to one of the oldest Italian patrician families and seems to have made up his mind to become a priest when still quite a child; a mere accident occasioned his entrance at the Vatican Seminary, where his remarkable intelligence caused him to be early noted as one destined for preferment; he took orders at twenty-three, and shortly after, Pius IX made him a Canon of St. Peter's. By the time Rampolla was thirty, he had entered Spanish nunclature. The Spanish Papal Nuncio was Simoni and a short absence made by him gave Rampolla his chance, for just then Spain was being torn in two by the Carlist War, and the young Italian priest played his difficult part between the two parties with extraordinary intelligence and astuteness. This brought him to the notice of another great Papal diplomat, the present Pope and it was through his efforts that Rampolla was made Papal Nuncio at Madrid, and together with the then new Pope and Rampolla managed the difficult arbitration case concerning the Carolines. Shortly after this episode, Leo XIII sent for his young coadjutor, and he has now been the Papal Secretary of State for fifteen years.

The fact that Cardinal Rampolla has kept his great position so long is perhaps the most remarkable proof of his marvellous ability.

THE COUNTY ACT.

The County bill is by no means dead yet, and there are those of the Republican party who do not intend that it should die.

Among some sections of the community the County bill is regarded as a thing that has been shelved but it will not be shelved for a long time yet.

The Republican party, however, has determined to give the Territory a County act. Whether for good or ill it is pledged to secure local self-government.

It is not the Republican party that is opposing the County act, or that is attempting to juggle with the County act. It is masqueraders in Republican clothes that are striving to upset it.

COTTON.

Cotton is still king in the export records of the United States, and its record in the present year is likely to surpass that of any preceding year.

Comparing the total values of cotton exported with those of preceding years, it may be said that 1903 seems likely to show the largest total value in raw cotton exports of any year in the history of our commerce.

Meantime the value of cotton exported in manufactured form has also increased, and will make its highest record in the present fiscal year.

At the same time the cotton manufacturers of the United States have increased and are still increasing their consumption of cotton both from our own fields and from abroad.

Meanwhile the importations of foreign cotton, chiefly Egyptian, are growing with remarkable rapidity, the importations in the present year being likely to reach 80 million pounds.

Auditor Austin's salary is somewhat of the will of the wisp variety. It is here, it is there, it is nowhere.

**WAS APPOINTED BY LINCOLN**

United States Circuit Judge Henry C. Caldwell of Little Rock, Arkansas, Resigns.

Attorney-General Knox has received the resignation of Judge Henry C. Caldwell of the United States Circuit Court of the Eighth Circuit. His home was in Little Rock, Ark. Judge Caldwell retires under the act of Congress which authorizes the retirement of United States Judges when they have attained the age of 70 years or have served ten years or more on the bench.

Henry C. Caldwell has been a United States Judge for thirty-nine years, and is one of the best known jurists of the day. He is a West Virginian, but removed to Iowa when a boy, over sixty years ago, and is thoroughly Western in his ideas and sympathies. He served in the Union Army during the Civil War and became Colonel of a cavalry regiment. In 1864 President Lincoln honored him with the appointment of United States District Judge for Arkansas, a place which he held with such acceptability that in 1890 President Harrison gave him a still higher judicial rank by appointing him Judge of the Eighth United States Circuit, the area of his jurisdiction extending over ten states and four territories.

Some prominent characteristics of Judge Caldwell are strength of statement, vigor of thought and love of substantial justice. He is described by the most competent authority as "one of those Judges, of which there are too few, who know the use and abuse of what is called technicality," and who have not only learning, but "penetrating common sense."

**INDIAN JIM THE OLDEST NATIVE SON**

Famous Character of Santa Clara Departs for the Happy Hunting Grounds.

"Indian Jim," a character well known in Santa Clara County, and bearing the reputation of being the oldest native son in California, died at the County infirmary at San Jose, lately.

Jim was far above the ordinary Indian in intelligence and appreciation of the methods and manners of the whites, and had many friends. For many years he lived on the Murphy ranch, and was much thought of by the family. Later he came to San Jose and eked out a living by doing odd jobs about the city.

He took an active interest in the current events of the county to the end of his life. His taking off was characteristic of his race. Eating a hearty dinner, he grunted his approval and laid down for a siesta. This was the last known of Jim.

For a long time his sleep was thought to be natural, but it was finally discovered that Jim had gone to the "happy hunting grounds" without notice of intention. He was supposed to be between 92 and 100 years old.

**HAS NO FAITH IN WOMEN'S OATH**

A Harlem Magistrate Says That Personal Feelings Blind Them to Justice.

Magistrate Crane, in a Harlem New York police court, has expressed some startling views as to the value of a woman's oath. He said, in substance, that he didn't attach much value to it. The case was that of Rebecca Maloney, a nurse girl, 25 years old, who said she had been insulted in the park by Frederick Van Dyke and Harry Gross, each aged 20. The two boys were arrested but the magistrate discharged them, saying: "In my experience I have found that women can seldom identify any one. I have no faith in their identification oaths when their personal feelings are concerned. They identify the first person they meet if they have been insulted or have had any trouble. They have no judgment in identifying anything or anybody. I have known cases where women have positively sworn to and caused to be sent to the penitentiary men whom it has afterwards been proved were innocent of any wrongdoing. I am always very careful as to how I take identification of a man when it is made by a woman. It is easy to sit here and send persons to prison—persons who are to be branded for life."

Magistrate Crane said he was not trying to ameliorate the offense itself.

**NEW OPPORTUNITIES**

A New View of the Workings of the Trusts as Affecting the Employment of Men of Capacity.

Mr. Dill is one of the leading corporation attorneys of this country of the University of Minnesota, his subject being "Outlook for the College Graduate in America." He declared that the trust movement, instead of restricting the field for educated men and women, opened for them new opportunities for usefulness.

"The corporation movement," he said, "instead of crowding men out, has opened for them new fields of usefulness and has increased the financial returns for intelligent concentrated effort. It has, to a large extent, eliminated the prestige of rich men's sons and ended the career of the 'Miss Nancy' type. From motives of self-interest alone no corporation can recognize the 'pull basis' of making appointments.

"When the trust movement shall have steadied itself, when it shall have eradicated wrong tendencies and strengthened those elements which are right, then of the men in charge of great combinations will be required not only an intimate knowledge of the business itself, but the training to be derived from a university course.

"Such combinations never had an excuse for existing, nor a chance of success, except as it was possible to suppress trade in a way thoroughly repugnant to American principles. A certain class also of the labor element is tending toward the suppression of production. Certain promoters, self-styled financiers, and certain labor leaders, have each made the same mistake—that of attempting, while only a minority, to extract for themselves more than their proportion of the prosperity of the country by the suppression of the output of others, rather than by an increase of the results of their own labor."

Dr. Dill is one of the leading corporation attorneys of this country. He is reputed to have received a million-dollar fee for his services in settling the quarrel between Carnegie and Frick, and in organizing the new steel combine. Dill is counsel for more banks and trust companies than any other lawyer in New York. Dill graduated from Yale in '76 and supported himself while studying law by reporting for a New York newspaper.

**BOOK BY COLUMBUS**

MURPHYSBORO, Ill., June 18.—A book in script, on parchment, purporting to be the secret log book of Christopher Columbus on his great voyage of discovery, is in possession of Frank Reeves, a resident of Murphysboro, living at 108 South Fourth street.

This book is a record of the events and of the secret hopes and fears of the great navigator on his first voyage across the Atlantic. The record begins when the fleet of three small vessels left Palos, Spain, Aug. 3, 1492, and continues complete until the two vessels that returned from the new world were caught in a terrific storm about 200 miles west of the Azores.

At this stage of the voyage, when Columbus and his crew had given up all hope of weathering the gale, the last entry is made that the secret log was placed in a secure box and cast overboard, in the hope that it might reach the shores of Europe and be picked up and the people would thereby learn the cruel fate which had overtaken the great discoverer and his crew.

It is written in quaint language, and the orthography is that of 400 years ago. It gives a vivid description of the discovery and of the disappointment of Columbus when he failed to find either gold or spices on the tropical islands which he visited.

Mr. Reeves received the book from an old German family in Cincinnati several years ago. He has been offered a handsome price for the book.

**SCENE OF MURDER**

WASHINGTON, D. C., June 19.—A dispatch from Belgrade, Serbia, says: The correspondent of the Associated Press was allowed to inspect the palace in which King Alexander and Queen Draga were murdered.

The bed room, which is furnished in empire style, remains in the same condition as when the king and queen fled from it on the approach of the assassins. French novels lie on the king's table and the queen's toilet articles, perfumes and cosmetics cover her dressing table. The costly silk bed covering are full of bullet holes, the conspirators having shot wildly in all directions, through and under the bed, chairs and tables, in the efforts to find their victims.

A simple wardrobe room, leading directly from the bedroom, was the scene of the final act in the drama. The apartment is lofty, but scarcely seven feet wide and fifteen feet long, and is furnished only with three great wardrobes. The officers who attended the correspondent showed the latter the blood-stained floor at one end of the room, where the king and queen fell, and the broken venetian shutter at the window through which their bodies were thrown to the ground below.

A secret stairway leads through the floor to the southern end of the palace. By this stairway the hapless couple might have attempted to escape, but they were unable to do so because the opening of this stairway was covered by a heavy chest. Escape, in any event, would have been impossible, as the soldiers who had surrounded the palace were so determined to kill the king and queen that they had even placed cannons in front of the palace and were prepared to destroy the building in the event of failing to find their prey.

Each of the three rooms between the vestibule and the bed chamber showed marks of the tragedy. Mirrors were shattered, pictures were shot through, the furniture was broken, there were bullet holes in the doors and in the oil portraits of the king, which were in every room, and most of the latter were otherwise mutilated.

Contrary to the general understanding but little effort had been made to renovate the apartments except where carpenters were making two new doors to replace those which had been blown to pieces at the time the conspirators forced their way into the rooms occupied by the king and queen.

The royal apartments were simply and tastefully furnished, chiefly in oriental style, and presented a homelike appearance. The interior of the palace might have been that of a country house belonging to a prosperous American.

The house of the king's adjutant, Lasar Petrovici, which was the first attacked, is even a greater wreck than the royal apartments in the palace. The entrance was completely destroyed by dynamite. The adjutant then escaped unhurt, but he was killed later in the vestibule of the palace. A large bloodstain marks the spot where the officer died.

It was in a bare, white washed room of the commandant's quarters, adjoining the palace, that Queen Draga's two brothers were shot, while sitting on wooden chairs, which bears marks of the bullets.

The proceedings in the palace today showed the same absolute callousness which has characterized the actions and demeanor of everybody in Belgrade since the tragedy.

**THE SHORT ROUTE**

Renewed and earnest attention is being directed in England toward a short trans-Atlantic route which has been talked about for a score of years past. The absorption of several steamship lines into one corporation controlled in the United States and the general advancement of that country in the shipping trade have thoroughly aroused the British public, and it is now plainly said in some quarters that if England does not immediately develop the shortest route project, the United States will step in and reap the golden harvest.

One of the best natural harbors in the British Isles is that of Galway, on the west coast of Ireland. Almost straight across the Atlantic is St. John's, Newfoundland. The distance between these two outposts is but 1,816 miles; from Liverpool to New York it is 3,116 miles, and from Southampton 3,095 miles. The time from New York to London could, it is claimed, be easily shortened twenty-four hours by the St. John's-Galway route. It is assumed that transit by land between New York and St. John's would be a material time-saver, while on this side the railway and steamboat distance from Galway to London is less than from Queenstown, where hurrying passengers are now accustomed to embark or disembark.

The harbor of Galway is said to be capable of almost indefinite expansion and development, and is protected from Atlantic storms by the Aran Islands, which form a natural breakwater across the entrance.

The fact that mails could be interchanged a day quicker each way than now is considered a very strong argument in favor of this route.

Commenting on this project an English periodical says, referring to the United States: "British trade in the Atlantic is seriously threatened; in a short time it will have fallen into utter decay unless a strenuous effort to regain it is made—and it is in the light of a bid for the lost supremacy and a challenge to all competitors that this enterprise must be viewed."

**MR. MORGAN AND THE BALTIMOREANS.**

The stock of the Atlantic transport company was largely held in Baltimore. It paid 10 per cent dividends, and was quoted at 275 when Mr. Morgan invited the company to go into his International mercantile marine combination. For each 100 shares the stockholders of the Atlantic transport company received 300 preferred shares in the combination and 100 common shares, which 400 shares are now valued in the market at about \$10,000, against \$27,500 for the 100 transport company shares given in exchange. Mr. Morgan's reputation as a disinterested financier is not as great in Baltimore just now as it was.—Springfield Republican.

# THE ROWING REGATTA

As last year, both the Healanis and Myrtles used slow strokes. At the start both crews in the senior event rowed 28 to the minute, while at the finish it was increased to 32. The Healanis showed better advantage in both events. The careful coaching which they had received at the hands of George Carter was in evidence. Both Healanis crews finished in fine shape and pulled a clean oar. This could not be said of the Myrtles. Lyle and Lishman having been taken down with the prevailing fever, were replaced by Sorensen and Johnson in the senior event, weakening the crew greatly. Sorensen and Johnson had only seven days training.

American boats were used this time by both the Healanis and Myrtles, the English boats not being taken out as a breeze was expected and they ship water too easily. In the senior event the weather proved calmer than it has ever been before in the history of the rowing events, and the English barges might as well have been used, as it proved. In the junior, conditions changed and several starts were necessary, owing to the heavy winds. Under these adversities the race was a much faster one than the senior. The seniors took 10:05 2-5 and the juniors even.

took 10:16, which, allowing for the heavy wind, was quicker work.

The Myrtle juniors beat the time of the Myrtle seniors by exactly five seconds, even with the wind against them, showing the disadvantage of the Myrtle senior crew.

The start in the senior race was at 10:30. At the half the blue flag went up closely followed by the red, for the Myrtles were racing close. At the mile it was blue again, red about three seconds behind. Here an attempt was made by the Myrtles to spurt and catch up, but it was of no avail. The Healanis distanced them. At the mile and a quarter flag four lengths had been gained in Healanis's lead and at the finish the winning crew were five lengths ahead. Time 10:05 2-5 Healanis and Myrtles 10:46 1-5.

The junior event proved a great surprise; it was conceded by all that seemed to know that the Myrtles were in better form. When the race was rowed however the Healanis proved their superiority, winning easily by at least five lengths. Time: Healanis 10:16, Myrtles 10:41.

As a result of the events, the two clubs are tied on racing events. Since the first contest in 1898, each club has won four races each and they stand even.

## RAPID TRANSIT ON THE FRONT

### PETITION TO THE GOVERNOR ASKING THAT CARS RUN TO THE IRON WORKS.

The Rapid Transit Company has applied to the governor for permission to lay tracks on Allen and Ala Moana streets from Alaieka street to the Honolulu Iron Works, and to operate the same as a part of their general system. The trustees under the will of the late Bernice Pauahi Bishop, Lieut.-Com. Hugh Robinson, commandant of the Naval Station, and the Honolulu Iron Works, the owners of a majority of the frontage along the proposed extension have signed a petition asking for this new track.

### PEDDLER AND THE QUAKER.

Captain Barr of the Reliance was talking about Sir Thomas Lipton. "He is a fine, sociable kind of man, and a great story teller," said Captain Barr. ### DISBARMENT PROCEEDINGS.

The defense in the Humphreys-Thompson disbarment case closed this morning. Frank E. Thompson occupied most of the morning with his testimony. His statements regarding the various transactions were in line with the testimony of Humphreys.

This afternoon at 1:30 Attorney General Andrews began the rebuttal. This he finished this afternoon and argument is to open tomorrow morning. It is expected that the cases will be submitted to the court tomorrow.

### SENATE SIDETRACKED HOUSE.

Tabled House Bill appropriating Money For The Band.

The Senate sidetracked a House measure this morning. It was House bill No. 8 appropriating \$2,000 for the expenses of the band in travelling to the other islands during the ensuing six months. The measure was up on second reading. It was tabled without debate.

House bill No. 7, appropriating \$1,000 for ex-Attorney General E. P. Dole fired better and passed second reading.

From the House was received notification of the appointment of the following committees to represent the House at conferences on the following measures, for Senate bill No. 9 for appropriating money for departmental use for the 18 months period R. W. Aylett, H. M. Kaniho, W. P. Haia, C. A. Long and S. F. Chillingworth, and for the salaries and pay rolls for the six months ending December 31, 1903, J. D. Lewis, F. R. Greenwell, J. Kakaleka, Jonah Kumalae, D. M. Kupihea, E. A. Knudsen and H. C. Vida. The Senate took a recess until 2 p. m.

### HELD TO ANSWER.

Isoye, the Japanese charged with importing a woman for immoral purposes, was held to answer this morning by U. S. Commissioner Douthitt, in \$5,000 bonds.

### OPERATED ON JUDGE WILCOX.

Owing to a change for the worse in the condition of Judge Wilcox, it was again necessary to operate this morning on the patient. His right leg was amputated at the knee. Drs. Woods and Hoffman performed the operation. The patient is now doing as well as could be expected after such a severe operation. Late this afternoon he was reported to be quite low.

## TEACHERS NOW AT THEIR TASKS

SECOND DAY OF THE SUMMER SCHOOL SHOWS AN INCREASE IN ATTENDANCE—PROF. REBEC.

The second day of the Summer school opened this morning with a considerably augmented attendance over yesterday. Fully 125 have now registered and begun the regular class work of the school. The classes were all organized by 11 o'clock yesterday morning, and the work of the school is proceeding without any delays or impediments. It is now believed that before the school ends there will be an enrollment of at least 175 or 200.

The formal opening of the school will be on Thursday at 11:15 o'clock in the morning. This day is chosen so as to enable all the purely detail and preliminary work in connection with registration and assignment to classes to be done, and for the members of the school to have actually entered upon the work. At the formal opening the Superintendent of Public Instruction, A. T. Atkinson, will make an address as will also Prof. George Rebec of the University of Michigan. To this formal opening all who are interested in education and the schools of the territory are invited to be present.

The school is in progress at the normal school building, corner of Fort and School streets. Prof. Rebec's regular course of lectures begins next Tuesday and will be given each morning at 11:15 o'clock. These lectures will be a course on psychology and pedagogy, but will not be directed specifically to teachers as such, nor confined to the limits of didactic instruction to teachers in training for their work. They are rather intended as a recreation from the more technical routine of the summer school and to give breadth and fullness to the work of the school. This being their purpose, others than those attending the school are invited to be present at these lectures. The invitation is extended to all who feel an interest in the subject itself or in the subject as a means of seeking breadth of culture.

Prof. Rebec is quite a famous pedestrian and has already walked pretty nearly all over this island, having sought out scores of places of interest that very many who have lived here for years have not as yet seen.

## KUMALAE AND THE TOILERS

WANTS LABORERS ON PUBLIC WORKS TO GET \$1.50 A DAY. HIS SPEECH.

Representative Kumalae introduced the following resolution in the House this morning:

"Be it resolved by the Legislature of the Territory of Hawaii that the laborers working under the Road Department be paid hereafter at the rate of One Dollar and Fifty Cents per day."  
—JONAH KUMALAE.

"Representative Fourth District." Paels at once moved the previous question but it was lost. Harris asked what the rate was now and Kumalae said it was \$1.50 for Republicans and \$1.25 for Home Rulers. Greenwell opposed the resolution, stating that it applied to the whole Territory and wages ought to be cheaper in the country districts, where living was cheaper. Greenwell moved to table and Knudsen seconded. The motion was lost by a vote showing more than was needed to carry the resolution but Kumalae didn't want to miss the chance for a speech and he made a long one. There was a rapid fire of words and then Interpreter Coelho interpreted as follows: "This is all about food and clothing. Do you want it?" No one wanted it and Kumalae continued to interest the lobby.

Harris called attention to the law providing that the road boards had power to use the funds in their own districts as they saw fit, and he said that the resolution would have no effect.

Kumalae answered that the road boards could pay what wages they saw fit, but if the resolution passed they would have to pay what it said.

Kellinot said the resolution would have the force of a law not an appropriation act and was therefore out of order in the session for appropriations. Beckley sustained the point, stating that if the House desired to pass such a resolution the form thereof had better be amended so as to make it an expression of the legislature's intention in making the appropriation to which it applies. Paels appealed from the ruling of the chair, but was voted down, and Kumalae's vote fishing came to an end for the time. The Honorable member can tell the voters next fall that he tried.

The bill to reimburse the Coney estate for land taken for the Tantalus road, passed third reading with four yeas. It provides \$12,000, or so much thereof as may be necessary, to reimburse the estate.

### ALLEN DIVORCE.

A decree of divorce in the case of Lydia Allen vs. George C. Allen, on the ground of failure to provide, was filed this morning in the Circuit Court. The divorce was granted last May by Judge Gear.
