How Long Animals Live.

The horse, in a domestic state, does not often live longer than from 20 to 25 years, and the ass usually ranges to about the same period. The wild horse is supposed to reach a much greater age; and a remarkable case is on record of even the domestic animal attaining 62 years.

The average life of the cow is 15 years, and a cow's age can be told by its horns. At four years of age a ring is formed at the root, and each succeeding year another is added.

Dogs usually live till they are 14 years of age. At 6 or 7 years the animal vivacity seems to diminish, indicating the fact that he has passed the bounds of youth. At 8 gray hairs can be detected, chiefly around the eyes and at the corners of the mouth.

These become more pronounced in the eleventh or twelfth year, when actual decrepitude sets in and develops so surely that by the fourteenth year the old favorite becomes a burden to himself and a nuisance to others.

Dogs, however, sometimes linger to twenty years. A cat's life is nearly on a par with the dog's, usually extending to about fifteen years.

Pigs have been known to drag out a lazy existence for thirty years, but their average term is less.

Up to the age of ten years sheep will usually live, and thrive tolerably well. The "guide-sheep" of shepherds, old wethers whose vocation is to direct the bleating flocks in unfrequented wilds, are said to attain the age of 20 years.

The hare and rabbit, if they manage to steer clear of the sportsmen's guns, live about seven years.

The average age of the fox is from twelve to fifteen years, and of the wolf from fifteen to twenty. The bear rarely exceeds twenty years, an age which the rhinoceros usually attains.

The camel arrives at maturity in five years, lives to forty or fifty and in rare instances becomes a centenarian.

The lion, commonly reputed a long-lived animal, does not usually go beyond twenty-five years, although there have been instances of members of the tribe attaining to the age of seventy and upward.

Of all the animals the elephant carries the palm for longevity, his average span reaching the century, and frequently overtopping it.

Respecting the age of this patriarchal mammal an old tale is told. The Alexander the Great invaded the dominions of Perus, one of the rajahs of upper India, he took a great elephant from the conquered prince, named him Ajax, dedicated him to the sun, and let him go with this inscription: "Alexander, the son of Jupiter, hath dedicated Ajax to the sun."

The animal is said to have been found alive with the inscription upon him 350 years afterward.—Philadelphia Star.

PROGRESS.

A Sound Criticism.

The Boston Transcript, one of the leading papers in the 'Hub' city, and the editorial opinions of which are very carefully considered before presentation, has the following leading editorial on the question of "right" or "might," in the Hawaiian matters now before the Congress of the United States. The words of the editorial are written in a most just spirit and the opinions therein conveyed are on equitable grounds. Following is the article, which it is a great pleasure to present from such an honorable and influential source.

The report of the minority of the Committee on Foreign Affairs of the House of Representatives is vigorously written, and clearly states the grounds upon which the Republican members of the House condemn President Cleveland's Hawaiian policy. It is not a document that will tend to create a dispassionate discussion of the points of difference between the majority and minority of the House, when the subject comes up for review.

One thing about the production is notable. It attempts to disconnect the question from annexation, undoubtedly Stevens's aim and object, and states that there is no issue as to the propriety of Minister Stevens's action, which the supporters of the administration claim to be the very keystone of the whole proceeding. The report severely criticises Mr. Cleveland for making Blount's disclosures the basis of a charge of "fraud, falsehood and wilful violation of the law" against the ex-minister whose conduct it pronounces not only "justifiable and necessary," but praiseworthy and patriotic.

Now why this commendation of Mr. Stevens, if he is not a pretty large element in any fair consideration of the matter? The rebuke which Mr. Foster, President Harrison's secretary of State, felt called upon to administer to Mr. Stevens for exceeding his authority is also a part of the evidence it is impossible to rule out. The minority report truly alleges that "the people of the United States are widely divided in their opinions upon the occurrences in Hawaii which resulted in the establishment of the present government." As this is the case, partisan condemnation or partisan commendation will amount to very little in the premises.

The Latest Proposition.

The readers of the Star were thrown into a paroxysm of intense surprise by reading an editorial headed *What of the ex-Queen* in which a proposition is made to the Queen to "abdicate" and receive a pension from the present oligarchical government. Of course Her Majesty ought to be filled with eternal gratitude to magnanimous editor of the Star who now asks for the abdication. The great power which he heretofore has proven to possess in the Councils of the land (except when his own ambitions are matters of consideration) must, of course, be a sufficient guarantee for the fulfilment by the councils of his implied promises. There is one thing which looks rather remarkable in this show of kindness at this late day towards the Queen and that is the statement in the very same editorial that her claims have been abandoned by the United States, that owing to the Munroe doctrine, no foreign power can help her, and owing to the qualifications of the much-ranked colonels and their army, her own people can't help her. When we at the same time remember that the annexation organs constantly have told us that the Queen has no claims whatever, and that her dethronement was the legitimate result of a legitimate revolution, we are still more puzzled over the proposition of the to-be or not-to-be, councillor editor Smith. We might for a minute be inclined to take the proposition as serious if the time-honored anecdote about the burgo-master

in a certain German village would not become too *apropos*. As our contemporary will remember the official referred to receive his sovereign with expressions of regret, because no salute had been fired on the arrival of His Majesty. The poor man had three reasons for his apology, but as the first was that the village possessed nothing with which to fire a salute, the other two were allowed without further hearing, and so with the Star's reasons for the proposed abdications. As the United States have not abandoned the Queen's cause, it is hardly necessary to speculate in eventual actions by European powers, or by steps which might be taken by the people of Hawaii still loyal to their lawful sovereign. There are absolutely no indications from the United States which can justify the absurd statements appearing in our local jingo press regarding a back-down of Mr. Cleveland. We know, of course, that Messrs. Hastings and Alexander have sent their usual encouraging (to the P. G.) and salary-procuring (to themselves) report by the Mariposa, but the heads of the government here by this time have had too sad experiences to ever believe in statements from its own ambassadors. Since C. L. Carter converted Hoke Smith and Frank Hastings received Gresham's solemn assurances which the two Hawaiian "statesmen" communicated to the P. G., there is not much inclination in the palace building to place faith in the peculiar hallucinations which are the order of the day in the Hawaiian Legation in Washington. However, this is a minor question. The information which we receive from Washington have so far proven to be more accurate and more authentic than anything which our opponents ever have heard, and we know that everything is O. K., and perfectly smooth sailing. But the point in taking up the Star proposition which we desire to mention and call the special attention to of the present government and its organs, is this: That although the fight and the agitation from Hawaii, and the policy and intentions all along, mention a wrong and an outrage as having been committed against Queen Liliuokalani, and amendments for the wrong as being due to her, such expression is simply used, because in her title and person the Hawaiian people have concentrated their claim for justice, and their demand for reparation for the wrong done to THEM. The Hawaiian people have been deprived through the agency and actions of John L. Stevens of their constitutional government and their sacred right to self rule. The Hawaiian people have unanimously declared against the proposed loss of their independence and their civil rights, they certainly cannot "abdicate" or abandon their claims or receive a pension. The Queen is simply a part of the constitution which we believe the United States are in duty, honor, and justice bound to restore to us. Her abdication or pensioning would in no way settle the debt which America through its chief executive has admitted, is due to the Hawaiian people. The loyalty of the Hawaiians to their Queen is undisputed, and it is the hope of every good citizen to see her back on her throne, but the act of justice which through that great American Grover Cleveland will place her there, is due to the outraged and cruelly insulted Hawaiian nation, and not due to any individual. For these reasons if not for any other, the proposition of the Star is absurd and untenable and would certainly never help to solve the present disastrous and political situation in Hawaii-nei.

The Star persists in its gross insults against the members of the *corps diplomatique* in Hawaii.

It is pleasing to notice that none of them take the slightest regard to the slurs and boorish remarks with which the paper fills its columns. It is evident that the character of the crowd which conduct the paper is too well known to make them worthy of any gentleman's attention while

the writer's has always been considered most radical and partisan.

It is indeed touching to see the ex-Chronicler man's bitterness against the family compact which yet prevents this adventurer from getting a seat in the government of this country which he has graced (?) with his presence for less than a year. To counteract the influence of the members of the "compact" he now spreads himself in the columns of the Star with any amount of suggestions and with an immense use of the ordinary catchword about "giving the people a chance" "down with close corporations" "popular representation" and "Americanism. Howly Moses! Fancy the way in which all these suggestions and implied promises are to be put into effect. A vote, even with restrictions! Not much that would lead to disagreeable complications, or at least take so long time before it could be put into effect that he would become tired of being kept waiting—if the Star, by that time wouldn't be tired of keeping him. He therefore proposes a very simple method, although it hardly smells of any kind of Americanism expect foreign boss-rule and that is to call a mass meeting and let ten Councillors be nominated there; whereafter a high official (Emmeluth?) guarantees that the Councils would elect the so nominated members. Yes, but who is to vote at the mass-meeting? Presumably only members of the annexation club, and the different secret societies, because if such meeting was for the "people" the chances of Mr. Smith would be smaller than ever. But on the other side only members of the mentioned political organization get a voice in the matter. Where, may we ask the man does the "Americanism" the "chance for the people" and all the other "high fallutin'" sentiments come in? Verily the suggestor must have a very small opinion of the common sense of people in this country while we fully realize that the opinion he has of himself would need number twenty boots for a covering.

An editorial in a last evening's annexationist paper is a peculiar make up, and strongly suggests indulgence in *spirits frumenti*. Excerpts are thus presented:

The news of Saturday ought to to convince the ex-Queen that the restoration cause will have no more aid from the United States Government. * * * * *

It must also appear to Mrs. Dominis that she can expect no aid from European powers. * * * * *

What then of the Queen's future? Politically it is black. * * * * *

As we sum things up, the late sovereign has but one available asset—the *privilege* [italics ours] she has to abdicate all claims or pretence of claims upon Hawaiian power and authority to the Provisional Government. We are inclined to think that such a privilege would be worth money to her. * * * * *

The "coming events" seem to have cast their shadows strongly before the writer as, he progresses, in a natural way, to the final result, desired by all loyal citizens, i. e; from "Ex-Queen" to "Mrs. Dominis" and then to the proper title "the Queen" and to whom he will, no doubt, in the near future be glad to bow the knee in taken of his position as a most loyal subject.

LIONEL STAGGE, who has again been brought to prominent notice here, was once the pet of the "goody-goody people" and was one of the first who contributed slanderous matter to foreign journals relative to Queen Liliuokalani. Through the services of a detective Marshal Wilson was enabled to locate the correspondence as being pushed through Clemens' News Agency, which then existed in San Francisco. Waterhouse was the name adopted by Stagge during his late rascalities and under which name he was jailed and served a term. His choice of jail cognomen seemed to indicate that he had not forgotten the Islands nor the peculiarities of the people, but he got caught. Following is the story lately related of him:

The Portland (Oregon) Evening Telegram of Jan. 11 gives the record of Lionel Stagge, the receiver of the suspended Oregon National Bank. It quotes the records of the Circuit Court to show that on December 17, 1889, Stagge, under the name of A. L. Waterhouse, was sentenced to one year's imprisonment in the States penitentiary at Salem on a charge of forging a name to a \$35 check. After serving his sentence Stagge returned to Portland.

It is asserted that Stagge, under the name of A. L. Waterhouse, passed a forged check for \$35 at San Diego. He represented himself as a traveling correspondent for the New York World and went about gathering data for an article on Southern California mines. Waterhouse went to San Diego with an insurance agent of San Francisco, and the latter indorsed a draft for him on an Oakland bank. The draft came back protested and the San Francisco man telegraphed to have Waterhouse arrested unless he paid the draft and the money which he had loaned him. Waterhouse did not pay, and accordingly the warrant was issued charging him with forgery.

A considerable sum of money is now to be expended to obtain, the previously freely proffered, information, that the *Vedalia Cardinalis*, or Australian lady-bug, was the boss of the blight. "Our Joe" got so mixed up with ladies, and bugs, and things, that it has required the services of a scientist to extricate him from his quandary; yet, of course, "Joe" knew it all the time, for, hasn't he got access to reference books?

AND, speaking now of Commissioner of Agriculture Marsden, it has been asked by several people why it was that the excellent and valuable assortment of plants, lately proffered by a lady of this city, was not forwarded to the Hawaiian exhibition? Somebody may be willing to tell why: will Commissioner Marsden tell?

THE American flag which was subscribed for by many people and which once hung upon the pole, near Robinson's Hall, should not be allowed to be lost sight of like the expensive silk Hawaiian flag which formerly belonged to the Honolulu Rifles, and, for which, many fair friends to the corps worked hard to obtain. Who knows where it is now?

American Patriotic Leagues are being formed in nearly all of the Eastern States. The boys there know an American when they see him and "only Americans are put on guard," no mongrels.

The story goes that, the secret meeting of the Advisory Council held on Saturday afternoon, was simply for the purpose of disseminating information which appeared in the *HOLOMUA* the same evening.

THERE is a little sheet in Washington called the *Post* which is very much annoyed especially because the *HOLOMUA* has been better informed than the *Post* has in regard to the policy of the American administration. We are truly sorry for the *Post*, but we should advise its editor to hang around the Hawaiian Legation in Washington and buy a few tickets for Thurston's dime-museum or "stand" a "smile" for Majah Frank and then be able to get some of the "official," if not very authentic, information which now is used to keep up the spirits of the P. G. in Hawaii. If anybody ever did notice the *Washington Post*—they would have been inclined to believe that the Hawaiian Legation was rather subsidized—that paper than it being subsidized—and that is where the *Post* was wrong.

Boys in the Marshal's department, not the Marshal himself, volunteer the information that the ammunition used is supplied at the shooters own expense. The explanation is satisfactory if the nuisance of the noise, complained of, is stopped.

Mr. Rudolph Spreckels called at Washington Place yesterday and paid his respects to the Queen.

There is a rumor to the effect that preparations are being made to arrange for a Provisional Legislature.

The secret League, rank and file, will be regaled with an expose of much interest to them in the near future.

The benefit to be given to George Washington the local colored boxer, will, from present indications prove a bumper.

Members of the Cricket club should not forget to be present at the meeting to be held at the Hawaiian Hotel, at 7:30 o'clock, this evening.

The four masted schooner Aloha sailed for San Francisco today. The prospects of a twenty odd-days trip did not warrant the forwarding of any mail.

The Mechanic's Union organization has been re-arranged by the substitution of some names in its former executive committee. The Union in its entirety is strongly on the side of law and order.

A leper, Chinese, walked away from the Kalihi lazaret station lately and has not since returned. He may be looking for a position as house-servant or cook, so people are warned.

The officers of the Planters' Labor and Supply Co., for the ensuing year are; president, W. G. Irwin; vice-president, F. A. Schaefer; secretary, C. Bolte; treasurer, F. M. Swanzy; auditor, J. O. Carter.

"Whale, O!" "Where away O?" Oh Waikiki, and right ahead of Col. Jim Sherwood's and the Sans Souci Hotel. Bathers are privileged to sport in the same waters as the whales, without extra charge.

Since Oct. 1, 1892 to Oct. 23, 1893 Japanese to the number of 4045 men and 975 women have arrived in Honolulu and from thence been distributed on various plantations. When the 4045 become voters the Japs will probably form secret political clubs.

As usual; energetic Mr. Hobron of the Hawaiian Exhibit wants the latest and rarest novelty and his rest is, now more disturbed, of nights, since the whales came into sight. His much desired shark has not yet been captured.

Miss Laurita Kaa daughter of Mr. and Mrs. Junius Kaa, of this city, was married this morning to Mr. Giovanni Long. The ceremony took place at the Roman Catholic Cathedral, and was attended by a large concourse of friends and invited guests.

Captain Hayward of the O. S. S. Mariposa was placed under bonds here, on the 20th inst., for his appearance before the February term of the Circuit Court, as the defendant in a civil damages suit for \$10,000, and in which, one Ralph R. Foster is the complainant. The complainant is at present a guest at the Hawaiian Hotel.

The question of the Hawaiian National Band boys going forward to the Midwinter Fair as representative of the musical ability of Hawaiians is again being agitated. Strong objections are made by them to any change of leader even if they should agree to go.

A divorce is reported to have taken place, some time yesterday, between two people well known in this community. The divorce is not regarded as absolute but is for the present at least *mensa et tora*. The parties to the affair are, policeman Wagner and police boss Klemme.

Mr. Rudolph Spreckels and party left this morning for Maui on the steamer W. G. Hall. Mr. Spreckels who is the President of the Hawaiian Commercial and Sugar Company will return to town next Saturday. Mr. C. A. Spreckels his brother is expected to arrive here on that day by the Australia.

Mr. and Mrs. Giovanni Long, the happy pair made one this morning at the Roman Catholic Cathedral, took passage by the steamer W. G. Hall for a honeymoon at Kona, Hawaii. The wharf was crowded, with friends of the bridal pair, and on departure of the steamer a bombardment of rice, oranges and leis took place, which was both interesting and amusing to onlookers.

One of the lately arrived steerage passengers from the Coast has lately obtained a billet as a collector of a doctor's bills. On a late tour in Emma street he attempted to ingratiate himself into the favor of some natives of the gentler sex. In a spirit of drollery the brown-skinned matrons led the stranger to indulge in various purchases of eatables and drinkables which were much relished by his guests.

A Coming Event.
 Miss Rose Albu has been the recipient of a great many favors from local people during her stay and has made herself most popular amongst a large coterie. Her benefit at the Opera House on next Saturday evening promises to be very well attended and manager Plunkett is arranging a programme of events which is hoped to please everybody.

Life History of Ferns.
 At the gardens of the Royal British Botanic society Professor Groves recently delivered an interesting lecture on the growth of ferns. Tracing the formation of fern spores from the first slight swelling upon the under side of the mature frond to the production of the perfect spore, or case; with its countless dust-like spores, the lecturer briefly sketched their further development; first as small green leaf-like bodies, lying flat upon the soil, through the subsequent formation and fertilization of other spores arising from them to the second and final birth of the infant fern. The "alteration" of "generation," as it is called, is that which divides ferns from flowering plants; for, while true seeds, when planted, grow at once into the likeness of their parents, fern spores have to pass an intermediate existence before they reach the same stage.—New York Advertiser.

PROPOSED STAMPS.

New Designs in Hawaiian Postage.

Postmaster-General Oat has received the proofs of the forthcoming issue of Hawaiian postage stamps, drawings for which were furnished by Mr. Holdsworth. The stamps are made by the American Bank Note Company and are exquisitely designed, printed and colored.

The one-cent stamp is oblong in shape and orange in color. In the center is the new Hawaiian coat of arms, which is like the old one, except that the crown is absent and eight stars take the place of two ancient taboo sticks. The legends "Hawaii" above and "One Cent" below, engraved upon scrolls, complete the design.

The two-cent stamp of the sepia shade of brown contains a fine engraving of Honolulu harbor, with the sky and mountains in the background. This stamp is also oblong, "Hawaii" in white letters, and "Two Cents," in the same fill the spaces above and below—spaces which make a square about the view like a frame. On each side is the word "Postage."

The next denomination is the five-cent stamp which has a groundwork of carmine red. A horseshoe-shaped scroll arches below the surface and contains the words: "Hawaiian Islands Postage." In the lower corner are two numerals 5. The middle of the stamp contains a picture of the Kamehameha statue, set amidst tropical foliage.

The ten-cent stamp is very striking. It is of vivid green in color and a big five-pointed star stands in the center with palm trees waving about it. Below is a scroll with "Hawaii" and below that, under a fancy turn of dashes is the denomination mark, 10c.

The twenty-five cent stamp is colored blue. A fine medallion of President Dole is at the right as the design is looked at, and from behind it, inclining towards the left, is an Hawaiian flag beyond and under which is a distant view of palms. An anchor under the medallion and the mark 25c. in a small square in the lower left-hand corner and "Hawaii, 1893," above, completes the design. It is expected that the stamps will be on sale by March 1.—Hawaiian *

This news caused a decided sensation, as the Princess is a granddaughter of the Emperor of Austria as well as a granddaughter of the Prince Regent of Bavaria. But the sensation which the report of the marriage created is as nothing to the consternation caused in imperial and royal circles today by the announcement made by the Germania chief organ of the clerical party, which declares that Princess Elizabeth was not married to Lientenant Siegfried, and that she is not now married to him, although they are living together.

The Germania adds other news which is undoubtedly most painful to the relatives of the Princess, but as it is not fit to be published it is not contained in these dispatches.

Geo. Gould proposes to dodge the taxes on some \$50,000,000 of personal property by moving from New York to New Jersey.

Omaha, Dec. 30.—Oscar F. Spate has filed a petition for a divorce from his wife, Honorah Spate, on the ground the person to whom he had been joined in wedlock was a man. The Spates married in Chicago, March 17, 1887.

In Great Britain and Europe persons are perishing from cold, while San Franciscans, all are of them, grumbling and shivering over a temperature of 40 deg. above zero. Saturday there was in some places a thin film of ice on watered sidewalks, which marks about the extreme of San Francisco cold.
