THE ATTORNEY GENERAL.
During the course of his remarks in the Supreme Court yesterday morning Attorney General Ashford, referring to the case of the King vs. W. S. Luce, said "that the defendant was acquitted by a jury of his creditors." It would have been considered unprofessional for a lawyer at the bar to have made such a remark, to say the least, but that the Attorney General of the Kingdom should have made such a statement in Court must be regretted by every one in favor of good government. If Attorney General Ashford's statements were true, they would be injudicious. Being untrue they are mischievous, and only show that he is totally unfit to be at the head of the law department and adviser of any Government, much less a very weak one. The statement was an insult to the jury, and no right-minded man can think otherwise.

THE MACFARLANE CASE.
The Defendant on Trial Before a Foreign Jury.

In the Supreme Court yesterday the case of the King vs. George W. Macfarlane, conspiracy first degree. Attorney General Ashford for the Crown, Messrs. F. M. Hatch, Paul Neumann and Antonio Rosa for defendant.

The Attorney General moved that the case be continued until the July term of the Court for the following reasons:
1st. The impossibility of obtaining a jury qualified to try the same from the present jury list.

2d. In order to facilitate the trial of defendant in company and jointly with the trial of F. H. Hayselden, with whom said defendant is jointly charged herein, the said Hayselden being now under bonds to appear for examination upon such charge on the 13th day of May proximo.

3d. To avoid the unnecessary trouble and expense of separate trial of the said defendant and said Hayselden herein.

4th. The absence from Honolulu and unavailability of a material witness for the Crown, viz.: L. A. Thurston.

2th. The probability that were the trial herein begun, it could not be concluded at and during the present term of Court.
Mr. Hatch stated the case was set for the next in trial to the Luce case. The counsel for the defense were instructed to be ready for this trial by the Court in the presence of the Crown prosecutor. He said the reasons set forth in that motion were not sufficient to warrant a continuance. He then argued on each reason separately, and showed the Court why he did not think them good and sufficient, and therefore asked the Court to overrule the motion and order the trial of his client at once.

Attorney General Ashford argued in favor of the motion, and said he was not surprised that the counsel for the defense wished the case brought to trial this term, as Mr. Luce for a similar offense, had just been acquitted by a jury of his creditors.

Mr. Neumann said that such a slur on the jury by the Attorney General was uncalled for. The jury was composed of as honorable and upright men as a jury could be, and their motives were as honorable as any of the Attorney General's. He then asked the Attorney General if he wished to prove by Mr. Thurston anything more than was adduced at the preliminary trial.

The Attorney General objected to being catechised.
Mr. Neumann then said, you refuse to answer? to which the Attorney General said yes.

Mr. Neumann, continuing, said to the Court, the Attorney General refuses to answer my question, consequently the object of his motion is to mislead the Court.

His Honor, after reviewing the reasons set forth in the motion, concluded they did not warrant a continuance, and overruled the motion.

On motion of the Attorney General, the Court allowed a recess until 1 p. m. At the latter hour the following jury was called: P. C. Jones, R. J. Lillie, W. Roland, F. W. Wood, R. W. Podmore, W. H. McLean, A. L. Louissou, E. J. Spalding, J. D. Tucker, A. N. Tripp, E. S. Cunha, W. C. Wilder, Jr.

E. S. Cunha was excused, and W. Lantz called.
The Attorney General moved that no jurors who had served upon the case of the King vs. W. S. Luce be allowed to sit in this case.

After argument by the Attorney General and Mr. Hatch, the Court granted the motion, and excused the following jurors: Messrs. Lillie, Podmore, Wood, McLean, Spalding, Tucker, Wilder and Lantz.

The defense excepted to the Court's ruling.
The Marshal then went out and summoned a number of talismen.

Quite a little time was spent by both the Crown and the defense in questioning the talismen.

The following conversation took place between the Attorney General and A. N. Tripp:

Att. Gen.—Are you satisfied with the verdict in the Luce case?
Tripp—I have to be.

Att. Gen.—Did you take special interest in the trial?
Tripp—When I got in the Court-room I staid and saw it out.

Att. Gen.—Have you any bias?
Tripp—I have not.

Att. Gen.—Did you not say outside that it would not take you two minutes to reach a decision?
Tripp—I may have stated so after hearing the evidence. My mind was made up.

Att. Gen.—Have you any bias against the Government in its action in this matter?
Tripp—None at all.

Att. Gen.—I think, Your Honor, the witness has admitted enough to be excused.
His Honor thought sufficient reason had not been shown.

Att. Gen.—Have you had any business relations with the defendant?
Tripp—None; only that Dr. McGrew has given me an order on defendant to collect some rents.

Att. Gen.—Are you aware of the nature of this case?
Tripp—I know very little of it.

Att. Gen.—Do you read the papers?
Tripp—I read the "Bulletin."

Att. Gen.—Do you read it all, including the advertisements?
Tripp—No, I do not read all the advertisements; only those where people are selling out and going away.

Att. Gen.—Have you not read a great deal about this case?
Tripp—I have read some, but they do not put it all in.

Att. Gen.—Is your mind clear?
Tripp—Yes. I am on my oath in the Court-room.

His Honor said it seemed to him that Mr. Tripp was unprejudicial.

Mr. Hatch asked Jurymen Petrie where he was when subpoenaed.

Mr. Petrie said he was at work as a carpenter at the Iron Works when called on the jury by the Marshal.

Mr. Hatch submitted that the Marshal had no right to go and get jurymen from their work. He could not exercise individual favor. He could say that the Marshal had an interest in the case with relation to the search warrant. He objected on these grounds.

His Honor did not think the grounds sufficient.

Mr. Hatch noted exceptions.

Hamilton Johnson said he could not serve on the jury as he was in the same line of business as the defendant and it was said that "they all do it." He had thoroughly made up his mind.

His Honor said he thought that Mr. Johnson was disqualified. He was excused.

L. La Pierre was peremptorily challenged and A. Young, jr. was excused.

T. S. Douglas was called and found to be disqualified.

Mr. W. C. Wilder who was next called said he had a decided opinion and had very decidedly expressed himself. He could not try it unbiased. Mr. Wilder was excused and E. G. Schuman was called.

The following jury was finally decided upon:

W. B. Wright, W. C. King, J. A. Kennedy, M. N. Saunders, A. N. Tripp, A. Moroff, W. Roland, H. McIntosh, A. Petrie, J. E. Bidwell, F. Turrill, E. G. Schuman.

Mr. Hatch noted general exceptions to the jury.

His Honor overruled the motion and swore in the jury.

Attorney General Ashford then opened to the jury, showing what the prosecution intended to prove in the case. He then called as the first witness:

I. Q. Tewksbury, who being sworn stated: I am storekeeper of the bonded warehouse at the Custom House. My duties are to receive goods in bond and deliver and collect the duties thereon.

There are considerable bonded liquors there in my charge. The dealers present their orders and I deliver the goods. Some pay cash and some give a bond. I have received orders where no duty was paid, orders signed by His Majesty or the diplomatic representatives. This order (produced) I have seen it before, it is an order from G. W. Macfarlane & Co. The signature at the bottom is W. Lishman, employed by the firm. He attends to the withdrawal of the goods from bond for G. W. Macfarlane & Co. I could not say when I first saw this order. It may have been two or three days before the date on the order, September, 1887. It was presented to me for the withdrawal of the list of wines, etc. as itemized. This (produced) is a blank voucher used by the merchants for the withdrawal of goods. The goods on this order were delivered. The order was filled in by Mr. Lishman. The figures in red ink are mine. They are the rate of duties. The aggregate duties on the order amount to \$1,500 07. No part of them have been paid because the name of Curtis P. Laukea, His Majesty's Chamberlain is on the order. The other order (produced) is for withdrawal of liquors by G. W. Macfarlane & Co. The amount of duties on the order would be \$1,749 35. Those duties have not been paid because the order bears the endorsement of His Majesty. The order (produced) is for the withdrawal of liquors by Macfarlane & Co. the duties on which amount to \$1,509. The nine dollars was paid but the rest was not, for the order bears the signature of His Majesty's Chamberlain. The goods were delivered. They were imported goods.

Cross-examined—I have received orders with other endorsements. The virtue on the order of the signature of His Majesty or any of the diplomatic representatives is just as if the duties were paid. It is according to custom. It has existed during my time. There were other instances where goods have been withdrawn without duty having been paid. A lighthouse went out a few days ago and no duty was paid. It was for the Government. Also a sidewalk. I have known Mr. Macfarlane for ten years. He has never made made representations to me for the purpose of obtaining merchandise. He had no dealings whatever with the Custom House as far as I know. The word consumption means the goods stay in the country. The change of the date on the order corresponds with the entries on my books. At the utmost three days elapsed prior to the filling of the order, Lishman presented the order and I delivered the goods. I have not learned nothing new about these orders since I first saw them that will lead me to say they are spurious and false. I was present at the preliminary examination of the defendant before the Chief Justice. I have received similar orders for the remission of duties from other business houses in town, in a great many instances.

At 5 o'clock the Court adjourned to 9:30 o'clock Friday morning.

Y. M. C. A. Annual Meeting and Social. Notwithstanding the fact that several other attractions were simultaneously in progress in different parts of the city, a fairly numerous gathering assembled at the Y. M. C. A. hall last evening, indicating the keen and widespread interest evinced in its affairs. The occasion was the annual business meeting of the Association and the chair was occupied by Mr. F. J. Lowery, the retiring president. The proceedings began with the singing of a hymn, after which the Rev. W. C. Merritt led the meeting in prayer. The various sections of the work are carried on by committees appointed for these purposes, and the reports of their doings were read by the several chairmen. The first to be presented was that of the Devotional Committee by Mr. W. A. Bowen. Mr. P. C. Jones read the report of the Temperance Committee, whose efforts put forth in conjunction with those of the Blue Ribbon League. The hope was expressed that the day was coming when Prohibition would be the law of this country. The Treasurer's report was read by Mr. E. O. White, after which Professor and Mrs. Van Slyke favored the meeting with a vocal duet which was heartily applauded. His Honor Chief Justice Judd read the report of work among native Hawaiians, in which he referred to the generosity of the Association in placing the Emma Hall at the disposal of those engaged in this work and that among the Japanese. In the course of his remarks he stated that drunkenness among native sailors had been greatly lessened by the efforts put forth. Dr. C. M. Hyde read a report from the same committee dealing with the work among the Japanese. Mr. S. D. Fuller read the 19th annual report of the General Secretary. Mr. F. J. Lowery, the retiring president, read an address to the members, and then called upon Mr. W. W. Caroline, the captain of which Sir William Wiseman, Bart. is a senior captain. The Russian corvette's captain being only a junior captain was not entitled to a salute. The Tsukuba is a third grade vessel of 1,978 tons displacement, and was built at Malacca in 1851, of teak wood, for the British navy, and was formerly named "Malacca." In 1874 she was sold to the Japanese Government who converted her into a training ship. Her horsepower is 700. The Tsukuba has 44 cadets on board from the Naval College at Tokio, Japan. It is probable that she will remain four weeks in port, after which she will leave for Yokohama. She carries eight 16-centimetre muzzle loaders and three 4-pounder field pieces. THE RUSSIAN CENSOR.

A CONTEMPTIBLE FEATURE OF THE ADMINISTRATIVE SYSTEM.

Every Foreign Newspaper Examined and All Objectionable Matter Blotted Out. How Letters Are Violated Without Scruple—Advice to Correspondents.

The censor must examine every copy before it is issued to the public. For his convenience the papers are printed one day in advance. The type of Thursday's paper is set on Tuesday. On Wednesday morning the forms are made up; one copy is printed and sent to the censor, who looks it over at his leisure during the day, and returns it to the office with his official stamp of approval on each page. This copy is carefully filed away as a protection for the editor, who then sets his presses at work and orders the edition distributed to the subscribers. If there is anything in it that the censor cannot approve he marks the objectionable article, which is taken out of the forms and something else substituted. If the censor is otherwise engaged the paper has to wait. Sometimes the issue of Tuesday will be delayed till Wednesday and sent out with the Wednesday issue, but it makes very little difference. Last week's paper is just as interesting as today's.

EXAMINATION OF THE MAILS.

All foreign mails are also submitted to the censor, not the same man who reads the local papers, but another, who has his headquarters and a staff of readers at the general postoffice. All newspaper mail is dumped on his table, except that addressed to the members of the diplomatic corps and high officials. That is supposed to be delivered promptly without examination. So the American minister gets his papers sometimes a week ahead of other residents. Every wrapper is opened. If the paper contains an objectionable article, something in the way of criticism of "the administrative system" of Russia, for example, the censor takes a large pad, dips it in the ink and stamps it upon the article, obliterating it. Thus no incendiary ideas are allowed to obtain circulation among the people. No criticisms of the government are allowed to be read, and no news from exiled nihilists.

When the censor has read one copy of a paper, The London Times, for example, he tucks it back into the wrapper and throws it into a basket for delivery, picking up the next paper that comes to his hand. If he finds that it is a copy of The London Times of the same date he stamps out the objectionable article that he has read before and throws it into the basket without further examination. If the first copy examined was found to contain nothing exceptional he examines no more of them, but throws them into the basket as fast as they come. To simplify matters, the circulation of very few foreign papers are allowed in Russia.

The censors cannot possibly read everything sent through the mails, so they confine their labors to the principal journals of Europe and destroy the remainder. One can receive The London Times or News or Standard in Russia, but no other London dailies. He can have Punch and the monthlies, provided they contain nothing objectionable. He can have Figaro, Gil Blas, The Petit Journal and one or two others of the Paris papers, but he cannot get the strong republican papers of that city. The New York Herald is the only American daily that can be taken. The censor will not read any other, so there is no use having them sent. I had two daily papers sent me from the United States all the time I was in Russia, but not one of them was delivered. I was told at the postoffice that the censor's paper that came in the mails, and none could be delivered till he had read it. He had only time to read one American paper, and if I wanted to subscribe for that it would be delivered.

This censorship of the mails is the most cowardly and contemptible feature of the Russian administrative system. It is simply a confession of weakness that tempts the average man to sympathize with revolutionary element, and they justly make it one of their chief causes of complaint. The Russian postoffice is under the direction of the police like everything else, and is one of their strongholds.

HOW LETTERS ARE VIOLATED.

They have the power to open letters as well as papers, and often exercise it. In fact there is no limit to their power. If a citizen or a foreigner is suspected of sympathy with the revolutionary element, or is supposed to be in communication with agitators, whether at home or in exile, the police give orders to have all his letters delivered to them. The gum upon the lid of the envelope is moistened by being held over a jet of steam, and opened, or a thin knife with a keen edge is slipped under the seal. The letter is read, resealed and sent back to the postoffice, or it is retained as evidence of treason.

Letters going out of the Russian post-offices are examined, as well as those that come in. All packages addressed to foreign newspapers are opened and their contents read. Correspondents residing in Russia write upon the thinnest sort of stationery, and address the envelopes to individuals or business firms, so as to avoid the espionage of the police, who destroy everything that in any way reflects upon "the administrative system."

All manuscripts carried in bags or trunks by travelers are examined at the Russian custom houses to avoid the circulation of incendiary literature. All newspapers found in the cars that cross the border are seized and destroyed. I had a lot of newspaper clippings in an envelope which I had cut from time to time, relating to Russia. A gentleman in Berlin, who was familiar with the operations of the Russian police, advised me not to take them with me, as they would certainly cause me trouble if discovered by the police. A gentleman connected with the police at Petersburg, to whom I spoke of this, said my friend's advice was good. If they had been found by some policeman or customs officer, they certainly would have resulted in my detention until my character and purposes had been investigated. He kindly suggested, too, knowing my business, that if I intended to write anything about the country it would be better not to commence till I had passed the borders.

The same espionage is exercised over the telegraph as over the mails. A correspondent dare not send a dispatch by wire from Petersburg to a newspaper. It would never be delivered if it contained anything objectionable, and if it did not, the fact of his having sent such a message would make him the object of suspicion and police attention. Correspondents of foreign newspapers in Russia have arrangements by which they send their news by mail to some agent across the border, who opens the envelope and telegraphs its contents.—William Eleroy Curtis in Chicago News.

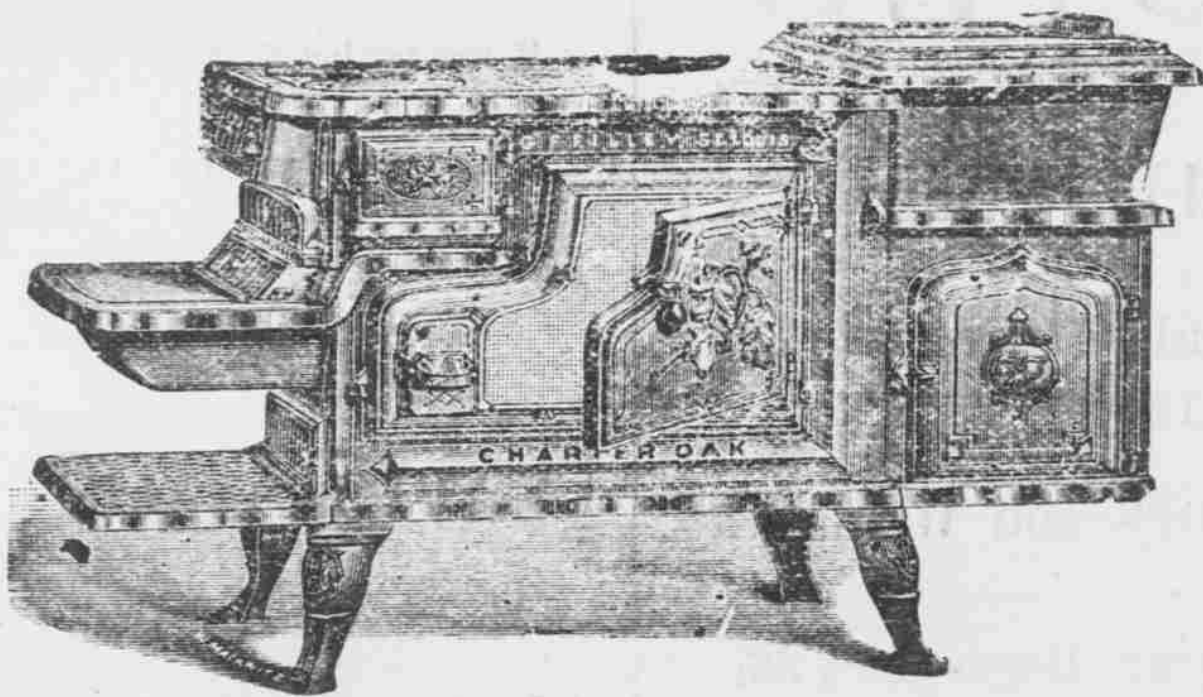
