## St. Gaudens's Indian Maid And Eagle And The Real Things Contrasted



WASHINGTON, D. C., Dec. 2.—Herewith are shown the much discussed designs by St. Gaudens for the new United States coins, upon which the "In God we Trust" is to be eliminated. President Roosevelt says, "that to put such a motto on coins, or to use it in any kindred manner, not only does no good but does positive harm, and is in fact irreverence which comes dangerously near to sacrilege."

The President, however, is not the only head of a government who in recent years has caused the removal of the motto on the coin of his country. The statesmen who are ruling France, in the earlier part of this year, decreed

that the exhortation "Dieu protege la France!" (God protect France) shall not appear on the coin of the French Republic to be minted henceforth, as it does on the present coins. President Roosevelt's action, according to a statement given out at the White House, was inspired by feelings of reverence for the words "In God We Trust" and his opinion that the placing of the same on coin tends to cheapen it. In this connection it may be of interest to know that for centuries the Popes expressed in Biblical phrases or moral sentences lessons of charity and kindness in the legends stamped on their coins. These coins have been out of circulation for a long time, but

the Popes evidently believed that the instruments of charity should be regarded as preaching a sermon on charity. The St. Gaudens "Indian" head was sketched from an Irish model, Mary Cunningham, a waitress. It is contrasted with two beautiful Sioux girls, the real thing in the Indian line. Alongside the St. Gaudens design is what purports to be an American Eagle. The real bird is pictured in contrast. The motto, "E Pluribus Unum," never authorized by law to be placed on the coin of the United States, first appeared on an American coin in 1786, in 1787 a New York goldsmith coined a piece of money which was known

as "the sixteen dollar gold piece," and upon it the motto was stamped in this form, "Unum E Pluribus." Only four of these coins are known to be in existence. They are valued at more than \$2000 each. The words "In God We Trust" were first placed on the 2-cent piece, which came into the subsidiary coinage in 1865. The motto was placed there by direction of James Pollock, then director of the United States Mint at Philadelphia. And of how little use money will be when the certain falls on life is brought home to the minds of most men by the warning that speaks from coins of Innocent XI: "They will not profit thee in the day of judgment."

## TWO WOMEN WITH FAITH ON KOREA

TO TAKE UP MISSIONARY WORK  
IN CHINA—TRAVELLING WITH-  
OUT FUNDS—STRANGE COUPLE.

Two women missionaries of the fanatical type, passengers on the Korea bound for China, attracted a good deal of attention in the Capitol grounds yesterday afternoon by sitting on one of the benches and singing hymns and praying. They were Mrs. H. E. Kirby, of St. Stephens, South Carolina, and Miss Mabel Evans of Florida. They were respectively dressed but stated that they were travelling without money in the implicit belief that their wants will be looked after. Asked how they expected to manage in China without a knowledge of the language, they stated that they would be given the power to speak it when necessity arose, and further volunteered the information that at times of spiritual exaltation they have already been able to converse together in tongues utterly unknown to them previously. They stated that they were considered demoted by the passengers on the Korea, and expressed much sympathy for the benighted condition of their fellow travelers.

## JAPAN CAN HAVE TIME

UNITED STATES WILL ALLOW  
EVERY OPPORTUNITY TO RE-  
STRICT EMIGRATION.

WASHINGTON, Dec. 8.—Although the Japanese question is still in a state of suspense, there seems at present no likelihood that Congress will be urged to take any precipitate action looking to the prohibition of immigration by statute, notwithstanding the introduction of Representative Hayes' bill for the exclusion of Orientals. Japan possesses an ability to control all questions which have been raised by administrative measures, and although this country is far from feeling satisfied with the progress thus far made on those lines, the President is anxious, in view of earnest representations from the Japanese Foreign Office, to give every reasonable opportunity for Japan to solve the immigration question without a recourse to treaty stipulations or legislative coercion, both of which are repugnant to the Mikado and his advisers.

It is not putting it too strongly to say that as far as treaty concessions are concerned there will be none on Japan's part at present. The only alternative, therefore, in case that Japan again adopts administrative measures which again fail to prove potent will be national legislation. If, however, Japan is acting in absolute good faith, as the President seems to feel satisfied, matters may soon be adjusted with full satisfaction to both countries. As things stand now it is declared that there is a perfect understanding between Japan's representatives and the State Department.

It may be that Ambassador Aoki, having assented to arrangements satisfactory to his Government, but which will not be popular with the people of Japan, is being withdrawn from Washington as an intimation to his countrymen that he has exceeded his authority, somewhat as Takahira was called home after his part in the unpopular settlement of the trouble with Russia. Confirmation of Maron Takahira's choice as Aoki's successor has not been made officially, and will not be, in deference to diplomatic usage, until after Aoki shall have reached home.

"In behalf of the boys I wish to thank everyone in Hawaii for the way they have treated us, and it will be many years before we ever expect to receive such treatment as this again." These words were spoken by Mique Fisher as he stood on the gangway just before the Alameda sailed. The scene at the departure this morning of the Alameda will be remembered for many days to come by all those who were present to wish the baseball boys a pleasant trip.

Long before the time set for sailing the friends of the team, and they were certainly there in large numbers, chiefly the fair sex, began to arrive all laden down with leis for the boys who have done so much for the islands by showing our teams how to play the national game.

The first member of the party to arrive on the scene was "Doc" Frost, the mascot, who arrived on the ship at 6:20 this morning. "Doc" is an "early to bed early to rise" man, according to his own statement, as he did not wish to be left. Mique Fisher and Mrs. Fisher were the next to arrive, and then the boys began to arrive at intervals of about three minutes. Each friend seemed to be anxious to out-do each other in the number of leis that they gave the players. "Red Dog" Devereaux and Donahue seemed to be the ones that came in for the biggest share of the Hawaiian token of aloha, but every one of the team had all that they could carry.

Several of the fair sex were bound that every player should receive a lei, and the collection that they carried over their arms presented a very pretty picture. Several times the boys started to go on board, but some one who would come along with a lei and keep them back. Jimmy Britt had more leis than any one else outside of the players, and he seemed to be very much affected with the farewells he received from several people. One little girl not more than five years old clung on to him as if her little heart would break, and when the last gong had sounded "All aboard," Jimmy, with the little one still clinging to him, stooped down and kissed her. The little tot seemed to think that she was the only person on the wharf, as she smiled and in a cute voice said: "I knew he would kiss me goodbye; he was so nice to me."

## SANTA CLAUS ON ALAMEDA

BIG CROWD, MONSTER MAIL,  
HEAVY BANANA SHIPMENT—TO  
MAKE PORT BEFORE XMAS.

"Three cheers for Berger's band!" shouted Mike Fisher on the Oceanic wharf this morning when the S. S. Alameda, taking away the San Francisco baseball boys and others, was about to leave for San Francisco.

There was an immense crowd on the wharf to see the Alameda off and the people were so packed on the outside of the barred gates that it was impossible for more to get through. As the steamship stood some ten feet from the wharf there was constant danger of somebody getting shoved overboard.

The Alameda was to have sailed at 10 o'clock, but owing to the unusual amount of mail on account of the approaching holiday, Christmas, it was nearer 11 o'clock when she got away.

Yesterday and up to 9 o'clock this morning hundreds besieged the post-office and the crowd at the registry window was particularly noticeable. The clerks in the postoffice had the job of their lives to get out the mail and it is safe to say that no letter mailed within the proper time missed the boat.

Captain Dowdell stated to a Star man on the wharf that he expected to put the Alameda alongside the San Francisco wharf at 10 o'clock on the night before Christmas at the very latest.

The Alameda's cargo consists of 2,700 bags of sugar, 3,500 bags of rice and coffee, 800 cases of fresh pineapples and 9,000 bunches of bananas. This shipment of bananas is the second largest ever shipped from here. The largest was 9,700 bunches, shipped also by the Alameda some time ago. Besides the items of freight mentioned there was the usual lot of miscellaneous freight and a great quantity of Christmas packages.

## ROTHWELL WINS

An error was made yesterday in reporting the judgment entered in the W. C. Peacock vs. J. G. Rothwell case in which it was stated that judgment was rendered for the plaintiff. The case was brought in 1905 by Peacock, who charged Rothwell with malicious prosecution, and demanded damages in the sum of \$25,000. The jury in the Circuit Court returned a verdict for the plaintiff, in a small amount, but the Supreme Court sustained the exceptions of the defendant and reversed the decision. Judgment was entered yesterday against Peacock for the costs, \$132.05.

## HARTMAN'S HOME IS DESTROYED BY FIRE

CHILDREN PLAYING WITH MATCHES CAUSE OF BLAZE—FOR A TIME  
IT WAS THOUGHT THAT YOUNGSTERS HAD BEEN CREMATED,  
BUT THEY TURNED UP ALIVE AND WELL—SPARK STARTS NEW  
FIRE.

Two fires startled the city this morning, the first at 10 o'clock consuming the residence on Sharratt lane of "Dooney" Hartman and the second, forty minutes later, perhaps originating through a spark from the former, ruined the roof of the gaudy Chinese temple of the See Yup Society.

The cottage in which Mr. and Mrs. Hartman and their two small children lived was owned by Sharratt who lives near by. The furniture belonged to the Hartman's and was until recently insured.

Hartman is on Kauai and Mrs. Hartman was at the Alameda wharf witnessing the departure of the S. S. Alameda for San Francisco when their little children got to playing with matches igniting paper in the front bedroom. The flames from the papers with which they were playing evidently caught the drapery of the bed and in a moment the room was afire and flames were shooting through the roof.

An alarm was turned in about 10 o'clock. Mrs. Dutra next door heard children in the lane shouting "fire" and ran to her back veranda to see her neighbor's house burning.

At once she thought of the Hartman children as probably in the flames, but her attention was demanded by her own children whom she hastened to gather together fearing at first that some of them might have been playing next door where the fire now raged.

The next consideration was the salvation of her own home and it was not long before neighbors were assisting energetically in the removal of furniture.

The fire department was quick in responding to the alarm, although when they arrived on the scene there was no hope of saving the Hartman home.

The chemical engine extinguished a small blaze that had started on the Ewa side of the Dutra house and a hose was then put in operation to keep the roof and side of the latter building wet.

Thousands of people gathered in a few minutes after the first cry of fire and the police had to exert their best efforts to keep back the mob.

There was considerable excitement among the throng and the question that passed from one to another was always as to the whereabouts of the children who were known to have been in the Hartman house when the flames were discovered. As soon as the fire was under control and it was possible for firemen to approach they raked among the embers to make sure whether or not anybody had perished.

It was while they were thus engaged that word came, much to the relief of all, that the babies, a boy of five and a girl of about three, were safe at Sharratt's house, having been taken out of the Hartman yard into which they had rushed when they found they had set the bedroom ablaze, by Mrs. Charles Broad who lives close by.

Women were hysterical, for when the word was passed that there were children in the burning house each was calling and running about to locate

her babies, since it was not unlikely that any one of them might have been playing with the Hartman children.

The prompt work of the firemen saved the surrounding property. The Hartman house is a cedar bed.

While the fire apparatus was finishing the fight on Sharratt's lane another alarm was turned in and it developed that the mauka end of the roof of the See Yup Society building was ablaze.

A large proportion of the crowd cut across lots, helter-skelter to the new fire which may have been started from a flying ember from the Hartman fire, for it was in a direct line and the wind was blowing fair.

It took a little time for all but one engine on the scene of the Hartman fire to hitch up and get to the King street fire and other engines were also called.

In the meanwhile a great crowd had gathered on King street within a block of Liliha street, where on the mauka side, the gilded temple's ornamental roof was smoking fiercely and red flames were licking through the haze.

From close-by tenements Japanese, Chinese, Hawaiians and others were issuing, panicky, with telescope baskets, trunks and other earthly belongings.

Newspaper men, insurance men who had been to the Sharratt lane fire and Chief of Detectives Taylor with one or two of his men were the first to reach the temple fire from the Sharratt lane blaze and, together with devout Chinese, were in a moment packing down stairs gilded images, glittering regalia, wonderfully carved dragons, great bronze censers, sacred symbols of more or less value, richly encrusted insignia altar articles, banners, tapestries, rugs, caskets of trinkets and other works of art.

Officer Apana carried a 200-pound bronze bowl down stairs from under the burning roof.

When a host of Chinese broke in upstairs things began to fly over the balcony in a fusillade. Chairs were broken, heavy porcelain and crockery pedestals were shattered on the pave and some things which could have been thrown out with safety were carefully carried down while breakables were hurled from the second-story.

A hose was soon carried up back near the roof and axes cut a way for the stream. Another hose followed.

Times of the tide are taken from the U. S. Coast and Geodetic Survey tables. The tides at Kahului and Hilo occur about one hour earlier than at Honolulu. Honolulu standard time is 10 hours 30 minutes slower than Greenwich time, being that of the meridian of 157 degrees 30 minutes. The time whistle blows at 1:30 p. m. which is the same as Greenwich, 9 hours, 0 minutes. The Sun and Moon are for local time for the whole group.

## U. S. DEPARTMENT OF AGRICULTURE—WEATHER BUREAU.

The following data, covering a period of 32 years, have been compiled from the Weather Bureau records at Honolulu, T. H. They are issued to show the conditions that have prevailed, during the month in question, for the above period of years, but must not be construed as a forecast of the weather conditions for the coming month.

Month, November, for 32 years.

### TEMPERATURE (1880-1906).

Mean or normal temperature, 74°. The warmest month was that of 1896, with an average of 76°. The coldest month was that of 1893, with an average of 73°.

The highest temperature was 86° on the 11th and 23rd, 1891; 21st, 1896. The lowest temperature was 56° on the 29th, 1892; 17th, 1893; 24th, 1897; 25th and 26th, 1902.

### PRECIPITATION (1877-1894, 1904-6).

Average for the month, 4.52 inches. Average number of days with .01 of an inch or more, 14.

The greatest monthly precipitation recorded in any 24 consecutive hours was 5.22 inches on the 30th, 1880.

### RELATIVE HUMIDITY.\*

Average, 9 a. m., 71 per cent.; 8 a. m., 79 per cent.; average, 9 p. m., 89 per cent., (1893-1903); 8 p. m., 74 per cent., (1904-6).

### CLOUDS AND WEATHER (1890-1906)

Average number of clear days, 10; partly cloudy days, 14; cloudy days, 6.

### WIND.

The prevailing winds are from the NE. (1875-1904, 1904-6).

The average hourly velocity of the winds is 3.0 miles (1904-6).

The highest velocity of the wind was 28 miles from the NE, on the 17th, 1904; 15th, 1905 (1904-6).

## BIG FREIGHTER ARRIVE.

SA FRANCISCO, Dec. 8.—The American-Hawaiian S. S. Co.'s freighter Nevada and Missouri arrived yesterday, the Nevada from Honolulu and the Missouri from Salina Cruz. The Nevada brought 2000 tons of freight, principally consisting of pineapples, coffee and sisal. She will take a full cargo back when she goes out on Tuesday. The Missouri brought 3000 tons of general merchandise from Salina Cruz. She will leave during the week for Seattle and on her return will load a cargo for New York. Officers of the Nevada bring news of the termination of the strike of marine engineers at the islands.

## HIGH AVERAGE OF LUSITANIA.

NEW YORK, Dec. 8.—Battered by storms that retarded her passage from the time she left Liverpool until she passed the Grand Banks, the Lusitania of the Cunard line came into port today. The time of passage was 5 days, 22 hours and 25 minutes. It was the first time that the new four-day ship had been compelled to battle with heavy seas during an entire voyage. The Lusitania made an average speed of 19.52 knots.

## HIGH RATE ON THE SEWALL.

SAN FRANCISCO, Dec. 8.—The rate of insurance on the overdue American ship Arthur Sewall, now out 24 days from Philadelphia for Puget Sound with coal for the Government, was advanced yesterday to 90 per cent, a rate seldom exceeded and which usually indicates that the knell of the overdue will soon be rung at Lloyd's, in London. The Sewall is believed by many persons to have foundered near Terra del Fuogo early in August.

# FOREIGN NEWS BY CABLE

## POWER WIRE CUT.

GOLDFIELD, December 18.—The Power wire connected with the city and the mines was cut last night and darkness prevailed. Gen. Fomston and Governor Sparks will remain here indefinitely.

## CORTELYOU HEDGING.

WASHINGTON, December 18.—Secretary Cortelyou denies that he is an active candidate for the Republican presidential nomination.

## DEATH OF LORD KELVIN.

GLASGOW, December 18.—Lord Kelvin, the scientist, is dead.

Baron William Thomson Kelvin was born in Belfast on June 26, 1824. His father was professor of mathematics of Glasgow University. He received his education at Glasgow University and at Cambridge University, graduating in 1845. He was electrician in charge of the laying of the first Atlantic cable and his first invention of great note was that of the mirror galvanometer and siphon recorder used in connection with submarine telegraphy. He acted as electrical engineer in the laying of the French Atlantic cable in 1869, of the Brazilian and River Plate cable in 1873, the West Indian cables in 1875, and of the Mackay-bennett Atlantic cable in 1879. Since then he has spent his time on various inventions among which have been the mariner's compass and navigational sounding machine and a number of instruments for the measuring of electricity. Baron Kelvin has written many scientific books and papers upon various subjects connected with the study of electricity and was ennobled in 1892, as a reward for the valuable services which he had rendered his country in these lines. He was a member of the French Legion of Honor, a Foreign Associate of the French Academy, and of the Berlin Academy and of many other orders of distinction. He leaves no heir to the title.

## REVOLUTION IMPENDING.

TEHERAN, December 18.—A revolution is impending.

TEHERAN, Persia, December 17.—The Persian Parliament has issued a manifesto to the nations of the world declaring that the Persian monarch is violating a covenant with the people and appealing for aid of the Powers in defending the constitution.

Since establishing a parliament, the Shah of Persia is said to have fallen back into the hands of reactionaries. The law-making body wants to obtain the removal of the prime minister and the ensuing ferment has brought on rioting in the streets of the Persian capital and now a revolution threatens.

## REDUCES SUGAR TAXATION.

SANTIAGO DE CHILE, December 18.—Congress has relieved sugar half the import tax.

Eight thousand laborers in the nitrate fields are out on a strike and business is paralyzed.

## FLEET OF CHARLESTON.

CHARLESTON, S. C., December 18.—A wireless message from Admiral Evans' fleet states that everything is going well.

## CUBA'S PEOPLE COUNTED.

WASHINGTON, December 18.—The census of Cuba shows a population of 2,028,282.

## BROKE SHAFT IN GALE.

PLYMOUTH, Eng., Dec. 9.—The steamer Kron Prinz Wilhelm received a wireless telegram today from the Red Star Line steamer Kroonland saying that this vessel had broken her shaft at a point to the westward of the Lizard, during a heavy gale. The Kronprinz arrived here this morning. The Kroonland left Antwerp December 1 for New York.

## SAILING FOR THE ISLANDS.

SAN FRANCISCO, Dec. 10.—The work of loading freight into the Matson steamer Enterprise was kept up until 12 o'clock last night. She is to depart at 10 this morning with a heavy cargo for Honolulu direct, and will call at Hilo on her return trip. The Enterprise will carry numerous passengers. Stiffs have been provided on deck for sixty-one head of livestock consigned to island persons.

## JAPANESE FROM VICTORIA.

SAN FRANCISCO, Dec. 10.—Three hundred Japanese immigrants arrived yesterday morning in the steamer President from Victoria, British Columbia. They made up the largest crowd of coolies from Japan that has come to port for many months, or since the steamer Alameda used to bring regular consignments of several hundred on every trip from Honolulu. The total number of passengers in saloon, second-cabin and steerage on the President was 471.

## TO TEST LEGAL VALUE OF SCRIP

LOS ANGELES ATTORNEY SAYS IT IS NO CRIME TO STEAL A CERTIFICATE.

LOS ANGELES, December 6.—Have clearing house certificates value in robbing a man of scrip? These questions will be raised in the trial of William Hoffman, a young man charged with holding up John Yates on Wednesday night in Arcadia and taking from him \$3 in scrip. The information was drawn up this evening and Assistant District Attorney McComas was inadvertently told by Hoffman's counsel that the point will be pressed; that it is not robbery to steal from a man that which may have no value technically.

The result will be the first criminal court test of scrip as money ever made. A judicial finding that scrip has no monetary value might have wide and important bearing, as many cases involving that substitute for legal tender are likely to be brought in the civil courts throughout the country during the present and other possible times of financial stringency.

## TO CRIPPLE POWER AT MINING CAMP

ONE HUNDRED STICKS OF GIANT POWDER FOUND AT GOLDFIELD. FEDERAL TROOPS DISLIKED.

GOLDFIELD, (Nev.), December 6.—Dynamiters made an effort yesterday to wreck the electric power line which furnishes light and power to Goldfield. Patrolmen today discovered 100 sticks of giant powder scattered around three poles near the place where the line crosses the railroad track, two miles from the city. Holes had been bored into two of the poles and caps had exploded, but the powder, being frozen, failed to ignite.

The Nevada-California Power Company maintains a patrol of its line between Goldfield and Bishop which covers the entire line once every forty-eight hours. The force has been augmented and hereafter a close watch will be maintained.

There is intense but suppressed excitement in Goldfield today over the expected arrival of troops in Goldfield tomorrow morning. It is the only subject of conversation. Miners' Union Hall has been filled all day, and a crowd fills the sidewalk and street in front. There has been no demonstration to speak of, although there have been threats made by hotheads as to what they will do to the town after the troops actually come. The miners were all a bluff, intended to intimidate them, and they have come to a realization of the real situation only within the past few hours. They seem disconcerted, as events have swept along too fast for them and they are unprepared for the turn in affairs.

## TESTIMONY WORTHLESS.

Deputy Attorney General W. L. Whitney thus explains the fact of nolle prosequing of the charges against Loo Pol of selling opium without a license, whom he had fined \$25 and costs for the offense while holding the office of District Magistrate two years or more ago.

Loo Pol was convicted in the District Court largely on the testimony of one Keptui, who at that time was a sort of spy or special officer for the police department. Although at that time Keptui was supposed to be a fairly creditable person, since then he has been convicted of "planting" Chinese gambling games, and narrowly escaped paying a penalty for it. His character has been so shot to pieces, in other words, that no jury would convict on his evidence, and hence the case was dropped.

## LITTLE CONCERN ABOUT "BIG JIM"

BURNS SAYS HE IS CONFIDENT THAT GALLAGHER WILL RETURN—IMPORTANT WITNESS.

SAN FRANCISCO, Dec. 7.—In spite of the fact that considerable apprehension has been manifested over the failure of James G. Gallagher, one of the inmate hoodlums, to return from his pleasure trip to New York in season to testify at the Calhoun trial, the prosecution expresses little concern at the non-appearance of "Big Jim."

"Gallagher will come back all right," William J. Burns said last night when he was asked as to the whereabouts of Gallagher. "He is on his way home now and intended to stop over at several points on the return journey. The last I heard from him he was in New York. That was about a week ago, and then he was about to start back. We are not worrying about Gallagher."

When the Calhoun trial was called on Thursday last Assistant District Attorney Heney asked for a continuance on the ground that Gallagher was missing and that another witness whom he expected to call was not in town.

Judge Lawlor granted the postponement until Monday, but it seems to be still a question whether or not Gallagher has gone to join Detweiler, and is seeking dignity and ease in a country where he is not so well known. If so it will be the first evidence of anything approaching moral sensitiveness on the part of the confessed and forgiven.

## HAYES FIGHTS FOR NAVY YARD BILL

PERKINS' OFFER OF ASSISTANCE NOT WELL RECEIVED BY THE CONGRESSMAN.

WASHINGTON, Dec. 3.—Congressman Hayes is respectfully notified by Senator Perkins that the former's intention to secure an additional navy yard for San Francisco bay is hailed as a laudable ambition. Senator Perkins says, further, that if Hayes succeeds in getting the bill through the House for a navy yard, coaling station or machine shops for San Francisco, San Diego, San Pedro or any other point on the Coast, he feels almost sure he can get such a bill through the Senate.

Perkins' attitude so far from mollifying the San Jose man, seems to be taken as a "def." "He has been here fourteen years and I have been here two," said Hayes when he heard what Perkins said.

"He gave out a statement today saying that he had 'no record to justify and no navy yard in his district to defend. I have no personal or political interest in it,' he added, 'and I am considering the subject solely from the standpoint of a member of Congress. Our facilities on the Pacific ocean are totally, almost pitifully inadequate for repairing the ships of the Navy.'

"We need a modern naval base on San Francisco bay and a dry dock and repair station in the south, probably at San Diego. This is the least, in my judgment, that Congress can grant or that California Representatives should demand."

Representative Hayes of California introduced a bill today providing for the appointment of a committee to select the site for a naval base on San Francisco bay and for a dry dock and repair station in San Diego harbor, also his bill to regulate Asiatic immigration.

## MAY TALK OVER ATLANTIC OCEAN

DANISH INVENTOR EXPECTS GREAT THINGS FROM THE NEW WIRELESS.

COPENHAGEN, Dec. 7.—The Danish wireless inventor, M. Valdemar Poulsen, is busily engaged in the completion at Lyngby, five miles from Copenhagen, of a wireless telephone station, which is to be connected with the wireless station at Esberg. He hopes to be able to telephone by his wireless method across the Atlantic.

"It is my fixed intention," he said to me in an interview today, "ultimately to establish a wireless telephone between England and Denmark (Esbjerg). I do not intend to hurry, however, although my system of wireless telephony has already proved very successful over long distances, and is in consequence of our new and improved microphones (the instrument which magnifies tiny sounds) and other apparatus.

## Growth of Cacao And Its Products

The growing popularity of cacao and its products among the people of the United States, to which reference has been made from time to time in recent years, is illustrated by some figures prepared by the Bureau of Statistics of the Department of Commerce and Labor, which show the relative growth in tea, coffee, and cacao importations during recent years. Cacao imports have grown from 18 million pounds in 1890 to 92 millions in 1907; coffee imports, from 499 million pounds in 1890 to 987 millions in 1907; and tea imports, from 84 millions in 1890 to 86 millions in 1907. Thus cacao importations have quintupled during the period under consideration, while those of coffee were scarcely doubling and those of tea making practically no increase. In value the importations of cacao have grown from 2½ millions in 1890 to 13½ millions in 1907, while those of coffee are practically unchanged, being 78½ million dollars in 1890 and 78½ millions in 1907; and those of tea have but slight increase, being 12½ millions in 1890 and slightly less than 14 millions in 1907.

Another interesting fact with reference to this more rapid growth in the imports of cacao is that it has occurred in the face of a greater advance in price of that article than has occurred in either tea or coffee. The average value per pound of the crude cacao imported in 1890 was 12.27 cents and in 1907, 14.5 cents, that of tea, 15 cents in 1890 and 16.1 cents in 1907; while that of coffee shows a marked fall, having been in 1890 16 cents and in 1907 7.9 cents.

The growing taste for cacao among our own people puts us into still closer touch with the people of the West India Islands and suggests possibilities in our own tropical islands, all of which are capable of producing this article. Of the 92 million pounds of cacao imported in the last fiscal year, 39 million pounds came from the West Indies, 20 millions from Brazil, 15 millions from other South American countries, and 16 millions from European countries, but doubtless originating in their tropical colonies.

## Beet Sugar Men Hostile to Taft

In the state of Colorado there has developed considerable opposition to Secretary Taft as a nominee for the Presidential office. The sugar growers of the State seem to be in the lead in the matter, largely on account of the Tariff views expressed by the Secretary. These beet men think it would be a great injury to their business, and to the interests of the State, to have the Tariff revised for the benefit of the Philippines and to the financial detriment of the people of Colorado. It is well known that Mr. Taft favors a lower duty, or no duty, on the sugar from the Philippines, thereby placing that product in closer competition with the Colorado product.

That the sugar beet industry is of considerable importance to Colorado may be gathered from the fact that the farmers will this year receive some \$15,000,000 for their crop. They are satisfied that free sugar from the Philippines would work a decided hardship upon them by forcing down the price of this commodity.

Naturally the farming interests of the State are sensitive upon this point, and this undoubtedly causes a lukewarmness, if not positive hostility, toward Secretary Taft's candidacy. The beet sugar industry has been steadily built up in Colorado until it has reached splendid proportions. It is one of the best and most profitable crops that can be raised, because the price is known, the money is sure as soon as the crop is delivered. Colorado already has a long lead over other States in sugar production and is likely to maintain that lead, if no embarrassments come in the shape of Tariff revision for the benefit of the Philippine Islanders.

## Senator Knox And Roosevelt

"The sum of democratic criticism of what we have accomplished is that they would have done it themselves if they had been in power, and this amounts to approval." The above from Senator Philander C. Knox, of Pennsylvania, in a speech delivered recently at a banquet, held in his honor, is attracting much attention among the republicans from all parts of the country, who are now in Washington.

The Knox presidential boom was given a fresh impetus at a dinner tendered by the Keystone delegation in congress to the distinguished senator who will receive Pennsylvania's sixty-eight votes in the next national convention for president.

A most significant feature of the occasion was the speech of Senator Knox himself in which he strongly commended the administration and its policies and championed the cause of President Roosevelt. Senator Knox who at one time was looked upon by the so-called "reactionary" element of the party as desirable presidential timber, delivered a body blow to the opponents of the president, who claim that he has set aside and violated the provisions of the constitution and set up in their place a little dynasty of his own. Mr. Knox went into details and cited the record to show that on every big question with which the administration has to deal, it has been vindicated. Not only has vindication come from the people at large, but the United States supreme court, the highest tribunal in the land, has sustained the present administration.

As a striking instance Senator Knox cited the Minnesota railroad merger suit which the court held to be unlawful, and which has established a precedent for many other cases. Senator Knox was for some time a member of Roosevelt's cabinet, and in his capacity of attorney general he was as close to the president as anybody. His speech in view of his candidacy for the republican nomination for president is therefore considered as most important in view of the statements which have been made to the effect that the Pennsylvania delegation would be used by Senator Penrose in the general scheme to defeat Roosevelt's

PITTSBURG, Pa., Dec. 8.—"I'll fix Harry Thaw. He got too fresh, and when I tell my story it will completely change the aspect of the case."

Such was the declaration of Miss Ida Veronica Simonton, who fled America ostensibly to study the monkey language in the jungles of Africa.

Miss Simonton has just returned to America and now declares she will go on the stand and testify in the next Thaw trial.

It was Miss Simonton who went to Europe and brought Mrs. Charles J. Holman, Evelyn Thaw's mother, back to this country when she claims to have been deserted by Harry Thaw and Evelyn.

Miss Simonton was a much desired witness in the last trial and Attorney Jerome is greatly pleased at her return.

Harry Thaw, when seen in the Tombs, would make no comment on the statement of Miss Simonton.

Evelyn Nesbit Thaw, nothing daunted by Miss Simonton's declaration, declares, "I will again tell my story. In fact, would tell it a million times if it were necessary."

We have received in a financial way more than we ever expected to, and what is more it came totally unexpected. We came here for our bare expenses and we are all going home with the yellow stuff in our pockets.

"Every one in town has been good to us, and I have not the flow of language which can express how I or the boys feel. Last night as a fitting ending to a happy trip, I thought it was only right that I should buy some foolish water for the crowd which I did. I do not see why it should be considered such a joke, but as it was a joke let it go.

"Speaking about getting I want to be quoted as saying that there are some good sports here with the exception of Sonny Cunha. You know I can do 50 yards in less than six seconds and when some one told him that he refused to race me. After I had waited for some time yesterday afternoon for him to show up, I decided that I would race any one for any amount. Big good hearted Charley Chillingworth came along and I offered to race him, and asked him how much he would put up. He counted his change and found that he had \$85. I drew my wad which is big enough to choke a horse, but when he told me that he could beat me running backwards and that he hated to take my money, I decided that I would keep my roll for some other purpose. TO KIOU, Dec. 7.—Strikes and labor troubles are more frequent in Japan than in any other country in the world, and this is not surprising when the conditions under which the industrial classes have to work are considered.

The commerce of Japan has shared in the wonderful progress of the country during the last thirty years, but while the trade has prospered with the introduction of modern methods, the workers have been ground down under the factory system into an incredible state of misery.

No consideration whatever is extended to the workers by either the government or employers. The employers are mere slave-drivers, while the government does nothing to regulate the conditions of labor. No limit is enforced for hours of labor or for a minimum wage.

In Tokio, where wages are higher than anywhere in the empire, thousands of factory girls work for 12 cents a day, a bootmaker about 25 cents and an ordinary laborer has to be content with 20 cents.

Excessively long hours of labor are the rule. Factory workers are busy from 7 in the morning until 6 in the evening, while a few minutes at noon suffices for them to swallow their scanty meal of rice. On the railroads it is not unusual for men to be on duty twenty-four consecutive hours.

The condition of female labor is simply pitiful and perhaps nowhere else in the world is the lot of the woman worker so hard. The Japanese factory girl is underpaid, underfed and has to toil long hours at tasks that are physically exhausting. As a class she is ignorant, helpless, unprotected and unorganized.

PHILIPPINE COIN IS AT A PREMIUM

UNCLE SAM IS RAPIDLY REPLACING MONEY TO THWART ASIATIC SPECULATORS.

SAN FRANCISCO, Dec. 8.—"The price of silver in the Philippines had increased sufficiently to make it worth while to buy money for the silver that was in it," said Superintendent Sweeney of the Mint yesterday, in explaining the reasons for the recoinage of Filipino money now in progress.

Superintendent Sweeney denied that there had been any oversight on the part of the Treasury officials. He said:

"When Congress authorized the purchase of silver for coinage into Philippine money, not to exceed 75,000,000 pesos, we redeemed a lot of the old Spanish money over there and recoinage it. We sent over about \$27,000,000 in pesos and pieces of 50, 20 and 10 centavos, all at 900 'fine.' But after the money arrived at its destination, silver rose to 61 cents, so that each coin became worth more than its value at the standard ratio of 2 pesos for every dollar gold. It was worth buying up, and Chinese and Japanese speculators and others took advantage of the chance. To remedy that, the United States Government recalled the money and ordered its recoinage at a lower percentage of fineness. We have got back already about half of it and we are getting more by degrees. We are recoinage it as fast as we can, the pesos at 800 fine, the pieces of 50, 20 and 10 centavos at 750 fine and 20 per cent alloy."

Chief Clerk Day states that since February last, when this recoinage was commenced, \$11,000,000 of Filipino money has been turned out and shipped. This is made up of \$9,468,000 pesos, \$1,056,000 in pieces of 50 centavos, \$502,000 in 20, and \$486,000 in 10 centavos. The turnout for here averages \$1,000,000 a month.

JAPAN NOT TO BUILD UNARMORED CRUISERS. SEATTLE, Wash., Dec. 9.—According to advices received on the steamship Empress of Japan, the naval programme of the Japanese Admiralty will entirely eliminate cruisers, coast defense ships, dispatch boats and gunboats, which in view of past experiences they consider useless. A prominent Japanese naval official says that future building will be confined to battleships, armored cruisers, destroyers and torpedo-boats. The new battleships will be of 20,000 tons and the armored cruisers not greatly inferior in armament and displacement. The duties of small cruisers will hereafter be done by destroyers.

A contemporary yesterday printed an article saying that third and fourth class mail matter would not carry even such written messages as "Merry Christmas." This is not so, the postal regulations expressly providing that such writings as "Happy New Year" and "Merry Christmas are allowed.

## NATIVE GUARD FOR SAMOAN STATION

SWARTHY COMPANY IN TURBANS AND SKIRTS GUARD PROPERTY OF UNITED STATES

SAN FRANCISCO, Dec. 8.—Naval officers recently returned from the American naval station at Tutuila, in the Samoan Islands, speak very highly of the company of natives which takes the place of the marine corps in guarding the station and preserving order.

It has been found the natives are amenable to discipline and can be trained to a high state of efficiency. For a uniform they have a turban, a sleeveless shirt and an abbreviated skirt. They are without shoes or stockings and are in this way unencumbered in the way of apparel, which condition has its advantages in the island climate.

The men are superb in physique, hardy and of great endurance. They go through the drills with great precision. Natives who do not belong to the organization regard the members with great respect or envy.

Naval officers will be permitted to draw pay hereafter for two months in advance on being ordered home from duty at foreign stations. This is in order that the expenses of travel may be readily met and that embarrassment until reimbursement is made by the Government at the end of the journey may be avoided.

Heretofore this permission to draw in advance pay for two months has been confined to officers ordered to foreign stations from the United States.

Yeomen, or ship's writers, are in great demand in the navy. The number of the class of men qualified for these positions, who are willing to enlist in the navy, is not sufficient to supply the demand. There are too many good positions available in civil life, with the advantages of better pay.

## MAKES CHARGES OF CONSPIRACY

OFFICIAL OF MINERS' FEDERATION ATTACKS PRESIDENT FOR SENDING TROOPS.

DENVER, Col., Dec. 7.—At a meeting of the executive committee of the Western Federation of Miners in this city today it was agreed to levy an assessment upon members of the organization for the benefit of the Goldfield strikers. The possibility of securing Congressional investigation of President Roosevelt's action in sending troops to Goldfield at the request of Governor Sparks of Nevada was discussed and it was practically decided to bring the matter to the attention of Congress.

"The action of the President in sending the troops to Goldfield was the result of a prearranged conspiracy between Wall street interests and Governor Sparks," declared Acting President Mahoney after the executive session. "There was absolutely no need for such action. It seems peculiar, to say the least, that the troops should be hurried to Goldfield before the Sheriff had made any request upon the Governor for aid. The action is unprecedented and some ulterior motive is undoubtedly responsible for the outrage. The federation will render every assistance in its power to the striking miners."

William D. Haywood, secretary of the federation, declared that the mine owners were themselves responsible for the strike, and any trouble that followed must be laid at their doors. He said that the owners had violated their agreement and ignored a compromise to which they had agreed. Haywood declared absurd the story sent out from Los Angeles that he had instigated the strike.

Certain alterations may have to be made to the rear platform of the cars to allow the conductor to collect without interference with the ingress and egress of passengers. A recess may have to be built for the conductor, or the rear platform may be extended to give the conductor a place to stand while he is collecting the nickels as the passengers board the car.

The advantage of the "pay as you enter" car is that under it no one can ride free. Another advantage, so President Calhoun says, is that it always allows the conductor full control of the rear end of the car, which is requisite for the safety of the passengers.

The loss of fares, it is claimed, on a line like Sutter street, one of the most congested in the city, is considerable. The conductor is unable to reach short distance riders when a car is crowded. During the rush hours often from 15 to 20 per cent of the passengers do not pay, the conductor being unable to collect their fares.

Mr. Calhoun says that nothing has been decided upon and no plan adopted, but that the question of changing the system of collecting fares is to be investigated.

## SEWER WORK COMMENCED.

The Concrete Construction Company began work yesterday morning on the new sewer system on Nuuanu Avenue, in accordance with the contract granted some days ago. The same company will put in the sewers on Bates, and by a right of way to Judd. This sewer work was all that was granted under the last call for bids, although this is but a part of all the work provided for by the appropriation. The other bids were unsatisfactory, and new specifications will be made and again advertised.

## BRYAN BURIES OLD HATCHET

FEUD WITH ROGER C. SULLIVAN OF CHICAGO SEEMS TO HAVE TERMINATED.

CHICAGO, Dec. 6.—William Jennings Bryan, seeking for a third time the Democratic nomination for the Presidency, arrived in Chicago today, looking well and also looking for the signs of harmony among the local Democrats which has been much advertised lately. So impressed was Bryan with the lack of real harmony and spirit of co-operation that at a luncheon at the Iroquois Club he made an appeal for harmony and an offer of forgiveness, full and free, to everybody in the Democratic party. He did not mention by name National Committeeman Roger Sullivan, whom he read out of the party eighteen months ago, but

his language was so broad as to include him.

Throughout, the Nebraskan talked as though he were already the nominee of the Democratic party for President. He discussed distributing the patronage of the National Administration after the election. He took his nomination for granted and by loud applause the assembled club members approved his course.

## FEDERAL OFFENSE

Before United States Commissioner Frank L. Hatch yesterday afternoon Pala and Nui, the two men caught selling swipes by Chief of Detectives Taylor and his assistants during a raid on a Vineyard street gambling joint Sunday morning, were given a hearing and bound over to the next term of court in the penalty of \$1,000 each. They are charged with selling matt liquors on which the United States revenue tax had not been paid. Nui was represented by C. F. Peterson. It is probable that a charge of illicit brewing may also be instituted against the pair.

**LAWSON GIVES UP "REFORM" WORK**

SAYS HE WILL GO BACK TO STOCK GAMBLING—HINTS AT A NEW MERGER.

BOSTON, Dec. 7.—Thomas W. Lawson has issued a statement which closes as follows: "I have devoted three and a half years of my time and some millions of my fortune to a reform work in the interests of the public. Beginning January 1st, I shall allow the public to do their own reforming, and I shall devote my time and capital exclusively to my own business of stock gambling in Wall and State streets—particularly Wall street—for the purpose of recouping the millions I have donated to my public work."

"P. S.—One of the oldest of human laws and as immutable as 'The devil take the hindmost.'"  
Lawson says he has perfected arrangements by which a new board of directors of the Amalgamated, with himself as president, will probably be chosen at the company's next election. "Barring accidents," he also states, "the properties of Trinity, Nevada, Utah, Balaklava and Arizona smelters will be merged into another property."

**CANADA FAVORS AGE INSURANCE**

PROPOSES THAT AN ANNUITY LAW BE ENACTED AT PRESENT PARLIAMENT.

OTTAWA, Dec. 7.—The Canadian Government proposes to enact legislation at the present session of Parliament providing pensions for old age. The purpose of the new law is to encourage thrift and saving among the working classes of the country and to insure the beneficiaries an annual income after they have reached the age of 60 or 65 years sufficient to keep them from actual want.

To illustrate the operation of the proposed bill, it may be pointed out that for an annual contribution of \$13, beginning at the age of 20 years, the beneficiary will become entitled after he has reached the age of 60 to \$120 per year thereafter as long as he lives. If the annuitant prefers to wait for his annuity until he reaches the age of 65, he will then be entitled to \$200 per annum.

The contributors' savings will be paid into local post-offices wherever they may reside. These savings will then be given compound interest, half yearly, from the Government at the rate of 4 per cent.

**CHICAGO WINS BIG CONVENTION**

REPUBLICANS WILL GATHER AT THE LAKE CITY ON 16TH OF JUNE.

WASHINGTON, Dec. 7.—Chicago was selected as the place for holding the National Republican convention by the following: Chicago, 31; Kansas City, 18; Denver, 4. June 16th was chosen as the date for the convention.

The members of the National Republican Committee congregated at the Shoreham Hotel early today for the last session of the present meeting. The committee was called to order by Chairman New at 10:18 and Governor Murphy was immediately recognized to present the report of his committee on retirement of Chairman Cortelyou. He expressed the regret of the committee, congratulated Mr. Cortelyou on increasing honors that have come to him and closed by expressing a wish for a long life for him. The resolution was adopted unanimously.

The respective claims of Kansas City, Denver and Chicago were then presented. The vote gave Chicago an overwhelming majority.

**MUST RECEIPT FOR PAPERS**  
The difficulty of keeping papers of the Supreme and Circuit Court property straightened out has caused Chief Clerk Henry Smith to issue a form of application blank to be filled out by all record searchers, which describes each paper taken from the files, and receipts for same. On return of the papers the form is also receipted for by the clerk in charge. The system involves considerable work on the clerk but is believed to insure better care being taken of important documents.

**SITUATION IN PORTUGAL.**  
LISBON, Dec. 8.—The Government, in its organ, "Diario Illustrado," promises to terminate the dictatorship and hold the elections in April if the present calm in the political atmosphere is maintained. The firm attitude of Premier Franco has caused a complete breaking up of the coalition of the opposition parties.

**FORTIFY ISLANDS**

PRESIDENT BELIEVES PACIFIC COAST AND HAWAII SHOULD BE PREPARED FOR WAR.

WASHINGTON, Dec. 9.—George A. Knight, in company with Senator Perkins, had a pleasant visit with the president today. Mr. Roosevelt greeted Knight warmly and called to him to join a group while the president hammered into them the necessity for fortifying the Hawaiian Islands immediately.

"I want you to hear this," said Roosevelt. "I want all Pacific coast people to get together and use their influence to push through these appropriations."

Knight was smiling when he emerged. He was asked if the president had approved his bid for permanent chairman of the national convention, but was noncommittal. Several national committeemen have suggested that Knight would make a fine presiding officer and they are now at work spreading his boom. Knight will return to California tomorrow.

President Roosevelt is taking the keenest interest in the question of fortifying the Pacific coast from any possible invasion of a foreign fleet. Not only has the chief executive made strong recommendations in his message to congress for a large appropriation for this purpose, but has talked the matter over with members of congress of the Pacific coast states.

Today Representative Hayes and Kahn had occasion to visit the White House to present some friends. After receiving them the president turned to the two California members and explained to them the necessity for fortifying not only the Pacific coast, but the Hawaiian Islands as well.

He said he realized that more money should be appropriated for the building of yards and docks on the Pacific coast, especially in view of the approaching visit of the fleet. He made it very plain to them that it was his desire that they should do everything in their power to convince congress of the necessity for large appropriations for the proper fortification of the western coast.

That all the members of California delegation are taking the same keen interest in the question goes without saying, and it is their purpose to do all they can to bring whatever pressure is necessary upon congress in order that the president's wishes may be carried out.

**AFTER THE NEGROES.**

GUTHRIE, Oak., Dec. 6.—The "Jim Crow" bill passed the Senate this afternoon by a vote of 36 to 2 against. The bill will become effective in sixty days and signed by the Governor.

**DARING WOMEN SCALE VOLCANO**

AMERICANS MAKE THE ASCENT OF POPOCATAPETL WITHOUT GUIDES.

MEXICO CITY, Dec. 7.—Two plucky young American women, Miss Hortense Eddy and Miss Octave Woodward of Rockford, Ill., have arrived here from the successful ascent of Popocatepetl volcano. They made the dangerous trip without the aid of guides and are the first foreigners, either men or women, to accomplish this feat.

The weather was severe on the summit of the mountain and other members of the party and guides declined to make the ascent on account of the risk that would be incurred. Misses Eddy and Woodward went on alone and after several hours' hard work and many thrilling experiences they reached the crest of the crater of the volcano.

By this time the snowstorm which had whirled about them during the ascent had given way to clear skies and they obtained a magnificent view of the valley of Mexico.

**INDIA NEAR TO A GREAT REVOLT**

CEYLON COLLEGE PRESIDENT SAYS ENGLAND HAS EXPLOITED PROVINCES.

CHICAGO, Dec. 7.—"India is on the eve of a great revolt. Two years, I fear, will see the trouble burst—not the Sepoy mutiny over again, but an intelligent and determined uprising by the educated classes against the intolerable exploitation of India by British money and her insular by British selfishness and stupidity."

These were the words of President S. C. K. Rutnam of the Central College at Colombo, Ceylon, in a remarkable address before the City Club today.

"Personally, I am a Conservative," continued the speaker. "In Ceylon they have called me pro-British because I have scored my people for their faults. I am a Christian, but I tell you that Christian England has killed her hundreds of thousands in my country. Families have actually increased under British rule. In the first fifty years of the last century, India had seven famines. In the next twenty-five years she had six famines. In the last quarter of a century she has had nineteen."

**NEW SINGLAIR SCHEME.**  
BATTLE CREEK, Miss., Nov. 27.—Upton Sinclair, who is here with his family, says about the first of the year he will head a new co-operative colony which will be a rival of the Heliopolis hall venture in some respects, but will differ even more radically from conventional ideas than did the ill-fated Englewood experiment which went up in flames this year.

"The new colony will be a triple-hall on the roof," said Sinclair. "We will live in wagons and tents. We will run California first of all and then go to Europe visiting noted places and people. The Countess of Warwick has invited us to spend a week at Warwick Castle. We will live thus for ten years, raising our children next to nature. We will be vegetarian and non-payers and go to dress reform and all other radical ideas which appeal to us. This is our solution of the modern problem of living without servants and living next to nature."

**JOHN MARKS MAY APPEAR IN COURT**

JUDGE DOLE DECIDES NOT TO INTERFERE IN CIRCUIT COURT TRIAL ON ANOTHER CHARGE.

Over an hour this morning was consumed in arguments before Judge Dole on the matter of the custody of John Marks and whether or not his custody by the United States Marshal pending the hearing on the habeas corpus writ granted him last week, would prevent his being produced in the Circuit Court to answer another charge against him of cattle stealing. The Circuit Court held that the writ would not so act, and accordingly Marks will have to stand his trial at once.

George A. Davis, who had checked the trial yesterday morning by springing the above point on Judge Lindsay at the opening of the trial, argued that Marks, being in the custody of the higher court could not be produced in a lower court until he had been remanded, or the habeas corpus writ disposed of in some way. M. F. Prosser and J. W. Cathcart for the prosecution opposed this, and were sustained by the court.

George A. Davis and E. A. C. Long in their fight to prevent the trial of John Marks on charge of cattle stealing really won their point, although the ruling of Judge Dole this morning did not prohibit Marks from being taken before the Circuit Court for trial. The Federal Court did however make clear that while the writ of habeas corpus remains in force, the prisoner is in the custody of the United States Marshal, and that while the lower court may try and convict him on a new charge, it cannot commit him until the habeas corpus writ is disposed of. Further that Marks would in no way be amenable to the lower court during the trial, and any unseemly actions on his part could not be restrained by Judge Lindsay.

After this decision the Circuit Court convened, but the prosecution signified its willingness to have the case go over for the term, and this was allowed.

**24,000 ACRES TO BE LEASED**

The Land department is about to advertise a large amount of pastoral land in Hanalei, Hawaii, for lease, application having been made for the same by the Kulanui Plantation Company. The tract in all aggregate 24,780 acres, and includes the lands of Kaeohe, Hoia-Kaoa, Niu-Kealakeha, and Manowalake. All this land is at a considerable elevation, some of it running back on the slopes of Mauna Kea to an altitude of over 7000 feet. It is to be leased for 21 years.

Of Hoia-Kaoa below the 1800-foot level, is 770 acres of cane land which is also to be offered for lease on five-year basis. This also adjoins the Kulanui plantation.

**JAPANESE SPREAD NET FOR FISHERIES**

BROWN MEN PREPARE TO WREST THIS TRADE ON COAST FROM CAUCASIANS.

SAN FRANCISCO, December 8.—Another field of industry here is about to be invaded by the Japanese. The wholesale taking of fish, both in the harbors of the coast and offshore, has until now been in the hands of Americans and Europeans with here and there a sprinkling of Chinese.

The little brown men of the Mikado's kingdom are preparing to break into the business, with good prospects of getting a good share of the trade. In Oakland harbor a new company, made up entirely of Japanese capitalists, has begun the construction of a large power schooner or tug, to be fitted with every modern device, not only for the catching of fish offshore, but the preservation of them alive in huge tanks on the vessel, with the idea of delivering them in the market in better condition than under systems now in vogue.

This feature obtains in the Atlantic where fish are delivered alive to the markets of the larger cities. The new fishing tug, which will have powerful gasoline engines, is being built by Japanese workmen. The field it is designed to enter is at present monopolized by A. Paladini of this city, who has long been the most prominent fish dealer on the coast, operating two or three large tugboats out of this port. He is, however, not a member of the fish trust.
