New Regime In Charge

Minutes Of The First Meeting of New Board.

REGULAR SESSION.

Wailuku, Jan. 4, 12 o'clock m. 1909.

The bonds of W. F. Pogue, T. B. Lyons, W. P. Haia, Geo. Kauhi and Theo. T. Meyer, members of the Board of Supervisors in and for the County of Maui having this 4th day of January, 1909, been duly approved by the Hon. A. N. Kekoikai, Judge of the Circuit Court of the 2nd Judicial Circuit, Territory of Hawaii, as by law required; and each of the members of said Board having subscribed to the oath of office before the Clerk of said Court, W. P. Haia then called the meeting of the Board of Supervisors to order at 12 M.

Roll call. Present: W. P. Haia, Geo. Kauhi, T. B. Lyons, T. T. Meyer and W. F. Pogue.

Mr. Haia moved that W. F. Pogue be appointed temporary Chairman. Seconded by Mr. Meyer and carried.

The Chairman stated that the first business was to inspect the bonds of the members of the Board.

Mr. Haia moved that the credentials of the members be inspected. Seconded by Mr. Meyer and carried.

The Clerk announced that he had issued a certificate of election to each member of the Board present.

Mr. Lyons moved that the five members, viz.: Messrs Kauhi, Lyons, Pogue, Haia and Meyer having been duly elected and qualified constitute the Board of Supervisors of the County of Maui. Seconded by Mr. Haia and carried.

The Chair called for nominations for permanent chairman.

Mr. Haia nominated W. F. Pogue. Seconded by Mr. Meyer.

Mr. Kauhi nominated W. P. Haia. Seconded by Mr. Lyons. The Chair putting the name of Mr. Haia the vote for the same stood: T. B. Lyons and Geo. Kauhi for and W. P. Haia, T. T. Meyer and W. F. Pogue against.

Mr. Haia putting the name of Pogue to a vote, the vote stood Meyer, Pogue and Haia for and Lyons and Kauhi against. Mr. Pogue was then declared elected Chairman of the Board of Supervisors of the County of Maui.

On taking the chair as permanent chairman of the Board Mr. Pogue thanked his colleagues for the honor conferred on him and said he would do all he could for the best interests of the County. It is true differences would arise and that there should be differences of opinion on matters brought up before the Board and that the Board

World Wide Scarcity

Why Beef Is A High Priced Luxury.

A leading grazer sent in the following clipping from the Butchers and Stockgrower's Journal, to show the reason for the rise in the price of beef. It looks like turning a bull loose on the beef market, but it represents the point of view of cattle men who are entitled to have their say as well as the consumer.

"The London Meat Trades Journal is of the opinion that the world's meat supply is rapidly decreasing, while the demand, if normal conditions continue, must necessarily increase with the increase of population. The world is eating up its sheep, says the Journal, and the number on foot is steadily being diminished. As this view applies to the former great herds of Australia and all the other sheep breeding parts of the world, it means more than such statements usually do; and if true it affects not only the supply of food, but the supply of clothing also. With the reduction of mutton must come a corresponding reduction of wool.

"The important British authority above referred to, declares further that available statistics show that the number of cattle, hogs and poultry is also diminishing at such a rate that should there be no increase all would be consumed within three years. In other words, the world now has on hand but three years' supply of meat, and unless the increase exceeds the consumption, which it is not doing now, the time can not be distant when meat will be more and more of a luxury."

Supervisorial Doings

Police Appointed and Belt Road Work Authorized.

H. Palakiko, democratic candidate for road overseer, district of Lahaina, was in Wailuku, Monday, to see the new board and county officers inaugurated, and incidentally to see what Supervisor Kauhi would do for him.

T. B. Lyons, Supervisor of Wailuku, received another evidence of his popularity from his worthy help meet in the shape of a boy, January 4th. Mother and child doing well. Congratulations.

A large number of towns people and visitors from the outside districts gathered about the County officers, Monday, January 4, 1909 to see the new set of County officers inducted into office. Come again, Wailuku is ready to welcome visitors at all times.

D. K. Kahaulelio of Lahaina was in Wailuku this week for a look into the County seat politics.

Deputy Sheriffs E. Devauchelle of Molokai, C. R. Lindsey of Lahaina, Edgar Morton of Makawao and Levi L. Joseph of Hana were in Wailuku this week to present credentials and qualify themselves to take up official duties.

Thirty-six residents of Molokai sent in a petition to the Board of Supervisors asking that County road laborers be given dollar and a half a day.

The County Committee of the Wailuku democratic clubs sent in a memorial setting for the claim that they represented "a majority of all of the voters of the district of Wailuku" and that the members of the board should kindly turn to and approve the appointment of any candidate for a job submitted by the supervisor of Wailuku.

The board of supervisors propose to take the office of county sanitary inspectors out of politics by appointing district government physicians to the office.

Mayor Fern of Honolulu is said to be the father of fourteen children, a fact which won the hearts and votes of the heads of large families, and to which the municipality still point with pride, but Oahu is not alone in her glory. Chairman Pogue of Maui's board of supervisors is also the proud father of fourteen children.

Chief Engineer Senator W. J. Coelho of the Wailuku-Kahului Fire Department sent in a request to the County fathers for fire extinguishers and 500 feet more of fire hose.

County Attorney Jas. L. Coke sent in a requisition for the following allowances for monthly expenses of his department, sixty dollars for salary of clerk, fifty dollars for traveling expenses, twenty dollars each for the Kipahulu, Makawao and Lahaina prosecutors.

Jas. L. Coke, County Attorney made the following appointments: Enos Vincent, Deputy; H. C. Mossman, Clerk; and deputy prosecutors as follows: W. E. Saffery; Levi L. Joseph for Hana; J. K. Kapoi for Kipahulu; Edgar Morton for Makawao, C. R. Lindsey for Lahaina, and E. Devauchelle for Molokai.

County Auditor Wilcox asked for a Remington typewriter and an appropriation for office stationery and incidentals \$100.

Lahaina News Items

Wedding Bells and Sunday School Conferences.

Mr. Furtado, manager of the Decoto's meat market, and Miss Lucy Kaukau, a popular teacher of the Lahaina school, were married at the Waihee church by the Rev. Mr. White on Dec. the 29th.

On Dec. the 31st the C. E. Society of Waihee church gave a grand concert at Halealoha hall and raised about \$70 which will be used to send the delegate to the mainland. The Molokai club rendered excellent music at this concert.

On New Year's day the Maui semi-annual conference of Sunday schools had a well attended meeting at Halealoha hall. In the evening an excellent concert was given in aid of the Waihee church. The collection amounted to \$50.

The Rev. R. B. Dodge was in town on Dec. 31st to attend the Sunday school conference.

Miss Bessie Mattison and Miss Haywood of Maunaloa Seminary came to town last week on horseback on their way around the island. They remained a day with Mrs. Simpson and attended the Sunday school convention and concert.

Is Santa Claus a Catholic? He presented Father Maurus with a carriage on Xmas eve.

Brothers Eugene and Louis of St. Louis college visited the Catholic mission on Thursday of last week.

County Engineer Howell presented a report on the High Street to Waikapu extension that the width of the road was originally about 120 feet and that the Wailuku Sugar Co. moved its fence and took in over fifty feet of it and planted the same to cane.

Martson Campbell, Superintendent of Public Works claimed the right under the law to sell the portion taken in to the owner of abutting canefields, without putting up the valuable town lot property at auction.

Mr. E. H. Hart wanted to acquire the strip between public road and lot recently purchased by Mrs. Hart. The government strip ranged from 30 to 25 feet in width. An adjoining land owner Mrs. Esther Crowell also wanted to acquire the strip between her premises and the road.

The Paia County Sanitary Inspector Dr. W. F. McConkey reported fumigating houses where there were cases of infectious diseases, such as tuberculosis and typhoid, stating that tuberculosis was on the increase in the Makawao district, a conclusion arrived at only after the most careful diagnosis of the cases examined. He recommended that the County provide a County farm where tubercular people may be taken care of and expressed his opinion that after the first cost such a farm could be made self supporting, besides checking the spread of the white plague.

Checking the spread of tuberculosis alone would certainly be worth the cost of two such farms in the opinion of the Maui News.

ROME, January 8.—The property damaged by the earthquake amounts to \$1,200,000,000.

MESSINA, January 8.—Thirteen hundred bodies were buried in one grave yesterday.

PALMI, January 8.—A severe shock here yesterday caused a panic.

NEW YORK, January 8.—There were pathetic scenes on board the liner Germania yesterday when 400 steerage passengers learned of the earthquake in Italy.

SAN FRANCISCO, January 8.—Calvin of the Southern Pacific, and Bancroft of the Union Pacific sail for Honolulu Saturday.

UNION CITY, Tenn., January 8.—Six night riders were found guilty of murder in the first degree and two in the second degree.

SACRAMENTO, January 8.—Perkins has again been selected for United States Senator.

PORTLAND, January 8.—The Columbia river is jammed with ice. Navigation above Astoria has been suspended.

LISBON, January 8.—The King was warned at a banquet today of a plot to dethrone him.

HONOLULU, January 7.—The Supervisors are getting along without Fern. Road Supervisor Wilson is not allowed inside the office of the Road Supervisor.

Judge Long in the District Court decided that the laundry license was unconstitutional.

ROME, January 7.—Grisolmi, the American Ambassador, goes to Messina today.

TOKIO, January 7.—Japanese bankers have contributed \$405,000 for earthquake sufferers.

Count Toba, whose engagement to the Princess was cancelled when it was learned that he had married while a student at Cambridge, made an unsuccessful attempt at suicide yesterday.

PORT SAID, January 7.—The first squadron of the American battleship fleet has sailed for Naples.

SEOUL, January 7.—The Emperor and Prince Ito have begun a tour of Korea.

SACRAMENTO, January 7.—Three bills have been introduced in the Legislature aimed at Japanese.

ROME, January 6.—It is reported that dogs are gnawing the decomposed corpses of earthquake sufferers.

PORT SAID, January 6.—The U. S. S. Georgia, Carter, navigating officer, went ashore in the Suez Canal. She was floated without injury.

ODESSA, January 6.—The Russian flagship Fatslov sank in a collision with a Greek steamer. Thirty-four lives are reported lost.

WASHINGTON, January 6.—The President points out the necessity of empowering the Inter-State Commerce Commission to compel the attendance of witnesses to testify.

WASHINGTON, January 6.—Stratton has been nominated Collector of Port of San Francisco.

HONOLULU, January 6.—Complications between the Mayor and the Supervisors are multiplying. There was a deadlock last night.

HILO, January 5. Kilauea is at present very active. Lava is rising near the west side. Many brilliant fountains form a grand spectacle and promise increased activity.

Belt Road Construction. The County of Maui will be greatly benefited if the plans for constructing belt roads outlined by Chairman W. F. Pogue of the Board of Supervisors are carried out, and as the present Maui Board of Supervisors has committed itself to the plan by voting funds to the amount of \$18,500 for the construction work to begin, this County is fairly pledged to carry out the policy outlined.

It is true the last Board of Supervisors did do some belt road construction, a few miles having been built last year, but the work was planned to be carried out with loan funds expected from the abortive County bonding act, and when that fell through, the County fathers used some of the current funds with good purpose on the proposed belt road line.

Chairman Pogue stated that, if the present plans are adhered to, in five or six years the whole of the belt roads of Maui County shall have been built without running the County into debt. We commend the stand taken by Chairman Pogue as a step in the right direction, and a business like way of handling the issues of the day.

Sanitary Inspectors and Tuberculosis. The Supervisors have made a move in the right direction in appointing medical practitioners for County sanitary officers in the several districts. The sanitary inspectors should be men who understand modern sanitation and no one understands that better than a physician.

The report presented by Dr. McConkey of Makawao shows what a medical man can do, and the value of the work for the protection of the people against that insidious disease, tuberculosis. It is inferred from his report there must be much tuberculosis in the other districts as well as in the Makawao, and it would be well if the supervisors could be prevailed upon to have the County sanitary officers take a careful census of the known cases of consumptives or tuberculosis within the County of Maui.

The doctor's recommendations for a County farm for keeping tubercular persons away from the healthy are to the point. Something should be done to protect the healthy. But before public opinion could be roused to take action a knowledge of the number of cases should be had. With that knowledge before the public a further step in the right direction shall have been taken, and the matter of providing a hospital, sanitarium, or County farm for the care of the afflicted would become a live issue. Let all the County sanitary inspectors join hands in the good work by reporting the number of tubercular people in each district to the supervisors.

Just Boys. Seeing so many boys returning to the Honolulu Schools after the holidays and reading the pessimistic utterances of Honolulu papers, and of Superintendent Babbit's worry over what to do with them have made us think of our boys.

The attitude of the pessimist is represented by that of the hen at the edge of the pond, worried and scandalized at the behaviour of her brood of ducklets who would go in swimming. They suggest closing up schools, and would have our children taken by lunas out to work in the canefields and there is a suspicion that such a course is favored by the Superintendent of Public Instruction, and there are those who would gladly hail the man or legislator bold enough and brutal enough to propose such a course as a savior of our youth and land. Away with such. Put a lover of boys at the head of the department that has anything to do with boys. We were boys once, and our hired man loves the little fellows, especially boys in which no one can see any good outside of the child's mother. Ask him and he magnifies the good points, till all the petty faults people love to drag out are lost in the glory of being a mere care free boy.

Perhaps the pessimistic ideas are engendered by racial dislike, from the fact that most of our school population are Hawaiians, Japanese, Chinese, Portuguese, Porto Ricans and a sprinkling of the more dominant races. But the idea of sending the little boys to hoe came out in the soft airs and gladsome sunshine of our canefields is nothing new. Our hired man sniffs at it as all rot and does not think the School Superintendent was hired for that purpose.

Way back in the seventies the Board of Education prescribed such a course of training in the common schools, and boys and girls spent two hours in school and two in the canefields each school day. But when the boys decided to have a lark there weren't enough teachers or lunas to keep them at work, they simply evaporated through the cane and were gone.

If there are boys to be pitied its the boys who were born with the silver spoon. They are doomed to go through life without a knowledge of its larger possibilities and may remain nonentities. That's the pity of it.

The boy who has had to struggle for it and gets cuffed and kicked and knocked about and yet forges ahead with some half formed or vaguely defined idea in his head of what he wants his future to be is the real boy, and is the boy to be proud of, although he may be the son of a laborer. His clothes may be ragged and his feet may be bare and to make ends meet he often goes hungry, and in his little heart he may envy the pampered son of the rich, who dress in neat clothes and goes about with nurse or attendant to look after him, but in the fullness of his time that boy will come forward as the better man for his knowledge of life.

We look for results and care not what brings it about. There are thousands of the lowly born who achieved greatness and whose names reflect glory on the entire human race. Abraham Lincoln and Benjamin Franklin were once poor boys, and yet America with all her wealthy people never yet brought forth one among them worthy to rank alongside of these two once poor boys. Ask a Scotsman of Bobbie Burns, who was born poor, lived poor and died poor, and he will tell you that not even a king or the wealth of Carnegie can take Bobbie Burns' place in the hearts of the Scottish people.

There is no glory or benefit from a full belly is a trite old Hawaiian proverb, and we should not bring up our boys simply with a view of getting them a full belly to the utter neglect of the issues which make life worth living.

Modesty and Immodesty. When Rev. R. B. Dodge, in delivering his address to the Maui teachers, spoke of the necessity of imparting to young minds a knowledge of sexual differences he touched the barriers between modesty and immodesty, which is a very delicate matter.

With the old Hawaiians there were no dividing lines there. When a boy found or felt something he did not comprehend which his companions could not explain he would ask some elder of the family in whom he had confidence, and he got it even if the explanation would make the hair of a modern man stand on end. And the girls got similar treatment from the women folks, and that would be the result if the distinction between modesty and immodesty is not kept. For the subject is a grave one and a serious one for both health and morals.

We know of a father who saw the utter wrong in allowing his sons and daughters grow up in utter ignorance, real or fancied, of these things and undertook to talk to his son who had just returned from one of our higher schools for vacation, on the subject.

In that household the lines between modesty and immodesty had always been maintained, and the scriptural adage "to spare the rod and spoil the child" had been the rule, in the hope that the children would grow up into right thinking, clean lived and useful men and women. After beating around the bush the father delicately brought the conversation round to the matter he had in mind, but the moment he touched on it, the boy blushed, sprang to his feet and made for the door. He chided the boy for his behavior and the boy turned at the door with a grin on his face and ejaculated one word "shamed" in a tone which left the father guessing whether his own son was ashamed of him for going back on his former practice, or to talk on the subject.

At another time after a confidential chat with his daughter, a girl of sixteen, he mentioned the delicate subject in a pleading tone, but the girl gave him a look of pained surprise and was up and gone in a flash.

And so it goes, and the lines drawn between modesty and immodesty remain until the people shall have abandoned the distinctions upon which it is based, but if that is done how are we to justify ourselves for holding up our noses at the modest Japanese laborer of the lower classes? What would become of the distinction between the proper and improper practice? Will not our own standards of living and conduct suffer? Between brutal coarseness and the finer sensibilities a line of separation must remain somewhere.

A DUCK SHOOTING STORY.

FRENCHY SHOTS AT DECOYS.

The sun had sunk behind the cloud bank which top the mountain west of Wailuku when two old cronies met outside the Wailuku Market. They beamed with that garrulous sociability of old people and sat down on a bench for a social chat.

Jim Jones spoke up first with a note of joy in his cracked voice. "Seems to me somehow the town is better 'n them old times when we used to snoop around together. The men seem just as open hearted as we were in them old times and the women just as pretty."

"Ho ho! ever tell the old woman that?" replied, Bill Reed. "You was a gay young rooster them days alright, always stuck on girls till the old woman got wind of your capers and kept her eye on you. O Jimmy, I remember them times well."

"You warn't any different from the rest of us, Bill, I can tell—"

"Oh, come off there!" was Bill Reed's rejoinder "we were all of a kind, as like as two peas in a pod, and looked through the same key hole as the boys would say."

"You remember the old watch maker that had a shop above Jim Girvin's corner?" said Jim Jones.

"Oh yes, I remember him well!" said Bill Reed. "He had a pretty daughter and don't I remember calling on her one evening after the old man had warned me to keep away from the house? Don't I remember how he jumped me and cussed and got after me with boot and club? And kicked me into a taro patch before I got away? He was a hot tempered old Frenchy alright."

"There you go talking about girls, after trying to make out I was more stuck on girls than you were—You always was great on girls them days and a lot of fathers watched your moves with a shot gun handy,—and that reminds me of what I wanted to tell you about old Frenchy" said Jim Jones.

"Old Frenchy was a great sport, likes to take his gun and go out gunning after ducks, plovers and the like, and being on the good side of the old man, for I knew enough not to make eyes to the girls when he was around. I was that foxy. I often went out gunning with him."

"The lagoon back of Kahului used to be a great place for water fowl, ducks, and the like, and us boys kept going there gunning till the birds got shy and wouldn't, light anywhere near the banks, but would plump in and stay about the middle of the pond when there was anything suspicious around."

"We had Hopke get us some real life like decoy ducks. One day we went down and planted a dozen or so of them decoys in a suitable place, and went off a little to give the real ducks a chance to come over and make friends with them wooden ones. While we were waiting developments, who would come along but Frenchy. He spied the decoys and stopped, looked around for cover but there warn't any except a few tufts of grass and the akuli cranberry here and there."

"He wanted the ducks, and wanted them bad. He didn't know they were only decoys! And there was nothing for him to do but to lie down and crawl for it. The place was flat with muddy spots here and there."

"We just laid back and roared to see the old man making for it. First he'd push his gun ahead then wriggle along on his belly hugging the ground close, not even rising to cross the mud holes. We laughed till we thought we had had enough of the old man's antics, then we got up and yelled at him, but he was that bent on bagging them birds that he didn't notice the fuss we were making."

"When he got in good range he ups and lets off one barrel at them dollar and a half apiece decoys, and the way them imitations bobbed serenely was a puzzle to the old

man, but to make sure he lets off the second barrel at 'em. Results same. No dead ducks or wounded ones flopping in the water for him to pick up, but just them imitations bobbing serenely as if nothing had been fired at 'em.

"When the old man looked around and saw us rolling about and cutting capers in the sand, holding in our sides and yelling at him he took a tumble to himself and flew off the handle. How he did dance and cuss and swear!

"There he was dabbed all over mud raving mad and swearing at us and we were laughing fit to bust our sides! He got madder'n madder finally he bust out crying, and with tears rolling down his whiskers, he called us wicked boys to fool a poor half blind old man like him by planting them wooden ducks for him to shoot at, and blubbered enough to make you feel 'shamed o' yourself."

"That sobered us. We weren't bad boys. We didn't mean to fool the old man. We wanted to fool the ducks but he got there first, and twas only natural for us boy like to take in the whole show. So we pitied the old man, and went over to help him pick up his things. When we got close, he flew off the handle again and tried to break his gun on us, and we felt glad he had fired off his second barrel before he had seen us and we got away before he could reload."

DUCK AND SHARKS.

"That was a good joke alright and a mean trick to play on the old man, even if its unexpected as you say, but I take your word for it," said Bill Reed. "And reminds me of the good old whaling times when I used to go duck shooting in the Ewa lagoon. That lagoon there was as pretty bit of water as you'd ever want to see them days."

"After the whaling ships had been in port a few weeks and we got tired of cruising round the Honolulu by-ways and alleys, we used to go down duck shooting on the Ewa lagoon."

"Among us boys was a whipper snapper of a young feller named Black. When I'd go down and fetch up with two ducks, he'd go down and come back with three, I'd go next and bring in four and he'd take a turn and come back with five, and then he'd brag about being 'em quicker'n any one else and brag—well I sized him up to be all brag."

"I remarked about it being easy enough to buy tame ducks from Chinamen and he took me up on it, and we had the boys settle the dispute. All web footed birds were ducks to 'em, and they awarded him the honor of being the best shot 'cause he produced more ducks 'n I did, and I got real downhearted for a spell."

"It was up to me to do something to show I was the better man of the two, so one fine morning I goes down to the lagoon and snooped around the bulrushes for birds and found them."

"I shot at 'em and they would go flopping clear into the middle of the lagoon and go under. I was killing 'em by the score and couldn't get any without havin' to swim for it, and the lagoon reputed to be the home of the king o' sharks."

"I had to have the birds for proof that I was better'n Black with his confounded string of one more duck than mine. So I says here goes for them ducks sharks or no shark, its ducks in hand that counts."

"I pulls off my clothes and swims out and dives for 'em. I found scores of 'em lying on the bottom, swaying easy like with the motion of the water. I picks up a few and turns to rise for a breath and as I looked around I saw one of them sharks, just a small feller about a fathom and an arm in length coming along lazily and he saw me. He gives a gasp and his eyes bulged out and looked at me like what Colum-

bus did when he discovered America, and with a flip of his tail he turned and was gone. Well, I rose filled my lungs with air and dove down for more birds."

"I started picking 'em up by the score, when I feels a slight stir in the water and looked, and there about a ship's length away coming full speed at me were a whole college of sharks! The place was alive with sharks, all looking at me with eyes fixed as much as saying you're my meat," jaws wide open, tongues hanging out, and a racing for me as if all hands had a bet to go to the first one to nab me."

"I gives one look, chunks them birds to the nearest shark and makes a break lickety spilt for dry land. I was a fast swimmer them days, but them sharks would a got me. They were better'n me in the water, and I owns it up like a man."

"I hits the shoal water with them sharks puffing after me, and just as I jumped for dry land the nearest feller made a grab at me, and nipped me in the back below the belt with the corner of his mouth, took a bit of flesh and left there a scar which I shall carry with me to the grave—"

"Hold on, Jones" for Jim was rising to go and Bill Reed caught him. "Set still. Now what do you mean?"

"The old woman wanted some fish and I was goin' to get some from them Japanese fellers over there before they're all gone" was Jones evasive reply.

"Well, you wait till I'm through, if you're a friend of mine" said Bill Reed.

"And your story is like the same one I heard from a one eyed sailor man," said Jim Jones.

"I am telling you no story. It's gospel truth from my own experience" said Bill Reed. "I listened to your yarn when you was spinning it, now—"

And some of 'em got reckless and claimed shooting down ducks by the boat load and couldn't get them ashore because of the sharks and finally said they couldn't bring 'em in on the old sore backed horses they got from the stable to go out on. Just brought in one or two for specimens, and let the rest sink in the lagoon."

That's the way they did, till I felt scandalized over it."

"Then this 'ere whipper snapper Black got to blowing about doing fancy shooting and the boys lionized him again, and I saw I had to do something or I was done for. So I goes in with the boys to try fancy shooting, and I did some shooting no one else could do. I made sure of myself and told the boys of my stunt."

"But they were that stuck on Black they'd wink at me and ask for the birds. I told 'em to look at the bottom of the lagoon, where their own birds were, and that sobered 'em up. But they snickered on the quiet for they had completely gone back on me, as if I was used to telling whoppers."

"It hurt some to think they took me for an ordinary common low down liar, and all because that feller Black were putting 'em up to it. So I ups and invited the whole bunch to go down Ewa and see me do my fancy stunts. That took the house. We hired every horse and rig we could get and went down. Ah, that was a great day!"

"We got there in good season and hid among the bulrushes and waited. The ducks came in flocks and just hung like a cloud over us, waiting to be shot at, and I was urged to bag the biggest lot of fowls ever one man could bag, and I felt tempted to do it, but I waved that aside. I wasn't going to spoil my chance by doing an ordinary every day shooting stunt."

"The bids got tired and went off to rest, and the scoffers began to throw slurs at me, and that was harder to bear, but I shut my teeth and waited for the chance I was looking for. The birds began coming in a line ahead, one after another, but I let them pass, then my own friends began to go back on me, they were that fickle!"

"I then up and told them, I was just going to shoot eight birds and no more. I was a humane man and had come to do fancy shooting not plain fowl killing. I waited till just eight ducks came by flying in a low string, one after another past me, when I ups my gun pointed at the leader and pulled the trigger of one barrel after another with a quick swing down the line as the gun went off and brought all eight of 'em down beautiful."

"They were coming out from a little valley towards the lagoon, and the force of their flight took 'em all eight clear out into the middle where they all flopped in and went under like all the ducks we shot before."

"The boys rubbed their eyes and grinned at me, but I loaded my gun and asked if I hadn't shot as I claimed? If I hadn't brought down the whole string on 'em, and if it were n't a fact the birds had flung into the middle of the pond flapped and gone under the same as they claimed the birds they shot did?"

 HONOLULU, January 5.—The battalion of marines will locate at Camp Very.

Mayor Fern has been inaugurated. There is dissension in the Board of Supervisors. Fern is ignorant of the rules of procedure and confusion follows. Two sets of laborers are working for the road board, Wilson with one set and Cummings with another. The session that lasted all day ended in talk. Republican members hold the fort and Fern threatens to appeal to courts.

Representative Holstein of Hawaii will contest Baker's seat in the Legislature.

HILO, January 5.—A sharp shock of earthquake occurred here at 12:39 p. m. just as the Supervisors were appointing Desha as Chaplain.

MESSINA, January 5.—Earthquake shocks continue. Scientists predict more. The bottom of the Strait of Messina has been pushed up 1400 feet by seismic disturbances. Ten thousand soldiers are working in the ruins. Fifteen thousand people have been rescued. The United States steamer Scorpion has arrived.

WASHINGTON, January 5.—Congress has appropriated \$800,000 for the relief of sufferers in the Italian earthquake.

The Senate has appropriated \$400,000 for an embassy in Paris.

BELLINGHAM, Wash., January 5.—The largest shingle mill in the world burned down. The loss is estimated at \$100,000.

SAN FRANCISCO, January 5.—The trial of Calhoun has been set for the 12th.

WASHINGTON, January 5.—The Supreme Court has decided against the Government in the famous \$29,000,000 Standard Oil fine.

HONOLULU, January 3.—Republicans have endorsed a number of persons for appointment and the fight with Fern begins tomorrow. The sum of \$6,600 was cabled from this city to the earthquake sufferers in Italy.

ROME, January 4.—There have been frequent encounters between guards and ghouls at Messina and Reggio. Six Russian sailors have been killed by looters. Nearly 14000 wounded have been moved from Messina. Stromboli was shaken again yesterday. The King and Queen of Italy have returned.

WASHINGTON, January 4.—The American Red Cross Society cabled \$150,000 to earthquake sufferers.

COPENHAGEN, January 4.—The Kaiser, who is visiting here, has ordered eight transportable hospitals of 80 beds each as used in the German army to be sent to Messina.

PEKING, January 4.—Yuan Shu Kai has been removed from office as comptroller of customs and counsellor as a result of a Manchu plot. He has fled to Tien Tsin and asks for the protection of the British from his enemies in the Chinese court.

SUEZ, January 4.—The American battleship fleet arrived yesterday, two days ahead of schedule. The fleet will be hurried to Sicily to assist in the work of rescue.

ROME, January 3.—The Italian parliament will be invoked upon the return of the King to vote an emergency appropriation of \$6,000,000.

TOKIO, January 4.—The Japanese government has headed a subscription list for Italian earthquake sufferers with \$5000.

SAN FRANCISCO, January 3.—This city has sent \$97,000 to the earthquake sufferers.

HELENA, Mont., January 3.—This city was shaken by a earthquake today.

UNION CITY, Tenn., January 3.—Night riders here attempted to assassinate the Attorney General, who is prosecuting the night riders cases here.

DENVER, January 3.—Members of two families were poisoned by eating candy received through the mail.

BERLIN, January 2.—At the New Year's reception yesterday the American, British, Turkish and Japanese ambassadors were received.

WASHINGTON, January 2. The New Year's reception at the White House yesterday was attended by 6000 persons.

MESSINA, January 2.—The director of the observatory estimates the death loss at over 200,000. Shocks and cold rains still continue. The city of Catania is one vast hospital.

The Kahului R. R. Co. is planning a railway extension across the Maliko gulch to the pineapple cannery and will probably begin work sometime this year. The extension will open up the East Makawao district.

The Kahului R. R. Co. has ordered two auto trucks for handling the freight traffic between the end of its line at Paia and the Haiku Pineapple Cannery.

The port of Kahului handles about 150,000 tons of sea bourn freight, in and out, in the course of a year. Of this 95,000 tons are shipped to the Mainland in sugar and pineapples yearly.

Quite a number of students returned to the Honolulu schools and colleges by the Manua Kea.

Doings In And Around Wailuku Police Court.

The following cases were tried before Judge McKay's court Wednesday forenoon, and as the new County Attorney Jas. L. Coke puts it were given "magnanimous treatment."

Territory of Hawaii versus Akaboshi, charged with practicing medicine without a license, there being two charges one was nolle pross'd, and the defendant plead guilty to the other. The kind hearted judge hung the fabled sword of Damocles over him for twelve months in the shape of a suspended sentence.

Kane Kalolo, charged with burglary in the second degree, waived examination and was committed to the grand jury for further trouble.

A number of Japanese were tried and found guilty of crap shooting and sentenced to pay five dollars each for the benefit of the Territorial Treasury.

Chung Wai Yung a Chinese aged about 34 years, committed suicide at Lamalii, Wailuku, by hanging himself. When found the man had been dead several hours.

After investigations the police was satisfied there was no foul play, as the man was off his head, and had told a cousin that he had but a few days to live.

Kimura Niihori, a young Nipponese aged 25 years, and an employee of the Puunene Store Stables while clipping a horse was kicked in the right side of his abdomen, from which he died, January 5th. Death resulted from an internal hemorrhage caused by a rupture of the kidneys.

Judge Kepoikai's Resignation.

Maui doubts that Judge Kepoikai's resignation was sent to or accepted by the President. We know nothing positive about acceptance, but it is true that Governor Frear the resignation to Washington to be used in case the charges against Judge Kepoikai should be deemed serious enough to warrant his removal. Rumors have come from there that the resignation has been filed and it is expected that, as soon as Congress reconvenes, the nomination of a new Judge will be sent to the Senate. This information, though not official, comes from well-informed sources, and we have no reason to discredit it.—P. C. Advertiser.

Maui people are not discrediting the rumored resignation entirely. It is like smoke in the air and every body has heard it. The Honolulu press is commenting freely on it, why should Maui clip in and spoil the guessing that's going on?

Supervisory Doings.

STANDING COMMITTEES.

A resolution providing for three standing committees, one on roads, one on police and one on the Wailuku Town Hall was adopted by a unanimous vote of the board.

The committees, to consist of one number of the board each are to take charge of the matters under them between the meetings, and all their acts are subject to the board's approval.

The Committee on Roads to gether with the County Engineer the district supervisor and road overseer practically have control of all road matters in each district of the County.

The Police Committee together with the sheriff the supervisor and deputy sheriff are to have control of all police matters.

The Committee on the Wailuku Town Hall, consist of the Supervisor for Wailuku, the Treasurer and County Engineer, and has full charge of the town hall.

After adoption of the resolution T. B. Lyons was appointed to the Town Hall Committee, W. P. Haia, Police Committee, and W. F. Pogue, on the Roads Committee.

Chas. Gav asked for an appropriation of \$2,500, for road work on Lanai for the year. Sent to Committee on roads.

The Supervisors made the following appropriations from its general funds for road improvements for six months to June 30, 1909.

It was expected the democratic minority would put in strenuous kicks at anything the republican majority would propose, and the people on the streets expressed some disappointment at the way in which the democrats ignored the opportunity of playing to the gallery, by settling down to business indisingarding politics when put- and in some work for the good of the County and the public service.

Even the noble work Jas. L. Coke is doing for the good of the public service gets scant recognition on the streets. The outsiders wanted to see a scrap like that going on in Honolulu, and were disappointed at the good common sense displayed by the democratic minority.

As shown by the reports the County of Maui spent in the year 1907 \$159,256.03, of which \$101,438.34 went for road maintenance and improvements, and \$57,817.79 for salaries, police and other general items of expense.

For the year just closed, 1908, \$188,670.72, of which amount \$136,945.89 was for road maintenance and improvements, and \$51,724.83, for salaries, police and other expenses.

The following recommendations for appointments as Road Overseers were submitted to the board of supervisors: Geo. Groves for Makawao, Frank Sommerfeld for Wailuku, and W. L. Decoto for Lahaina. Deferred to February meeting.

The supervisors also appointed the following: Hugh Howell, County Engineer, C. J. Foss Jr., Assistant County Engineer, Samuel Keliinai Clerk of the Road Department.

Hilo Horse Wins Merchant's Stakes.

The Hilo races were a three cornered fight between Hawaii, Maui and Oahu horses. While the Maui horses sent up there were good racers yet with the advantage of place and environment in favor of Hawaii, it was uphill work to land any of the purses offered.

The weather was disagreeable to visitors but probably the usual thing for Hilo. The first race was a half a mile dash for Hawaiian bred horses. The starters were Elko and Breakwater. Breakwater had the lead for a while but on the home stretch it was nip and tuck and Elko passed under the wire by a head to the good and abjudged winner. Time, 0:53 3/4.

The second race for the \$1,600.00 Merchants' Stakes were between Banonica, Frolic, Adion and Bruner. Won by Banonica, with Adion second. Time, 2:14.

Another communication from M. P. Robinson, President Board of Health in re transfer of the Territorial Telephone system Molokai from the Territory to the County was read and the same was ordered placed on file.

Communication of C. S. Holloway, Pres. and Executive Officer Commissioners of Agriculture and Forestry re appointment of Inspectors to inspect imported plans etc at ports on Maui was read and action on the same was deferred.

Communication of J. N. S. Williams Supt. K. R. R. in re lumber furnished for pound at Kahului was read and action on the same was deferred.

Communication of Jas. A. Thompson re stenographer was read and the same was ordered placed on file.

Report of S. Keliinoi, Clerk Road Dept. in re petition against John Kapu road luna at Nahiku was read. The chair ordered the report accepted and the committee discharged.

Annual and monthly reports of the Treasurer and Auditor, monthly reports of Sanitary Inspectors Lahaina and Wailuku, Fish Inspector Wailuku, Deputy Sheriffs Wailuku, Lahaina, Makawao, and Hana and the statement of the poundmaster Makawao were all submitted and the same were ordered placed on file.
