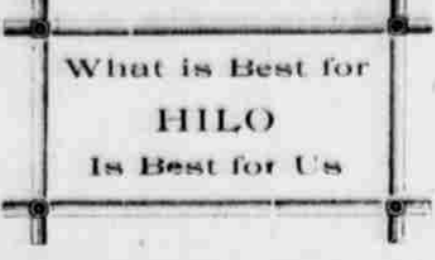

REPUBLICAN HOSTS RENOMINATE KUHIO

The Republican Territorial Convention Convenes in Hilo—A Strong Platform Adopted—Delegate Kalaniana'ole the Unanimous Choice of Delegates—A. G. M. Robertson Selected as Chairman of Territorial Central Committee.

It was several minutes past ten o'clock Thursday morning when Chairman Crabbe called the delegates to order. Spreckels' Hall had been decorated with palms and bunting strung across the ceiling and along the walls. The national colors were the prominent features used by the Decoration Committee, under the supervision of H. Kendall. The delegates filled the seats in the spaces reserved for them in the front of the hall. On the platform back of the Chairman were seated a number of Hilo's prominent citizens, as well as outside guests. Secretary A. L. C. Atkinson was a conspicuous figure on the platform. Among others were Judge Chas. E. Parsons, G. W. H. Hapai, L. Severance, Rev. C. E. Shields, Albert Horner, Dr. Milton Rice, W. H. Smith, Jas. D. Lewis, F. S. Lyman, W. Geo. Kaihenui and E. E. Richards.

There were sixty-eight delegates responded to roll call, the other delegates being represented by proxy. Some amusement was caused by the response of W. H. Rice, Jr., to the names of ten Kauai delegates, whose proxies he held. Col. Sam Johnson of the Fourth District held twelve proxies from Honolulu which he distributed upon his arrival, so that he would not hold the balance of power in convention.

A. G. M. Robertson nominated Rev. S. L. Desha as temporary chairman, which was seconded by a score of delegates. On being escorted to the platform, Chairman Desha said:

"Gentlemen of the Convention—Permit me to express my thanks for the honor conferred upon me. If this were a convention of men I would have no difficulty in presiding, but I confess my ignorance of parliamentary procedure in a political gathering like this. If in presiding as Chairman I forget myself and conduct the convention as though it were a body of clergymen I hope you will pardon me. It is necessary that the action of this body be harmonious. The Democrats claim their conventions are held without any friction, owing to the fact that the wheels are well oiled. The Republicans in convention assembled should live up to the established reputation of the party under Lincoln and Garfield."

His remarks were greeted with applause. The convention proceeded to nominate a temporary secretary. H. Vida nominated M. K. Nakuina, which was seconded by W. T. Rawlins.

W. J. Coelho was selected unanimously as official interpreter. T. McCants Stewart moved a Committee on Credentials be appointed, each district being entitled to one member. On motion this was carried. Chairman Desha appointed: First District, W. Horner; Second, J. H. Wise; Third, S. E. Kalama; Fourth, H. V. Murray; Fifth, N. Fernandez; Sixth, W. H. Rice.

The committee reported on the credentials of the several delegates, and upon motion of Crabbe it was adopted. The roll of delegates was then called and proxies announced. On motion of T. McCants Stewart all persons holding proxies were required to file their authority with the Secretary.

W. T. Rawlins moved the appointment of a Committee upon Permanent Organization, two members to be named from each district. The Chair appointed: First District, H. J. Lyman, W. G. Walker; Second, J. K. Nahale, E. E. Olding; Third, J. H. Kaleo, M. S. Deput; Fourth, C. A. Long, J. A. Gilman; Fifth, J. C. Lane, A. S. Mahaulu; Sixth, J. I. Silva, J. H. Kaiwi.

After an intermission of half an hour J. A. Gilman of the Fourth District read the report of the Committee on Rules and Permanent Or-

ganization, which in substance was as follows: That the officers of the convention shall consist of a Chairman, Secretary and Sergeant-at-Arms.

- That the order of business be as follows:
1. Election of officers.
 2. Appointment of a Committee on Platform, two men from each representative district.
 3. Report of Committee on Platform.
 4. Balloting.
 5. Nomination of Delegate.
 6. Appointment of a Territorial Central Committee, to be appointed on the representation of each district.
 7. Adjournment.

Delegate Holstein called attention to the omission of the office of Interpreter from the report, which was promptly added to the list of officers. With this amendment the report was unanimously adopted.

J. I. Silva of Kauai immediately nominated H. L. Holstein as Permanent Chairman of the convention and before Silva had gotten off his feet the nomination was seconded by a dozen delegates from every part of the convention. Without delay Mr. Holstein took the chair, and after thanking the convention for the honor conferred upon him, spoke in part as follows:

"I do not intend to make a speech, for I believe we want to expedite matters and get through with our work today. My attention has been called to the fact that there is a distinguished gentleman sitting in the body of the hall who is not a delegate and who is entitled to an honored seat upon the platform. Of course this is an oversight. I refer to Admiral George C. Beckley, who is present in the convention, and who has done much for the Republican party."

He appointed Col. Samuel Parker and Governor John T. Baker to escort the Admiral to the platform, and amid resounding applause the doughty Admiral marched between his ponderous escorts to the rostrum. There were cries of "Speech, speech!" and Mooheau was compelled to respond, which he did in his usual style and flourish. His remarks were punctuated with applause at the beginning and end of every sentence. With a profound bow the Admiral spoke in part as follows:

"Gentlemen and Delegates of this Republican Convention (Applause)—I am much overwhelmed and want to thank you for this honor. (Applause.) I want to assure you of my entire feeling of sympathy with your work. I will assist you. (Applause.) I know your choice for Delegate will be Kuhio (applause), and that when you return back to your homes you will all vote the straight Republican ticket. (Applause.) Also to vote for Hilo's breakwater, for a post office and a jail for Hilo (applause), and cries, 'Yes, a jail, jail!'"

The Admiral received the ovation of the convention, which alone varied the monotony and tameness of the gathering. Nakuina was chosen permanent Secretary, W. J. Coelho Interpreter, and Willie Crawford Sergeant-at-Arms.

Stewart moved the appointment of a Committee on Platform, and Chairman Holstein proceeded to appoint the following: First District, J. T. Moir, J. T. Brown; Second, E. A. Frazier, Geo. C. Hewitt; Third, W. J. Coelho, M. K. Nakuina; Fourth, A. G. Robertson, W. T. Rawlins; Fifth, F. Meyers, T. McCants Stewart; Sixth, J. I. Silva and W. H. Rice, Jr.

Rawlins wanted to continue with the convention, but as the hour of 12 o'clock had arrived, and a number of the delegates had lunch engagements, upon motion of A. G. M. Robertson the convention took a recess until 2 o'clock.

At 2 o'clock the convention reconvened and Chairman Robertson of the Committee on Platform read the result of their labors. The speaker was interrupted in the reading of the report by repeated outbursts of applause. The complimentary allusions to President Roosevelt, Governor Carter and Delegate Kuhio were especially well received. The convention and audience showed their approval by repeated applause of the various planks in the platform on county government, land matters, citizen labor and an improved public school system.

Before the adoption of the platform, as reported by the committee, T. McCants Stewart was accorded the privilege of speaking on the motion. His speech was a carefully prepared argument touching upon the issues of the campaign. He set forth the claims of the party and outlined the forward march of the nation under Republican administration from Washington to Roosevelt.

The speaker referred to some of the historic characters of Hawaii and showed that the absorption of Hawaii into the Union was not without its blessings. He urged that united support be given to the Delegate in Congress, whom he said had worked zealously and faithfully for Hawaii's interests. Governor Carter whose aim was to form a government of the people by the people and for the people, was also entitled to the support of every citizen. He complimented the Governor on his economical and careful administration, his labors and achievements, and his desire to build up a united and harmonious commonwealth. In closing, Mr. Stewart said:

"All of the islands from Hawaii to Niihau are clamoring for local self-government, an efficient and economical administration, and for the continued ascendancy of the Republican party. With these common objects in view we should be inspired to fulfill the words of that sweet singer of Israel, 'Behold how good and pleasant a thing it is for brethren to dwell together in unity.'"

Upon putting the motion the platform was adopted and is as follows:

REPUBLICAN PLATFORM.

The Republican party of the Territory of Hawaii, in convention assembled, hereby declares its allegiance to the principles and traditions of the Republican party of the nation, and to its policies as outlined in its platform, adopted at Chicago, in June, 1904.

We heartily endorse the wise and patriotic administration of President Roosevelt, and rejoice that he has so successfully carried out the policies of his lamented predecessor, William McKinley. We endorse the nomination of President Roosevelt and Senator Fairbanks for President and Vice-President respectively, and we pledge ourselves to further show our approval by electing to Congress the nominee of our party in this Territory.

We heartily endorse the successful administration of Governor Geo. R. Carter. Since his appointment, he has gained the confidence and respect of all classes within the Territory. He has shown that he relies upon the patriotism and good judgment of the people by calling the legislature for the re-adjustment of the finances of the Territory, thus placing in the hands of the people's representatives the duties and responsibilities for which they were elected.

We cordially pledge our support to Delegate Kalaniana'ole, in his endeavors to secure Federal aid for this Territory, and we direct the attention of the voters to the necessity of returning him to Congress in order that he may complete the work he has planned to accomplish and has so well begun. His exertions have resulted in the taking over and maintenance of our lighthouses by the Federal Government. He aided in securing appropriations for the erection, at Honolulu, of a Federal quarantine station, and for the purchase of sites for national defenses. Among the measures he introduced in Congress were bills providing for Federal buildings at Honolulu and Hilo, for harbor improvements, for a revenue cutter, and for the relief of the occupants of government lands on the slopes of Punchbowl and to secure title to their homes.

We have fulfilled the promises we made two years ago, and we point to the good work done by our party at the last regular and special sessions of the Legislature, recalling the passage of the County Act, of the Act reorganizing the Board of Health, of the Act authorizing the issuance of Territorial bonds, of the Act providing for the appointment of a commission to compile the statutes of the Act providing for the employment of citizen labor on public works and making eight hours a day's labor on such work of the Act adopting the flag of Hawaii as the flag of this Territory, and of many financial and other important measures, all of which tend to the material welfare of the people of this Territory.

We express our appreciation of the Republican Congress that so promptly ap-

propriated \$1,000,000 toward the payment of the Fire Claims.

The Republican party stands for the equality of labor and capital and reiterates the principle established by the citizen labor law passed by the Republican Legislature and so honestly upheld by the Territorial Executive requiring that all labor on public works shall be performed by citizens of the United States.

We reiterate our adherence to the principle of decentralization of power, and demand the immediate establishment by the Legislature, of county governments throughout the Territory, and also the passage of a general municipal government act under which cities and towns may be established. We will secure, if necessary, such amendments to our Organic Act as may be required to enable the Legislature to enact such legislation fully and completely, and upon approved modern lines. And in this connection, we point with satisfaction to the appointment by the Governor, pursuant to the resolution of the Legislature, of a Commission to draft a new County Act.

We believe in the disposal of public lands to bona fide settlers on the most favorable terms, and will advocate the enactment of a law which will enable homesteaders to purchase their holdings and apply the value of their labor thereon to the purchase price.

We staunchly support the principle of the best education for the youth of the Territory in the public schools in order that they may become good citizens and intelligent voters, and the party pledges itself to provide appropriations sufficiently liberal to maintain the schools in the highest efficiency. We have secured liberal appropriations for the permanent improvement of school houses, thus providing for the proper accommodation of the scholars. Our constant endeavor has been to secure capable educators and to give the people the best possible educational system. We express our approval of a law creating a permanent school fund to be devoted to school purposes only, which shall be a guarantee of ample funds to meet the demands of the broadest and most advanced educational development.

We advocate continued liberal appropriations for the maintenance of our unfortunate fellow citizens segregated on Molokai, and will urge Federal assistance toward measures for their relief and cure. We approve the work of our Board of Health already initiated in this behalf.

We advocate the speedy improvement of our harbors, wharves and landing facilities throughout the Territory, and shall earnestly strive to secure from the National Congress the necessary appropriations for such work.

We urge liberal appropriations for the erection of needed public buildings and other necessary public works, and for the improvement and maintenance of the public highways throughout the Territory.

We favor the continuance by the Legislature of a permanent settlement upon Ex-Queen Liliuokalani.

We oppose all trusts and monopolies and all combinations tending to control supplies and prices.

We contend that the interests of this Territory can be best served by the loyal adherence of our people to the policies and principles of the Republican Party, and so, relying on the wisdom and integrity of the voters of the Territory, we confidently bespeak their support in the approaching election for a Delegate to Congress and for Senators and Representatives in the Legislature.

Rev. S. L. Desha made the nominating speech of Jonah Kuhio Kalaniana'ole. He spoke feelingly in Hawaiian and was listened to attentively by all the delegates. As the address was not translated into English we are unable to reproduce it here. When he closed, the convention set up a deafening cheering for Kuhio which lasted for several minutes. E. A. Fraser spoke on behalf of the Second District, which he said yielded the honor of seconding the nomination to the Fourth District. Here F. E. Thompson, the silver tongued orator of Oahu, was called upon and delivered a ringing speech, filled with many beautiful periods. He spoke in part as follows:

MR. CHAIRMAN:—Gentlemen of the Convention:

Oahu esteems it a pleasure and an honor to raise her voice and pledge her votes in support of the name presented to this convention by Hawaii.

Oahu does this not because the nominee resides upon her shores; not because he belongs to any faction, clan or schism; not because he is a prince among men; but because he is a man among princes. Oahu joins hands with Hawaii because Oahu's Republicans believe that the laborer has been worthy of his hire; because they believe that it is unwise to slough off the old and tried and take on the new and untried, because they believe that Hawaii's nominee, like the party he is called to represent, will move on with years, meet the requirements of today, and advance with the requirements of tomorrow.

The result of the coming November election places the Territory of Hawaii in the Republican or non-Republican, the Democratic or non-Democratic list, and the Republicans of this Territory demand of this nominating convention a leader who can scatter the thin skirmishing lines of Democracy, capture the citadel of the Home Ruler and march the youngest Territory squarely into the ranks of that grand old party upon every page of whose record is engrossed a history of the prosperity and progress of a country, which is at once the admiration and the envy of all other nations.

The success of the Republican party in the coming presidential election is in itself a silent and sad concession by Democracy whose candidate for the

presidency stands upon a self conceived and self erected platform; whose candidate for the vice-presidency stands upon a platform built by that master political carpenter, Hill, according to plans and specifications submitted by Chief Inspector Bryan, and whose rank and file are standing barefoot in the snow without any platform.

The two great national parties recognize no goats, be they branded Socialist, Populist, Prohibitionist, or Home Rule. The people of the Territory want a man who will keep green in the memory of our national leaders the party's platform promises to maintain a tariff wall which will protect our sugars from foreign competition and our Islands from dry rot and commercial decay. We want a man who will insist upon the fulfillment of our party's promise to foster and encourage American shipping interests, so that the bays and harbors of this way station of the Pacific will again be crowded with a merchant marine flying the flag of its nation.

We want a man who will demonstrate to the authorities at Washington the unequivocal necessity of studding our shores with guns of defense so that American ships nesting in our harbors after a trip through the Panama Canal, for the completion of which the party is pledged, will be safe from the attack of the navies of hostile nations.

We want a man who can carry the victorious standard of his party through the rolling valleys and along the sun-kissed foothills of that brightest pearl in the neckless of the Pacific, Kauai.

We want a man who can, and will inspire confidence in the breasts of the voters of that Island of ancient kings, Maui.

We want a man who can clasp with the true sympathy of a deep sorrower the withered hand of the Territory's wards at Molokai.

We want a man for whom a chant of welcome is always on the lips of the hardy inhabitants of Lanai; a man who has the confidence and love of the magnificent Island of Hawaii from its surf-lashed shores to its snow-crowned peaks; a man who has the respect, esteem, confidence, honor and support of the voters of busy Oahu. And it gives me the greatest pleasure to second the nomination of John Kalaniana'ole, who possesses all the magnificent prerequisites of the man the Territory demands; one under whose leadership the campaign of 1904 will be carried to a Republican victory as certain and as gratifying as was the campaign of 1902 under the same leadership.

On behalf of Maui, Delegate Coelho asked that the convention sing standing, the Hawaiian anthem "Hawaii pono," which was done with a good will. Kaiwi, of Kauai in a short speech seconded Kuhio's nomination for that island. John C. Lane seconded the nomination from the Fifth.

The secretary was instructed to cast the ballot of the convention, and Hon. Jonah Kuhio Kalaniana'ole was duly nominated by acclamation, amid wild enthusiasm. At this juncture the delegate was ushered into the hall and upon the platform by a committee consisting of A. G. M. Robertson, J. H. Wise and C. L. Crabbe. The convention received the delegate standing and three rousing cheers were given him as he took his place on the platform.

Delegate Kuhio spoke briefly, thanking the Convention for the honor of a second nomination. He spoke of the opposition which he had to contend with in Washington, not only from other states seeking appropriations, but by the efforts of individuals in Hawaii who sought to discredit his work before Congress. A delegate can only work through the friends he makes in Congress, and it had been his aim to create as many friends for Hawaii as possible, which he felt he had succeeded in doing to a large extent. His remarks were received with prolonged applause and many expressions of approval on the part of the delegates.

T. McCants Stewart introduced a resolution, which was passed unanimously, as follows:

RESOLVED, That the Convention notes with pleasure the artistic and splendid manner in which the convention hall is decorated, and expresses its appreciation of the largeness and heartiness of the hospitality extended by the committee on reception and the citizens of Hilo.

The Territorial Central Committee was then appointed upon the nomination of the several districts, as follows:

A WIRELESS SERVICE.

Recognizing the necessity for an improved news service in Hilo the TRIBUNE will inaugurate, beginning with its next issue, a special Wireless service. At considerable cost and by special arrangement with the Inter-Island Telegraph Company, the TRIBUNE is thus enabled to give to its readers all the telegraphic and cable news of the world upon its occurrence. Special attention will be given to war news pertaining to the Russo-Japan war, and every effort made to obtain authentic and reliable reports, eliminating all rumors and conjectures or contradictory dispatches. The Wireless has been improved to a degree almost of perfection, and with the governmental aid which the local company has been receiving in the form of a monthly subsidy, the method of transmission has been so improved that the accuracy and promptness of its service is guaranteed. The change in location of stations has dispensed with two intermediate stations, which have heretofore been located on Lanai and Molokai, and messages are now sent direct from Hawaii to Honolulu. It is possible with the improved system in operation to deliver messages in Hilo within ten minutes after their receipt in Honolulu, and vice versa. The Territorial government utilizes the Wireless almost daily, and the advantages of prompt and easy communication by inter island telegraph has saved many delays and much loss in time and money to the government. The Wireless is now recognized as a safe means of communication and has attained an established footing in the business and mercantile world. The establishment of a Wireless service will enable the TRIBUNE to give to the public the latest cable and island news to Tuesday morning of each week, which will be the new date of publication. No additional charge or increased price of subscription will be made to the public for the increased news service, and we hope the efficiency of the TRIBUNE as a valuable news gatherer will compensate for the effort expended.

THE CONVENTION.

The Republican Territorial Convention completed its labors yesterday afternoon amid great enthusiasm. This is especially remarkable in view of the fact that there was no contest to create any rivalry or excitement. The energy and interest shown in the deliberations of the body portends well for the success of the party. There was no evidence of any factional feeling and to a spectator the convention was like unto a love feast, merely ratifying the wishes of the majority of the voters in an expressed platform and the renomination of Delegate Kuhio. Cupid's renomination was conceded from the first and his selection as the party leader insures the party's success this fall. The outlook is full of promise and with Chairman A. G. M. Robertson at the helm of the party, there should be no doubt as to the outcome. It now devolves upon the individual voter to carry out the will of the convention and to elect Kuhio and the various legislative tickets to be put in the field by an overwhelming majority. Hawaii is glad of the opportunity afforded her to test the hospitality and cordiality of her welcome. The Crescent City is especially proud of the distinction of entertaining the leaders of the dominant party and stands ready at any other time to give to the republican hosts equally as hearty a reception as on this occasion. RECEPTION TO DELEGATES.

The Visitors Being Looked After by Hilo Citizens.

Contrary to expectations, there were ample accommodations provided for the visiting delegates to the Republican Territorial Convention. The Reception Committee had made arrangements for the entertainment of so many delegates at private homes that the Peacock and Demosthenes rooms were not all taken. Twice the number could as readily have been taken care of, despite the closed condition of the Hilo Hotel.

Jas. D. Lewis met the steamer Kinan at Laupahoehoe, with a list of the accommodations available and roomed the delegates before their arrival at the Hilo dock. There was therefore no confusion or delay when the crowd disembarked. A special train was provided on the Hilo Railroad to take the visiting Shriners to the Volcano House and a Puna train was in waiting on the dock for steamer passengers.

The delegates were met by the several reception committees and the Hilo Band and escorted to the Convention Hall, where the fourth and fifth districts immediately held a caucus as to the various committees they desired. The several other delegations held caucuses Wednesday night and Thursday morning preliminary to the convention.

The band concert Wednesday at the Hilo Hotel grounds was largely attended. W. H. Beers, chairman of the District Committee presided and introduced the various speakers. Representative Aylett was the first speaker and spoke entirely in Hawaiian. He was followed by Delegate Kuhio, who recounted the difficulties which confronted him at Washington. He explained that it was impossible to get a hearing on Hawaiian affairs before any of the committees of Congress, on account of this being Presidential year. Everything was politics, and would predominate the next session of Congress. He spoke of the factional feeling in Hawaii which retarded his efforts and urged all republicans to work together to a common end. As to the Hilo Breakwater, he doubted the passage of an appropriation for this purpose during the coming session, but felt confident that a bill for a federal building in Hilo would be passed. He said he was not unmindful of the wants of Hilo and the island of Hawaii, but without the united support of the entire Territory, he could accomplish little. His speech was greeted with applause and he then addressed the assembled crowd in Hawaiian.

Wm. J. Coelhoe, the Maui delegate and nightingale, sang several solos with guitar accompaniment, which were sweet and plaintive. T. McCants Stewart came with a prepared address, but owing to the length of the program he found it necessary to confine his remarks to the general subject of republicanism. He spoke of the reputation of the Hilo Young Men's Republican Club, which had become a household word in the Islands, and prophesied a brilliant career for this body of young men. The hope of every community lies in its young men. Like a great battle of arms, our leaders are commanders, and we are their army. It is hopeful and inspiring, therefore to see the young men get together under these captions, form a solid phalanx and prepare to march to a glorious victory. He recalled the loyalty of the young men to General Grant, who followed that intrepid leader to victory. He compared the young men of Hawaii to soldiers, who under the leadership of the former Commander Prince Cupid would march forward to a glorious victory next November. He expressed regret the time would not permit him to dwell on the issues of the campaign, which he hoped later he might discuss with the young men of Hawaii. Closing he said the republican party represents the best forces of the nation and stands for the nation's prosperity and advancement. Roosevelt would be elected and if the party in Hawaii were harmonious, he prophesied that Prince Cupid would return as Delegate to Congress. His remarks were interrupted by repeated applause.

Chairman Robertson was called upon and urged that united support be given to Delegate Kuhio, which would insure his re-election and his success at the next session of Congress. He likened Hawaii to a small child with the federal government as the parent, who would treat its offspring as it deserved if it behaved itself. The meeting was brought to a close by speeches by John Wise, a converted Home Ruler and John C. Lane, both of whom delivered able addresses.

Last night, equally as large a crowd gathered to hear speeches by Col. Sam Parker, John T. Baker, F. E. Thompson and others.

Only a Few Danced.

Owing to the general humidity of the atmosphere all last week, few members of the Hilo Cotillion Club attended the regular dance of that organization given at Spreckels hall last Friday night. No pains were spared by those in charge to make the dancers have an enjoyable evening. The decorations were dainty and attracted attention and a large supply of church lemonade enlivened the evening. The feminine portion of the membership of the Club predominated, but the male dancers managed to distribute themselves so that there were no wall flowers, which to the feminine mind is always a criterion of a successful dance. The gathering dispersed about midnight.

WILL PLAY GOLF.

A Club Organized by Local Players.

Not to be outdone by the fashionable set of Honolulu, some of the lovers of outdoor sport have organized a Hilo Golf Club. Fred C. Smith of Honolulu, who is now in Hilo, is largely responsible for the interest in this fascinating game, but W. T. Balding and E. C. Mellor are originators of the movement to organize a Hilo club. A meeting of those interested in the subject of golf was held at the Board of Trade Rooms last Monday night, when a sufficient number were present to perfect organization. A fourteen acre field at the edge of town, opposite Pakihue gulch, has been secured, which it is claimed will give sufficient room for a seven hole course. It was explained that this was the most accessible and satisfactory grounds available, and could be obtained at a nominal rental. As soon as the grass can be cut, the greens and trees put in shape the course will be ready for use. Already the flags and permanent markers have been sent for, and within two weeks a sufficient number of players will have gotten clubs to begin playing.

The following officers have been elected: President, W. T. Balding; Secretary and Treasurer, E. C. Mellor, Captain, S. Grace, and Board of Directors, W. T. Balding, E. C. Mellor, E. N. LEGISLATIVE HOPEFULS.

Aspirants for Honors Rise up on Every Hand.

The woods are full of them and as the time draws nigh when the republican nominating convention shall name the party ticket, one need not shake the bushes more than once to see a wild scramble of possibilities hurrying and scurrying, some nursing a secret ambition for a political career, while others are absolutely refreshing in their innocence and veridancy. There are those that are still unripe, a few that are just mellow for the picking, and a number that have grown old and sear in the storms of the past. A few there are that have been served up once or twice before to the public, and either have not been to the popular taste nor created an unsatisfied demand for more. Altogether there is offered a motley assortment of candidates, good, bad and indifferent any of whom can be had for the choosing.

For the Senate, it has seemed that Senator John T. Brown would force his candidacy upon the Young Men's Republican Club and the republican party. His term of office expires and he is up for reelection. While the young men are not particularly wedded to the Senator, they will accept him, if no better material offers. Rev. S. L. Desha will not brave another fight against his former antagonist and with a sense of propriety of his profession, cannot be expected to again undergo the unpleasanties, of another campaign. W. H. Shipman of Hilo has been suggested, if he will permit the use of his name. He would doubtless be a strong candidate with the Hawaiians on both sides of the Island, but as there is talk of his brother Ollie Shipman being the democratic nominee, he might be opposed to waging a vigorous fight in his own family.

For the lower house, the names mentioned are almost innumerable. Under the rules which Albert Horner was wise to have adopted in the convention last Saturday, Olaa and Puna are entitled to one candidate, Hamakua to one and the rest of the district, including Hilo, to two candidates. The adoption of this program rather simplifies the situation, and prevents the springing of the proverbial "dark horse" at the last moment to carry off honors.

There is no decided conviction among republican leaders as to the Olaa and Puna candidate. Tom Cook appears to be in the lead, but he says his work as road supervisor requires his undivided attention and he cannot afford to resign his position to make a campaign and go to Honolulu, if elected. D. Kelipio, H. J. Lyman and Kewela have all been mentioned as possibilities. In the event of the refusal of W. H. Shipman to run for the senate, the alternative has been suggested that his name be put on the ticket for the house, which is generally believed would be a good move and insure success for the entire ticket. In Hamakua, according to the statement of Albert Horner, Antone Fernandez who has recently been converted from Home Rule ranks is entirely satisfactory and the party could not select a better man for the place.

In Hilo, however, and those districts which must join with it on two names, according to the program adopted by the convention, there is the greatest array of statesmen. R. A. Lyman Jr., who has practically been the leader of the Young Republicans is seriously considering his own candidacy, and with the support of the Club and of the Acting Governor Atkinson, there is little apprehension of the outcome. The name of I. E. Ray has been variously offered as the candidate of the Young Men's Republican Club. Ray is the president of the Fourth Precinct Club and has a certain following which might mean success. Home: L. Ross is not eligible as a candidate, by reason of not having resided here three years and repudiates the imputation of the Herald's announcement, which he says would never

have been made had the writer been familiar with the Organic Act.

Jim Lewis will be the most formidable candidate for a place on the ticket. There is an element in Waiakaa seeking his downfall, which met with a measure of success in the last primaries, defeating him as a delegate to the district convention. H. B. Nalimu, the veteran stage driver, who drives the ark between the post office and Waiakaa, is out for legislative honors and is leading the fight against Lewis. The rivalry has drawn David Spaulding and Kikino Kealawaa, a former legislator, into the race, and the combination of elements may cause Jim's defeat. Lewis polled the largest vote of any one on the ticket two years ago, but conditions have changed more or less, and Hilo's former representative is not the popular idol with the young men that he has been. It is claimed he is not aggressive enough to suit the temper of the new movement in the party, and the plan is to shelve him, if possible.

Chas. Akau, one of the more promising young republicans, by his tact and modest bearing has won to his side an array of warm admirers, who will put forward his name as a candidate for the lower house. Akau has been one of the conservatives in the councils of the Young Men's Republican Club, and while not always successful in carrying to success his opinions, has instilled into that body a growing spirit of harmony with the old rank and file of the party. There is little doubt expressed as to his election, if placed on the ticket, which will probably be done unless there are other forces at work to prevent it. The three Smiths: Carl, J. U. and W. H. Smith have been mentioned as possibilities. W. H. says he is a married man now, and no longer in politics. The others say the same thing about themselves, but where there is a lightning rod up, there is a suspicion the owner is afraid he might be struck. As the head, front and shoulders of the Young Men's Republican Club, Carl S. Smith might be elected without much trouble, although the influence of that organization outside of Hilo has been questioned.

Among other mentionables is A. B. Loebenstein. 'Alape' has still an unmistakable influence with the natives, but like many another old war horse of previous campaigns sits quietly back and smiles his own smile at the scramble for empty honors. The end is not yet, and no man knows what two weeks may bring forth.

MANY ALIENS IN JAILS.

Statistics Given out by Commissioner General Sargent.

Washington, Aug. 13.—Frank P. Sargent, commissioner general of immigration, has made public the tables relating to the number of aliens confined in the various penal and charitable institutions in the United States in the first four months of the present year. Only such aliens as have been in the United States less than five years are counted.

The tables divulge a startling condition of affairs. There are confined in the institutions covered by the report 28,939 males and 15,643 females, all of whom have not become citizens of the United States. Of this number 3,995 are imprisoned for grave offenses, 5,686 for minor crimes, while 20,279 are insane and 14,604 are confined for life and 10,112 for more than two years.

In state institutions there are 23,548 persons, 14,979 in county institutions, 5,358 in private hospitals, and 679 in federal institutions.

New York leads in the percentages, with Boston second and Philadelphia third. The investigation is being continued.

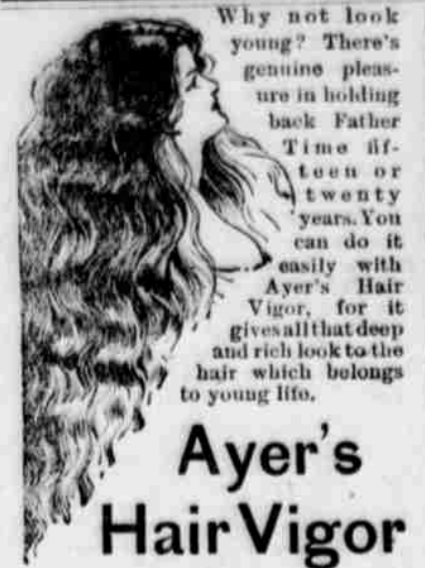

"But I should think they would have done something for you at the mill!"

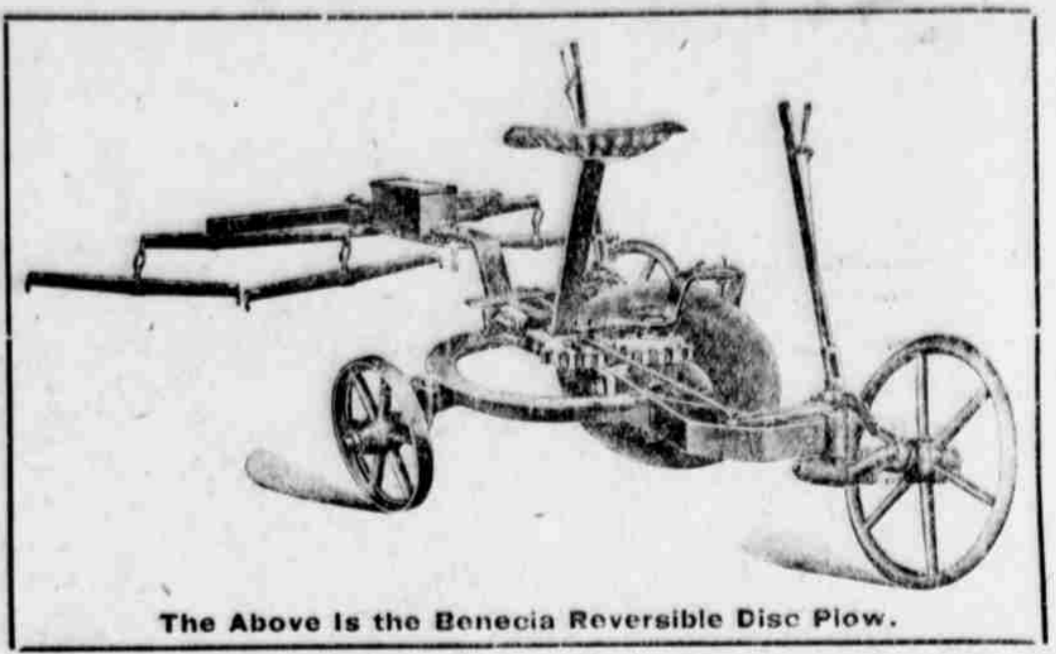
"Oh, we didn't come by way of your mill. We drove from Marquette."

"But I'm sorry I didn't know, I'm sorry you didn't let me know. I suppose you thought I was still at the mill. How did you get along? Is Wallace with you?"

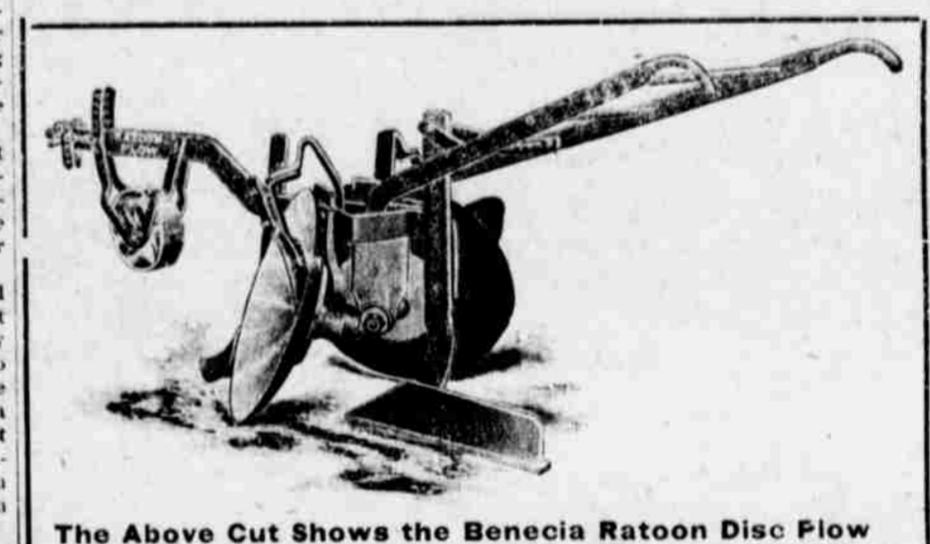

STRIKE ON HIS HANDS.

Whitehouse Has More Trouble With Oukala-Kukai Contract.

Contractor Whitehouse seems never to be able to get to the end of his troubles over the Oukala-Kukai road contract. After complying with the demands of the Hilo Young Men's Republican Club with reference to citizen labor, and the employment of a white luna instead of the Japanese overseer, the new gang of laborers, most of whom are Hawaiians, struck last Friday and refused to go to work. They claimed bad treatment on the part of Fukui, who, though a sub-luna, is in charge of the work; that they were discriminated against in character of work given them, and that several of their number were being laid off or discharged without cause.

When word was received in Hilo of the labor difficulty, Secretary A. L. C. Atkinson started for the scene. In company with his secretary, J. W. Lloyd, and two lymans, he left late Friday afternoon and arrived at Oukala early Saturday morning. He met and heard the complaints of the strikers and listened to the contractor's story. From all the evidence and information he could gather there appears to have been a misunderstanding on both sides. In a sensible talk which the Secretary gave to the laborers he said that even though citizens, they could not expect to receive the support of the administration if they would not do a full day's work. There must be no more threats, and if they went on a strike and refused to work the contractor had only one alternative left, which would be to employ Asiatics on the road. He would not countenance the employment of Japanese on this or any other government contract. He asked the strikers whether they would be satisfied to leave the matter to be adjusted between himself, Albert Horner and Fukui, representing Contractor Whitehouse. This appeared satisfactory, and after an extended conference with Fukui and members of the Road Board the strikers returned to their work and Secretary Atkinson left for Hilo. There has been considerable friction, according to Mr. Atkinson, on both sides, and he urged that there be less disposition to wrangle over unimportant matters. The government wants to recognize citizen labor, but all the law is not on the laborer's side.

PREVENTED FROM BIDDING.

Bidders Object to Faulty Specifications.

There have been many objections made by Hilo contractors and others to glaring inconsistencies in the specifications of the Public Works Department, which it is claimed prevents many responsible contractors from bidding on government work.

The attention of the Hilo Board of Trade has been called to the specifications and plans submitted for the Hilo sewerage system, which it is alleged are indefinite in so far as the amount of work to be done. The Board in turn have taken the matter up with Superintendent Holloway, for correction, if possible. Objection is made to the clause in the specifications which calls for bids on work "to include a complete system or such portions as the Engineer may decide." The specifications it is alleged, should set forth definitely the number of lineal feet of sewers embraced in the contract, but the Department reserves the right to grant a contract for a portion or for the whole sewerage system. It is claimed that a contractor having inside information from the Department as to the amount of work contemplated has the advantage over other bidders and is enabled thereby to submit a lower figure.

To do a small amount of work will require as extensive a plant as is needed for a larger job. It requires approximately the same outlay in tools, teams and plant to construct 2,500 feet of sewer as to construct 1000 feet. Obviously, a favored contractor with definite information in advance of the amount of work projected, would have a decided advantage over his competitors.

It is also set out in the specifications that the drawings and plans referred to "are not necessarily those submitted before letting the contract." The Department may alter the plans and specifications after receiving the contractors' bid upon the plans first submitted and agreed upon. It is claimed this is unfair and any deviation from the original plan would not entitle the bidding contractor under the wording of the specification, to extra compensation for additional work done. It is stated by contractors that there is no plausible reason for not furnishing to prospective bidders a definite statement of the amount of work to be done and any substitution of other work not bid upon would work a hardship on the contractor.

Well Worth Seeing.

At the Board of Trade rooms can be seen as handsome a collection of polished calabashes, tables and stands as can be found anywhere in the Islands. The collection is the property of Mrs. A. James of Hilo, and are the handiwork of her husband, who turned out and polished the various articles. A unique settee is formed from an old kua canoe head, which has been polished to a high finish and mounted on legs of the same wood. The articles are not for sale, but Mrs. James has been prevailed upon to leave them on exhibition for a few days for the inspection of the public.

W. S. Terry of the Hilo Coffee Mill has on exhibition three jars of Hawaiian coffee. The flat and pea berry are shown, as well as the product in the parchment, all of which is grown on the big island.

The Luau.

Nearly all of the delegates took advantage of the luau prepared by the Young Men's Republican Club at the home of Rev. S. L. Desha. The basement was decorated with ferns and palms, and each guest was given a lei. Rev. S. L. Desha presided and on his right sat Delegate Kalaniana'ole. The other guests were seated at the various tables. The feast began about 5 o'clock and continued till nearly nine, the latter part being devoted to speech making. Prince Cupid was called on, as likewise A. M. G. Robertson, F. E. Thompson, Admiral Beckley and others, all of whom were heartily received. The delicacies provided for the occasion were the rarest to be found in Hawaiian shores and every one went away happy and contented.

HOME RULERS NAME TICKET.
Held District Convention and Nominating Candidates.
The Home Rule party proposes to be a factor in the coming election, and forestalled the other parties by putting their legislative ticket first in the field. The district convention of the Home Rule party for the First Representative District was held at Firemen's Hall on last Monday and the flow of oratory held sway all day. The convention was called to order at 10 o'clock by Thos. B. Ahleong, President of the First District Committee, with Joseph Oliver of Puna as Secretary. Charles K. Nodley, candidate for Delegate to Congress, occupied a prominent seat, and Senator David Kalan-kalani, the Chairman of the Territorial Central Committee, who was present, was asked to preside during the deliberations of the convention. Kalanokalani has had some experience as a Senator and in the clever art of making conventions follow his dictates. He was more or less familiar with what the leaders in East Hawaii wanted, and the result is a specimen of his handiwork which it is claimed promises to be a surprise to both the Republican and Democratic parties. Jonah Kumalae was active in the convention, instructing delegates as to their duties.

There were thirty-four delegates present, and after organization the convention proceeded to the business of nominating an "unbeatable" ticket, as they call it. For the Senate there was only one name mentioned, and when Ollie Shipman was nominated in a speech of some length by James N. Kamakawi he was unanimously selected as the candidate for the upper house. Shipman is a native born white citizen, well known throughout the island, and the Home Rulers are confident that he will lead in the race for the Senate.

For the lower house there were nine aspirants for legislative honors. S. H. Haaheo of Kalapana desired to be on the ticket again, but as his strength had been tried two years ago and found wanting the convention refused to make him a candidate. The Home Rule candidates on the local county ticket last fall seem to have risen to popularity again in the Home Rule mind, for the two candidates for Representatives chosen from Hilo were successful in the election under the recent county act. T. J. Ryan of Olaa, who fell by the wayside last fall as an independent candidate for County Auditor, and who has now re-established himself as a Home Ruler, will be the party candidate for the House of Representatives. Simeona K. Kahana, the hack driver, was a popular candidate, but withdrew after the final ballot.

William Keolanui, elected as County Sheriff last November, and William E. Edmonds, the former County Assessor, are the candidates for the lower house from Hilo. Former Representative W. N. Purdy of Hamakua was nominated for re-election. There was no effort made apparently in the opening of the convention to recognize each section of the district on the ticket, but the first ballot showed that Hilo would monopolize the entire ticket, and matters adjusted themselves on the second poll of votes.

The name of William Keolanui was put in nomination by Simeona K. Kahana, who was later nominated as a possible candidate by another delegate. One of the Olaa delegates thought Olaa should have representation on the ticket and named T. J. Ryan. S. H. Haaheo of Puna, Wm. E. Edmonds of Hilo and W. N. Purdy of Hamakua were also named. Upon a cast of ballots the vote stood: Keolanui, 25; T. J. Ryan, 22; Simeona, 20; Edmonds, 14; Purdy, 11, and Haaheo, 10.

Keolanui here called attention to the fact that if the ticket stood as the count of votes showed Hamakua would be left out. He moved another vote and Edmonds seconded the motion, at the same time withdrawing his name from consideration. Haaheo and Edmonds were also tied on the first ballot, but when a second vote was taken the

four highest names were found to be William Keolanui, T. J. Ryan, William E. Edmonds and William N. Purdy.
There were speeches by all the big guns of the party, who came over from Honolulu and Maui, including Candidate Charles K. Nodley, Senator Kalanokalani, Jonah Kumalae, J. M. Poepeo and D. H. Kalalelio of Maui. Some of the smaller fire crackers from Hilo and vicinity were heard from and the convention adjourned late in the afternoon.

The Gaelic Escapes.
The Occidental and Oriental liner Gaelic on her trip from Honolulu to Hongkong narrowly missed being run down by the ill-fated cruiser Novik. The Gaelic, was held at Midway for a few days awaiting news of a clear track to Japan, and later received orders to proceed and she passed into the Japanese ports safely. After leaving Nagasaki for Shanghai, the vessel had a narrow escape sighting the Russian cruiser Novik between Shanghai and Nagasaki, proceeding south. The Novik sought refuge at T-singchou, but left there at the expiration of twenty-four hours and has not been reported before. The local authorities are anxious, and shipping is disturbed. The course showed her to be heading for Van Diemen straight. Van Diemen straight is about 120 miles south of Nagasaki, and it is thought that she proposes to try and reach Vladivostok by the east coast of Japan.

War.
Tokio, Aug. 27.—Part of Kuroki's army has advanced on the Russians beyond Yushilling. The artillery fire, which was very heavy, ceased at noon and the Russians retired toward Anping.

Washington, Aug. 27.—Japan has notified the powers that unless Russia disarms the warships at Shanghai she will take radical action.

Tientsin, August 28.—The Japanese are 1200 yards to the west of Port Arthur and one mile to the east.

Kobe, Aug. 28.—The Japanese have captured all of the outlying fortifications of Port Arthur. The Russians hold the citadel together with Antzshan, Golden Hill, Tiger's tail and Liaoti forts. It is believed that the Russians will attempt a sortie before the end of the month.

Tokio, Aug. 8.—It is reported that General Kuroki has cut the railway south of Mukden, separating the Russian forces on opposite sides of the point severed.

Shanghai, Aug. 28.—The disarming of the Russian warships Askold and Grozovoi will begin tomorrow.

St. Petersburg, Aug. 28.—General Kuropatkin is drawing in his advance lines after three days of fighting. The Russians were compelled to disable six guns. Up to this date the Russian losses have been 1500.

St. Petersburg, August 29.—General Stoessel, commander at Port Arthur, reports that he believes the garrison may hold out for six weeks.

St. Petersburg, Aug. 30.—An imperial decree has been issued granting the Port Arthur garrison credit for a year's service for every month in which they hold out between May and the end of the year.

Harbin, August 29.—The Russian losses in the recent fighting against the Japanese advance on Liaoyang number 3,000 men. The Russians are evacuating Anping. They abandoned a quantity of stores. General Routokocsky was killed in the fighting. Kuropatkin's army numbers about 170,000 men.

Shanghai, Aug. 30.—The Russian warships have been disarmed.

Foreign.
London, Aug. 27.—The Dean of Rochester is dead.
New York, Aug. 27.—The Archbishop of Canterbury has arrived here from Canada.
Seattle, Aug. 28.—The Alaska cable has been completed.
Manila, P. I., Aug. 29.—Binang has been destroyed by fire in which 100 persons perished and 5,000 are rendered homeless. The loss is estimated at \$200,000.

CURRENCY FOR PANAMA.
Arrangements Concluded by Taft and Commissioners.
Washington, Aug. 13.—Secretary Taft and the commissioners for Panama have concluded arrangements for a currency system for Panama, which is to be submitted to the Panaman Legislature for ratification. The plan provides generally for a sufficiently reserved bimetallic system, by which the gold currency of the United States shall be legal tender in the canal zone. This agreement will be transmitted by the Panama commissioners to their government, and if adopted by the constitutional convention will settle the question of the currency to be used in the construction of the canal.

The substance of the agreement is that a gold dollar of the same value as that of the United States shall be the standard of value in Panama, and that the gold currency of the United States shall be legal tender there, with provision for the issuance of fractional silver currency of the republic of Panama. It is provided that such silver currency shall be coined to an amount in nominal value of \$1,500,000.
