"At the battle of Gettysburg a rifle

The Situation.

EDITOR BULLETIN:—

Since the vote of want of confi-
dence the streets have been hazy
with rumors of projected cabinets.
As usual the Reform party assumes
to itself all the credit of the change
in public affairs and report has it,
speaking of projected cabinets, that
this arrogant party proposes to pro-
ject on our unoffending public two
or three hidebound individuals who
falling of election at home went
elsewhere to secure seats. And these
are the men who representing a
minority sentiment where they re-
side are pushed ahead by their
servile party. If the Reform party
is in the ascendancy and if the re-
sults which lead to the formation of
a new cabinet are attributable solely
to its agency, it is but natural the
party should avail itself of its advan-
tages to place its own men in power.
Yet even so it is questionable policy
to foist upon the country men who
are representative of their party
only.

Now as this party cannot arrogate
to itself the entire credit of change
in the administration, let it be modest
enough to withdraw its claims to the
sole benefits of such change. Men
who represent the community in
which they live by an overwhelming
minority are not well calculated to
run the Government. And let the
Reform Party, which is but one factor
in the present political situation,
merely take its place as one factor
in the contemplated changes.

In every way the National Reform
Party has proven itself the cham-
pion of popular right. It can lay
equal claims to the accomplishment
of everything claimed by the Reform
Party, and it is not to be ignored to
facilitate the choice of a clique
whose ascendancy means allegiance
and subservience to party rather
than devotion to the general wel-

Tenders for the Purchase of Hawaiian Government Treasury Notes.

DEPARTMENT OF FINANCE, HONOLULU, H. I., Sept. 1, 1892.

Under authority of the Act approved August 20, 1892, the Minister of Finance offers at par Treasury Notes of the Hawaiian Government for \$50,000, in denominations of not less than \$500 or more than \$5,000, payable one-half in four months and the other half in eleven months from the first day of September, 1892.

Tenders for the above will be received at the Treasury up to the 23rd day of September, 1892, which tenders shall state the amount desired, and the interest which will be accepted by the person applying for same.

NOTICE TO MARINERS.

During the process of Deepening the Channel at the entrance to Honolulu harbor the Dredger will be in operation night and day.

At night there will be a Danger Signal placed on the forward derrick of Dredger, about 30 feet above sea level, which can be seen by all vessels approaching the harbor.

The Signal consists of 3 Red lights and a White light—as in the diagram—the red lights being about 3 feet apart, with the white light in the center.

All steamers crossing the Bar will stop at a safe distance from the Dredger and give one blast of their whistle, which will be answered by a single blast from the Dredger, to be followed by three blasts from the Dredger when the passage is clear and they can proceed.

The Tug will be on hand when not otherwise engaged to assist sailing craft in passing the Dredger when necessary.

Pledged to neither Sect nor Party, But Established for the Best of All.

SATURDAY, SEPT. 3, 1892.

Between letters on the lottery and the full reports of the queen's birthday celebration our columns are crowded to-day. There are more letters on the lottery on hand. Full discussion will tend to bring out the real nature of the lottery scheme. A cartoon in this issue gives one view of the matter, which we believe to be correct, as emphatically as would a column of words.

Mr. H. S. Townsend, of Lahaina, has a few pounds of imported sea-island cotton seed, which he would like to dispose of gratis to some person who is prepared to plant it on the windward side of one of the islands, near the sea, where the roots can reach brackish water. It is thought that under favorable conditions a superior article of cotton can be produced here, in which case there will be good money in it. The experiment is worth trying. The crop is a quick one, and the matter can be fairly decided in a few months. Mr. C. F. Horner is making the experiment on the leeward side at Lahaina.

An important notice from the Minister of Finance appears in this issue. It is a call for tenders for Treasury notes bearing interest not exceeding six percent, the notes being payable one-half in four months and the other half in eleven months from September 1, 1892. Tenders will be received at the Treasury up to the 20th inst. At this stage of each biennial period the Treasury is always run low, and this scheme for its replenishment affords an opportunity of a good investment to capitalists. The specific purpose of the Act under which these notes are issued is for the further protection of depositors in the Postal Savings Bank.

SUNDAY SERVICES.

SECOND CONGREGATION. 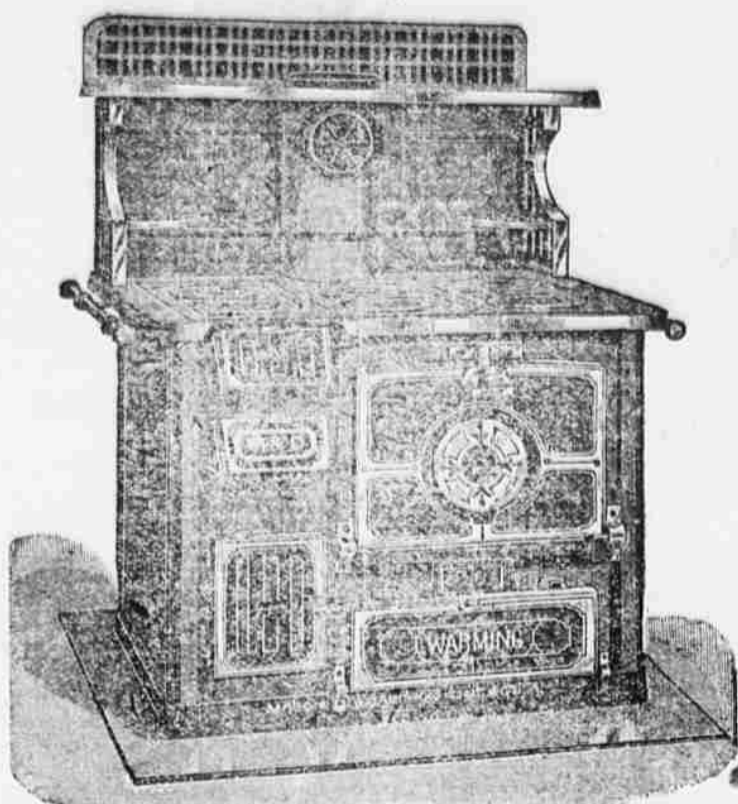

THE QUEEN'S BIRTHDAY.

Sundry Series of Celebration.

Her Majesty Gives a Full Day's Hospitalities.

Full Reports of the Events Royal and Popular.

Friday, September 2nd, was the fifty-fourth anniversary of the birth of Her Majesty Liliuokalani, Queen of the Hawaiian Islands. Besides a large series of events in celebration of the day under the auspices of the Queen, there was enough of outdoor pastime provided by private enterprise to make a successful holiday. Salutes were fired, morning, noon and night, by the U. S. S. Boston and the shore battery. Government, diplomatic and consular buildings had their respective flags flying; the Boston was fully dressed and the merchant shipping made a gay picture with their profusion of bunting. Below will be found records of the day's events.

Official Reception, Etc.

From 6 to 8 o'clock the Queen received the hookups (friendly gifts) of her subjects. Besides the usual gifts of four-footed and feathered creatures fit and fat for food, with varied tributes gathered from the vegetable kingdom, Her Majesty received some beautiful and rare works of artistic handicraft from her lady friends. The decoration of Knight Companion of the Order of the Crown of Hawaii was conferred on the following musicians of the Royal Band: D. Naone, S. Kamanao, J. Kuamoo, D. Kau, W. Aylett, R. Kapua, L. Pio, M. Kaulua, J. Pohinu and V. Keawe.

At 11 o'clock Her Majesty received in state in the throne room the dignitaries of the realm, diplomats and consuls, with their lady relatives, and Captain Wiltse and officers of the U. S. S. Boston. The autographs of visitors take several pages in the register.

The Queen's Luau.

At one o'clock people were gathering at the Palace, and continued to come for the next half hour, in response to invitations of Her Majesty for a luau. After a short wait the Queen sat on the throne, which was covered with a yellow feather cloak. She was dressed in black with a lei of flowers around her head. On her right were Prince Kawananakoa, Governor Rice of Kauai, Chief Justice Judd, their Excellencies Samuel Parker, H. A. Widemann and C. F. Spencer, and Hon. Justice R. F. Bickerton. On her left were Mrs. C. B. Wilson, Mrs. Widemann, Mrs. J. O. Carter and Mrs. Robertson. Major the Hon. J. W. Robertson, Chamberlain, and Her Majesty's staff ushered in the guests, who marched past the throne and bowed to the Queen, retiring to the sides of the room and to the hall when Her Majesty had acknowledged their respects. A goodly number of Privy Counsellors, members of the Legislature and officials, with ladies, led the way, followed by Captain Wiltse and officers of the U. S. S. Boston, and a large representation of the general public. As bodies Kawaiahaeo church choir, the United Chinese Society, a Portuguese society and other organizations passed before the throne.

At 1:50 Her Majesty and retinue rose and marched to the lanai in the yard on the King street side, where the luau was spread on tables capable of seating four or five hundred people. The band from the band stand accompanied the royal progress to the feast with Hawaii Pano. Following in the train the guests in general proceeded to the lanai, where the Chamberlain and a corps of native ladies with great celerity assigned them seats. At the head of a crescent-shaped table at the head of the lanai Her Majesty was seated. To her right were Prince Kawananakoa, Mrs. A. F. Judd, His Excellency Sam'l Parker, Mrs. H. A. Widemann, Hon. Chief Justice A. F. Judd, Mrs. Chas. Clark, Col. the Hon. W. H. Cornwell, Mrs. C. B. Wilson, His Excellency C. N. Spencer and Mrs. J. O. Carter. To the Queen's left were Captain Wiltse, Mrs. Sam'l Parker, His Excellency H. A. Widemann, Mrs. R. F. Bickerton, Mrs. J. W. Robertson and Hon. Justice Bickerton.

Three long tables extended from near the crescent to the foot of the lanai, the inner one being several yards shorter than those outside. At the projecting arms of the out-

side tables were seated members of the Privy Council and of the Legislature with ladies, among them Hon. and Mrs. S. M. Damon, Hon. and Mrs. J. T. Waterhouse, Jr., Hon. H. P. Baldwin, J. M. Horner, W. Y. Horner, D. W. Pua and A. S. Horner. All being seated Rev. J. Waiamau in Hawaiian invoked the divine blessing. Then the company fell to with a will on the sumptuous array of dishes cooked in the native style. The distinguished guests were privileged with knives, forks and spoons, while those at the lower tables were permitted to do ancient Hawaiian honors to the viands with Adam and Eve's meat hooks.

It was a cheerful company above the average of a mixed luau, as the guests being seated with good tact in groups of similar tongue, there was full scope for sociable chat. At the start the fusillade of popping soda and ginger ale corks by the hundred made a singular opening salute to Her Majesty. No sooner had the Queen and party withdrawn to the lawn, and the rest of the company risen, than the tables were all filled by fresh relays. But there was abundance for all.

The lanai was beautifully decorated. Stripes laid on diagonally of red, white and blue covered the trusses overhead. Around the sides the flags of various nations were draped, and festoons of vines and other greenery depended from the stringers. The band on the stand adjacent played in its best style throughout the feast.

Regatta in Town.

The races in the harbor under the auspices of the Healani and Kailani boat clubs commenced shortly after 9 o'clock. The attendance along the city front was not extra large, although the races were particularly good. The first event was a six-oared sliding seat race between the Healani's Carl W. and a Kailani crew in the Healani's Liliuokalani. The Carl W. maintained the lead to the finish easily. The pulling of the Healani crew was specially admired, the stroke being neat and clean. Time, 17min. 35sec.

The second race was to have been an interesting one between the boat boys and a crew from the U. S. S. Boston, but the latter failed to appear for some reason or other. The race was rowed by boat boys in the Kapiolani and Puaala, and was won by the former. Time, 20min. 5sec. A 5-paddle canoe race caused no little amusement. The course was to and around the can buoy off the Marine Railway. The Kakaako canoe covered the distance in 10min. 50sec.

A swimming race was won by Alapai, an old-timer, in 3min. 20sec. The course was about 500 yards.

The event of the day was the four-oared barge race between the Hanalei, manned by a crew from the U. S. S. Boston, and the Kuliakau, manned by the redoubtable boat boys, with Jack Atkinson at the tiller. The course was to and around the bell buoy and return. The Boston took the lead at the start and led the boat boys by a nose to the lighthouse, when they fell behind. The boat boys finished six lengths ahead, in the fast time of 30min. 31sec.

The judges were Lieut. Baird of the U. S. S. Boston and J. Simerson; starter, C. B. Wilson; time keepers, Frank J. Kruger and C. Crabbe. The tug Elou followed in the wake of the different events.

The Oahu Railway & Land Co. had planned a day's outing at the site of former pleasures, viz., the Peninsula at Pearl City and the surrounding waters of the Pearl Harbor lochs. Superintendent Ashley had made provision for the accommodation of a large number of spectators and the prizes offered by the company for sailing and rowing races were suggestive of many interesting events in the regatta sports.

The special train went to Pearl City from town here at 8:30 o'clock, conveying the race judges, Captain J. A. King of Wilder's S. S. Co. and Captain J. Griffiths of the barkentine S. G. Wilder, the official time-keepers and others; also the detail of officers, under Sergeant Kamanao of the police, whose presence, simply, was expected to aid the pleasures of the occasion, their services not being regarded as liable to be called upon.

Train after train went down to the Peninsula, the cars well filled with people who appreciated the opportunity given to obtain fresh life by the inhalation of the health-giving breezes that rippled the surface of the lakes of Pearl River and made an atmosphere pleasant to be in. Conductors Archie Turner and John Coakley, besides other train officials, were kind and obliging as usual, and their carefulness was evinced by the usual lack of accident of any kind among the ladies and children under their care.

At the lakeside the early arrival would have thought that the yacht races, at least, would be very interesting, the presence of all the first-

class yachts in the country tending to give that impression. The Spray and the Helene, it was true, had many of the fair sex on board and the Helene was dressed in true man-of-war style, flags fluttering aloft and aloft from stem to stern. It was thought, however, that the captains of both those yachts would easily clear decks for participation in the races when required. The Bonnie Dundee, Hawaii and Healani were in sailing trim and seemed to have racing crews on board, and as those latter three were maneuvered about the waters of the lake they presented an interesting sight and seemed as though taunting their less active sisters to also engage in the preliminary runs. So thus before the start it seemed that opportunity would be given the special correspondent of the BULLETIN to meet the detail expected to be filled and supply an account of a yacht race in which all of the first-class yachts would be "in it."

The firing of the warning gun, to get ready, brought forth the disappointing fact that only two of the five yachts present would take part as competitors, viz., the Bonnie Dundee and Hawaii, the others remaining out even after several concessions had been made. At 10 o'clock the signal gun was fired for the start, and both the yachts, Bonnie Dundee and Hawaii, ran past the line within a few seconds of each other, the Hawaii to windward.

A run of about five minutes was had when the Bonnie Dundee made a reach to endeavor to get to windward of the Hawaii and possibly to give a blanket to her close competitor. The captain of the Hawaii would not allow the maneuver, however, and he also hauled closer up. The jockeying thus commenced continued until the boats both reached the end of Ford's Island and then, from their courses, it was thought that both captains meant to carry their yachts to windward and run through that channel instead of running free as the wind and proper course permitted. The captain of the Bonnie Dundee had made an effort to pass to leeward, but was headed off again by a movement of the Hawaii. As a last resort seemingly, and although the windward shore was toward shoaling water, the Bonnie Dundee again hauled close up and slowly but surely crawled on her antagonist. The captain of the Hawaii, however, forced the contest for every foot of the way, the nose of his yacht being turned to windward in such a way that the extending shoal, which was approaching, could only be gotten over by the Bonnie Dundee on wheels. No quarter was given by the Hawaii and as a consequence at 10:14 the Bonnie Dundee put the greater portion of her length on a sand-spit, going on at about the rate of six knots an hour. The Hawaii did not hesitate now but quickly squared away for the free run, which had been open from the start and sailed along the course, the captain giving a backward glance at the stranded Scotch lassie probably to ascertain if wheels were going to be used or not. The steam yacht Annie, in which was Dr. Trousseau, the owner, and also the judges of the races, made fast to the shoaled yacht and endeavored to free her. It took an hour's labor before the yacht was got off and then she was sailed over the course. Protests have been entered by both boats, therefore no decision yet.

In the second class yacht race there were three competitors—Mr. Lyle's Edith L. (now changed from a cat-rig to a sloop), Mr. Dowsett's Kaohinani and a cutter from the Boston. The yachts got away well together but the race was won easily by the Kaohinani, the Boston second.

In the free-for-all yacht races there were four entries, but only three boats were regarded as at all in it, viz., the Hermit, sailed by Frank Johnson, the Sinnette by Dr. Henri McGrew, and the Ella by Hiel Kapu. These boats were not evenly matched, but no allowances were made. In points of difference the Sinnette was the better sailed, although the Hermit took the prize, the Ella third.

An interval was had at a little past noon, for refreshments. It was 1:45 before the noise of the gun, for assembly of the rowers in the first race, again woke the echoes, and soon thereafter the scarlet shirts of the Myrtles were visible in the vicinity of the company's bathhouse on the beach. The race was between two six-oared crews from the Myrtle Club, one in the Stranger, of goodly renown, and the other in the Alice M., often a winner. The race was in reality for a record, and the crew of the Alice M. were expected to make it. The start was had at 2:45, both boats getting away well, a 28 stroke being pulled by the Alice M., a quicker and less effective stroke by the Stranger. The course was three measured miles with one turn, and the distance was covered by the Alice M. in 20 minutes and 5 seconds. A spurt between the two

boats for about one hundred yards at the finish added interest to the race.

The next interesting event was a contest "for blood" between two four-oared crews of the Myrtles, the Alf. Rodgers and Alice M. being the boats entered. The Alf. Rodgers won by six boat lengths, in 22 minutes 34 seconds.

Superintendent Ashley added to the interest by the addition of a native canoe race, which afforded considerable amusement. The homeward tramp was taken up at a little past 4 o'clock, connection was made with the train and at a little past the pleased travelers and spectators of the regatta at Pearl Harbor were again landed within the confines of Honolulu.

Sons of St. George.

The Sons of St. George Lodge held a successful picnic at Remond Grove yesterday, beginning early in the forenoon and lasting till near midnight. At 3 o'clock in the afternoon dancing was commenced in the pavilion to music by a band of Portuguese musicians. At the same time sports were held in the grove. The first event, a 75-yard race for boys under 15 years, was run in three heats owing to the number of competitors present. The final was won by W. Lyceett, George Woods second. Time 10 sec.

The second event was a 75-yard handicap-race for children of members only. Harry Platt took first prize, F. Wright second. Time 12 sec.

A potato race for boys under 15 was a cause of merriment. W. Isaac finished, gathering up his allotment of potatoes first, with Hassinger a close second. Time 1 min. 16 sec.

The fourth race was for girls under 15, 75 yards. Marion Lovejoy secured first prize, L. Lyceett second. Time 14 seconds.

A 75-yard handicap egg and spoon race for boys under 15 years was gallantly won by B. Lemon, Rowcastle second. Time, 14 sec.

The girls had a similar race which was won by A. Lyceett, and Jennie Wright second. Time, 14 sec.

A potato race for girls under fifteen ended the sports for the day. M. Rawlins finished first, L. West second. Time 1 min. 17 sec.

The prizes were then awarded the different winners and all were happy. Those of the children who had not won prizes were given baseballs. Later in the evening more people arrived from town, making up for the early goers and keeping up the interest. Dancing was maintained with increased zest until 10:15 and the last train left half an hour later for town. All carried away recollections of a delightful outing and an evening party thoroughly enjoyed.

Struck by a Swing.

Capt. J. R. Robertson was struck across the nose by a swing board at Remond Grove last night, receiving a painful wound. Seven or eight persons were coming along in a group toward the swing, when Tommy Price, who was swinging, warned them to look out. Some ran back, others, including Capt. Robertson, forward, to get out of the way. The Captain miscalculated the distance and was struck down by the swing. He was stunned by the blow but soon recovered from the shock. Mr. Ashley immediately cut the swing away and said it should not be replaced in the range of the path.

The Lottery Franchise.

A Little Heroine.

Tillie told me the story of the battle in her naive and child-like way: "I went after the cows across the canyon the other evening and was returning up the trail toward home, and just as the cows were passing that rock," a quarter of a mile distant, "I heard a rattling noise and the cows got scared at it and ran all the way home and I went to see what it was, and just as I peeped under some brush I saw a big monster of a snake spring down from off the rock directly over my head. I dodged as quickly as I could, but felt the snake brush my shoulder as he passed over me. I got up and started to run, but the snake kept springing at me as fast as he could with its forked tongue darting out and its eyes flashing like fire, but I managed to get away. "I looked back and saw the mean thing coiled up in the trail so I could not go home. I called for papa, but he could not hear me and I began to cry, but I stopped crying as soon as I could, as it did not help me, and got a stick and went up to him to drive him away. His eyes looked so wicked and his mouth so cruel I was afraid to hit him and went and cried again until I was almost sick. When I got through crying I made up my mind I would kill that snake if he did not let me go home. I went and struck him with the stick, but it broke and the snake fought furiously. I got a stick and went back. He looked awfully wicked. I shut my eyes and came down with my stick with a whack and broke his back, and then I gave it to him good until he died. Look," said Tillie, holding up something in her hand, "these are his rattles, twenty of them, and here is a bottle of his oil we saved. 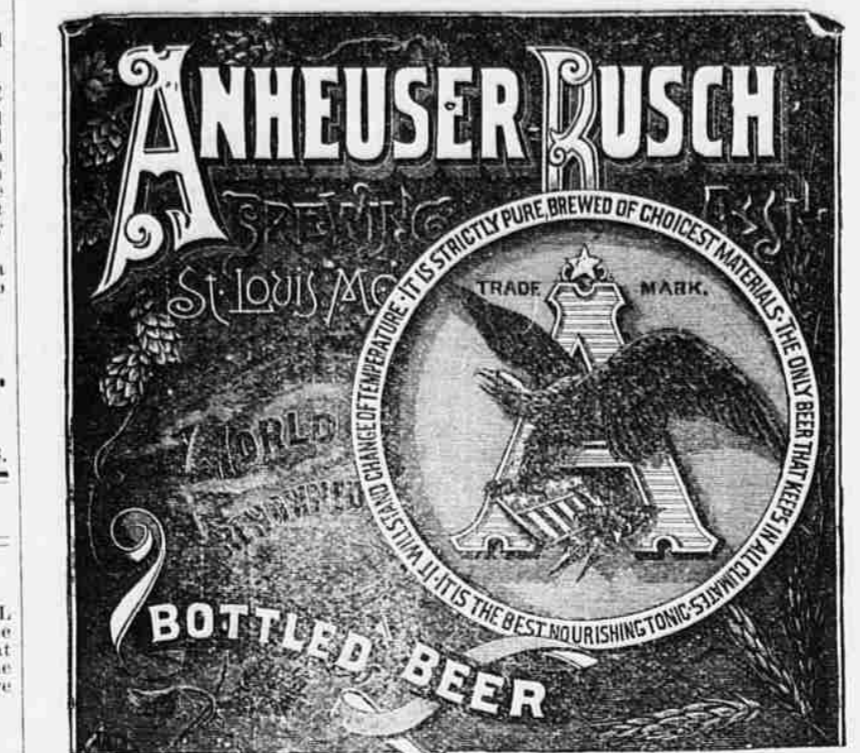
