NO CAUSE FOR KICKING.

There are kickers in every community and Honolulu can boast of a fair share of them. It is pleasing to THE INDEPENDENT, which never "kicks," to record any occasion where the "kickers" are at fault and their "kicks" not built on good or just basis.

When President Dole went away with a sack of \$10,000 of the taxpayers' money, the "kicker" was around and said, "beastly outrage; what are we to get for that money; what are we to gain?" etc., etc. Some of the most ardent annexationists were among the "high kickers," and Dole was scored, and his advisers and the Council of State, which allowed Mr. Damon \$10,000 to defray the expenses of the funny expedition.

The first despatches after his departure told us that Dole is traveling cheaply, and that he enjoyed a free passage from here to San Francisco, and from that city to Washington. As he has been dined and wined (beg pardon, lemonaded) since he landed in San Francisco, the "kickers" hoped that the \$10,000 would be returned intact to the Treasury—if not judiciously invested in the Riverside orange grove.

There is no fear, however, that such will be the case, and the taxpayers can rest assured, that they will get a quid pro quo for their money, even if it is not annexation.

According to the Evening Bulletin, the "Court organ" of Mr. Dole, the first investment made by the travelling party has been in clothing. The Mrs. President has had built a reception dress and a ball dress, which are dreams of "duchesses," "imperial," and "Marie Antoinette," words sounding rather peculiar to our democratic "kickers."

The Court organ does not print the clothing of the Mr. President, for which the taxpayers will pay, nor does it mention the costly gold-brick which we hear Mr. Iaukea, of many titles, has invested in.

The reception suit of Mr. Dole was made in the "Albert Edward Kash Emporium." It is composed of very handsome patent leather pump without handles (No. 13), a chapeau a la stovepipe (child's size). Low collar and starched shirt front with diamond studs (crown jewels), bicycle bloomers with stockings to match and shooting jacket a la Puuwaawaa.

The ball dress is partly made in Frisco and partly looted from the palace here. It is composed of a military helmet (formerly Kala-

kaus'), a feather cap (formerly Lunailo's), a dress coat ornamented with Hawaiian royal decorations, a toga (used when a Supreme Judge) regulation upturned trousers and hulabula footwear.

The uniforms of Chief Secretary Iaukea and Chief Physician Day are being daily changed as the outlook for the treaty goes, looking one day "territorial" and the other quite "monarchical."

The "kickers" ought to take a rest. Somebody is getting the moneys worth out of that paltry \$10,000, that some fools say are needed for schools, roads, wharves and other interior improvements in the Hawaiian Islands.

TOPICS OF THE DAY.

We are always told that we are extremely wrong when we accuse Mr. Dole and his government of nepotism and favoritism. If we could afford sufficient space, we could publish numerous instances bearing out our assertions. Let us enquire, as an example why it is that one government official can send in an application for a lease of a certain government land, and immediately have it put up at auction at his own terms and place, while another equally prominent official can apply for a lease of a government tract simply to be put off with frivolous excuses for seven long months, and then have to wait for the Legislature to bring the matter to a focus. If presidential patronage don't move the wheels of the land-office we are greatly mistaken. Any "commish" in it Mr. Riverside?

The manner in which Asiatic "slaves" are being carried in our inter-island steamers, should have the special attention of the Marshal, the Legislature and incidentally of the officers of the society for the protection of cruelty to "animals." The Japs recently sent to the other islands are packed in the steerage of the steamers as sardines in a box. Besides the sufferings to the slaves the steamship companies should consider the unspeakable nuisance to the ordinary passengers who patronize the boats, and the dangers which they incur by over-crowding. We hope the Legislature will pass an act regulating the carrying capacity of steamers as well as of trams. The other night 78 passengers boarded a car which left at 11:30 p. m. from the Chinese theatre bound for Waikiki, and drawn by two very tired mules. The car could probably carry 24 passengers comfortably.

The bicycle shops were happy yesterday, because the authorities had listened to the wise words of THE INDEPENDENT and allowed them to keep their shops open and rent their wheels. While we feel glad for the stores which benefitted by this action on the part of the authorities, we cannot approve of the policy of the Marshal. If there is a law in our statutes, which provides certain regulations for work to be done or not done on Sundays, its provisions should be carried out until the law is repealed. The Marshal a week ago, claimed that a certain law prohibited the business of the bicycle shops on Sundays, and he ordered them closed. Yesterday he adopted a different view and construction of the law, and allowed the shops to keep open. All liberal minded people in the community want the present obnoxious Sunday laws changed or repealed; not by Marshal Brown, however, but by the Legislature.

Cottage on Queen Dowager's Premises Burnt Down.

The house, which was very old, was in flames before any furniture could be saved, and as there is no insurance on building or furniture, the owner and tenant are both losers.

The uniforms of Chief Secretary Iaukea and Chief Physician Day are being daily changed as the outlook for the treaty goes, looking one day "territorial" and the other quite "monarchical."

The "kickers" ought to take a rest. Somebody is getting the moneys worth out of that paltry \$10,000, that some fools say are needed for schools, roads, wharves and other interior improvements in the Hawaiian Islands.

TOPICS OF THE DAY.

We are always told that we are extremely wrong when we accuse Mr. Dole and his government of nepotism and favoritism. If we could afford sufficient space, we could publish numerous instances bearing out our assertions. Let us enquire, as an example why it is that one government official can send in an application for a lease of a certain government land, and immediately have it put up at auction at his own terms and place, while another equally prominent official can apply for a lease of a government tract simply to be put off with frivolous excuses for seven long months, and then have to wait for the Legislature to bring the matter to a focus. If presidential patronage don't move the wheels of the land-office we are greatly mistaken. Any "commish" in it Mr. Riverside?

The manner in which Asiatic "slaves" are being carried in our inter-island steamers, should have the special attention of the Marshal, the Legislature and incidentally of the officers of the society for the protection of cruelty to "animals." The Japs recently sent to the other islands are packed in the steerage of the steamers as sardines in a box. Besides the sufferings to the slaves the steamship companies should consider the unspeakable nuisance to the ordinary passengers who patronize the boats, and the dangers which they incur by over-crowding. We hope the Legislature will pass an act regulating the carrying capacity of steamers as well as of tram-cars. The other night 78 passengers boarded a car which left at 11:30 p. m. from the Chinese theatre bound for Waikiki, and drawn by two very tired mules. The car could probably carry 24 passengers comfortably.

The bicycle shops were happy yesterday, because the authorities had listened to the wise words of THE INDEPENDENT and allowed them to keep their shops open and rent their wheels. While we feel glad for the stores which benefitted by this action on the part of the authorities, we cannot approve of the policy of the Marshal. If there is a law in our statutes, which provides certain regulations for work to be done or not done on Sundays, its provisions should be carried out until the law is repealed. The Marshal a week ago, claimed that a certain law prohibited the business of the bicycle shops on Sundays, and he ordered them closed. Yesterday he adopted a different view and construction of the law, and allowed the shops to keep open. All liberal minded people in the community want the present obnoxious Sunday laws changed or repealed; not by Marshal Brown, however, but by the Legislature.
