TOOK HIS OWN LIFE

FREDERICK ANDRECHT SHOOTS AND KILLS HIMSELF.

Claimed Kauai Plantation Was Indebted to Him in Sum of \$300 Which He Could Not Collect.

Frederick Andrecht, a German aged 68 years, committed suicide some time last night by shooting himself in the forehead, in the lodging house of Albert Kaus in Kakaako. The body was not discovered until this morning. Dependence over business troubles is thought to have led the man to take his life. Andrecht came here about a month ago from a Kauai plantation where he had been employed. He had stowed up with Albert Kaus during the past two weeks. Andrecht claimed that the plantation people were indebted to him for \$300 for some sort of work performed for them. For some reason, this money had not been paid him and he had said that he intended going to see Mr. Hackfeld the German consul to enlist his aid in getting the money. Andrecht is said to have threatened on Saturday that if his claim was not speedily settled he would commit suicide.

No one at the Kaus place had any well defined idea as to Andrecht's movements before he retired to his room. Evidently he shot himself about 3 o'clock last night for a shot was heard from that quarter about that hour. The only other person in the house at the time was Mrs. Johanna Kaus who is deaf and unable to hear the report of a pistol. She found the remains of Andrecht this morning, as they lay on the bed. He had used an old fashion single action pistol of about 28 caliber. The muzzle had been placed against his forehead and he had blown a large hole in his head, death evidently resulting instantly. Life had been extinct for hours before the body was found.

The deceased leaves a widow, two daughters and a son living at Makawili plantation. An inquest was held today at noon by Deputy High Sheriff Chillingworth. The coroner's jury returned a verdict of death by suicide. The evidence went to show that the reported story of the plantation having owed the deceased money, was incorrect and domestic troubles are thought to have been the cause for his act. He was employed as a night watchman. His name is thought to have been F. Andrecht, instead of F. Andre as was first reported to the police.

LEGISLATION NOMINEES.

Hilo Home Rulers Name Members of Other Parties.

Hilo Home Rulers have already nominated their legislative candidate for the next campaign. They held a convention last Thursday. Nominees for the Senate were Rev. S. L. DeSha, John T. Baker, R. H. Makekai, I. K. Lalakea, J. D. Faria, Palmer Wood, A. E. Loebenstein, J. Palau, H. S. Rickard and Sam Kaunane.

After a number of ballots had been taken John T. Baker and Palmer Wood were chosen. Baker is a well known Republican and Wood is said to be a Democrat. Wood was a Democratic candidate in the last election.

For the House the following were the nominations: J. N. Kamoku, David Ewaliko, William Naillima, R. H. Makekai, H. S. Rickard, M. K. Koalawa, J. K. Paahan, J. Matooan and David Kellipio.

J. N. Kamoku, David Ewaliko, William Naillima and David Kellipio were chosen. Kamoku and Kellipio are members of the Hawaiian Republican Club of Hilo.

HEALTH CONDITIONS

APRIL REPORTS ARE UNUSUALLY GOOD.

Government Physicians Generally Report Excellent Health Conditions Throughout the Islands.

"Nothing to recommend, health conditions excellent," is the general report of physicians from all over the islands, just received by the Board of Health, made up the best general showing that has been made for many months, there being no serious sickness reported from any district. To the question "is consumption increasing in your district?" the physicians answer "No" in all but two cases. Dr. H. Wood of Waialua, Oahu, reports in the affirmative and Dr. W. P. McConkey of Makawao, Maui, says "slightly." Dr. Wood remarks however, that the conditions in his district are exceptionally good, and that there "have been no deaths for over 50 days."

In Hana, Maui, Dr. R. J. McGeigan reports having treated 45 cases of cholera infantum. There was only one death, however. The doctor says that the cases were probably caused by the extreme humidity of the atmosphere, following the long wet spell. With these exceptions, throughout a long table made up by Registrar Henderson of the Board of Health, the reports are of good conditions, with no dangerous diseases during the month, and nothing to be recommended. The doctors are required to answer a number of inquiries every month, as to infectious diseases, malarial fevers, etc.

"The report is a better one as a whole than usual," said Dr. Pratt, executive officer of the board, "and it makes a showing of improved health conditions throughout the Territory generally."

SET THE SCOW ADRIFT

THIEVES STEAL THE ROPES FROM DREDGER LIGHTER.

Thought to be Work of Japanese Fishermen—Scow Discovered Stranded on Beach at Puuloa.

The dredging contractors at Pearl Harbor have suffered a serious loss at the hands of some thieves, thought to be some of the Japanese fishermen who frequent the lochs. All the lines and the machinery of one of their heavy lighters were taken by the thieves and the valuable scow itself left adrift at the mercy of wind and waves.

The theft occurred when the force was absent from the lochs and the scows were as usual, during the off hours, securely tied up to the wharf of the salt warehouse. A large quantity of valuable rope was annexed and a shear was taken but, not content with acquiring the coils that were lying loosely around, the plunderers were desirous of taking the line that fastened the scow and accordingly cast it adrift after making off with the rope. With an ordinary wind the lighter would have blown out to sea and have been a complete loss. Fortunately a southerly wind helped to keep it along shore and, after scraping along the reef and the shark pen, the scow stranded on the beach at Puuloa where it was discovered by the returning dredgers.

The matter has been reported to the police who are investigating. There have been a number of thefts more or less petty in that neighborhood of late and suspicion points to the Japanese fishermen. The peninsula of Puuloa is practically inaccessible except by water and it is believed that the Japanese loaded the stolen property in their sampans having made the trip deliberately with that purpose. In the interests of property owners who are commencing to build a thorough investigation is to be made and the offenders, if caught, will be rigorously dealt with.

LAND LEASE SOLD.

Land Commissioner Boyd on Saturday sold a land lease at public auction. The Peenicko Sugar Co. bought the Kaunakua lease, for which it made application some time ago. The lease is for 210 acres for five years and was sold for \$600 per year.

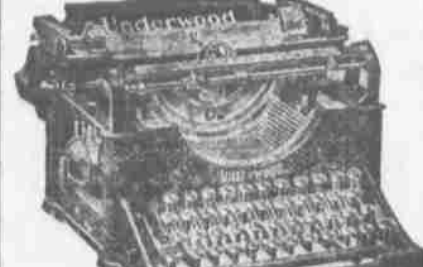

APPOINTED A TRUSTEE

NICHOLS BEFORE REFEREE IN BANKRUPTCY.

May Be Breakers Ahead For the Petitioner Before He Secures a Discharge.

H. T. Marsh was appointed trustee at a meeting attended by the creditors of A. E. Nichols presided over by W. S. Fleming, Referee in Bankruptcy and held in the rooms of that attorney this morning at nine o'clock. His appointment will be made out today, he being required to furnish a bond of \$1500 to cover the known assets of \$1460.50. The following creditors were represented at the meeting and voted on the appointment of a trustee: The Honolulu Burying Company, \$250; M. Whitney, \$118.80; Emerald & Co., \$7.25; and the Hawaiian Paper Co., \$67.30, represented by W. L. Whitney, Whitney and Marsh, \$1270.15; Hawaiian Supply Co., \$19.98; and the California Feed Company Ltd., \$75.50, represented by H. T. Marsh. C. S. Dale proposed the name of Wade Warren Thayer as trustee. H. T. Marsh being already proposed by W. L. Whitney, Mr. Dale's nomination was disallowed, his claims not having yet been filed. A. A. Wilder then nominated Mr. Thayer. On votes being taken, Mr. Marsh voting for himself, H. T. Marsh was duly appointed trustee. Others present during the meeting were A. E. Nichols, C. F. Schermerhorn, P. L. Weaver and A. Lewis.

A. A. Wilder was the only one to question the applicant for a discharge in bankruptcy, which he did to the following effect: "Have you not an interest in a piece of land mortgaged to the Queen's Hospital?" "No," you did have?" "Yes." "What became of your equity in redemption?" "I sold it to George A. Howard and through him to my wife." "For what consideration?" "I do not remember." "Was there any consideration?" "Yes." "Was it a hundred or a thousand dollars, approximately?" "About a thousand, for money previously advanced." "When was the transfer made?" "I do not remember, the end of 1900 or the beginning of 1901. It is a matter of record." "This money was advanced prior to the mortgage?" "Both prior and afterwards." "Was there any consideration named in the papers drawn up?" "What I believe." "What was done with the money advanced by Mrs. Nichols?" "It was used for improvements on the property to a partial amount." "Which then belonged to her?" "Yes after the transfer was completed."

"If this is going to be a lengthy session Mr. Wilder, I will adjourn the session and obtain a stenographer," said the referee. "I am through," replied the attorney and the others present stated their non desire to ask further questions.

The presence of A. Lewis appearing for the Harrison Mill Co., creditors for \$8,000 and the attendance of Arthur Wilder and C. S. Dale was thought to be significant of a fight that will be made against the discharge of A. E. Nichols. The Harrison Mill Company's account is for material in building the Metropole building on Alakea street, to erect which a company was formed some time since with A. E. Nichols and Dr. Howard as promoters. Dr. Howard is one of the creditors for a claim of some thing like \$500. The stock owned by A. E. Nichols in the Metropole building as well as other stocks and securities belonging to him are said to have been made over to his wife and it is along this line that probable fight will be made.

H. T. Marsh the trustee is secretary of Whitney and Marsh, who are large creditors. He is also a creditor himself to the amount of \$10.80 in his capacity of president of the Hawaiian Supply Company. He is a personal friend of A. E. Nichols and lives in the same house. J. Day and Company presented a claim at the close of the meeting. Claims may be filed any time within one year but the referee requested that all claims might be filed within thirty days to facilitate proceedings. All creditors are entitled to a rehearing when the matter is brought up in court, the referee being an aid to the court in the summing up of the matter and making a preliminary report upon the same. Considerable comment was made after the meeting by some of the creditors as to the disappearance of assets of a man whose credit was sufficiently good to have the Harrison Mill Company and other concerns allow him to run up amounts to several thousand dollars in extent.

PEARL HARBOR SUITS

DUNNE TO FIGHT THE CASES IN SAN FRANCISCO.

Bishop Estate's Appeal and the Appeal By the Government in Honolulu Plantation Company's Case.

Assistant United States Attorney J. J. Dunne has received a letter from the Solicitor General and Acting Attorney General of the United States giving further instructions in the matter of the Pearl Harbor suits. The Honolulu Plantation Company case and the Bishop Estate case will both have to be fought out in the Ninth Circuit Court of Appeals, at San Francisco, and Dunne is instructed to prepare to go and represent the United States. The letter of instruction is as follows: "J. J. Dunne, Esq., Asst. U. S. Attorney, Honolulu, H. I."

"Sir:—Your several letters in relation to the trial of the cases growing out of condemnation proceedings for the acquisition of land at Pearl Harbor for naval station purposes were duly received, and have had consideration. I note that an appeal to the Circuit Court of Appeals has been taken in the case of the Bishop Estate. I am also in receipt of a request from the Secretary of the Navy that an appeal shall be taken to that court in the second case which was decided adversely to the Government. Inasmuch as the case was in your personal charge, and the United States Attorney concurs in your report thereon, I write to you direct to instruct you, in accordance with the Secretary's letter, to take proper steps to have the case reviewed by the Circuit Court of Appeals. You are also instructed—the United States Attorney, as I understand, consenting—to represent the Government in these cases in the Circuit Court of Appeals at San Francisco.

"In order that you may know when the Bishop case will come on for hearing, I have today instructed the United States Attorney at San Francisco to write you at once advising you of the status of the case upon the docket, and when it will be reached for hearing. If possible, you will please arrange so as to have both cases come on for hearing about the same time, thereby avoiding the necessity of a second trip to San Francisco.

"Please acknowledge receipt of these instructions. Respectfully, "J. E. RICHARDS, "Acting Attorney General."

SALVATION ARMY TOUR.

An inspection tour of the work done by the Salvation Army on the island of Maui will be made by Major Wood who leaves on the Kinohi tomorrow for that purpose. Meetings will be held at Lahaina where the major will land, on Tuesday night, at Waiehe, Hamakua, and Wailuku. The major returns from Kahului on the Claudine next Saturday.

THE EXPOSITION.

Meeting to Be Called on Maui to Discuss It.

A meeting is to be called on Maui in the near future to discuss the matter of arranging an exhibit at the Louisiana Purchase Exposition. The following letter from the Acting Governor has been received by Sheriff Baldwin, who will call the meeting: "L. M. Baldwin, Esq., Sheriff of Maui. "Sir:—At a meeting of the temporary committee, formed for the purpose of securing a participation of the Territory of Hawaii in the Louisiana Purchase Exposition at St. Louis, held on Friday, May 9th, it was unanimously voted to extend an invitation to the island of Maui to nominate three persons to become members of the permanent committee, and I address you upon the subject suggesting that a meeting be called for the purpose of selecting the nominees.

"An early response is requested so that a permanent organization may be effected. "I am, very respectfully yours, "HENRY E. COOPER, "Chairman Temporary Committee."

TWO MEN SENTENCED

CHINESE AND JAPANESE ROBBERS SENT UP.

The Jap Asks the Court to Send Him to Japan to Care For His Parents—Light Sentences For Robbers.

Ah Wa and Nishiyama, the Chinese and Japanese who were found guilty of robbery last week, were up for sentence this morning before Judge Robinson. The Chinese got five years and the Jap three years, at hard labor. Ah Wa and Nishiyama held up a Japanese woman at Iwilei, in her own home, robbing her of \$20 at the point of a pistol. Ah Wa had the weapon and was therefore given the heavier sentence. He also carried a police badge which he displayed with a view to frightening the victim of the robbery. For these reasons Judge Robinson thought that Ah Wa ought to be more heavily punished than Nishiyama.

When Nishiyama was called up for sentence he asked to be transported to Japan. He stated that if he was guilty as the jury had decided he would like to be sent home. His parents were old and feeble and he would like to be able to help and support them. Judge Robinson said that the court had no power to order him transported and that it was a matter for executive agency after the sentence. Nishiyama then asked his attorney, S. F. Chillingworth, to see Acting Governor Cooper and ask him to issue a pardon. Ah Wa declared that he was innocent, in spite of the jury's verdict.

The offense of which the defendants were found guilty is robbery in the first degree. The penal code provides a maximum sentence of life imprisonment for this offense, so that both the Chinese and the Jap got off easily.

JAPANESE ARE LEAVING

RECRUITING AGENTS HERE FROM THE COAST.

Laborers From Hawaii Wanted for California Orchards—Procurers at Work in Iwilei.

The Hawaii Shipho has the following in its last issue: "Lately almost every steamer for the coast carries away a large number of Japanese laborers from here. They are said to be pre-engaged to work in California orchards, beet fields or on railroads. Several recruiting agents now in the city are offering every inducement for them to migrate. We hope the condition on the opposite side is all that is pictured by these gentlemen, and our honest, yet too frivolous, working men shall be well contented. Our migrating regarding this new move of our laborers is probably due to the fact that the recent most deplorable ending of the laborers shipped to a Mexican coal mine by a certain immigration company is yet too fresh in our mind.

"As a side issue, we are told, these recruiting agents are sprouting away a number of the late inmates of the Iwilei stockade in that same direction, for which we offer no objection, provided that they will present them with a vote of thanks for the service. It is said by a good authority, the keepers of brothels in the other side offer as high as five hundred dollars to their agent as the commission for strangling a girl into their abode."

AERONAUTS' TROUBLES.

Leonard's Balloon Goes Up Unexpectedly.

Prof. Leonard made another attempt to go up in his balloon last Tuesday afternoon in Hilo, but when the canvas was nearly full someone pushed over a support and the helpers were powerless to hold the big bag. It shot up into the air about 1000 feet and then sailed in the direction of Puuloa, landing on the bank of the Wailuku. A Japanese became entangled in one of the ropes when the balloon broke away and it looked for a time as though he would make a journey heels up. When the Professor recovered his balloon he addressed the crowd saying that the disappointments met with in Hilo were through no fault of his, a cord that he would give an ascension before leaving Hilo, so that those who paid their admission to the park last Saturday would get their money's worth if it was possible to give it to them.

A third trial was set for 5 p. m. Wednesday but the wind was too strong for the aeronaut to venture up.

STEWART MAY RUN

McCANTS AND HIS "OUT OF POLITICS" LETTER.

Ex-Central Committeeman From Kailhi Said to Harbor Ambition to Be a Legislator.

McCants Stewart "out of politics" is a mystery to the politicians, and his letter of resignation addressed to Chairman Kennedy of the central committee is the subject of much discussion. Stewart has ever seemed to take to politics as a duck to water, and he is the last man who was expected to resign. As if a preparation for a reappearance in a new role is a question which some of the knowing ones are discussing. When a man who has had a good deal of success in the fights he has taken up and who has shown unusual interest in every political move suddenly says he is "out of politics," the politicians usually begin to speculate on motives. In the case of McCants it is said that he has legislative ambitions, and perhaps when the fall comes, instead of being a committeeman and managing the campaign for others, he will appear in the role of a candidate for the Senate or House.

Stewart, however, insists that he is ready out of the game, and intends to stay out for a while. He has not sworn that he won't go into politics again some time, however, and is at liberty to make another start any time. His letter of resignation only says he wants to retire from politics "for the present."

The meetings of the central committee will seem very quiet without Stewart," said one of those who have been wont to listen to his eloquence. "They are also likely to be much more quiet, for the member from Kailhi did not spare time or words."

Stewart was ever productive of resolutions, suggestions and controversies. He usually had a Cushing's manual with him if any other member opposed his idea of rule of order, the authority was promptly brought out to crush the rash opponent. Even the chairman had to listen to Stewart's Cushing, and it seemed that during meetings the man from Kailhi whiled away many an hour by getting rules ready and preparing other business for the next meeting.

Now he is suddenly "out of politics" and the men who are left in can scarcely believe it. In the midst of a contest over primary rules, in which Stewart led the successful faction, he has suddenly disappeared. "It is an 'out of politics' letter, and it is a mystery," said one of those who should shake their heads and say "wait till the time for nominations comes."

BANKRUPTCY CASE.

Judge Esteo this morning approved trustee Wunderberg's sale of property in the matter of the P. J. Voeller bankruptcy. The bankruptcy case of K. Taketa was postponed for one week.

EXECUTIVE COUNCIL.

The Executive Council met this morning. The session was devoted to discussion of routine matters and some questions to be submitted to the Attorney General.

INQUEST ON MOLOKAI.

The result of the coroner's inquest into the cause of the death of Keahi Uia who died this month from the effects of a gunshot wound received while hunting, was received today by High Sheriff Brown. The deceased was shot in the ankle by a gun which was carried by S. K. Kekahuna, a school teacher, being accidentally discharged. A verdict of accidental death was returned.

PERU BRINGS NEXT MAIL.

AMERICAN MARU THIS WEEK.

The American Maru will be three days late in reaching here from the Orient. Figuring that she runs a day ahead of her regular schedule, she should be sighted on Wednesday, May 21. She will probably leave for San Francisco, within a few hours after reaching Honolulu.

ALAMEDA FOR THE COAST.

The Alameda will sail at 10 o'clock Wednesday morning, for San Francisco. She will take a large crowd of passengers, among them being R. O. Yardley, the former artist of the Advertiser.

RAPID LOADING.

The record day for loading sugar in Hilo harbor was made last Wednesday when 10,487 bags were transferred from the warehouses to the capacious hold of the Alaskan in one day by one gang of men—Hilo Tribune.

WIRELESS TELEGRAPHY.

The U. S. Army to Establish a System in Alaska.

WASHINGTON, May 7.—An object lesson in the progress made by the world in the development of wireless telegraphy was furnished yesterday in the office of Brigadier General A. W. Greely, chief signal officer of the army, where bids for establishing a system in Alaska were opened.

Five proposals were received, and another from the Sigsbee-Arcos Company is on its way to Washington. These were the bidders: Queen & Co., of Philadelphia, for Professor Fessenden, who with Professor Moore has developed a system of wireless telegraphy for the Weather Bureau; Roote, Pierson & Co., of New York; Marconi Company, of London, England, which has a branch house in

America; American Wireless Telegraph and Telephone Company of Philadelphia; De Forest Wireless Telegraph Company, of New York.

The bids were received and opened in accordance with an advertisement issued by General Greely, who invited proposals for "furnishing and installing a complete system of wireless telegraphy in the Territory of Alaska. General Greely required bidders, before the contract was awarded, to demonstrate their ability to transmit legible records for two consecutive days at a distance of sixty miles and before acceptance each separate system would be required to work satisfactorily for not less than ten consecutive days. General Greely expressed gratification at the number of proposals received. He says he will refer them to a board of examination of the systems and a report.

FOURTH HILO'S DAY

DISCUSSION OF THE HONOLULU FIESTA.

Hilo Will Celebrate Herself on the Fourth—Hawaii's Commercial Independence of Oahu.

A Fourth of July fiesta in Honolulu does not seem to meet with Hilo approval, though the general idea of a fiesta is endorsed both in Hilo and on Maui. Hilo wants her own Fourth, however, and is making preparations for a big celebration. The Fourth has come to be regarded as Hilo's day, and the rainy city doesn't propose to have Honolulu cutting in. The Herald says:

"Honolulu has a laudable ambition in announcing preparations for a Merchants' Day at the fair to be given in that city July 4th next, the idea being to have the merchants from all the islands gather there and incidentally, it is presumed, examine the wares of the dealers. This would no doubt be advantageous to all Honolulu storekeepers, provided, however, they can arrange prices of transportation so that the goods may be landed in Hilo in competition with San Francisco. To have a base of supplies nearer home is a commendable object to be wished for by every dealer in Hilo. But in the limited transportation facilities, such as now exist, and high freight rates between Honolulu and the other islands, the Honolulu merchant finds obstacles in his way of holding the same volume of Hilo trade as formerly. Coast merchants see the advantages of quick and rapid communication between San Francisco and Hilo and the steamer Enterprise is the result. If the merchants of Honolulu were as keen of foresight the means of transportation between Honolulu and this side of Hawaii would not be limited to one line of steamers. In the old days the demands of Hilo were not so great but what a single sailing vessel could carry all goods brought on the coast, now six sailing vessels and one steamer are required. It is reasonable to suppose that, under favorable circumstances a smaller fleet would answer for coast business while the Honolulu fleet would have been proportionately large. The opportunity is still here and it remains for the Chamber of Commerce of Honolulu to grasp it. Within the last sixty days nearly \$30,000 worth of goods was sold by coast representatives in Honolulu to one store in this district and the goods were shipped direct from the coast. Honolulu might have had the order. By referring to Merchants' Day on the Fourth of July: Is it not generally understood that Hilo celebrates the day and Honolulu June 11?"

"The Fourth of July is a day of big preparations for the Fourth in Hilo and says: "The Agricultural Fair to be held in Honolulu the third week in July, should be participated in by the farmers of this island. No doubt they would come home laden with blue ribbons and diplomas, thus further establishing the supremacy of the Big Island. The Merchants' Week at Honolulu during the Fourth of July week, will not attract so many visitors from this island as it would, had it been held at a more propitious time. Hilo will have Berger's band and a glorious celebration on hand. But this need not prevent Hilo and Hawaiian merchants from having representatives at the Merchants' Fiesta. If Honolulu has benefited in the way of prices and goods for the merchants of this city it is to Hilo's interest to take advantage of them. However it is plain enough that to the independent merchant Honolulu cannot compete in prices with mainland houses, since the Enterprise came with quick connection.

"Hawaii will never cease to be sociable with Oahu and take all the diplomas she may hang up. But our commercial independence cannot be ejailed by 'fiesta.'"

The Maui News has the following: "Honolulu deserves credit and generous support from all the other islands, in its effort to give an agricultural, mechanical and mercantile fair in July. While Honolulu will be primarily benefited, still such a fair will be largely educational in its tendencies, and the visitors will bring away rich results in enlarged views of the industrial possibilities and future of the islands, which will much more than compensate them for the cost of the trip. Let every one who can, make it a point to go."

MR. MATHEWS' WORK.

How He is Performing Cures on Outside Islands.

LAHAINA, May 17.—St. John James Mathews, the pastor of the Christian Congregations at Lahaina and on Lanai is now on duty at the wireless telegraph office in Lahaina. At present no public business is being transacted, but it is hoped that he will be recognized soon.

Mr. Mathews was formerly a pupil at the government school in Honolulu, and afterwards studied in Honolulu. He says that his church is in no way connected with the Christian (Campbellite) churches, nor is it closely affiliated with the Christian Scientist movement inaugurated by Mrs. Eddy. Mathews positively affirms that he has performed many cures, using only the Bible as a text-book. He denies the reports that have been published as to religious fanaticism on Lanai. Everywhere on that island, good order prevails. Mr. Mathews will probably preach on Lanai every Sunday, and hold week day meetings at Lahaina. He claims that two-thirds of the natives on Lanai accept his doctrines.

Rev. Mr. Emerson of Honolulu returned from Lanai a few days ago, and he confirms the statement that tranquility prevails. He has instructed Rev. S. Kapu of Lahaina to visit the Lanai Hawaiians occasionally; and he hopes that the natives will all renounce the new teaching, and renew their allegiance to the Congregational church. It is stated that a kahuna, or prophetess, gained complete control of the Lanai natives, ten or twelve years ago. Her treatment proved fatal to a child. Several of her followers were sentenced to long imprisonment in Honolulu.

On Saturday morning the steamer Kinau landed the property of a merry-go-round company from Hilo. It is expected that Major Wood of the Salvation Army will hold a farewell service next Tuesday evening.

The new stock dividend of the Lahaina Ice Company for April 1-3 per cent, has been paid to the stockholders.

A concert will be given at the Wainee church on June 11, and the proceeds will be added to the Sunday school convention fund.

THREE AUTHORS GONE.

Quite recently three prominent literary men of our country have been removed by the unerring and merciless hand of death. First there was Frank Stockton who died a few weeks ago, and then last Thursday's mail brought us news of Bret Harte's death and of Paul Leicester Ford's murder. They were of essentially different types, but each had had a distinct influence not only in his own country but wherever the English language was spoken.

When death struck Stockton he was still producing, and his latest work is supposed to be in such shape that it can appear in posthumous form. There is always something sad in reaching the unfinished work of an active mind. No one can read Dickens' unfinished "Edwin Wood," or Butler Lytton's "The Parisians" without experiencing the feeling of sadness inherent in life. The minds of the authors were clear and distinct. They knew in what direction the story would go and the lesson that should be taught and emphasized as the closing paragraphs would be written. We may guess them, but how bald and commonplace is our guess, compared with what would have been the brilliant climax which each of these writers would have concluded.

Stockton's forte lay in humor of a subtle, not of a broad kind, and in the occasional presentation of a dilemma which he left the reading world to solve. Of the former class Rudyard Kipling, Mrs. Alshine and dozens of similar stories belong. Of the latter the most famous is "The Lady of the Tiger." No one has ever decided which door was opened. Mr. Stockton was also successful in some children's books. His "Adventures of Captain Horn" can certainly be classed with Stevenson's "Treasure Island." It is as thrilling, and it contains some admirable character sketches. Stockton made the English speaking world laugh in honest, hearty tones. There never was any harshness in his mirth. And to lose such a man was a loss to literature and to the world.

Bret Harte's career had practically closed years ago. Not that he did not write, but he ceased to create. He had for the past twenty years been simply refreshing the puppets of his brain and moving them about from one part of the Sierras to another. But what a vein Bret Harte had struck in the seventies, how he showed to the world in his short stories when they seemed fresh from his pen how rich a field there was in the country. What humor and what pathos could be found in the miner's cabin, in the bars and in the gambling saloons even. Every thing that he had seen in this way he laid under contribution, and he put his characters amid the most romantic and yet exhilarating of scenery. One could hear the roar of the waterfall, the tinkle of the mountain streams, smell the aroma of the pines and the redwoods, shudder over the deep abysses, the gloomy canyons and shiver at the snow storms that covered everything with their white pall, and unafraid and sterner in one last, long sleep.

No one can forget how in the early seventies the "Luck of Roaring Camp," "Miss," "The Exiles of Poker Flat," "Tennessee's Partner" and others created just as much of a furor as Kipling's "Soldiers Three" did a decade or so ago. Bret Harte has left his mark and a distinctive one upon our literature, he had a path which many have followed. They have looked for material at home and not abroad.

It is in Paul Leicester Ford it is that our literature has suffered the most serious loss. He was suddenly cut off by violence when he had established his reputation and could have put forth thoughts of value, and sketches of absolutely historical accuracy. His "Honorable Peter Stirling" is one of the finest studies of character extant, and the knowledge of politics and their manipulation which it displayed was wonderful, especially when one knows what kind of man Ford was personally. On the other hand his "Janice Meredith" was far superior to the average historical novel, as called. Ford was not a man who had to "read up." He was like Walter Scott, he knew. He might have to search up episodes, for greater accuracy, but the ramifications of our colonial and early federal history were stored in his brain. In him there has been a distinct loss, and one not easy to replace.

If we have been progressing commercially and industrially, we have also been progressing with wonderful success in literature. Though the immense output of books which come from our presses contains much that is ephemeral, much that is worthless, there is a solid residue which will live long after the authors have passed away, and the early generation of readers have passed away. To such writers belong Frank Stockton, Bret Harte and Paul Leicester Ford and the United States should be proud of having nurtured such men in her bosom.

SIXTEEN TO ONE.

Sixteen to one has been a great battle cry in the United States, and the same and credit John Wise as a delegate from the Democratic of Hawaii, succeeded in pulling that plank on to the last Democratic platform. On such

small pivots do great events sometimes turn. It was true that John did not know what sixteen to one meant, but that was a minor detail. Politicians of Mr. Wise's calibre are not supposed to know what party cries mean, they are only supposed to shout them. But sixteen to one is not to be confined to the United States. Great Britain has been invaded by the balfair cry, and curiously enough it is supported by King Edward VII and the whole band of officials connected with the coronation ceremonies. In spite of the two Houses of Parliament there seems a determination to adhere to this slogan of sixteen to one. Of course it is a very curious thing that a conservative sovereign and his officials should adopt Mr. Wise's motto, or should follow in the steps of the Democratic party. It shows how American ideas are spreading all over the civilized globe.

Wait, however, this is not John Wise's sixteen to one, but another sixteen to one which that statesman may be able to understand better. At the coronation exactly sixteen inches of sitting room is allowed to one peeress, and there is much trouble among the stout Duchesses, Countesses and so forth. Of course the willowy peeresses are all right, but there are peeresses whose noble curves require somewhat more than sixteen inches, and there is no hope to be gained from tight lacing. What are the poor things going to do? The horrid order should have been issued before, and then there might have been an exodus to Carlsbad, but what a splendid opportunity there must have been for some enterprising Yankee with an anti-fat remedy. "Guess another bottle will take of the last half-inch, Duchess," he would bawl. "Countess, two bottles more, or we can never make a fit of it." It must have been a great time for accurate measurement. This is the British sixteen to one. Pity the fat Peeresses.

It is of no use forming an opinion of alleged cruelties in the Philippines until all the evidence from both sides is in. The charges are being used for a political purpose, and when such is the case, one must look very carefully to the evidence.

In speaking of premonitions of the volcanic disaster in the West Indies people go back to the earthquakes of Guatemala, but as far back as February 16 of this year a tidal wave ten feet high struck the whole coast of Salvador, one small coast village was inundated and all the houses swept away, many people being drowned. One can understand the fear that is now felt throughout the Central American coast towns of a tidal wave.

It looks very much as if the end of Boer irregular warfare is in sight, in fact any steamer may bring us the news that Peace has been definitely proclaimed. There will be some irreconcilables who will not come in, but who will endeavor to escape northward, probably penetrating as far as the Congo Free State. There were irreconcilables among the southern troops who never surrendered but went to Mexico, and to the South American Republics. Most of these have long ago gone to their everlasting home. Only here and there a specimen is found. It is very evident that the majority of the Boers are anxious enough to start into their regular and peaceful avocations if the irreconcilables will only let them.

Should the young Queen of Holland die, leaving no direct heir, there will be a nice complication among the European Royal Houses. Germany regards Prince Albrecht of Hohenzollern as the nearest heir. Whether this will be satisfactory to the Dutch is quite another thing. They have not taken kindly to Queen Wilhelmina's German husband, and it is doubtful whether they will look with equanimity upon the accession of a Prince of the House of Hohenzollern to the throne, which many of them would regard but as a step towards eventual absorption into Germany. But it will not be only the Dutch who will object. The jealousy of France and the fears of Belgium will be aroused, as neat a complication as has occurred for a century or two among the Continental European states hangs upon the frail thread of an ailing woman's life. European diplomats are studying genealogies very carefully just now.

Affairs in China are by no means satisfactory. The anti-foreign feeling is as strong as ever, and, as usual, is displaying itself in violence toward the missionaries. Before this century has passed its first lustre it will have to face the Chinese question again. The Chinese Government is not a government as we Westerners understand governments, but we will persist in so regarding it. When we have had our representatives murdered once or twice we shall begin to understand how we must act. The effect of the occupation of Peking by the allied troops was nothing. The Imperial family returned in triumph to the capital. There are the elements of much trouble to the western commercial nations in China during the present century. One of the gravest dangers lies in the possibility that the Chinese may be taught to fight on our methods. Once that shall be acquired and China becomes one of the most powerful of the nations of the earth, add to that Chinese unscrupulousness, and there will be a combination that will be irresistible.

HE HAD NO HOME.

Kelekoilo, a little Porto Rican boy about 8 years of age, both of whose parents were dead, was before Judge Wilcox this morning to answer to the charge of truancy. Deputy High Sheriff Chillingworth explained to the court that none of the charitable institutions seemed to have any desire to take charge of the child, and there was absolutely no other place to send him but the reform school. Several people had attempted to look after the little fellow but he was not amenable to clean living so he had been turned over to the police. Judge Wilcox ordered that the child be confined in the reform school during his minority, or until such time as the court or the Board of Education should deem it proper to order his release.

Judge Robinson has referred the accounts of the estate of H. A. P. and Grace Carter to M. P. Simonton, as master. The accounts of the guardianship of Robert D. King were referred to J. O. Lightfoot.

TO KILL EACH OTHER

STRANGE AGREEMENT BETWEEN KIMURA AND WOMAN.

The Prisoner Relates the Result of a Visit to a Christening Party—How He Killed the Japanese Woman.

Kimura was brought to Honolulu this morning by Deputy Sheriff Cox. The Japanese's injury was not so serious as to require his being sent to the Queen's Hospital. High Sheriff Brown deciding that the man might be cared for just as well at the jail hospital. Kimura was able to give an account of the murder of the woman. High Sheriff Brown subjected him to a rigid cross examination through Chester Doyle, the Japanese interpreter. Kimura tells an entirely different story from that which came from Waiataleia. According to the story of Kimura, he and the woman had been on very friendly terms until four years ago when she married Yamanada, the store-keeper. After her marriage she ceased her friendly relations with Kimura, in spite of the fact that the latter was employed as a clerk by her husband. Yesterday Kimura and the woman received an invitation to attend a christening party of some Japanese, so went in a brake to the place. The brake broke down on the way and they repaired the thing. When they started home, two Japanese men named Ito and Muranaka, asked to be allowed to ride with them in the brake. Kimura said that the men would have to walk, so drove on ahead, leaving the woman and the two men to walk home. He thought afterwards that the husband would be angry at him for having left the woman, especially as she was intoxicated, so he drove back along the road, but found no trace of the woman and the two men. He put the brake up and started to walk and overtook them. From certain circumstances, he thought that the woman had permitted the men to take liberties with her and, after taking her away from them, he bitterly reproached her for her remiss conduct. He declared that the only thing they could do was to commit suicide. She agreed, so they started to kill each other, each with a knife, so Kimura asserted, and slashed at the other's throat. He was stronger than the woman, and he nearly severed her head, while she simply gashed his throat. He left her by the road, and hurried home and took an old shotgun for the purpose of killing himself. Before he could do so, the house was surrounded by people who said that the officer wanted him. He surrendered then without any struggle.

The statement of Kimura differs very materially from the report received from Waiataleia, and puts a somewhat different aspect on the affair. There are some discrepancies in his story, however, which have not yet been cleared up. No sum of money appears to have been found on him, however, and this fact goes to throw some doubt on the first story which came from Waiataleia, to the effect that the murder was due to his desire to get the woman's money. Kimura's windpipe was severed but no arteries cut. The officer had Kimura conveyed to the court house, where medical attention was given the injured man.

THE DRAMA.

"Richelleu" with its romanticism of character and epoch, proved an intensely popular bill at the Opera House on Saturday. The spectacular nature of Lytton's play, the foreknowledge of the audience with the chief character and the brilliancy of the scenic production with its pictures of love, and silks and laces, its medievalism and the presentation of the fascinating intrigues of the court of France, caught the fancy of the house. Frederick Warde's "Richelleu" was masterly in its interpretation showing with subtle skill Richelleu the man, as well as Richelleu the minister. The first act with the attributes of love, and sympathy not usually attributed to the great cardinal by the casual thinker were delightfully portrayed while serving to show the maturing of his entire greatness. Always preserving the effects of almost exhausted old age fired by the indomitable spirit and purest patriotism, Richelleu as given temporary life by Mr. Warde showed the magnitude of the man's character, the will and magnetism that aved while it defeated his enemies. The lines "Mark where she stands. Around her form I draw the mystic circle of our holy church. Step but one foot within the sacred ground and, on thy head, yea, though it wore a crown, I launch the curse of Rome" were rendered with magnificent force. Barry Johnstone's Chevalier de Mauprat was admirably presented making an excellent stage picture of the gallant of those days, when guining and indebtedness were creditable attributes. Mr. Herman's Baradas, type of the schemer that constantly sought to secure the downfall of the great cardinal and failed as constantly from their weakness as compared to the wily minister who read his countrymen and countrywomen too. In carrying the pages of a book of engravings that need not even the text to explain their meaning, Miss Ashton was well cast as Julie playing the role with considerable force besides contributing a pretty stage picture. Mr. Coleman looked François very well and Mr. McGinn was a satisfactory if somewhat robust Joseph. Joseph was not the sharpest of Richelleu's instruments but a little toning down would make the presentation seem less crass without weakening the play at all. The gentleman who played Hugot, was too blustering for an officer of the cardinal's guard and somewhat spoiled the effect of Richelleu's shaking the priming of his arquebus by appearing with a modern Winchester. Miss Warde contributed a few lines with charming manner and personality.

THE TALE OF A TAIL.

Arthur Williamson, a negro hostler employed by J. Cary, was before High Sheriff Brown this morning to explain what he knew about the mysterious cutting of a horse's tail. Cary declared that the darky had been the man who had cut the horse's tail. It appears that the colored man was discharged this morning by Cary and within a short time after this happened, a fine horse in the stable was minus a tail. There was nothing but circumstantial evidence to connect the colored man with the offense, so High Sheriff Brown decided that there was nothing which justified placing him under arrest.

KILLED BY A FIEND

SHOCKING CRIME COMMITTED AT WAIATALEIA.

Kimura Said to Have Killed His Employer's Wife—Made Desperate Effort To Take His Own Life.

A cold-blooded murder was committed at Waiataleia yesterday and Kimura, a Japanese store clerk, is under arrest charged with the crime. The victim was a Japanese woman named Yamanada, the wife of a storekeeper named Yamanada. The desire of Kimura to secure a quantity of money which the woman had collected, is thought to have been the motive for the crime. According to reports received from Waiataleia, Yamanada sent his wife among the Japanese about the plantation for the purpose of collecting various small accounts which they owed him. Kimura as the clerk in the store, was sent with the woman for the purpose of aiding her in locating the men indebted to her husband. The collectors were busy all of the day, driving about in a wagon. Just how much money was collected by the woman is not known, but it is thought to have been considerable, as the Japanese had money and she and Kimura visited a great many of them. About 8 o'clock the wagon they used was discovered near the roadside between the court house and school house at Waiataleia. Apparently no person was in the wagon, as the horse was browsing. An investigation disclosed the murdered remains of the woman Yamanada. Her throat had been severed from ear to ear. Deputy Sheriff Andrew Cox was notified and, within a short time, he learned that Kimura had been the woman's companion, so began a search for the missing man.

Kimura was found near the upper reservoir, next to the mountains back of Waiataleia. He evidently had anticipated the arrival of the officer, for when Cox located Kimura, the Japanese leveled an old muzzle-loading shooting gun at Cox, with the evident intention of shooting the officer. Cox made no attempt to rush the Japanese but parleyed with him, urging him to surrender as there was no hope of escape. Kimura finally consented to surrender the muzzle of the gun and when he did so, Cox rushed forward and grabbed the gun. Kimura slipped away and drew a knife and tried to commit suicide by cutting his throat. Cox checked the desperate Japanese by grabbing the knife, although during the course of a struggle, Kimura tried to stab Cox. Kimura's windpipe was severed but no arteries cut. The officer had Kimura conveyed to the court house, where medical attention was given the injured man.

With constant practice and a good man behind the bat the Artillery will make things very interesting for the balance of the league. Kiwa in the box for the Customs, pitched a wretched game, Lieutenant Newton umpired with perfect satisfaction.

WIELDED THE WILLOW.

The eleven captained by C. P. Morse won from S. Beardmore's team with five wickets to spare in the first game of the cricket season on Saturday. Beardmore made the top score with 35, A. T. Miles contributing 34, not out. The scores when stumps were drawn showed 87 for the winners with five men waiting to bat as against 33. Considerable interest was shown in the game and cricket appears to have started a revival which bids fair to keep up throughout the season.

TUG OF WAR FINISHED.

The finals of the tug of war tournament resulted in defeat for the Public Works team by the Pacific Hardware. The old Wela Ka Hao men pulled gamely but the youth of their opponent who are the end came with a rush after twenty minutes. The full time was twenty-two and one half minutes. The Pacific Hardware gained the championship and a prize of \$200, the losers getting a second prize of \$50. A preliminary pull between the Lumbermen and the Kanj Ke Aus saw the latter defeated after 20 1/2 minutes. There will be another pull next Saturday evening for the benefit of the teams who have helped to make up the tournament.

BASEBALL ON MAUI.

The Maui Athletic Association has challenged Hilo to a baseball tournament on June 13, offering the visitors all expenses outside of steamer fares and three-fifths of the gate receipts. No answer to the defiance has been as yet received. The first game of the Maui baseball league was played on Saturday, when the Morning Stars defeated the Waikapus in a loosely played game by 23 to 12.

Y. M. C. A. BASKETBALL.

The Diamond Heads and the Blue Streaks were the winning teams at basket ball on Saturday evening defeating the Spartans and the Intermediates by respective scores of 14-9 and 16-14.

DID NOT EXERCISE "TACT."

Action of American Consul Criticised by Some People.

LONDON, May 6.—Private letters from Rome give a very different complexion to the arrest of the American naval officers at Venice. They say that instead of thanking the King of Italy for the clemency in pardoning the officers, the United States should demand an apology.

A correspondent writes that when United States Ambassador George von Meyer first heard the news he was "inclined to let justice follow its course," but on second thought he was touched by the probable ruin of the future careers of the American officers and therefore approached the Foreign Minister to arrange matters if possible.

The action of the American Consul at Venice, Henry A. Johnson, was much criticized by some people, as showing "want of tact" but, according to reports which have now arrived here, he acted in the most energetic manner and with proper backing would have had the officers returned to their ship.

A correspondent writes that when the Consul was summoned in a hurry after the fight he energetically protested against the arrest of the officers and demanded their immediate removal on board the Chicago. The Italian authorities, however, would not yield the point. The consul's failure to exercise "tact" seems, according to the correspondence from Rome, to have been failure to offer immediately adequate pecuniary compensation for the damage done and to those who were wounded in the fight.

NO MORE BOXERS

POWERS WATCHING THE REVOLT IN CHINA.

Will Insist Upon Punishment of the Men Engaged in the Uprising in Southern Province.

Washington, May 4.—In order to prevent a recurrence of the boxer outrages of 1900, the powers will insist upon severe punishment of the men engaged in the revolt which has broken out in the southern portion of the province of Chili. The rebellion in southern China and the outbreak in Chili show that the whole of the empire is in a state of ferment, and diplomats in Washington who are well informed regarding conditions in the Far East say they would not be surprised should the insurrection become far more serious. A general uprising would forbid the organization of another international column for its suppression and the powers would have to adopt toward China a policy different from that pursued two years ago.

It is of the utmost international importance therefore, that the Chinese government should succeed in suppressing the revolts which have occurred in Southern China and Chili. The Foreign Ministers in Peking will make earnest representations to the Chinese government with a view of obtaining prompt and adequate action.

One of the demands made by the powers in 1901 was that every anti-foreign society should be at once suppressed and persons involved in it should be punished.

Carrying out this demand, the Chinese Emperor issued an edict declaring that "if hardened and incorrigible malefactors should again secretly organize anti-foreign societies they shall be punished by death, as well as those belonging to these societies. They shall not be shown the slightest mercy."

Minister Conger has not reported to the State Department that the outbreak in Chili is anti-foreign, but the dispatches reporting the murder of a French priest clearly indicates its character.

No apprehension is felt for the safety of the diplomats in Peking. The United States has 150 men, and other nations have equally strong guards in that city. Besides there are troops stationed on the road between Peking and Taku, so that in case of an attack upon the legations a way for retreat is open and protected. What concerns the authorities is not the safety of diplomats, but the possibilities that may arise from the delicate situation which a general uprising would create.

AN IMPOSING FUNERAL

REAR ADMIRAL SAMPSON BURIED WITH NAVAL HONORS.

Military and Naval Features Were Brilliant and Impressive—The President Was Present at the Funeral.

WASHINGTON, May 9.—With a pomp and circumstance exceeding that of any naval funeral in this country in recent years at least, the remains of William T. Sampson, Rear Admiral in the United States Navy and commander in chief of the United States naval forces on the North Atlantic station during the war with Spain, were today laid to rest. Every department of the National Government was represented. The military and naval features of the ceremonies were brilliant and impressive. They were conducted under the direction of Rear-Admiral Terry, commander of the Washington Navy Yard, assisted by Lieutenant Henry George.

The funeral escort was composed of a light battery of United States Artillery, commanded by Captain Foote and drawn from Fort Myer; the naval cadets from Annapolis, 247 strong, a corps that never has paraded in Washington before save when a President was to be inaugurated, and a battalion of blue jackets from the North Atlantic station, of which Rear-Admiral Sampson was formerly commander.

Rear-Admiral Terry, commanding the escort, with his staff, assembled at the church and when the word of command was given the cadets swung into line, and headed by the Naval Academy band, marched slowly from the church to the residence of the dead Admiral on New Hampshire avenue, about a half mile away. Here the honorary pall-bearers were gathered, headed by Admiral Dewey. The remains, borne on the shoulders of eight stalwart sailors from the dispatch boat Dolphin, were placed in the waiting hearse and escorted to the church.

Here the battalion formed in line on the north and silently saluted as the remains were carried into the church and placed in the chancel. As many people as the large edifice possibly could seat were assembled in the body of the church. There were no signs of mourning about the church, but two score magnificent floral emblems, made up of the rarest roses, lilies and orchids, laced with purple ribbon, the gifts of the President, the Navy League, the Ordnance Bureau, the navy yard workers and the many societies and personal friends of the dead Admiral, were banked near the chancel.

The President arrived at the church almost simultaneously with the head of the funeral escort. He was accompanied by Secretary Cortelyou and Commander Coville. The Supreme Court met and adjourned at 10 o'clock, and within a few moments the not playing of music by the Marine Band, stationed at the entrance of the church, gave notice of the appearance of the funeral party.

The procession to Arlington lay through the western section of the city and historic Georgetown, whence, after crossing the aqueduct bridge, it went by way of Fort Myer to the cemetery. The weather was exceptionally fine and crowds of people, approximately between 40,000 and 45,000, thronged the streets and gathered about the grounds at Arlington.

The burial ceremonies were simple, being confined to a prayer for the dead, the reading of a Psalm and music. At their conclusion the saluting battery of the Fourth Artillery, stationed outside the gates, boomed out three salutes. This salute was in lieu of the usual volleys of musketry. As the remains were lowered into the grave the Marine Band played the hymn, "Safe in the Arms of Jesus," and then followed the sounding of "Taps" by a bugler, marking the last earthly ceremony over the late officer. The President and his Cabinet did not go to Arlington.

When the Empire State express was put on it was believed to be the fastest train in the world. Afterward it was found that the Sud express, on the Midi Railroad between Paris and Bordeaux, was faster—at least, according to its schedule. The Sud express made the distance, 486 miles, at an average rate of 54.13 miles an hour, while the running time of the Empire State express for 340 miles, from New York to Buffalo, is 53.33 miles an hour. It was

said at the Grand Central Station today, however, that the Sud Express was never on time and that now its speed has been reduced to fifty miles an hour, while the Empire has been running ever since its installation, ten years ago, with rarely a loss of a few minutes from its schedule.

It is the boast of the New York Central that it holds the record for the fastest mile ever made by a passenger train. This was when the Empire, in May, 1901, ran a mile between Batavia and Buffalo in thirty-two seconds, or at the rate of 112 1/2 miles an hour. Cutting the schedule for long distance runs has been made possible by improvement in the power and speed of locomotives. The new type has not yet been subjected to purely speed trials, but it is said to be as much in advance of the fastest type of ten years ago as the locomotive that used to draw the Empire State express was in advance of the older type when it was built.

The main innovation of the new machines consists of a rearrangement of the driving wheels and boxes, so as to give a greater area in which water can be heated quickly to the boiling point. George H. Daniels, general passenger agent of the New York Central, left Cleveland for this city tonight, and it is understood that the new train will be put on as soon as arrangements can be made for it.

A PRELATE'S FUNERAL

SOMBER PAGEANTRY AT ST. PATRICK'S CATHEDRAL.

Six Archbishops and Eighteen Bishops Took Part in the Services—Sermon by Archbishop Ryan of Philadelphia.

NEW YORK, May 9.—The body of Michael Augustine Corrigan, Archbishop of New York, was interred today in the crypt of St. Patrick's Cathedral. The funeral was conducted with all the impressive solemnity and ceremony of his church, and was attended by a remarkable gathering of clergy. Almost with the break of day crowds began to assemble at the cathedral, and when the hour of the funeral service arrived a multitude had assembled to pay last reverence to the late prelate.

Inside on the Gothic altar six candles were burning and the smoke of incense hung about it. Around the bier where the dead Archbishop lay three candles burned on each side of him, with a double row in a candelabrum above his head and another double row below his feet. These were the only lights except the blue and crimson altar of sunning which shined through the window of the sanctuary. Black cloth was hung about the fluted pillars; on the vacant archiepiscopal throne there were purple and black and wild laurel tied with red silk. Opposite, on the episcopal side, a Cardinal's throne had been prepared all purple. These, with the cope on the pulpit, were all the signs of mourning.

The chimes played and then the bells tolled from the spires, and after that the hundreds of priests and eighteen Bishops and six Archbishops and Cardinal Gibbons, accompanied by four bishops of the archdiocese, Bishops Burke, Gabriel, Ludden and McQuaid descended to the catafalque. The five absolutons to which the dead Archbishop by rank of office was entitled were then given.

At the close of the service a death mask of the Archbishop was taken. The body was placed in a casket, which was taken to the crypt under the high altar and placed in a vault beside the bodies of Archbishop Hughes and Cardinal McCloskey. Bishop McQuaid of Rochester said the final prayers.

POTTER PALMER DEAD. CHICAGO, May 4.—Potter Palmer, for nearly half a century one of Chicago's most prominent business men died tonight at his residence on Lake Shore drive. The exact cause of Mr. Palmer's death has not yet been determined. He had been suffering for several days from a nervous disorder, but, as he was able to be about the house, his condition was not thought to be serious.

When he retired last night he was feeling, if anything, better than for several days. During the night, however, he seemed to lose all his energy, and this morning was unable to leave his room. He gradually grew weaker during the day and at 5:40 o'clock this evening he suffered a sudden collapse, from which he expired. The physicians who were attending Mr. Palmer are at a loss as to the ultimate cause of his death, as apparently he had no organic troubles. Mrs. Palmer and their two sons, Honore and Potter Jr., were with Mr. Palmer when he died.

No arrangements have yet been made for the funeral, but in all probability he will be buried in Chicago, where he accumulated his fortune.

Mr. Palmer's fortune is estimated at \$25,000,000.

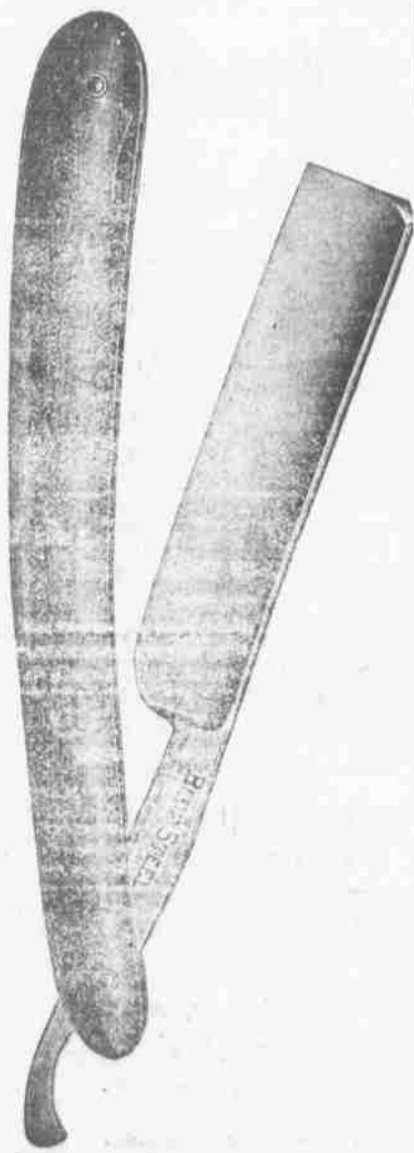
