SOME COMMENT ON MR. DOLE'S LABORS.

(Communicated.)

Poor Dole! Poor P. G.'s! At last the reply from Mr. Dole to United States Minister Willis is made public. Mr. Dole in concocting his answer no doubt had the assistance of such renowned lawyers, as Emmeluth, Carter, Hartwell, Smith, Kinney, Thurston, Hatch and the political, chief justice; and yet, what do their combined efforts amount to? Nothing more than an ordinary lawyer's plea at Bar. A brief, containing a lawyer's lies and misstatements for the benefit of his client. It is called a diplomatic document. Caesar's ghost! what a laugh President Cleveland and his cabinet must have had over it on the day when they read it.

Let us see what Dole says to Minister Willis. Dole says in substance, that he is disappointed to learn that the thieving scheme proposed to the United States has been rejected, but nevertheless experiences a sense of relief now that he knows it, although he has waited over nine months for such relief.

The declination of President Cleveland to further consider that grand thieving scheme, has received the acceptance of Mr. Dole; but, at the same time Mr. Dole intends to hold on until President Cleveland's successor is elected, then bring his thieving scheme up again.

Mr. Dole goes on to say that his answer to the question, "are you willing to abide by the decision of the President?" might be made in a single word. Wonder if that is not a misspelt, because "go to the devil," is four words? He then tells the President of the United States that he has no right of interference here. That's a funny thing. Especially when a President of the United States interfered so much in our domestic affairs as to unlawfully and without provocation, allow his Representative with the aid of the naval troops at his command to dethrone the constitutional and lawful sovereign of the Hawaiian Kingdom, on January last. Dole was of opinion then that it was alright. The "boot" is "now" on the other leg, he "squeals," and now wants to know "upon what then, does the President of the United States base his right of interference?" A lawyer is not needed to answer that question. Some reference is made to the expressions of Marcy, Seward, Fish, Blaine, and a President of the year 1836, what have they to do with the present question? Although, if President Harrison had acted up to the policy which Mr. Dole quotes was that of President Jackson, that "The uniform policy and practice of the United States is to avoid all interference in disputes which merely relate to the internal government of other nations." Mr. Dole and his satellites would not be in power to-day.

Mr. Dole very politely (?) inform Minister Willis that his communication appears to him (Dole) to contain misstatements, and erroneous conclusions based thereon which are prejudicial to the P. G.'s. He squeals again. The fact is that such a plain truthful statement of the status of the case is laid before Dole by President Cleveland that he winces, and can only take recourse to a lawyer's method of drawing out of his predicament. Had those misstatements tended to have had an opposite effect, the situation would no doubt

have been far more pleasing to Dole.

Mr. Dole endeavors to be little Mr. Damon. Now, the community knows very well what Mr. Damon's sworn testimony to Col. Blount was. Surely Mr. Dole does not wish to have that testimony disbelieved as being untrue. Whether Mr. Damon assured Queen Liliuokalani "that if she surrendered under protest her case would afterward be fairly considered by the President of the United States," on his own responsibility or not, is of no moment. When Mr. Damon gave the Queen those assurances, it was understood that he was representing the Provisional Government. From the character of the situation on the 17th of January, and his connection with the affairs of that day, Mr. Damon did undoubtedly represent the P. G. at the time the Queen yielded.

Mr. Dole, wants to know what "her case" was that was to be fairly considered etc., and thinks there is "no case because the President of the United States has recognized the P. G. How innocent. How in the world did Dole think the President of the United States was to take any steps into investigating the Hawaiian Affairs unless he did recognize it. He had to recognize it so as to enable his Government to negotiate. But because of such action, he is not compelled to ignore Queen Liliuokalani's rights or claims. Further comment on that stupendous diplomatic document will be made in a later communication.

Thurston's Bad Break.

The conservative and forbearing disposition of the administration in dealing with the various phases of the Hawaiian question has added to the good effect upon public opinion of the publication, early last week, of Commissioner Blount's report, upon which the policy of the administration was largely based. It has taken no notice of the very unusual and injudicious action of Mr. Thurston, the minister here of the Provisional Government of Hawaii, in writing and giving to the press an answer to Blount's report, containing language that would not have been tolerated from a foreign minister by any other government in the world. Had the administration upon the appearance in the newspapers of Mr. Thurston's defense sent that gentleman his passports no one would have had any right to complain; it would only have followed precedents set by every civilized government in the world, including our own. It is not improbable that President Cleveland in ignoring the bad break of Mr. Thurston was influenced by the thought that the Hawaiian minister was perhaps only too anxious to pose as a martyr. But whatever the object, on either side, the fact remains that Mr. Thurston was guilty of an act that would have driven a foreign minister from any other country and that not the slightest official notice was taken of it by the administration, and this forbearance is generally recognized as altogether creditable to the administration.—*Waukesha Dem.*

A Polyglot Institution.

The estimable Cornellite who is responsible for the abusive attempts at sarcasm which feebly scintillate in the editorial columns of the Star gives the following as the result of "an American residence of thirty-three years," (he doesn't say whether from baby-hood or not), in gathering facts as to the nature and functions of the United States Government: "The American executive exceeded his legal privileges and spoke, therefore, not for the United States' Government, but for one-third of that polyglot institution." (The italics are ours).

In the "happy by-gone days" the half-baked Hen-nery used to term the Holomua with the most opprobrious epithet at his command, a "polyglot" sheet. Wherefore shall we learn wisdom at the

feet of Gottingen Hen-nery or Cornell Smith? "Under which King, Bezonian?" Possibly the Star jester did not mean any opprobrium to the U. S. Government and wished to say—but that his vocabulary was defective—polyglot, in the sense of multi-lateral or many-sided. Is this the evolution? Possibly this "5000-miles-away decision" that the U. S. Government is a "polyglot institution" and actually exists without a "Head" as this mixer of metaphors manages to make out will not trouble the U. S. Government or its esteemed President and Head, Grover Cleveland.

IN HARD LUCK.

Mr. Walter G. Smith still out in the Cold.

At yesterday's meeting of the councils, the Attorney General read a communication in which Mr. T. Murray on behalf of the Secret League ordered the councils to fill an eventual vacancy in their membership with Mr. W. G. Smith. As there was no vacancy Mr. Murray's order was pigeon holed. The expected demand from the annexation club didn't materialize and Mr. Smith's organ last night bewails that some one, very bad man, had spirited it away. It had been hoped in radical circles that Mr. John Ena would resign, but that great councillor says that he will stand and fall, presumably to the last, with the government and that he will be—say an angel, before he resigns his seat in favor of the Star man. The next hoped-for vacancy should occur, according to Star calculations, when Mr. Hatch was made Minister of Foreign Affairs. Unfortunately for the chances of the "New York Legislator" of San Diego fame Hatch leaves for San Francisco to-morrow, and when he returns the prospects are that there will be no necessity for any Councils or Councilors. If there is Mr. W. N. Armstrong will presumably take the Foreign Office as we never can believe that Mr. Hatch would give up his lucrative practice for a cabinet position, and it would hardly be in accord with the dignity of a Minister of foreign affairs to appear in the police court on a twenty-five dollars fee, and defend some Chinaman who had violated the laws of the government which his defending attorney represented. There is one amusing point in the business, and that is the seriousness with which the annexation club presents one resolution—when it can be found—and the Secret League another as if they were two separate bodies while the fact is that all the members of the "League" are members of the club, and therefore, virtually "resolute" themselves twice. The effect will be small though. Mr. Smith will have to be satisfied by going to the council as a reporter—and also by being a partner of the only Emmeluth.

THE DEMAND, dared to be made, by the so-called secret political organization which is permitted to exist by Government order, is sufficiently strong evidence of the weakness of the "powers that be" and of the class of people on whom they depend for support. Rarely, if ever, would Messrs Dole, Hatch, King, Wilder, Atherton, Henry Castle, Rev. Hyde, Sereno Bishop, or other annexationists invite, even the officers of the League, to their houses. What a comical combination it would present if Dr. McGrew should give a reception at his residence and among those present would be noted, besides the leading citizens mentioned, the shining visages of Tim Murray, Jack McLain and "Poker Dan." But may be they would be represented by filibuster Smith.

The foreign correspondents have rather dry work now-a-days. They got scooped on the Dole message it being published abroad.

Hawaii. Many persons who admit the injustice of the attitude of the United States during the Hawaiian revolution now insist that two wrongs cannot make a right, and that, having deposed the Queen, it would be as great a wrong to return her to power as it formerly was to dethrone her. It is claimed that the Hawaiian Government has been recognized by all civilized powers, it is therefore the Government of the islands, and we are bound to respect it as such. This argument might be sound if the present Government were in its nature permanent. But it is not. It calls itself a Provisional Government, and cannot even maintain itself without gross injustice to the Hawaiian people. It must either proclaim dictatorship or a Republic. If it pursues the latter course, practically all the natives and of course all the poorer foreigners must be disfranchised. In brief, the republic would be so only in name, and a handful of whites would rule the rest of the islanders.

Since we have assisted the Provisional Government, we at least have the right to demand that it shows justice to those whom it rules; in other words, it should summon a convention that shall faithfully represent all the people of the island. This convention may declare for the Queen, or for her niece, Princess Kaiulani, for a republic or for annexation; but in any event our responsibility will be ended.—*Brooklyn Citizen.*

The Hawaiian Problem.

Since the publication, some days ago, of the letter of Special Commissioner Blount, who went to the Hawaiian Islands to investigate the condition of affairs there for the administration, there have appeared several replies to Mr. Blount's statements from ex-Minister Stevens, Mr. Thurston, Hawaiian Minister to the United States and others. These replies have contained little else than angry protestations and veiled threats of future exposures, but they have otherwise fallen flat as far as throwing any additional light on the Hawaiian problem is concerned.

The report of Mr. Blount has served to put the situation in a much clearer light, and the criticism of the administration's course is now confined mainly to the Republican press and persons identified with the late administration. These partisan critics are now endeavoring to goad the State Department into making public the instructions to United States Minister Willis, now at Honolulu. It is understood that the Minister has been instructed to reinstate the Queen, but the delay in carrying out these supposed instructions creates the impression that the duty allotted to the Minister has been coupled with a very liberal share of discretionary power.

The restoration of the Queen not having yet taken place as far as known, there has arisen a serious doubt in the minds of the Republican critics of the administration as to the exact course mapped out by the administration, hence they are beginning to apprehend the effects of a too virulent denunciation for fear that subsequent developments in Hawaii may turn their arguments into boomerangs. They are, therefore, clamoring for the publication of Minister Willis' instructions.

If the administration acceded to this unreasonable demand, it would be showing its hand to its enemies, without in any way helping its friends or bettering the situation in Hawaii a single jot. It is, therefore, to be hoped that President Cleveland will pay no attention to the partisan clamor which has been raised against his policy in Hawaii. If it is proven that the facts connected with the deposition of the Hawaiian Government are correct and there is little doubt on the subject, all fair-minded people will applaud the restoration of the Queen as a proper and just reparation for an outrage perpetrated upon a helpless state.

It is somewhat strange that the partisans of an administration which reluctantly recognized the revolution which deposed Dom Pedro, of Brazil, and the popular upheaval in Chili which destroyed the Dictator Balmaceda, should experience such spasms of patriotic wrath when a Democratic administration refuses to countenance the active intervention of a Federal official in the affairs of a friendly foreign state.—*Orleans Picayune.*

LOCAL NEWS.

Weather showery.

Business still continues very dull.

The wind is east to day. More opportunity for the "wind flew end--ways."

The new marshal does not seem to materialize. Probably only a shadow picture.

A towaway was returned from the steamer Miowera yesterday afternoon. It is reported that four others had preserved their incog.

Care-taker R. J. Greene, is doing a good work in clearing away the superfluous arboreous matter about the Palace grounds. The improved appearance is creditable.

Brilliant flashes of lightning were rapid in succession on the north-western horizon last evening. At early morning the muffled roll of distant thunder was audible.

Don't forget the concert by the Misses Albu to-night at the Opera House. It will be quite a relaxation to hear the strong, rich, yet soft and sweet, voices of the lady singers caroling Hawaiian songs. The chorus singing by the Quintette club will be an interesting feature.

The clock on Kawaiahao church has been stopped for some time back and is still allowed, by the trustees, to remain in that tickless and non-communicative condition. It was an expressive and much looked at face in the past, but, it may have, developed Royalist tendencies so its power has been temporarily removed.

The present situation, which we, the Native Hawaiians, justly style as the "Dark Ages of Hawaii" will ever remain indelible to our memories, and never from the face of history or of the universe shall it be effaced. It is an era marked by unconstitutional violations and by the fraud usurpation of our country under a monarchical form of government at the time of intervention. We were contented and happy under the reign of the *Aliis* from Kamehameha I. to the present dethroned Queen Liliuokalani.

Never during that long duration has there been an act of tyranny as grave and great as the crisis that has befallen us. Our Queen was dethroned not by the rightful inheritants of the land, but by a foreign colony of dishonest adventurers who came here so they might preach and teach the Hawaiians on Sundays and in their various missionary gatherings for the purpose of teaching and spreading the gospel. There is much truth in this statement viz. that missionaries devote more time to political affairs, than to works that serve to promote Christianity for which purpose they came to our sunny isles.

But woe to that band of robbers who succeeded in dethroning Queen Liliuokalani's government; and disgrace to the missionaries of Honolulu for indulging in treason with no fair reason or cause whatever for doing so. They are traitors for they have committed treason.

OUTWARD BOUND

The Departure of the Australia.

An unusually large crowd was present at the wharf to-day to witness the departure of the steamer Australia, for San Francisco.
