This ceremony will most likely go unnoticed in most American households. It may even be looked upon with disfavor by some, because it means bringing in more "foreigners". To those Americans who may feel this way and to others who do not deem this occasion to be important, let me express the belief that all Americans should be required to witness these ceremonies.

To most Americans, citizenship is something that is bestowed automatically at birth. No price was paid, no sacrifice was made, so citizenship is often taken for granted.

Here at this ceremony we have men and women, young and old, who have decided to leave their place of birth -- notwithstanding emotional ties, family roots, ancestral bonds -- to declare themselves citizens of the United States of America. This is something I believe one does not take lightly, to leave one's homeland and loved ones. It would be very difficult to remain unimpressed by such courage and commitment.

This ceremony loudly proclaims a message for those willing to listen. Why have these men and women selected the United States to be their new home? Why not France or Poland, India or Indonesia, Soviet Russia or the Peoples Republic of China? Why the U.S.?

The advantages of being an American should be obvious. Regardless of our many faults, and we do have many faults, our country is considered by most to be the best country in the world, the land of opportunity, the land of freedom, the land of good will. You who have paid the price and endured sacrifices in the struggle for citizenship understand and appreciate this better, perhaps, than most Americans.

To those of you new citizens of our country I wish to, in my capacity as a United States Senator, and more importantly, as a citizen of the United States of America, welcome you and wish that your future in this land be a happy, peaceful and meaningful one.

THIS CEREMONY WILL MOST LIKELY GO UNNOTICED IN MOST AMERICAN HOUSEHOLDS. IT MAY EVEN BE LOOKED UPON WITH DISFAVOR BY SOME, BECAUSE IT MEANS BRINGING IN MORE "FOREIGNERS". TO THOSE AMERICANS WHO MAY FEEL THIS WAY AND TO OTHERS WHO DO NOT DEEM THIS OCCASION TO BE IMPORTANT, LET ME EXPRESS THE BELIEF THAT ALL AMERICANS SHOULD BE REQUIRED TO WITNESS THESE CEREMONIES.

TO MOST AMERICANS, CITIZENSHIP IS SOMETHING THAT IS BESTOWED AUTOMATICALLY AT BIRTH. NO PRICE WAS PAID, NO SACRIFICE WAS MADE, SO CITIZENSHIP IS OFTEN TAKEN FOR GRANTED.

HERE AT THIS CEREMONY WE HAVE MEN AND WOMEN, YOUNG AND OLD, WHO HAVE DECIDED TO LEAVE THEIR PLACE OF BIRTH -- NOTWITHSTANDING EMOTIONAL TIES, FAMILY ROOTS, ANCESTRAL BONDS -- TO DECLARE THEMSELVES CITIZENS OF THE UNITED STATES OF AMERICA. THIS IS SOMETHING I BELIEVE ONE DOES NOT TAKE LIGHTLY, TO LEAVE ONE'S HOMELAND AND LOVED ONES. IT WOULD BE VERY DIFFICULT TO REMAIN UNIMPRESSED BY SUCH COURAGE AND COMMITMENT.

THIS CEREMONY LOUDLY PROCLAIMS A MESSAGE FOR THOSE WILLING TO LISTEN. WHY HAVE THESE MEN AND WOMEN SELECTED THE UNITED STATES TO BE THEIR NEW HOME? WHY NOT FRANCE OR POLAND, INDIA OR INDONESIA, SOVIET RUSSIA OR THE PEOPLES REPUBLIC OF CHINA? WHY THE U.S.?

THE ADVANTAGES OF BEING AN AMERICAN SHOULD BE OBVIOUS,
REGARDLESS OF OUR MANY FAULTS, AND WE DO HAVE MANY FAULTS,
OUR COUNTRY IS CONSIDERED BY MOST TO BE THE BEST COUNTRY
IN THE WORLD, THE LAND OF OPPORTUNITY, THE LAND OF FREEDOM,
THE LAND OF GOOD WILL. YOU WHO HAVE PAID THE PRICE AND
ENDURED SACRIFICES IN THE STRUGGLE FOR CITIZENSHIP UNDERSTAND
AND APPRECIATE THIS BETTER, PERHAPS, THAN MOST AMERICANS.

TO THOSE OF YOU NEW CITIZENS OF OUR COUNTRY I WISH TO,
IN MY CAPACITY AS A UNITED STATES SENATOR, AND MORE IMPORTANTLY,
AS A CITIZEN OF THE UNITED STATES OF AMERICA, WELCOME YOU
AND WISH THAT YOUR FUTURE IN THIS LAND BE A HAPPY, PEACEFUL
AND MEANINGFUL ONE.
