# CUC Director to resign

Commonwealth Utilities Corporation Executive Director Ramon S. Guerrero has written to the CUC Board Chairman Jose M. Taitano informing him and the members of CUC's Board of Directors of his decision to vacate his position a year after he assumed it.

In a letter dated October 29, Guerrero said that he has tentatively scheduled his departure on January 18,1991 as Executive Director of the CUC.

Guererro said that he has developed the highest priority for reorganizing the CUC into a utility service "it is time that I begin preparing for my departure to

my private business enterprise."

In the letter, Guerrero said the structure and composition of the

CUC in 1987 has not allowed it to develop into a self-sufficient agency since the "prior legislature did not give its support in funding the corporation in its birth as an independent and autonomous agency separating it from the Executive branch," Guerrero said.

Guerrero said that he believes that the CUC will be solvent towards its success and should be self-sustaining and self-sufficient within a short span of time "unless it diverts its course backwards."

Guerrero said that for CUC to reach its goal of self-sufficiency, the Board must "make sure that the manager on top is firm in the guidance of the management and activities of daily operation."

Guerrero also recommended to the Board to "lobby with the legislature" to amend and restructure the salary of the Executive Director. In the letter, Guerrero said that "it is necessary that the person of such caliber leading the Corp. is better paid," so as to challenge the person to operate CUC.

The person will not only have the initiative to work eight hours a day but, he will also have the initiative for the "additional devotion of time" needed for the improvement of the firm, Guerrero said.

Guerrero said that the since much needed improvements must continue until CUC is at par with the intended infrastructure development, "the CUC Board must closely and evenly support the individual that will assume the position as Executive Director."

Guerrero wrote that the CUC should not be allowed to be privatized to outside interests. He said that since CUC has already started the process of becoming self-sufficient, "to let someone pick the fruit away from CUC would be the greatest of sins-a diservice to the local people."


Tenorio said the board considers the report as a "serious matter" since under the Federal law, the Economic Development Loan Funds cannot be used for other purposes other than for

# Mosquito-borne disease hits Saipan

People on Saipan are at risk of contacting viral encephalitis which is a mosquito-borne disease that can cause brain damage.

Berthilia John of the Departmen of Public Health said that it has been confirmed that there is an occurrence of the disease on the island however, it is not yet known if there is really an epidemic.

John said that as of Thurs-

day morning, 8 cases have already been reported to the Commonwealth Health Center over the past two weeks. She said that of the reported cases, three are still in the Intensive Care Unit of the hospital. She said the persons affected by the disease range from an 8-month old child to a 70 year old man.

Since this is the first time that the disease occurred on the island, it is speculated that people from all ages are susceptible to it because of their non-exposure to the virus, John said.

The disease is caused by a virus affecting the lining of the brain. It manifests itself by sudden headache, high fever with associated symptoms of brain impairment including disorientation, delirium, spasticity, tremors, convulsions and coma, according to the press release from the CHC. Lifelong immunity also results after the infection since the disease does not recur.

Healthy adults usually fight

off the virus after a period of time and the symptoms appear 5-15 days after a person has already been infected, John said.

"There is no known cure for the virus however, supportive treatment can be administered to alleviate pains, headaches and nausea," John said.

The virus is found in insects and is very common in mosquitoes. It is known to be transmitted by bites of infected Continued on page 12

# EDITORIAL

In a recent reception hosted by Governor Lorenzo I Guerrero at the Governor's house at Capitol Hill for a group of high ranking Japanese officials, financiers, bankers and other island dignitaries, one high Japanese banking official told a Saipan guest that financial assistance for CNMI can be made only thru a bank such as the Pacific Islands Development Bank (PIDB).

CNMI officials in the past eight months have repeatedly asked the US State Department to allow the CNMI to seek and receive financial assistance from other countries like Japan, for the development and upgrading of the Island's infrastructure, but US policy does not allow such assistance or aid for any US state or territory from a foreign copuntry/nation.

Commonwealth officials have become persistent to the idea of receiving financial help from Japan when some Japanese businessmen encouraged them.

Some Japanese businessmen made it possible for Gov. Guerrero to visit Japan and meet with Prime Minister Kaifu and several government officials.

In the past few months, high-ranking Japanese officials were invited to visit and meet with Saipan officials too. The idea is to show support that financial aid is ,indeed, possible through a friendship group or organization of bankers and businessmen from Japan.

Such a move may convince or influence Us officials and the Japanese government that monetary aid may work out if it is properly channeled between Japan and the

The CNMI definitely needs more financial assistance as long as the current system of budgetting and spending is without proper planning and projection. And as long as the absence of control for growth and development that have a great impact on the costly infrastructure continues; and as long as the flow of raw green dollars out of the CNMI will continue through certain businesses due to absence of control and lack of knowledge about their income by responsible CNMI agencies.


Of course, assistance is needed but nothing is free in this world!

Let's think positively and ask: Will the Japanese government and its businessmen really give monetary aid to a country like the CNMI without strings attached or something in return? It is impossible.

More than that, and before we ask for any assistance, we must ask. Can this administration commit the next administration for what it has done or what it has obligated itself to? We think it is not appropriate.

The State Department policy, we believe is based on certain principles, just as the way the Japanese government and financiers have their own principles to follow.

# Guerra expresses concerns of CUC's financial status

Assistant Secretary of the U.S. Department of the Interior is asking CNMI Gov. Lorenzo I. Deleon Guerrero about the financial status of the Commonwealth Utilities Corporation.

In a letter to the Governor dated Oct. 26, Guerra informed the Governor that she was advised that Lyonnaise Marianas America Inc., the firm which was hired to operate and manage the CNMI power system, has filed a formal grievance against the CUC.

Guerra said that the dispute between LMA and CUC raises questions about the progress of the CUC in meeting the performance standards established by the Agreement of Special Representatives on Future Financial Assistance for the CNMI that the Government signed on July 10,1985 by representatives of the United States and the CNMI.

Guerra cited in the letter paragraph 4(e) of the agreement which states that the CNMI has agreed to "ensure the continuation of an independent public agency that sets rates and fees for public utilities. These services shall be fully funded, including current ex-

penses and long term-debt. without government subsidy through such user rates and fees by the end of the third year after the agreement is made effective."

The letter stated that the performance standards were incorporated into the Grant Pledge Agreement signed on Sept. 18,1987 between the U.S. and the CNMI government with the Bank of New York as

The letter also cited three conditions regarding the management of the CUC which has been incorporated in the GPA. One of the three conditions states that full responsibility for power services must be transferred to the CUC from the Department of Public Works.

A condition also stated that the the CUC will assign a private management firm to be responsible for all power services in the CNMI for up to three years and that CUC adopt a full cost recovery plan in consultation with the DOI.

Guerra stated that the conditions were set forth in a letter dated July 16,1987 to the Gov. Guerrero from the Asst. Secretary which states that the conditions are "in accordance

with the agreement of the special representatives."

Guerra said that although the Department of Interior is not considering the formasl consultation process as provided for by the GPA, they are concerned with the CUC's progress in meeting the performance standards they have cited in the letter.

· Guerra said that as concerned parties "it is vitally important" that both the CNMI government and the DOI maintain "adequate communication" on the status of the CUC's efforts to maintain the goals that have been agreed upon in the Special Representatives Agreement. Guerra also asked the

Governor to provide the DOI with answers to several questions regarding the extent with which the CUC has been utilizing LMA to operate and manage the power system, the CUC's plan for the continued operation and management of the power system upon the expiration of the current contract of the LMA.

Guerra also asked about the status of the CUC's debt service Commonwealth Development Authority, Matsui and Mitsubishi, the status of

CUC's cost recovery plan and metering program and the projected date that the CUC will achieve the goal of fully funded services.

In a press conference Wednesday, CUC's Executive Director Ramon Guerrero said that as per advice by the Board of Directors of the firm, he deems it best not to discuss the several issues regarding the dispute between LMA and

Guerrerro however revealed that he has assigned three representatives to discuss the possible termination of the O&M contract entered into by CUC and LMA regarding the management of CNMI's power system.

Guererreo said that Assistant Attorney General John Cool, former executive director Pete Sasamoto and CUC's legal counsel have been appointed to look into the LMA and CUC contract.

As to the debt service regarding the three companies, Guerrero said that the debt owed by the CUC to Mitsui has already been paid by the Department of Finance since last year. He also said that the CDA has approved to reorganize the package loan of

CUC regarding their more them \$55 million debt used for the improvement of water and power services.

Guerrero said that as for the Mitsubishi issue, the Guerrero administration has already submitted a proposal to the legislature for the purchase of two additional power generators for the power plant.

The executive director said that he does not blame the DOI for interfering in the dispute between LMA and CUC.

"The Department of Interior is likely to interfere since the money we are using comes partially from them," Guerrero

# Control towers funds not enough, Manglona

The Commonwealth of the Northern Marianas Islands is "hoping" that it will get some other money from the United States Congress aside from the \$2.5 million appropriated for the construction of the control tower, says Acting Governor Benjamin T. Manglona.

According to Manglona, it is only the over ceiling appropriation that the US Congress approved which is in addition to the guaranteed amount of \$28,850,000 that the Northern Marianas will be getting out of the covenant fund.

Manglona said that the information that "we had from both our Washington Representative Juan N. Babauta and from the Office of Territorial and International Affairs...that is the only money we have for over ceiling appropriation."

He said that "Originally, we

The Commonwealth then is expecting that in the "final compromise, we may at least get money for the control tower and the sewage system...but for unknown reasons, we don't know what happened and we only have \$2.5 million," he said.

According to Manglona, "that amount is far from being adequate to build the control tower facility which according to current estimate will cost about \$15 million."

He said that the money will still help at least in procuring some of the tower's accessories..."and still, we will look for other source of funding to build the structure."

The Commonwealth can go back to the U.S. Congress and the oversight committee hearing by February next year and request of more money for the control tower, sewage system and the American Memorial Park, he said.

Manglona mentioned that the CNMI already got an authorization approved by the U.S. Congress back in 1978 in the amount of \$3 million to be used for the improvement of the American Memorial Park.

He said that "what we need now is only appropriation."

Manglona said that earlier, Governor Larry Guerrero and the Commonwealth Ports Authority officials "have been corresponding with the proper federal officials to obtain money for the control tower."

CNMI government isconcerned with the safety of the local community and the tourists as well, he said.

He said that this year, the

Commonwealth has over 400,000 visitors "and in case of an emergency at the airport, due to the non-availability of a control tower...it will truly affect the tourism industry.'

He said that right now, the CNMI government officials are communicating with business people from Japan, creating a sort of a league of friendship to the "extent where the Commonwealth will have them contribute the necessary funds that we may need for infrastructure development including the control tower."

Manglona further added that Washington Rep. Babauta will meet with the U.S. Legislature staffers to find out what actually happened..."why is it that we only have \$2.5 million?...What about the other appropriations...there is not much explanation?"

# Grand Jury hands two indictments

The Federal Grand Jury indicted a Filipino national for one count of bank fraud while another was indicted for possessing and dealing with counterfeit money.

Genedino Montjo Samiano has been indicted for knowingly executing a scheme to defraud the Bank of Hawaii of \$9,000.

According to the indictment, Samiano, with the assistance of an accomplice, stole bank


cheques from the office of Lyonnaise Marianas Americas then forged the signature of an authorized LMA representative on the check which was written payable to cash.

The indictment also stated that it was part of Samiano's scheme to present the cheque as genuine whereby he received \$9,000 from the bank.

The Grand Jury also handed down an indictement Wednesday charging Vicente T.

Camacho with two counts of possesion and dealing with counterfeit money.

On Sept. 3, Camacho was found to be in possesion of, with the intent to sell or use, 109 counterfeit \$100 bills amounting to \$10,900. According to the indictment, Camacho transferred the counterfeit money on Aug. 27 with the intention to pass, publish or use the bills as true and genuine.

# Two child abusers sentenced

Two men convicted of sexually abusing children were sentenced in the Superior Court on Wednesday.

After being convicted of oral copulation and sexually abusing a minor, Charlie Oden was sentenced by Superior Court Judge Marty Taylor to 10 years of probation, a 5 year jail term with a two year suspended sentence. Oden was also ordered to pay a \$2,000 fine and was advised to undergo counselling and treat-

Oden was convicted of sexually abusing a nine year old child two years ago. The child was brought to Oden's home by his former girlfriend who said that acts were performed in front of her and the child.

Oden was convicted by the jury of sexual abuse of a child through exhibitionism. Based on the testimony of the child, the

tionally exposed his genitals for the purpose of sexual arousal and gratification. Edward Manibusan, special

jury found that Oden inten-.

prosecutor for the government said that evidence shows that Oden is a sexual deviant and that he is an opportunist who takes advantage of people who cannot defend themselves.

Manibusan told the court that the message should be sent out that anyone who commits such acts should serve time for it. "There is nothing, no amount of restitution to pay for; no amount of money can buy the self-esteem of the child."

Through his counsel Oldiais Ngiraikelau, Oden said that he plans to appeal the conviction to the Supreme Court. Taylor also gave credit to Oden

for the 16 days he had spent in the Department of Corrections.

In a separate hearing Wednesday morning, Judge Alexandro Castro sentenced an 18 year-old teen to 2 1/2 years in prison with a 2 year suspended term for sexually abusing a minor.

Melvin Basa, who pleaded guilty to the crime, raped a 15 year-old teen in a motel in Garapan in April of this year. He had already been in trouble with the law and was being held under probation for 5 years for bur-

Castro rejected the one year jail term recommended by the prosecutor and said that "anyone who walks into this court for sexually abusing a child does not walk out scot-free.

Basa was also ordered to perform 200 hours of community work service and to remain gainfully employed.

### In other court news:

A former Department of Public Safety police officer was sentenced by Judge Marty Taylor to two years of imprisonment for writing fraudulent cheques.

Sylvan Camacho was charged for issuing three Bank of Saipan cheques worth \$470. Two of the cheques were written for purchases made at the Happy Market while another check was paid out to cash, court records show.

Taylor sentenced the former cop to two years suspended sentence, 120 hours of community service and full restitution on a \$1,680 debt he made. Camacho's counsel

Nicholas told the court that restitution had already been paid and that his client is enlisting in a counselling program to curb

Taylor told Camacho that he should be thankful that his counsel worked on the agreement, if not, he could have ended up in jail.

Taylor also exonerated the \$5,000 cash bail imposed by the court for the release of Camacho.

Washington, DC—The board of Directors for the National Council of Architecture Registration Boards (NCARB) has announced dates through 1994 for the Architect Registration Examination (A. R. E.), the national annual exam for candidates seeking an architectural

NCARB offers the entire eight division exam each June and offers Division B: Site Design-Graphic along with Division C: Building Design each December.

Candidates wishing to apply for the exam should contact their registration board for information on exam locations, deadlines and admission requiements.

NCARB comprises the architectural registration boards of all 50 states plus those of the District of Columbia, Puerto Rico, Guam, the Virgin Islands and the NMI.

NCARB assists its member state registration boards in carrying out their duties and provides a certification program for individual stan-

# Acting Gov. Manglona to help CUC

Acting Governor Benjamin T. Manglona recently asked members of the Legislature to come up with a yearly appropriation of \$2.4 million for the payment of the new power plant.

Members of the Legislature were called upon for a meeting Wednesday by acting gov. Manglona in the governor's conference room to discuss the Senate resolution authorizing the government to pay for the purchase of "power plant phase II."

Manglona said that the purchase of the new power plant, consisting of two 13 megawatt engines, "is somewi. troublesome to some members of the Legislature."

He said that \$21 million is really a "big chunk" of money "and very difficult to get all at one time.'

He said that one way to address the issue concerning the possibility that the government will carry the burden in case the CUC defaults in its capacity to pay back Mitsubishi, "should be approached in a little different

In order not to be liable for the \$21 million payment, the Legislature should set aside \$2.4 million every fiscal year beginning this fiscal year, Manglona

According to him, this amount will be used "as an advance payment for the procurement of the power generators," and should sum up to \$ 15 million..."and let the CUC be responsible for the remaining \$6 million."

He said this should be done "rather than compounding the problems of the CUC with regards to its recurring deficits amounting to \$14 million."

The Legislature should recognize the need for the generators and should not deprive the people of a reliable and dependable power service, he said.

He said that after approval of this proposal..."nice if we will get the money from the general appropriation act which will be passed by the Senate...then we will sit down and do a full investigation of the the CUC's problem.'

According to Manglona, the amount of \$15 million "is a generous contribution" for the government to the CUC and with that assistance..."I hope the CUC can straighten up their financial problem...as it will help them recover and be self-sufficient."

He said that the present administration is committed to the improvement of the infrastruc-

Sen. Herman Guerrero, chairman of the oversight committee is looking into the financial capability of the CUC to buy the

In a separate interview he said that "we counterproposed that

The Legislature will be in a better position if that amount is given to the CUC as a payment for government utility rates."

Government power bills at present are being offset by the CUC, which will only last until 1992.

The money should be used as a reserv fund or be given directly to the CUC as payment instead of using it for the power plant,

# Senate final hearing on CUC re-scheduled

by Ronel B. Concepcion The fifth and final public hearing scheduled for yesterday, by the Senate committee looking into the capability of the CUC to pay back the financing of power plant phase II, was rescheduled until next Wednesday due to the CUC's failure to provide the committe e with a copy of its audited financial report.

Sen. Herman Guerrero, chairman of the oversight committee said that they are "not satisfied" with the financial statement, projections and other documents previously submitted by the CUC.

He said that "all those documents lead to the fact that the CUC is not capable of keeping up with its obligation."

The committee then "is afraid" to authorize the passage of the resolution because the CUC is not in the position, in its present financial crisis, to pay the \$21 M financial obligation, he said.

That is one of the reasons why the committee is awaiting a certified auditor's report for fiscal years'1988 to 1989 which "we have not yet received up to this moment," he said.

The audited report is very important to the committee for

"we will weigh our decision on that, whether the CUC really can or cannot pay for the financing of the new plant."

He said that if there is a favorable report, the CUC will simply pass it on to the Legislature. But if not, they will take their time to read it and try to come up with responses.

The report is being studied by the board members of the CUC... and "we are hoping that they will at least give us a copy," he said.

He said that since they have to respect the decision of CUC..."it kind of delayed the process in determining whether CUC really has the capacibility."

If the audit report shows that the CUC cannot pay the \$21 M, the Legislature will have to find money to buy the generators or to repair some of the existing generators that are just lying around, Guerrero

According to him, the old generators can still be repaired at a cost of around 3 million and "will still last long enough to provide the necessary need for power generation."

He said that funding for the repair of these old generators could "possibly" be included in FY 1991 "if it is very critically

He said that if there are really no choices, the mentioned alternatives should come into the scene because "we are trying our very best to help the CUC in its quest to have additional generators."

According to him, the government should be "realistic" that in case the CUC fails to pay the \$21 million; where will the Legislature get the money.

He said that it is not sound to cut off appropriations for essential services like medical service and education among many others.

What disturbed the committee "most" is the fact that there is a letter from Sea Hunter's James McDonald saying that a 10% commission will be received by some people with the purchase of the

He said that that information adds more inquiries to the ongoing hearing.

The Legislature has sought the assistance of the Federal government to help determine the people that are involved in this so-called commission, so that they can be properly sanctioned and prosecuted.

According to Guerrero, another problem that surfaced in one of the committee hearings was that the Japanese government needs only \$15 million which is contrary to the \$21 million amount CUC is asking.

Guerrero said that Mitsubishi on the other hand, through its legal counsel Robert O'Connor, "would like to have this transaction settled by next

## **Pre-law courses** offered for summer

The Offices of the Governor and the Attorney General is scheduled to hold a six-week pre-law course program this coming summer to prepare students for law and a proper education in the United States.

Assistant Attorney General Vanessa M. Ceravolo said that interested and qualified individuals who will participate in the summer pre-law program course "would have direct assistance in admission to law schools throughout the US."

The program, which is being worked out by her together with AG Robert C. Naraja and Northern Marianas College's Dean of Student Affairs Manny F. Borja, aims to primarily place qualified Northern Marianas descent in western United States law schools "with the hope that those law schools will equip them or make them more aware of the various issues that occur in the pacific."

She said that applicants must have graduated fror. four-year U.S.-accredited university, desire a legal education and "commit to return to the CNMI to assist in the administration and development of the Commonwealth.'

Ceravolo cited that the same kind of program is being undertaken by the University of New Mexico which houses the American Indian law center.

She said that the university carries a law program designed specifically for the native American Indian.

She said that they are trying to figure out how the Commonwealth can make an affirmative action program for the CNMI students, "so the same thing will happen for our students as with the American Indians."

Professor Bob Desiderio from the University of New has Mexico communicating "quite frequently" with "the offices" and has given them an estimated cost of the pre-law program which will be about \$30,000 "which could still go up," she said.

She said that Desiderio also would like the University of New Mexico to create law courses that are designed especially with CNMI issues and interest "in mind."

According to her, they are bringing over two US law professor including Desiderio to the CNMI to teach some of the courses the program will offer this summer.

Local lawyers will be asked to volunteer and provide assistance with regards to tutoring, legal writing assignments, or mock-court arguments where they will sit and act as judges, she said.

Ceravolo said that the program will give students preparation for their first year of law school. One of the courses is the legal writing program, "probably the most important course, because it gears the student not only toward legal research but also toward legal analysis," she

She said that they are hoping to place as many students as possible into the U.S. law schools and a lot of preparations are being drawn up right now.

Students are required to take the law school scholastic aptitude test (LSAT).

The officials will see how they do with the pre-law program because the CNMI wants to make sure that these students are capable, since law schools have criteria before accepting applicants, she said.


The CNMI needs more lawyers, "people who are trained to think to address special problems in the CNMI," Ceravolo said.

Manny Borja of the NMC is working in putting together a financial aid package for the students, she said.

She said that this pre-law program will allow the CNMI people to have the education that puts them in a position to deal more effectively with the CNMI's current issues.

Species List was made by the Director of the Division of Fish and Wildlife Alex Palacios and the Director of Natural Resources Nicolas M. Leon Guerrero to help increase protection of certain wildlife species determined to be rare, declining or have gone extinct.

The purpose for the creation of the list is to improve the legal protection for the animals, Wildlife biologist Derek Stinson said.

Stinson said that by changing the status of the species from protected to endangered, the maximum fine for harming any of the species on the list would result in an increased maximum fine of \$5,000 per violation.

Stinson said that they are now currently in the process of

comments from other agencies including the U.S. Department of Wildlife regarding the list.

Included in the list are the Marianas Fruit Bat (Fanihi) and the Sheath-tailed bat locally known as Payesyes. Stinson said the Fruit Bat which comes from the Southern Islands have been wiped out on Saipan and Tinian due directly to poach-

The proposed lists also consists of seven birds which are the Pulattat or the Marianas Common Moorhen, the Nosa or the Rota Bridled White-eye, the Chachaguak or the Island Swiftlet. Also included are the Aga or the Mariana Crow, the Sasangat also known as the Micronesian Megapode, the Gaga Karrisu or the Nightingale Reed-Warbler and

reptiles-the Haggan or the Green Sea Turtle, Hagan Karai or the Hawksbill Sea Turtle and the Guali'ek or the Forest Gecko. Two plants which are known as Cat's tail and the Tronkon Guafi have also been named in the list. Stinson said the Gecko has

been included in the list because the birds have declined in the last couple of years. Stinson attributes this greatly to the extensive agricultural changes particularly during the last 30 years however, he said that there are still chances that such species still occur in

The species in the list are being threatened by a wide variety of factors including poaching. destruction of crucial habitat and the effect of introduced ex-

CNMI endangered species list will not only add local protection to species already in the Federal Endangered Species list but will also give much protection to a few species not included in the Federal list, according to a press release from the DFW.



# Task force to look into child abuse

Sen. Paul A. Manglona is set to address the growing problem of child abuse by introducing a measure to create a task force composed of various government officials to investigate the issue.

Senate resolution 7-16, is requesting that the Governor appoint a task force that will conduct an investigation and research on child abuse and neglect within the CNMI, "and will issue a report to the Legislature recommending

appropriate legislation."

Manglona said that "Basically, I am concerned about the problem of child abuse and neglect which is becoming serious...a lot of people are raising concerns that parents are really not attending to their kids."

The task force will be composed of representatives from the Catholic Social Services, Division of Youth Services, Public School System, Department of Public Health and environmental

Services, Department of Public Safety, the Attorney General's Office and the Public Defender's Office.

> He said that he is "aiming at the formation of the task force so that other officials can get together" and "brainstorm" so that the CNMI can do it "right away" and "attack" the problem.

Manglona also introduced a statute, Senate bill 7-14, SD 1 which penalizes those found guilty of abusing a child a mandatory jail sentence, is now before the Governor to signing into law.

With this mandatory jail sentence bill, child abusers will now go to jail, said Manglona.

Meanwhile, based on information reported to the Child and Family Services Unit of the Division of Youth Services, the CNMI has seen a continuing increase in the number of sexual molestation cases.

The statistics provided by the Division, says that sexual molestation is the largest single offence reported which comprises about 45% of all the cases committeed against girls.

An increase in reported cases

was determined as a total of 82 cases or 33% were reported for fiscal year 19989 while 1988 records show that there were only 52 cases which have been reported to the agency. The victims included 10 boys and

DYS resource coordinator said earlier that sexual molestation and child abuse are "not imported problems."

The coordinator said that on a per capita basis, cases in the CNMI were almost identical with any other child molestation cases from any other place in the world.

# Mosquito borne-disease ...

mosquitoes and not directly transferable from one person to another, according to the press

John said that although it is not known yet where the source of the virus is, it is speculated that the virus is transmitted from the mosquitoes from livestocksuch as fowl, birds and pigs.

Most of the reported cases came from the southern part of the island however, it cannot vet be determined since no pattern has been established, John

Since this type of virus has not yet been isolated, preven-

tive measures have to be undertaken, John said. She said that if the entire population has been found to be susceptible to the disease, mass immunization would be needed to prevent an epidemic.

The Division of Public Health is urging the public to exercise extra precaution so as to protect the citizenry from the outbreak of an epidemic and to eliminate occcurrences, the press release stated.

The public is encouraged to observe proper waste and garbage disposal so as to eliminate the breeding places of mosquitoes.

It is also urged that screening for living and sleeping quarters be installed and that outdoor activities during the evenings should be avoided, according to the press release.

Insect repellent should also be applied to the skin's surface before going outdoors and that pyrethrin aerosol sprays should be used indoors while a proper residual spray should be used outdoors to kill mosquitoes, the press release said.

# MTC switches to new digital system

Three years after the Hawaiibased GTE bought Micronesian Telecommunications Corporation (MTC0 from its original owner, Kentron Int'l., the Hawaiian telephone company is now ready to transfer its 9,000 customers to its newly-installed \$80 million state-of-the art digital switching system.

"Our aim is to complement the fast economic growth and development of the CNMI's citizenry.

We want to give them top quality, cost effective telecommunication services that are up with the times," said MTC vice-president and general manager Roy Morioka. With the new and modern

telecommunications equipment that will be inaugurated today, MTC will be able to quadruple its service capacity.

From the old system of 96 international circuits, MTC will now employ 366 circuits clearly establishing its international gateway to the US mainland, Hawaii, Japan, Korea, the Philippines and

> Guam. What's even encouraging is that the whole system would be able to continuously function without any power interruption because of MTC's battery and own a 750 KWP generator with 6,000 gallons of fuel that can be easily switched to should the electrical power of the CNMI fluctuate.

"Rest assured that local and international calls will be transmitted on a non-stop, 24hour basis," said Morioka who became MTC's GM since 1989. Morioka added that with the

highly sophisticated equipment and network, switching capacity from 7,000 lines to 15,000 lines would culminate to faster and better connections to both local, overseas and inter-island usage at a reduced

MTC employs 18 people in the renovated building which now houses the latest telecommunication machines.

Big computer terminals have been changed into smaller but more effective ones to keep up with the Island's escalating demand for a better, faster and efficient communication system.

"MTC is striving to maintain a grade of service which provides only one busy signal per 100 call attempts," Morioka said.

To date, the capital


cabling was \$12.5 million for Saipan, \$2,3 million for Tinian and Rota.

The DMS-100,200 and 300 switching systems came with a price tag of \$7.7 million, while the fiber optic facilities cost about \$1 million.

"Nothing spectacular and highly efficient costs cheap, but as I said, it is a part of MTC's desire to serve our customers with the very best that we can afford," said Morioka.





There will be a big emphasis on counseling, in both large and small groups.



They would prefer a partially enclosed structure with electricity, toilets and running water, and in a rural area if possible. They also say they'll settle for less than that, just to get started, until a more suitable place is found.

# Northwest Airlines expands service to Saipan

Northwest Airlines earmarked its nonstop flight expansion service between Tokyo and Saipan Tuesday with the take off of one of its Boeing 747 from the Saipan International Airport.

L. J. Gilbert Jr., Guam and Micronesia Northwest Airlines Manager said that he is very much excited with the new scheduled service to the CNMI.

He said that from the existing two flights per week between Tokyo and Saipan via Guam, they will now be scheduled for daylight service, operating non-stop in both directions five times a week except Saturdays and Sundays.

According to Gilbert, and Guam Visitors Bureau Chairman, the new service flight is already an "overdue" long-term expansion plan for the airlines.

He said that although this is some sort of an answer to what the people of the CNMI are clamoring for, a plan has already been set up earlier and Saipan is part of that total project service expansion,

He said that another reason why Northwest moved into the schedule is the acceptance of the people of Saipan, who all welcomed the idea by reacting in an very good manner.

He said that this not the first time the Northwest airlines' crew landed on Saipan without hesitation..."even without the control tower facility."

Gilbert said that the airlines are offering Boeing 747 equipments with three distinct types of service which are the bussiness class, executive class and the economy class, where passengers are afforded different accomodation.

He said that "We are looking forward to improving our service now that we are already here."

The aircraft crew consists of multinational individuals from various nations like Japan, and Korea, and etc.

Gilbert, when asked on how flight operations are affected

with the increase in fuel prices said the airline will either reduce the number of flights to reduce the cost of fuel consumption or maintain the flight schedules and increase the fare.

New flight schedules are as follows:

Northwest flight 062 will depart Narita Monday through Friday arriving on Saipan at 7:20 a.m. Flight 063 is scheduled to depart Saipan for Narita at 9:30 a.m. Monday, Tuesday, Thursday and Friday. Wednesday's flight 063 will depart Saipan at 11:30 a.m.

Arrival at Narita will be 11:55 a.m. on Monday,

Tuesday, Thursday and Friday and 2 p.m. on Wednesday.

The arrival times at Narita will enable Saipan originating passengers to connect to all of Northwest's Transpacific and Interport flights.

According to a press release, Northwest was the first airline to introduce a scheduled air service between North America and across the Northern Pacific in July 1947.

It said that over the past 43 years, the airline has progressively developed its pacific route system so that today, Northwest is the world's largest airline operating between Asia and the United States.

## **Three** journalists charged in Fiji

SUVA, FIJI (AP)- The publisher of the Daily Post newspaper and two of his staff appeared in court Monday charged by the government with "suspicion of malicious publication."

Publisher Dan Bolea, reporter Subhash Verma and sub-editor Robert Wendl were charged in relation to a story saying that the University of the South Pacific students in Suva planned to hold a rally where they intended to burn a copy of Fiji's new constitution.

Verma, who wrote the story, was arrested on Saturday, while Bolea and Wendl were arrested and charged Sunday.

All three were released on bail and will appear in court again Thursday.

Paterson Mae, chairman of the Pacific Islands News Association, said the arrests were a clear case of intimidation and harassment of the Fiji media.

The university students protested against the detaining and reported torture of a university lecturer, Anirudh Singh, last week. Singh was involved in the protest burning of a copy of the new constitution.

The recently enacted, racially weighted constitution guarantees indigenous Melanesian Fijians political dominance, including majorities in both houses of a new Parliament that is to be elected next year.


The constitution also has been roundly criticized by other countries, particularly India. Fiji closed down the Indian Embassy five months ago and expelled its diplomats in a continuing row over the constitution issue.

Ethnic Indians, originally brought to Fiji by the colonial British last century as indentured sugar plantation workers, comprised a majority of Fiji's 720,000 population before the coups. But emigration since then has left them a minority.







some reporters and columnists, who felt presidential aides were taking the first steps in throwing a "cordon sanitaire" that deprived Mrs. Aquino of feeling the real pulse of the people. Then, numerous government

scandals broke out, dominating the headlines and talk shows. Slowly, the criticism hurled at Cabinet and other government officials was reaching Mrs. Aquino herself.

Some of Mrs. Aquino's bitterest critics in the local press were.... A common theme of their attacks is that her government and the efforts lacks direction and is just as corrupt as that of Marcos.

Mrs. Aquino has often complained that the press today does not report on the achievements of her making to improve the lives of ordinary Filipinos.


She says that sometimes, officials feel that "the country we read about is not the Philippines but a terrible, cursed land in an outlandish world created by the imagination of reporters and columnists."





ing \$939,000 in interest charges and that loans totalling \$5.7 million are in default. The report alleges that at least \$426,000 had been loaned to borrowers for purposes not authorized in the loan agreement.

In answer to queries made on loans given to government officials, Tenorio said that the CDA considers every loan applicant, as long as he meets the requirements set by the firm.

He said that local laws allow that "anyone who is a U.S. citizen and who is eligible" is considered and that the CDA does not discriminate in terms of collecting delinquent loans.

Tenorio said that when the new board resumed office, the delinquency rate has been lowered to

One of the recommendations made in the audit report asks the executive director to require that every loan applicant be thoroughly analyzed. Tenorio said that although the Board sometimes approves of high-risk loans, they make sure that the business involved in it can improve and benefit the economy.

Another allegation made in the report was that the CDA accepted loans amounting to \$1,663,406 which were not secured by a sufficient collateral. Tenorio said that allegations were not true and that the CDA has always maintained its stand to ask for collateral, which may come in the form of real estate properties, from its borrowers.

Tenorio said that although \$500,000 have been appropriated for farming and fishing loans, not much borrowers were applying under the category.

"Most of our clients are concentrated on commercial businesses. Only 1% avail of the farming and fishing loan," Tenorio said. Another allegation made in

the audit report is that the CDA had been granting loans to commercial establishments with projects that are not commercially feasible. Manglona said that such practice may have been true before however, he knows .that current Board members have

stayed away from "that practice.'

The audit report has asked CNMI Governor Lorenzo I. Deleon Guerrero to investigate and possibly file legal actions on former and current CDA officials responsible for the millions of dollars worth of loan fund losses.

The report recommended to the Governor that an investigation be made on several board members and consider legal actions to hold them "personally responsible" for loan fund losses resulting from the board's apparent neglect of its fiduciary responsibilities.



Six to ten year olds were the






