"THE POLICY OF JUSTICE."

What a "Journal of Civilization"
Thinks of the Hawaiian Ques-
tion.

[Harper's Weekly, Nov. 25, 1893.]

There are two things which never
ought to be the football of party
politics: one is the judiciary, and
the other is the foreign policy of the
government. As to the judiciary the
people of New York have recently
administered to the party bosses a
most wholesome lesson. It would
be a great blessing if the domag-
ogues could be taught a similar
lesson with regard to our foreign
policy. The frantic partisan out-
cries we hear at present against the
attitude of the administration con-
cerning the Hawaiian business are a
disgrace to a civilized community.
There are certain moral precepts
which apply to nations just as well
as to individuals. A person not re-
cognizing the binding force of the
commandment, "Thou shalt not
steal," or denying that it is wrong
to keep stolen goods, would certain-
ly not be tolerated among gentle-
men. If he carried his theories into
practice, he would be looked up in a
penitentiary. It is true, a nation
doing the same thing cannot be so
easily brought to justice as an indi-
vidual. But it will, by doing the
same thing, just as surely forfe

Those who are not regular readers of Harper's Weekly will thank us for reprinting in this issue that "journal of civilizations" powerful deliverance on the Hawaiian question.

It takes a great deal of dirt to make ground for planting the tree of freedom in Hawaii. And it's nip and tuck between the Advertiser and Star for the prize as champion scavengers to shovel the dirt.

We believe the Hawaiians may trust the United States Congress to do justly by them as implicitly as they have trusted President Cleveland. The most impartial and some of the most powerful organs of public opinion in the United States support the President's policy.

All the arguments that have been used here and in the United States to show that it would be illegal for President Cleveland to restore the constitutional government of Hawaii are only additional reasons for the utter condemnation of the Harrison-Blaine-Stevens rascally conspiracy to subvert the independence and self-governing institutions of this friendly nation.

While abusing Commissioner Blount and opponents of the P. G. who gave him their testimony, the organs are as dumb as ex-Minister Stevens on the testimony cited by Secretary Gresham from P. G. persons and papers. In fact, not one of the local annexation papers has yet given the citations from the mouth of Minister Damon and from under the hands of President Dole, the committee of safety and Minister Stevens himself. Yet it is on this testimony that the United States Executive has put the case.

Nothing more contemptible has ever appeared in Honolulu journalism than the invoking of the so-called sedition law of the P. G. by the Star against the Holomua. There is only one similar instance in remembrance. That is, when the Advertiser—in terror of public opinion's rolling back on the conspirators like an avalanche—beseeched the P. G. early in the present controversy to suppress free speech and the freedom of the press. The talk of war times and war measures is only a plausible screen for the despicable retreat of disputants who cannot hold their own. It was bad enough for the rabid tinker, with no chivalric sense of fairplay to opponents, to croak dismally in the P. G. councils against the freedom of the press—when he wanted to shut everybody up to taking the sheet that he was interested in. But that a newspaper, claiming to reflect American ideas and to illustrate American ideals of liberty, should sink behind a law resurrected from a medieval tomb, for shelter from the literary fire of an antagonist, is—well, it is only a proof that the Star's boasted Americanism is a sham to cover the trail of a campaign for boodle and the spoils of power.

GRAND STAND BURNED.

Heavy Loss Sustained by the Honolulu Cricket Club.

On Saturday night the grand stand at Makiki recreation ground was burned down. It is supposed to have been wantonly set on fire by hoodlums. The stand was in rather a dilapidated condition and was not a beautiful object in the landscape. But the closets underneath the seats had been renovated the past season by the Honolulu Cricket Club, and contained all the implements of the game owned by that body, including practice nets, bats, balls, stumps, pads and gloves. It will take fully \$150 to replace the paraphernalia. There was no alarm given and it is fortunate there was no wind to drive burning embers upon valuable buildings in the neighborhood. For many years the matches of the Hawaiian Baseball League filled the benches of the grand stand now destroyed with enthusiastic spectators. Since the organization of the Hawaiian Baseball Association as a corporation two or three years ago, with grounds of its own, the Makiki recreation ground has been abandoned to all-comers for practice of various athletic games. The cricket club lately organized, however, spent a good deal of money and some of its members' time in improving the ground, and thus in a manner created a claim for precedence in occupation which has not been disputed by other athletic bodies.

HOW CHRISTMAS WAS KEPT.

Lively Streets Saturday Night—Services Sunday and Monday.

Saturday night being the last opportunity for Christmas shopping was taken large advantage of by the people. Port streets sidewalks were densely crowded from dark until nearly midnight, and the stores were a babel with buyers in several languages crowding them. There was a large force of noise makers on the outside, who wore masks and blew squeaky whistles, besides putting themselves badly in people's way. In spite of this drawback, due to the absence of any intelligence directing the police, the stores seemed to do a lively business.

What might be termed a Christmas carol service was held on St. Andrew's Cathedral last Sunday evening. A selection of carols was well sung by the choir, assisted by the leadership of the organ. The Rev. A. Mackintosh read the prayers, omitting entirely the usual sermon. In the musical part of the services solos were well rendered by Miss Ward, Mrs. Dr. Howard and Mr. Iauka.

At the service of the Cathedral congregation, conducted by Bishop Willis and Rev. V. H. Kiteat, the same evening, carols were sung by the boy choir and the pupils of St. Andrew's priory.

There were large attendances at the services of both bodies in St. Andrew's Cathedral on Christmas day. Chairs had to be placed in the aisles at the services of the Second congregation. A detachment of marines and bluejackets from H. B. M. S. Champion marched to and from the church in a body. Captain Rooke of that ship, Captain Nelson of the U. S. S. Adams, and many officers of those ships and the U. S. S. Philadelphia were present, also Rev. H. Bingham, D. D., and other representatives of the Congregational communion. Rev. Mr. Griffith, chaplain of the Champion, assisted in the service. A choir of twenty-six voices rendered the music very effectively, the solos being taken by Misses Ward and von Holt, Mrs. Tenny, Messrs. C. P. Iauka and Wakefield. Rev. A. Mackintosh preached an appropriate sermon.

There were two celebrations each of the holy communion by the Bishop's and the Second congregation, with a large attendance of communicants—from over seventy on each occasion. Mr. Wray Taylor played the organ with his usual ability at the services of both congregations.

A large audience met in the Roman Catholic Cathedral yesterday, at 10:30 o'clock a. m., to celebrate Christmas. It was estimated that nearly 2000 people were present. The Bishop of Panopolis, assisted by the clergy, conducted the service. The music of the choir led by the Rev. Father Valentyne, was vigorous and enlivening. Instrumental music was furnished by the St. Louis College band, conducted by Brother Francis. At the close of the religious services in the Cathedral many of the attendants inspected the recently constructed representation of the Queen of Peace in the Cathedral yard.

At Central Union Church (Congregational) both of the regular services on Sunday took on a Christmas aspect. The choir rendered special music with fine voices and accomplished skill.

Saturday evening the Christmas festival of the Chinese mission conducted by Rev. F. W. Damon took place, and was as always a highly interesting event. Mr. Damon also superintended a Christmas tree for the Japanese Sunday school in Queen Emma hall. In both places the exercises of the kindergarten classes were particularly bright features.

The Portuguese Protestant mission Sunday school had an entertainment Saturday evening. Rev. A. V. Soares conducted the exercises, and Dr. N. B. Emerson, superintendent, with Misses Fernandez and Ferreira, teachers, made the youngsters glad by the distribution of prizes and presents.

At the Kalili leper receiving station, the little girls in the home for children of leprosy parents were not forgotten. There are eleven of them under the care of the good Sisters, and they were furnished by friends with a grand Christmas tree.

RACES AT WAILUA.

List of the Events With Time in Each.

Not a few left town on Saturday, going by way of the Pali, to be in time to witness the horse races at Wailua on Christmas Day. Those who were so fortunate as to be present on the race-course were rewarded with some very fine performances. The races started with a three-eighth mile event, the following being the entries: Leilani, entered by T. Gay; Tillie, by L. Warren; Mischieff, by E. Halstead. They covered the distance in the aforementioned order. Time, 40 seconds.

The next was a half-mile race, the winner being Kahuku Boy, entered by W. Rathburn; second, Kangaroo Tom, by L. Warren; Joe D., by Kapu Bros. Time, 51 seconds.

Half-mile race. Won by Vanguard, J. J. entered by E. Halstead; Kahuku Lilili, by Kahuku Ranch, second. Time, 54 seconds.

After these events there were several scrub races between ranch horses. The final event was a quarter-mile match between Bushwagger, entered by J. F. Clay, and Kangaroo Tom, by L. Warren. After a hotly contested match Bushwagger came in with a rush, winning by a neck. Time, 20 1/2 seconds.

COURT CHRONICLE.

Appellate Court in Session—Breach of Promise Case.

The Supreme Court began its December term this morning. One case was argued and submitted, viz.: Gum King et al. vs. Kahuna et al., water controversy in Nuanuu, Honolulu. Davidson and Achi for plaintiffs; Maqoon, Kaulia and Kane for defendants.

This afternoon Chief Justice Judd, alone, is hearing argument on exceptions from both sides to partition commissioners' report, in Hawaiian Commercial & Sugar Company vs. Waikapu Sugar Company. The full court has adjourned till to-morrow.

Three cases have come up from the Lahaina term on exceptions to the Supreme Court. One is the Ayers-Mahuka breach of promise suit.

BELLOUSE SOLDIERS.

They Try to Pick a Quarrel with Peaceable Natives.

Complaints are heard of the misconduct indulged in by P. G. soldiers when on liberty, especially when under the influence of liquor. Between Saturday night and this morning, in divers places, natives and other inoffending citizens were insulted by these soldiers, their spite being directed more particularly at natives. A group of peaceable natives was at the wharf near the Fish-market on Sunday morning, when a couple of drunken P. G. soldiers passed by, and began to abuse the Queen's name in a most insulting manner, without provocation. They even went to the extent of challenging all-comers to fight, and the natives stood a great deal of nonsense from them for the sake of peace.

Besides roast turkey and plum pudding, there were many rarities in the menu, and everything was cooked to perfection. It was a great novelty to visitors recently arrived to have fresh strawberries at a Christmas dinner. Sans Souci is an ideal seaside retreat for either day or evening entertainments, and has a fine beach for bathing.

ANOTHER STAGE REACHED.

Answer of the Provisional Government to the Request for Surrender.

It was foreshadowed in this paper some days previously, that United States Minister Willis would expect an answer from the Provisional Government by the end of last week.

President Dole's retirement at his house, after the special session of the Councils at which the request for surrender to the Queen was considered, was generally understood to be for the purpose of elaborating the answer.

As this paper went to press on Saturday afternoon, the Councils were going into special session. At 5 o'clock it was learned that the United States revenue cutter Corwin had hoisted one of her anchors and was making other arrangements for departure.

Shortly afterward President Dole called at the United States Legation. All these things led people to believe that the answer of the Provisional Government had been made to the United States Minister's request for a surrender of affairs to the Queen.

The Corwin sailed at 4 o'clock Sunday morning. Shortly before her departure Minister Willis and Consul-General Mills visited the cutter in the ship's barge. They only stayed a short time.

According to the Advertiser, the Government requested the Minister to forward the answer to President Cleveland, and in consequence will not give out the documents—the request and the answer—for publication at present. The fact has previously been published that the answer is a refusal.

Reports are again current that the Provisional Government will not await final action by the United States authorities, but will precipitate the proclamation of a republic one of these fine mornings.

Young Hawaiian Genius.

Two good-sized pictures representing Mr. and Mrs. Wm. Auld are now on exhibition at the window of the Pacific Hardware Co.'s store.

They are the work of a young native artist, Mr. Lapua Lapua, who made the pictures as Christmas presents to Mr. and Mrs. Auld. 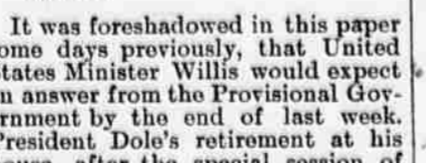

fair-minded man what is the duty of our government, as an honest government, under such circumstances? Accept the stolen goods and stow them away as our property? Do this, knowing that the Hawaiian people have never been consulted about the matter, and that, as there are the best reasons for believing, they are strenuously opposed to it? And try to justify so shamelessly dishonest and so utterly unrepentant an act on the ground that the Queen of Hawaii is only a monarch, and that with the treatment of monarchs the moral law has no concern? This is what the demagogues denouncing the administration insist that our government should do. What patriotic American will wish to see his country placed in so humiliating an attitude? Whoever considers it the business of our national government to maintain the honor of the republic will admit that the duty of the administration in this case is as clear as sunlight. If the overthrow of the government of a friendly state was effected by the unwarranted intervention of an armed force of this republic for the purpose of bringing about the annexation of that country to the United States—which is by indisputable evidence proved to have been the case—then we are not only precluded from annexing the country so offered, but, as a decent people, we are in honor bound to undo the wrong that has been done, and to that end to restore the status quo ante as far as we can under the law of nations. Any failure to do so will stamp this nation as a faithless, disreputable concern.

There is much high-sounding talk by the demagogues about the power and influence in the affairs of the world which would come to the United States by the possession of the Hawaiian Islands, no matter how acquired. No man, unless he belongs to that class which values more highly a success won by crooked means than one honestly achieved, will fail to see that far greater and far nobler power and influence will be won by the policy of justice than by a policy of fraud and force. There is no reasonable commercial advantage the government of Hawaii will not be glad to grant to a power which has treated it so honorably, and such advantages we shall have unburdened by any political responsibility. We shall occupy a much higher position than ever before in the estimation of mankind, and wield a much more powerful authority in the councils of nations. The demagogues talk of Great Britain standing ready to grant to the Hawaiian people the Hawaiian Islands. But we tell them there is no power on earth, be it ever so greedy, that will dare to take an unfair advantage of our policy of justice for its own benefit, and our veto will be more conclusive than ever to stop proceedings injurious to our interests. The demagogues raised a mad outcry about "hauling down the American flag" when President Cleveland first caused it to be removed from the Hawaiian state-house, where it had no right to be. But it was the flag of the pirate that was hauled down; it is the true American flag, the flag of honesty, justice, and good-will to all men, that has now been hoisted by the administration. The country owes a debt of profound gratitude to Secretary Gresham for having courageously told the truth, and to President Cleveland for pursuing the path of rectitude in our dealings with the world abroad. The American government has never stood in a prouder position before mankind.

A. talks of a dignified answer to Minister Willis. Request dignity from that crowd! Why, they don't know the meaning of the word. Look at their slobbering over the Hon. J. H. Blount while he was here, and now they are abusing him like a pick-pocket, because he really was impartial in his reports. He stated facts as he found them. So Minister Willis can see the kind of cattle he has to deal with.
