MAJORITY rule is good, but it is not always just. The representation of minorities has been engrained upon the English elective system. This was considered essential to a fair representation of the British people in the Imperial Parliament.

MEAT SUPPLY.

The production of beef is in excess of the consumption at Honolulu. Prices of fat cattle have fallen of late years until at present fat bullocks bring about \$35 top price. There is a much lower range of values of course, and the tendency is downward. However, the retail price of beef does not vary at all from what it was when fat bullocks brought \$45 or \$50 each. It is of course the interest of stock raisers to get the highest possible price for their cattle, and so share profits with the butcher, or middleman. To that end, we understand that the owners of three large cattle raising ranches have secured an interest in the leading butchering business of this city. The result must be advantageous to them, and consumers stand a chance of getting a better quality of meat. Be this as it will, however, the price to consumers will remain unchanged.

This brings us to the further point that another outlet must be found for Islands cattle or the country will become overstocked. This should be avoided if possible because it not only loses money to stockowners, but it impoverishes the country by exhausting the food supply. There is a possible outlet to Tahiti, but the trend of trade is not in that direction, and transportation would be difficult and costly. Samoa is not available either, because it could be much more cheaply and easily reached from New Zealand and cattle can be bought as cheaply there as here. The Pacific Coast is capable of supplying its own needs, and is shipping to Eastern points. What remains therefore to do, is to increase the consuming population as speedily as possible, and that can only be accomplished by promoting colonization and land settlement. Mr. Dillingham is in England forwarding such a scheme, and Hon. S. G. Wilder's railroad project is in the same line exactly. Unfortunately recent political events here put a damper upon these gentlemen's efforts, but we hope for the best in each case. The matter is one of very great importance to this country, and we trust it will have a practical solution.

THE CREDIT SYSTEM.

In these stringent times the credit system forces itself upon the attention of everyone engaged in business. Collections are dull; to some extent they are impossible. Money is not in circulation as freely as in times past, and political unrest has checked investment. That this is only temporary is what everyone hopes; but hoping will not effect a remedy. Action is needed. Those who believe in the stability and resources of the country—and we believe nearly everybody does—should be willing to assist in bringing about a more healthy condition of affairs than now exists. Attention should be given to something outside of politics, and sound business methods should be adopted. The modification of the credit system is a preliminary step in that direction. It cannot be done by any arbitrary act, but gradually under an agreement with importers who sustain the entire credit fabric. It is not for us to suggest how this can be accomplished. The Chamber of Commerce, composed as it is of clear-headed and experienced business men, might be able to suggest a suitable method. Our evening contemporary, we are pleased to see, is of the same opinion as the ADVERTISER on this subject.

Second Ward Reform Club.

A meeting of the Second Ward Reform Club was held last evening in the Lyceum. Mr. Henry Waterhouse is in the chair. The attendance was quite large. The minutes of the previous meeting were read and adopted. The Secretary, Mr. J. F. Morgan, stated that before they got through there would be nearly 200 names on the roll.

Mr. C. B. Reynolds, employed by the Board of Health, asked that his name be withdrawn from the Committee on Credentials. His resignation was accepted, and E. C. Rowe elected to fill the vacancy.

Mr. Turrill was called upon for a speech, and said that he thought the Ward would be able to send nine delegates to the Convention. In the course of his remarks, which were quite lengthy, he said that out in the West there were two requisites to make a man a politician—one that he could take a drink, the other that he could make a speech.

Messrs. J. D. Tucker, Waiwaiote, S. Savidge, Smith and others also made remarks.

Fourth Ward Reform Club.

A meeting of the Fourth Ward Reform Club was held last night at the Government Building. The attendance was moderately large, including a considerable proportion of Hawaiians. The business was chiefly of a formal character. Mr. Joseph W. Kawainui tendered his resignation as a delegate, which was accepted, he having been asked to become a candidate.

Supreme Court Decisions.

The following decisions were filed yesterday: W. C. Parke, assignee of T. J. Moorman, bankrupt, vs. M. P. Robinson and I. N. Robinson. From July term. Jury waived. Before Mr. Justice Preston.

DECISION.

This is an action of trover brought to recover certain stock in trade, consisting of crockery, glassware, etc., belonging to the bankrupt, or its value. It appeared from the evidence that on April 1, 1884, James Robinson and Robert Lawrence granted a lease of a store, corner of King and Nuuanu streets, Honolulu, to T. and F. J. Moorman, for the term of three years from date, "with the privilege of holding the same three additional years," at the yearly rent of \$1,030, payable quarterly. That at the expiration of the said term no other lease or agreement was made, and the tenants and the survivor, T. J. Moorman, remained in possession of the premises, paying the same rent as reserved by the lease, until the bankruptcy of the said T. J. Moorman, which occurred on the 24th day of January, 1887, on which day the defendants, who had become the owners of the premises, distrained and removed the goods in question for one year's rent, due on the first day of the said month. The plaintiff was appointed assignee of the bankrupt's estate, and claimed that the distress was illegal.

On behalf of the plaintiff it was contended that at the expiration of the term created by the lease the lessees continued in possession as tenants at will only, and therefore under the statute relating to distress for rent the plaintiffs had no right to distrain, or at most for four months rent only. I am of opinion that the defendants are entitled to judgment. The lessees, on the expiration of the term, became tenants from year to year, subject to the tenancy being determined by proper notice. The statute allowing distress for rent does not limit the right to any definite time, or to any express amount. It provides that no goods shall be liable to be taken on execution, unless the tenancy shall be by the week or month. This provision cannot apply in this case. The defendants having distrained and removed the goods before the order to the Marshal to take possession was made are entitled to hold the proceeds, and I therefore find for the defendants, and direct judgment to be entered for them with costs, as of the July term.

DECISION.

This is an action by the plaintiff, as the trustee of the estate of the late Thomas Cummins, as the holder of a promissory note for \$1,000 made by the defendant, Richard Oliver, on December 24, 1877, in favor of A. S. Cleghorn & Co., and payable six months after date, and indorsed by A. S. Cleghorn to the deceased.

The defendant, Oliver, allowed judgment to go by default. The defendant, A. S. Cleghorn, pleaded the general issue and gave notice that he would rely upon want of notice of dishonor and the statute of limitations.

The note was indorsed by the defendant Cleghorn, "protest waived." I am of opinion that the indorsement did not dispense with notice of dishonor, and I also find that the defense of the statute of limitations is sustained.

I therefore decide that the defendant is entitled to judgment, and do order the same to be entered with costs.

Declaration of Principles.

Faction, however powerful, or usurpation however successful, shall receive no quarter. It will uphold the Constitution and laws of the Kingdom, and advocate equal civil rights for native and foreign-born subjects.

Class legislation and unequal representation will be opposed as wrong in principle and contrary to the progressive spirit of the age.

Manhood suffrage, with residence, should be the basis of the franchise, as in the United States. Property qualification should be abolished.

Office-holders and Government contractors should not be eligible for nomination or election to the Legislature.

Members of the Legislature should be debarred from accepting any office of honor, trust or emolument under the Government for a period of twelve months after the expiration of the Legislative term to which such members were elected.

Ministers should be held responsible for all appropriations, and no money vote should pass without Ministerial approval.

Reduction of taxation and economy in expenditure are essential to the progress and prosperity of the country. To that end a reorganization of the Departments is necessary.

Personal fitness and a good reputation should be the only requisites for official appointments. This implies a thorough overhaul of the civil service.

The military should be subject to the civil power. The independence and integrity of the Bench must be upheld. A corrupt or partial judiciary is a curse to any country.

Encouragement should be given to immigration for the two-fold purpose of developing the natural resources of the Kingdom and rendering possible the establishment of new industries.

The public lands should be administered for the public good and not for the enrichment of individuals.

A well-considered and feasible policy of improvement works should be adopted and adhered to.

The United States being the natural market for Hawaiian products, public policy should be directed toward strengthening existing political and commercial relations with that country.

Honolulu should be proclaimed a free port, and increased facilities provided for the repair of shipping and the handling of merchandise.

Steamship and cable communication with the Pacific Coast and Australia should be encouraged.

Sugar being the staple product of the country, those engaged in its production are entitled to have their interests studied by the Government.

The public debt should not be increased. There is ample revenue—if an honest accounting were made of receipts—to pay interest on loan, defray reasonable expenses of Government, and carry out a progressive system of public works.

The public school system should be sustained and improved. Hawaiian children should be taught exclusively in English to equip them for the duties of life. Instruction in English alone should be similarly given to children of foreign parentage.

The sanitation, lighting and improvement of the city of Honolulu are matters of paramount importance. A policy of interior development, by means of highways, etc., will be advocated. In brief, all matters and things tending to the benefit of the country, and to the promotion of peace, order and good government, will have an advocate and exponent in the PACIFIC COMMERCIAL ADVERTISER.

It has frequently been affirmed by various local agents that the risks taken here worked in the end a loss to the insurers, or in other words, that the aggregate of losses paid by the several companies on policies issued in this Kingdom exceeded the amount of premiums received to the home offices and that the Hawaiian public should be thankful to these companies for taking compassion on us, and reimbursing our losses with hard coin; these assertions have been made notwithstanding the fact that the profits of the business have been sufficiently tempting to induce over thirty companies, hailing from all parts of the business world, to establish agencies in this city, which under healthy methods of management, or reasonable rates, would seem to be out of all proportion to the extent of the field of operation.

Even a very indifferent knowledge of the laws of business, and the causes prompting the investment of capital, and the taking of commercial risks, and ventures do not confirm the truth of these statements; on the contrary they become more and more apparent at every step.

Shortly after the fire already mentioned, the local insurance agents formed themselves into a board, and advanced the rates to figures, which in many cases were prohibitive, and numbers who formerly carried policies have either reduced their amounts of insurance, or taken the risks themselves. This increase on the part of the underwriters would hardly seem fair or even wise in view of the fact that the space denoted by the late fire, and which was the most dangerous part of the city, has since been mostly included, by statute, in the fire-proof limit, a great portion of which has been covered by substantial brick buildings, with regulation fire-escapes. The water supply of the city has been largely increased, the apparatus of the Fire Department greatly added to, and its organization, numbers and efficiency much improved. These facts which are well known to all who are acquainted with the city would seem to have furnished good grounds for reducing rather than increasing the rates of Fire Insurance.

The idea of local companies of the character proposed is by no means experimental, as many instances, both on the Pacific Coast and in the older States of the Union might be cited, which have not only proved financially successful, but under judicious management have greatly extended the benefits and protection of insurance amongst those who stand in greatest need of this class of assistance.

It would seem only fair and just that a community paying the heavy taxes levied by Fire Insurance Companies should share in whatever profits may accrue from the business, by the redistribution of these profits in the form of dividends, and this result can be attained in no way more readily than through the mutual system, and the proposition is to organize a local company on this basis.

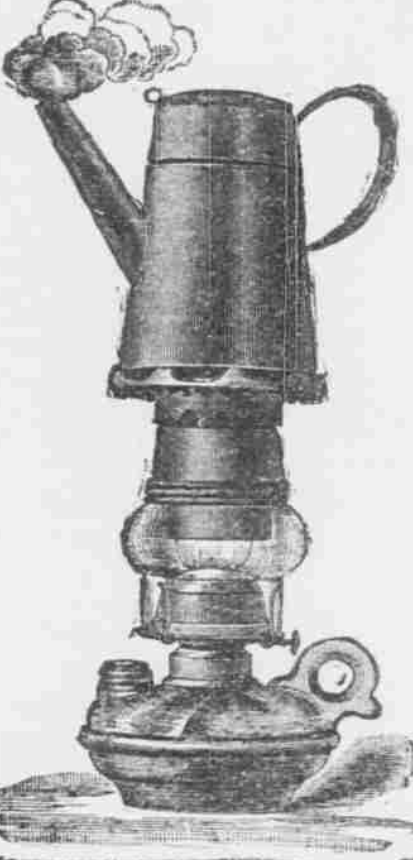
